Brewster man one of five arrested on drug charges - all part of same drug trafficking organization

Caleb Ritz arrested in Manson on Dec. 8

WENATCHEE - On December 8, Chelan County Deputies responded to a male passed out in a vehicle in Manson. Deputies that arrived on scene recognized the male as Caleb Ritz, a 39 year old male from Brewster. Ritz was arrested on drug related charges and search incident arrest, Ritz had a loaded revolver on his person. Ritz is a convicted felon. Ritz's vehicle was seized for a search warrant. Deputies worked with the Columbia River Drug Task Force De-

TECTIVES and a search warrant was served on the vehicle resulting in suspected Fentanyl pills, suspected heroin and suspected methamphetamine seizure. Ritz was charged with Unlawful Possession of a Firearm in the 1st Degree, Possession with Intent Fentanyl, Heroin and Methamphetamine, and Possession with Intent Heroin.

On December 9, Detectives from the Columbia River Drug Task Force served a search warrant in the 700 block of North Grover Place in East Wenatchee. The search warrant resulted in over 8,000 suspected Fentanyl pills being seized. A second search warrant was obtained for the resident of the property's vehicle which resulted in roughly

400 more suspected Fentanyl pills along with 2 ounces of suspected methamphetamine an ounce of suspected heroin and a large amount of cash. Shawn Drummond a 36 year old resident of East Wenatchee was arrested for Possession with intent to distribute Fentanyl, Heroin and Methamphetamine.

On December 16, Detectives with the Columbia River Drug Task Force conducted an investigation at the Red Lion Hotel in Wenatchee, where it was determined Fentanyl pills were being dealt out of one of the hotel rooms. Numerous known drug users were seen coming and going from the suspect's room. A search warrant was served at the suspected hotel room which resulted in the arrest of Kasey Cooper, a

34 year old resident of East Wenatchee. When Cooper was contacted in the hotel room by law enforcement he destroyed evidence by flushing suspected drugs down the toilet. Additional drugs to include suspected Fentanyl pills and suspected Methamphetamine were recovered in the hotel room. Cooper was arrested for Possession with Intent for Methamphetamine and Fentanyl. He was also charged with Maintaining a Drug Property and Obstruction.

Over the course of the investigation it was determined that Shawn Drummond, Kasey Cooper, Matthew Hendricks, Caleb Ritz, and Casey McKinstry are all part of the same drug traf-

Keeping our schools safe

CHELAN - While the laws, styles, and dangers change over time, the fact remains that illegal drugs do not have a place in our schools. Unfortunately, they do show up from time to time in a variety of forms. It is very important to the safety of students and staff that we take proactive steps to keep our schools free of weap-

ons, drugs, and alcohol.

Please be advised that to assist in that endeavor, Lake Chelan School District #3230 states that "school officials may allow the use of trained and certified detection canines on district property or at school events to protect students from exposure to illegal drugs, weapons, and contraband." This action is taken by having all students in classrooms and asking

students in randomly selected classrooms to step out into the hall while the canine roams the classroom to identify any bags or jackets that may have contraband in them. If a student's bag or jacket is hit on, they will be asked to the office so administration can conduct a search. The canine will also patrol lockers in the hallway and/or locker room and cars in the parking lot. Should contraband be found, school

administration will handle the situation per school policy.

Our hope for any canine visit is that we find zero contraband and that students and families can be reassured that we are doing our due diligence to protect our learning environment. Please feel free to reach out to your student's principal or myself should you have any further questions on this policy. We appreciate your support.

Chelan County PUD bids farewell to long-serving commissioners Congdon, Bolz

WENATCHEE - Friends and colleagues shared memories and fond farewells with two long-serving commissioners - Ann Congdon and Dennis Bolz - during their last board meeting December 20.

Commissioner Ann Congdon was elected to the commission 18 years ago. She was encouraged to run by family friend Jean Ludwick, the first woman in the state elected as a PUD commissioner.

"When I became commissioner, it was clear that Chelan PUD needed to earn back trust with our customer-owners," Congdon said. "As a board, one of the things we did right was hire the right general managers at the right time."

One of the longest-serving commissioners in PUD history, Congdon helped hire five general managers including Rich Riazzi, Steve Wright and Kirk Hudson. During her tenure, she worked alongside staff to reduce debt by nearly \$1 billion and position the PUD as one of the most financially stable utilities in the nation. She was a major proponent of a supported employment program at the PUD, which helps people with cognitive disabilities to develop job skills. She also joined other commissioners to adopt the PUD's vision of providing the best value

for the most people for the longest time.

"Of everything we've done, I feel really good that we worked hard and gained the trust of the community over time," she said. "My parting words to fellow commissioners is that we've got to do everything it takes to keep earning that trust. That means open communication,

a lot of outreach, and staying engaged in conversations around the community."

Commissioner Dennis Bolz championed many issues during his 16-year tenure on the board, including parks development, transparency, and fiscal responsibility. In 2019, he received the Lifetime Achievement Award from the Washington Public

Utility Districts Association in recognition of his long-standing work on behalf of public power.

"One of the things I'm most proud of is the transition in culture that we helped facilitate at Chelan PUD," Bolz said. "The five of us worked to create a tone at the com-

Cold weather tips from Chelan County PUD

WENATCHEE - When all you want for holidays is warmth, Chelan PUD has a few tips on how to keep your home cozy without cranking up the thermostat.

• Door socks: Place blankets or towels by the door to prevent the cold air from drafting in and the heat from escaping.

• Close the shades: Close your drapes to retain heat. If it's sunny during the day, open the drapes to capture warmth from the sun.

• Better air flow: Replace your air filter. Clogged filters make your heating system less efficient. Keep doors open in your house (unless you have baseboards or other zonal heat).

• Take AC units out: If you still have an AC unit in your window, remove it and close the window.

• Dress warmer or put an extra blanket on the bed. It's less expensive than turning up the heat.

• Close the damper: Fireplaces are designed to move heat quickly up the chimney. When you're not using it, keep it closed so it doesn't suck the heat out of your home.

• Lower your water heater temperature: Keep the water heater temperature at 125 degrees to conserve energy.

• Close foundation vents for winter. If your vents don't close, taping a piece of plastic on the outside will help considerably.

Residential Energy Efficiency Adviser Josh Mitchell cautions against switching heat pump systems to e-heat or auxiliary heat, which uses a lot more energy.

"If you have a heat pump, keep the thermostat to heat or auto mode," said residential energy advisor Josh Mitchell. "The thermostat is smart enough to tell your back-up heat to turn on when the heat pump can't keep up. Only turn the heat pump off during emergencies like when your defrost cycle stops working."

If you're concerned about water pipes freezing: Consider letting a cold-water

faucet drip continuously when the weather is at its coldest.

• Know the location of the water shut-off valve in your home. Check to make sure it works.

• Open cupboard doors under sinks, especially where plumbing is in outside walls, to let interior heat warm the pipes.

The electrical grid is working hard to keep everyone warm as temperatures dip into single digits. As the demand for electricity increases, so does stress on the equipment that delivers electricity. If the power goes out, check for updates on the new outage map: outages.chelanpud.org. If you don't see an outage on the map, call us 24/7 at 877-783-8123 to report it.

These tips can help keep you safe, and help PUD crews safely restore power as quickly as possible:

• Turn off all but one light – on the porch or inside where it can be seen from the street – so you and PUD crews know when power is restored.

• Never use fuel-burning devices, like gasoline-powered generators, gasoline-powered pressure washers, camp stoves and lanterns, or charcoal grills inside, or in any confined space, or within 10 feet of windows, doors, or other air intakes. Using these items in your home can produce carbon monoxide, which can be deadly. If you plan to use a portable generator, make sure you plug appliances directly into the generator. Or, make sure your home is disconnected from the PUD's electric system with a transfer switch installed by a licensed electrician.

• Prevent cold-load pickup: When power is restored after an outage, sometimes the pent-up electrical demand can overload the system and result in another outage. For the first two hours after power is restored, keep use of non-heating appliances to a minimum. DO NOT go near, touch or try to move any lines on the ground or trees tangled in them – stay far away and call the PUD at 877-783-8123 or 9-1-1 for help.

22 organizations to receive lodging tax dollars from Chelan County

WENATCHEE -- Chelan County commissioners awarded \$328,600 in lodging tax dollars to a variety of tourist-related organizations.

The awards come at the recommendation of the Chelan County Lodging Tax Advisory Committee (LTAC), which reviewed this year's applications and interviewed some of the finalists.

"We are especially excited to see some new applicants in this round of annual funding," said Tiffany Gering, Chelan County commissioner and LTAC chairman. "Because we had several good applications and tourist-generating projects, the committee also decided to award more money than we

originally budgeted – about \$50,000 more."

In 2023, 22 groups or non-profit agencies will receive a portion of the \$328,600 allocated in grants. They will use the money in a variety of efforts, from marketing and outreach to new and well-established festivals to museum exhibits and a youth baseball tournament.

- Icicle Creek Center for the Arts (\$15,000)
- Lake Chelan Arts Council (\$5,500)
- Lake Chelan Wine and Jazz (\$33,000)
- Lake Chelan Wine Alliance (\$30,000)
- Leavenworth Summer Theater (\$15,000)
- Leavenworth Village Voices (\$8,000)
- Manson Chamber pickleball tournament (\$15,000)
- Ohme Gardens (\$30,000)
- Stehekin Heritage guidebook (\$3,500)
- Upper Valley Historical Society (\$17,500)
- Wenatchee Arts Alliance (\$11,000)
- Wenatchee Chamber Rails and Ailes (\$5,000)
- Wenatchee Chamber La Terrezza (\$10,000)
- Wenatchee River Bluegrass Festival (\$15,000)
- Wenatchee Valley Museum (\$25,200)
- Wenatchee Youth Baseball tournament (\$15,000)

Overall, the county received 30 applications. Another call for applications related to tourism-related capital projects is expected this spring. The call for applications will be posted to the county's website: www.co.chelan.wa.us.

Lodging tax dollars are generated by local lodging establishments. In unincorporated Chelan County, about half the money generated in a year is allocated to six local chambers as well as Ohme Gardens, the Cascade Loop and TREAD. Another portion is used to operate the county's Visit Chelan County campaign. mission level to model a healthier balance for how people treated each other, with respect and dignity."

Bolz was also part of creat-

ing the Public Power Benefit program, which supports community-minded projects such as expanded access to fiber internet, parking passes at PUD-owned state parks, electric vehicle charging stations and more. His leadership has advanced

several PUD strategic plans, including critical decisions on rate design and economic development, guided by input from thousands of local customers.

"The public is important," Bolz said. "We had the courage to go forward because we took the time to hear what the public was thinking. It's been a great experience."

In other news, commissioners:

- Heard an update on the safety recommendations from an investigation at

Rock Island Dam in 2018. Most of the recommendations are complete, and three are in progress.

• Approved resolutions to support 2023 hatchery operations, and monitoring and evaluation activities pursuant to the Habitat Conservation Plans for Rocky Reach and Rock Island hydroelectric projects.

• Approved a resolution to authorize the general manager to negotiate the acquisition of Peshastin Water District.

Community Foundation of NCW awards \$412,000 in grants to NCW nonprofits

NCW - The Community Foundation of NCW has awarded \$412,000 through the Regional Impact Grant (RIG) program to 52 nonprofits across North Central Washington.

The RIG provides annual core operating support to eligible nonprofits in Chelan, Douglas, and Okanogan counties serving their community in a variety of ways - through access to the arts and cultural experiences, protecting the environment, building and maintaining recreation areas, improving health services, and programs that support our youth and seniors.

"The RIG is the largest grant opportunity for nonprofits in our region" said Beth Stipe, the foundation's executive director. "Over the years, we have continued to shape the grant program to best serve the needs

of our region and this round of grants really showcases the breadth of nonprofit work that our communities depend upon."

Often in philanthropy, the larger and more established organizations have a competitive edge in the grant process, but the Community Foundation strives to support a variety of nonprofits including smaller, volunteer-run organizations. This year the size of the grant award was based on the size of the organization which allowed the Trustees to focus on providing a balanced number of grant awards across budget sizes.

"We don't expect organizations to have professional grant writers on staff, so our Board is committed to connecting with every applicant through a site visit with a team at the Foundation to learn more about their work" said Claire Oatey, director of community grants, "We find this helps level the playing field and it's such a

rewarding experience to connect with these groups who are so passionate about making their community a better place for all."

The funding for the grants comes from unrestricted dollars gifted to the foundation and a portion of the fund management fees. "These grants wouldn't be possible without the generosity of people in our community who have left legacies to ensure the community they loved continues to be cared for and protected for future generations," said Stipe.

Follow these simple tips to keep you safe for winter weather:

- Stay informed of winter weather.
- Prepare your home by insulating walls, attics, and

pipes to avoid freezing during cold weather.

- Learn how to shut off water valves in case a water pipe bursts.
 - Gather supplies in case you need to stay home for several days without power.
 - If you have an emergency generator, follow the manufacturer's instructions.
 - Avoid using carbon monoxide producing appliances indoors to include lighting, heating, and cooking equipment. Proper ventilation and following manufacturer's instructions are key.
 - Create an emergency supply kit for your car and if possible, keep a full tank of gas.
 - If you have a fireplace or wood stove, store a good supply of dry, seasoned wood for back-up heating fuel.
 - When preparing, keep in mind each person's specific needs to include medication, and remember your pets need's too.
 - Create a home emergency supply kit to include rock salt, sand, and shovels, and include extra clothes.

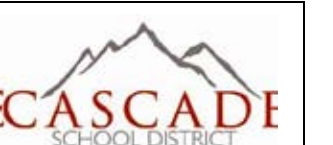

Americans Face Elevated Winter Power Outage Risks From Tight Fuel Supplies, Faltering Grid: Report

As the snow flies and temperatures plummet, regulatory agencies and analysts alike warn that residents in multiple U.S. states are at an elevated risk of dangerous winter blackouts.

States such as Texas and North Carolina, and also the Great Lakes and New England regions are in the highest risk category, according to a report from the North American Electric Reliability Council (NERC).

Meanwhile, a “large portion” of the U.S. power grid is at risk of insufficient electricity supplies during peak winter conditions, the agency concluded in the same analysis.

Although climate change advocates claim that severe weather events are the primary culprit, energy insiders say tight fuel supplies and an outdated electric grid play a critical role in potential blackouts.

Conservative estimates this year put the cost of critical power grid and infrastructure upgrades at \$4 trillion, with the use of supplemental nuclear power; the price tag jumps another \$500 million without nuclear energy.

The Biden administration approved a \$13 billion stopgap measure on Nov. 18 to “modernize and expand” the power grid. However, people in the energy industry say it will take months or years for U.S. residents to see the difference.

Falling Behind

“There is a significant gap to upgrade aging grid infrastructure to meet net-zero mandates and maintain reliability, and we are running out of time,” analyst Kim Getgen told The

Epoch Times.

Getgen is the CEO and founder of Innovation Force, which tackles complex issues such as America’s energy crisis. She says the Biden administration’s infrastructure investment is a good start, but it’s exactly that, just a start.

“Upgrading aging infrastructure, system hardening, and resilience measures while complying with the evolving set of new cyber and physical security threats will require even more investment,” Getgen said.

She added that the American Society of Civil Engineers gave the U.S. power grid a C- grade on its 2021 Infrastructure Report Card.

Getgen maintains that a greater level of investment is needed, saying, “we can’t maintain the millions of miles of distribution and transmission lines that deliver the power, and we can’t harness the potential of renewable clean power.”

And although upgrades are crucial, some energy specialists say the U.S. electrical grid won’t become efficient overnight, or even by next winter.

“It’s important to remember that something as complex as the electricity grid takes time to change,” Ted Kury, director of energy studies at the University of Florida, told The Epoch Times.

Working in the university’s Public Utility Research Center, Kury says the regulatory process for new utility projects moves slowly, no matter how much money is thrown at it.

“It’s a process with numerous safeguards, but that also means it takes more time. It’s reasonable to think that we’ll start seeing impacts in the next few years,” he said.

Eric Hendrick, senior consultant in risk management at Customized Energy Solutions, agreed with Kury’s assessment.

“Given the politics involved in any legislation, it’ll take some time before any of these funds trickle down to the states that need the funds,” Hendrick told The Epoch Times.

During a press statement, John Moura, the director of reliability assessment for NERC, said there are “more areas at risk” of blackouts this winter amid power generation and fuel supply challenges.

U.S. Secretary of Energy Jennifer Granholm also noted in a November brief that 70 percent of the nation’s power grid is more than 25 years old.

Grid upgrades aside, strained natural gas and coal supplies are also, quite literally, fueling higher power-outage risks.

Fuel Factor

Not only are millions of Americans facing a greater risk of losing power this winter, they’ll also be paying more for energy.

Homes that run on natural gas can expect to pay 28 percent more. For those using heating oil, a 27 percent price spike is expected, and a 10 percent increase is likely for households that rely on electricity alone for heat.

The increases are due to a combination of higher market prices and demand, according to an Energy Information Administration analysis.

And with the continued push toward Biden’s net-zero energy goals,

an additional 11,778 megawatts of coal generation was retired in 2022. Meanwhile, the demand burden has shifted heavily toward natural gas, which is already encountering supply issues.

“This problem will be difficult to address in the short term. ... Keep in mind gas storage is currently 89 BCF below last year’s level and 86 BCF below the five-year average,” Hendrick said.

He noted that low levels of natural gas storage and a lack of transportation infrastructure in the northeastern United States would likely create “volatile scenarios” with just 10 to 12 days of colder-than-normal weather.

Nevertheless, the Federal Energy Regulatory Commission predicts a 24 percent increase in net natural gas exports for the 2022–2023 withdrawal season.

And then there’s the coal conundrum. With fewer generating facilities and sporadic supply-chain disruptions in 2022, NERC asserts that coal has “limited stocks and resupply uncertainty” this winter.

Kury says 2021 saw a spike in coal consumption for electrical power. This year has seen an overall decrease in demand, but it doesn’t shore up with diminished reserves.

“It’s still impacting coal stockpiles at power plants,” Kury said.

“When you also consider that coal is delivered by rail, and rail transportation has been impacted by labor disputes, it reinforces the need to get more fuel to power plants.”

McCarthy to Support Revival of Holman Rule That Strengthens Congress Against Bureaucrats

House Minority Leader Kevin McCarthy (R-Calif.) has told Republican colleagues that if he’s elected Speaker of the House, he’ll support the restoration of a controversial legislative tool used by Congress to reduce or eliminate salaries for specific executive branch programs and employees.

Multiple congressional sources confirmed to The Epoch Times on Dec. 15 that McCarthy told members of the House Republican Conference on Dec. 14 that he will back reviving the rule, which could potentially strengthen congressional oversight.

McCarthy’s agreement on the Holman Rule appears to be a move in his continuing effort to gain sufficient support to be elected House speaker on Jan. 3, when the 118th Congress takes office.

There will be 222 Republicans in the House and 212 Democrats, so, assuming all members are present for the speaker vote, McCarthy must gain the votes of at least 218 House members. A dissident group led by Rep. Andy Biggs (R-Ariz.) claims to have enough votes to prevent a McCarthy speakership.

Members of the conservative House Freedom Caucus (HFC) have pushed for the rule’s return as a con-

dition of the 42-member group’s support for McCarthy’s bid to become speaker. However, McCarthy has balked at agreeing to another proposed rule change that would make it easier for an individual representative to force a new speaker election.

McCarthy has hinted recently that he might be agreeable to a modified rule requiring some number of House members to support the action rather than a lone lawmaker. Adoption of such a rule, even in a modified form, could significantly reduce the power of the speaker to enforce caucus discipline.

The Holman Rule was first adopted shortly before the Civil War and since then has had an on-again, off-again tenure. The previous House Republican majority, led by then-Speaker Paul Ryan (R-Wis.), brought the rule back in 2017 after it was rescinded by Speaker Thomas P. “Tip” O’Neill (D-Mass.) in 1983.

Congress has the “power of the purse” authority under Article 1 of the Constitution and can thus increase, decrease, or eliminate any federal spending if the Senate and House agree, but the president must also agree, so the rule’s application is rarely easy.

The Holman Rule provides an exception to the long-standing House

rule against including anything in appropriations legislation other than spending provisions.

The HFC contends that bringing the rule back is needed to put muscle in congressional oversight of the policies and programs of President Joe Biden.

“Congress has the tools in its arsenal to hold the Biden Administration accountable—if we activate them. Democrats eliminated the ‘Holman Rule’ when they took the House because it allows Members to make targeted spending cuts in appropriations funding bills by slashing the funding

of specific federal programs or cutting the salaries of individual federal employees (e.g., Dr. Anthony Fauci). Republicans must reimplement the Holman Rule,” the HFC stated in its rules change proposal.

Likely incoming House Committee on Oversight and Reform Chairman James Comer (R-Ky.) is enthusiastic about the prospect of potentially having the Holman Rule available to House Republicans.

“We have bureaucrats and agencies all over Washington, D.C. that are answering to no one. They’re trying to enact their own ideologies on the will of the private sector, on the will of the taxpayers, and they, thus far, haven’t been held accountable,” Comer told *Just the News*.

“That’ll give us the tools in the toolbox, when we do an appropriations bill, to actually pinpoint that particular employee of the federal government and erase their salary, cut their salary down or maybe lower it down to \$1. I don’t know what the exact rule will be, but make it very hard on them to where they’re basically no longer employed there. So that’s something that you have to have if you’re serious about providing oversight and actually holding people accountable.”

After House Republicans had the House majority and reinstated the Holman Rule in 2017, a half-dozen attempts were made to utilize it in the form of amendments to appropriations legislation, but all of the attempts failed.
