

Development fee increases coming Sept. 1 at Chelan County Public Works

WENATCHEE - Beginning Sept. 1, Chelan County Public Works will increase development fees that the department collects on permit applications.

Citizens will see increases in permit fees that are related to new driveways or approaches to county roads, new addresses, private road namings, work in the right-of-way requests and event applications. The new fees also will include Public Works' review for land use permits and road construction. The new fee schedule is available online.

The increases, which were approved by the Board of County Commissioners in July following a public hearing, are based off of the average time spent to process and review the permit applications, said Eric Pierson, Chelan County Public Works director and county engineer.

"The increases will cover about 75 percent of our costs associated with the applications, which include not only reviewing the applications but also field inspections, in some cases," Pierson said. "Unfortunately, at this time, we're recovering only about 30 percent of our costs. The last time we adjusted fees was in 2014."

Additional fee categories that were created with the increase in fees were missed in the 2014 adjustments, or are unique and needed to be separated out, Pierson added.

Chelan City Council votes on Apple Blossom Center Planned Development

CHELAN - The Chelan City Council at their Tuesday, August 23 meeting voted unanimously to adopt the hearing examiners recommendation concerning a major amendment to the Apple Blossom Center, Planning Development District (PDD). Council member John Olson made the motion, "I move to adopt the Hearing Examiner's findings, conclusions, and recommendations as the City Council's decision." The motion was seconded by Erin McCardle.

Before the council took a vote Erin McCardle reminded those in attendance that the council could only take into consideration those comments made before and during the public hearing which was held on June 14 before the City of Chelan's Hearing Examiner Andy Kottkamp. City of Chelan Planner John Ajax, read the proposed amendment to the packed and standing room only council chambers

at that meeting.

Council can take into consideration those letters and comments received after that hearing, when they work with the developer on the Developers Agreement.

Concerns, comments from the public have included water pressure, affordable housing is needed - but they don't like the size, how the quality of life will change; increase in crime, increase in traffic through the Suncrest development and in downtown Chelan, parking on the streets in the proposed development and downtown Chelan, the need for a traffic study, the need for another water reservoir in Chelan, the sewage treatment plant, concerns about evacuation of the area in case of a wildfire if round-a-bouts are put in; and concerns of no sidewalks along the highway to the area.

Future notice of Chelan City Council meeting(s) regarding final action on this application will be provided to parties of record at a later date; to be

determined.

Multifamily housing will be now allowed on up to a maximum of 30 acres within the existing 198 acre PDD boundary at a gross density of 24 units per acre, resulting in a maximum of 720 multifamily dwelling units. Gross density would allow individual projects to exceed 24 units an acre, resulting in a lower density for the remaining multi-family acreage. The project area is located at U.S. 97A, SR 150, Apple Blossom, Gala, Golden, Pinata; commonly known as "Apple Blossom Center," and the project applicant is Apple Blossom Center Holdings, LLC in Kirkland.

Council member Chris Baker encouraged residents to reach out to council members when they have a concern about something that is going on in the city.

The council also approved the distribution of \$26,658 of Recording fee Surcharge Funds and \$23,342 of HB 1406 State share revenues to Heritage Heights Assisted Living;

Devyn Walter, new Associate Planner was introduced to the council by Interim Community Development Director Luis Gonzalez and Servando Robledo announced his resignation from the council as he is moving out of the area.

Hawkins' sixth annual 'listening tour' begins in Chelan County Sept. 13-16

OLYMPIA — Sen. Brad Hawkins will soon hold his sixth annual 12th District "listening tour," starting with visits to several Chelan County communities for meetings in mid-September.

"As the state senator for the 12th District, it is very helpful for me to hear directly from constituents, which is why I started conducting annual listening tours," said Hawkins. "After meeting primarily via Zoom the past two years because of the pandemic, I'm pleased to resume in-person meetings for those wishing to meet face to face, although we will also make Zoom or phone meetings available."

This year's listening tour will be split between the traditional areas of the 12th District and the new western areas of the district resulting from the recent redrawing of the state's legislative district boundaries.

Hawkins begins his listening tour on Sept. 13 with stops in Cashmere and Leavenworth, followed by meetings in Wenatchee on Sept. 14-15 before concluding the Chelan County part of the tour with appointments in Chelan on Sept. 16. The meetings will be scheduled approximately 20 minutes apart to accommodate as many groups as possible. The first meeting each day will begin at 8 a.m. and the last will end at 5 p.m.

During past listening tours, meetings included businesses, local governments, and community groups.

All meetings are by appointment. Those interested in meeting with Hawkins should contact his office at brad.hawkins@leg.wa.gov or 360-688-8951.

Hawkins' staff will provide the necessary technical details to constituents who prefer to meet via Zoom or by phone.

Hawkins said his annual listening tour allows him to hear ideas and concerns that can be turned into successful legislative action.

"Leavenworth officials told me in 2017 about an issue about disposing of brush and yard clippings and worked with me to enact a new law in 2018 to address it," said Hawkins. "A funding request related to the Saddle Rock trail in Wenatchee became reality when it was included in the state capital budget four years ago, and a road paving project to a popular fishing location in Okanogan County was recently funded. Last year, a Methow Valley biochar demonstration project was funded for forest management purposes along with funding for renovations at the city of Wenatchee's Community Center utilized by Pinnacles Prep School. All of them were ideas discussed with constituents during past listening tours."

As in the past five years, Hawkins has invited legislative staff to join him on this year's tour, including his office staff, communications staff and issue specialists. "People appreciated us making these resources available to their communities, and it's good for our staff to hear directly from people about the issues of interest in our region," said Hawkins. "If we need to research concerns or begin developing ideas, we are ready to do that."

The remaining leg of the listening tour will take place Nov. 14-18 in the parts of the 12th District now in King and Snohomish counties.

Later, the Council focused more on housing needs, offering a revolving low interest loan fund to help first time home buyers make a down payment, so they could qualify for lower rate bank loans. Kathy Miller, Council President shared that "working with banks, realtors, churches and borrowers this program was a success, and all First Home Loan borrowers re-paid their loans".

The Council now enjoys meeting for about an hour each month to learn about the important needs of a wide variety of community organizations serving Chelan Val-

Confluence Health announces changes to naming of hospitals and other locations

WENATCHEE - Confluence Health announced this week

that it will be transitioning its naming conventions for its hospitals and other locations by summer of 2023 to increase clarity and allow for smoother services for patients. Though the name is changing, Confluence Health's commitment to care is not.

"It's important for patients to know that their doctors, medical professionals, and others they have come to know and trust are not changing," commented Glenn Adams, chief operations officer at Confluence Health. "The commitment to care and service that our communities have come to rely on remains the same."

The naming transition has its roots in the history of the organization and how it came to be known as Confluence Health. In Wenatchee's earlier history, there were several medical facilities independent of one another which evolved and changed in their relationships over the years. In 1940, Dr. L.M. Mares, Dr. A.G. Haug, and Dr. L.S. Smith founded the Wenatchee Valley Clinic. In 1974, Central Washington Deaconess Hospital and St. Anthony's Hospital merged to become Central Washington Health Services Association. Soon thereafter, St. Anthony's was renamed Rosewood Hos-

pital and

the facilities combined at the expanded Rosewood site under the name of Central Washington Hospital. In 2013, Wenatchee Valley Medical Center (now known as Wenatchee Valley Medical Group) and Central Washington Hospital affiliated under the name of Confluence Health, while keeping the legal name of Central Washington Health Services Association. Though now affiliated, the two hospitals continued to operate under separate licenses due to needs at the time of the affiliation.

Now, almost ten years later, the time has come for the affiliated organization to transition fully to a single entity name: Confluence Health. Leaving behind the name of Central Washington Health Services Association, Confluence Health will officially now do business as, and be legally known by, one name.

Additionally, the current two hospitals – Central Washington Hospital and Wenatchee Valley Hospital – will unite under a single hospital license, being known collectively as Confluence Health Hospital. To differentiate between the two locations, the current Central Washington Hospital will be referred to as Confluence Health Hospital Central Campus and

the current Wenatchee Valley Hospital will be referred to as Confluence Health Hospital Mares Campus. One hospital, two locations.

A few other changes will occur as well. In Omak and Moses Lake, the locations will now be referred to as campuses, specifically Confluence Health Omak Campus and Confluence Health Moses Lake Campus, to better reflect the locations' offerings. All other rural health clinics, such as those in Winthrop and Cashmere, will still be referred to as clinics.

"We believe our new names will be easier for our patients to understand and show that both hospital locations are part of a unified system," remarked Dr. Andrew Jones, CEO for Confluence Health. "We at Confluence Health are unified in our efforts to deliver safe, high-quality care in a compassionate and cost-effective manner, and are happy to now have a more unified naming convention which reflects this."



Obituaries are priced by the number of words and include one color photo and go online at no extra charge. Memorials are priced per column inch. Please call for cost. *Payment is due at the time of placement. *Exception: Chapels, funeral homes who have an account, can be billed. There is no charge for a Death Notice - information is limited.

Deadline is 4 p.m. on Friday - some exceptions may apply.

THE WASHINGTON OUTDOORS REPORT

Fishing round up

BY JOHN KRUSE, THE WASHINGTON OUTDOOR REPORT

SOCKEYE - It has been a banner year for sockeye salmon. Over 663,000 sockeye passed through Bonneville Dam this year, the largest run on record since they started counting salmon there in 1938. Most of them were bound for Canada but a sizable number of them took a left below Rocky Reach Dam and headed

to Lake Wenatchee. As of August 23, 110,514 sockeye had swam through the fish ladder near Leavenworth, besting the previous record run from 2014 by over 10,000 fish. Biologists believe favorable ocean conditions were the main reason so many sockeye came back this year.

Fishing Reports
COLUMBIA GORGE - Jaelyn Justesen at Gorge Outfitters Supple says the walleye bite is better than normal for this time of year. They are deep in the Columbia River.

The best way to catch them is with a spinner worm harness and bottom walker. Small-mouth bass are definitely biting and they are biting anything bright colored. Salmon are expected soon in the area. Anglers are gearing up with Short Bus 360 Pro Troll flashers and Brad's Super Baits which they are stuffing with tuna. Catch and release sturgeon fishing is going well and squid is the hot bait. www.gorgeoutfittersupply.com

LAKE ROOSEVELT - Steve Morris with SJM Guide Ser-

vice says the sturgeon fishing in Lake Roosevelt has been slow and he doesn't see it getting much better before it closes in September. Steve thinks the cold spring and cooler water temperatures have kept many of the fish north of the reservoir in Canada. Having said that, there are sturgeon scattered through Lake Roosevelt, just don't expect big numbers of fish. Steve will be heading to the Hanford Reach starting September 7 to target fall Chinook salmon and is expecting good fishing with this year's run over the 10-year average. www.sjmguideservice.com

LAKE CHELAN - Joe Heinen with Lake Chelan Adventures says Chinook salmon fishing on Lake Chelan has been good all summer long and he is averaging 3 take downs a day from these landlocked salmon. Heinen says numbers are way up and the bite has been very good with the average Chinook weighing 3 to 12 pounds. The lake trout bite has been consistent and clients are boating 8 to 15 fish in a four-hour trip in the lower basin. As for the kokanee, there are only a handful in the lower basin right now. The majority of the kokanee are migrating to the upper basin, staging to spawn in the Stehekin River this fall. www.lakechelanadventures.com

BREWSTER SALMON DERBY - The Brewster Salmon Derby was a smashing success this year. 250 anglers participated and they weighed in a total of 134 salmon. The average fish weighed just under 30 pounds. As for the King of the Pool? That was the 29.1-pound Chinook salmon caught by Mike Burnam from Yakima who won \$2,000. The winning Chinook in the Youth Division wasn't far behind, a 26.1-pound salmon reeled in by Katlynn Gibbons from Tonasket. She cashed a check for \$550. www.brewstersalmonderby.com



POTHOLES RESERVOIR - Nathan LaFrance at MarDon Resort says the channel catfish bite turned on in August and in recent days he has weighed in an 18 pounder, a 13 pounder and several catfish close to 10 pounds. Most folks are fishing cut bait at night while others are catching them while targeting walleye or bass. Two good areas are in front of O'Sullivan Dam as well as in front of Frenchman's Wasteway in the reservoir.

There are a couple of events coming up at MarDon Resort worth noting as well. One of them is the "Old Fart's Bass Tournament". Put on by the Banks Lake Bass Club, this one-day tournament launches out of MarDon Resort Saturday, September 17 and at least one person on each boat has to be over 40 years of age. Sign up for this one at www.bankslakebassclub.com.

The other tournament doesn't require a boat. It's the annual MarDon Resort Dock Tournament, happening Friday, September 16 and running through Sunday, September 18. You can fish day or night for up to ten different species off the resort docks in this derby, and the heaviest two fish from each species caught earns a cash prize. This is a popular event that fills up fast so you will want to register soon if you want to participate. www.mardonresort.com

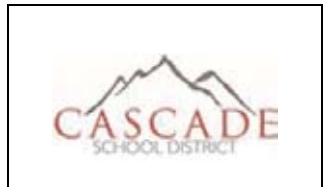

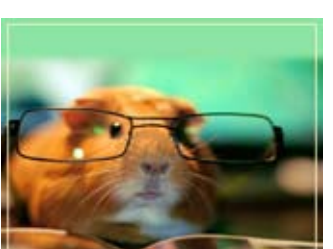

Consumers assume homeopathic products are 'natural' and cannot be harmful, but this is not always the case

Most consumers assume homeopathic products are "natural" and cannot be harmful, but this is not always true.

Homeopathy comes from the Greek word homoios, which means "similar." Homeopathic physicians believe diseases can be cured by giving a substance that causes similar symptoms in healthy people, just in tiny amounts.

In the late 1700s, the German physician and chemist Samuel Hahnemann developed homeopathy as an alternative to conventional medical remedies. Dr. Hahnemann was appalled by the treatments commonly prescribed in his day, such as repeated bloodletting, attaching leeches, and swallowing large doses of compounds containing lead, mercury, and arsenic.

Instead of using these toxic compounds, Dr. Hahnemann gave his patients minimal doses of one medicine at a time and watched how they reacted before giving them more. His patients often felt better and recovered faster than those treated with blood loss or poisonous metals. Homeopathy was born.

Traditional homeopathic remedies are small dissolvable tablets labeled with their active ingredient and the dilution, which is a number followed by an "x." A "1x" dilution is made by diluting one part of the original solution by adding 9 parts of water. The resulting liquid is dripped onto small sugar tablets.

A "2x" dilution is made by



driluting the original solution 2 times, using one part active ingredient solution to 9 parts water each time. This is repeated many times. Most traditional homeopathic remedies are dilutions of "100x", "1000x", or "10,000x", meaning that there are little to no molecules of active ingredient left in the product.

In the world of traditional homeopathy, the more diluted an agent is, the more effective it is considered to be. I find it hard to believe that medication can be helpful after diluting it 1000 times or more. You are left with only a few molecules in each sugar pill.

The belief that anything so diluted could not be harmful has led to minimal oversight or regulation of homeopathic products by the Food and Drug Administration (FDA).

In fact, according to the National Center for Complementary and Alternative Medicine (NCCAM), which is part of the National Institutes of Health (NIH), there is little scientific evidence to support using homeopathic remedies.

The FDA does not require homeopathic products to prove safety or efficacy. This allows the manufacturers of any homeopathic remedy containing active ingredients listed in the Homeopathic Pharmacopeia of the United States (HPUS) to skip the expense and oversight otherwise required by the FDA.

One example of this contradiction is Arnica. The FDA classifies Arnica as an unsafe herb when taken by mouth. Under FDA regulations, Arnica is available as an over-the-counter (OTC) homeopathic remedy for various indications in melt-under-the-tongue tablets.

The FDA has not addressed the lack of regulation of homeopathic remedies because it assumed they were too dilute to cause harm. Although that was probably true of homeopathic agents of 1,000x and 10,000x dilutions, some manufacturers market products as homeopathic with dilutions of 3x or 10x.

That was the case with Zicam®, a nose spray con-

taining zinc. It was initially marketed as a homeopathic cold remedy. However, unlike traditional homeopathic formulas, there was a significant amount of zinc in Zicam®. Soon after its introduction, The FDA started receiving reports of loss of smell after using Zicam®.

In 2009, the FDA issued a warning about Zicam®. It reported evidence of permanent loss of smell in some people with as little as one dose of Zicam®. The FDA eventually forced Zicam's® manufacturer to reduce its zinc concentration.

The FDA investigated when they received reports linking the use of Hyland's Teething Tablets® in infants with seizures, shortness of breath, tremors, and even death. They found highly inconsistent levels of the toxic compound belladonna, suggesting poor manufacturing practices.

Although the FDA has since issued several safety warnings on the dangers of homeopathic teething products, the manufacturer of Hyland's Teething Tablets has continued to sell the product as is. Unfortunately, the FDA has no authority to issue a mandatory recall, despite accumulating over 400 adverse event reports in children associated with Hyland's Teething Tablets®.

To address this, Congresswoman Rosa DeLauro from Connecticut introduced the Recall Unsafe Drugs Act on February 16, 2017. This bill would give the FDA mandatory recall authority over homeopathic products. DeLauro resubmitted it earlier this year as the Recall Unsafe Drugs Act of 2022, and it's now in the House's subcommittee on Health.

Homeopathic remedies can be sold in the United States without proving they are safe or effective. I suggest you avoid homeopathic products entirely or use them cautiously.

US Government Imposes First-of-Its-Kind Fee on Greenhouse Gas Emissions

Hidden deep within the more than 700 pages of the recently enacted Inflation Reduction Act (IRA) is a provision that intends to boost the Environmental Protection Agency's (EPA) power to regulate greenhouse gas emissions.

Specifically, the IRA establishes the "Methane Emission Reduction Program" under a new section in the Clean Air Act, allowing the EPA to impose a fee on certain "air pollutants."

Importantly, this is the first time the federal government has ever imposed a fee on any greenhouse gas (GHG) emissions and is part of Congress' effort to bolster the EPA's power to address the "climate crisis."

Congress Sends a Message

In June, the U.S. Supreme Court ruled in *West Virginia v. Environmental Protection Agency* that the EPA didn't have the authority under the Clean Air Act or the Clean Power Plan to essentially force power plants to transition more toward wind and solar.

Moreover, the court determined that the interpretive question raised under the Clean Power Plan fell under the "major questions doctrine," which states that Congress must make a "clear statement" if it wants to delegate authority "of this breadth to regulate a fundamental sector of the economy."

Notably, the ruling expressly limited the EPA's ability to regulate carbon emissions from power plants, which President Joe Biden called "devastating."

Biden further added that he planned to "find ways that we can, under federal law, continue protecting Americans from harmful pollution, including pollution that causes

climate change."

Enter the IRA and Congress' "clear statement" on what it wants the EPA to do.

Indeed, the Environmental Defense Fund (EDF) said Congress' passing of the IRA "modernized" the Clean Air Act and established the EPA's authority "to protect American families from climate and air pollution."

Additionally, via the IRA, Congress reaffirmed that GHGs are "air pollutants" and further specified that the term "greenhouse gas" includes the pollutants "carbon dioxide, hydrofluorocarbons, methane, nitrous oxide, perfluorocarbons, and sulfur hexafluoride."

"These new Clean Air Act sections and the new provisions that rely on the Clean Air Act reinvigorate EPA's responsibilities under the law addressing the climate crisis and longstanding inequities with new tools, new solutions, unprecedented investments, additional policies, and with great urgency," EDF concludes.

Incentives and Penalties

The IRA includes several tax credits, incentives, and grants, totaling \$369 billion for "Energy Security and Climate Change investments."

And the investments include more than \$1.5 billion to the EPA for "grants, rebates, contracts, loans" and "other activities" to reduce GHG emissions in the natural gas and oil sector.

But incentives aren't the only tool the IRA utilizes regarding the oil and gas sector.

According to a report from the Congressional Research Service (CRS), the Methane Emission Reduction Program applies to specific types of facilities that report their GHG emissions to the EPA's Greenhouse Gas Emission Reporting Program.

Specifically, the facilities that the charge applies to include:

"Offshore and onshore petroleum and natural gas production, onshore natural gas processing and transmission compression, underground natural gas storage, liquefied natural gas storage, liquefied natural gas imports and exports, onshore petroleum and natural gas gathering and boosting, and finally, onshore natural gas transmission pipelines."

In other words, the EPA now has the authority to impose charges on oil and gas power plants, fulfilling SCOTUS's requirement.

More importantly, facilities that fall under one or more of the above categories and exceed a specific methane threshold (thresholds vary by facility type) will have to pay \$900 per metric ton of methane starting in 2024.

In 2025, the charge increases to \$1,200, and in 2026 and beyond, the cost is \$1,500.

The Congressional Budget Office estimates, based on 2019 data, that the new fees will raise \$1.1 billion in fiscal year 2026, and almost \$1.9

billion by fiscal 2028. CBO projects revenues will decrease after that as facilities implement methane reduction strategies.

EPA Powers Up

Methane is the primary component of natural gas, and the EPA reports that methane emissions accounted for 11 percent of total U.S. GHG emissions in 2020. Carbon dioxide (CO₂) accounted for 79 percent.

However, methane is considered more "potent" than CO₂, with some experts putting its "climate change impact" at 25 to 72 times greater than the equivalent mass of CO₂. Consequently, reducing methane emissions is "one of the best opportunities for reducing near term [global] warming," CRS says.

Further, Biden made it clear that by 2030, he wants GHG emissions reduced by 40 percent compared to 2005 levels; reduction levels of that amount require significant transformation.

The IRA's passage and its implementation of a methane charge put Biden's goals within reach.

Indeed, the Department of Energy reports that because of the IRA, the United States will not only meet the 40 percent reduction goal but exceed it, as it now projects GHG emissions at 50 to 52 percent below 2005 levels.

According to the EPA, the primary source of methane emissions isn't natural gas or oil—it's livestock.

Biden's Push for Electric Vehicles Will Benefit China: House Republicans

The Chinese Communist Party will likely become the beneficiary of President Joe Biden's push to fill U.S. streets with electric vehicles, according to 16 Republicans on the House Oversight Committee.

The lawmakers, led by the committee's ranking Republican member, Rep. James Comer (R-Ky.), and Rep. Andy Biggs (R-Ariz.), sounded the alarm in an Aug. 24 letter to Transportation Secretary Pete Buttigieg. They wrote that Oversight Committee Republicans are examining "the false claims" made by the Biden administration about the impact of electric vehicles on U.S. jobs.

To rebuke the administration's claims, the lawmakers pointed out how Ford will cut about 8,000 jobs this summer to "boost profits to fund its push into the electric-vehicle market," citing a July article from Bloomberg.

"Most of the 8,000 jobs will be salaried workers in the United States, representing as much as 25 percent of Ford's American salaried workers," they wrote. "Ford is focusing on eliminating employees from its gas-fueled vehicle line."

Aside from the job cuts, Ford has turned to a Chinese supplier for bat-

tery packs. According to a statement from Ford's website, the U.S. automaker inked a cooperation agreement with China-based Contemporary Amperex Technology Co. Ltd. (CATL) in July. Under the terms of the agreement, CATL will supply electric batteries for certain models of Ford's electric pickup trucks and SUVs beginning in 2023.

CATL stated that its agreement with Ford allows the two firms to "leverage their respective strengths to jointly explore new business opportunities worldwide."

However, the lawmakers warned about CATL's ties to the Chinese communist regime.

"CATL is influential in the Chinese government—being able to independently draft government safety regulations while completely dominating the EV battery market with support from the Chinese government," they wrote.

CATL, the world's largest electric vehicle (EV) battery manufacturer, has obtained billions in subsidies from Chinese authorities, according to China's state-run media outlets. The company's chairman, Zeng Yuqun, is also a member of the Chinese People's Political Consultative Conference (CPPCC), a political advisory body.

The CPPCC is currently headed by Wang Yang, former Chinese vice premier and a current member of the Chinese regime's top decision-making body, the Politburo Standing Committee.

"This raises concerns about whether the push for EVs over gas-fueled vehicles will make America even more reliant on the Chinese Communist Party (CCP) instead of American energy resources," the lawmakers wrote. "It is troubling that the Administration-endorsed EV future is already eliminating American jobs while benefiting China."

In August 2021, Biden signed an executive order, with one of the goals being that half of all vehicles sold in the United States in 2030 be zero-transmission vehicles. In May, electric vehicles accounted for 6.1 percent of new cars sold in the United States.

The Inflation Reduction Act, legislation that Biden signed into law on Aug. 16, offers tax credits of up to \$7,500 for people buying a new electric vehicle and \$4,000 for those purchasing a used one. The tax relief program has been criticized by some Republican lawmakers as benefiting only wealthy Americans, given the higher cost of electric vehicles compared to gasoline models.

Also in their letter, the lawmakers questioned Buttigieg's statement during a congressional hearing in July, when he said the rise of U.S. domestic clean energy production would be "creating a lot of jobs."

"As the Secretary for the U.S. Department of Transportation (DOT) and an advocate for Americans' widespread adoption of EVs, your agency is in a position to explain how Ford's actions help American

workers and the economy," the letter reads.

The lawmakers wanted Buttigieg to schedule a briefing with Oversight Committee Republicans before Aug. 31.

"We request that you provide the Republican staff of the Committee a briefing to address the loss of American jobs and industry to China and other nations," the lawmakers wrote.
