## One rescued from Lake Chelan

CHELAN - On Saturday, June 10, at 11:02 p.m. Chelan Fire and Rescue was dispatched to a drowning near the "Old Chelan Bridge".

Initial dispatch reported two individuals in the water, one of which made it to shore and the other was reported missing.

Upon arrival, Chelan Fire and Rescue Swimmers along with the help of Chelan County Sheriffs located the missing individual holding onto one of the bridge pillars in the water. The individual was in distress and losing his grip on the bridge pillar.

One Rescue Swimmer entered the water retrieving the male subject bringing him to shore.

One patient was transported by Lake Chelan Health EMS and one patient went POV (private owned vehicle). Both patients were treated for a near drowning event.

## PUD cautions about higher spring water flows in the Chelan River

CHELAN - The Chelan River will flow faster and water levels will rise as Chelan PUD begins spring spill to manage Lake Chelan water levels. This year's spill began in June and will taper off around the end of July, but it can fluctuate at any time depending on weather conditions.

Please help Chelan PUD promote safety in local waterways: Stay on trails in the upper reaches of the Chelan River and abide by "no trespassing" signs in other areas, specifically in the Chelan River Gorge.

The Chelan Gorge is the narrow, rocky channel of the Chelan River, located in an area with limited cell phone coverage and hazardous terrain. Rescues are extremely difficult.

Changes in river flow can create hazardous conditions quickly and unpredictably, including higher water levels, fast currents, and potential entrapment. Chelan PUD has posted dozens of signs warning of the no-trespass areas for public safety.

## Customer-owners give Chelan PUD high marks for reliability, customer service

WENATCHEE - A lot has changed since 2020, but customer-owners remain steadfast in their satisfaction with service and communication from Chelan PUD.

About 89 percent of survey participants said they were satisfied to very satisfied with Chelan PUD overall. That's an increase from 86 percent in 2020. The margin of error is +/-4% with a confidence level of 95%.

"Your customers are giving you a very strong vote of confidence," said Alex Dunn, vice

president of research at Strategies360, the firm that conducted the survey.

The survey, performed every two years, helps the PUD assess customer sentiment and areas of community interest as it develops its programs and services for customer-owners. The results were presented to PUD commissioners today.

More than 600 people participated in the survey. They were contacted via landline, cell phone, email and text messaging from May 4 to May 10. The surveys represented a cross-section of customer-owners that spanned different generations,

ethnicities, and towns throughout Chelan County.

Customer-owners also expressed a desire for more mobile communication tools, including text and email alerts, and an online outage map. Chelan PUD published a preview of its new outage map at [chelanpud.org](http://chelanpud.org) last week, and plans are in the works to launch more customer communication tools in the next few years.

"Customer satisfaction is a key function for us as a publicly-owned utility," General Manager Kirk Hudson said. "I think it's clear that our customers' expectations are changing.

We're going to have to be very innovative to keep up with change. We know we have our work cut out for us, and we're up to the task."

## Chelan County's Cascade Public Infrastructure Fund grant opens

WENATCHEE - Chelan County seeks applications for funding from the Cascade Public Infrastructure Fund. The application period is open June 6 through July 15.

Applications will be accepted for public facilities projects, including permanently affordable housing, applied for by local governments, junior taxing districts (Regional Port Authority, P.U.D., Water and Sewer Districts, for example) or qualifying providers, such as authorities or housing trusts.

The Cascade Public Infra-

structure Fund, approved by the Chelan County Board of Commissioners in 2021, is a grant program for public facility projects serving economic development in Chelan County. The grant program does not impose a new tax on Chelan County citizens but is instead funded by existing revenues from the sales-and-use tax for public facilities in rural counties, or the Rural Counties Tax.

New this year, Sen. Brad Hawkins sponsored legislation to expand the use of these funds to include projects that supported permanently affordable housing. The legislation passed and was signed into law in

March, allowing Chelan County to consider applications from housing authorities or housing trusts. The expansion of the definition "public facilities" to include "affordable workforce housing infrastructure or facilities," in Sen. Hawkins' legislation, was prompted by the community's critical housing shortage.

"Inadequate housing stock directly impacts economic development when businesses cannot recruit or retain employees because they cannot afford the housing available in this region," said Sasha Sleiman, Chelan County's interim Economic Development

director and Housing Program coordinator.

Between 2021 and 2023, the CPIF plans to invest nearly \$2.5 million into economic development projects in Chelan County. In 2021, the Chelan County Board of County Commissioners awarded nearly \$740,000 in CPIF funds to six local agencies. The total amount of funding available for 2022 is \$823,200.

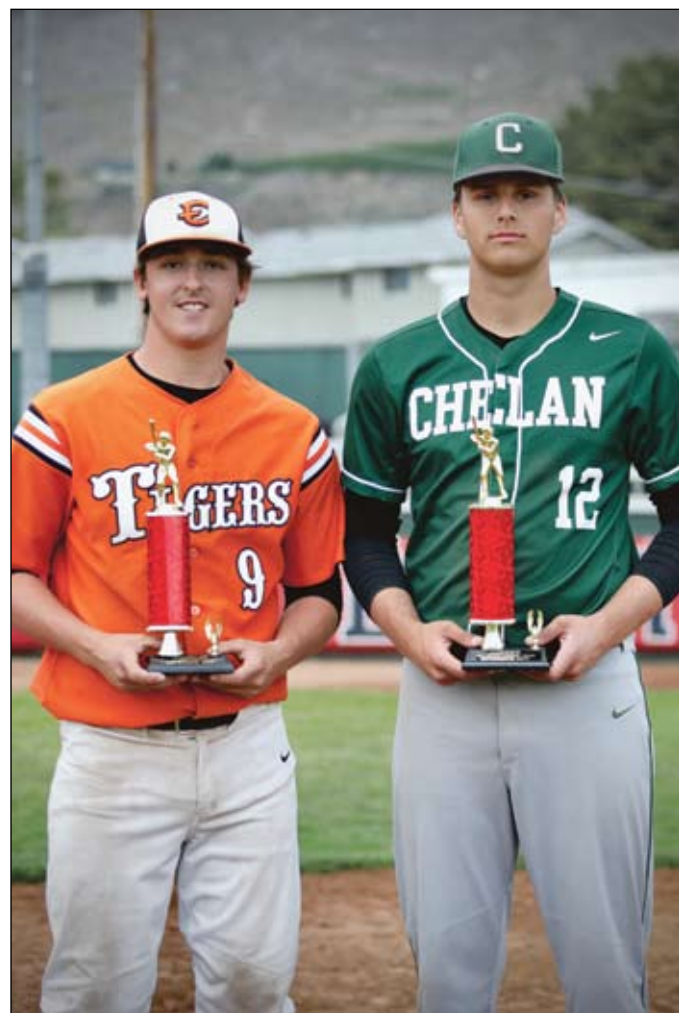
The Offensive MVP was Reed Stamps of Chelan who went two-for-two at the plate with three RBIs, a double and two runs scored.

# Teegan Silva the chaser, became the chased, sets standards for Chelan High School program

CHELAN - Running and racing are two separate entities. While the second encompasses the first, a racer requires something particular: another racer. Inevitably, one racer will pace the others. That's the tenacious tango of running: the chased and the chasers.

For three years, Teegan Silva acted the chaser. She always set her sights on the runners ahead of her. During her final track and field season, the senior star became the chased, setting the standards for a Chelan High School program with a longstanding pedigree. In her harrier swan song, Silva finished seventh in the 800 meter race at the 2022 Washington Interscholastic Activities Association 1B, 2B, 1A Track and Field Championship held May 27 at Eastern Washington University's Roos Field in Cheney.

"Teegan's an athlete who wants to race the best of the best to push herself," Chelan head coach Christopher Alexander said. "That's what was challenging to her this year, for her to be that person that everyone's trying to get to. For the last three years, she's always been that person who's trying to get to the best, and follow the best, and be in the

same distance as the best."

Now, she's the best.

After years of chasing, she became the leader, the runner everyone else wanted to beat. With no one to chase during most races, Silva saw her times began to dip. Her solution? She asked Alexander to let her race the boys in a few track meets. As a result, her times improved. Now, the curtain has recently closed on Silva's Goat career in which she's earned four varsity letters in both track and cross-county, 1st-Team All-Conference in the Caribou

Trail League, and four State appearances. Her long career allowed her to mature into a new role on the team and a new mindset as a runner.

"For every athlete in distance running, they're always chasing sophomore and junior year. And senior year it's a whole different mindset and that's where the growth mindset of good athletes comes in and they have to be able to switch that and train to be that leader now," Alexander said. "And I think that she's taken that on very well."

Yet the desire for greatness

has not led to runner's pride. Alexander describes her as quiet but confident.

"At practice she's always pushing herself and she's pushing everybody that's running with her because of leading by example," Alexander said, touting Silva's character and morals. "She's always the person who's in the lead. She's not a real vocal leader. She leads by example."

Megan Ellis is one of Chelan's assistant coaches who, along with longtime CHS fixture Mark Anderson, worked with Silva during her four

years with the Goats. Ellis described Silva as the consummate teammate who always sought to help others. Sometimes that came in the form of cheerleading. Ellis recalled a Chelan athlete who always performed a little better when Silva cheered for her.

Ellis also reiterated Alexander's description of Silva as an exemplar. The senior never complained about a workout and went all-in during every practice. She also communicated the workout location to teammates who either were unaware or didn't want to ask a coach. For teammates who did not have their own transportation, she would drive them to practice.

"Teegan is friendly, easy to get along with, hardworking, and respectful," Ellis said. "She is always encouraging her teammates to do their best at every practice and meet and almost always has a smile on her face."

The runner's quiet leadership and dedication caused Alexander to name Silva a team captain before season without having a vote. Though his choice was somewhat unprecedented, Alexander knew the team would approve of his appointment.

"Her teammates look to her for comfort. They just want to be around Teegan," he said.

"Just because she's quiet, that doesn't mean anything. It's her energy, the respect she has around our community and the respect around our team. It was a no-brainer to have her as one of our captains right away."

Though humble and hardworking, Silva remained fiercely competitive. In the hours before the race, she was quiet but relaxed, thoughtful yet determined. Alexander and Ellis describe her as coachable and someone who trusts the Goats' program.

Silva's running days will continue in the Last Frontier State. This coming fall she will run cross country for the University of Alaska Fairbanks on a partial athletic and academic scholarship. A 4.0 student, she will study geoscience at UAF which features a renowned outdoor laboratory. Wherever the track of life takes her, Silva's kindness, humility and hunger will allow her to hit her stride.

"Even if Teegan was the fastest runner in the state she would not settle but would continue to push herself to run faster," Ellis said. "She also is self-reflective on her performance and in tune with what she needs to do to improve."

**With their careers coming to a close, the Entiat seniors gathered with parents and coaches on Senior Night.**

ENTIAT - The most ancient athletic events in human history belong to track

and field. Based on that very moniker, these competitions take place on both—wait for it—a track and a field. Yet during practice, the Entiat squad enjoys only the latter

half of the sports' name. Lacking a track at school, all Tiger runners simulate their events on a grassy field. Despite its disadvantages and humble re-beginnings, Entiat's track and field program sent at least one athlete to the State tournament each year from 2005-2021.

"Our kids work so hard and have always done really well with what they have to work with. They never complain," EHS head coach Erika Ward said, citing the football field on which her athletes practice. "It's a horrible ground to run on. When it rains it gets pretty slick. We have kids go around the corner and they wipe out."

Like the mythological phoenix, EHS track and field became reborn in 2003 after lying dormant for about a decade. Julie Cannon served as head coach that first season up to her retirement last year. At the time, tennis, baseball and softball were all the rage at Entiat. This left very few students for Cannon to recruit. Ultimately, seven kids signed up for the team. Among that septet was a young junior runner named Erika Griffith. Little did she know, but that challenging first season served as the stepping stone of her journey toward head coach.

During that first year, Tiger

track faced a myriad of challenges. Entiat only had two shoddy hurdles in its inventory. Ward's father constructed hurdles out of PVC pipe so that the runners could better practice. The throwers also lacked proper facilities.

"We really didn't have any equipment," Cannon recalled. "We went to Cashmere so we could long jump and high jump and actually run on a track."

During practice John Barnes, the father of one of the Tiger athletes, watched the budding athletes from the stands. A former thrower himself, he felt called to support the cause.

"I just couldn't stand seeing some throwers without much coaching," Barnes said. "I asked if I could help out with (Cannon) a little bit and she said, 'Yeah, come every day if you want.'"

The next year, Barnes joined as a full-time assistant. With each passing season, the Tigers team grew. Eventually the baseball and fastpitch teams faded away due to lack of athletes, so track and field received an influx of participants. The team's equipment inventory slowly improved as well. Now, the Tigers have built pits for shot put, discus and long jump/triple jump. The high jumpers now have mats. The pits finally have sand rather than dirt which tends to harden quickly. The current roster includes about 21 athletes and has peaked at 30 competitors.

In 2015, Ward returned as an assistant coach

focusing on hurdles, long jump and triple jump. Remembering how the team started, Ward felt awed.

"It was impressive coming back and saying, 'Holy Cow, you actually have people,'" Ward recalled.

After the 2021 season, Cannon and Barnes officially retired, handing the baton to Ward. Despite the program's growth, challenges remain. Entiat still has no track, so coaches set up hurdles around the field and have to measure the distances. Even though the hurdles stand at the same height, the ground makes them look uneven. The long jump runway has been cracking and falling apart. Every year, coaches have to paint lines so the jumpers know where to start.

Ward feels hidden advantages may exist from practicing on the fields. While running on grass in practice, the hurdlers can barely three-step the barriers because their feet stick to the lawn. Grass tends to slow runners down, so when the athletes hit the track, they feel faster.

"I've always told them, 'When you go to a meet, treat this as a practice as well, because you're actually getting the chance to run on a track. Work on something. Do it. Push yourself because this is where you're going to get better,'" Ward said.

Ward would love to have proper facilities and longs for a track for Entiat. In the meantime, she sets a positive example for her athletes and

pushes them to avoid complacency. For years, Cannon and Barnes told Ward that she was the chosen one to take over for them. Though Ward felt hesitant, her former coaches turned colleagues placed trust in her which has paid dividends.

"Entiat is very lucky to have Erika. She's passionate for the sport. She's a coach," Barnes said. "She loves the kids. She's firm when she needs to be firm and gentle when she needs to be gentle, which is always a challenge."

While coaches navigate the ship, Ward, Cannon and Barnes all know the program's success rests on their resilient athletes' shoulders.

"It's been the kids. It's been the athletes that we've had that were willing to work, that were willing to put up with facilities that weren't great and how to use that to our advantage," Cannon said.

Sometimes at meets while watching her athletes, Ward catches herself being grateful for the heartiness and dedication of the track team without a track.

"It's really fun to see because they do have a passion for it and it would be very, very easy for them to say, 'Well, every time I jump on the high jump mat, stuff flies in my face and I have to jump with my eyes closed,' or 'The hurdles are uneven on the grass,'" she said. "They could easily say, 'This sucks. I don't want to do this,' and move on, but they love it. They have the same love for it that I do and it's just fun to watch."
