

All this moving during her adolescence instilled a spirit of independence in Pat. This, together with her strong work ethic and being a prodigious reader, made Pat a stellar student. Pat graduated from Wenatchee High School at age 17 and went on to earn a degree in Library Science from the University of Washington. She returned to Wenatchee where she used her knowledge and love of books to work as a librarian for what is now the North Central Washington Regional Library. Always fond of adventure, Pat's favorite part of the job was journeying to the remote libraries of Lake Wenatchee, Holden Village, and Stehekin to replenish their books and publications.

Pat found a kindred spirit in Paul Tift, a local mechanic and stock car racer. Paul and Pat married in Coeur d'Alene, Idaho, in 1956, and after a few years of hard work and saving money, the two purchased land on Brewster Flat in Okanogan County, so they could realize their dream of orcharding. After planting their first Golden Delicious trees in 1959, Paul and Pat moved to Brewster with their two young children. Pat was an energetic mother who instilled a sense of independence in her children at a young age, allowing them to ride alone around the many orchards and hide aways of the area on either motorcycle or horseback. She led by example teaching them to enjoy literature, good food, music, travel, and lively discussions.

She was known for always having a book by her side, her sharp wit, delicious pies, and beautiful handknit gifts; personalized Christmas stockings were a favorite. 

"We are extremely pleased with our move to Manson and purchase of Chelan Ridge Winery, Candace declared. The people are amazing in this down-to-earth community. Welcoming, friendly and supportive are just a few of the reasons we love it here. Add the weather and beauty, what took us so long."

I asked Candace if they had discussed owning a winery in the past. "Once he retired, I knew Bill was going to be looking for something to do. He's not the kind that can sit and watch the world go by. He enjoys wine, and being a lifelong learner, the wine business was interesting and a challenge, which he needed. Once we moved to Manson in 2015, Bill got his first taste of the winery business serving as Regional Marketing Director for Mellisoni Vineyards, located on the south shore of Lake Chelan. 

# China's Killing of Prisoners of Conscience for Their Organs a 'Tool of Genocide': Rep. Smith

The Chinese communist regime's mass killing of prisoners of conscience for their organs is a "tool of genocide," according to Rep. Chris Smith (R-N.J.).

Beijing's forced organ harvesting involves "the execution of people declared enemies of the state, as if on order to provide certain organs to meet transplant needs," he said. "This is also an apparent form of punishment, and indeed a tool of genocide meant to cull minority populations deemed 'undesirable' by the state."

Smith made the remarks at a May 12 hearing of the House's Tom Lantos Human Rights Commission to explore evidence of China's organ harvesting. The Republican from New Jersey is a co-chair of the commission.

A 2019 independent panel found "beyond a reasonable doubt" that the Chinese regime has for years been forcibly harvesting the organs from detained prisoners of conscience on a significant scale, with no signs showing that the practice had stopped. The primary victims are detained Falun Gong practitioners, the tribunal found. It also found that the practice amounted to "crimes against humanity."

Falun Gong is a spiritual practice consisting of meditative exercises and moral teaching centered on the tenets of truthfulness, compassion, and tolerance. After it became widely popular in China in the 1990s, the communist regime, perceiving that popularity to be a threat, began a nationwide persecution targeting the practice and its adherents. Millions of practitioners have since been held in detention centers, jails, and labor camps across the country, effectively turning them into a living organ bank for the Chinese regime.

Smith also urged Congress to approve his legislation seeking to punish those involved in China's forced organ harvesting trade.

He said the proposal, the Stop Forced Organ Harvesting Act (H.R. 1592), would impose sanctions against known perpetrators such as Chinese officials, prohibit surgery devices proved to be used for forced organ harvesting from being exported from China, and require the State Department to report on these measures.

#### Chilling Details

At the hearing, Ethan Gutmann, China studies research fellow at the Victims of Communism Memorial Foundation and author of "The Slaughter," recounted his interviews with victims

who were jailed in concentration camps in China. The people shared strange and chilling details that he said were signs that they were a living pool of involuntary organ donors.

"Following a camp-wide health check, including comprehensive blood tests, certain individuals are cross-matched for organ harvesting," Gutmann said, recounting how Sayragul, a teacher in a camp, told him she had printouts for the blood tests on which "a pink checkmark" was manually added to certain names.

"Other witnesses recalled that certain individuals were forced to wear colored bracelets or vests, sometimes pink, sometimes orange," he said. "Either way, approximately a week after the test, the color-coded individuals vanished in the middle of the night."

Gutmann noted that "witness testimony from approximately 20 camps is strikingly consistent—between 2.5

percent to 5 percent annual disappearances from the entire camp."

These disappearances, he said, are predominantly of people in the 28-year-old age group, which is "deemed the ideal age for organ ripeness by the Chinese medical establishment."

Adding to the testimony was a regretful recount by Dr. Enver Tohti, a former oncology surgeon who the Chinese regime ordered to carry out the first known case of live organ harvesting, in 1994. Tohti was made to extract the organs of a prisoner who had purportedly just been executed, only to discover on the operating table that the man was still alive.

"The whole operation took around 30 to 40 minutes. Chief surgeons happily put those organs into a weird looking box, and said, 'OK, now you take your team back to hospital; remember nothing happened today," Tohti testified.

The hearing came weeks after re-

searchers published a paper in the American Journal of Transplantation that reviewed more than 2,800 Chinese-language articles from between 1980 and 2015, and concluded that Chinese transplant surgeons forcibly removed organs from people without performing tests required to determine brain death.

"In plain language, the papers appear to show that the donors, who were prisoners, were alive at the time of surgery, and were killed by the transplant surgeons in the process of heart extraction," Matthew Robertson, co-author of the transplant paper and a doctoral candidate at the Australian National University, testified at the hearing.

#### **More Action**

Others at the hearing called for more action from the international community and medical entities.

"The topic for today's hearing, organ harvesting, has far too long been swept under the rug by the international community," said Rep. Gus Bilirakis (R-Fla.), who is a co-sponsor of the Stop Forced Organ Harvesting Act.

"The United States and our allies must send a strong and unwavering message in defense of basic human rights and protections for all people."

Last week, the European Union approved a resolution voicing "serious concerns" about the Chinese regime's "crime against humanity."

"Respect for human rights is not an option, but a requirement in all areas, including in the challenging medical and ethical area of organ donation and transplantation," said the EU's top foreign policy official, Josep Borrell.

The medical community, meanwhile, has been largely silent on this issue because of significant professional and financial opportunities in China, Gutmann said.

"This catastrophe was created by Beijing. Yet, for the last 10 years, it has been continuously enabled by a handful of Western doctors who thought they could ride the Chinese dragon and come back home as if everything was normal," he said.

Robert A. Destro, former assistant secretary for democracy, human rights, and labor during the Trump administration, urged the United States to take concrete action.

Congress must use its "power of the purse to demand accountability from the bureaucracy and the business community."

# US Baby Formula Shortage Worsens As Families Panic

The baby formula shortage is intensifying in the United States, according to new Datasembly numbers.

The retail information provider reported that out-of-stock (OOS) rates continue to climb nationwide, rising to 43 percent in the week ending May 8. This is up from the 30 to 40 percent readings in April.

"Unfortunately, baby formula outof-stock levels have continued to soar since the beginning of April, and we see no indication of a slowdown," Ben Reich, CEO of Datasembly, told The Epoch Times. "Baby formula out-ofstock levels have reached 43 percent nationwide and continue demonstrating higher out-of-stock levels than other categories."

Data as of May 1 show that nine states have OOS rates above 50 percent, including Tennessee (54.7 percent), Delaware (54.5 percent), Texas (52 percent), Montana (51 percent), and Nevada (51 percent). Jurisdictions with the lowest OOS rates were Colorado (26.3 percent), New Mexico (29 percent), and Indiana (29.7 percent).

Across the United States, multiple retailers including CVS, Kroger, Target, and Walgreens, have applied limits on purchases of infant formula.

Last month, CVS limited in-store and online purchases of baby formula to three per order. Kroger installed a limit of four products per customer. Target and Walgreens have maintained restrictions for several weeks.

Media reports suggest that some parents are responding to the shortages by producing their own, watering down current supplies, and rationing formula.

The FDA has discouraged parents from making formula at home due to "very serious health concerns" for babies.

"The potential problems associated with errors in selecting and combining the ingredients for the formula are very serious and range from severe nutritional imbalances to unsafe products that can harm infants," the agency noted.

Health experts warn that too much water for infants under six months could trigger seizures and brain swelling and dilute the calories.

As of 2018, four companies control close to 90 percent of the market: Abbott, Reckitt Benckiser, Nestlé, and Perrigo.

## How Did This Formula Crisis Begin?

Earlier this year, Abbott Laboratories, a leading baby formula maker, recalled products sold under the Alimentum, EleCare, and Similac brands that were produced at a Michigan facility. Four children had become sick with bacterial infections, resulting in two deaths. This prompted public health authorities to encourage shoppers to avoid buying formulas tied to the plant, although Abbott doesn't believe there is a link between these illnesses and its formulas.

In addition to Abbott's recall, the baby formula shortage has been exacerbated by global supply chain snafus, the shifts in pandemic-related consumer patterns, and soaring price inflation worldwide.

At the beginning of the COVID-19 public health crisis, many parents hoarded containers of baby formula much in the same way consumers accumulated large amounts of toilet paper and paper towels.

In 2021, manufacturers noticed that demand had been sliding. They responded by curbing production. Today, infant formula demand is surging once again as shortage fears grow and breastfeeding rates fall.

According to the Centers for Disease Control and Prevention (CDC), only one-quarter of babies born in 2018 were breastfed exclusively in their first six months.

In recent years, the prevalence of breastmilk substitutes has been a source of controversy among public health experts.

"The promotion of commercial milk formulas should have been ter-

minated decades ago," said Dr. Francesco Branca, director of the WHO Nutrition and Food Safety Department, in a statement last month. "The fact that formula milk companies are now employing even more powerful and insidious marketing techniques to drive up their sales is inexcusable and must be stopped."

The global formula milk industry is now worth \$55 billion.

Meanwhile, Abbott announced that it will work closely with the FDA to restart operations within two weeks. The company projects that it could take six to eight weeks to get its products back on store shelves.

#### 'Life and Death'

The U.S. government has been scrambling to resolve the issue.

President Joe Biden met with infant formula manufacturers and retailers

on May 12 to gather updates on intensifying shortages across the country.

Following the meeting, the president announced additional steps to address the issue to get more infant formula on store shelves faster, including reducing red tape and boosting supply through increased imports. In addition, he urged the Federal Trade Commission and state attorneys general to tighten down on any infant formula price gouging.

Earlier, more than 100 House Republicans urged the administration and the FDA in a letter to release data on the nationwide shortages and provide specific details on how they plan to address the issue.

"This issue is a matter of life and death, and it is time this administration treats it with the appropriate urgency it deserves," the 106 Republican lawmakers wrote.

Rep. Elise Stefanik (R-N.Y.) says this is an example of Biden's "failed leader-ship," adding that the FDA didn't have a plan to figure out how to address the supply chain crisis aspect of baby formula manufacturing.

"But it even goes back earlier than that, as a result of just the labor shortage in this country, the lack of accessing basic materials that are part of the manufacturing process," she told the host of NTD's "Capitol Report," Steve Lance. "But what's really struck me is the sheer incompetence of Joe Biden and House Democrats and frankly, failure to address any aspect of this."

FDA Commissioner Robert Califf assured the public that "we are doing everything in our power to ensure there is adequate product available where and when they need it."

# Guilty Verdict in First Illegal Alien Trespass Trial in Texas

BRACKETTVILLE, Texas—The first jury trial under Texas's Operation Lone Star border program wrapped up in Kinney County, Texas, on May 9.

The defendant, Honduran native Lester Hidalgo Aguilar, was found guilty of criminal trespass on a local ranch and sentenced to the maximum jail time of one year. The judge declined to apply an accompanying fine, which could have been up to \$4,000, but said Aguilar should pay court costs (\$290).

Aguilar's trial was a litmus test for the Operation Lone Star arrests, which began around August last year as Gov. Greg Abbott directed state troopers to arrest trespassers on state or private land.

Until now, almost all defendants

have pleaded guilty or no contest to trespass or other misdemeanor charges, and have reached a plea deal of time served and no fine.

Aguilar's trespass charge was enhanced to a Class B misdemeanor as he was found beyond 100 feet inside the property line of an agricultural operation, then elevated to a Class A as the crime occurred during a declared state disaster.

Most of the Operation Lone Star arrests have taken place in Kinney County, with ranchers and landowners increasingly finding cut fences, broken water troughs, and other property damage as scores of illegal immigrants have traversed their land to avoid law enforcement.

The Del Rio border sector, in which Kinney County sits, is consistently one of the highest regions for illegal immigrant "gotaways"—

those who are detected by Border Patrol but evade capture.

In April, preliminary numbers from Customs and Border Protection revealed more than 16,000 gotaways in the Del Rio sector.

Those gotaways either coordinate with smugglers to drive them to San Antonio or Houston, or walk through private ranchland until they're clear of the Border Patrol highway checkpoints, then arrange for transport.

Cheryl Gabler Tomlin, upon whose family ranch Aguilar was arrested, testified at the trial, saying the property is fully fenced and no one was authorized to enter the property, where she raises cattle and goats.

After the trial, she told The Epoch Times she was satisfied with the outcome. "I thought he would get off. I'm happy," she said as she left the courtroom. Tomlin said her life has changed considerably in the past year and a half as more illegal aliens encroach on her land. She recalled one of her scariest moments when she was opening a fence to let her horses out while still astride her ATV. A man appeared, and she said he whispered, "Don't tell, don't tell," and leapt over the fence toward her ATV.

She hit the gas, and he struck the side of the ATV and fell down. She waved down Border Patrol agents who were down the road looking for him. The agents arrested the man and later told her he was a five-time aggravated assault felon from Honduras.

"I have a gun all the time now," Tomlin said.

#### Big Trial for Small Town

Texas Department of Public Safety (DPS) Sgt. Ryan Glenn, who super-

vises the tracking and arrest teams in the local area, testified that the priority for his teams is to protect local property owners.

"We met with local landowners and asked who should be here and who shouldn't," Glenn said. He said DPS uses surveillance cameras, drones, and communication with landowners and Border Patrol to help apprehend trespassers.

Defense lawyer Bryan Owens appealed to the jury for a not guilty verdict, saying the state didn't meet the burden-of-proof threshold.

"Your verdict today won't change anything about the border situation," he said. "A guilty verdict is not going to deter even one person from trying to cross the border. This is about trespass."

Prosecuting lawyer Tony Hackebeil suggested the jury "send a message" with a guilty verdict.

"You folks live in this community. I would say this is a good time to send a message ... that the people of Kinney County do not tolerate people trespassing in our county," Hackebeil said.

The jury took less than 20 minutes to find Aguilar guilty.

Aguilar chose to allow state District Judge Roland Andrade to sentence him, rather than the jury—which was subsequently allowed to go home—and Aguilar took the stand to appeal for a light sentence.

He said his parents brought him to Florida at age 6, where he later graduated from high school.

Aguilar admitted to a criminal history that includes a 1996 shoplifting charge in Omaha, Nebraska, buying cocaine in California in 2002, and conducting a home invasion in Florida in 1999.

After being jailed in California, Aguilar was extradited to Florida to face the earlier home invasion charge. Upon his release, he opted to voluntarily return to Honduras rather than take an extended probation period. He later moved to Mexico but said cartels were targeting him, so he crossed the U.S. border.

He said he hasn't made any attempts throughout the years to enter the United States legally.

At its conclusion, Aguilar said he was happy with the trial.

"I'm still grateful. Everything's OK. There's tough feelings from the community," he told The Epoch Times. With eight months served since his arrest on Sept. 13, 2021, he has four months to go.

# Lawsuit Seeks Documents on Biden 'Climate Disinformation' Push

A nonprofit is suing the White House Office of Science and Technology Policy (OSTP) to obtain records that it argues "will inform the public of highprofile ethics revelations at OSTP and media coverage thereof," including correspondence related to an OSTP event on "climate disinformation."

In a lawsuit filed on May 5 in the D.C. District Court, Energy Policy Advocates (EPA) stated that it asked OSTP to provide correspondence and other documents it requested under the Freedom of Information Act (FOIA). Those records include materials that the nonprofit says were produced for Politico's Alex Thompson and discussed in Thompson's article on billionaire Eric Schmidt's influence over the Biden administration's OSTP. According to EPA, OSTP's only

response was a request for a minor formatting change.

"OSTP's failure to simply turn over what it has already processed and produced to another party is inexplicable, at least outside of the White House. There literally is no excuse," Matthew Hardin, a member of the EPA's board, told The Epoch Times in an email.

Politico declined to comment on the complaint.

EPA is also seeking emails connected with OSTP's February event on climate "denialism and delay," which featured such speakers as Michael Mann.

Hardin characterized that roundtable as "more of a strange than sinister

misuse of taxpayer resources, in seeking a social-science answer for why people continue to stand in their way."

Specifically, EPA requested correspondence related to the event between former OSTP Director Eric Lander and Jane Lubchenco, who's serving as OSTP's first deputy director of climate and environment.

Lander, a mathematician and geneticist who leads the Broad Institute of MIT and Harvard, resigned from OSTP in February after admitting that he bullied his subordinates within the agency.

Lubchenco, a marine biologist at Oregon State University who also belongs to the OSTP's new Scientific Integrity Task Force, has come under fire for a scientific ethics violation—she edited a paper written by some of her former coauthors, including her brother-in-law, University of California–Santa Barbara marine scientist Steven Gaines.

According to EPA, OSTP partially denied their FOIA request, redacting some information based on either personal privacy or the claim that it reflected "deliberative process."

Hardin told The Epoch Times that he believes OSTP's deliberative process objection was made "on what appear to be specious grounds."

EPA's lawsuit comes soon after the Department of Homeland Security announced the formation of a Disinformation Governance Board (DGB), to be led by Nina Jankowicz.

The push by Democrats and Big Tech against "disinformation," "misinformation," and "malinformation" has grown to encompass claims about climate change.

On Oct. 5, 2021, former Facebook Civic Integrity team member Frances Haugen testified to Congress that the social media company had "profited off spreading disinformation and misinformation and sowing hate."

Just two days later, Google announced that it would ban ads and monetization for "content that contradicts well-established scientific consensus around the existence and causes of climate change."

"This includes content referring to climate change as a hoax or a scam, claims denying that long-term trends show the global climate is warming, and claims denying that greenhouse gas emissions or human activity contribute to climate change," the announcement reads.

On April 23, Twitter announced that "misleading advertisements on Twitter that contradict the scientific consensus on climate change are prohibited."

Some activists have gone beyond pushing for steps such as demonetization by suggesting that "climate denial" could be defined as a crime.

In a 2019 article for the UNESCO Courier, University of Exeter professor Catriona McKinnon argued that "climate deniers" such as energy executive and former Secretary of State Rex Tillerson could be brought before the International Criminal Court for "postericide."

The term "postericide" was invented by McKinnon, who defined it as

"intentional or reckless conduct fit to bring about the extinction of humanity."

"The damage that climate deniers do is heinous, and they have no excuses. The time has come to prosecute them for postericide," McKinnon wrote in the U.N. publication.

Hardin said, "On the heels of the news about a 'Disinformation [Governance] Board,' it's certainly a reasonable conclusion that this administration and its allies, including on Capitol Hill, seek to use the weight of the federal government to silence political speech in opposition to its 'whole-of-government' climate agenda. Whether that means attempts at criminalization or not, we shall see."

In 2018, EPA received \$45,910 from Government Accountability & Over-

sight PC, another nonprofit, to "help support their mission to seek to bring transparency to the realm of energy and environmental policy."

Hardin also serves on the board of Government Accountability & Oversight PC.

Government Accountability & Oversight PC's board members have included Chris Horner, an attorney and climate change skeptic who has received funding from the coal com-

pany Alpha Natural Resources.

"Like all nonprofits, Energy Policy Advocates is grateful for and respects the privacy of donors who support its work," Hardin told The Epoch Times when asked about the organization's financial supporters.

OSTP officials didn't respond by press time to a request for comment.




