## Chelan County PUD to hold North Shore Substation design update meeting Feb. 16

CHELAN - Chelan County PUD has been working on design details for the new North Shore Substation, which will be located on Henderson Road, and they want input on the aesthetic design of the new substation.

PUD staff and the landscape architect will present a viewshed analysis for the substation, as well as design alternatives for discussion, at an in-person meeting on Wednesday, Feb. 16, 5:15 p.m., at the Lake Chelan Chamber of Commerce, 216 E. # **County proposes Multimodal Pathway** Plan, routes to connect communities

NCW - Chelan County's proposed Multimodal Pathway Plan gains traction as they brainstorm new routes that could connect neighboring communities to Chelan, Leavenworth, Cashmere, and Wenatchee.

On Feb. 9, Chelan County Natural Resources Director Mike Kaputa presented to the Chelan County Transportation Council a Powerpoint presentation that illustrated constructed pathways that would connect Manson to Chelan, Monitor to Cashmere, and Malaga to Wenatchee.

Public discussion started on Dec. 16, 2020, with over 1,500 responses from their feedback survey collected last spring. Many of the respondents had an opportunity to draw their own desired pathways between towns, which is what Kaputa later demonstrated to the council.

"People could actually draw like on a map where they thought a pathway could go, and so it was pretty cool because we just haven't had that kind of tool before," Kaputa said.

Pathway corridors that Kaputa and his team have been focusing on include those surrounding Leavenworth to Lake Wenatchee West areas, Leavenworth to Lake Wenatchee East areas, Icicle and Leavenworth Roads, Leavenworth to For the Chelan corridor, residents wish to see continued construction of the SR 150 pathway to Manson, with some consideration for other options due to limiting geographical factors.

Wenatchee, South of Wenatchee, Wenatchee to Lake Chelan, and the shores of Lake Chelan.

The presentation also addressed multiple pathway options for Cashmere, which include widening the sidewalk on the Cottage Ave. Bridge, extending Riverside Trail and cross over to Old Monitor Road, a shared use trail for U.S. Hwy. 2, or a new road crossing through the middle of Cashmere parallel to the railroad and the river.

For the Chelan corridor, residents wish to see continued construction of the SR 150 pathway to Manson, with some consideration for other options due to limiting geographical factors.

The next step includes looking for more funding sources for the plan and to work out the designs for these routes. Kaputa hopes that the Transportation Council will help assist them alongside their Steering Committee.

So far, the project has received a total of \$100k in funding, with \$50k coming from Chelan County, \$20k from the Port Authority, and approximately \$2-5k from each city involved in the pathway project, which include Cashmere,


Chelan, Entiat, Wenatchee, and Leavenworth.

"We're looking at the infrastructure bill and some other policy and state-funding sources to help move that work forward."

Road options included additional bike lanes and sidewalks, separated shared use paths, paved shoulders, or a shared roadway. These options would include micro-mobility vehicle access alongside wheelchair and stroller access.

The majority of respondents stated that they would use the pathways for exercise and recreation, with the second option used for commute.



In class students engage in learning tasks that strengthen their Spanish skills in reading, writing, listening and speaking. At the end of the trimester students can take an assessment in Spanish called Avant STAMP. STAMP stands for Standards Based Measurement of Proficiency and can be used to show competency towards high school foreign language credit as well as to earn the Seal of Biliteracy. The Seal of Biliteracy is established to recognize public high school graduates who have attained a high level of proficiency in speaking, reading, and writing in one or more world languages in addition to English. Students earn a Seal of Biliteracy on their high school diploma when they score a level 4 on the STAMP test and earn their high school English credits. Students need 2 credits to meet the graduation requirement.



Trump told former top White House aide Kash Patel, host of EpochTV's "Kash's Corner," that completing the wall would have a significance beyond domestic policy, because it would project an image of strength to China's Xi Jinping and other world leaders.

"When [Xi] sees millions of people pouring into our country, he loses respect for our country," Trump said.

"When he and Putin and Kim Jong Un and Iran's leaders, when they're watching millions of people walk into our country ... they lose respect." risdictions began requiring COVID-19 vaccines to dine out, attend concerts, and even work. Biden ordered the military, federal contractors, agencies in his administration, health care workers, and all Americans who work at companies with 100 or more employees to get vaccinated.

While all of the mandates have been challenged and some blocked by courts, mask mandates have largely survived legal challenges.

Trump told The Epoch Times that Biden, who campaigned on a promise to "defeat the virus," has done "such a horrible job" in managing the pandemic.

"It's like they don't know what the hell they're doing. He came in [saying], 'I'm going to solve COVID.' They had more [deaths] in his year. And that's after everything that we developed—therapeutics, vaccines, everything," he said.

Deaths attributed to COVID-19 were

Less than two weeks later, the U.S. military left the airfield. What ensued was the widely criticized chaotic U.S. withdrawal from Afghanistan in mid-August.

A recent report by the Federation of American Scientists (FAS) revealed that China has been secretly building three missile silo fields near Yumen, Hami, and Orodos in western China, the region that neighbors Afghanistan. Durham secured the first guilty plea in August 2020, prior to his appointment as a special counsel. Former FBI assistant general counsel Kevin Clinesmith admitted to forging an email used to prepare an application to surveil former Trump campaign foreign policy adviser Carter Page. Clinesmith was sentenced to probation for a single charge of making false statements related to the forgery.

In September and November last year, Durham brought indictments against Russian national Igor Danchenko, the primary source of the infamous Steele dossier, and Michael Sussmann, an attorney for Hillary Clinton's 2016 presidential campaign.

The comments were part of an exclusive interview the former president gave to EpochTV on Jan. 31, during which he discussed a wide range of topics, including the ongoing investigation by special counsel John Durham, Beijing's potential occupation of the Bagram Airfield following the United States' pullout from Afghanistan, and why he believes CO-VID-19 mandates should be lifted.

Trump lamented that the United States now resembles a communist nation under his successor, pointing to rampant inflation, diminishing freedoms, and the porous U.S.–Mexico border.

"They're destroying our country. They're making us a different country. We're becoming like a socialist or a communist state," he said.

"Why [would they] want to have a weak military? Why would they want to have high interest rates and higher taxes? And why would they want to have no border?

"Why would they want to have no voter ID, for example, or sanctuary cities that take care of criminals? All of these things—defund the police? Why do they want to defund our police?

"It can't possibly be good. So either they're stupid, which I don't think they are, or they hate our country."

#### **COVID-19 Mandates**

Trump also said that mandates related to COVID-19 are wrong and should be rescinded.

"We have to end the mandates. ... They have to be ended. They shouldn't have started," Trump said.

Under Trump, the federal government didn't impose vaccine or mask mandates, but some states, including California, and counties required the face coverings.

Under President Joe Biden, many ju-

higher in 2021 than in 2020, and new case records were set in many areas in late 2021 or in January.

Trump left office on Jan. 20, 2021.

The Republican didn't force lockdowns early on in the pandemic, but his COVID advisers, Dr. Anthony Fauci and Dr. Deborah Birx, recommended that people stay home, and many states forced so-called nonessential businesses to be shuttered.

Trump eventually diverged from top health officials and urged the reopening of closed areas, famously declaring the "cure" shouldn't be worse than CO-VID-19 itself.

Lockdowns had little to no effect on COVID-19 mortality, a meta-analysis of 24 studies concluded.

#### Bagram Airfield

Trump says the United States should have never abandoned the Bagram Airfield in Afghanistan last year, given its strategic proximity to China.

"I would have kept Bagram; it was always my plan to keep Bagram," Trump said. "It's right next to China. It is one hour away from where they build their nuclear weapons."

"How can you lose Bagram?" he asked during the interview, before adding, "China is going to have Bagram."

Bagram, the largest airfield in Afghanistan, was the heart of U.S. military power in Afghanistan for nearly two decades before it was taken over by the Taliban last year. One of the construction projects completed by the United States at the airfield is a 12,000-foot (3,660 meter) runway, which opened in 2016 at the cost of \$68 million. The airbase is about a one-hour drive from the Afghan capital of Kabul.

The U.S. airfield was determined by

colonel and global strategist, previously told The Epoch Times that keeping Bagram airfield, given its proximity to China, would have given the United States a "strategic advantage" in contending with threats posed by Beijing.

"The way they withdrew from Afghanistan was like we were the 'gang that couldn't shoot straight," Trump said. "I think it's the most embarrassing day or week in the history of our country."

In the aftermath of the Taliban's swift takeover of Kabul, the Chinese regime seized on the event to embark on an aggressive propaganda campaign to label the United States as an unreliable ally and delegitimize U.S. democracy.

Trump also said that Beijing has now acquired U.S. military weapons that were left behind from the withdrawal, and the communist regime is now "studying" and "re-engineering" them.

"You have to get strong with China. You have to do tariffs. You have to do a lot of different things," Trump said.

#### **Durham Investigation**

Trump said he heard that "there's a lot coming" from the wide-ranging investigation led by Durham, who is probing the origins of the FBI's investigation into Trump's 2016 presidential campaign.

"I hear there's a lot coming. ... We're gonna see what happens. But what he's doing is one of the most important jobs being done right now in America," Trump said.

Attorney General William Barr assigned Durham on May 13, 2019, to investigate the origins of the FBI's investigation of the Trump campaign, which was codenamed Crossfire Hurricane. In October 2020, with the presidential election approaching, Barr designated tration with the pace of Durham's investigation. In March last year, he issued a statement saying: "Where's Durham? Is he a living, breathing human being? Will there ever be a Durham report?"

The former president told Epoch TV he still wishes the investigation would move faster.

"I wish it were faster," Trump said. "It is really the crime of the century and changed everything, including the election."

Some of the earliest evidence of misconduct in the Crossfire Hurricane investigation emerged in a report prepared by the Republican-led House Intelligence Committee in early 2018.

Later, an internal inquiry by the Department of Justice Office of Inspector General yielded two significant reports. Inspector General Michael Horowitz ultimately concluded that, despite errors in the Foreign Intelligence Surveillance Court applications to spy on former Trump campaign aide Carter Page, the FBI opened the investigation of the Trump campaign on lawful grounds. Durham publicly disagreed with that finding, issuing a formal statement in December 2019 explaining that his investigation reached beyond the DOJ and its components.

Recent court filings by Durham in the Sussmann case show that Horowitz withheld vital evidence from the special counsel in the Sussmann prosecution and the criminal leak investigation of former FBI General Counsel James Baker. According to the filings, Horowitz's office failed to disclose that it was in possession of two of Baker's cellphones.



# Olympic Venues 'Right Alongside Prison Camps': Torture, Detention Occurring Just Miles Away From Beijing Games

NEW YORK—The opening ceremony of the Beijing Winter Olympic Games contained all the pageantry that one might expect from an authoritarian regime eager to burnish its global image: Hundreds of children holding dove-shaped props formed the shape of a heart while they danced in a starlit stadium as green and white fireworks spelled out the word "spring" overhead, a reference to the Lunar New Year celebration.

"One world, one family," so read the slogan displayed to spectators in the partially filled "Bird's Nest" National Stadium on Jan. 4, echoing a call for unity that the Chinese regime has often repeated on the world stage over the past few years.



Over the past two years, more than 31,000 arrests and harassment cases of adherents have taken place, according to Minghui.org. Records from the site show that about 1,800 of them were sentenced and more than 200 people have died over the same period; however, human rights experts believe the true death toll to be vastly higher because of the challenge of getting official information from China.

## Disposable Chopsticks and Cotton Swabs

Thirteen miles north of the skating oval is the Beijing Juvenile Correction Facility where Liu Jiying, who escaped to New York in 2016, first crossed paths with Xu in 2001, Liu told The Epoch Times. The facility was actually an underground forced labor facility, where they became practically slave laborers. Both were later transferred to Beijing Women's Prison, then still under construction. Liu was serving an eight-year jail term, while Xu was serving a fiveyear sentence.

Each prison unit sourced its own "jobs." Xu was given some of the harshest labor, including sewing shoe soles, which often kept her up until 2 a.m. Liu made sweaters and scarfs for export, stitched lacings on ski socks, and assembled stamp albums. More often, she would need to package about 10,000 disposable chopsticks each day. There would be no sleep until the allotted quota was met. Talking wasn't allowed, but once, Liu flashed a thumbs-up to Xu to cheer her up.

The hygiene situation on the production floor was often deplorable, according to Liu, now 67. The chopsticks sometimes came with shoe prints on them. When placing cotton swabs—another product she had to package—into plastic bags at the Beijing Women's Prison, small insects would crawl out. The swabs would be labeled as "disinfected," she said.

It was while at these facilities that Liu vowed never to use disposable chopsticks again.

"When people take the chopsticks to eat, they'd assume those are clean. Who would examine them that closely?" she said.

#### **Detained Again**

On Jan 14, three weeks ahead of the Winter Games, Xu was handed another eight-year prison term for her role in supplying photos to The Epoch Times that documented the early months of the pandemic. While following Xu's case from New York, Liu said the news gave her inexplicable sadness.

"She already served eight years, now's another eight," she said. Liu knows of others who have fared even worse: One of her friends, who didn't cave in to authorities' pressure to renounce her beliefs, served 12 years. Her son was 9 months old when she was jailed. When the woman was freed, the child didn't recognize her as his mother. "What did we do? I didn't do anything illegal. What right do they have to imprison me for eight years?" Liu said. "It is they who are breaking the law." She had once posed the same questions at an arraignment hearing in 2016. "You are committing a crime," she told authorities.

With this glitzy show, the Chinese Communist Party (CCP) is trying to divert the world's attention from much grimmer realities, including the detention, torture, and death taking place mere miles away from Olympic venues, according to activists.

One detainee was so emaciated that she was taken home on a stretcher and slapped with a 2 1/2-year sentence days later. Another detainee spent his entire 30s in prison, only to receive another long sentence years later. A third one lost her husband to persecution and is now behind the bars herself. All three became regime targets merely for persisting in practicing their faith.

Their stories and others were featured in an interactive map released on Feb. 4, the same day that Beijing became the world's first city to host both the Summer and Winter Games. The map, developed by the Falun Dafa Information Center, spotlighted more than a dozen "persecution hotspots" in and around Beijing, where adherents of the persecuted faith group Falun Gong are languishing for not surrendering their beliefs.

It's the first comprehensive map of its kind to allow "a glimpse inside the places the Chinese Communist Party does not want you to see," according to the New York-based human rights group.

The "proximity of Olympic glory to terrible human suffering highlights the tragic and often deceptive rule of the Chinese Communist Party," said Erping Zhang, spokesperson for the Falun Dafa Information Center.

"There is no other regime on earth

that has the audacity, and international clout, to host the Games while simultaneously detaining such large numbers of prisoners of conscience in settings ripe with abuse and torture," he said in a statement.

#### Olympic Venues Alongside Prison Camps

Adherents of Falun Gong have been subjected to more than two decades of persecution under the communist regime, which deemed the group a threat after the practice exploded in popularity during the 1990s. An estimated 70 million to 100 million people were practicing Falun Gong by the end of that decade, according to estimates at the time.

A half-dozen torture facilities that hold Falun Gong detainees are roughly 10 to 20 miles away from Beijing's major Olympic venues, from the National Stadium to the National Speed Skating Oval, where the speed skating competition commenced on Feb. 5.

"You could literally watch the speed skating Olympic event, walk out the door from the oval, and walk 14 miles due, east and you are at a prison camp where people are being incarcerated at least one case for nine years—for their faith in Falun Gong," Levi Browde, executive director of Falun Dafa Information Center, told The Epoch Times. It took a month for researchers to verify the details and complete the map. Many of the facilities have both a public and private name and even two addresses to avoid outside scrutiny. Some of them, serving concurrently as labor camps, have adopted a secondary name as a cover for their slave labor business, according to the researchers.

Despite his years of research into the persecution campaign, seeing the facilities visually was still striking, according to Browde.

"That's sort of like going to see Yankee Stadium and walking down to somewhere in Central Park, where there's a prison camp," he said.

#### Long Years Behind the Bars

The detainee that Browde cited was 52-year-old Shi Shaoping, who holds a master's degree from the photochemical institute at the country's lead national scientific institution, the Chinese Academy of Sciences.

While Shi was arrested at his home in November 2019, his family didn't hear any news about his whereabouts until April 2021. That's when police notified them of Shi's nine-year sentence at the Beijing No. 2 Prison, a facility for death-row inmates and those serving life sentences.

Shi had already served a 10-year prison sentence because of his faith

prior to this arrest. At Qianjin Prison, which also is on the interactive map, Shi was made to sit motionless on a small stool for up to 20 hours daily over a period of a few years, according to Minghui.org, a U.S.-based clearinghouse for the persecution of Falun Gong in China. On the coldest winter days, guards would leave the window open, causing Shi's body to shiver. He was once barred from using the restroom for an entire month.

Sixteen miles away from the same skating venue is the Beijing Women's Prison, where artist Xu Na was held until last month.

Months before the Beijing Summer Olympic Games in 2008, police arrested Xu and her husband Yu Zhou during an "Olympic check," after discovering Falun Gong books in their car. Yu, a folk singer and musician, died in detention 11 days later, on the eve of Chinese New Year. Xu subsequently spent three years in detention.

About 22 miles northwest of National Stadium, the Changping District Detention Center held Wang Chaoying for distributing informational materials about Falun Gong. The 68-yearold was hospitalized three times over a six-month period between 2020 and 2021. She was sent home on a stretcher after having lost 40 pounds. Ten days later, the court delivered her verdict: a 2 1/2-year prison sentence. They, in turn, "said not a word."

Liu lost her mother shortly after her release in 2016. The woman had fallen unconscious following Liu's arrest and a house raid.

"My mother didn't have to die," she said.

The tragedies traversing two Beijing Olympics should make plain to the international community that the regime hasn't changed at all, Browde said.

"Too often, they would look at the high rise buildings and all the Starbucks around Beijing, and they think, 'Oh, this is the new China,'' he said. "They just think it's better and more civilized.

"Seeing Olympic venues right alongside prison camps ... where people are incarcerated and tortured because of their faith makes the deception and the hypocrisy of the CCP very clear."

I can't stand fried chicken. I never go to KFC, and I'll avoid fried chicken at potlucks unless there's nothing else available. Then, I peel off the fried coating until there's just plain chicken on my paper plate.

My grandparents retired and moved from Arizona to Washington State when I was in primary school. Every few months, we'd visit, driving from Seattle to Ocean City, just north of Ocean Shores on the coast.

I loved staying with my grandparents, but getting there wasn't fun. We always left right after Mom fed us lunch, usually fried chicken. Halfway there, I'd get queasy sitting in the back seat of our station wagon. One particularly twisty section of the road was excruciating. I'd often lose my lunch by the side of the road or into a trash bag inside the car.

I suffered motion sickness on boats and planes, too. One day, I discovered that ginger root might help. I tracked down candied ginger root in the spice section of my local grocery. After measuring out the suggested dose, I took it about an hour before my next road trip.

What a difference. Without a headache or queasy stomach, I enjoyed riding and reading in the back seat of the car. What a relief to master my motion sickness.

Years later, the airport was crazy busy on the early morning of Christmas Eve, and I almost missed my flight to Dayton, Ohio. In the confusion, I forgot my dose of ginger. Everything went well until we hit turbulence on the final approach. Staggering off the plane and feeling four shades of green, I raced for the nearest restroom. Finally arriving at my in-laws, I spent the rest of the day in bed.

Cinnamon, ginger, and turmeric are spices with additional medicinal properties. Although some people seem to experience benefits from these natural products, many others do not. How can you tell if they are helping you?

When your doctor gives a prescription medicine to try to lower your blood sugar, they will have a way to decide how you respond to it. You may poke your finger to measure your blood sugar. If your blood sugar levels don't change, then another approach is needed. You may get a higher dose or different medicine. Not everyone who takes a medicine, food supplement, or herbal product will respond to it. There's no way to predict who will benefit and who won't. Even with dozens of glowing testimonials, taking any supplement or herbal product doesn't guarantee similar results. Each of us responds to medications and



supplements in our own way.

The best way to determine if your supplement is helping you is to document your results. Before you start, write down how you feel before taking the first dose of your medication or supplement, then at regular periods afterward. Trying to recall exactly how you felt a week ago is not as nearly as accurate as documenting it in writing.

In the words of a Chinese proverb, "The palest ink is better than the best memory."

Despite recent studies showing that ginger is ineffective at relieving nausea from motion sickness, I have confirmed that it works for me. And that's what counts.

Other medicinal spices include clove oil and cinnamon. Clove has been used as a dental analgesic and antiseptic for decades. I think the hint of clove is part of what gives dental offices their distinctive smell. Pure Cassia cinnamon has been shown to lower blood sugar by up to 25 points, and turmeric may help your knee pain.

Here are 5 steps to help determine if a supplement works for you:

1. Decide which symptoms you hope will improve.

Answer the question, "If this really helped you, how would you know?" What exactly do you expect it to do? Relieve your pain? Increase your energy? Help you lose weight?

2. Create a before and after scoring system.

Before taking the first dose of your supplement, score yourself on how you are doing on each symptom. If you want increased energy, score your current energy level on a scale of 1 to 5 or 1 to 10.

3. Start your new supplement.

4. Score yourself on each symptom.

Every week, notice how you are doing on each symptom and record it in your symptom diary.

5. Evaluate your progress.

Check your before and after scores to determine any changes to your symptoms. If you don't see any measurable difference after four to six weeks, it's not helping you. Try something else, instead.
