



# **Return to Learn COVID Update from Lake Chelan School District**

Dear Chelan Families:

I hope that this correspondence finds you and your family well. As you know, the next few weeks will be challenging for our schools. The transmission rates in our county are at an alltime high, even so, I want to assure you that we will continue to do all we can to keep our schools safe and open for in-person learning. I am confident that by all of us working together, we will get through this with a minimal loss of learning time. By continuing to focus on maximizing in-person learning and minimizing classroom interruptions, we have implemented the following strategies:

**Nursing Staff** We have hired a nurse and a health assistant through a grant program to oversee all testing throughout the school district

**Classroom Coverage** 

All available staff including administrators and central office personnel will be available to cover classes

Pay has been increased for substitute teachers resulting in a much larger pool

Testing The district has an abundant supply of testing

Athletes continue to test 3 times per week regardless of vaccination status

The "Test to Stay" program has been successfully implemented allowing students exposed to the virus to remain in class by testing and shortening time for those infected.

**Updated Isolation and Quarantine Guidance** Guidance has been updated and shortened to 5 days.

New guidance applies regardless of vaccination status.

# **National Guard** deployed to assist **Confluence Health**

EAST WENATCHEE - Due to the COVID-19 Omicron surge, Chelan Douglas Health District (CDHD) will receive non-clinical emergency department support at Confluence Health's Central Washington Hospital from the National Guard.

Governor Jay Inslee made the announcement during a press conference on January 13, stating that National Guard members will also be sent to hospitals in Everett, Spokane, and Yakima, and others will be sent to hospitals in Olympia Richland, Tacoma, and Seattle to set up testing locations outside facilities.

Chelan-Douglas had the highest infection rates since the pandemic yesterday with over 2,000 cases per 100,000 people, and given the infectiousness of Omicron we expect this number will likely rise. CDHD is shifting priorities with staffing related to vaccination, testing, contact tracing, and potential hospital surge planning.

Other key statewide actions issued by Governor Inslee involve deploying the National Guard to help both emergency department personnel and COVID-19 testing teams, pausing non-urgent hospital procedures, and discharging hospital patients to long term care facilities.

The Governor also asked for help from anyone who can assist with vaccinations, testing or work at hospitals or facilities. If you have the capacity and availability to assist, please sign up at https://waserv.org/.

CDHD looks forward to welcoming the National Guard and will update the public as we receive more information. To stay up-to-date on the COVID-19 response, visit www.cdhd.wa.gov and follow us on Facebook, Twitter and Instagram.

#### **Public Health Prioritizes Testing Over** Vaccine Efforts

The Chelan Douglas Health District (CDHD) is deciding to prioritize local testing efforts in hopes of getting all infectious individuals isolated at home to help reduce local case rates.

If you received a first dose at the CDHD 2nd street clinic and are due for a second dose, please plan to attend one of the upcoming vaccine clinics scheduled at 1224 Methow Street in Wenatchee. Dates, times and pre-registration details are available at: https://www. eventbrite.com/e/pfizer-drivethru-covid-19-vaccine-clinicat-lincoln-elementary-registration-205358411537. CDHD staff is working to personally communicate this change to any first dose individuals who are due for their second dose in the coming weeks.

#### Testing

The Chelan Douglas Health District (CDHD) is now operating a community testing site at the Town Toyota Center on 1300 Walla Walla Avenue in Wenatchee. Due to high demand and limited test supplies. please note the following:

· Testing is only available for symptomatic individuals

· Testing site is open Monday-Saturday, 10:30 a.m.-4:30 p.m.

• Pre-registration is required. Pre-register at www.cdhd. wa.gov. For help with preregistration call 509-903-3900.

· Testing site will continued to operate as time and supplies allow.

Anyone can be tested. CDHD highly recommends testing for:

· Anyone who has symptoms consistent with COVID-19, even if their illness is mild.

• Anyone who has been in close contact with a person with confirmed COVID-19.

· Anyone who has attended an event or social gathering with many people

If you need medical evaluation for COVID-19 symptoms including difficulty breathing, increased heart rate, a temperature greater than 101 degrees, or severe weakness, go to the Triage Center at Saddlerock EPC Church located at 1400 S. Miller Street in Wenatchee.

CDHD continues to stress the importance of a COVID-19 vaccine and getting the booster as soon as possible. If you are in need of a first, second or booster vaccine, please contact a local pharmacy or your local medical provider.

# Swanson Gulch barn burns, goats rescued

CHELAN - Last night (Saturday, Jan. 8) at 11:32 p.m. Chelan Fire and Rescue was dispatched for a reported fully involved barn fire in the Swanson Gulch area. Neighbors noticed the fire and alerted the home owners who called 911.

Crews arrived to find a well involved large shop with a full-size RV next to it. The main fire building was quickly called a defensive fire and suppression efforts focused on protecting the RV from catching fire. Crews faced challenges with the fires remote location, snow

conditions, and no hydrants. Crews from Chelan County Fire District #5 (Manson) and Douglas County Fire District #4 (Orondo) also assisted. In all, eleven firefighters responded and units were on scene till approximately 2:30 p.m. this morn-

ing.

Three goats that were in a pen attached to the structure were helped to safety by the homeowner.

The shop was declared a total loss. The fire is currently under investigation and appears to have been caused by an electrical issue. Chelan Fire and Rescue would like to thank Manson and Orondo for their help in getting this fire under control.



# Supreme Court Blocks Business Vaccine Rule, Declines to Stay Health Care Worker Mandate

The Supreme Court has blocked the Biden administration's COVID-19 vaccine mandate for private businesses, but has decided to allow a separate regulation that requires health care workers to get a vaccine to take effect.

In a 6–3 ruling on Jan. 13, the court halted the mandate for all private employers with 100 or more workers, ruling that the states and companies that challenged the rule were likely to succeed. Biden administration officials had argued that the Occupational Safety and Health Act (OSHA) of 1970 gave them the authority to impose the mandate, but a majority of the justices disagreed.


"Applicants are likely to succeed on the merits of their claim that the Secretary lacked authority to impose the mandate. Administrative agencies are creatures of statute. They accordingly possess only the authority that Congress has provided. The Secretary has ordered 84 million Americans to either obtain a COVID-19 vaccine or undergo weekly medical testing at their own expense. This is no 'everyday exercise of federal power.' It is instead a significant encroachment into the lives—and health—of a vast number of employees," the majority slip opinion reads.

The ruling came from Justices John Roberts and Samuel Alito, George W. Bush appointees; Clarence Thomas, a George H. W. Bush appointee; and Justices Neil Gorsuch, Brett Kavanaugh, and Amy Coney Barrett, all Trump appointees.

Justice Stephen Breyer, a Clinton appointee, and Justices Sonia Sotomayor and Elena Kagan, both Obama appointees, dissented. They wrote in their dissent that the law in question didn't limit the labor secretary's powers.

The majority "[imposed] a limit found no place in the governing statute," the minority opinion reads.

"Not so," the majority wrote. "It is the text of the agency's Organic Act that repeatedly makes clear that OSHA is charged with regulating 'occupational' hazards and the safety and health of 'employees.""

While Solicitor General Elizabeth Prelogar in an earlier brief didn't dispute that OSHA is limited in regulating "work-related dangers," she claimed that the risk of contracting COVID-19 qualifies as such a danger.

"We cannot agree," the majority opinion reads. "Although COVID-19 is a risk that occurs in many workplaces, it is not an occupational hazard in most. COVID-19 can and does spread at home, in schools, during sporting events, and everywhere else that people gather. That kind of universal risk is no different from the day-to-day dangers that all face from crime, air pollution, or any number of communicable diseases. Permitting OSHA to regulate the hazards of daily life-simply because most Americans have jobs and face those same risks while on the clock—would significantly expand OSHA's regulatory authority without clear congressional authorization."

The ruling means that the mandate is blocked while the case goes back

to the U.S. Court of Appeals for the 6th Circuit, which overturned a stay that had been imposed by a different appeals court.

OSHA is part of the Department of Labor.

Missouri Attorney General Eric Schmitt, a Republican who brought one of the challenges against the mandate, said in a statement that the ruling was "a massive win for millions of workers and businesses across the country, including Doolittle Manufacturing here in Missouri, who would've had to shutter their doors if this mandate was not halted."

"While we're disappointed in the Supreme Court's ruling on our lawsuit against the health care worker vaccine mandate, that fight is far from over, and the case is still ongoing," he said.

Schmitt was referring to a majority of justices agreeing to lift lower court orders that blocked a separate Biden administration mandate imposed by the Department of Health and Human Services' Centers for Medicare & Medicaid Services (CMS).

The CMS mandate, which doesn't allow a testing opt-out, covers more than 17 million health care workers.

Congress granted authority to the health secretary to promulgate, as a condition of a health care facility's participation in Medicare and Medicaid, requirements that he or she "finds necessary in the interest of the health and safety of individuals who are furnished services in the institution," the majority of the court stated in their ruling.

While a vaccine requirement has never before been imposed, "we agree with the government that the Secretary's rule falls within the authorities that Congress has conferred upon him," the majority opinion reads.

The justices said getting a COV-ID-19 vaccine would "substantially reduce the likelihood that health care workers will contract the virus and transmit it to their patients." However, this doesn't align with studies and real-world data on the effect of vaccination against the Omicron coronavirus variant.

"The rule thus fits neatly within the language of the statute. After all, ensuring that providers take steps to avoid transmitting a dangerous virus to their patients is consistent with the fundamental principle of the medical profession: first, do no harm. It would be the 'very opposite of efficient and effective administration for a facility that is supposed to make people well to make them sick with COVID-19," the majority opinion reads.

The narrow 5–4 opinion saw Roberts and Kavanaugh join the Democrat-nominated trio of justices, while Thomas offered a dissent that was joined by Alito, Gorsuch, and Barrett.

Thomas said the government hadn't made a strong argument that it was likely to succeed in the case, stating that the administration didn't establish that the Medicare Act or any other law gives it the authority to impose a vaccine mandate in order for facilities to participate in Medicare or Medicaid.

"These cases are not about the efficacy or importance of COVID-19 vaccines. They are only about whether CMS has the statutory authority to force health care workers, by coercing their employers, to undergo a medical procedure they do not want and cannot undo. Because the Government has not made a strong showing that Congress gave CMS that broad authority, I would deny the stays pending appeal. I respectfully dissent," Thomas wrote.

Cases involving the health care mandate will now go back to appeals courts for disposition.

CMS "is extremely pleased the Supreme Court recognized CMS' authority to set a consistent COVID-19 vaccination standard for workers in facilities that participate in Medicare and Medicaid," CMS Administrator Chiquita Brooks-LaSure said in a statement. "The bottom line is that vaccine requirements work and are an important tool to protect patients and also to keep our health care workers healthy," she added.

# December, Fastest Pace Since 1982

Consumer prices accelerated in the year through December 2021 at their fastest pace in 39 years, new government data show, marking the seventh straight month of inflation running at more than 5 percent and a fresh sign that inflationary woes continue to weigh on U.S. consumers.

The Bureau of Labor Statistics (BLS) reported on Jan. 12 that the Consumer Price Index (CPI), which reflects inflation from the perspective of end consumers, rose by 7 percent in the 12 months through December 2021, a level not seen since June 1982, when it reached 7.2 percent.

On a monthly basis, the CPI inflation gauge rose by 0.5 percent in December 2021 after a 0.8 percent jump in November 2021, suggesting a slight easing of inflationary pressures.

Still, so-called core consumer prices, which strip out the volatile categories of food and energy, continued to rise at an outsized pace. Core inflation rose by 5.5 percent in the year through December 2021, the fastest pace in nearly 31 years.

"This is not a lucky number 7," Bankrate Chief Financial Analyst Greg McBride told The Epoch Times in an emailed statement.

McBride noted that the pace of inflation was "far outstripping the wage growth of most Americans

and squeezing the buying power of households."

A separate government report shows that real average hourly earnings, which are adjusted for inflation, fell by 2.4 percent in the 12 months through December 2021. Without adjustment for the pace of inflation, average hourly earnings rose by 4.7 percent over the year.

"The headline rate of inflation accelerated on an annual basis, hitting 7 percent, but did decelerate on a monthly basis for the second month in a row, owing to a decline in energy and slower increases in food prices," McBride said.

# Prices Rise Across the Board

New data show that almost every category was higher in the 12 months ending in December 2021.

Food prices surged by 6.3 percent, while energy was up by 29.3 percent. New vehicles and used cars and trucks soared by 11.8 percent and 37.3 percent, respectively. Apparel jumped by 5.8 percent, shelter picked up by 4.1 percent, and medical care services inched higher by 2.5 percent.

Close to every food item cost more in December 2021 compared to the same time a year earlier, including meats, fruits, and vegetables.

In the overall category of meat,

poultry, fish, and eggs, prices swelled by 12.5 percent.

Beef and veal prices were up by 12.6 percent, pork prices surged by 15.1 percent, ham rose by 10.5 percent, and chicken soared by 10.4 percent. The cost of eggs spiked by 11.1 percent, while fish and seafood rose by 8.4 percent.

Fruits and vegetables increased by 5 percent, milk rose by 4.2 percent, and coffee surged by 6.3 percent.

Among other food items on the list, baby food surged by 7.9 percent, margarine advanced by 6.7 percent, potatoes soared by 4.8 percent, and apples rose by 7.8 percent.

Energy prices eased on a monthover-month basis, but they were still high compared to the same time in 2020. Gasoline soared at an annualized rate of 49.6 percent, electricity prices jumped by 6.3 percent, and natural gas increased by 24.1 percent.

Charlie Bilello, chief executive of Compound Capital Advisors, wrote on Twitter that he believes that the true rate of inflation is being understated.

"Shelter is the single biggest component of CPI (33 percent of Index) and is being wildly understated (+4.1 percent) with rents up 17.8 percent over the last year (largest annual increase ever), and home prices up 19 percent (also largest annual increase ever). True inflation rate is much inflation numbers in a statement.

"Today's report—which shows a meaningful reduction in headline inflation over last month, with gas prices and food prices falling—demonstrates that we are making progress in slowing the rate of price increases," Biden said. "At the same time, this report underscores that we still have more work to do, with price increases still too high and squeezing family budgets."

In response to surging inflation and ongoing firming in the labor market, the Federal Reserve has moved to roll back emergency pandemic support measures and normalize monetary policy.

There's now a 74.4 percent chance of the Fed announcing a 25-basispoint rate increase in March, according to the CME's Fed Watch tracker.

## **Inflation Fallout**

The Dow Jones Industrial Average rose by 38 points to 36,290. The S&P 500 added 0.28 percent to 4,726, while the Nasdaq Composite Index tacked on 35 points to 15,188.

The U.S. Treasury market was mixed, with the benchmark 10-year yield sliding to 1.736 percent. The 30year bond rose to 2.086 percent, while the one-year bill rose slightly to 0.445 percent.

The U.S. Dollar Index (DXY), which gauges the greenback against a basket of currencies, declined by 0.72 percent to 94.93.


