Chelan County Sheriff's Office, schools come to agreement on school resource officers

Chelan, Manson contracts begin *Dec.* 1

WENATCHEE -- The Chelan County Sheriff's Office has finalized contracts with the four schools that utilize school resource officers via its office.

The contracts began Nov. 1 with the Cashmere and Cascade school districts and Dec. 1 with the Chelan and Manson school districts. Chelan Coun-



Manson has given a verbal Brian Burnett, agreement as Chelan County the County is Sheriff just waiting to approve their signed copy.

Chelan County Sheriff Brian Burnett said that after discussion with the Sheriff's Association and the school districts, the officers will meet the requirements of the school districts, which include a COVID-19 vaccination or an approved exemption from the individual school district.

"We needed some time to work through this issue on our end, which included finding a solution that the Sheriff's

Association, the officers and the schools could accept," Burnett said. "We feel comfortable moving forward."

The Sheriff's Office in early September put the annual contracts on hold following the governor's announcement a month earlier that all

school employees and on-site contractors and volunteers would be required to receive a COVID vaccination or apply for an exemption.

At the time, Sheriff Burnett expressed concern about the mandate violating people's rights as well as a need to discuss the state mandate with union representatives.

"Personally, I have not asked any of my deputies or staff if they are or aren't vaccinated," Burnett said. "I have maintained the decision

As thousands fired under Inslee decree, Senate Freedom Caucus calls on governor to resign

Mass-termination event is last straw -- senators cite failure of leadership

· Thousands of state employees get ax under Inslee vaccination mandate

• Follows nearly 600 days of autocratic decisions in 'emergency' that never ends

• Ferries on reduced schedule due to severe staffing shortage, other impacts expected

 Governor has ignored Legislature, shut the people out of decision-making

OLYMPIA - As thousands of state employees get pink slips under Washington Gov. Jay

Inslee's "get vaccinated or get fired" mandate, members of the Senate's Freedom Caucus are calling on the governor to resign.

The mass firings last Monday of state employees and others who balked at the governor's COVID-19 vaccination order already are creating a crisis in state government, as state agencies struggle to provide services under an Inslee-created staff shortage. The number of terminations was not available Tuesday morning, but press accounts indicate thousands got the ax at the end of their shifts.

"This mass-termination event is the straw that breaks the camel's back," said Sen. Doug Ericksen, R-Ferndale. "Never have we witnessed a failure of leadership in this state as we have seen under Gov. Jay Inslee. For nearly 600 days, he has used COVID emergency powers to establish autocratic rule, refusing to call the Legislature into special session, and shutting the people out.

"Inslee has done significant damage to the credibility of state government and has eroded the public's trust. Now he is firing thousands of public employees, without regard to the harm it will cause. This effort to punish can only be seen as the willful act of a failed governor. Inslee has failed miserably. We don't take this lightly. But the only thing that can allow our state to heal and move forward is for Jav Inslee to resign."

Inslee has been operating under COVID emergency authority since Feb. 29, 2020, allowing him to suspend state laws and issue sweeping executive orders. His authority was extended indefinitely by the Legislature in January under a controversial measure supported by most Democrats and opposed by all Republicans. Thursday will mark the 600th day of the longestrunning emergency in state history.

The result, Freedom Caucus members say, is a nightmare

for the state and a challenge to the democratic principles outlined by the state constitution. They observe:

Ferries are operating on a reduced schedule due to staffing shortages, bus routes are being canceled, and other immediate impacts to state services are expected.

Public safety is threatened by the termination of law enforcement officials and workers at the state Department of Corrections.

The firings follow months of arbitrary decrees based on questionable or non-existent science that have forced thousands of businesses across the state to shutter for good.

Inslee has repeatedly refused to call the Legislature into a special session – and give the people a voice. When the Legislature met earlier this year, Inslee ordered construction of a cyclone fence around the Capitol, and stationed 600 National Guard troops to keep the public out.

Inslee is using his COVID


son makes all the decisions. there can be no question who is at fault."

Other comments:

"The governor and Democratic legislators have increased health risks and jeopardized public safety, while Inslee pats himself on the back as being the only person who can save us from COVID," said Sen. Phil Fortunato, R-Auburn. "He has been a boon to other states seeking to reduce their staffing shortages. Nebraska is actively recruiting our nurses, reducing our available staffed hospital beds. Orange County in Florida is targeting King County and Seattle police who are 'looking to relocate due to the vaccine mandate'. While other states have issued guidance and are dealing with the problems COVID has created, it seems COVID is a crisis only in Washington, much of it created by Inslee's heavyhanded actions."

"Inslee isn't responding to a crisis," said Sen. Jim McCune, R-Graham. "He's creating one. He sees this as a golden opportunity to sweep out public employees and others who object to his high-handed rule. And he doesn't care what a mess he makes in the process. There are many who have serious and well-founded objections to vaccination, and they could have been accommodated as they have been in other states. This is a disgrace. State employees don't deserve pink slips. The governor does." "It's heartbreaking," said Sen. Mike Padden, R-Spokane Valley. "These callous decisions by the governor are having a devastating impact on working families. There are dedicated public servants who have worked for state government who will lose their ability to pay their mortgage or provide food for their family. Others are just a few years or months away from vesting in their retirement plans. Some have received medical advice from their personal doctors that they must now ignore in order to keep a job they love. This is wrong.'

powers to advance his controversial political agenda, and is purging law enforcement officials most likely to object to defunding police agencies and establishing central state government control.

No other state has gone to this extreme, as anyone who has ventured beyond the state's borders can see.

Inslee has yet to identify the criteria under which he will declare an "all-clear" and relinquish his emergency authority - meaning no end is in sight.

"We objected on principle in January when our colleagues voted to give Inslee emergency powers for as long as he wants them," said Sen. Jeff Wilson, R-Longview. "But I don't think any of us realized it would come to this, and I think many in the state Legislature are having second thoughts today. Other states are requiring vaccinations, but none of them have taken it to the level of mass terminations. When one per-

"This past year, we have been working hard to introduce Kait and the jail's narcotics detection program to the community," Lewis said.







Supreme Court Takes Aim at Restrictive New York Concealed-Carry Gun Law

The Supreme Court seemed receptive to arguments that New York state's tough concealed-carry gun permitting system violates the Second Amendment during a court hearing on Nov. 3.

The legal challenge is important because it could result in a nationwide recognition of the right of Americans to possess guns outside the home and carry guns in public places such as parks, schools, shopping malls, and churches.

The Supreme Court has been strengthening Second Amendment protections in recent years and observers say the court's 6-3 conservative supermajority could help expand gun ownership protections.

In District of Columbia v. Heller (2008), the Supreme Court held that the Second Amendment protects "the individual right to possess and carry weapons in case of confrontation," and in McDonald v. City of Chicago (2010), it held that this right "is fully applicable to the States."

This case is New York State Rifle and Pistol Association v. Bruen, court file 20-843, on appeal from the U.S. Court of Appeals for the 2nd Circuit.

It comes amid rising crime rates, activist demands to defund police departments, and a Biden administration push to strengthen gun control policies.

New York state's gun permit law, like laws in seven other states, generally requires an applicant to prove "proper cause" in order to obtain a license to carry a concealed handgun in public.

The specific issue before the court is whether the state's denial of the petitioning individuals' applications for concealed-carry licenses for self-defense violates the Second Amendment.

Respondent Kevin Bruen heads the New York State Police. Founded in 1871, the lead petitioner, the New York State Rifle and Pistol Association, describes itself as "the state's largest and nation's oldest firearms advocacy organization," and as the official National Rifle Association (NRA) affiliated state association in New York.

Arguments ran 48 minutes overtime, perhaps reflecting the importance of the constitutional rights under discussion. Sick at home, Justice Neil Gorsuch participated by telephone.

Representing petitioners at the hearng Nov. 3 was Paul Clement, U.S. solicitor general in the second term of

then-President George W. Bush. Clement said the Constitution is on his clients' side.

"The text of the Second Amendment enshrines a right not just to keep arms but to bear them, and the relevant history and tradition, exhaustively surveyed by this court in the Heller decision, confirmed that the text protects an individual right to carry firearms outside the home for purposes of selfdefense," he said.

That history "is so clear that New York no longer contests that carrying a handgun outside of the home for purposes of self-defense is constitutionally protected activity," Clement said. "But that concession dooms New York's law which makes it a crime for a typical law-abiding New Yorker to exercise that constitutional right."

New York Solicitor General Barbara Underwood confirmed to Justice Amy Coney Barrett that she was "quite content" to say the Heller case "was rightly decided."

Clement said New York likens its law to laws restricting weapons in sensitive places, "but the difference between a sensitive-place law and New York's regime is fundamental." "It is the difference between regulating constitutionally protected activity and attempting to convert a fundamental constitutional right to a privilege that can only be enjoyed by those who can demonstrate to the satisfaction of a government official that they have an atypical need for the exercise of that right.

"That is not how constitutional rights work. Carrying a firearm outside of the home is a fundamental constitutional right. It is not some extraordinary action that requires an extraordinary demonstration of need. Petitioners here seek nothing more than [what] their fellow citizens in 43 other states already enjoy."

Justice Sonia Sotomayor suggested Clement oversimplified the history of concealed-carry restrictions.

Most of those 43 states "didn't give unrestricted rights to carry in one form or another until recent times. ... I don't know how I get past all that history you are, sort of, making it up."

Later in the hearing, Underwood said limits on carrying firearms in public go back 700 years, to "the 14th-century statute of Northampton, which prohibited carrying arms in fairs and markets and other public gathering places, to similar laws adopted

by half of the American colonies and states in the founding period, to later state laws that relaxed restrictions for people who had a concrete need for armed self-defense."

Justices Samuel Alito and Brett Kavanaugh zeroed in on the seeming bureaucratic arbitrariness in New York's granting of concealed-carry licenses.

If someone works late at night in high-crime Manhattan, why shouldn't that person be able to get a concealedcarry permit, Alito asked Underwood.

Being in a crime-ridden area doesn't justify the issuance of a permit, Underwood replied.

"The core right to self-defense ... doesn't allow for all ... to be armed for all possible confrontations in all places."

Alito agreed, but asked, "Does it mean that there is the right to self-defense for celebrities and state judges and retired police officers, but pretty much not for the kind of ordinary people who have a real, felt need to carry a gun to protect themselves?"

"Proliferating guns in a populated area where there is law enforcement ieopardizes law enforcement," she added.

"Why isn't it good enough to say, 'I live in a violent area and want to be able to defend myself'?" Kavanaugh asked.

Having plenty of concealed guns increases the chance of problems such as fights breaking out, Underwood said.

"With any constitutional right, if it's [left to] the discretion of an individual officer, that seems inconsistent with an objective constitutional right," Kavanaugh said.

Alito pointed out that in Underwood's brief, it states that in founding-era America, legal reference guides told local officials to "arrest all such persons as in your sight shall ride or go armed."

Alito said he looked up the cited guide from 1814, "A Manual of the Laws of North Carolina," by John Haywood, "and what it actually says is 'you shall arrest all such persons as in your sight shall ride or go armed offensively."

"Somehow, that word 'offensively' got dropped from your brief," he said.

"If any possession of weapons outside the home was illegal, then there would be no need to put in the term 'offensively," Alito said.

Report of Problems With Pfizer COVID-19 Vaccine Trial Being Investigated: Contract Company

Alleged problems with a major clinical trial examining Pfizer's COVID-19 vaccine are being probed, a contract company involved in the research has confirmed.

Ventavia Research Group operated several of the trial sites in the fall of 2020. Brook Jackson, who worked for the company during this time, told the British Medical Journal that the trial was riddled with issues, including the falsification of data.

Jackson said she alerted the Food and Drug Administration (FDA) to the problems she witnessed and was fired within hours.

Ventavia confirmed to The Epoch Times that it employed Jackson for two weeks last year. Lauren Foreman, director of business development and communications, said in an email that Ventavia is investigating Jackson's allegations.

"Ventavia takes research compliance, data integrity, and participant safety very seriously and stands behind its important work supporting

the development of lifesaving vaccines and is conducting its investigation accordingly," she said.

The FDA appeared to confirm it was aware of the matter.

"Although the agency cannot com-

ment further at this time in this ongoing matter, FDA has full confidence in the data that were used to support the Pfizer-BioNTech COVID-19 vaccine authorization and the Comirnaty approval," a spokeswoman told The

Epoch Times in an email.

Ventavia worked on the trial that led to emergency use authorization (EUA) for Pfizer's jab. The FDA later approved the shot, though many or all of the doses being administered in the United States continue to be the EUA-version.

Pfizer didn't immediately respond to a request for comment.

Jackson, who had worked with clinical trials for over 15 years, told the British Medical Journal she repeatedly raised concerns with her superiors about what she was witnessing, including patient safety concerns. She began to feel her reports were being ignored and began taking photographs using her phone. One photograph apparently showed that needles were discarded in a plastic bag instead of a box, while another was said to have showed packaging materials that revealed trial participants' identification numbers, signaling they may have been unblinded.

Jackson listed 12 concerns she had in a Sept. 25 message to the FDA,

including participants not being monitored after receiving an injection and vaccines not being stored at proper temperatures. She also alleged that Ventavia staff members were targeted by higher-ups for reporting problems.

Jackson said the FDA sent her an email acknowledging receipt of the list and she received a call from an FDA inspector, but she has heard nothing from the agency since then.

The Epoch Times has submitted a Freedom of Information Act request concerning Jackson's email to the FDA and internal communications from the agency regarding the message.

The FDA said in August it inspected nine of the trial's 153 sites. None of Ventavia's sites were inspected.

The inspections were limited "because the study was ongoing, and the data required for verification and comparison were not yet available to the IND [investigational new drug]," an FDA officer wrote in a summary of the inspections.

Some pharmaceutical companies have seen inspections waived or FDA officials deciding to conduct an inspection remotely, Philip Crooker, technical vice president of Paraexel, told a forum in December 2020. Inspections of domestic sites plunged to 6,574 in 2020 from 13,001 in 2019, according to FDA data.

Durham Grand Jury Indicts 'Steele Dossier' Source Igor Danchenko

An analyst who was a source for the infamous 2016 "Steele dossier" that contained allegations against then-presidential candidate Donald Trump has been arrested on charges stemming from special counsel John Durham's investigation.

A grand jury indictment issued in a federal court in Virginia charges Igor Danchenko, a Russian analyst, with five counts of false statements. The case was brought as part of Durham's investigation into the origins of the FBI's probe into alleged ties between Russia and Trump's 2016 presidential campaign.

Specifically, Danchenko was charged with misleading FBI officials about the sources of the information he provided to former UK spy Christopher Steele. He was interviewed multiple times by FBI officials in 2017 as they attempted to corroborate the allegations in Steele's dossier.

According to the indictment, Danchenko's alleged lies "were material to the FBI because ... the FBI's investigation of the Trump Campaign relied" on the dossier to obtain warrants to surveil former Trump aide Carter Page.


"The FBI ultimately devoted substantial resources attempting to investigate and corroborate the allegations contained in" the dossier, including whether Danchenko's subsources were reliable, the indictment states. The dossier and information provided by Danchenko "played a role in the FBI's investigative decisions and in sworn representations that the FBI made to the Foreign Intelligence Surveillance Court throughout the relevant time period."

The Epoch Times has contacted the Department of Justice and Danchenko lawyer Mark Schamel for comment.

Danchenko provided information to Steele, who was hired by Fusion GPS to conduct opposition research on members of the Trump campaign during the 2016 election. Fusion GPS was, in turn, retained by law firm Perkins Coie on behalf of the Democratic National Committee.

Steele's memos, collectively known as the Steele dossier, alleged that Trump had colluded with Russian intelligence officials to help him defeat then-candidate Hillary Clinton in the 2016 presidential election. However, Trump has long panned the allegations in the dossier as a long-running "witch hunt" designed to discredit his presidency and suppress his reelection chances.

Numerous claims in the dossier turned out to be false, triggering criminal, congressional, and inspector general investigations into how the reports were used for the basis of a surveillance campaign targeting Trump campaign officials.



Steele gave the dossier to the FBI, which then used it as the basis for a Foreign Intelligence Surveillance Act court order to surveil former Trump campaign aide Carter Page. In 2019, the Department of Justice's Inspector General's Office released a lengthy report that criticized the FBI's processes in handling the surveillance of Page. Danchenko previously told the

FBI that he had acquired the infor-

mation that was used in the dossier by "word of mouth and hearsay" from his sources in Russia, according to the inspector general's report. But affidavits filed earlier this year said that sources for Danchenko denied having provided any information that was used in the dossier.

All of Danchenko's sub-sources have now denied—under penalty of perjury—that they provided Danchenko with any information that was attributed to them in Steele's dossier, according to court documents filed earlier in 2021. Before, Steele claimed in testimony that Danchenko's sources were "Russians with 'personal knowledge of and/or direct access to the relevant information' and that they included 'top-level' Russian government officials 'at the peak of the vertical of power."

Danchenko is now the third person who has been charged in connection to Durham's probe. In September, Durham's office charged former Perkins Coie attorney Michael Sussmann, alleging that he gave false information when he spoke with then-FBI General Counsel James Baker in 2016. Sussmann has pleaded not guilty to a charge of lying to the FBI.

Prosecutors involved in Durham's probe said during a court hearing last month that they're planning to call Baker, who now works for Twitter's legal department, to testify in the Sussmann case. The indictment against Sussmann alleges that he lied to Baker when he provided data that linked the Trump Organization to a Russian bank.

In 2020, former FBI lawyer Kevin Clinesmith was found guilty of altering an email related to the Trump-Russia investigation, known as Crossfire Hurricane, although he was spared prison during sentencing earlier this year.

Lawsuits Pile Up After White House Sets COVID-19 Vaccine Mandate Deadline

Numerous lawsuits have been filed against the Biden administration over vaccine mandates for private employers and federal contractors that are set to be published in the federal register on Nov. 5.

The attorneys general of Ohio, Kentucky, and Tennessee announced they would take legal action against the White House over the rule and filed a lawsuit in a bid to challenge President Joe Biden's rule affecting federal Safety and Health Administration (OSHA) issued a rule requiring businesses with 100 or more employees to make sure all workers are vaccinated or submit to weekly testing, affecting tens of millions of workers.

"Unless we intervene, federal contractors in Tennessee will be forced to make sense of the mandate's many inconsistencies that require their entire workforce be vaccinated or face potential blacklisting and loss of future federal contracts," Tennessee Attorney General Herbert H. Slatery III said in a statement. ever it wants, however it wants." "The Constitution lays out critical rules by which the executive branch must operate," Yost said. "Congress and the states have their own powers, which the administration can't just take over because it wants to."

Arizona Attorney General Mark Brnovich, who filed a lawsuit against Biden's mandates after he announced them in early September, said he would sue the administration on Nov. 5, according to a statement.

DHS Sees No Rise in Violence Against Educators, but Federal Probe Continues

Department of Homeland Security Counterterrorism Coordinator John Cohen said on Nov. 3 that the DHS hasn't found evidence of rising violence against educators—refuting the ostensible reason that Attorney General Merrick Garland launched an ongoing investigation into the matter.

Cohen's remarks came during a House Permanent Select Committee on Intelligence hearing on domestic terrorism in response to questions from Rep. Elise Stefanik (R-N.Y.), who asked about Garland's decision last month to open an investigation into violence against educators. The probe comes at a time when parents groups have increased pressure on school boards over the teaching of critical race theory and the imposition of

mask mandates, among other issues.

Garland cited a "disturbing spike" in harassment and threats of violence as his reason for opening the probe, but Cohen said at the hearing that his department has found no evidence of widespread violence.

Cohen said: "We did reach out to state and local law enforcement. There have been some sporadic instances of violence at school board meetings and in educational facilities. However, the information that we received is that state and local law enforcement were not seeing widespread action."

Responding to questions from Rep. Adam Schiff (D-Calif.), Cohen said the DHS hasn't seen any quantifiable evidence of a rise in death threats.

Cohen's statements mark the latest development undermining Garland's reason for launching an investigation—an action critics accuse of being politically motivated and chilling free speech.

Last month, Garland admitted that the evidence underpinning his claims of rising threats of violence was a letter from the National School Boards Association (NSBA) sent to the Biden administration—a letter characterizing protesting parents as domestic terrorism threats and calling for the FBI to use statutes such as the Patriot Act.

Since then, the NSBA has retracted and apologized for the letter. A group of 17 state attorneys general has also called for Garland to rescind his memo, saying it "chills lawful dissent."

Nevertheless, the federal probe continues. Garland defended his actions at an Oct. 27 Senate Judiciary Committee hearing, saying that the NSBA's follow-up apology letter "does not change the association's concern about violence and threats of violence."

Republican lawmakers demanded answers in a Nov. 1 letter to the DOJ, requesting internal emails and other records related to the probe.

Lawmakers also questioned FBI Assistant Director of Counterterrorism Timothy Langan about the matter at the Nov. 3 hearing.

Stefanik asked why the Department of Justice hadn't closed the investigation, given that the NSBA has retracted its letter, but Langan said that question would have to be referred to the DOJ. Stefanik then asked Langan whether he thinks the investigation should be closed, to which Langan replied that he "doesn't want to speak for the AG."

Langan also said he didn't know

whether any state or local governments had reached out to federal authorities for assistance dealing with threats of violence against educators.

When Stefanik raised questions about the status of a series of meetings Garland directed federal law enforcers to hold across more than 94 state, local, and other jurisdictions, Langan said he didn't know how many had taken place.

The FBI official said the district U.S. Attorneys' Offices were to coordinate those meetings, which is why he didn't have much information.

Later in the hearing, Stefanik pointed out that Garland's memo directed the FBI to work "with" the U.S. Attorneys' Offices to hold the meetings.

"So the FBI is directing this," she said.

Langan maintained that the U.S. attorneys are the ones handling the meetings.

"The FBI's not directing this. It's the U.S. Attorney's Office that, in my understanding, was going to direct and format the meetings—and we would react," he said.

Over a year ago, I noticed a small round, raised spot on the pad of my right index finger. Hard, flat, and a light gray, it wasn't a blister or part of a rash. It didn't itch or burn but felt rougher than the skin around it. A month later, it was still there.

Two months later, it was still there. It stayed just like it was: a small, round, raised, flat, and light gray spot on the pad of my finger.

Hmm... Could it be a wart?

When I showed it to my doctor, he confirmed it. That spot on my finger was a wart.

I'm not alone. After acne, warts are the most common and annoying skin condition that people want to get rid of.

Warts are a viral infection of the outer layer of your skin. Human papillomavirus or HPV is responsible for creating a wart. Skin infected by HPV grows into a thickened mass that eventually juts out from the normal skin surrounding it.

Warts can be different colors, like light gray, yellow, brown, even gray-black. More often found on your hands and feet, children are more likely to have warts than adults.

There are several main types of warts found in humans. These include common warts, flat warts, palmar (on the palm of your hand) warts, plantar (on the sole of your foot) warts, and genital warts. Although most warts are relatively flat, some grow outward, creating

a "bushy," cauliflower-like appearance.

Even though they are considered unsightly, most warts are harmless. Although they aren't dangerous, warts can be pretty inconvenient if they appear on your face or grow on a weight-bearing surface, like the bottom of your foot. When a wart creates pressure or pain when you walk on it, it should be removed as soon as reasonably possible.

How do you remove a wart? Most treatments work by damaging or destroying the infected skin. This is believed to trigger your immune system to address the wounded area, attacking the HPV virus helping to eliminate it.

If you do nothing, nearly half of all warts will eventually go away by themselves, without any treatment, within about 2 years for children and within 2-5 years for adults.

Most wart treatments involve applying a topical product to the wart for several weeks to around 3 months. The most common method is to attack the wart with a caustic liquid or gel containing salicylic acid. Some products contain either 17% or 40% salicylic acid as a concentrated liquid or patch, like Compound W® and Dr. Scholl's Clear Away®.

When using salicylic acid, always cover the treated area

Avoid using abrasives like sandpaper or emery boards on the normal skin around your wart. Apply your treatment ONLY to the wart itself; injuring nearby healthy skin makes it easier for a wart to spread.

4.Be Patient.

It takes weeks to respond to wart removal treatments and up to 3 months for warts to completely go away, and no treatment works on everyone. If you don't notice improvement after 2 months, try something else or contact your doctor.

5.Try Salicylic Acid First.

Concentrated salicylic acid products have the best track record for removing warts. Apply 40% salicylic acid gel, then cover with a bandage. For sensitive skin, use a product containing 17% salicylic acid.

6.Combine Your Approach.

For stubborn warts, freezing it first, then applying a topical agent will give better results than using either approach alone.




