This endorsement came from the Federal Department of Interior, which reviewed and approved the sports betting amendment to the Tribes' gaming compact. 



from seeping into the wall, but it is also used around windows and doors to prevent air from escaping. Check for significant air temperature differences near windows and walls and use a digital thermometer to verify air leaks. Make sure to also check areas where vents and plumbing fixtures meet the outside wall.

Old caulking can dry out and crack, making it vulnerable to air and water leaks. If you notice dry or cracked caulking, remove as much of it as possible and reseal. Caulking gun sets that include the sealant, scraping and smoothing tool can begin at \$35 and be found online or at your local hardware store.

Examine the roof

The first step of roof inspection is to check the inside of your home. Look for damp spots or water stains on the ceiling or for cracked plaster along the wall. These can be signs of water damage.

At ground level do a visual examination of your roof's exterior for any cracked or missing shingles. Notice if you have to trim back tree branches that may make contact as they can damage your roof's exterior. If you suspect any type of damage, contact an experienced roofer who can perform a thorough inspection.

Clean the gutters

Gutters are necessary to direct water away from your home's foundation. Their exposure to the elements means that they need to be cleaned and inspected regularly. 



What's the easiest way to locate a public charger?

There are various resources to help drivers identify where they can easily stop for a charge. For example, the U.S. Department of Energy Alterna-

What does fast-charging mean?

Not all electric vehicle charging is the same, and charging time depends on how much electricity your EV's battery can handle and how much energy the charger can dispense. Charger power is measured in kilowatts and charging time is measured in kilowatt-hours, a unit of which is the amount of energy a charger can deliver in one hour.

For example, some public chargers only dispense 6kW - such as Level 2 chargers, an option most commonly found in settings like work offices, apartment complexes and hotels. But other chargers, like direct current (DC) fast-charging, uses technology that can dispense 150kW or even 350kW to capable vehicles - allowing for quicker charge times. DC fast-charging is especially great for drivers taking road trips or who don't have access to overnight charging, who will need chargers that can deliver the maximum amount of energy in

gle comfortably. Prioritize grouping furniture to facilitate conversation and interaction while keeping common traffic areas open for ease of movement.

In addition to rearranging furniture, now is the time to address functionality of pieces and swap in multiuse options when appropriate. How do you know which charging connector to use?

You can check your vehicle's specific settings, but most electric vehicles use a connector called the Combined Charging System (CCS). CCS got its "combined" name by incorporating two types of plugs within the same larger plug: the connector for DC fast-charging, and the connector for Level 2 charging. Level 2 is a form of electric vehicle charging with slower charging speeds than DC fast.

CCS is now the most common connector used by electric vehicle manufacturers.

Different electric vehicles have different battery sizes, affecting both the charging speed and how much total energy the battery can accept. Check the vehicle manual for the maximum charging power



On a public fast charger, the speed at which energy enters the car battery slows after the battery reaches an 80% SOC. This may help prevent wearing out the battery too quickly, therefore extending the battery life. The battery can still charge to a 100% SOC, although getting from an 80 to 100% SOC may take a little longer. So while it's counterintuitive, it's best to minimize the time spent charging to 100% battery SOC to reduce wear and tear.

While embracing electric vehicle technology has many benefits and is quickly becoming more mainstream, adopting this lifestyle requires some basic education. By understanding how charging works, new electric vehicle drivers can make the transition to electric much smoother - and perhaps convince others to make the switch as well.





Family of five loses home to fire, one dog did not get out

CHELAN - Last night (Oct. 17 at 10:25 p.m. crews from Chelan Fire & Rescue were dispatched to a reported structure fire at 524 N. Markeson Street in Chelan. First arriving crew was on scene at 10:28 p.m. and reported heavy flames and smoke coming from the rear of the structure and initiated a defensive fire attack.

Residents of the house reported that five people were living there with four of those people in the residence at the time of the fire. All were able to escape without injury. Residents also reported that two dogs were also in the house

and that one did not get out. Second alarm resources from Manson, Orondo, and Wenatchee were dispatched due to the number of exposures nearby and the difficulty in controlling this fire.

Fire was contained at 12:49 a.m. and crews remained on scene to monitor the structure throughout the night.

Residents of the structure were put in contact with Red Cross for shelter and assistance.

A total of 11 apparatus and 24 personnel were on scene with no reported injuries. There is no estimate of total fire loss at this time and the cause of this fire is currently under investigation.

Marine Lt. Col. Scheller Pleads Guilty, Renews Calls for Accountability

Marine Lt. Col. Stuart Scheller pleaded guilty Oct. 14 to all charges against him at a special court-martial trial related to his criticisms about how senior military officials handled the U.S. withdrawal from Afghanistan, although he didn't backpedal from his calls for accountability.

Scheller's punishment has yet to be finalized. U.S. Marine Corps Judge Glen Hines accepted his plea agreement and stipulation of facts, and witnesses testified about Scheller's character to inform his sentencing decision.

Scheller spoke just before this article's publication, and The Epoch Times obtained a copy of his written testimony. Closing arguments are still scheduled before Hines renders his punishment.

According to the written testimony, Scheller apologized for the unprofessional nature of some of his comments, but he still criticized senior leadership for failing to accept accountability for the disastrous Afghanistan withdrawal.

"I believe the General officers have demonstrated that they are unable or unwilling to hold themselves accountable. As a result, I believe fundamental change needs to occur in the military," he said. "I am being held accountable for my actions. The General officers should be held accountable for their failures."

Scheller also criticized the Marine Corps for apparently leaking confidential records about him to Task and Purpose.

"I was painted as a violent extremist, fascist, and the journalist even made a connection to Hitler. Obviously, you can understand that I was very angry following the article," he said. "After everything I've been through, I feel it's reasonable to conclude that the Marine Corps and Task and Purpose were working together in an effort to smear my name."

The Marine further pointed out that he hasn't been charged with making false statements "because everything I have said is true."

"If the Marine Corps could have charged me with it, they would have," he said.

According to a person familiar with the matter, the maximum punishment Scheller faces is a letter of reprimand. He also faces a potential general discharge under honorable conditions, which can reduce the number of benefits available to him.

The Epoch Times also obtained the stipulation of facts accepted by Hines. The document specifies the statements that put Scheller in hot water with his superiors, as well as Scheller's reasons for pleading guilty.

The first charge stems from an Aug. 26 video he posted criticizing leaders for abandoning Bagram Air Base.

"Potentially, all of those people did die in vain if we don't have senior leaders that own up and raise their hand and say we did not do this well in the end," Scheller said.

Scheller also pleaded guilty to charges related to his continued social media messages made after officials placed restrictions on posting.

Florida Fines County \$3.57 Million for Alleged Violation of Law Against COVID-19 Vaccine Passports

The state of Florida has fined a county more than \$3 million for allegedly violating a law that bans entities from requiring proof of COVID-19 vaccination.

Leon County was fined for 714 instances of violating the law, the Florida Department of Health announced on Oct. 12. The law in question, passed earlier this year, forbids any business, government entity, or educational institution from requiring so-called vaccine passports, or proof of vaccination.

Violators face a fine of up to \$5,000 for each violation.

Florida officials warned last month that they would fine violators. Gov. Ron DeSantis, a Republican, said the fines could total millions of dollars.

According to a notice sent to Leon County Administrator Vincent Long on Oct. 6 and released Oct. 12, the government required 714 former or current employees to provide vaccination documentation to gain access to, entry upon, or service from the county government.

The county was ordered to pay \$3.57 million within 30 days by check or money order.

Leon County terminated 14 workers for refusing or failing to submit documentation, Florida officials found.

"These are people that presumably have been serving throughout this whole time. And now all of a sudden, they're basically getting kicked to the curb. And so that violates state law," DeSantis told reporters in Pinellas County.

"They're creating a system where just your operation in normal society is constantly requiring you to have to show different types of papers just to go in. And I object to that, period."

Florida Surgeon General Dr. Joseph Ladapo said in a statement that firing workers over COVID-19 vaccine passports "leads to resentment in the workplace, and loss of employ-

ment impacts individual and public health."

"Individuals have every right to choose how to best protect themselves and their families, and the Department will continue to enforce this law," he said.

COVID-19 is the disease caused by the CCP (Chinese Communist Party) virus.

Leon County is the 22nd most populous in Florida. It has roughly 279,000 residents and includes the state capitol, Tallahassee.

Long, the county's administrator, said in a statement that the county was made aware of the notice.

"The county strongly contends that

our employee vaccination requirement was not only completely legally justifiable, but it was a necessary and responsible action to take to keep our employees safe, protect the public, and ensure our readiness as a frontline response organization."

The county "fully intends to enforce its rights using any remedies available to settle all arguments about the applicability of the statute at issue so that we can continue to direct our full and undivided attention on combating the virus, protecting our employees and citizens, and fulfilling our obligations to our community," he added.

The fine appears to be the first imposed under the law. Other potential violations are being investigated, according to state officials. Some local governments planning to impose vaccine requirements have backed off in recent weeks, including the city of Gainesville.


