# Application period for existing short-term rentals now open

WENATCHEE - Chelan County Community Development is now accepting applications from existing short-term rental operators as of Sept. 27.

The application process will be open through Dec. 31 for those looking to be grandfathered into the new

"We've created a new application, a variety of helpful forms and a website to help people through this process. We also are preparing staff on what to expect and how to accept those applications," said Jim Brown, director of Community Development. "We are expecting hundreds of applications between Sept. 27 and the end of the year."

In July, Chelan County commissioners passed a new code, Chapter 11.88, that establishes the operating standards of the county's short-term rental industry, which has seen rapid growth in most recent years. The code comes after more than two years of board and community discussions.

The county estimates there are up to 1,500 known rental units in Chelan County. Most are single-family homes being used as shortterm rentals.

Through the end of the year, all existing short-term rental operators will be afforded the opportunity to apply to be grandfathered in, as long as they are able to answer "yes" to all of the following questions:

- · Was your location used for short-term rental purposes between July 28, 2019, and August 25, 2020?
- · Can you prove you received short-term rental revenue during that time?
- Can you prove sales and lodging taxes were fully paid for all short-term rental use during that time?

If owners cannot answer yes to all of the above questions, they must apply as a new short-term rental. That application process opens Dec. 1 and runs through July 29. Operators of new short-term rentals can visit the county website and begin their applications at this

time; however, applications will not be accepted until Dec. 1.

For existing short-term rental applicants, a provisional permitting process is being used for the 2021 and 2022 permitting years because of the large volume of applications expected. Upon turning in their applications and paying their fees, applicants will be issued a provisional permit, giving Community Development time to review the application and determine if a final permit will be issued, or if an issue needs to be corrected prior to issuance of the final permit.

"It may take several months to review your application," said Kirsten Ryles, manager of the Community Development's newly created Short-Term Rental Division. "But we will get to all of them as quickly as possible."

Existing short-term rental operators are asked to keep in mind:

· Because of the high number of applications expected, the department highly encourages people to download the application and complete it at home. Then turn the application and its attachments in to CD.STR.applications@ co.chelan.wa.us. If submitted electronically, staff will reach out to you regarding payment. However, applicants also can turn applications in at Community Development, 316 Washington St., suite 301, in Wenatchee.

· Applicants also are encouraged to visit the county's short-term rental website, where they will find not only the application but also checklists of necessary items for submission, a fee schedule, submission date deadlines, and other materials to help them through the process.

· For a short-term rental to maintain its existing, nonconforming status, owners will need to apply for both the remainder of 2021 as well as 2022. To make this process easier, they can apply for both years on their first application.

• If existing operators miss the Dec. 31 deadline, they will need to apply as a new

# Chelan PUD names Kirk Hudson as new general manager

Energy industry veteran brings 24 years of public power experience

WENATCHEE – After an extensive national search, the Chelan County PUD Commission today unanimously selected Kirk Hudson, a recognized public power leader in the Pacific Northwest, as its new general manager. Hudson, who will assume the role on Jan. 1, 2022, has served in several positions for Chelan PUD in the past 24 years, most recently as its managing director of generation and transmission. He replaces Steve Wright who has served as general manager since 2013.

"During our community outreach this spring, we received hundreds of comments from customers and employees about the qualities they wanted to see in a new general manager," said Randy Smith, president of the PUD's Board of Commissioners. "This input was vital to our recruitment process and our selection of Kirk Hudson. He was the clear choice to advance the PUD's mission and continue our work to enhance the quality of life for our customer-owners."

"We heard several consistent themes from the community and employees," Commissioner Steve McKenna stated. "There was interest in recruiting a candidate with strong leadership skills, business management acumen, integrity, background with Pacific Northwest issues, solid communications skills and understanding of renewable energy. We also heard numerous comments about considering candidates internally and within our region."

"Kirk is keenly focused on customers and meeting their changing interests," said Commissioner Ann Congdon. "He shares our interest in creating the best value for customers and continuing to offer new ways for them to do business with us and make choices about energy use."

Commissioners also reinforced Hudson's commitment to implementing the PUD's 2020-2024 Strategic Plan.

"As part of our five-year plan, we're making multiple investments on behalf of customers," said Commissioner Dennis Bolz. "We're modernizing hydropower projects, building new facilities for better customer service, accelerating fiber buildout for faster internet, building new substations and expanding tree trimming to support reliability. Kirk was the best candidate to lead

these critical efforts going forward."

"Kirk shares our vision of providing the best value for the most people for the longest time," added Commissioner Garry Arseneault. "The utility industry is undergoing massive change as we move toward more clean energy sources and new technology. Kirk is very well suited to take advantage of opportunities and create value for the community."

"I am honored the PUD Commission has selected me to be the next general manager," Hudson said. "I'm looking forward to serving our communities in this new capacity. The Commission and Steve Wright have developed a solid five-year strategic plan that we are two

years into, and I'm excited to work more closely with the board and our extremely talented employees who are essential to successfully implement that plan."

In addition to his experience at Chelan PUD, in 2018 Hudson led the formation of the Hydropower Research Institute, a data-driven collaborative aimed at driving the digital transformation of hydropower. He also worked in the consulting industry for seven years prior to joining the PUD. Hudson graduated from the University of Washington with a degree in civil engineering. He and his wife, Andrea, have three children, ages 25, 22 and 20.

Hudson is the 13th general manager since Chelan PUD was formed in 1936. The PUD offers some of the lowest electric rates in the country, as well as providing water, wastewater and wholesale broadband internet services. The PUD reinvests a portion of its revenues back into the community through the Public Power Benefit program, which supports community projects such as expanded fiber internet, day use parking passes to state parks, electric vehicle charging stations, public art and more.

# 25 Mile Fire at 22,117 acres

Burn Severity and Runoff Potential *Mapping Completed* 

CHELAN - The Burned Area Emergency Response (BAER) team has completed mapping burn severity for the area affected by the Twentyfive Mile Fire. Due to persistent cloud and smoke cover, repeated satellite image acquisitions that are usually used to aid in soil burn severity mapping were unusable. The team instead relied primarily on field observations to develop the map. Determining burn severity is an important step in the rapid assessment process, allowing a team to prioritize field reviews and identify increased risks to critical values within or downstream of the burned area. The resulting map displays burn severity in four categories: areas of unburned, low, moderate, or high.

The Twentyfive Mile Fire burned around 22,117 acres. 5% was identified as unlow severity, 35% moderate, and 20% high.

Once the burn severity map was complete, the team considered additional data to develop a runoff potential map. Inputs to this map included the soil burn severity, hydrologic soil groups, rock outcrops, and known water repellent areas, either as a result of the fire or naturally occurring. These inputs modeled together help the BAER team understand where increased runoff is likely to occur. This further analysis was deemed necessary given that the area of re-burn within this fire was substantial and soil burn severity alone is likely to underestimate magnitude of runoff events.

The BAER team determined that 88% of the burned area has a moderate or high runoff potential, so land managers and private landowners should take warning to be prepared to see an increase in flooding and debris flows.



# Comedian Bo Johnson performs at Ruby Theatre

Sometimes, you just know. When comedian Bo Johnson first walked through Chelan's Ruby Theatre, he could instantly feel the punch lines reverberating through the building's seasoned walls.

"When you're in high school and you're at a school play and there's a buzz in the room before the show starts, it's almost that feeling," he said. "It's a beautiful old theater. It's got really nice acoustics and sound. It just feels like a good show as soon as people walk in."

That feeling is vital for someone who's paid for laughs. Johnson received plenty of those during three shows in Chelan Sept. 4-6. The north Seattle comic said people seemed eager to return to normalcy and get their giggle on. On Sunday, thanks to a grateful patron from the Friday show, he and a friend had access to boat to enjoy Lake Chelan. Johnson joked about the opposite scenario of performing at restaurants when the people weren't expecting a comedy show.

"We're going to ruin some-

one's dinner basically. Someone came on a date and there about to be surprised that they're not going to get to talk," he said. "You can tell that the people who are there don't even know that a show is going to hap-

Johnson didn't necessarily know his comedy career was going to happen. He started digging stand-up in middle school and watched Mitch Hedberg clips. After college, he began

restaurant where he had ample time to ruminate while balancing plates. He transferred the material in his head to open mikes around the area. One happy accident that helped speed along his budding comic career was a quirky video he made with his best friend Matthew. By using oversized clothing, Johnson wrapped Matthew around his body to make the duo look like one very large man. With Johnson moving like an obese duck, he waddled up to a movie theater and successfully bought a ticket with for Avengers: Age of Ultron with his friend secretly hidden. The video, titled simply "Bo

and Matthew Sneak into a Movie Theater" became the number one post on Reddit for a day and has garnered over six million views on Youtube. The clip saw airtime on MTV's Ridiculousness and NBC's Caught on Camera with Nick Canon. Eventually, Johnson saw a post online from someone encouraging him to audition for Kevin Hart Presents: Hart of the City, a program where the comic superstar travels to different cities

bussing tables at a seafood looking for budding stand-up comedians. Johnson's audition went well and he ended up meeting Hart and was featured in the second season of the Comedy Central show.

> "Those opportunities don't show up in Seattle too often. There were definitely other people who were far more qualified than I was," said Johnson, who has also opened for Lionel Ritchie. "Sometimes things just work out where you're in the right place to do well at the right time. I was just kind of lucky and that was kind of the kick start of a few other things."

While his break with Hart sparked his career, it's his comedy that keeps it burning. Unlike the aforementioned comedian, Johnson is not particularly high energy on stage. He describes his humor as dry, observational and mischievous. For him, the challenge is transitioning jokes from a personal approval to broader appeal.

"It's coming up with an idea that's funny to just you and the people you care about the most, 'he said. "Then if you can make other people that you don't know laugh at that, that's such a cool feeling."

Even as his star rises in the vast galaxy of stand-up, Johnson keeps his ego deflated. He works for a non-profit in Seattle while fitting in his gigs during nights and weekends. Citing the Chelan shows, he acknowledged that people aren't flocking to the Ruby Theater for him.

"I'm not a household name by any means outside of my own family. I have some credits and have done some cool stuff, but nobody's showing because they know who Bo Johnson is," he said. "I want to make people laugh because it's cool that people are sharing their time with you and you don't know what they did to be able to come out."

Johnson credits Rotten Apple, a central Washington comedy business, with cultivating a booking reputation that people trust. He's previously done some shows for the group including some in Wenatchee.

"Bo is a great person on and off the stage," said Shaimoom Newaz of Rotten Apple. "Chelan loved Bo. He's a great storyteller and is highly dedicated

to his craft. Folks were chatting with him and taking pictures with him after the show."

Indeed, breaking permanently into the tough stand-up business is an uphill battle. It requires hard work and humility. It requires accepting as many gigs as you can and continuing to try new things. It even requires, as Johnson can attest, flying to a small town in the Midwest to, unexpectedly, perform in front of 15 people. True story. But Johnson recalled thinking that if at age 11, he was told he'd perform standup for a handful of folks, he'd be thrilled. Wherever his comedy journey takes him, it's that appreciation for the privilege that ultimately gives Johnson the last laugh.

"I think it's very easy to be caught up in what's the next thing you want to accomplish and the next thing to do," he said. "Getting to go to a beautiful place like Chelan and performing in a cool theater in front of great crowds for three nights in a row and go on a boat and hang out with good people, really shows. It kind of all ready is the dream."







# US Deports Over 1,000 Haitians but DHS Declines to Say How Many Released Into America

DEL RIO, Texas—The United States has deported more than 1,000 Haitians who streamed into the small border city of Del Rio, Texas, although officials are refusing to say how many others have been released into America's interior.

The number of illegal immigrants, primarily from Haiti, rapidly grew under the international bridge near the border last week, at one point topping 14,000. The quick jump sparked the deployment of more than 600 agents and officers, as well as repatriation flights to Haiti.

U.S. officials have since moved more than 6,500 people from Del Rio to other parts of the border in an attempt to alleviate pressure. Approximately 1,083 have been deported back to Haiti on nine flights through Sept. 21, a Department of Homeland Security (DHS) spokesperson told The Epoch Times in an email.

Others are being released into the interior. How many is unclear, because DHS officials aren't saying.

The same spokesperson declined to answer questions about those being released, while Customs and Border Protection as well as Immigration and Customs Enforcement, both offices within DHS, referred The Epoch Times to DHS.

White House press secretary Jen Psaki refused to give the data during a briefing in Washington and DHS Secretary Alejandro Mayorkas has twice this week declined before Congress to share data about the number of illegal immigrants being

released. On Sept. 21, he told senators in Washington he didn't have the precise numbers and wanted to wait so he could provide accurate information; on Sept. 22, he again said he didn't have the data.

"Yesterday, you were asked exactly the same question and you gave exactly the same answer. You would think you would be a little better prepared now that you've been asked that question. ... You don't have that information?" Rep. Carlos Gimenez (R-Fla.) said.

"I work 18 hours a day. So when I returned from yesterday's hearing, I actually focused on the mission," Mayorkas responded. "We will get that data both to the senator who posed it yesterday and to you, congressman, today."

The Biden administration is dealing with an unprecedented surge in illegal immigration, a surge critics say stems from his administration's policies. The number of illegal immigrant apprehensions at the southern border is on track to set a new record for the calendar year. And the administration has refused to shift its strategy, claiming it's working.

Part of the strategy is releasing illegal immigrants into the country's interior, which has been described by some as "catch and release." Some 600,000 illegal aliens have been released into the United States since President Joe Biden took office on Jan. 20, Brandon Judd, president of the National Border Patrol Council, told The Epoch Times in a text message.

That's about half of the aliens who have been stopped by border agents

since the inauguration. They're released with a Notice to Appear, which gives a future court date to kick off their immigration proceedings, or a Notice to Report, a new phenomenon that requests the alien reports to a local ICE office within 60 days of being released.

Two U.S. officials told The Associated Press that many Haitians are also being freed, undercutting Mayorkas's claims that Haiti nationals shouldn't travel to the United States because they won't be able to stay. One official said many of those being freed are being told to report to an immigration

office within 60 days, as opposed to receiving a notice to appear in court.

A Border Patrol source told The Epoch Times that 3,843 illegal immigrants were apprehended in the Del Rio Border Sector in Texas between Sept. 20 at midnight and Sept. 21 at 11:45 a.m., with another 1,125 immigrants evading capture. Another 2,435 were apprehended in the Rio Grande Valley sector, in addition to 301 "gotaways."

An ICE spokesperson told Fox News that the agency has, over the past several weeks, "released numerous immigrants who transferred from the border after determining they could safely be released into the community under alternate forms of supervision." One independent reporter spoke with Haitian nationals on a flight out of Texas headed to inland destinations.

Roughly 8,400 illegal immigrants remained in the makeshift Del Rio camp as of late Sept. 21. Mayorkas told senators on Sept. 21 that the goal was to clear the litter-ridden camp in the next 10 days, with "dramatic results" expected in the next two to four days.

That could prove difficult if more keep crossing the border illegally. Rep. John Katko (R-N.Y.), the top Republican on the House Homeland Security Committee, said on Fox News that lawmakers were briefed on Sept. 21 that 40,000 to 60,000 more Haitians are amassing in Central America "and are on their way in a caravan up to the southwest border."

Katko said some Haitians are being deported but some aren't.

"Why? We don't know," he said. "The lack of consistency is feeding the frenzy to come across the border, the Southwest border. It's making our country a lot less safe."

While Republicans call for more deportations, some groups and Democrats are calling to stop them altogether.

"Deportation flights to Haiti must stop, and those seeking safety at our borders must be granted their legally assured chance to seek asylum," a coalition of 39 groups, including the American Civil Liberties Union, wrote to Biden on Sept. 21.

Senate Majority Leader Chuck Schumer (D-N.Y.), who rarely criticizes Biden, took him to task on the Senate floor in Washington.

"The policies that are being enacted now—and the horrible treatment of these innocent people who have come to the border—must stop immediately," Schumer said.

# Michigan Hospitals Cut Workers, Beds Amid Patient Surge

Employees who lost jobs for refusing the COVID-19 vaccine say cuts are related to staff resignations over vaccine mandate

Staff shortages have forced two large Michigan hospital systems to cut hundreds of beds.

The action comes as a fourth wave of the CCP (Chinese Communist Party) virus, the pathogen that causes COVID-19, has caused hospitals to be swamped with patients.

The Detroit-based Henry Ford Health Systems announced on Sept. 13 that it was cutting 120 beds from five of its eight hospitals due to a lack of nurses and other staff members to service them. Two days later, Beaumont Health Systems announced that it was temporarily closing 180 beds for lack of staffing.

Henry Ford Health and Beaumont Health, along with most of Michigan's hospital chains, implemented requirements earlier this year for all of their employees to be vaccinated against the CCP virus. Those who refuse to do so face suspension, firing, or resignation for refusing the shot.

Henry Ford Health System hasn't disclosed the number of employees it has lost due to noncompliance with its

mandate. Data quantifying the nursing shortage in Michigan are hard to come by.

At a Sept. 9 press conference, Brian Peters, CEO of the Michigan Health and Hospital Association, said that no precise figures will be available until a statewide study is completed later this year.


"What I can tell you is ... I have never heard a consistent theme from across our entire membership like I have on this staffing issue," Peters said. "Right now, our staffing is stressed to a level that we have not seen previously."

In a statement released by Beaumont Health on Sept. 15, CEO John Fox outlined another cause for the flood of patients at the system's eight hospitals.

"Many people delayed getting tests and treatment for medical issues because of their concerns about the pandemic. Now, more than a year and a half after the pandemic began, those delays in care are resulting in medical emergencies," Fox said. "Add in a staffing shortage and you have a perfect storm."

In an interview with The Epoch Times, a former Henry Ford physician, Dr. Mo Talia, who was recently stripped of his hospital privileges for refusing the CCP virus vaccine, questioned the wisdom of "letting go badly needed nurses and other health care workers at a time when they are needed the most."

Former Henry Ford nurse Katie Kirn, who was also let go for refusing to get vaccinated, told The Epoch

Times: "I absolutely think the bed cuts are due to staffing (shortages) because of the mandate."

Former Henry Ford nurse Kristen Noble, who also lost her job for refusing to be vaccinated, told The Epoch Times that a pandemic was no time for a health care system overwhelmed with patients and already short on staff "to be firing health care personnel"

"I absolutely believe there is a correlation between the suspension of staff and systems cutting beds," Noble said.

Henry Ford Health System's an-

nouncement of the bed cuts came on Sept. 13, three days after the system's Sept. 10 vaccination mandate deadline. Vaccine refusers were given until Oct. 1 to change their minds.

"They do not have enough staff to care for their patient load," Noble said. "Patient safety takes a big hit with being short-staffed."

In a Sept. 13 press briefing, Henry Ford's chief clinical officer, Dr. Adnan Munkarah, said that despite the staff shortages and resultant bed cuts, "our patients continue to receive the highest and safest level of appropriate care from our care teams."

The Biden administration's national vaccine mandate, which affects 17 million health care workers, isn't helping the situation, according to Rick Pollack, president and CEO of the American Hospital Association.

"As a practical matter, this policy may result in exacerbating the severe workforce shortage problems that currently exist ... which the American Nurses Association has called a national crisis," Pollock said in a Sept. 9 statement.

According to the Michigan Annual Nursing Survey for 2020, nearly one in five registered nurses and licensed nurse practitioners have said they plan to leave the profession within the next five years.

The survey of more than 40,000 Michigan nurses found that one in five cited too heavy a workload, stress, safety issues, and not enjoying the profession as some of their main reasons for leaving.

According to the Michigan Hospital Directory, the state has 185 hospitals with 26,632 beds. As of Sept. 20, 30 of the state's hospitals were at 85 percent or higher occupancy, with the average occupancy rate being 78 percent.

The state of Michigan's official virus-tracking website shows that on Sept. 20, there were 1,492 adults in hospitals sick with the virus. From Sept. 18 through Sept. 20, there was an average of 2,395 new cases per day.

Since the pandemic struck Michigan in spring 2020, there have been 995,910 confirmed cases of the CCP virus, resulting in 20,700 deaths.

# **US Rights Group Calls on UN to Address** China's Forced Organ Harvesting

U.S.-based advocacy group Doctors Against Forced Organ Harvesting (DAFOH) is calling on the United Nations to take action against China's state-sanctioned practice of killing prisoners of conscience to supply organs for its lucrative transplant market.

"The failure of the United Nations to address and thoroughly investigate the forced organ harvesting from living people in China is an unacceptable omission that needs to be resolved," said Dr. Torsten Trey, founder and executive director of DAFOH, in a Sept. 23 press release.

Condemning this inhumane practice remains an unfulfilled task for the largest organization in the world.

The 76th session of the U.N. General Assembly began on Sept. 17 in New York City, as world leaders and foreign ministers gather to discuss issues such as climate change and the COVID-19 pandemic.

DAFOH stated that China's horrific practice should be on the agenda of the world body. It also called on participants of the U.N. summit to "treat this issue like any other crimes against humanity."

"After more than two decades of forced organ harvesting from living Falun Gong practitioners and other prisoners of conscience, DAFOH believes the UN has fallen short in taking the lead in stopping these crimes against humanity," according to the press release.

China is one of the top destinations for those in need of vital organs as its transplant industry boasts an extraordinarily short waiting time. To explain such a phenomenon, the communist regime has claimed that there are many voluntary donors in China while locals have a low demand for transplant organs. Beijing has also said it relies on its national organ donation system to procure

In 2019, evidence surfaced that Beijing was killing innocent people to drive its transplant market. That year, a London-based people's tribunal published a report concluding that forced organ harvesting was happening on a "significant scale" in China, with Falun Gong practitioners being the main source of

Adherents of Falun Gong, a spiritual practice also known as Falun Dafa, have been targets of persecution by the Chinese regime since 1999. Several years later, the Chinese regime allegedly began harvesting organs from detained Falun Gong adherents.

China's public transplant data has also been debunked, according to a 2016 report by David Matas, a human rights lawyer; David Kilgour, former Canadian Secretary of State for Asia-Pacific; and Ethan Gutmann, a U.S. investigative journalist. The report estimated that Beijing carried out between 60,000 and 100,000 organ transplants a year, as opposed to 10,000 claimed by Beijing.

The report concluded that most of the organs came from Falun Gong adherents, while the remaining originated from other prisoners of conscience—House Christians, Uyghur Muslims, and Tibetans.

"Given the scope of China's organ harvesting crimes with an unknown number of victims and the nature of the crime itself, a commercialized murder for transplants, condemning this inhumane practice remains an unfulfilled task for the largest organization in the world," Trey added.

The United Nations, the Office of Spokesperson for the U.N. Secretary-General, and the U.N. High Commissioner for Human Rights (OHCHR) didn't immediately respond to requests for comment.

In June, OHCHR special rap-

porteurs and several other human rights experts said they were "extremely alarmed by reports of alleged 'organ harvesting' targeting minorities, including Falun Gong practitioners, Uyghurs, Tibetans, Muslims, and Christians, in detention in China."

They called on China to "promptly respond to the allegations of 'organ harvesting' and to allow independent monitoring by international human rights mechanisms."

China's forced organ harvesting is now being discussed at the World Summit on Combating and Preventing Forced Organ Harvesting, which began on Sept. 17 and resumed on Sept. 24, ending on Sept. 26. DA-FOH is one of five NGOs sponsoring the online event.

# Biden Administration 'Strongly Opposes' Honorable Discharge for Troops Who Refuse COVID-19 Vaccine

President Joe Biden's administration on Sept. 22 came out against efforts to prevent dishonorable discharges for U.S. troops who refuse to get a COVID-19 vaccine.

The Office of Management and Budget said in a policy statement it "strongly opposes" an amendment to the 2022 National Defense Authorization Act (NDAA) that bars any discharge but honorable for service members.

The provision "would detract from readiness and limit a commander's options for enforcing good order and discipline when a Service member fails to obey a lawful order to receive a vaccination," the office said, adding that commanders "must have the ability to give orders and take appropriate disciplinary measures" in order to have "a uniformed force to fight with discipline."

The amendment received support from members of both parties during a markup of the act on Sept. 1. It was authored by Rep. Mark Green (R-Tenn.), a military veteran and a doctor.

At the time, Green said he understood the need for a vaccine mandate but noted that no longitudinal data is yet available for the COVID-19 vaccines, adding that service members who decide not to get vaccinated and are ultimately discharged should receive an honorable discharge.

"I am dismayed and concerned that the Biden administration is trying to remove my amendment to the National Defense Authorization Act that prevents anything but an honorable discharge for servicemembers who refuse to get the COVID-19 vaccine," Green told The Epoch Times in an email.

"This was a bipartisan amendment—not one Democrat on the House Armed Services Committee opposed it. Nothing is more telling of the current political climate than the Biden administration refusing to respect the rights of our military that every House Democrat on the Committee voted for."

Defense Secretary Lloyd Austin last month ordered U.S. troops to get Pfizer's COVID-19 vaccine shortly after it was approved by the Food and Drug Administration. The order was backed by Biden, who has imposed mandates on all government workers and has ordered a mandate on the private sector.

Service members who aren't approved for a religious or medical exemption and still don't get vaccinated will face discipline, the Pentagon

"Our commanders have a range of tools available to them short of using the Uniform Code of Military Justice to again try to get men and women in the department to make the right decision here," Pentagon spokesman John Kirby told reporters during a briefing.

The Biden administration also said it opposes another amendment, which would exempt troops who demonstrate they have recovered from CO-VID-19 from the mandate.

COVID-19 is the disease caused by the CCP (Chinese Communist Party) virus.

The protection afforded by recovery is known as natural immunity, and some scientists argue those who have it shouldn't have to get vaccinated.

That amendment "would create a new and overly broad exemption from the vaccination requirement for previous infection that would undermine the effectiveness of the requirement," the Office of Budget and Management stated.

If the provisions don't stay in the NDAA, they could be passed separately. Four senators on Sept. 21 introduced a bill that would prevent dishonorable discharges for troops who don't get a COVID-19 vaccine.

# Florida Acquires Monoclonal Antibodies From GlaxoSmithKline After Biden Administration's Rationing

The state of Florida has obtained thousands of monoclonal antibody treatments to treat COVID-19 from a UK-based company after the Biden administration's abrupt rationing of federally acquired doses.

Florida went to GlaxoSmithKline, which produces monoclonals that haven't yet been bought up by the federal government. They reached an agreement on about 3,000 doses, Gov. Ron DeSantis announced on Sept. 23.

"That's showing that we're going to leave no stone unturned. And, if there's somebody that needs a monoclonal antibody treatment, we're going to work hard to get it to them," the Republican told a press conference in

The Biden administration seized control of monoclonals this month in response to what some officials have described as a national shortage. The federal government has bought millions of doses from Eli Lilly and Regeneron. The only other monoclonal authorized for use in the United States is produced by GlaxoSmithKline, or GSK.

A GSK spokesperson confirmed to The Epoch Times in an email that Florida obtained doses of its treatment, which is known as sotrovimab.

The doses were through AmerisourceBergen by CDR Health, the company stated. Any health care providers or facilities have an option of directly ordering the treatment.

The wholesale cost per dose is \$2,100 roughly the same as its competitors were charging the government. Patients often pay much less, if anything.

Drug regulators in May authorized GSK's treatment for mild-to-moderate COVID-19 in patients 12 and older and weighing at least 88 pounds.

Regulators and state officials say the drug and similar others help keep people out of DeSantis estimated thousands of Floridians

have been able to avoid going to the hospital after getting COVID-19 or being exposed to a positive case because of the treatments. But, like other states across the country,

Florida is struggling with a looming shortage because of the Biden administration's sudden rationing. Florida announced last week it was in touch

with GSK. Health officials in other states told The Epoch Times they're not exploring buying their own treatments, with some suggesting that cost was a factor. Earlier this month, sites in Florida were

getting more than 30,000 doses. That doesn't include hospitals. All sites could order directly however much they needed, and the federal government provides the doses for free. In the next weekly shipment, Florida was scheduled to receive less than 18,000, state officials say.

"I would hate to see somebody who really could benefit from this treatment not be able to have access to it. When we know that the track record has been very, very positive," DeSantis said.

He hosted Floridians who credit monoclonal treatments for their recovery.

Betsy Palmer Bigler, a former teacher in Pascoe County, received Regeneron's monoclonal antibody treatment, as did her husband and her father after her husband tested positive for COVID-19.

"I certainly feel that it saved probably one or all three of our lives," she said.
