## **Rock slope scaling** project on US 97A will bring highway closures

Project south of Entiat begins March 29 with two full weeks of hourly closures

ENTIAT – Another rock slope scaling project to address an unstable slope along U.S. 97A begins Monday, March 29. The work will require two weeks of daytime highway closures from milepost 213.63 to 213.76, about a mile south of Entiat. Strider Construction has been awarded this project with a bid of

Similar to the rock scaling work completed last summer, contractor crews will remove loose, unstable rock from slopes adjacent to U.S. 97A in an area where rock fall often reaches the highway. To complete the work, crews will close the road between 8:15 a.m. and 5 p.m. weekdays, utes on the top of every hour to allow traffic through the work zone. These extended closures allow the contractor to complete more work, shortening the project duration, and ensures the safety of travelers.

The closures will last two weeks, and work is scheduled to be complete by 5 p.m. Monday, April 12. April 13 and 14 there will be flagger controlled traffic with delays up to 10 minutes as the contractor wraps up the project. The highway will be open during non-working hours and on weekends.

OLYMPIA - Gov. Jay Inslee on March 18 announced that the statewide eviction moratorium will be extended through June 30, as well as upcoming vaccine eligibility expansion, including restaurant workers and Washingtonians 60 and older. He also announced that effective immediately, visitations at longterm care facilities and nursing homes may resume.

In addition, the state Department of Health (DOH) launched a new web tool to help people find open vaccination appointments near them.

> **Eviction moratorium** extension

The governor announced that the statewide eviction moratorium will be extended through June 30. The moratorium, first put in place exactly a year ago today, has been a vital protection for families struggling with the persistent economic effects of the COVID-19 pandemic.

"The pandemic's economic toll continues to burden many Washingtonians, particularly tenants," Inslee said during a press conference Thursday. "People need these supports right now. There is no other way to look at it."

Since the moratorium was first instituted, hundreds of millions of dollars have gone

## **Sheriff Burnett: Short Term Rental rules will only** be enforced during normal work hours ... for now

MANSON - At a recent Zoom meeting of the Manson Community Council (March 16), Chelan County Sheriff Brian Burnett explained that when the time comes to start enforcing Short Term Rental (STR) rules, it will be handled by a force of "code

enforcement" sheriff's office officers who will be on duty Monday through Friday, during normal working hours.

Burnett went on to say that these officers must undergo similar police academy training on certain subjects like use-offorce, firearms and driving before they will be allowed on the streets to enforce STR issues.

This learning curve is expected to last four weeks, but some applicants may take less time if they are already previously experienced law enforcement

Once these criteria are met, candidates for the three positions would also be required to learn code enforcement. Burnett expects the county offices responsible for STR rules will be teaching staff the new rules. That would mean Chelan County Community Development staff.

Burnett said there would be one position (new hire) for Leavenworth, one for Chelan and one supernumerary as in an "at

# Brush fire consumes three acres

At 3:10 p.m. on March 21 Chelan Fire and Rescue and Chelan County Fire District #5 were dispatched to a Brush Fire on Little Butte Ranch Road. Twenty mph wind gusts caused an ember from a smoldering burn pile to catch the nearby sagebrush and grass on fire. A second alarm was called as the fire was spreading quickly in the thick pockets of sagebrush. The erratic winds eventually shifted in the opposite direction helping crews to get around the head of the fire keeping it at about three acres in size. This was the first significant brush fire for Chelan Fire and Rescues new Brush 74 Heavy which is a six wheel drive 1,000 gallon brush truck with a high ground clearance allowing it to go over sagebrush and rougher terrain which proved very helpful on this call.

Normal working hours in this case would mirror any other government agency's 8-5 or thereabouts office hours. Burnett said it may become more flexible in the future and might even be subject to evening and weekend shifts within the code

enforcement department. As of right now, Burnett is asking for some "slack" as the entire concept is a fairly new one in the realm of county law enforcement and he sounded sure that minor tweaks will be an ongoing chore before the kinks are ironed out, hopefully by the fall season.

As far as the expected deploy-

ment of these officers, Burnett stated it would be around mid-May to early June.

He said he still needs to work with his staff to formulate a job description, policies and procedures as well as deal with sworn and administrative personnel and their respective unions.

The codes are due to be officially on the books around April 5, in time for tourist season. Burnett said there was a distinct difference between the expected Memorial Day crowd and the July Fourth tourists.

He noted the 4th tourists were perhaps a bit more rambunctious, but the code enforcers would already have boots on the ground, and with a little mud on them, by that time.

Burnett said the Leavenworth/Plain and Chelan/Manson areas are the two parts of the county expected to receive the most attention when STR rules start to apply.

He said most if not all county residents, live in Commissioner Bob Bugert's (Leavenworth) district or, in the case of Lake Chelan, in Commissioner Tiffany Gering's district.

Perhaps the biggest surprise, as gauged by the reaction of MCC members, was the fact that these code enforcers will not be available 24/7 like the normal sheriff's office patrol deputies.

Burnett told them that in the meantime, complaints should be called-in to a non-emergency administrative phone voice mail for action beginning the following workday morning.

So, if you are complaining

a Saturday night, it isn't going to be handled by the Chelan County Sheriff Office (CCSO) department of code enforcement until Monday, depending on where your complaint might fall in the order of complaints received. However, if you hear gunshots

or see acts of violence or public safety concerns, then call the regular Rivercom emergency dispatch center and a deputy will be sent to that location asap.

Burnett said his office is experienced in serving warrants and legal notices and the like, but not in the area of STR's.

He clearly made sure the MCC members and a couple dozen citizen listeners under-

stood that there was a huge difference between a criminal act and a code violation. The latter may be subjected to a fine, like a barking dog complaint, if the issue isn't corrected. After the initial response by the officer, a \$75 fine on second infraction or \$150 on third violation may result in an issuing of an order to appear in court. Details not yet set.

Burnett said the regular CCSO patrol cars would be painted in silver and have lettering on the car stating: "Code Enforcement."

The enforcement officers would be armed and in uniform and that is why they must undergo police academy training, he said.

About 33 people, including

MCC, staff and invited guests, attended the meeting.

They were also witness to Burnett's description of taking on this code enforcement challenge when he said he didn't really jump at the chance to take on this responsibility, but realized it was the best thing to do for the citizens of Chelan County.

"I try to be a team player" with the close cooperation of the Commissioners and the Community Development Department," he said.

He then asked the MCC and the entire STR-affected area to give him "a little bit of grace and patience" as he was hoping to iron out the kinks by a year from now, once tactics and policies are worked out.

Long-term care visitations

Effective immediately, visitation at long-term care and nursing home facilities may resume, eliminating visitation phases, in accordance with guidance from the Centers for Medicare and Medicaid Services and the Centers for Disease Control and Prevention.

Outdoor visitation remains the safest, preferred option, but indoor visitation will be permitted for visitors or residents who are fully vaccinated. Compassionate care visits will still be permitted, regardless of vaccination of either party.

"These new visitation guidelines are very welcome after a year that was filled with so much hardship and isolation," said Bill Moss, assistant secretary, Department of Social and Health Services. "Thanks to the effectiveness of the vaccine, infection control procedures and previous visitation restrictions, we are now seeing a steady decline in facilities reporting COVID-19, which means longterm care facilities can begin implementing a process for in person visits."

Indoor visitation is not allowed if there is a current active outbreak in a facility or for residents with confirmed cases of COVID-19 or in quarantine due to exposure to the virus.

Long-term care and nursing home facilities must follow Core Infection Prevention Principles, like symptom screening, environmental cleaning, PPE and testing, among other infection prevention tactics.

**Public-private partnerships** In order to improve access for eligible Washingtonians to find and make vaccination appointments, as well as provide more resources for vaccination sites statewide, the governor announced a myriad of public-private partnership efforts stemming from the Vaccine Action Command and Coordina-

tion System Center. "Our success in getting more than 2.5 million doses administered to date is thanks to the efforts of many dedicated providers and public health professionals, as well as the National Guard," Inslee said. "These public-partnerships with small and large Washington-based employers have helped us improve delivery of the vaccine to the people of Washington."

Last week, the Department of Health launched a new, user friendly web tool to help Washingtonians find a vaccination appointment. The web tool looks at various scheduling options from multiple providers to find a vaccination appointment easier and is available in multiple languages.

The web application was made possible by a number of partnerships with Washington companies, including Microsoft, Starbucks, Expedia, Costco, Prota Ventures, among others.

The state is also collaborating with Amazon to improve

customer support for the state hotline for scheduling vaccination appointments. Starting next week, Amazon call center representatives will join existing hotline workers to schedule vaccine appointments for eligible Washingtonians who may have difficulty accessing or using technology needed to register online.

Finally, Challenge Seattle, an organization of CEOs from 20 of the largest employers in the Seattle area, will be publishing a Playbook for mass vaccination sites. This resource, for public and private organizations running or planning on setting up clinics, will help centralize best practices and lessons learned through the vaccine administration process here in Washington

"It's another great day to be from Washington state," Inslee said. "From protecting people's housing to helping people see their loved ones and getting more Washingtonians vaccinated, we're continuing to move forward toward recovery."



NCW - Seasonal road closures on Oklahoma Gulch Road (Entiat) and Mountain Home Road (Leavenworth) will remain in effect until further notice. Both roads have not been re-opened as scheduled because of snow on the roadways. Road crews will monitor the two roads, and we will update the public when they are re-opened.

As a reminder, Horse Lake Road (Wenatchee) also remains closed until at least April 1. The seasonal closure will be re-evaluated at the end of the month to determine if it will be re-opened, as scheduled, on that date.

Horse Lake Road is among four seasonal road closures that are put in place annually by Chelan County Public Works. The closure on Horse Lake Road, which is done in conjunction with the closure of the Sage Hills trail system by the Chelan-Douglas Land Trust, is due to migrating mule deer that feed off the spring greenery after enduring the lean winter months. The number of deer in that area typically peeks in March, according to the land trust.

It is the obligation of all land owners under RCW 17.10.140 to eradicate all Class A noxious weeds and control and prevent the spread of all Class B and Class C noxious weeds listed on the Chelan County Noxious Weed List. Noxious Weeds can be highly destructive, competitive and difficult to control. These plants invade our croplands, rangeland, forests, parks, rivers and lakes, causing both ecological and economic damage that affects us all.

To help protect Chelan County's resources and economy, the Chelan County Noxious Weed list has been adopted for 2021 and includes all Class A and Class B Designate species from the Washington State Noxious Weed List, and selected Class B Non-Designate and Class C species. The list is posted on the Chelan County Noxious Weed Control Board website and is also available by request from the office.





When a drug triggers a side effect, another consideration is how important it is for you to stay on a medication that could be causing side effects. Heart medicines and antibiotics are examples of drugs that should not be stopped abruptly unless you experience a severe reaction or under your doctor's advice.

Here are 6 tips on treating side effects of medicines:

1. Document when you take your first dose.

The best way to tell if a new symptom is caused by medicine is to verify that it showed up AFTER you started taking it.

2. Call 911 for any severe allergic reaction.

Shortness of breath or swelling or itching of your mouth are signs of a severe and lifethreatening reaction. Don't call

your doctor; call 911. 3. Inform your doctor.

Most primary care clinics have an "after-hours" phone number or an answering service that answers phone calls that come in after they are closed for the day.

If you experience a rash, itching, or hives, DON'T take any more medicine. Contact your doctor immediately, instead. If you develop any mouth or tongue swelling or tingling or any problems breathing, call 911

instead of your doctor. 4. Know when to re-dose. If you vomit more than 30

minutes after taking your medicine, DO NOT REDOSE. After 30 minutes, your body has had enough time to absorb most of the drug. Nausea is the most common side effect of antibiotics, and they can't help you if you don't absorb the entire dose.

Try eating something bland or drinking something soothing, then repeat the dose in about an hour. If you vomit it up again, contact your doctor right away to get a different antibiotic, even if it is after hours.

5. Don't mix liquid antacids with antibiotics.

Liquid antacids like Maalox and Mylanta contain minerals that bind to many antibiotics, preventing them from being fully absorbed.

6. Apply medicated patches to alternative sites.

To reduce skin irritation, try applying medicated patches to your buttocks instead of your abdomen. Pre-medicating a new patch site with non-prescription hydrocortisone 1% cream or Voltaren gel may also help prevent itching.

Individual taxpayers do not need to file any forms or call the IRS to qualify for this automatic federal tax filing and payment relief. Individual taxpayers who need additional time to file beyond the May 17 deadline can request a filing extension until Oct. 15 by filing Form 4868 through their tax professional, tax software or using the Free File link on IRS.gov. Filing Form 4868 gives taxpayers until Oct. 15 to file their 2020 tax return but does not grant an extension of time to pay taxes due. Taxpayers should pay their federal income tax due by May 17, to avoid interest and penalties.

The IRS urges taxpayers who are due a refund to file as soon as possible. Most tax refunds associated with e-filed returns are issued within 21 days.

This relief does not apply to estimated tax payments that are due on April 15. These payments are still due on April 15. Taxes must be paid as taxpayers earn or receive income during the year, either through withholding or estimated tax payments.

In general, estimated tax payments are made quarterly to the IRS by people whose income isn't subject to income tax withholding, including self-employment income, interest, dividends, alimony or rental income. Most taxpayers automatically have their taxes withheld from their paychecks and submitted to the IRS by their employer.

State tax returns

The federal tax filing deadline postponement to May 17, 2021, only applies to individual federal income returns and tax (including tax on self-employment income) payments otherwise due April 15, not state tax payments or deposits or payments of any other type of federal tax. Taxpayers also will need to file income tax returns in 42 states plus the District of Columbia. State filing and payment deadlines vary and are not always the same as the federal filing deadline. The IRS urges taxpayers to check with their state tax agencies for those details.
