Gebbers Farms responds to L&I action

BREWSTER – The latest action by the Washington Department of Labor and Industries announced on Dec. 21 in the form of a \$2,038,200 fine against Gebbers Farms elicited a one-page response from the Brewster-based company on the same day.

Gebbers Farms Company Statement Regarding Dec. 21, 2020, L&I Announcement

December 21, 2020 - We are deeply disappointed by the

evidenced by the fact that 99.3% of our entire workforce tested negative for the virus, which is better than county, state and national rates to date. While we cannot comment on the specific violations because we are evaluating our options to appeal, we strongly disagree with the agency's assessment. Gebbers Farms collaborated with an infectious disease specialist early in the pandemic to develop a group-shelter program that put employees' health, safety and well-being first. Our groupshelter program had many of

of common areas, and using exhaust fans to create extra airflow in living quarters.

We had already established cohorts of 42 people before the state set a 15-person cohort. We consulted experts to develop our program, and there is nothing magical about the number 15. Consider that the state recommended size for community group gatherings is far fewer today than at any other time in the year, and community cases are rising. We said that we would (and we did) change our program as quickly as possible

following: "The L&I based its fine on the same allegations it made last summer when it issued an Order of Notice of Immediate Restraint (OIR) against Gebbers. We learned after the attached statement was released that the Board of Industry Insurance and Appeals (BIIA) ruled this week that Gebbers Farms was in compliance with the emergency rule on July 27 – the date that L&I issued the OIR. The judge also stated that the OIR makes no specific allegations as to how any worker's death might be related to any condition, practice,

method, or process present in Gebbers' workplace(s) or how Gebbers specifically violated the COVID-19 emergency rules."

"In reference to the worker death that was not reported in eight hours-Gebbers Farms did not learn of the worker's passing for several days because the hospital would not release the information to the company," Philpott said.

Philpott noted that "the BIIA ruling doesn't negate the fine and the citations. It demonstrates that, during the inspections, Gebbers Fully intended (and did) comply with the emergency order."

'The company will be appealing the fine." Philpott said.

Over the years additional cut out board displays have been made, which visitors and neighbors love for picture opportunities. The candy canes in the downtown area were made by an assembly line of volunteers in Jeff and Debbie Conwell's backyard. Volunteers traced and cut patterns, some sanded and it was group painting party. Ron Trickett, one of the

team leaders said. "Last year we added animated displays to the Manson Bay Park that capture the ambience of the area with Santa fishing in the lake and a farm tractor pulling a trailer along with the traditional Santa checking his list twice with his "Naughty or Nice Elf" assistant. We have been gradually upgradally enhance the vibrancy of these elements. This required exchanging almost 1,200 bulbs with assistance from Deb Conwell, K.J. Chelan PUD: Current compassion trumps 'more equitable future'

I am a big fan of our Chelan County Public Utility District and its dedicated staff and management. I am a huge fan of efficiencies and frugalities. I have also lived in other places where the utility company is a citizen-owned cooperative and gave dividends to its owner/ customers at the end of the year, if money was made.

Once again, I am a huge fan of the PUD commissioners, all of them, as well as General Manager Steve Wright.

Here's the rub, from a strictly compassionate point of view. Before I rant, please read the



below quote sent out by the PUD just after its Nov. 17 meeting. I started the quote with the headline that topped the news release in bold:

"PUD envisions a more equitable future for households who struggle most: Chelan PUD commissioners heard a plan last month to expand energy conservation programs to focus on households that spend more than 6 percent of their income on power bills. About 2,100 households qualify as "high energy-burdened" because they spend more than 6 percent of their paychecks on electricity. About 98 percent of these households earn less than \$20,000 a year. Staff recommended greater engagement with nonprofits and landlords, as well as greater assistance to help low-income homeowners cover the up-front cost of home improvements.'

I am overjoyed that staff has suggested greater interaction and cooperation with the landlords and non-profits of these unfortunate citizens, but these measures won't occur until sometime in 2021.

How about right now? Can commissioners see it in their hearts, during this, the greatest modern pandemic to ever hit America, to forgive the 2,100 households' electric bills at least for the month of December?

There is no harm to the PUD profits if just a small handful of impoverished citizens get a month without an electric bill. I have never been a member of the Communist Party, my idea is merely a decent gesture to our decent people who need a break

in life, especially during this bizarre time of our history.

We are spending millions on the new PUD headquarters in Olds Station. The salaries of the commissioners and a few senior staff cost more than the forgiveness of 2,100 families' electric bills.

I am writing this with the full

Thanks for your letter (See "Apples" column inside) suggesting Chelan PUD provide free electricity to low-income consumers for a month in light of the pandemic and associated challenges. We love to hear from our customer-owners. We appreciate and share your empathy for fellow citizens who are most in need. In fact, the PUD already supports customers with challenges in the following ways:

We have the lowest or next to lowest electric rates in the country benefiting everyone in Chelan County.

We have discounts available for low-income and senior customer-owners as well as for disabled customers that apply year round.

We partner with Community Action Council in helping customers who qualify for energy assistance under the federally-funded Low **Income Energy Assistance** Program (LIHEAP) to cover a large portion of their electric bills. This program has paid out nearly \$186,000 to over 500 Chelan County households with an aver-March of 2020.

Last month, PUD Commissioners also directed staff to advance aggressive energy efficiency programs that are targeted at low-income customers. We believe these programs provide substantial benefit because they provide long-term lower bills. Reducing electricity use also allows the PUD to sell the power in the wholesale market offsetting the cost of the energy efficiency investment and reducing the impact on other customerowners.

We reviewed your proposal while keeping an eye on your other concern that we

customers is that the PUD does not maintain income records for our customers. We would have to find a way to get this information, match it up with our billing records and make changes to our billing systems - all for one month's bill reduction. That's a lot of bureaucracy and administrative cost. We think there may be a better alternative.

The Board has considered in recent months the possibility of making some form of a PUD contribution to the Helping Hand program. We are still doing the legal research, but this might be done as a match for any dollars customer-owners contribute. We have been actively tracking customer overdue bills since the pandemic began. We have only a modest increase in overdue residential accounts. We think an amount of roughly \$50,000 would keep our overdue balances about equal with previous years. This should assure that the unique challenges created by COVID-19 are addressed. So, on Monday, Jan. 4 our Board will consider and take public comment on making a contribution to our Helping Hand program. We will do this in public session in order to fulfill our firm com-

mitment to transparency. Thank you for your suggestion and the contribution the WBJ (Wenatchee Business Journal) makes to our community.

THE WASHINGTON OUTDOORS REPORT

Outdoors round-up

By John Kruse, The WASHINGTON OUTDOOR REPORT

There is a lot of news to cover as we roll into the new year covering everything from salmon forecasts to adjusted sportsmen's show schedules to winter recreation in our state parks.

COLUMBIA RIVER FISH FORECAST - The Oregon and Washington Departments of Fish and Wildlife have issued their joint forecast for fish returning up the Columbia River in 2021. The good news is a number of projected runs are better than last year. Lower Columbia tributaries like the Cowlitz, Kalama and Lewis are expected to see higher numbers of Spring Chinook coming back. However, the overall return for springers past Bonneville Dam (and all the tributaries beyond) is again troubling with only 75,000 fish predicted to come back. This would be the second lowest year since 1999 for spring Chinook salmon.

As spring turns to summer the Chinook forecasts do get

better. Nearly 78,000 summer Chinook are expected to head towards the Upper Columbia, which is nearly 20 percent over last year's run. We don't have hard numbers for fall bright Chinook but biologists expect continued improvement there as well. Coho salmon should see a banner year of young jacks returning, the highest number since 1977.

On the other hand, the Sockeye return is only expected to be around 156,000 with only 700 heading up the Snake River. This is less than half the number that returned last year up the Columbia. Then again, sockeye salmon forecasts have been notoriously inaccurate in recent years and most of the time Columbia River sockeye numbers have been stronger than forecast.

Finally, there's the American shad. Six million came back last year and another strong run is expected for 2021. If you are just looking for a fun day of casting and catching one to four-pound, scrappy fighting fish, consider a trip to the Columbia River below Bonneville or the John Day Dam between late May and mid-July to catch a whole bunch of shad and while you

can fish from a boat, bank angling works just fine too.

FIRST DAY HIKES - Normally, Washington State Parks hosts a number of guided "First Day Hikes" on New Year's Day but because of Covid-19 restrictions your First Day Hike for 2021 will be a do-it-yourself affair. On the bright side, no Discover Pass is needed to enter any of Washington's State Parks on New Years Day and Martin Luther King Day (January 18th) is a free day for day use activities in Washington State Parks as well.

If you decide to go crosscountry skiing or snowshoeing at one of the state parks that has warming huts be sure to check in advance to see whether those huts are open. Covid-19 restrictions has forced the closure of several this winter.

SPORTSMANS SHOW SCHEDULES – Sportsmen's show season came to a crashing end last March as events were banned with the arrival of the Covid-19 pandemic and things are not much better right now. With that in mind, all of the sportsmen's shows scheduled for January have been postponed. Here's a current line-up of shows that producers are hoping to put on in the first quarter of 2021:

For example, let's say you enter into a forbearance agreement of three months. If your monthly mortgage payment is \$1,000, you will owe about \$3,000 in missed mortgage payments at the end of your forbearance term. Your servicer can help you determine the workout option that works best for you, including:

• Full repayment, where you pay back the missed payments all at once.

• Repayment plans, which allow you to catch up gradually while you are paying your regular monthly payment.

• Payment deferral, which allows you to resume making your normal monthly payment. Your servicer can work with you to leverage alternative ways for you to pay back the missed payments from your forbearance period at a later date and in a manner that is affordable.

• Modification of the loan, which changes the terms of your loan, usually to reduce your original monthly payment amount. Your servicer can help with a modification that might suit your new circumstances.

Additional Information: To stay on track with paying down your loan balance and less interest over the life of the loan, it's important that you resume your payments as soon as you're financially able. Keep in mind that while you're not charged "extra" interest, you won't be paying down your principal, and the interest will continue to accrue on your unpaid mortgage balance.

Good healthy habits to practice daily

My husband and celebrated our 38th wedding anniversarv last week, on Dec. 21. We usually mark the occasion by having dinner with our oldest friends, Dick and Kay, a couple who stood up with us on that afternoon all those years ago. Although Dick passed away 6 years ago from pancreatic cancer, we still have dinner every year on Dec. 21 with Kay. Except for this year.

We couldn't make reservations at our favorite restaurant to eat, but that wasn't the only reason. Kay is in the hospital, fighting COVID. Bombarded with reminders

to "Mask Up," practice Social Distancing by staying 6 feet from each other, and avoid gatherings, it has been a lonelier holiday season for most of us.

Although these 3 habits have been proved to reduce the spread of COVID in communities, there are two OTHER habits that can make a difference in reducing the risk of transmitting COVID to our loved ones.

One of the best ways to stay healthy is to develop 2 habits that I call Healthy Habits: Wash or sanitize your hands frequently and thoroughly, and extinguish face touching behavior, particularly avoiding your eves, nose, and mouth.

When I teach about antibiotics and infections with my pharmacy and physician assistant students, I always emphasize how they will be on the front lines of medical care. Whether as pharmacists or physician assistants, they'll be exposed to more infections than if they worked in other settings because their customers or patients will be coughing and sneezing near them.

These two habits have been shown to help reduce infection long before COVID showed up and will continue to be significant even when COVID is finally vanquished.

Long before COVID, face touching has been associated with the spread of respiratory illnesses such as common colds, influenza, and flulike infections. The area most important to avoid touching is the "T-Zone" of your face: your eyes, nose, and mouth.

Touching our face with our hands is an unconscious habit for most people. One study done in 2008 observing behavior in the office work setting showed that workers touched their faces nearly 16 times every hour in that environment.

A group of 26 medical students in New South Wales, Australia, in 2015 was observed to touch their faces an average of 23 times per hour. They handled the "T-Zone" of eyes, nose, or mouth 45% of the time. Earlier this year, a group of 131 clinical staff working in a pediatric specialty clinic in San Francisco was surveyed on whether they thought wearing a mask would change facetouching behavior. Most participants believed that masks would change face-touching but were divided in whether they thought it would increase or decrease it. When clinic clinicians and staff were observed during their workday at the clinic, in situations where they were masked, they touched



their face 5.4 times per hour, compared to 20 times an hour when not masked.

Dr. Sawyer also has studied face-touching behavior in a clinical environment, observing nursing staff, and clinicians working in a family medicine office. Published in 2011, long before COVID and regular use of wearing a mask, the study showed staff and clinicians touched their eyes, nose, or mouth nearly 20 times in two hours.

Social distancing, wearing a mask, and avoiding gatherings effectively reduce COVID transmission and are TEMPORARY inconveniences. If we all do our best to practice them, we can preserve lives and access to

medical care during the pandemic. Thankfully, the vaccines developed against COVID will eventually bring the COVID pandemic under control.

The first week of December is National Handwashing Awareness Week. This year I felt that handwashing was overshadowed by the controversy over mandatory masking and limiting social interactions.

To Reduce Your Risk of Infection Both Now and in the Future, Practice These Healthy Habits:

1.Wash or sanitize your hands frequently and thoroughly.

Sing a song while you rub soap or sanitizer over every surface of your hands, including fingernails and between your fingers.

2. Avoid touching your face. Do your best to extinguish face touching, especially in

the"T-Zone": your eyes, your nose, and your mouth. Have a happy and healthy
