day, Oct. 20, in a ceremony held at the new facility's site on Bighorn Way, just below The Lookout housing development. Chelan County Sheriff's Department maintains peace in the county

Around the country we hear cries to "Defund the Police." The Seattle city council and mayor are already in a dispute over how much the city will reduce the police budget. Seven of the nine council members have called for a 50 percent reduction. Virtually gutting the current law enforcement in the city.

With that in mind we felt it was important to look at law enforcement in our rural communities - The Chelan County Sheriff's Department. The Sheriff's department provides police services for the cities of Chelan, Entiat, Cashmere, and Leavenworth. It also provides service in the unincorporated county including the communities of Manson, Dryden, Monitor, Peshastin, and Lake Wenatchee. In total the department patrols 2921 square miles of Land and 73 square miles of water. To accomplish its duties the Department has a total of 61 officers assigned

to a number functions including Patrol, Investigations, Drug Task Force, Search and Rescue, Marine Patrol, Contract Cities, Training, SWAT, Administration and Reserves.

The Chelan County Sheriff's Department is a key part of the Columbia River Drug Task Force. Through that program the department works closely with a number of other local and national drug enforcement agencies to remove drug trafficking criminals from our communities.

CCSO maintains an Air Support unit that has 2 OH-58 helicopters. These helicopters are used for search and rescue, evidence search and patrol assistance.

Chelan County is promoted across the state as Washington's Playground. As a result, our county draws millions of tourists who come here each year to recreate in our magnificent outdoors. Many



CDHD Health Officer asks families to avoid trick-or-treating this year

Suggestions for safer Halloween activities

EAST WENATCHEE - The health officer for the Chelan-Douglas Health District urges families to skip the tradition of trick-or-treating this year and plan holiday activities closer to home.

It may be a hard message for some families to hear, but trick-or-treating during a pandemic is a bad idea, said Dr. Malcolm Butler, CDHD health

"I know Halloween is a very exciting time, especially for our kids," he said. "But I have to tell you, if I was an evil virus and I wanted to design the perfect holiday to make sure I could

spread myself around the community, what I would do is encourage young people with a sweet tooth to go house to house, passing infection around."

For the past three weeks, Douglas and Chelan counties have seen their case counts per 100,000 people rise weekly. On Sept. 30, the positive case count was at 114 per 100,000 people. This week, that number is 168 per 100,000 people.


Butler stressed that he would like to see families celebrating the holiday within their households, continuing tofollow COVID-19 safety precautions, such as social distancing, wearing a cloth mask when outside the home and washing hands frequently.

"This Halloween needs to be a holiday that we stay home and focus on family," Butler said. The health district offers the following family friendly activities to safely celebrate Halloween:

· Visit a local pumpkin patch and bring a pumpkin home to carve. When outside your home, always wear a cloth mask and maintain social distancing, even in the out-

- Put a new twist on trick-ortreating. Try a candy scavenger hunt in your yard, or fill up a pinata.
- Have a costume parade with your family.
- Throw a Halloween movie marathon. Settle in for the night with your holiday favorites.

Local communities also are organizing events in place of trickor-treating. Candy drive-thrus are being organized in Cashmere and Chelan. With the drive-thrus, families will be able to drive up to locations to receive individually bagged candy.

Union Valley resident explains 'hopes' to Dale England

Thanks Dale for weighing in on the Union Valley hopes. You should know that the first year that Sally and I moved up here I was involved in a meeting with the county commissioners and a number of neighbors regarding Union Valley Road and our inquiries regarding paving. That was 2015. At the time we were told that Union Valley Road was on the county's 5 year plan for paving and that at that time our road had already been designated as non-primitive and was perhaps the only nonprimitive road in the county that was not paved. This is starting to sound like a shell

Given the pronounced sale of properties and subsequent building up here the dirt surface can no longer support the traffic it is subjected to. The last work done by the county road crews to clear the dangerous washboard conditions

Union Valley Road can't be classified as 'Primitive Road'

Mr. England, according to the RCW's, a county road cannot be classified as a "Primitive road" if there are over 100 average trips per day. Union Valley road crossed that threshold over 15 years ago. Still no major improvements have been done. All that was done was moving the primitive road sign up to what is now Idyll Spurs Lane (formerly Clark Road). Again with NO IMPROVMENTS. We have also been on the Six Year Street Plan for most of those years. We have been promised that officials would seek some funding, but none has been secured.

The County Road crew does spend a lot of time & effort trying to keep the road passable and safe. Mr. Spence's points are well-taken that it would appear to be more cost effective for the County to find a permanent solution. Wash-

Dale England talks about Union Valley Road upgrade

One of the folks on your email list asked me if I'd be able to address some concerns regarding the Union Valley Road. I hope I don't offend anyone by jumping in with my thoughts.

The Union Valley Road has been designated a Primitive Road from the time it was constructed. Growing up I spent many hours riding motorcycles in your area. In order to upgrade the road it needs to meet a minimum Average Daily Trips threshold. I'm sure you have seen the counting strips laid out on the road once or twice a year. Once that threshold is met, the road can be placed on a higher priority basis for upgrading with the associated

funding.

The road is currently on the Chelan County Public Works 6 year plan. As such it is in a position that if the money is found to improve the road, it will happen. The list is the same list many other County roads are on for improvement. Traffic flow dictates a portion of where on the list the priorities are.

Some of the joy of living in the outlying areas of Chelan County also have some determinants associated with it. The County Public Works/ Road Crew spend a good bit of time and money keeping the road open in the winter and doing their best to keep it up after weather events.

While it would be nice to

promise you a new road, that would only be a campaign promise that would be difficult to keep. I will promise you, I know of your needs and desires and in the event I have any sway in providing you those needs I will with full vigor.

local residents have chosen to live here to take advantage of these same outdoor recreation opportunities. Sometimes they get into trouble and the Sheriff's search and rescue division is called on to help. In addition to their air support unit, the department maintains High Angle Rope Rescue and Swiftwater Teams who to train for difficult rescue activities in the rivers and mountains in Chelan County.

Many of our local communities hold regular festivals and events that draw large crowds that sometimes can overwhelm our ability to handle traffic and maintain the safety of our visitors. Working with these communities the Sheriff's Department provides important traffic control and security.



It takes a valley to build a Community Center

The Community Center at Lake Chelan will be a 44,000 square foot building, including a 8,320 square foot multi-purpose room with a full size basketball court, two practice courts, three volleyball courts and a community meeting space. It will also include a 25-yard competition pool, indoor children's play structure, a coffee shop, affording office space, picketball, sand volleyball and more. As of now, they are estimating a \$10 Million dollar project and over half way funded. They are currently working through cost engineering.

ers. With an excavator and bulldozer serving as a backdrop, Mr. Williams kicked off the event by speaking to the gathering, saying "although we're obviously elated to put shovels into the ground to begin construction of the Community Center at Lake Chelan (CCLC), it's a shame we couldn't make this a public event for our entire community. That was our intention all along because this truly is your facility, but we decided against doing that given the current COVID-19 situation. But I want to emphasize how much we appreciate everyone's incredible enthusiasm and support, and we know you'll be proud of the Community Center we're building and planning to open next Spring or Summer." Williams added that all necessary permits have now been received, and thus earthwork will begin immediately to level the site for the next phase of construction.

Following his opening remarks, Mr. Williams announced the second major advancement by introducing Seven Acres board member, Brooke Isaak, who along with her husband, Scott, recently made an exceptionally generous donation of \$1 million in cash to help construct the

CCLC. Describing themselves as "high school sweethearts who met on a basketball court," the couple has deep roots in the Chelan Valley area. Born and raised in Manson, Brooke Steveson was active in high school sports and clubs, and was honored to serve her senior year as the Manson Apple Blossom Queen. She also was instrumental in leading the mentoring program for Thrive Chelan Valley. Scott originally hailed from Coulee City, where he co-managed the generational farm with his family, producing wheat, canola and raising cattle. He also created a highly successful niche business selling straw to mushroom farmers in Canada. The Isaaks have raised seven children together, ranging in age from 12 to 27 vears old.

When asked why they decided to make such an enormous contribution, the central theme from both Brooke and Scott was giving back to their community and inspiring others to do so as well. Brooke said "I just feel incredibly blessed to have grown up in the Chelan area, a community that has provided so very much to me. It's given me my roots and the foundation of who I am as a person. For our family, this is our way of saying 'thank you' to the community that's had such a huge impact on our lives." Scott said they were originally

going to make their donation anonymously, but decided to go public mainly to encourage others. "Brooke and I just felt this was something we needed to do. We wanted to show good stewardship of the financial situation we've been blessed with. Our job is to not just sit on our money, but to find ways to pay it forward for the good of others. What a wonderful tool the Community Center will be for kids, families, small businesses, non-profits, you name it. We are very grateful and humbled to be a part of this," he added.

In summarizing the current situation, Mr. Williams concluded "it's been quite a remarkable last few days for everyone connected with this project, most importantly our area residents. Yes, the CCLC is happening, folks. It's now full speed ahead. And regarding the donation from the Isaaks, I'm simply at a loss for words. There is generous, and then there's overwhelmingly generous that Brooke and Scott have shown. We are so incredibly grateful for the love they've extended to all of us."

Chelan PUD partners up to address wildfire threats

WENATCHEE - Massive fires in Douglas County, California and Oregon last month put an exclamation point on an area of increasing concern. Wildfire risks are growing for Chelan PUD and its customer-owners. Chelan PUD is rising to meet that challenge with new tools and collaboration.

At the PUD Commissioner meeting Monday, staff outlined a community-based approach to build resiliency before, during and after a fire.

The PUD is working with partners like Cascadia Conservation District, Firewise neighborhoods and government agencies to identify projects with mutual benefit to electrical infrastructure and fire-prone communities. Many of these opportunities come with the possibility of matching grants.

One of the early benefits of collaboration is shared data. PUD staff presented several studies and maps produced by other agencies that showed where Chelan County faces the highest risk of wildfire. Those maps matched a study commissioned by Chelan PUD to assess wildfire risk to PUD's transmission lines.

"Everyone has a role in reducing wildfire risk to communities in fire-adapted landscapes," said Patrick

Haggerty, Forestry Program Manager Cascadia Conservation District. "It is great to see Chelan PUD using the best available data to identify where their wildfire resilience investments can be most strategically located, and how those investments can best align with the ongoing work of communities, responders, and land managers."

For several years, the PUD has been strategically fortifying the electrical grid against wildfire, including steel pole installation and fire-retardant paint. The utility has also adopted higher standards for tree-trimming

and line inspection. This work was initiated by damaging fires in Chelan County in 2014 and 2015. Enormous fires along the West Coast in the past three years accelerated the PUD's development of fire risk management strategies.

The PUD is also considering moving some power lines underground in a few isolated. rural, high-fire risk areas where a business analysis would indicate it is the lowest cost option for all PUD customer-owners.

PUD staff are also researching best practices and protocols regarding preemptive power shutoffs as an option during

extreme fire and high-wind events.

"We're beginning to rethink our position with respect to publicsafety power shutoffs," General Manager Steve Wright said. "As wildfire damage to homes and businesses has become more prevalent, insurance premiums are increasing. Proactive actions to reduce fire risk are increasingly perceived as a bestpractice."

Outdoor round up

Between fall hunting, fishing, bighorn sheep and news from our state parks there's a lot to cover this week:

HUNTING: There were no official deer check stations set up last weekend for the modern firearm opening of deer season in Northeast Washington due to Covid-19 concerns but checking with several Washington Department of Fish and Wildlife Enforcement Officers, Spokesperson Staci Lehman was able to relay hunting was slow in Pend Oreille County where one officer checked 29 hunters with no harvested deer. Other officers working in Stevens and Ferry Counties said Ferry County was the most productive and the majority of animals checked there were mule deer. Participation also appeared to be above normal in Ferry County during the opening weekend. Unfortunately, enforcement officers did cite several hunters for violations, the most common one, for having a loaded firearm in the vehicle.

On the duck hunting front participation was much greater than in recent years in the southern portion of the Desert State Wildlife Area encompassing the land around Potholes Reservoir as well as public land along Winchester and Frenchman Wasteways. That's where I went hunting with my longtime friend Rusty Johnston and we had a fine morning, bagging nine ducks. Checking a total of 19 hunters at access points along the two wasteways I found the average harvest to be between three and four ducks each, a bit higher than previous opening weekends. The majority of the ducks taken were green-winged teal.

FISHING: When it comes to coho salmon fishing the two hottest rivers in Southern Washington are the Kalama and Klickitat Rivers where state creel checkers found a number of anglers with not only coho, but also a few Chinook salmon too. There are also reports of better coho fishing on the Icicle River below the fish hatchery near Leavenworth though photos posted on social media of these fish indicate their table

fare might be better out of the smoker as opposed to the grill. These Icicle River salmon are getting pretty dark in color.

BIGHORN SHEEP: The good news is as of October 22nd Kyle Garrison, an Ungulate Specialist with WDFW, says so far it does not appear a pneumonia causing bacteria has spread from a domestic sheep to wild sheep in the Quilomene Herd, which calls the region between Vantage and Malaga home, though biologists continue to monitor this situation. Unfortunately, the Cleman Mountain Herd, has now been found to be infected. Located west of Yakima, a hunter found a dead bighorn lamb and several other lambs that were lethargic. WDFW biologists tested the dead lamb and found it tested positive for pneumonia.

rector for this area, Mike Livingston, stated "The fact that this bacteria has been found in the Cleman Mountain herd is significant, and we have limited options for how to address this positive test. We reviewed options such as lethal removal, testing, or increased monitoring. Because of the size of the herd and their range, we don't believe that removing animals from the population is the best option at this time." WDFW officials plan to collect samples from legally harvested animals from this herd to get an idea of how far the bacteria and pneumonia, which is often fatal, has spread. CAMPING SEASON EX-

You don't need much estrogen when applying it directly to vaginal cells. When used at appropriate doses, it doesn't create detectable estrogen levels in the blood that could reach endometrial

or breast tissue. There are several forms of low-dose vaginal estrogen: vaginal creams used with an applicator (Premarin®, Estrace®), vaginal tablets with individual applicators (Vagifem®), and a gelatin ring that releases estrogen (Estring®). The starting dose for the cream and vaginal tablet is once daily at bedtime for 2 weeks, then twice

a week as maintenance.

Estring® is a vaginal ring that's inserted and left in for up to 3 months. As a pharmacist, I have to be careful when filling prescriptions for vaginal rings. There are 3 different vaginal ring products available, each containing different estrogen concen-

Estring® has the least amount of estrogen and is worn for 90 days at a time for vaginal atrophy. Femring® has two strengths available to relieve hot flashes and other menopausal symptoms, worn for up to 90 days. NuvaRing® is used for birth control and worn for 3 weeks at a time with one week off.

Other prescription options for vaginal atrophy include Osphena® and Intrarosa®. Osphena® mimics estrogen's action in vaginal tissue but blocks estrogen action in breast tissue. Osphena® is a pill taken daily by mouth.

Intrarosa® is a tablet containing DHEA (dehydroepiandrosterone) inserted into the vagina every night. This is more effective than supplements containing DHEA, which don't work well to ease vaginal dryness and increase breast cancer risk.

Testosterone vaginal cream is in clinical trials as an alternative to vaginal estrogen.

If you have significant vaginal discomfort, see your doctor. After ruling out infection or other issues, ask about whether low-dose vaginal estrogen or another medicine is a possible option for you.
