CHELAN - Yesterday (July 2) Governor Inslee issued and order directing businesses to require and enforce the use of face coverings by all customers or visitors. The order is effective July 7 - guidance for businesses is being developed.

The Governor also ordered that Counties will not be able to move out of their current phase for at least another two weeks.

Are there exemptions or times I don't have to wear a face covering?

There are some exemptions to the DOH order, including people with certain disabilities or health conditions, people who are deaf or hard of hearing, and children under the age of two. Officials encourage use of a face covering by children ages 3-5 if possible. Children five and older must wear a face covering.

You do not need to wear a cloth face covering in your home when you are only with people in your household, or when you are alone in your car. You do not need to wear one when seated at a restaurant eating, or when you are outdoors and people socially distant.

ACRES FOUNDATION

CHELAN - Seven Acres Foundation has announced receipt of a financial commitment of \$500,000 from the Names Family Foundation to help fund the development of the Community Center at Lake Chelan (CCLC).


"We are overwhelmed and very grateful for this incredibly generous commitment from the Names family's charitable organization," said Ben Williams, Board President of Seven Acres Foundation. "With this wonderful grant, we have now reached nearly 60% of our total fundraising target of \$8.5 million, and it provides a tremendous boost moving forward to help us attain our total financial goal."

The Names Family Foundation, created back in 1996 and based in Fircrest, provides grants for nonprofits that promote athletics, physical education, health and wellness within Washington state. Grants from the Foundation have helped to build everything from playgrounds to community centers to an aquatics complex. The Foundation has awarded over 891 grants, and donated more than \$28 Million to worthy organizations and causes. CCLC includes \$200,000 already received, plus an additional \$200,000 in 2021 and \$100,000 in 2022.

Erin Shagren, Treasurer of the Names Family Foundation, said granting this award was a relatively easy decision to make. "Although we are based in the Puget Sound area, our family has deep roots and very close ties to the Lake Chelan area. Our parents.

Meg's father, John Horan, was an apple orchardist, and he and his wife Helen were deeply committed to the Wenatchee community. The Seven Acres Foundation is continuing fundraising efforts for the Community Center at Lake Chelan and expects to begin construction no later

With a little over 3 weeks before the primary election. It is unclear who is running. The deadline for filing was May 15. The Secretary of State's office lists 37 candidates have filed although one has apparently dropped out as it has been lined out on the list.

Most media are reporting that Jay Inslee is the only Democrat(ic) candidate running, but SOS lists 5 who listed Democrat(ic) Party as their preference. We are attempting to contact the other four Democrat(ic) candidates but one has no contact information other than a snail mail address. Here is what we have been able to discover through an Internet search:

Dr. Cairo D Almeida is President of Government Employees Local 1121. According to his website Dr. Almeida's vision is, "Help the homeless get their basic needs met and provide the veterans and foster parents with more psychological support so they can exist and function within a society that does not understand how it feels to be different. Use the Affordable House Care Act (AHCA) to give the people an opportunity to recreate the middle class. Develop ways to improve the current infrastructure and put an end to the use of fossil fuel era. Support the use of new technology to create more jobs that takes into account women, LGBTQ, WOMXN, LatinX, people of color and other minorities. This

Omari Tahir Garrett is a long time Seattle Activist. He ran for Seattle City Council in 2015. He spent 21 months in prison for punching Seattle Mayor Paul Shell in the face with a megaphone in 2001. Action: Opens Chinook seasons.

Effective date: One hour before official sunrise July 16 to one hour after official sunset on Oct. 15, 2020. Species affected: Salm-

on. Chelan River: from the mouth (railroad bridge) Chelan County PUD safety barrier below the powerhouse and the

Entiat River: from the mouth (railroad bridge) to the boundary markers located approximately 1,500 feet upstream of the upper Roaring Creek Road Bridge (immediately downstream

of the Entiat National Fish Hatchery).

Rule: Salmon daily limit is 6; up to 2 adult hatchery Chinook may be retained. Min. size is 12". Release sockeye, coho, and wild adult Chinook.

Reason for action: The U.S. v Oregon Technical Advisory Committee (TAC)

updated the summer Chinook run from a pre-season value of 38,000 to 65,000. At this updated run size there are more surplus hatchery fish available for harvest. The TAC is comprised of representatives from Washington, Oregon, Idaho, NOAA, and the Treaty Tribes and are responsible for develop-

ing pre-season and in-season run forecasts that salmon seasons are based on.

Additional information: The summer Chinook run will be closely monitored and updated by TAC weekly. The season could change or close quickly if necessary.

Chelan County, Regional Port form partnership to assist small businesses The Regional Port plans

WENATCHEE - The Chelan County Commissioners have allocated \$920,000 dollars from a Federal CARES Act grant to support small businesses within Chelan County. These federally funded dollars, made possible under the recent CARES Act, are expressly intended to provide relief resulting from the impacts of COVID-19. The Chelan Douglas Regional Port Authority has agreed to administer a Chelan County Small Business Grant Program on behalf of the county at no cost.

Chelan County Commissioner Kevin Overbay said "Small businesses throughout Chelan County have been impacted by the COVID-19 pandemic. The County Commissioners wanted to prioritize a portion of our Federal CARES Act grant towards supporting small businesses." The Federal CARES Act relief funds are limited to COVID-19 related issues and expenses, and these monies must be spent by October 31st, 2020.

The grant program is open to any small business throughout Chelan County with 20 fulltime employees or less. The business must have a Washington State Unified Business Identifying (UBI) number, and been in business for a period of six months. Businesses can apply for up to a \$5,000 grant.

"The Regional Port would like to thank the Chelan County Commissioners for prioritizing small business grants with the Federal CARES Act grant. Providing meaningful financial support to small businesses is critical to getting our economy going again," said **CDRPA Board President** Rory Turner.



Passed away in Boise Idaho, March 25, 2020, five days before her 97th birthday.

Graduated Chelan High School – 1942.

Attended 1 year of business school in Seattle where she learned to operate a comptometer.

Married William "Bill" Veroske February 23, 1944. 75 years married, 80 years together.

George and Lileta Cox auctioned off their worldly possessions on December 5, 1912, on their farm near Piedmont, Oklahoma, now part of NW suburban Oklahoma City. They relocated to Chelan, Washington, (then-population about 900) to help care for Lileta's widowed sister. Wilma Helen Cox came into the world in George and Lileta's South Chelan home where the winter shadows of the Chelan Butte had just given way to the sun. And so began Wilma's life in Chelan that would span 85 years.

In Junior High School, Wilma met 13-year old Bill Veroske who had moved from the Entiat Valley, Ardenvoir district, with his older brother, Jack, into a rented house to attend Chelan Public Schools. Wilma often babysat for the owners of the Ruby Theater. When a movie was playing, she would sell tickets and tend the concession. Knowing that Bill could not afford the 5-cent ticket cost, Wilma would let Bill in to sit in the last row where they would hold hands when Wilma wasn't tending to

customers. These Jr. High School sweethearts married on February 23, 1944, a marriage that flourished with love and adoration for over 75 years.

Bill entered the Army Air Corps on December 1, 1943, transferring to Georgia and leaving Wilma behind in Chelan. Always industrious, she worked in the apple packing sheds and in the Chelan Hardware. In December, 1945, Bill was discharged and returned to Chelan. However, a lung infection contracted in Georgia sent him to the Vancouver, Washington, VA hospital, leaving Wilma alone again as a voung war-time bride. Then as Bill recovered in complete bed rest at home, he busied himself making small pipe cleaner animals (rabbits, squirrels, skunks etc.) that Wilma would take around to local Chelan merchants to sell. Then, after nursing Bill back to health, Wilma lost her job at Chelan Hardware who hired Bill in her place! She greatly enjoyed telling that story for the rest of their lives together.

Wilma in the apple industry. Their success in that industry brought them many adventures and friends. It also allowed them the luxury of time to devote to their children and by which to give back to the Lake Chelan Valley communities. Although they were a typical family of the 1950's and 1960's with Bill in front, Wilma was fully involved and an active force in many organizations in the Chelan Valley:

Helped run and grow Echo Valley ski area, making it strong enough to buy the Squilchuck Poma lift when Mission Ridge opened.

Supported the organizing efforts that established the Apple Cup unlimited hydroplane racing on Lake Chelan from 1957 to 1960.

In 1959 helped establish Cub Scout Pack 59, with Bill as its first scoutmaster and Wilma as one of its first den mothers.

Wilma and others established the Chelan chapter of the Bluebirds, the young girls' stage of Camp Fire Girls.

Chelan Little League Mom, helping to organize the league, transporting kids to games, running the concession, repairing skin scrapes, and whatever else necessary to assure participation.

Active in the Women's

finest wineries. Wilma was one of their best customers. It was her favorite place to catch up with friends on later visits to Chelan. Wilma was known for

her generosity, her sense of humor, her happy spirit, her great capacity for caring and for her combination of patience and luck that left Nevada casino owners and fellow poker players often distraught (no generosity there!). Her capacity to care perhaps showed most strongly when the abused wife of an orchard worker appeared at our home one morning and revealed her bruises. Wilma gave her enough money to escape home across country to her parents. At the end of the day with plenty of distance behind the victim and Bill at her back, she confronted the abuser and terminated his employment. Blessed with good health and an active lifestyle in their retirement years, Wilma and Bill hosted many parties and events at their Chelan lakefront home and beach cabana. She and Bill enjoyed traveling the U.S. and Europe, skiing, fishing, golfing, boating and being with family and friends from across the U.S. Ultimately, they outlasted

Chelan and moved to Portland, Oregon, to be closer to son, Nick, and their sole grandchild, Ariel Veroske. They continued returning Chelan twice annually to maintain their lakefront property and visit friends until the property sold in 2014.

With the declining health of both Wilma and Bill in late 2018, it became necessary to move Wilma and Bill into separate memory and nursing home facilities. Later in 2019 they reunited for a short time at Wilma's nursing home in Boise, Idaho, close to their daughter, Sally Hunt. They achieved 75 years of marriage on February 23, 2019. Wilma lost Bill to complications of dementia in September, 2019. In the ultimate display of caring, she was with him at the time of his death holding his hand one more time and no doubt feeling the love from their junior high school days when they would hold hands in the Ruby Theater, and of a beautiful lifetime together.

Wilma Veroske passed away peacefully in the early morning hours of March 25, 2020, five days short of her 97th birthday. Wilma and Bill are now truly Together Forever. 

How sweet do you like your iced tea? Drinking tea over ice during the heat of the summer months is refreshing. Most places serve iced tea unsweetened and poured over a tall glass with a straw. You can drink it as is, or add the amount and type of sweetener you prefer. In the South, they serve "Sweet Tea", a version of iced tea that is sweetened while hot and before adding cold water and ice.

I used to make "Sun Tea" by placing tea bags in cold water and setting them out in the sun to steep. This practice has been called risky because the water gets warm but not hot, definitely below 100 degrees. That's warm enough to encourage yeast and bacteria to multiply, like letting homemade bread rise to allow the yeast to multiply. When you pour boiling water over tea, most bacteria don't survive.

You can also brew tea with cold water, in the refrigerator overnight. This method helps bring out the more subtle flavors of green teas and white teas.

When it comes to sweeteners, you have quite a few choices: liquid or powdered, natural or artificial, plain sugar or sugar alternative. Liquid sweeteners like honey, agave, molasses or simple syrups like those used to flavor lattes and other coffee drinks can also be used in teas. Powdered sweeteners include cane sugar, coconut sugar and various sugar substitutes.

When reaching for a packet of sweetener for your glass of iced tea, which color do you grab? White, pink, blue, yellow, or green? White packets contain cane or beet sugar, while colored packets contain non-caloric sweeteners. Pink packets have the sweetener saccharine,



known as Sweet'N Low®, yellow packets contain sucralose or Splenda®, and blue packets have aspartame or NutraSweet®.

Green packets contain stevia, one of the newest calorie-free sweeteners. Stevia comes from a plant native to South America in the crysanthemum family and related to ragweed. Originally approved as a dietary supplement to improve blood pressure and diabetes control, stevia was approved for use as a food additive in 2008 and is marketed as the sweetener Truvia®. Stevia is also sold blended with other non-caloric sweeteners.

Sugar substitutes have been used for decades as food additives and are considered safe. You'd think that switching from using sugar to a non-caloric sweetener would help you lose weight and control your blood sugar, but that has not been consistently the case.

Non-caloric sugar substitutes help reduce cavities, but in certain people they can trigger increased blood sugar, just like regular sugar. One study showed that after meals including a food or drink sweetened with non-caloric sweeteners, the blood sugar of participants rose higher than expected and dropped back to normal levels much more slowly, a pattern called glucose intolerance associated with an increased risk of becoming diabetic.

Xylitol is a low-calorie sweetener extracted from natural sources such as corn. Because of its protective effect on tooth enamel, xylitol is added to sugarless gum and mints and is marketed as a sugar substitute for baking. Xylitol may be a dentist's

friend but it's a dog owner's nightmare.

Xylitol is deadly to dogs, causing very low blood sugar, liver damage, and liver failure. Xylitol triggers a dog's pancreas to pump out insulin. Without sugar to balance that extra insulin, their blood sugar drops so low they have seizures. There is no safe dose; even a small amount of xylitol can kill a dog.

Iced tea sometimes tastes bitter. During brewing, agitating the leaves of tea releases tannins into the water, turning it bitter. Luckily, there are several ways to avoid the astringent "pucker" of tannins in your iced tea.

Three ways to make a mellow glass of ice tea:

1. Don't dunk. Avoid agitating your tea bag or tea ball when brewing hot or iced tea. Dunking your tea bag up and down in your cup encourages tannins to leach into the brew, making it bitter.

2. Choose a special blend.

Teas and teabags formulated especially for making iced tea are available from companies like Luzianne® and Lipton®.

3. Add a pinch of baking soda.

I was amazed at how this took the "bite" out of my ice tea! Decrease the bitterness of your ice tea by adding a pinch of baking SODA (not baking powder) to your tea bags right BEFORE you add any boiling water. This also helps your ice tea brew up clear instead of cloudy.

Sockeye Salmon

Sockeye fishing opened on the Columbia River from the Highway 395 Bridge in Pasco to the Highway 17 Bridge in Bridgeport on July 1 and with a two fish limit angler interest is high.

Some 200,000 sockeye had passed over Bonneville Dam as of July 1. This is indeed a good run compared to last year's paltry returns but still about 8 percent below the 10-year average. Although the season is open now for Upper Columbia River anglers the best fishing won't happen for another week or two. As of July 1, only 22,580 sockeye had made it over Priest Rapids Dam.

The initial hot spot for this fishery will be just below Wanapum Dam south of Vantage though some anglers are already having good success above Rocky Reach Dam near Wenatchee. As the month progresses the hot spots will be just below Wells Dam south of Pateros, and in the Brewster Pool below the mouth of the Okanogan River. If you don't have a boat there are some opportunities to catch a fish from shore just above Rocky Reach Dam. However, trolling for sockeye is the best way to go.

Traditionally, trolling a bare red hook behind a flasher is what most people use to get bites from sockeve salmon. In recent years though, offerings like a Mack's Lure Cha Cha Sockeve Souidder with a small squid body below a mylar spinner in hot pink, red or orange have become go to offerings for many anglers

to include Bob Loomis with Mack's Lure who helped design them. Loomis also recommends baiting the hook with a small amount of coon shrimp. The photo accompanying this article is proof that this works.

It's still too early to know if Lake Wenatchee will be open for sockeye fishing this year. Biologists like to see at least 27,000 sockeye heading to the lake before they open a season and it will be hard to get an idea as to how many fish are making the turn from the Columbia into the Wenatchee River until the middle of July.

Meanwhile, sockeye fishing remains closed below the Hwy395 bridge in Pasco to protect endangered Snake River sockeye salmon. As of July 1, only 88 sockeye had crossed Ice Harbor Dam on the Snake River east of Pasco.

Shad

It's been another strong run and for the second year in a row we are on pace to have over six million shad go over the fish ladder at Bonneville Dam again. For the next week or so a great place to fish for these sporty fish is on both the Washington and Oregon shores below John Day Dam where there is plenty of room to spread out. **Brewster Salmon Derby**

Cancelled Even though summer Chinook salmon fishing is opening on much of the Columbia River this month, the popular Brewster Salmon Derby has been cancelled. It wasn't a lack of salmon that did this event in though. Posting on Facebook, organizers said, "Covid-19 state and county mandated rules make it virtually impossible for us to safely hold a derby this year."

More money to counties from federal lands

The U.S. Department of the Interior announced this week that counties in Washington State will receive 24.1 million dollars from this year's Payment in Lieu of Taxes (PILT) program. These funds are allocated every year to individual counties, compensating them for the tax-exempt federal lands that lie within their boundaries. These lands include national forests, fish and wildlife refuges, national parks and Bureau of Land Management land.

This year counties are seeing a million dollar increase in the funds they are receiving across Washington State. The approximate funds received by each county in our region are:

Chelan County -\$3,244,000 (\$150,000 more than last year)

Douglas County - \$164,600 (\$20,000 more than 2019)
