Open House on public access to Lake Chelan yields mixed results

CHELAN -- The Chelan City Council held a Special Town Hall meeting regarding "Lake Chelan Access Site Analysis and Programming" Wednesday, Oct., 9 at the Senior Center here.

"Lake access is critical to the quality of Chelan and addressing the future of our access is important. This Town Hall is being held for the citizens of Chelan to listen and discuss the options regarding access," said Chelan Mayor Mike Cooney.

"This will give the entire community a chance to weigh-in on the value of retaining open space and lake access points. I made a promise that we would evaluate all opportunities and now the process begins," Cooney said.

About 50 people agreed with Cooney's assessment of the importance of lake access and showed up at the meeting.

Jim Brennan, namesake of J. A. Brennan and Associates, presented the results of the feasibility analysis. Attendees learned of the opportunity to create enhanced or additional community access points to the lake. Concept designs were provided for eight potential lake access points either

already owned by the city or being considered for purchase. Acreage on Spader Bay, just below The Lookout housing development, is the subject of great uncertainty as to whether or not it will be bought by the city for \$400,000.

Brennan displayed each site and then gave the pros and cons to go with that site including possible future uses, issues with physical access and adjoining property problems or plusses.

After his discussion, the audience was invited to place a red dot for "no" or a green dot for "yes" in regards to explore further lake access development.

The infamous Three Fingers, now court-approved for further development by owner Goodfellow Brothers, became a popular landing spot for the green dots (see photo) showing agreement that the former landfill should be considered as a potential purchase so the city can develop it into lake access for the public.

Most of the speakers expressed concerns that the city should finish projects already started, such as Don Morse Park, before buying more land or starting new projects.

As usual in meetings where Spader Bay purchase and access is concerned, some speakers expressed cynicism that a purchase plan has already been agreed upon during executive sessions held by the city. Those sessions allow for real estate talks to be held behind closed doors as per state law to protect the integrity of the bargaining.

Cooney said at the start of the town hall meeting that retired State Senator Linda Evans Parlette and her sister, current owners

of the land, have made a counter offer to the original offer. Cooney denied any agreement has been reached during the executive session held the day before the town hall during a regular city council meeting.

There was no obligation implied by the city that the site receiving the most green dots would be approved for the lake access, but the Three Fingers had 30-plus green dots applied to its site photo, while Spader Bay received a few green and red dots.

The "Green Dock" site also received more than 30 yes votes while the site across the street from Waterslide Drive received all no votes.

Brennan stated more than once that current lake access

CHELAN - National Book Award-winning author Robin Benway will spend a week in North Central Washington this month, visiting eight schools and headlining two community speaking events.

During her residency on Oct. 21-24, Benway will speak to students at Quincy High School, Ephrata High School, Soap Lake High School, Wahluke High School in Mattawa, Chelan High School, Cascade High School in Leavenworth, Oroville Jr./Sr. High School and Curlew High School.

She will also speak at two all ages, free, community venues:

Oct. 24: North Central Regional Library Distribution Center, 16 N. Columbia St., Wenatchee, 6:30 p.m.

Every year, North Central Regional Library hosts an author of young adult literature for a week-long residency.

"We select a thoughtprovoking book and author from staff, teen and teacher suggestions, provide schools with copies of the book, and craft a tour schedule that reaches all parts of our region," said Jessica Lynch, teen services manager for NCRL. "These author visits offer students a unique chance to meet an acclaimed author, hear their stories, and ask them questions. The books we select ask students to reach outside of their own experiences. This exercise in empathy generates great discussions in our schools and communities

In Front of Change

You hear it on the street, "This isn't the Chelan I grew up in." "This isn't the Chelan I moved to." These voices are correct. Our valley is changing. I was born here in 1971 and some areas of the valley are unrecognizable compared to my youth.

How do we respond to this change? It is tempting to lash out. To blame the tourists. To blame the newcomers. But will such blame address the cause?

Will it lead to any solutions?

I often jokingly say we have three issues in our valley: our lake is beautiful, most of us buy products from Amazon, and many of us use Microsoft Word or Excel on a regular basis. Habits #2 and #3 feed tech giants like Amazon and Microsoft. And reality #1 - our beautiful lake - attracts the thousands of wellpaid, vacation-hungry Amazon and Microsoft employees.

Who among us can change any of this? The only thing we can do is work to get in front of the change.

Like an incoming tide, this

change wave can not be stopped – but it can be channeled.

From the day Mike Cooney entered office as Mayor he has been on the go. At every turn, Mike addressed community challenges: planning deficiencies, public safety issues, housing issues. It takes a village to collect \$1.2 billion tax increase

Although state revenues were already projected to increase by nearly \$5 billion, lawmakers last session raised taxes by more than \$1 billion. We now know thanks to the Department of Revenue's (DOR) supplemental budget request, that it takes a village to collect a tax increase of this

size. As reported by Jerry Cornfield: "The Department of Revenue says it needs 44 more peo-

ple — 17 now and another 27 in the next fiscal year — to handle added responsibilities created by 32 revenue bills signed into law earlier this year.

Agency leaders want to hire information specialists to help taxpayers understand what they may owe, examiners and auditors to ensure compliance with the laws, and legal support for an expected increase in appeals and other disputes.

They are asking for \$4.1 mil-

Opening Day *Memories*

By John Kruse

The second Saturday of October tends to be the busiest day of the year when it comes to hunters taking to the field. That's because it's "Opening Day" in Washington State for both deer and waterfowl. It's a day steeped in tradition for many families, traditions that last through several generations and my family and friends have experienced these longstanding traditions as well.

My father was both a deer and a duck hunter when he lived in Oregon but when we moved to Washington in the mid-1970's, he chose to introduce my brother and I to waterfowl hunting. Our opening day ritual for over 20 years took us to the north end of Potholes Reservoir south of Moses Lake. In the 1970s and 1980s you would count dozens of cars and trucks with hunters parked or camped off the gravel road leading into the area as we drove to an off-shoot road that paralleled power lines leading to Crab Creek. Back then this road was gated and the habitat behind it was fantastic, holding not only lots of local waterfowl but also pheasant, jackrabbits and a variety of other birds from herons and egrets to owls and hawks. (Sadly, ORV use in this area and lax enforcement of seasonal off-road vehicle restrictions have changed that today).

It was work to get back to the ponds sprinkled through-

out this area, and it was easy to get turned around, especially in the early morning darkness. Eventually though, my father, brother and I would get to our spot, a place we called "the Round Pond", and we had some spectacular hunts there. The bag was mixed. Mallards of course, but also gadwall. wigeon and the occasional pintail. The most plentiful duck was the small greenwing teal. My father and brother wouldn't shoot at them, deeming them too small to be worthy of a shot. I had not such prejudices against these acrobatic, low flying ducks though and shot at them with abandon!

As I got older, I started bringing a friend or two with me out for the opener and in the early 1990s we started a new twist to our opening day tradition...Duck Camp. Up to 10 of us would set up camp a day or two before the opener. Prior to the hunt we would build blinds and cast for bass

or panfish in the same ponds we were hunting. After the opening day hunt, we would come back to camp, clean our birds and share stories of the day. This was often done over dinner or next to a campfire where a few adult beverages were consumed while the dogs lay at our feet after a full day of retrieving birds and busting brush.

The weather was as variable as one would expect. Some years we'd be hunting the opener in t-shirts and slapping mosquitos off of us in the hot weather. Other years it would be below freezing. Some years it rained on the opener but most of the time, the night skies were clear and the Milky Way and a canopy of stars above kept you company overnight. One year, as we prepared to walk to our pond in the dark, I even remember seeing the Northern Lights.

Eventually, my father aged out of the sport of duck hunting but both my brother and

I had the opportunity to introduce our children to the sport and rituals of opening day. As the cast of characters changed, so did the evolution of duck camp. After several years of "drive to" camping, we began to take a small 12-foot boat back into channels and waterways linking the various potholes to the greater reservoir. These journeys were hard work. We would sometimes have to push the fully loaded boat across shallow sandbars several times to get to our spot but once there, we would have the place to ourselves. And in this setting, we were surrounded not by other duck hunters, but instead by stealthy mule deer and singing coyotes who serenaded us in the evening.

Today, my best friend has a home just feet away from Potholes State Park and Duck Camp has become very comfortable sleeping in his guest rooms and spending time in his shop after the hunt watching college football.

The rituals remain though. My son is now grown, just graduated from college, but we will once again be venturing forth to a favorite spot for the opening day of waterfowl hunting season. We'll set our decoys in the dark and then sip coffee while we wait for the gray dawn of morning. We'll then greet the sunrise with duck calls and shotguns in hand, an eager dog by our side, and the hope for a good season of hunting ahead.

Surveys to occur on the National Forest through Sept. 30, 2020

WENATCHEE – The public will encounter contractors, students and employees of the University of Washington, working on the Okanogan-Wenatchee National Forest in developed and dispersed recreation sites and along Forest Service roads. They will be out in all types of weather conditions, wearing bright orange vests and be near a sign that says "Traffic Survey Ahead".

The National Visitor Use Monitoring (NVUM) survey is being conducted on the Okanogan-Wenatchee National Forest and started October 1 and will go through September 30, 2020. The information gathered is useful for forest planning as well as local community tourism planning. It provides national forest managers with an estimate of how many people actually recreate on the national forest, what activities they engage in while there, and how satisfied people were with their visit. Economic impact to the local economy is also captured in the survey.

The survey gathers basic visitor information. Surveys are voluntary and all responses are confidential; names are not included. Interviews last about 10 minutes. Questions asked include where you recreated on the forest, how many people traveled with you, how long you were on the forest, what other recreation sites you visited while on the forest, and how satisfied you are with the facilities and services provided. About a third of the visitors will be asked to complete a confidential survey on recreation spending during their trip.

"The survey is entirely voluntary," said Forest Recreation Program Manager Suzanne Cable. "It is extremely important for people to participate so we can assess visitor experiences on the national forest and strive to make it a better place to visit. We really appreciate all those who are willing to answer a few questions. It's important for interviewers to talk with local people using the forest, as well as out-of-area visitors, so all are represented in the study.²

In addition to the traffic survey, visitor use information will also be gathered via a self-service QR code posted at different recreation sites across the forest.

"People can go to the QR code where they will be asked a few short questions about their visit and their trailhead observations," Cable said. "If you don't have a chance to participate in the NVUM surveys, providing information about your visit using the QR code is another way to be involved."






