## Fourth of July week keeps CFR busy, Lt. Woods retires

CHELAN - After 10 years of service in Chelan, Lieutenant Evan Woods retired from Chelan Fire and Rescue (CFR) on July 6. Deputy Fire Chief Mark Donnell mentioned during the July 17 commissioner meeting, that seven candidates put in their applications to replace Lt. Woods. However, only six moved on to the panel interviews, due to one not passing the written test.

"After the panel interviews we were able to rank those folks from one to six," said Donnell. Beginning the first week of August, CFR Fire Chief Tim Lemon, Deputy Chief Donnell and Assisant Fire Chief Brandon Asher, will be interviewing the candidates and will be making a decision. "We are trying to have some-

one on board by September 1," Donnell stated. That evening after the meeting, a retirement barbecue was held at Station 71 to honor Lt. Woods.

Donnell added that CFR has six new rescue swimmers, after they completed the course last July 14. Under the guidance of Lt. Shawn Sherman, rescue swimmer program manager, and another three program assistants, the six participants were able to learn different rescue techniques. CFR's rescue boat, Marine 71, was also on water during the training.

"I have to say that it is pretty impressive the endurance the swimmers need to have, they spend a lot of time in the water," said Fire Commissioner Russ Jones.

At the moment, CFR is looking for people who are

capable of operating the rescue boat. Jones mentioned that other than that everything is set and ready to go. Commissioner Phil Moller brought up the idea of adding lights to the rescue boat. Jones added that perhaps a siren could also be installed. Fleet manager John Goyne said he will look into it and install lights and a siren that follow the code.

Chief Lemon gave a quick summary of Fourth of July week activities. In total CFR responded to 46 calls that week. Out of those calls 31 were for medical aid, one water rescue and three vehicle accidents. "On the fire side of things, we actually did fairly well. Only one brush fire and five others outside of fire events," reported Lemon to the commissioners.

## Six CFR volunteers complete rescue swimmer course

**CHELAN - Seventeen hours** in water, plus a couple more in the classroom - that's all it took six Chelan Fire and Rescue (CFR) firefighters to complete the extensive rapid rescue swimmer course.

The program which was implemented in 2011 by CFR was adapted from the Professional Association of Diving Instructors (PADI) program, which focusses on scuba diving and is recognized worldwide.

Lt. Shawn Sherman, rescue swimmer program manager, explained that at CFR they use West Pierce's Rapid Entry Rescue Swimmer Program model.

The risks in Chelan are high since the town is surrounding a lake. "There are no lifeguards, the Sheriffs can't go in the water and they do not always have their boat in the water. There is no protection for swimmers, boaters, skiers in the water anywhere and we recognize that risk," said Lt. Sherman,

all career staff at CFR goes through the rescue swimmer training. Right now there are seven. From there any volunteer that wants to do it can try the training, however not many succeed.

This year, 11 were registered and only six were able to complete the course due to the high intensity of it. The six participants were able to learn different swimmer rescue techniques from Lt. Sherman and assistant instructors Firefighter Taylor Rains, Firefighter Troy Keene and Firefighter Adam Jones. "The most important thing we

do in training is called drownproofing," said Lt. Sherman. Drownproofing is method for surviving in water disaster scenarios without sinking or drowning.

Lt. Sherman described that, "essentially we stress out the student to the point they are either getting close to panick-

ing or wanting to get out of the water. We keep at that for as long as possible while being safe," he said. With majority of drownings happening close the shoreline within 30 feet, rescue swimmers must be able to be confident and competent.

Masks, snorkel and fins are

the majority of equipment used by the swimmers. "We do not use air for this, it is all free diving," said Lt. Sherman. Instructors were able to teach the students to free dive not past the 30 feet mark. The course also consisted in taking night dives, Lt. Sherman mentioned that the last one

took place on July 19. The night dives are needed to train them with no visibility.

CFR's rescue boat, Marine 71 was also on water, it was operated by Fire Commissioner Russ Jones and Firefighter James Belch. Swimmers learned how to enter the

## Parks board hears pros, cons on pickleball courts

The memorial plaque

CHELAN - After constantly attending the Chelan Parks and Recreation board meetings, the Chelan Valley Pickleball Club will see action be taken in terms of converting the tennis courts at Don Morse Park into dual purpose to accommodate the club's needs.

Recreation and facilities supervisor James Hayter opened the discussion by providing a little history on the tennis courts during the July 18 meeting. Hayter mentioned that in one of the court's corners a Lions Club memorial plaque lays in honor of Paul Harper. (see The 'memorial plaque' for more) Hayter then began giving a general overview of the courts. He said that the dimensions of the courts are 3 feet short and there is not enough room to place four pickeball courts per court side. However, Hayter explained that two pickleball courts on each court side

could be easily done. This dual purpose option will give the public an opportunity to use the tennis court plus have two extra pickleball courts open for use. To make this happen, portable pickleball nets and a storage unit will be necessary. Hayter reported that the nets average

\$240, with the lowest cost one being \$109 and the priciest one \$350.

If the tennis courts were to be converted into all pickleball courts up to eight of them could fit into the current space - if the tennis nets were to be removed.

A member of the Pickleball

club mentioned the club's proposal to the board. "What we are proposing here is that vou convert the Don Morse tennis courts into six very nice, roomy pickleball courts that will accommodate 24 players," he said.

Lake Chelan Rotary Presi-

CHELAN - On May 14, 1953 the Chelan Valley Mirror, now the Lake Chelan Mirror, published a story by Dr. L. V. Woods titled "Local Community Tennis Courts Nearly Finished." In it Woods tells the story of Paul Harper and his dream of building a community tennis court that could be used for ice skating in the winter.



In order to raise funds for the community tennis court, Harper enlisted the aid of the Chelan Junior Chamber of Commerce. However, while working for his dream Harper was taken fatally with a heart seizure.

The Lions Club then took over with the thought of making the courts into a Memorial to Paul Harper. It took nearly five years for the Lions to obtain the money necessary to build the courts in what is now Don Morse Park. The local VFW and the Soroptomists helped the Lions achieve their goal - a tennis court measuring 105 by 120 feet.

Ever since the courts were inaugurated the plaque in honor of Harper has remained intact. Chelan recreation and facilities supervisor James Hayter said he first discovered the plaque 10 years ago and it is located in south east corner of the tennis courts.

### 3,700 sq. ft. room will be added

CHELAN - The high number of donations, plus current merchandise at the Chelan Station Reruns store, gives no other option but to expand their display room by 3,700 square feet.

Store manager Debbie Reed explained that for one there was no room to display every category of goods they have in stock. The additional space will be added towards the back of what is now the furniture warehouse. In it, electrical, lighting and geriatric sections plus remodel items and exercise equipment will be displayed.

In order to clear out the space needed, Reruns stopped taking donations for nearly two months. "We just had to, there was no way the guys had time to do anything else but do donations," said Reed.

Reruns volunteer John Olson is taking the lead on the project and little by little is organizing the room. With all the renovations happening at the Reruns, Olson's workshop will be moved to different space away from the shopping area.

water from a boat. Mariner 71 is huge asset to the swimmers since now they have a way to access the water and get there faster. "We are really lucky to have that boat, it is an excellent boat," said Lt. Sherman.

Firefighter Rains, who helped instruct the course this year, recalled his rescue swimmer training. "There's a big difference between recreational swimming and having to swim to exhaustion," Rains said. Over the last two years, he has seen big improvements when being in water, "before I was not comfortable in the water at all, now I am," he explained. In September, Rains will be taking a 40 hour PADI course.

With these additional six rescue swimmers, CFR has

doubled their rescue swimmer numbers. Each year, CFR responds to two to three emergencies in the water.

As a reminder Lt. Sherman wants to remind parents to keep an eye on their kids when they are in the water. "Be as careful as you can, pay attention and have somebody that can call 911 at the very least and we have a program to get there as well," he said.

## Lake Chelan project: The Little Hydro that can

WENATCHEE – Once again the Lake Chelan Hydro Project has earned recognition for sustainable operations from the Low Impact Hydropower Institute.

The designation takes into account all of the environmental work done at the 59-megawatt project at the base of Lake Chelan. That includes restoring yearround flow in the Chelan River after 80 years and creating an award-winning habitat that attracts healthy numbers of salmon and steelhead, and offers paddling and fishing for people.

"All of our environmental work at the Chelan project contributed to our successful application," Suzanne Grassell, government affairs program manager, told Chelan PUD commissioners Monday.

The Lake Chelan project first earned Low Impact Certification in 2007. Grassell said the recertification, good through September 2022, was "a much more rigorous application process." The institute upgraded its criteria in 2014.

There was more good news. The state now recognizes efficiency gains from turbine upgrades as renewable energy under state I-937 requirements.

A key factor in earning Low Impact Certification was the increasing numbers of steelhead and spring Chinook

returning to spawn and rear in the habitat near where the Chelan River joins the Columbia. So was restoring year-round water flow in the Chelan River as part of the project's a new federal license in 2006, she said. The National Hydropower Association honored the habitat with an Outstanding Stewards of American Waters award in 2010.

"This certification from a respected third party highlights how we can generate carbonfree power and protect fish at the same time," Grassell said.

Commissioners were delighted with the news. "The Chelan River Project is a real showcase," added Commission President Garry Arseneault.

Approved purchase of 2.12 acres of property next to the site of the PUD's new Service and Operations Center in Olds Station. The Nevio and Elizabeth Tontini Living Trust agreed to sell

### Dr. Jobe stresses the importance of **RiverCom**

RiverCom is a critical part of the infrastructure of our communities, and I am asking that vou join me in renewing the RiverCom 911 Emergency Communication Systems and Facilities Tax. No matter the emergency, the staff at RiverCom quickly determine the nature of the

call and then rapidly dispatch the appreciate resources. As the medical director for EMS in Chelan and Douglas Counties, I am intimately familiar with the key role that RiverCom plays in taking care of people with medical emergencies.

Nearly 10 years ago, we began a systematic effort throughout our emergency medical service partners to make improvements in each of the links of the "chain of survival" to save more lives from sudden cardiac death. RiverCom has played a key role in that effort. We instituted a process change that focuses on early initiation of CPR anytime the call-takers determine the victim is not conscious and not breathing normally.

Ten years ago, this was a controversial practice, but one back by peer reviewed, scientific studies. Now, it has become the standard that dispatch centers are striving to achieve. In cardiac arrest, seconds make the difference between life and death. These process improvements are an integral part of why, in Chelan and Douglas Counties, we have one of the highest survival rates from cardiac arrest in the country.

This tax was initially approved in 2009 and we must renew it before it expires at the end of the year. This is not a new tax or a tax increase, but a vital tax required for RiverCom to continue to provide quality service. This is a sales tax of 1/10of 1%, or one dime for every \$100 spent, paid for by the citizens as well as visitors who might experience some type of emergency. So please join me in voting top support the RiverCom 911 Tax when your ballot arrives. Lance W. Jobe, MD, FACEP Wenatchee Emergency Physicians

## How to take iron supplements

After a short hospital stay for a bleeding ulcer, 78 year-old Mabel was discharged home on pills to heal her ulcer and an iron supplement to correct her blood loss. Despite taking iron for 3 months, Mabel's blood tests showed she was still low in iron. When I asked her which iron supplement she was taking, she proudly showed me a bottle



me tore up my stomach, so the pharmacist recommended this one. I can take one every day without a problem."

Iron supplements have been

people who were pale and tired with drinking water enriched with iron, either created by leaving swords in water to rust or by saving the water blacksmiths used to cool hot iron in.

Iron is a critical part of hemoglobin, a protein responsible for carrying oxygen throughout the body, with four atoms of iron in

globin, your body can't supply enough oxygen and you'll become pale and tired.

The most common cause of iron deficiency is blood loss, from stomach bleeding like Mabel experienced, heavy menstrual periods, or chronic blood loss from the intestines such as hemorrhoids. Less common causes of iron deficiency are poor diet, poor absorption due to gastric bypass surgery or kidney disease, or an increased need for iron during pregnancy or breast-feeding. We treat iron deficiency anemia by giving iron supplements to replace both iron in your blood and replenish iron stores in your bone marrow, usually by giving 100mg to 200mg of elemental iron daily over several months. The most common side effects of iron involve stomach or intestinal irritation: stomach pain, constipation, nausea, vomiting, and even diarrhea. Iron can also make your stools dark and cause a metallic taste. The 3 most common forms of oral iron supplements are ferrous sulfate, ferrous gluconate, and ferrous fumarate.

Ferrous fumarate contains 33% elemental iron, ferrous sulfate has 20% elemental iron, and ferrous gluconate has only 12% elemental iron.

Iron is poorly absorbed and needs an acidic environment to assist its absorption. Vitamin C (ascorbic acid) improves the absorption of iron by converting some of it from the less soluble ferric form to the more soluble ferrous form. 2.For best absorption, take iron on an empty stomach.

If taking your iron supplement on an empty stomach causes stomach irritation, try taking them with food instead of skipping doses.

3. Avoid sustained release or enteric coated iron supplements.

Sustained release, delayed release and enteric coated iron may cause less stomach upset but are less well absorbed.

4.Start by taking one ferrous sulfate tablet daily, increasing the dose if tolerated.

Higher doses of iron are not absorbed as well and cause more stomach upset and constipation.

5.Consider cooking with cast iron skillets and pans.

Cooking with cast iron increases iron content of your food and can treat mild iron deficiency.

6.Keep iron tablets out of the reach of children.

Both ferrous gluconate and ferrous sulfate tablets look like chocolate M&M candies.
