LCCHC CEO Steve Patonai to retire in September of this year

CHELAN - Lake Chelan Community Hospital and Clinics Chief Executive Officer Steve Patonai will be retiring in September. In a letter addressed to the LCCHC Board of Commissioners, which was read by Board Chair Phyllis Gleasman at the June 18 meeting, Patonai notified the Board on his intent to retire from his position as CEO. "I appreciate the opportunity to serve in both the interim and permanent CEO capacities but it is time to pass the reins to someone else as I enter the

next phase of my life," read Gleasman.

As Gleasman mentioned after reading the letter, "LCCH will be going through another transition."



Gleasman reported that a CEO search committee will be formalized to begin looking for a new CEO. "We will be putting together a plan and moving forward," she added. Commissioners thanked Patonai and he said,

"there's a lot of opportunity here ... the light at the end of the tunnel is there." Patonai was hired as Interim CEO in March of 2018 after Kevin Abel's departure. After a long hunt, the LCCHC Board of Commissioners appointed Patonai as Permanent CEO last December.

In a press release by the LCCHC Board, Gleasman said, "while we have know all along that Steve would be with us for only a short time, his excellent service and vision for our Hospital District, patients, community and employees, have been so respected and appreciated. We are glad he has chosen to live in Chelan and wish him the very best in his retirement. We are glad he has chosen to live in Chelan and wish him the very best in his retirement.'

A new hospital block diagram was presented to the Board. Keith Null described the diagram and answered questions via phone call. The diagram illustrates the principal functions of the new hospital in block form. It also included dotted blocks which represent the space for future development and expansion of the hospital. Included in the future expansion list are the clinic building location and parking, EMS building, Med/Sur expansion and business office space. With the approval of the plan from the Board, Null will move onto the next step of the design process. Previous to this, the design was presented to the Facilities Committee.

Starting June 24, the Lake Chelan Clinic will be transitioning into having same day appointments as opposed to walk-ins. Chief Nursing Officer Kris Hassl explained that with the walk-in clinic model, "people tend to have the idea that is an urgent care and it is not," she said. Furthermore, Hassl reported that there will be the need to educate the public about what a same day appointment is. "Even though it says same day, if the urgency is not there they can be scheduled in the next day," said Hassl.

The Board met again on Thursday, June 20 in Executive Session and they discussed CEO qualifications and had a lease discussion. No action was taken afterwards. The next regular meeting will be held on July 23 beginning at 1:30 p.m. in the board room at the hospital.

Chelan fire commissioners add **Q&A** time to meetings' agendas

CHELAN - Fire Commissioners Russ Jones, Phil Moller and Jay Witherbee did some town hall meeting debriefing during the June 20 regular meeting, all thought it was a good start.

"We had 17 of our staff and 17 citizens over there," said Fire Chief Tim Lemon on the town hall's attendance. "The purpose of the town hall was to get input from people and for making the right plans," said Jones. Commissioner Witherbee didn't think the town hall was "presented that way. I thought we could've done a better job of real simple communication," Witherbee told Jones. For Moller, the most beneficial way to get the community's input is to have the citizens talk to them instead of the Commissioners talking to them. "There's definitely a lot to build on," Moller added. Jones said he would like to see a town hall meeting take place once every three months in the future.

Under new business, Jones went over an addition to agenda items that will give the public the option to interact with the Commissioners towards the end of a regular meeting. The idea is to have a Question and Answer period for the public to address their concerns. "That's probably the right thing to do. That's what we are looking for, input from the public. I think that's beneficial," said Moller. The Commissioner will give the Q&A period a

trial run at the next regular board meeting.

Jones presented an article to the rest of the Commissioners regarding a watercraft incident that occurred over the weekend. "I think we can and we will provide a much better response in emergency situations on water once the boat's ready to go," said Jones. He reported that the rescue boat successfully completed its sea trials and engines are performing well. The fire radio is installed and now the boat is being prepared for paint. Talks with the City of Chelan are also taking place to figure out a parking situation for the boat.

City of Chelan holds community meeting on pump track

CHELAN - Parents, children and skateboarders raised their voices during the pumptrack/skatepark community meeting - they want to see the park be done right this time around.

"This can become whatever the community decides they want," said Chelan City administrator Mike Jackson. Jackson then introduced American Ramp Company (ARC) Bike Park Development Manager Tim Babcock. "I am in charge of everything to do with bike ramps and trail development throughout the country and the world," said Babcock.

During Babcock's meeting with different city staff earlier that day (June 19) they visited the site in order to observe and explore opportunities it presents. He told the 25 attendees that the current size of Don Morse skate park is about 10,000 square feet. "If you are familiar with that space right there, there's room to expand towards the water," stated Babcock.

Babcock explained the work he will be doing with the conceptual design. "We want to figure out what you guys want to see here. We are looking into improving,

expanding or changing the used as an example of a site adding a bike element like an asphalt pumptrack," explained Babcock. He mentioned that his ultimate goal will be able to provide the community a sustainable and durable site that will

serve generations to come. There was also a brief introduction to pumptrack competitions. One community member asked about the requirements needed in the pumptrack in order to host a competition. He mentioned that Chelan could potentially host such an event during the shoulder seasons. Leavenworth's pumptrack was

Board learns about short-line railroads

CHELAN - The North Central Washington Economic Development District (NCWEDD) Board met on June 12, at the Chelan City Hall Council Chambers to hear from Zach Boehme of Genesee and Wyoming industrial development railroad services. As part of his job in the in-


dustrial or economic development in the west coast, Boehme described that he works with existing customers to help with expansion and new products, recruits businesses and works with groups such as NCWEDD and have open dialogue and provide resources.

Boehme referred to his presentation as a 101 introduction of railroad services. He first gave a quick background of G&W. Boehme stated that "G&W has doubled in size every five years in the last 25 years."

They also operate in 41 states across the United States which "gives them a pretty good view of the landscape across the country."

The company which was founded in 1899 owns or maintains 120 railroads worldwide, employs 8,000 and serves 3,000 customers. In Washington, G&W operates three railroad lines, the closest one to the region being the Cascade and Columbia River Railroad. Boehme mentioned that the other two lines are further East.

The difference between Class I railroads and short-line railroads briefly was explained by Boehme. A Class I moves commodities from point A to point B with the least amount of stops possible. On the other hand, a short-line is used as a connection between customer and Class I. He also touched on transloading, "this is probably the most beneficial thing to everyone in this room. It allows someone to participate in a rail network without having to put all of money their into it."





Dick and Roberta retired to Chelan, Wash., in 1998 where he volunteered as president of the Lake Chelan Rotary Club and president of the Lake Chelan Historical Society. He was proud of rowing his homemade rowing shell the entire length of Lake Chelan to raise money for the Chelan Historical Society. He was well known for a Saturday radio segment called "Nugget of Knowledge" on Chelan's KOZI radio station, where he shared stories of historical events in and around the Lake Chelan area.

Dick is survived by his wife Roberta "Peach" Simonds, sister Joanne Scott, sons Derrick "Gus" and Andrew, and grandchildren Chelan, Madison, Colton and Dexter.

Richard (Dick) Lutz

Richard (Dick) Lutz was the first child of a cattleman cowboy, born in Collinsville, Oklahoma on October 16, 1925. Early in life his father and mother moved the family several times to find work on ranches in Oklahoma, Texas, and Kansas.

In the midst of the great depression, dust bowl storms forced another move. The family packed all of their belongings onto a flatbed truck and set out for Washington State, landing first in Moses Lake and later establishing a small ranch up the Palisades. In those days, a small cabin, woodstove, fresh water and an outhouse were all considered luxuries. Through this experience Dick learned the values of self-reliance, thrift, and a tireless work ethic that he would carry with him the rest of his life.

During his school years, the family moved to Rock Island. He attended Wenatchee High School, graduating in June, 1944 a few days after D-Day. He enlisted in the Army Air Corp a week later. He was assigned to pilot school in Texas but before he could



earn his wings the war ended, stopping all pilot training. He was re-assigned to a base outside Chicago where he served until being honorably discharged.

He returned to Washington State and enrolled in the Perry Institute Trade School in Yakima. On weekends he would travel back to Wenatchee to court his future wife, Betty (Highfill). After graduation he was hired as one of the first few employees at Van Doren Sales where he built a successful career over the next 30 years.

Dick and Betty were married in 1949 and spent the next 70 years together as inseparable partners in every aspect of life. They raised a family and planted orchards in Wenatchee and Chelan.

The opportunity to work at Van Doren Sales was a perfect match for Dick's skills. He became a key problemsolver and trouble shooter on the Van Doren team, helping design, build, and install packing equipment for fruit warehouses from British Columbia to California. As one warehouse manager commented, "Whenever Dick finished everything in my warehouse ran better."

Dick was a tireless worker, seemingly racing the sun to see how much he could accomplish in a single day. Water would be changed at the orchard at dawn. He would then work his full shift with Van Doren Sales, return home for dinner and head straight to his orchards to work until dark. was a notorious cat-naper, frequently falling asleep at the dinner table to catch a few precious minutes of sleep before waking refreshed and charging out to the orchard.

A skilled builder, he was never without his small spiral notebook tucked into his shirt pocket. Sketches were made of farm implements and devices that he would later fabricate in his shop. He had a well-spring of inventions that he needed to capture on paper lest he lose the inspiration. When asked why he chose to build equipment rather than buy it, his response was, "I think I can make it better." And he was usually right.

Dick loved Lake Chelan. In the late 60's he bought property on the lake and true to form started building. First came a massive dock, welded together piece by piece with channel-iron steel. Then he built concrete bulk-heads. Large retaining walls built by hand from concrete slabs came next, and finally the start of a house. All of which he built himself.

His house on Lake Chelan was a slow project as nearly all his free time was dedicated to planting a large, new orchard in Chelan. The house had to wait. Single-handedly, he installed wells near the orchard, buried nearly a mile of pipeline, graded the land, grew his own apple trees in a nursery, and finally planted his orchard. It was a thing of beauty.

He was a gifted mechanic. Virtually anything broken could be repaired and made better than before. It didn't matter if it was a toaster, heat pump, sprayer, mower, truck, wind machine or even D8 Caterpillar tractor. As necessary, he would fabricate new parts on his metal lathe, weld up broken pieces, replace faulty parts and put it all back together. As he liked to joke, "Somebody built it, I'm smart enough to take it apart."

He was a dedicated family man and regularly challenged his children to be better. When one of his kids wanted to quit a difficult task because the challenge was too great, his frequent comment was "Can't never accomplished anything." He lived those words. Even though Dick did not attend college, he held a strong belief that education could save mistakes and get you much faster to where you wanted to be in life. Some of his proudest moments were watching his children and grandchildren graduate from

He was a member of the Wenatchee Masonic Temple for over 65 years and served on the Board of Directors at Trout/Blue Chelan Fruit Co-op.

Dick is survived by his by Betty, his life-partner and wife as well as his daughter Karen Lutz-McCutcheon (Don) and his son Steve (Jan), both in Wenatchee. He was so proud of his five grandchildren; Jessica and Steven McCutcheon and Richard, Taylor and Parker Lutz. He cherished every opportunity to see his grandchildren and loved seeing them perform in concerts, sports, and other school activities.

Dick is also survived by his sister Cleta Craig in Kalispell, Montana and brother David Lutz in Kennewick, Washington. He was preceded in death by his father William Henderson Lutz, his mother Mona (Cox) Williams and sister Margarite McPherson.
