MANSON - The Manson Community Council is back to having five council members after swearing in Gordon Lester and Cindy Smith on May 21.

Smith takes over the vacant spot left by Sarah Cushing who resigned from her position last month. During her introduction Smith mentioned she has been living in Manson since 2001. Smith explained she moved away from North Seattle "to get away from traffic, shootings and school things." She wants Manson to have a controlled change as it continues to grow. Smith's term will end next December.

Talks between the council about opening up a Facebook page on behalf of the organization took place. The idea behind opening up a Facebook page is to have more community engagement at the public monthly meetings. "The Facebook page will be for us to be able to post our meetings and the agenda. So anybody who is on Facebook can see that information," explained Kari Sorensen, council chairwoman. Sorensen made it clear that

she would disable the commenting option to avoid any controversies. Agenda meetings will not be shared on the Facebook page, instead they will continue to be posted on the council's website. Council members voted and agreed to set up the Facebook. Sorensen will be in charge of managing the page.

Manson resident Carl Blum took time during the public comment portion of the meeting to acknowledge Sorensen's personal efforts to help with an issue at the dog park. "I understand that Kari, as an example of our types of citizens we have here, you witness or heard about somebody's lovely pet that died because they wanted go into the swimming hole for dogs and there was no fence," said Blum. He explained that he is aware that Sorensen asked them to do something about the issue, however the Parks Department said the didn't have the money to do so.

"She with her money, paid to have that whole thing fenced down there, so nobody else would lose their beloved pet," added Blum. He also thanked Sorensen for her kind donation to the community park.

# May 6 plane crash under **NTBS** investigation

CHELAN - A JA30 Superstol airplane impacted terrain shortly after takeoff from Lake Chelan Airport in Chelan on May 6 at 6:29 a.m. According to the National Transportation Safety Board Aviation (NTSB) accident preliminary report, Kenneth W. Van Assche,68, of Chelan Falls, was killed by asphyxia and burn from the plane's post-crash fire.

"The examination of the site revealed that the airplane impacted terrain in a vertical attitude," stated the report.

The plane remains have been recovered to a secure location for further examination under NTBS investigator Maja Smith.

HDCA Executive Director, Erin McCardle, first and foremost thanked all donors for their contributions to the project and all those who were involved in the project one way

McCardle was then recognized by Chelan Mayor Mike

Cooney. "Erin on council and as director of HDCA really pulled this together," said Cooney. Mayor Cooney also took the time to thank the Chelan County PUD for its donation to help fund the project. "This is a really cool place for our town. It is one more access point to the lake," said Cooney. **Chelan Public Works Director** Jake Youngren also had special recognition for working with HDCA, the City and the project's contractor. The landing park is not yet in its final form, as landscaping will be going in early June. Vice-president of HDCA,

Steve Clark was excited to share with the attendees the launch of the Charm Program. The purpose of the program is to fundraise money in order

to continue "mixing history

and the future of downtown Chelan together" with a series of projects.

Charms will line the railings leading down to the water with commemorative messages created by who those purchase them. The public will have four different sections to choose from that range from \$100 up to \$500 depending on where their charm will be placed. Section 1 - railing along the north side of Woodin Avenue; Section 2 - middle section of the ramp; Section 3 - lower ramp and west edge; Section 4 - railing along south side of Woodin avenue. # David A. Lindeblad

David A Lindeblad, age 70, died from cancer on May 17, 2019 in Omak, WA. He left behind a wife, Elizabeth Fry, and daughter, Mary M. Lindeblad-Fry. They married June 22, 1985.

He was born on December 7, 1948. Dave grew up in Spokane, WA with his parents, Twila Anderson Lindeblad Rees (deceased), and Malvin Lindeblad (deceased). He also had a stepfather, Art Rees (deceased). He is survived by his siblings, Jim Lindeblad (Jean), John Lindeblad (Mary), Jerry Skalet, Gary Lindeblad (Kris), and Maryanne Lindeblad (Kevin Krueger). He spent his summers in North Dakota with his grandparents, Andy and Martha Anderson.

Dave graduated from North Central High School in 1967, and Eastern Washington University in 1971. He later received a master's in education history from EWU. He completed the courses, but not thesis for a Leadership in Education doctorate at Gonzaga University.

Dave spent two years in VISTA at the Puerto Rican Community Center in New London, Connecticut, where he learned Spanish. He then worked at Opportunities Industrialization Center in Spokane, WA.

In 1978 he moved to Omak, WA to teach at Wenatchee Valley College at Omak, and received tenure. He was also Dean for 15 years, and then returned to teaching. He taught Political Science, History, Philosophy and Communications. He helped many students and was greatly appreciated as a teacher, mentor, and colleague. He championed the Omak Campus in many ways and was awarded Wenatchee Valley College's Faculty Member of the Year in 2012.

He was diagnosed with Myeloid Dysplasia Syndrome in August 2017, received treatment at the Seattle Cancer Care Alliance and was in remission until February 2018. He relapsed and was diagnosed with Acute Myeloid Leukemia. He was treated in Omak.

He chaired the Omak Chamber of Commerce for two years. He also chaired and later was a member of the boards for the Okanogan Valley Orchestra and Chorus and the Performing Arts Center. He was on the board of the Okanogan County Historical Society. He was an active member of the St. Joseph Church and St. Mary's Mission.

He was a long-time member of the Okanogan Flyfishing Club. Flyfishing was his passion and he introduced many people to it. He asked that his epitaph be "Bon Vivant and Fisherman."

He was a dedicated life-long Democrat. He never had a hard word for anyone. He influenced many to continue with their educations.

Jerry was drafted by the Army and was a three-time decoratedveteran of the Korean War. Once the war ended, Dad returned to Chelan and took a temporary position with the U.S. Forest Service, running phone lines up the Stehekin. He often ate lunch at Chelan's Apple Cup Café, where he met Helen McCarrell. They were married in December, 1953.

That next September would find Jerry and Helen in Pullman, WA., so Dad could enroll in Washington State College. Soon

## Chelan girls team 2nd at state tourney

YAKIMA - The Chelan tennis team took five players to the WIAA 1A/B State Tournament this past weekend, and all five left with hardware! In addition, the girls team placed 2nd overall behind Seattle Academy (Chelan is "public school state champs"!) and the boys team placed 5th behind Charles Wright Academy, Seattle Academy, University Prep, and local district champion Tonasket.

Here are the paths that each player took this weekend-

Junior Emma McLaren opened the tournament early Friday, May 24 by topping Makilie Hernandez of Zillah 6-2, 6-0. That win pitted Emma against a rival from the 2018 state tournament: Bailee Wallace of Three Rivers Christian. Emma avenged a narrow 2018 defeat to Wallace by earning an exciting, hard fought and emotional 7-5, 6-3 victory over Wallace here in 2019, and punching her ticket into the Saturday semifinals. In the semifinals, Emma gave eventual runner-up Penelope Owen of Seattle Academy all she could handle and played some of the best tennis of her career. but fell short 4-6, 3-6. The same can be said of Emma's subsequent 3rd place/6th place matchup vs a talented Zoe Rose of Charles Wright Academy. Nonetheless, it was an outstanding two days of tennis for Emma, finishing in



Saturday, May 25 Abby and Bella faced La Salle, and also handled them soundly 6-3, 6-1 to earn a 5th place medal in girls doubles.

There are very few teams that send multiple entries to the state tournament, and even fewer that earn multiple medals, so Chelan's 6th place and 5th place girls finishes were enough to earn our girls 2nd place in the team rankings.

That 2nd place finish is the second self-proclaimed "public school state champs" title for Chelan in the past three years (the Chelan boys placed 2nd behind University Prep in 2017).

Speaking of the boys team, due to their #3 and #4 seed rankings entering the tournament, senior Wyatt Habich and junior Tobin Wier faced very tough #1 seeds from other districts in the opening round on Friday.

Wyatt opened by facing 2018 singles tourney runnerup Andy Simmerman of Freeman, and played well, but lost 3-6, 1-6. Like our girls fight through the consolation bracket by winning two before losing two. In match #2, Tobin dispatched of Fernando Godoy of Zillah 6-0, 6-3. In do-or-die match #3, Tobin used two impressive momentum shifts to get past Cameron Whittle of Newport. First, Wier overcame a 1-4 deficit in a first set tiebreaker to win that breaker 7-5. Then, in the 2nd set tied 2-2 but down 0-40 in the 5th game, Tobin rattled off 5 straight points, and then won the next three games to win the match 7-6, 6-2.

Those four Chelan boys singles wins meant that Tobin and Wyatt would face each other on Saturday for a rare Chelan vs Chelan match-up to determine 5th and 8th place (possibly the first Chelan vs Chelan matchup at the state tournament in school history?). In set #1, Wier opened up strong and won the decisively 6-2. The middle set was dead even, with Habich eventually winning a tiebreaker. The final set was won by veteran Habich 6-2. So, Wyatt finished 5th and Tobin finished 8th in boys singles.
