

## Mortimer speaks suicide awareness

NCW - The Christ Center in Chelan and Cashmere have been working alongside business owners in Wenatchee and a group of 12 in Chelan, Manson, and Pateros to bring Bob Mortimer into schools to speak on suicide awareness from April 8-15.

Chelan Campus Pastor Nick Longmire stated that suicide rates in Chelan County are high, and not only statewide, but also nationally, and it is a concern to many community members. Last year, a group of business owners reached out to the Cashmere Senior Pastor wanting to do something in order to help educate students in North Central Washington on this sensitive topic.

The group decided that they would subsidize Mortimer as a guest speaker to the schools. Mortimer will be sharing his story at 13 different school assemblies on the time he was coming home from a party during his high school days and suffered a fatal ac-

cident, losing his two legs and one arm. "He struggled with suicide and depression, and eventually he came through that and found hope," said Longmire.

Mortimer will also be present at the three youth rallies that will take place in different community locations. "We are trying to get the students from the schools to jump in and be a part of that," said Longmire.

## Food trucks approved for summer in Chelan park

CHELAN - In a previous Chelan City Council meeting, the Council heard from City Administrator Mike Jackson and his idea of bringing food trucks to Chelan during the summertime to the Lakeshore Marina area.

After doing more food truck research, Jackson brought up the topic once again on March 26 as an Administrative Report. "The concept is to bring in a variety of foods that aren't currently available in the City. Food trucks generally can be an attraction for tourists and bring people in," said Jackson.

A few food trucks members of the Washington State Food Truck Association would qualify as contenders since they do not duplicate any of the foods already sold in Chelan. "There would be local representation amongst the people there," said Mayor Mike Cooney. As he explained, so far there has been three locals who have food trucks or are in the process of acquiring one.

The space for the food truck

would be rented out on a daily basis for \$100 to offset any expenses the City might have. "We anticipate a seven-day time limit versus all summer, at least on a starting basis," said Jackson. To start off, the City would allow two to five

food trucks to be parked at the Marina. The food trucks would be required to collect their trash and recycle from the bins; no loud music and alcohol would be permitted.

Amy Mack owner of the Lakeview Drive-In was invited

by council member Ray Dobbs to state her opinion as her business is "ten steps away from the path."

"I have a couple of questions and concerns I want the Council to consider in further discussions," said Mack. Mack's first comment was geared towards parking, and how the food trucks would impact that. "We do not have the resources day-in and day-out when we are at the volume we are at, to be able to monitor the walk-offs ourselves," she said. As mentioned parking, is a major concern to her and her family.

She also showed concerns with the food truck's food offerings. She was relieved after Jackson clarified that they won't be competing with other local businesses. Another thing she touched bases on was the bathroom at the Marina and whether or not that would be always open and clean. Mack also proposed that the Council encourage more bike and foot traffic to the area.

## English as a Second Language class culminates for the summer

More than two dozen receive certificates

CHELAN - After spending 35 years in Latin America as missionaries, Tom and Ellen Dunbar took on another mission by starting the English as a Second Language (ESL) class in Chelan nearly seven years ago with the help of other church members.

When the couple arrived in Chelan, they immediately saw the large Hispanic community in need after seeing that so many of them didn't know English. "It just said to me there's something you can do," explained Dunbar. From there Dunbar, along with other church members, decided they all wanted to do something for their fellow Hispanic community.

An ESL class seemed to be the way to help many of them out. With the sponsorship of the Living Stone Church, the group set the date and gathered enough materials to teach 10 people to begin with. Little did they know that 40 people were going to show up on the first day of class, leaving them with no option but to scramble for some more books.

After one year of teaching ESL during the months of October through April, they realized that the time wasn't

working out for many of the ESL students. "The workers in the orchards couldn't get away from work, so the next year we started the first of November and went all the way through March," explained Dunbar.

The ESL program started in Chelan; however, the volunteer teachers realized that the majority of their students were from Manson. A volunteer teacher suggested starting a class in Manson to accommodate those living there. The ESL class in Manson then began to be offered at North Shore Bible Church on Monday and Wednesday nights. Later the group found out that some people could

not meet at night because of their work schedule, so they started an afternoon class which continues to be held at the Chelan Public Library.

Between the three centers, 50 to 60 students get registered each year with an average attendance of 20 in Chelan and 15 in Manson. In Chelan, the classes are taught on Tuesdays and Thursdays during the evenings at Chelan Valley Hope.

Altogether there are 21 volunteer teachers working

with the students at different levels. One of the major philosophies of the program is to build relationships, "even if they do not get the exact English we want a relationship," said Tom. Bob Meyers started teaching ESL from day one and has enjoyed it ever since. "I really enjoy the people whom I've meet ... I really like the people I meet, it's not just a one-sided thing these friends of mine, they really are my friends," Meyers said.

## Special Election ballots mailed by week's end

Former Lake Chelan School District superintendent shares his concerns

CHELAN - In the mailboxes this week Chelan voters will find the Special Election ballots, in which they will decide to "approve" or "reject" the Lake Chelan School District (LCSD) Bond Proposal of \$75.5 million to construct a new high school and renovate aging school facilities.

According to a statement on the Citizen's Campaign Committee's website, "the Lake Chelan School District has a tradition of excellence, providing career and technical education, producing high graduation rates and offering sports, clubs and arts activities that produce well-rounded students who are prepared for careers of the future."

LCSD Superintendent Barry DePaoli stated in a March interview, that the projects are the best way to amplify learning opportunities in the schools as they move into the 21st Century. The bond funds will be broken down into three parts; \$59 mil-

Jackson mentioned that a list of requirements would serve as a guide to select the trucks. Some of the things the City would look for are: the truck's background, past performance, pictures of the truck, how it would enhance the Chelan experience, insurance, references and so on. "We are looking to bring in quality," said Jackson.

Council member Tim Hollingsworth sees the potential in creating an environment that attracts people in which everybody would benefit. Council member Kelly Allen also had a few things to say regarding the garbage and bathroom cleaning. Allen mentioned that she would like to see an action plan on these two items before moving forward with the food truck establishment. "It's a beautiful location and if it's not taken care of it can go from a beautiful location to one that is just trashed," she said.

With the feedback received from Mack and the rest of the Council, Jackson will be back with a proposal for the Council

In other business:

current panels are difficult to install and have deteriorated in last the 17 years of use, she said. The total project will cost \$22,445 and the Lake Chelan Bach Fest Board has already raised half of the monies. The project goals are to improve the acoustic and visual en-

lion will go towards building a new high school, \$9 million will cover the costs of reconfiguring Morgan Owings Elementary and Chelan Middle/High School plus renovating them, Sargent Field will then be modernized with the remaining \$7 million.

Former LCSO Superintendent Jim Busey addressed some of his concerns with the bond, in particular with the \$59 million for a new high school and the "flat" student enrollment over the years. "People can say that building new schools is not about enrollment, but building new schools is about enrollment," said Busey.

After six weeks of asking questions, scheduling meetings with LCSO superintendent, board members, and business manager and conducting lots of research, Busey's "concerns are bigger today than they were two months ago."

According to Busey, enroll-

ment at LCSO has been flat for 20 years and it continues trending down. To Busey, the "overcrowding" doesn't justify building a new high school and paying \$59 million for it. "You're going to pay the maintenance and operations and extra staff costs for 21 years ... that building is not needed, it's a decision I am in total disagreement," he said. To Busey, the request of \$75 million is "outrageous." Further-

more, he mentioned that other improvements could be fixed for a lot less money. Instead, Busey suggested remaining debt free by prioritizing improvements and plan for small projects with a budget of a few million dollars from capital levies.

Election Day will take place on April 23. If approved by 60 percent or more, the taxpayers will begin paying for the bond in 2020.

The rallies are open to all youth and are welcome to attend. Food will be provided and they will be able to hear more from Mortimer and his message of hope. Those who attend the rally are going to receive a resource card with contact information, along with the suicide hotline number.

Longmire explained that in Chelan a 30-day Kindness Challenge is being developed. The idea is to have a social media bundle for the schools to post describing a challenge for the day. The challenges might start off easy and get harder as the days go by. "A lot of those cases of suicide develop out of cases of being bullied, so this is a way to also approach it from that point," clarified Longmire.

The big picture of the week is to spread awareness, recognize signs and for people to get accurate help. Longmire and the rest of the group don't want this to be a one-time event. "We would like to develop some support groups for it and possibly do more with that," said Longmire.

answers.

That same day, the Board was supposed to hear from the Facility Steering Facilities Committee, however, the item got tabled for the next meeting. "There are a couple of issues we need to discuss before any decisions are made ... we would discuss further before recommendations to the Board," said Board Chair Phyllis Gleasman, who is a member of the committee.

A progress report on the Service and Quality/Safety was presented by Kris Haasl, Courtney Wallace and Brad Hankins. Haasl reported on the Service pillar which mainly deals with improving patient satisfaction, so far all goals are "green." Wallace stated that the staff is doing all the work needed to meet the goals, "they are staying on top of it doing a wonderful job," she said.

Recruitment for a CFO that has strong revenue cycle and financial operations capabilities is currently taking place,

informed Hospital CEO Steve Patonai. "We had three candidates, one we pulled away from and the other two took other positions elsewhere ... we have three more in the pipeline right now," said Patonai. He mentioned that current CFO Vickie Bodle needs "additional horsepower in the finance department," since she is dealing with the construction project and USDA loans.

Committee meetings will now be scheduled during the first two weeks of the month to allow the minutes to have

a quick turn around process. Currently, the committee minutes take up to one month to get approved. The idea will now be to approve them electronically that way the Board can view the minutes during the monthly meeting.

The Board will hold an open workshop on April 16 starting at 4:30 p.m. in order to discuss an array of different topics, the agenda is yet to be determined.

The next regular meeting will be on April 23 at 1:30 p.m.

## Wanda Darlene (Riley) Godbey

On March 21, 2019 our mom was relieved from her suffering after 365 days of pain. As was her nature, she fought a hard fight.

She was known by many names - Mom, Grandma, Great-Grandma, and GG, but the name that she held dearest was "Mrs. Vaughn Godbey." Her family takes great comfort in knowing that now she is reunited with the great love of her life, her husband, Vaughn - their first born daughter, Marcia - their grandson, Carter - their son-in-law, Ken - plus other loved ones who passed before her.

Mom was born on September 18, 1925 in Gove, Kansas to Alexander and Lois Riley. In 1937, her parents decided to leave the "dust bowl" of Kansas.

They left in an old Chevy pick-up, with \$40.00, a stove in the back, and five children. After many stops along the way to work for money in order to continue their journey, they finally settled in Chelan Falls, Washington.

She graduated from Chelan High School in 1943. As her children and grandchildren

went through their high school years, she would tell each one, "I never had to read The Grapes of Wrath - I lived it!"

As a young woman she was selected as Chelan County War Bond Queen. Her picture was displayed in store windows, and shortly after V-E Day a young man came to Chelan - Vaughn Godbey from Nebraska. He saw her pictures in various windows, then saw her walking across the street one day. He told the man that he was working with, "I'm going to marry that girl!" Mom, however, was not interested. He pursued, she alluded. She always told us girls, "I just knew he was too much for me to manage: so handsome and self-confident." However, Daddy persisted and won his girl. Five months later they were married on New Year's Eve. As they said, "we always had a party for our anniversary!"

They were two hard working young people who survived the "dust bowl," poverty, the depression, and WWII.

Daddy was the man with the vision, but Mom was the help-mate who helped turn his vision into reality. She always disputed her importance, because she wanted Daddy to have 100% of the credit. Those of us who loved them know that it took two - the perfect match - to make their hard work turn that vision into reality.



In 1950, while living in a John Countryman's cabin in Brewster, Washington, with a three year old, a newborn (who slept in a drawer), a brother and father-in-law, they used Daddy's money from the GI Bill to start Godbey Red-E-Mix Concrete, Inc. Many years of hard work and sacrifice followed to make their business successful. Years later they purchased Chelan Concrete, Inc.

Because "Mr. Wonderful" wanted a family, their lives were blessed with three daughters - Marcia, Portia and Jinx.

They, also, suffered great heartache when in 1984 an automobile accident took the lives of their daughter, Marcia, grandson, Carter, and son-in-law, Ken. 18 months later Mom lost the love of her life in a workplace accident.

She missed him every day.



At her most difficult time, her "Irish Spirit" came through and she gave her trust to her remaining sons-in-law, David Freels & Stephen Pauli, to carry on the family businesses. She would say, "well done, boys" as the businesses grew and are now entering into the hands of the third generation, fulfilling a dream that Mom and Dad envisioned.

Us girls always called Daddy "our rock," but after his death, we soon discovered that Mom was "the foundation" that provided the stability and support. She always denied that, because she always gave Daddy all the praise and credit. However, she truly was "the foundation" that he needed in order for the vision to become

reality.

Many parts of this eulogy refer to Mom and Dad, because her story in many ways was their story. It was the way she always wanted it, and the way she always told it.

Mom lived a long life filled with dignity, hard work, self-sacrifice for family and those she loved, and always striving to be an independent person.

She left us all with a great legacy. She believed that love shows itself in discipline, example and sacrifice. We will miss her dearly and will forever be grateful for the lives she made possible for each and every one of us.

Every evening when Mom would come to the end of another day shared with Daddy, the last thing she would do is say, "good night, sweet prince."

Her family who so loved her, would like to paraphrase William Shakespeare and say, "Good night, Sweet Prince and his Princess"

*May flights of angels sing thee to thy rest!*

Mom was preceded in death by her husband, Vaughn, daughter, Marcia, grandson Carter, and son-in-law, Kenneth. Also by her parents and all of her siblings. She is survived by her daughters Portia (Stephen) Pauli of Chelan and Jinx (David) Freels of Brewster. Grandchildren Trevor Kelpman, Camisha

Hughbanks, Piaget Huewe, Griffin Freels, Chauncy Titcomb, Colton Freels and nine great-grandchildren, with another on the way.

In lieu of flowers, the family believes that Mom would wish for you to "pay it forward" in her memory. Do good deeds for others when possible, and as you do so remember her with a smile and warm thought.

The family would like to thank all of you who gave Mom such loving care during the past year. Everyone at Harmony House, the doctors and nurses at Lake Chelan Community Hospital and at Confluence Health Hospital. Many of you went the "extra mile" and gave her compassion and understanding, which made the past year easier for Mom and those of us who love her.

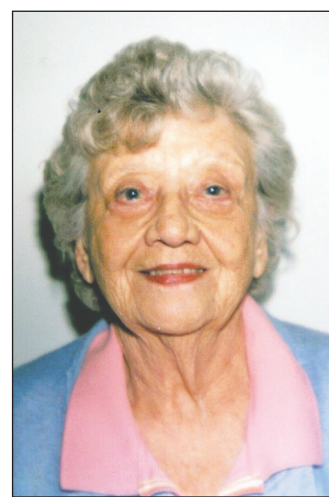
