Zimmer to replace Jerome as Lake Chelan's community nurse

CHELAN - Susie Zimmer has been getting to know clients and the needs she will be filling in as she takes over as the new nurse for the Lake Chelan Community Nurse

"I've lived here for 30 years, I live in Manson and I like to garden and farm ... now that is changing because I am in town a lot more," Zimmer said.

Since August of 2017, Michelle Jerome has served the greater Chelan Valley from Manson to Chelan Falls visiting, assisting and educating vulnerable and older adults in their homes as the community

Recently, Jerome and her husband decided to move to Twisp, leaving behind the big role as community nurse open. After consideration, Zimmer has stepped up and will fill in Jerome's nursing role.

Back in November, Zimmer joined Jerome in some of her in-home visits to "get a grasp" of the program. "I have been a nurse for a very long time this is just different, it is a totally different setting," Zimmer

A month later, Zimmer started shadowing Jerome and now she is doing some charting and becoming more independent. Zimmer has also gotten the chance to take a closer look at the different resources in the Chelan area.

Once she get's a full picture of the program itself, she feels that she will be ready to step up as a community resource.

Next month Zimmer will be shadowed by Jerome and in March she will be consulting all on her own.

The Community Nurse program is free and was initially funded by grants and generous donations from those who helped Jerome.

At the moment the program has no grants and now both nurses are actively fundraising. "It is between \$2,000 to \$2,500 a month budget right now for a half-time nurse, which includes expenses," stated Jerome.

According to Jerome, "Keeping the program at its grassroots and being funded by grants and donations makes it possible to see everybody, we don't go in and ask for payment, we are not reimbursed by any government entity, it's totally grants and donations. That makes it accessible to all."

The program has maintained in constant growth, at the end of the first year Jerome stated that the program had 50 clients. Right now in the database, there are over 200 people that Jerome has had contact with. "We currently have active 23 clients but we are also keeping track of another 27," said Jerome.

One of the other services the Community Nurse program of-

MANSON - Kari Sorensen who was selected by the community to fill the open position as council member for the Manson Community Council back in December, joined Kathy Blum, Sarah Cushing, Chris Willoughby and Jorge Valencia on the first meeting of 2019.

On Jan. 15 council members nominated and voted on three members to be officers for the year. Without any opposition Chis Willoughby was voted as Chair, Sorensen as Vice Chair and Cushing will be the Secretary and Treasurer for the council.

That evening, Chelan County Sergeant Chris Foreman stopped by to speak about what the Sheriff Department is doing and seeing in Manson and to also answer questions from the board and community mem-

"Nothing has really changed from years past. We heard from business owners on mainly the downtown corridor on the complaints and the frustration

with the speeders ... most of the people speeding are local and in off season, the summer time people who are vacationing," said Foreman.

Glass to Sand girls crush 217 wine bottles in one weekend

MANSON - The Friday after New Year's, Megan Clausen and Devyn Smith founders of the Glass to Sand project received the GLS and machine to start crushing glass bottles.

After receiving over \$3,000 in donations, Clausen and Smith had to rely on a loan to cover the reminder cost of the GLSand. "We are going to take out a loan and you are going

to learn how to do this," said Clausen's mom to them both.

Once the machine was ordered, a few weeks later it was delivered at the North Shore Café. Soon, they realized that the machine couldn't be plugged into an electrical outlet.

'There weren't any parts to plug it into, so we rewired it, we talked to some electrical people," Clausen explained. After the machine was re-

wired and ready to go, during one weekend Clausen and Smith got together and crushed 217 bottles and produced eight sand bags. It took about one hour to rinse the bottles and to press them. Each of them had took a chance to work the machine which was easy to use said Smith.

The sand bags are selling for \$5.00 at Lake Chelan Building Supply. Clausen and Smith receive \$4.00 of that profit for each bag sold.

Now that they have the sand, the girls are planning on collaborating with members of Chelan Earth Day to experiment with the sand. This will also serve as a way to spread the word out to the community on the different ways the sand can be use.

At the moment, the Glass to Sand girls have partnered

Foreman also spoke about the Marine Patrol, for the most part he stated that the patrol stays on the lake mainly in Chelan, however they do check out the Manson area. "One of the things we are trying to do is break up the lake into different zones, so we can document what we are handling and where. Then we can look at those numbers and see the issues are and then adjust accordingly from there," he said.

The Sheriff Department operates differently as the seasons change. For example, during the summer times they deal with alcohol related issues such as DUIs, fights and domestic violence.

Neighbors in the Lloyd Road expressed their concern with people speeding through the neighborhood. Foreman suggested to place a portable speed trailer to collect data in the area from the cars that drive by. This

area is of concern to the Lloyd Road residents because a lot of kids walk to and from school and the road has no shoulder and it is also a blind turn.

"When it comes to our kids in the community we take that very serious," said Foreman.

Sorensen asked a question regarding noise complaints in vacations rentals. According to Foreman, based on County ordinance, there's no time frame for quiet hours. Before that quiet hours started at 10 o'clock.

If someone calls with a noise complaint, Foreman stated, "we will go out there and verify that it's noisy and we will contact them ... whatever they are doing that's noisy needs to stop, then at that point if we get called back the next time they are getting cited."

The frustration with noise complaints in vacation rentals is the fact that every week there's different people, therefore talking to different people every

Foreman explained that during the busy weekends if the Sheriff Department gets a call

up with different wineries around the area to crush their bottles and are not accepting the public's bottles.

On average during the week there are five officers patrolling from Entiat to Manson and three during the weekends. During the summer time four to five officers patrol the areas.

The council also reviewed Council Bylaw changes and came to the conclusion to make a few more changes before fully adopting them. It was determined that letters that contain public comments to the County by the council will be posted on the website for the public

Blum will contact the Peshastin and Malaga Community Councils via phone call to set up a meeting time to discuss questions the Manson council members have for them. The idea of meeting with Peshastin and Malaga came from Manson's concern with soil contamination.

Manson Chamber of Commerce Director Jeff Conwell spoke to the council about the acquisition of Leffler Field. After explaining details on the project, he went ahead and ask for a

letter of support from the board members. The council agreed to write the letter in support of the acquisition.

On Tuesday, Jan. 8, the council hosted an informational meeting on the Master Planned Resort Antheia of Chelan. After the town hall meeting, the council met and wrote their comments to the County on the MPR based on what they heard that night from the area neighbors.

"The Manson Community Council passed a motion based on information available, to recommend the application for the MPR 2018-283 Antheia of Chelan be denied due to parts of the application, and information provided by Antheia of Chelan does not meet State of Washington Growth Management Act, Chelan County Comprehensive Plan, or Chelan County Code requirements."

From employee to owner: Catalina Jimenez acquires Lake Chelan Bakery

CHELAN - In 2013, Catalina Jimenez started working for Lindsay Evans at Lake Chelan Bakery and just five years later, Jimenez has become the new owner of the bakery.

Jimenez comes from an immigrant Mexican family who works in the fields. When she arrived to Chelan from Mexico 20 years ago, she decided she didn't want to work in the fields. Without knowing English, Jimenez applied to work at the Red Apple, where she worked for 10 years before becoming an employee for Evans.

Last summer, Evans assigned Jimenez as the store manager for Lake Chelan Bakery, as she realized she was spending too much time in town running the

Evans commute to work consisted of about three hours said Jimenez. Soon Evans came to the conclusion of selling the business. As a longtime employee, Evans had Jimenez in mind to sell the business to.

"She offered it to me, she said I had a lot of time working here and knew a lot," said Jimenez.

Without doubts Jimenez went on and accepted Evan's offer. "It's a good business, I know how to manage it, it has a great reputation and being the owner has its advantages, Jimenez explained.

Jimenez became the official owner of Lake Chelan Bakery on Jan. 1 and she says there has not been a lot changes now that she is the owner.

"Basically the only changes are that I am here more and on top of that I have to deal with office work," she says. The rest of the work she is already familiar with since she was already running the store under Evans management.

Jimenez is not only in charge of doing just one thing, she explains that she fills in the gaps when needed. She, however, does prefer being in the back,

looking out and making sure everything is well done.

The community has already noticed the recent change of ownership and has been nothing but supportive towards Jimenez. "They have accepted me, very well ... I've had a great relationship with the customers even before it was mine," said

Jimenez is working and planning on adding new items to the bakery. For example she mentioned the possibility of incorporating a tres leches cake.

In terms of beverages, Jimenez has already added a Mexican Mocha to the menu. "During the summer we will be making Italian sodas and Matcha lattes, Matcha teas," she said.

Lake Chelan Bakery employs four others, in both part-time and full-time positions. One of the employees is Jimenez's sister, who is always looking out for her, she says. During the weekends, Jimenez brings her 14 and 17 year olds to the business to help her with washing

"I love food, I do not see this so much as a job, I really love it. Sometimes when I am not here I think about the bakery, even if I am not working I want to be here," said Jimenez.

Soon, Lake Chelan Bakery's bread will be available to purchase at the Chelan IGA Market. Bear Foods is another local store that currently sells the bread. Jimenez will continue to have talks with other local stores that way she can seel more Lake Chelan Bakery's

Jimenez shared her goals, "I want every year to be better than the previous year, every year our goal will be to have the business grow a little ... instead of losing of losing money we want to see that we've made money even if it is one penny."

She would also like to have a bigger space for the bakery and for the customers to enjoy, however, that will come with

At the moment, Jimenez will continue to open the bakery Monday - Saturday 7:00 a.m. to 3:00 p.m. and Sunday 7:00 a.m. to 2:00 p.m. Closed on Tuesdays. Prices remain the same.

fers are blood pressure screenings. Those screenings target a lot more people, "it helps us introduce ourselves to the community so it's a good opening if they need some type of help at home," explained Zimmer.

Jerome states that herself and Zimmer hang out a lot at the Chelan Senior Center and people there recognize their work as nurses. When the seniors see their health declining they know they should contact the nurse to get checked out. The nurses also get a lot of referrals from the clinic.

According to Jerome the program is having a hard time

serving the Hispanic community. Due to this, a student nurse working towards her BSN is working on a project that will help the program reach that population.

In March, both nurses will be presenting at the Northwest Rural Health Association Conference in the Sea-Tac area. The topic of their presentation will be on ways to develop a program as the one currently here, "it was not really hard to do, in a small community because everybody knows everybody and as long as you can figure out a way to get some funding then it's not that hard," said Jerome.

Zimmer's goal as the new community nurse is to serve the

needs of the community to the best of her abilities.

In order to continue to serve the Chelan community, Jerome hopes to get approved for another big grant of some sort, as she and Zimmer continue fundraising. 





The persecution of Tim Eyeman continues

If you are going to challenge the political system be sure you have a lot of money and the help of a major law firm. Otherwise, you are in for a fight you cannot win.

Itappears Attorney General Bob Ferguson continues his legal persecution of political activist Tim Eyman. Last week he requested the court declare Eyman's attorney unqualified to represent Eyman.

It seems the AG has invoked the nuclear option by convincing the court to declare no individual practitioner can keep up with the army of lawyers employed by the state. So only hours before he was to appear in court Eyman found himself without legal council.

It has been said that anyone who chooses to represent themself in court has a fool for a client. The problem is Eyman did not choose to represent himself he was forced to by the very people who have filed the actions against him.

Of course he lost the hearing on procedural grounds that he didn't follow proper court procedures. Of course he didn't. Eyman is not an attorney.

The goal of all of this appears to be nothing more than an attempt to silence



Eyman. A blatant attempt to strip Eyman of his civil rights under our Constitution.

Ferguson is using the Campaign Finance Laws to persecute Eyman. Claiming Eyman did not file proper reports with the Public Disclosure Commission. The suit is for \$2.1 million dollars and a lifetime ban from participating in any political activity. It has forced Eyman to file for bankruptcy.

The problem is the penalty far outweighs other suits by the AG's office for similar violations of Campaign Finance law. A review of the Attorney General's website regarding enforcement action against campaign finance law violations shows the action against Eyman is remarkable. Only one other claim exceeds the amount sought against Eyman. That was against the Grocery Manufacturers Association for \$19.1 million. The next closest claim was against the Washington Education Association for \$975,000. The other 32 cases listed averaged \$74,609 including AGO costs for prosecuting the cases.

In December of 2017 The Spokesman Review ran a story about how Campaign Finance complaints were becoming the newest political weapon Washington politics. Bob Ferguson's assault on Tim Eyman is moving that weapon from the big money politics of labor unions and political parties to individual citizens who are simply seeking to petition their government for redress of their grievances.

That is unconstitutional. As the chief legal officer for the state, Attorney General Robert (Bob) Ferguson should know that.

There is another political activist who has promised to bring suit against Ferguson for violation of the very Campaign Finance laws he is charging Tim Eyman with violating. Glen Morgan of WeTheGoverned.com has filed 14 claims of violation of Campaign Finance Laws by Ferguson according to a story on his website.

There is no reason that

There is no reason that individual citizens should need to hire a major law firm to represent them when they are simply exercising their Constitutionally

protected rights.

It is time for political activists and organizations that claim to support holding government accountable to come together to support Tim Eyman. Organizations like Glen Morgan's WeTheGoverned and The Freedom Foundation need to call on Ferguson, Governor Inslee and both political parties to end this travesty.

The suit needs to be dropped. The state needs to agree to pay for Eyman's current legal costs and Attorney General Bob Ferguson needs to resign. It is the only fair solution to this egregious abuse of an ordinary citizen.

In light of the Supreme Court Decision in Citizens United there is some question about the legality of the entire Campaign Finance Law and the Public Disclosure Commission. That law was passed as a result of a citizen's initiative but now is being used as a political weapon not a tool for citizens to make more informed decisions.

In light of the travesty being perpetrated on Tim Eyman as a result of this law it may be time for an Initiative to disband the PDC.

Gov. Inslee wants state to spend \$10B more, paid for by \$4B in taxes against 'the haves'

Why must it always be thus - the "haves" versus the "have nots"? In this case it is vice versa. Big government, i.e., the state of Washington, wants more tax revenue so it can spend more money.


