

Builders oppose new GFCs and water, sewer rates for 2019

CHELAN – The Chelan City Council had a busy meeting on Nov. 27 with a packed agenda, a series of public hearings and administrative reports had the meeting running for more than three hours.

Two weeks ago Amy Hannu representing K&L Homes spoke in front of Council on her concerns regarding water meter costs. “The biggest thing is to make sure that these water meter hookup fees are at an affordable cost,” she said.

According to Hannu, K&L Homes has been building affordable homes in the area for the past six years and they want to continue doing so. “I talked to several people and have done some research online ... in some of my findings the cost of connection for labor and materials, for most water systems reported paying \$800 to \$1,200 per connection ... that does include

water and sewer,” Hannu reported.

Such information was taken from the June 2018 Washington State Department of Health website.

However, Hannu understands that there are costs to keeping City water and sewer going. She only asks for a reasonable price, “let’s not have this at a price where people just won’t be building here.”

In charge of the proposed water and sewer rate discussion was Andy Baker of FCS Group. Back in late October, the FCS Group presented a rate study to the Council which in part evaluated the cost-of-service for water and sewer, along with General Facilities Charge (GFC).

Baker then presented a drafted resolution to the Council which sets fees to be charged for water, sewer and installation fees.

Councilmember Tim Hol-

Chelan Fire & Rescue Ladder 71 will be replaced with a dual purpose truck

CHELAN – Chelan Fire Commissioners approved \$220,000 to purchase a new dual engine truck to replace Ladder 71, during a special meeting held on Nov. 29.

In a previous Chelan Fire and Rescue Board of Commissioners meeting, Fire Chief Tim Lemon and Fleet Manager John Goyne reported on Ladder 71 being out of service.

Ladder 71 failed the UL testing which certifies the performance and safety of fire apparatuses, systems devices and ground ladders, back in early November.

During the special meeting, the Commissioners heard from Lemon on different replacement options for the ladder truck.

Goyne reported that it would cost anywhere from \$90,000 to \$100,000 to fix Ladder 71. To take the ladder apart it will cost \$10,000 alone.

However, some of the truck parts are obsolete. It would take anywhere from six to eight months to put the ladder back together.

Commissioner Russ Jones,

requested more information from Lemon during the meeting as to why a ladder truck is necessary.

“If we do not operate the ladder within Chelan, the four story structures, we won’t be able to reach them ... insurance issues will go up, I am not sure what that really means but the price will go up,” said Lemon.

Not having a ladder truck will also affect the Washington Survey and Rating numbers, “the most high risk aspect is not having the capability, it’s a unique tool that is not used every day, but it’s the only tool that can do the job if we have people up, on the side of the building,” Lemon added.

To Commissioner Phil Moller, “not having a ladder is not an option.” He argued that Chelan’s ladder will service other communities, not just Chelan.

On the other hand Commissioner Jay Witherbee, wants the fire department to obtain a dual purpose vehicle.

Lemon expanded on how a dual purpose vehicle would work, “we are looking at something different that we can actually run in the front plan

engine out here for the city and the commercial area.”

With a dual purpose vehicle, the plan would then be to reduce the fleet by one vehicle. “Seventy-one will bump down as a second out for further out and support of the City response, that moves engine 79 down and we actually put all of our trucks down and retire

the oldest truck.”

The engine to be retired would be 74, which appears to be the weakest one of all. By reducing the fleet, the fire department is looking to reduce some costs.

With that being said, Lemon presented a few used engines

LCCHC Board of Commissioners sign delegation authorization, interim CEO Patonai and CFO Bodle to decide new hospital bond levy target

No decision yet on new CEO

CHELAN – By unanimous decision the Lake Chelan Community Hospital and Clinics Board of Commissioners voted on a Delegation Authorization for Interim Chief Executive Officer Steve Patonai and Chief Financial Officer Vickie Bodle to make a final decision on the bond levy target on behalf of the Board.

At the Nov. 27 meeting, the Board heard bond updates from Jim Nelson of D.A. Davidson. “Today we released what we called a preliminary official statement ... it describes the district, the commissioners, the terms, the finances of the district, the

terms of the bond ... that goes out to local investors to insurance companies,” informed Nelson.

The next step will be a preliminary pricing conference call, “that would be on Dec. 10 and then on Dec. 11 we would set the final restraints to the bond,” said Nelson.

Towards the end of December the hospital will receive \$20,000,000, which will go into the county’s treasure account into a restricted fund.

The bond money will finance a portion of the cost for the new hospital facility. The rest of the funding comes from the USDA financing.

Nelson also talked about the different forms of payment options. “The voters approved the bond on the amount of \$20,000,000 for a term of 30 years or less ... the goal is

come in at .35 cents or less and also financing the bond for a term less than 30 years,” he said.

Nelson presented the following levy rates for a \$300,000 home to the Board:

- 28 years has a levy rate of .32 cents with a monthly cost of \$8.06
- 27 years has a levy rate

of .33 cents with a monthly cost of \$8.25

- 26 years has a levy rate of .34 cents with a monthly cost of \$8.48
- 25 years has a levy rate of .35 cents with a monthly cost of \$8.67

“For each year reduce it from 28 years then lowers your interest cost by approxi-

that could be purchased by the fire department to replace ladder 71.

In the options was a Pierce 2007, coming from the low part of Florida, with 13,000 miles, 2,000 hours. This engine costs \$418,880 after tax, with an annual cost of almost \$30,000 and a life span of 14 years.

Such engine was preferred by Jones, due to low hours, miles and for the "decent value."

For his part, Moller doesn't think any of the vehicles presented to the Commissioners are the right ones to buy.

The real question came from Witherbee, when he asked, "how do we pay for all this? Where does the money come from?"

mately \$940,000," reported Nelson.

In case interest rates creep up Nelson suggest that the best way to go is the 26 years mark at .34 cents.

"I am just one of those people that I want to get out of debt as fast as I can and on a building that ages, I want to be done as soon as I can," said Commissioner Jordana LaPorte.

After further discussion other Commissioners agreed with LaPorte, "I wouldn't go with the 28 years, I would look into the 25, 26 years," said Commissioner Mary Murphy.

With a 25 - 26 year target in mind, Patonai and Bodle

"We are currently sitting just under \$300,000 in the apparatus account \$299,153 ... if we go for higher end one we would tap over the emergency reserves," said Lemon.

Moller presented Lemon a different option, a Pierce 2005, "it's two years older, a hundred and some thousand dollars less." The actual cost of such truck is \$185,000.

Lemon and Goynne will be looking into the 2005 truck and get in touch with the seller to get more details on it. The Commissioners voted on authorizing \$220,000 to purchase the Pierce 2005.

If it doesn't work out, Lemon will continue to search for a dual purpose vehicle to fit Chelan Fire and Rescue needs without surpassing the \$220,000 range.

Community Foundation Awards \$240,455 in Grants to Nonprofits, Prepares for Give NCW

WENATCHEE - The Community Foundation of NCW has awarded \$240,455 in grants to 30 nonprofits across the region. The grants were funded by the Regional Impact Grant and Partners in Giving programs.

The Regional Impact Grant (RIG) is an annual, competitive grant program that supports charitable organizations in Chelan, Douglas, and Okanogan counties. Sixty organizations applied for the grant, and 30 received awards.

To evaluate and determine award recipients, a team of foundation staff and board participate in site visits with each applicant to learn more about their organization's grant request and potential impact. The site visit teams visited all 60 organizations spanning the region, from Leavenworth to Chelan to Tonasket, and logged over 600 driving miles. These insightful visits are essential in helping the foundation's

board make thoughtful, informed decisions to ensure grant making supports a broad base of areas that enhance quality of life in the region's communities.

Of the awarded organizations, 25 will participate in Give NCW, an online crowdfunding campaign beginning Thanksgiving Day through Dec. 31. Since the RIG can only award a portion of the grant requests, Give NCW provides an opportunity for the public to donate and help organizations reach their ultimate goals. Last year, Give NCW received over \$253,000 in donations from the public - over \$50,000 more than the foundation's grant award amount.

While Give NCW is limited to 25 participants, the foundation's board agreed to fund 5 additional organizations with programs that meet essential needs and/or have a significant impact in the community. A portion of this funding was made possible by the Partners in Giving program, comprised of individuals, families, and businesses that make unre-

stricted gifts to support the general work of the foundation.

"The foundation's budget for these annual grants is around \$200,000 each year, which comes from bequests left by generous individuals and families who loved the region" said Claire Oathey, director of community grants. "We're trying to help nonprofits make a greater impact with larger awards, but each year we have more requests than we can fund. Added resources from our Partners in Giving allows us to grant a few extra awards, and Give NCW gives nonprofits an amazing opportunity to reach their full goal. We are so grateful for those that invest in making our region a better place for all."

City of Entiat received \$9,500 for Fire Station Park and Tender Loving Care for Seniors received \$5,000 for home based support for seniors.



As part of that preparation, I invited some of my colleagues to our area to learn directly from local officials about issues important to North Central Washington. I was proud to help host recent visits and discussions with senators on energy and transportation issues.

While I had hoped certain colleagues and staff would be willing to visit our area, I was pleasantly surprised with how both opportunities came together. What I wasn't surprised about was how well our local officials did at articulating the issues important to us and describing the uniqueness of our needs.

Senate Energy, Environment and Technology Committee Meeting - October 29

Members and staff from the Senate Energy, Environment and Technology Committee gathered together with nearly 40 statewide stakeholders to discuss a variety of energy issues important to our area. I'm proud to serve on this committee and am thankful that Chair Reuven Carlyle and Vice Chair Guy Palumbo both attended, along with longtime public power advocate Sen. Tim Sheldon and senior committee and caucus staff.

Special thanks go to our local PUD general managers Steve Wright of Chelan PUD, Gary Ivory of Douglas PUD, and Steve Taylor of Okanogan PUD, who helped provide local insight on energy and broad-

Following the extensive discussions in the morning, my fellow senators and staff colleagues toured Rocky Reach Dam, where we learned about hydro efficiency and experienced the insides of one of the worlds best hydropower projects. After the hydro tour, our group visited Link Transit to learn about its all-electric bus fleet the states largest powered by our renewable hydropower.

Senate Transportation Committee Chairs Visit and Tour November 7 and 8

My colleague Steve Hobbs, chair of the Senate Transportation Committee, visited the North Central Washington region over two days in early November to learn more about our regional transportation needs. Among his many stops

included a discussion with staff at the regional Department of Transportation office, a Chelan-Douglas Transportation Council meeting, and a tour of local transportation priorities. The tour included Representative Mike Steele, Representative-elect Keith Goehner, Wenatchee Mayor Frank Kuntz, Chelan County Port Commissioner JC Baldwin, Regional DOT Administrator Dave Bierschbach, Transportation Council Executive Director Jeff Wilkens, Link Transit General Manager Richard DeRock, and other local officials and staff.

We discussed the proposed \$25 million McKittrick Street Railroad Underpass, \$21 million Wenatchi Landing Interchange, \$4 million South Wenatchee Apple Capital Loop Trail Connection Bridge,

and Wenatchee's \$113 million Confluence Parkway Project, along with a presentation about Links electric bus fleet. I could not have been more proud of how well our ambassadors did in working together to develop the tour, detail our local transportation priorities, and put our best effort forward describing our needs to the Transportation Committee chair and committee staff. Regardless of what legislation advances in the upcoming session, good things come from all of us working together to build relationships and advocate for our region.

Hollinsworth brought up a concern regarding dormant, vacant properties and the fact that they pay an ongoing charge regardless of their use.

"I do not see this being addressed in the resolution," said Hollinsworth. Baker clarified that the monthly service charges payment of such dormant properties, "go to the ongoing operational maintenance of the system, which has been constructed to serve them ... they have to continue to maintain that."

Hollinsworth wants the Council to debate at a later date the fairness of this to dormant properties in the City. He believes that a short term waiver could be a big help and it won't affect the revenue. Councilmember Kelly Allen agreed.

Finance Director Steve Thornton lead the Proposed 2019 Final Budget public hearing by giving an overview presentation of the 2019 budget. Thornton provided a summary of each of the City's funds, proposed expenditures, revenues and budgets.

The Council discussed the budget during five budget workshops. The last one was held on Nov. 6. A couple of items grabbed the attention of councilmembers during the workshops. "Three of them were in

the budget and one of them was added," said Thornton.

In early November the City received a letter from Thrive Chelan Valley. "They are budgeted for \$13,000 and they are requesting an additional \$7,000." Secondly, Councilmember Ty Witt requested a moderate waste facility contribution of \$13,000. Added at the Nov. 6 workshop was \$30,000 towards the Pingrey Wall Mural cost share. The fourth amendment to the proposed budget includes the removal of an interfund loan repayment of \$162,000 beginning in 2020.

Thornton wrapped up his presentation with a summary of all capital funds. The proposed 2018 budget will be adopted in the next City Council meeting on Dec. 18.

Chelan Mayor Mike Cooney reported that on Dec. 5. he will be meeting with County Commissioners to talk about glass recycling. Cooney will be inviting Devyn Smith and Megan Clausen, Glass to Sand at Lake Chelan founders.

A week after, on Dec. 12, Cooney will meet with Port of Chelan Commissioners and Director to discuss a five year economic development plan within the town.

On Tuesday, Dec. 4 the Chelan City Council held a workshop with some of the items from the Nov. 27 meeting being addressed.

The Tyranny of the law

One of the most sacred principles of the American justice system is that an individual is presumed to be innocent until proven guilty.

The concept is embedded in our Constitution and the Bill of Rights - the first ten Amendments to the Constitution that protect our individual freedoms from abuse by the government. His success has infuriated legislators and liberal west side politicians for two decades.

But now Attorney General Bob Ferguson is suing Eyman for violation of Washington state campaign finance law. AG Ferguson is seeking a \$2.1 million fine be levied against Eyman and a lifetime ban against Eyman being involved in any future political

activity.

Read that again - Ferguson wants a lifetime ban on Eyman for any future political activity.

In other words, the Attorney General of the State of Washington wants to strip Eyman of his constitutionally protected rights as guaranteed to him under the Bill of Rights.

The very first Amendment not only guarantees freedom of the press but it promises that the government shall make no law restricting "...the rights of citizens to peaceably assemble and to petition the government for a redress of grievances."

Putting it a little more directly, our liberal minded Attorney General wants to violate Eyman's civil rights to petition the government for a redress of his grievances.

If you think I am overstating the case, consider that in a court hearing in October of 2017 Ferguson's attorneys attempted to argue that Eyman's request to dismiss the suit based on his constitutional protections should be denied and Mr. Eyman's attorney should be sanctioned

(fined) by the court for even raising them as a defense.

The court ruled against the state and opened the door to the Ferguson having to be deposed himself for prosecutorial bias against Eyman. Score one for Eyman and the American system of justice.

Unfortunately, the case isn't over. AG Ferguson has now begun to put pressure on Eyman by deposing his wife, who is not involved in Eyman's political activism.

The result is that Eyman announced as of last Thursday that six years of persecution by the state's Attorney General has resulted in the end of his 25 year marriage and the need to file bankruptcy.

In the words of Tim Eyman, "the process has become the punishment."

Unfortunately, Eyman's case is no longer an isolated incident in American politics.

Consider what we have witnessed over the last two years following the election of President Trump.

The FBI and "Special Prosecutor" Robert Mueller have wasted a small fortune and destroyed the lives of numerous individuals in an effort to find evidence that Trump stole the election with the help of Vladimir Putin.

While some of those convicted by Mueller's investigation have questionable backgrounds at least one of them threw in the towel and fell on his sword to protect his family. General Flynn pleaded guilty to lying.

This is not the American way. It is a travesty of justice that the government is now using legal extortion and intimidation to beat citizens into submission. It is a tactic that many trial lawyers have utilized for decades to extract damage awards from American Industry driving up the cost of health care. But now our own government is turning it against citizens.

Attorney General Robert Ferguson is running for governor. He has filed over as dozen lawsuits including lawsuits to protect the "rights" of illegal immigrants but he apparently is unconcerned about the rights of American citizens. He is not only unfit to be the attorney general he is unfit to be governor.

What he has done to Tim Eyman and his family is disgraceful.

What he has done to the American system of justice should be of concern to all Washingtonians regardless of their political persuasion.


Vola 'Grandma Jean' Walker







RCW 87.03.051 "... No one ownership may accumulate more than forty-nine percent of the votes in one district. ... an elector shall be entitled to two votes for each five shares or fraction thereof. The ballots cast for each ownership of land or shares shall be exercised by common agreement between electors or when land is held as community property, the accumulated votes may be divided equally between husband and wife. Except for community property ownership, in the absence of the submission of the common agreement to the secretary of the district at least twenty-four hours before the opening of the polls, the election board shall recognize the first elector to appear on election day as the elector having the authority to cast the ballots for that parcel of land for which there is more than one ownership interest. ...An agent of an entity owning land in the district, duly authorized in writing, may vote on behalf of the entity by filing with the election officers his or her instrument of authority."

ABSENTEE BALLOTS:

RCW 87.03.032 "... any qualified district elector who certifies that he cannot conveniently be present at his proper election precinct on the day of election may vote by absentee ballot, and that a ballot and form of certificate of qualifications will be furnished to him on written request being made of the district's secretary.
