# **Chelan Fire and Rescue** ladder truck fails testing

Options to buy or to fix debated

CHELAN - All apparatus owned by the Chelan Fire and Rescue are doing well, except for one.

Ladder 71 is out of service. It failed the UL testing on Nov. 13. The UL test certifies the performance and safety of fire apparatuses, systems, devices and ground ladders.

Fleet Manager John Goyne explained, "when they did the drift test it failed the drift test and it also has a plumbing leak that I am working on."

During the drift test, "The aerial device is placed at full elevation marking the cylinder piston on the second section in relation to the base section and allow the ladders to stand for one hour with engine off."

The drift test was conducted twice and Ladder 71 failed both

times, "It relaxed a little too much which compromises the safety of the personnel in the aerial apparatus," said Fire Chief Tim Lemon.

In other words, they cannot use the ladder truck on any structure fires, CFR is now unable to reach a fourth floor. At the moment, CFR is checking to see what needs to get done in order to get the apparatus fixed.

"I am waiting for calls back from four places to find out if they are able to fix it and see how much is going to cost, "said Goyne.

Even though CFR cannot use the ladder truck to put anyone on it, they can still shoot water up from the truck.

Lemon added,"Our immediate fix is to get a hold of District 1 and let them know in what kind of shape we are," that way

CFR can get a hold of Ladder 1 or Ladder 11 out of Cashmere, which is an hour away.

The ladder truck is 26 years old, so "everything on the truck is obsolete." Govle stated that the cost to repair the truck could perhaps range from anywhere between \$40,000 - \$60,000.

One of the options CFR is looking into is the purchase of

Cooney representing the Chel an Valley Housing Trust had an ask for the Council, which involved the City's help in form of a grant of \$100,000 to help with subsidize GFC fees.

Cooney also asked for the City to pledge \$20,000 a year over the next five years in order to help cover development fees and permits.

Before Goldie started her presentation, she thanked the Mayor, the Council and the Planning Department for focusing on affordable housing.

"We are talking about homes, this is where people get to be their true self. This is a place where they make memories with their families and having the opportunity to have that is a huge deal," said Goldie.

Chelan is home to many, however over the years housing costs have gone up dramatically. "The current median home price is at nearly \$400,000."

Fifty percent of the local population cannot afford those homes because their income is usually less than \$50,000, this makes it difficult for employ-

ers to find "adequate labor."

At the same time, the senior population is becoming more vulnerable to poverty and homelessness. When it comes down to attracting new industries, there's also trouble.

The City and the County have been working on affordable housing ordinances to help organizations such as Habitat for Humanity and other non-profits' efforts. Yet, "there's still something

missing." Goldie believes that the CVHT can partner up with the City as an "effort to improve the housing market," through private fundraising.

Three major features of the CVHT include, "serving a variety of incomes and households who are cost burdened, promises a permanent investment

in the community because the it is own and run by the community, while maintaining Chelan's character and diversity."

Affordable housing is defined as "not spending more than 30 percent of ones income on housing." At the moment Chelan needs 80 homes to reach a healthy vacancy rate, "I believe that by providing single family home opportunities, we will help get that vicinity rate level," said Goldie.

Over the next 20 years, CVHT estimates to have 335 units. They will start with 900 to 1,100 sq. ft single family homes, however "this will vary as capacity and need grows and changes."

The CVHT will have "limited restrictions for who is going to be in the homes." Income qualifications have to be in between \$30,000 to \$50,000 a year range. To qualify one must also take a home ownership class, "we will be providing home ownerships classes and being able to be educated home owner is going to be a huge piece." The last piece then is to qualify for USDA or any conventional loan from the CVHT lenders.

A tripartite board represents the organization. It is made up of leaseholders, the general community and business and public institutions. The board is also advised by different subcommittees, one of them being a fundraising committee.


# **Bugert defeats Smith for Chelan Commissioner seat**

The latest results of the November 6, 2018 General Election updated Wednesday, November, 14 at "4:04 p.m." by the Chelan County Auditor's office show independent Bob Bugert has defeated Republican Shon Smith for Chelan County Commissioner, seat 2.

The tally: Bugert 15,931 votes or 50.7% versus Smith's 15,491 or 49.3% out a total vote count of 31,422. This race was easily the most competitive contest in the county this election cycle equalling a victory of only 440 votes. The previous count showed Bugert up only 160 votes.

Smith, the owner of two "Wok About Grills," one in Wenatchee and one in Leavenworth, said "I am very proud of the campaign we ran. We kept it clean and above board. I'm grateful for the opportunity and the trust the community put in supporting me in this. Off to the planned Noodle Expansion

## and job creation!"

Bugert survived a fiveman August primary field, which included two other independents, Zach Miller and Lee Duncan.

Likewise Smith survived the same primary battle that included one other Republican.

Bugert will be serving with Republicans Kevin Overbay and Doug England on the commission beginning in January 2019 for a four-year term.

For the next five years, CVHT has set some goals.

• 2018 – incorporation, marketing and message development, initial fundraising, site research and planning.

• 2019 – formalization of board, fundraising master plan, site development, Home Owner recruitment, construction of first 10 to 20 homes, vetting next projects.

• 2020 - fundraising, build next 10 to 20 homes, project vetting for next site .

• 2021 – fundraising, build next 10 – 20 homes, project vetting for next site.

• 2022- fundraising, build next 10 – 20 homes, project vetting for next site.

In terms of fundraising, Goldie reported that they have about \$70,000 out of their \$250,000 goal. "I think we will meet our goal ... we are currently vetting out about five different properties and hopefully one of these will turn out."

North Cascades Bank has offered CVHT "a \$2 million construction loan, "as soon as they get any land donation, "once we have the land we can build the houses and that is a very big deal, in 2019 we can have 10 – 20 homes in the ground at least," said Goldie.

Goldie explained to the Council that their \$100,000 donation for subsidy hookups "will rollover for next year," in case not all the money is used, on the other

hand the \$20,000 contribution will go to an operational fund.

Council members had a few questions for Goldie. Ty Witt asked, "what is \$250,000 being used for?" In short Goldie responded that such money will fund an operational fund, "We need to make sure the organization has the staff it needs, the tools it needs to manage and steward the land."

The organization has their bylaws created, yet are not an official 501 (c) 3. "We are hoping that by the end of December we have all this figured out," said Goldie.

"It is a big ask, so we want to make sure some of the foundation pieces are in place," said Councilwoman Erin McCardle. McCardle explained that this ask is setting the standards for every other organization that comes in front of Council to ask for any type of monetary support.

McCardle also asked Goldie if the organization had a business plan, which at the moment they do not. She also thinks there should be an exact breakdown of the where the funds are going to be spent and be reported to Council.

Mayor Cooney wrapped up the presentation by saying, "this got started in the very first part of January and I think there's great progress to date, if this organization is not the one to handle it, who will be?"

# *My first visit to Holden Village*

HOLDEN VILLAGE - My Grandpa Johnny Veroske, my Uncle Jack Veroske and my great-uncle Jack Anthony all worked in the Holden mines off and on during the 1940s and '50s. Jack Anthony had his family living up in Holden for several years right before the mine was shut down for good.

My father Ray Olson played on the town baseball team back in the 1940s too. I can still see him in his wool baseball uniform playing under the lights in the field across the street from the Moose Court, which sat where the clinic is now right across the street from the field.

My father and mother went on the trip to Holden when the town team went up to play the Holden mine team. So I have always been curious about Holden and what was up that long dusty road from the boat landing at Lucerne.

Well, now I know. The Lake Chelan Watershed Planning Unit and the U.S. Forest Service have offered two outings to those who have regularly attended the watershed planning meetings the past several years. I was lucky enough to become one of the participants to go to Holden to see firsthand the remediation that Rio Tinto has done.

We left the Forest Service dock just up lake from 25 Mile Creek State Park at 8:35 am. It was a blustery, sunny day so it was slow going on the Forest Service boat. At 9:45 am we arrived at Lucerne, jumped into two FS rigs and headed up the road. Meanwhile, boat captain Dick Gordon took off to do his boat-in campground maintenance.

Passing by Dan's Camp, we first explored the huge mount of mine tailings that had been

excavated, covered with a protective seal and landscaped. We saw how Railroad Creek had to be rerouted to make room for the protective barrier, five feet wide by 90 feet deep, which protects the creek from being polluted by runoff waters from the tailings.


We next explored the area near the mine portal, which has been sealed with a plugagain to protect runoff waters and thus Lake Chelan from contaminated waters within the deep mine shafts which run extensively into the mountain from the portal.

We enjoyed a wander through Holden Village, parked near the water treatment facility and listened to the knowledgeable Forest Service guides Kari Grover Weir and Rena Rex explained more about the Rio Tinto remediation as we hiked a loop along Railroad Creek and back to the dining hall

After a bountiful vegan lunch, the group had an extensive tour of the mine water treatment plant. Lead and other contaminants are leached chemically from water which had previously just flowed into process result in pure water and a byproduct known as "cake" which is removed to a repository back on the old tailings (which is supposed to last for 50 years before being covered and secured).

The ride back down the mountain, return boat trip and good-byes were uneventful. But it was a pleasure to be among others who work for the Department of Ecology, the Bureau of Reclamation, the Lake Chelan Research Institute, Lake Chelan Now, and others interested in preserving Lake Chelan. Our Forest Service guides were more than accommodating-and even brought along brownies!

It is impossible to imagine what has gone on with the Holden Mine Company tailings. Rio Tinto acquired the mine company which had acquired the Holden mine. So Rio Tinto went into the transaction knowing full well the liabilities at Holden with regard to the environment and Lake Chelan. To me, they have done an exceptional job in a relatively short amount of time. And Rio Tinto is still at work with the mine water treatment plant.
