Fire Levy Lid Lift causes commotion

CHELAN – Community members came together at the July 11 Chelan Fire and Rescue Commissioner meeting to share their opinions on the Fire Levy Lid Lift rejection in the spring.

In summary, the property tax lid lift was placed on the April 24 ballot. Which would increase the tax rate to \$1.32 per \$1,000 of the value of a residence. Since this tax lid lift did not get approved by the voters, the Fire District was affected by losing \$863,052 which will cause the level of services in the District to decrease.

The public had lots to say to the commissioners. More than a handful of people spoke their minds on the subject which it is of major concern to them.

In general, the community members present all agreed that cutting staff members by half is a crucial factor that will affect Chelan as a whole.

“The employees here and the community want what is necessary ... it is necessary to have a certain number of staffing, let's not go backwards to an ageing population and a growing population,” said

Mike Kavanagh.

Kavanagh also wants the lid lift to be pushed to vote a second time around. “Educate the population and let them speak again and if it's true they will vote it down again,” he added.

Also present was community member Jacquelynn Dalton, “I know I am not your favorite because you guys have gotten around 845 emails from a petition signed by locals here in Chelan ... I own two parcels and a small business I am here as an individual to support these guys and to keep our kids safe, to keep our town safe.”

Dalton went on and read some statements from locals who are also in support of the levy and who couldn't attend the meeting.

“Half of the community spoke at the last ballot, the rest of the community needs the opportunity to have their voice heard too and if they vote down I will back off,” claimed Dalton.

Future Chelan permanent resident John Corbin also contributed to the discussion.

City Council reviews projects for further funding

CHELAN – Chelan Mayor Mike Cooney and all seven council members were present for the June 10 city council meeting. For almost three hours the council reviewed ongoing projects, future projects and went over the city's finances.

First off, John Olson and Mike Coopersmith representing the Chelan Senior Center proposed to the council a project to increase the parking lot at the Senior Center. “The Senior Center is not only for the seniors, it is for the community,” said Olson. Due to this, the Senior Center has parking issues that need to be solved. Approximately 30 parking spots are available to the facility, not including offsite parking on the nearby streets and the dirt field where overflow cars tend to park. The proposed project will add around 60 new parking spots and will cost \$87,000. “We were hoping that the City of Chelan would approach the PUD and become partners in this, we would find a way for the three of us to find some money to have the project done,” Coopersmith said. The City Parks leases some of the land from PUD in which the new parking lot will potentially be constructed, because of this they have to be the intermediary between the PUD and the Senior Center. This proposal will be discussed by the council

and they will try to help as much as they can.

Special presentations followed. Historic Downtown Chelan Association board member Linda VanLusen updated the council on the Woodin Avenue Landing Project. Considerable adjustments had to be made throughout one and a half years to make the land next to Campbell's a micro park for everyone to enjoy. Two major changes were made from the very first design that were not going to work out, one being ADA accessibility and two, a retaining wall. These two items had a huge cost increase to the project. In total both the ADA requirement and the retaining wall will cost an extra \$186,000 on top of the project bid of \$420,000.

The HDCA “have been modifying things all the time ... we are trying to make all these considerations.” Towards the project HDCA has raised \$55,000, the City of Chelan has committed to give \$75,000 and PUD has donated \$40,000. HDCA com-

mitted to give an extra \$20,000 for the new design of the micro park. Left to be covered is \$329,000, which could come from a city bond. VanLusen presented the council with different options to help cover the left over costs:

- HDCA pays for entire bid cost. In 15 years they would pay \$14,856 per year to pay it off.

- City of Chelan contributes another \$80,000 towards the project. Then they would help HDCA pay the bond. The city would pay \$5,500 and HDCA pays roughly \$9,300 per year for 15 years.

- The city pays the bid costs for 15 years and pay \$14,856 per year.

“At this point I ask the City of Chelan to look at what we are proposing, see what would work within the city's budget to help this continue to move forward,” said VanLusen. For this project Cooney suggested to discuss this project with Campbell's for a potential contribution, either way the council will be helping the HDCA out.

Lake Chelan Arts Council Barb Koenig brought to the council the latest art idea. A metal six foot guitar, the guitar sculpture is a creation of a Texan artist. The guitar is music related because the LCAC wants to bring more music related arts to town. The cost of the guitar is \$3,800, “I am just here to ask for funds and of course the LCA Council will match half and half with the city”, said Koenig. In the future interactive sculptures will be added to Don Morse Park for kids to play with, as well as water features throughout the city.

During the meeting one of the biggest concerns by the council was authorizing the sale of bonds for street and park projects. Finance Director Cheryl Grant gave a quick overview of the city's projects finances. Some projects have exceeded bid expectations and their cost has taken the council by surprise. Initially the Woodin Avenue Bridge Project included the sale of bonds in the amount of \$500,000, however due to additional costs not originally included the cost increased to \$1,200,000.

A bond for \$1,700,000 was approved six to one, the extra \$500,000 will go to parks projects. Repayments of the bond are projected to be completed in 15 years.

Manson Parks meeting reveals 'bank' to Board's bottom line

MANSON – On Thursday, July 12, Manson Parks Board of Commissioners held a regular board meeting to discuss a Comprehensive Plan follow-up and also touched on other items.

All Board members were present at the meeting. Manson Parks & Recreation District Director Robin Pittman gave a quick financial report. So far Manson Parks is up by almost \$19,000 the boat launch is down \$4,000 and also down is the Marina at \$2,500. The cold weather has been affecting the recreational uses of the launch and the Marina and with the that the financial side. However, the campgrounds are looking just fine.

There was an issue with a campground user earlier on the month, “a costumer got checked in during the quiet hours and they had a complaint about that” said Commissioner Randy Reed. At the moment Manson Parks is dealing with the incident and most likely will refund back the user's money for the inconvenience.

Funding Specialist Kara Raftery from Pacific Engineering has been working with Manson Parks for a few months now. Raftery is helping Manson Parks find different funding options for future park projects, including the Manson Bay Waterfront Revitalization Project.

Right now Raftery is finishing up a drafted letter that will go to the PUD, the letter will “outline further requests and the different parts of the project we have identified.” The PUD responsibilities for the project will also be listed, along with a timeline and costs estimates.

“We wanted to finish that ... so then we'll let them marinated it ... give them a couple of months to assess it then we will come back to touch bases with them,” said Raftery.

The contract with Pacific Engineering has expired and currently Raftery is working pro bono. Raftery wants the all of Manson Parks to be “golden” and is willing to work with them until they can find a funding solution.

Manson Parks is also working on a RCO Grant, they will present their project on August 16.

The 4 of July celebration was addressed by Pittman, “it went very well, we had live music and everybody was dancing ... we had a sprinkler malfunction at the grand finale,” she said. The malfunction had to do with the timer not being adjusted from daylight savings.

In other business:

- Willow Point Park a new pump was installed two weeks ago, yet there has been two failures. Manson Parks is working on that and will get it improved.

- Manson Bay Park is having sewer issues, Manson Parks is working with PUD to find the best option to fix the main vault.

- Manson Parks was able to get down and help out immediately with a boat sinking a few weekends ago. The staff did a great job and they have been receiving a lot of compliments, in particular from PUD on their work.

- So far five applicants have applied for the Campground Host.

Next regular meeting will be on August 9, at 4:10 p.m., 142 Pedoi Street in Manson.

CHELAN – After two community meetings the Lakeside Park Master Plan was modified.

On June 21 and 27, Parks, Recreation and Community Services Director Karen Sargeant hosted two community meetings in order to present two Lakeside Park

Master Plan alternatives.

About 20 Lakeside residents who are very familiar with the area showed up in bulk to the meetings. In the two meetings the public spoke and they showed their concerns towards certain areas of the park.

Based on the public's opinion an improved Master Plan Alternative was drafted.

Some of the most important components for the public included:

- New restroom building
- Two outdoor showers and changing rooms
- Better/more pathways
- Reconfigure swim areas
- Move T-Dock and Swim areas
- Enhance boat ramp
- Expand parking area

– Only Johnson Place Parking

- Refurbish beach areas
- More picnic areas

The updated Master plan still covers all required components for the RCO Grant. “The Board and the public came up with great suggestions and were able to incorporate them,” said Sargeant.

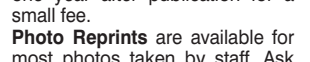

sion. “The key is having an appropriate balanced staffing model, this department is out of balance, it needs more paid personnel not less. It is a safety issue not only for citizens in this community, but it is dangerous for your paid firefighters and volunteer firefighters out there.”

The community members who spoke also claimed that there was not much information about the levy to inform the public about it when it first went to vote.

To all this, Commissioner Russ Jones believes everything was a drive by the State Union. Immediately members of the crowd denied that the Union had anything to do

being at the meeting. “I started this with the town and many individuals, not the Union,” claimed Dalton.

Jones still stands with not voting for putting the levy back on the ballot. “We are here to represent the community. The community voted. The concept of spending additional taxpayer’s money to run another vote, you know I do not see a climate change out there,” said Jones.

Commissioner Jay Witherbee ended the meeting with one final note. “Do I believe that Chelan County District 7 needs additional revenue? Yes. Do I think now is the time to ask? No.” However, Witherbee said he will likely support a future levy.

In other business:
• Two bats were found in the firehouse, one bat was captured the other one couldn’t be found. It was determined that the bats were able to (get) in from a window that had no screen cover. Overall the situation was contained.

• Still working on preparation readiness. In a meeting with the Lake Chelan Home Owners association, the owners had questions regarding what CFR 7 can do and can’t

do to help them.
• Evaluations for the volunteering program have started to come in, this will help with future improvements. Almost every single recruit has attended at least one drill.
• Current number of volunteers at each station compared to 2017 numbers.
Station 71 – 12 more volunteers
Station 72 – 3 more volunteers
Station 73 – 2 more volunteers
Station 74 – 3 more volunteers
Station 75 – 1 less volunteer

Two potential recruits are in the works for Chelan for when the academy starts back up again. The District is also reconnecting with previous volunteers and so far they are getting success from that.

• The Association started off with \$36,247 and ended the month of June with \$37,141.
\$3,054 was brought in and \$2,168 was spent that same month, most of the money spent helped out the Apple Acres family who lost their home in a previous fire this year.

• The parade soon approaches therefore the Parade Truck will be up for maintenance leading up to the event.
• Three weeks ago rescue airbags were ordered, these airbags will help stabilize a vehicle for the firefighter to go in and help out. As soon as training is complete, the airbags will be available for use.

• Approved by the Priorities Committee was \$2,000 for a GoFundMe that has been created for a local family that is dealing with health and medical bills. The Association was approached by community members in order for them to support a new levy, however after further discussion the Association will remain neutral.

On Wednesday, July 18 at 9 a.m. the Chelan Fire and Rescue will have a Commissioner Workshop in which a Fire Levy Lid Lift will be considered for the future.

“If we continue to have good REET years we may want to pay down this down so it is not 15 years” advised Grant. Over the 15 years this bond will collect interest that equals half a million dollars, because of this it is necessary to pay it off quickly if there are any extra funds available.

Even though most of the projects the city is working on at the moment have gone over the initial estimated budgets Cooney believes that something must be done. “It’s one more council after another looking at those same projects and the restrooms stay lousy, the irrigation stays lousy ... we are going to get things done that have been here for a long time. We have smart people up here and we will know at the right time when to say it is too much,” stated Cooney.

In other business:
• New Building Inspector Scott York was introduced to the council. York moved from Arizona and has over 20 years of construction experience and has been working for the City of Chelan for two months now.

• Luis Gonzalez presented new changes in the Continuity of Government Operations Plan. The following revisions to

the July 2018 Final Draft were made to address the questions and suggestions of the Mayor and Council:
• Addition of roles and responsibilities of City Council during emergencies.
• Revision of LocalTel Communications services and capabilities.
• Addition of alternative areas for City of Chelan facilities.
• Finance Director Cheryl Grant went over the Software & Professional Services Agreement with Vision Municipal Services. Back in mid-winter a Request for Proposal for integrated financial software services was advertised. From there two vendors were selected for presentation of their software, the finance staff went for Vision Municipal Solutions proposal. This new service will cost \$63,130, with \$60,000 being paid by a contribution from the General Fund to the Capital Improvement Fund.

• Highland Booster Pump Station Project received two bids on June 19. The city budgeted \$539,000 for the project, the council authorized to pay the amount of \$778,084.75 to contract Western Engineering Constructors Inc. of Ellensburg, Wash.

• Woodin Avenue Bridge Construction Management Supplemental Agreement No.1

provides material testing for the project. This separate contract with SCJ Alliance will cost an estimated \$12,317.
• From Public Works, Jake Youngren addressed the Woodin Avenue Bridge Project Website Communication launch. This website will allow the public to be informed about all Woodin Avenue Bridge updates. The public will also be able to leave comments under the portal contact tab. Visit: www.woodinavenuebridgeproject.org
The Woodin Avenue Bridge Project will be submitted for a WAC Municipal Award Project.
• The Library Second Floor is now available for rental or other uses for the space with City Council. The Lake Chelan School District No.129 moved out and did not exercise an extension for the space. The council will look into different options to better use the space, in order to so the restrooms and the elevator need to be refurbished.
• The Woodin Avenue Bridge Project will start after Labor Day and will be stopped in November. Due to a delay on a 16 inch water pipe, the renovations on Woodin and Columbia will hold until Spring. The whole project will be completed before Memorial Day 2019.

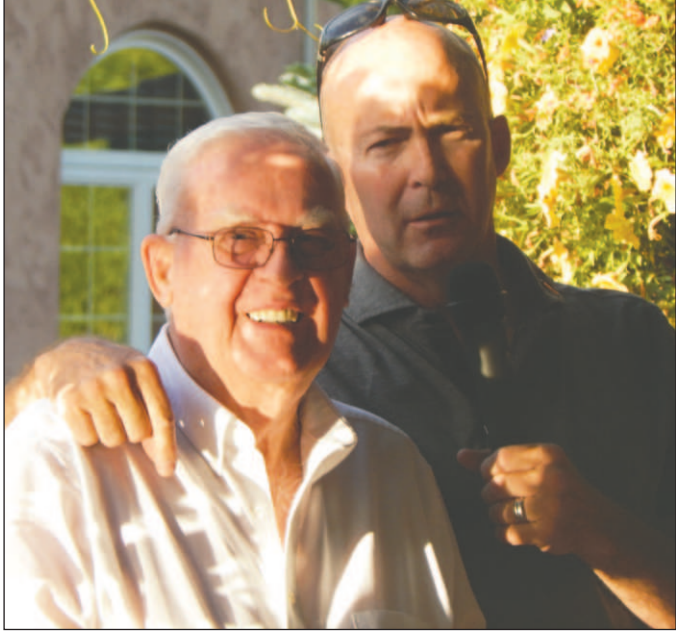

CHELAN – This month, the Garcia family is celebrating one year of operating their business, Chelan Vape, Smoke & Cigar.

After working for Nintendo for 25 years, Rob and Naheida Garcia were looking forward to retirement. Rob and Naheida sold their house in Lynnwood, Wash. with the help of their son, Raheel Qureshi who currently works in real estate. Soon after, they moved to Chelan to start a new life. After living here for a while, the Garcias thought of the idea of opening up their own family business.

"We came here and this store was a smoke shop before, but it was never open. I talked to the owner and the landlord and basically we bought the business," claimed Raheel.

After renovations and adding new inventory, the Chelan Vape, Smoke & Cigar was born.

The Chelan Vape is the only business of its kind in the area, "a lot of local people are really happy, now they don't have to go to Wenatchee," said Rob.

The most popular item sold at the store is the Juul, an electronic smoking device. In-store people can find over 30 flavors of e-juice to choose from. A variety of goods are also sold, however Chelan Vape focusses more on vape products, glass products and also cigars.

During the summer time, sales start picking up, "on average we see 25 to 30 customers a day" including local people and tourists. Once winter hits local people are mostly the ones purchasing goods from Chelan Vape, "we give them special discounts ... we know that a lot of people aren't working."

The Garcias want people who shop at their store to be happy. According to Raheel, "once a lady thought our price was a little bit high, she still bought it, she didn't complain and then she wrote a review ... I contacted her and gave

her a \$10 credit for next time she came in. We always try to work with people, we are not trying to screw people over." If Chelan Vape doesn't have the product people go in asking for, they take note of that and they will get the product.

"Our five year goal is to purchase this lot and construct a building where half of it is a smoke shop and the other half will be something else. It might be real estate or we might do something in food since we have a background in food. At the top will be a two bedroom apartment, that's a goal for us," said Raheel.

The publisher's rant diverged into a potpourri of subjects, from Stormy Daniels to Hillary Clinton's emails (can't miss that one). More of his claims:

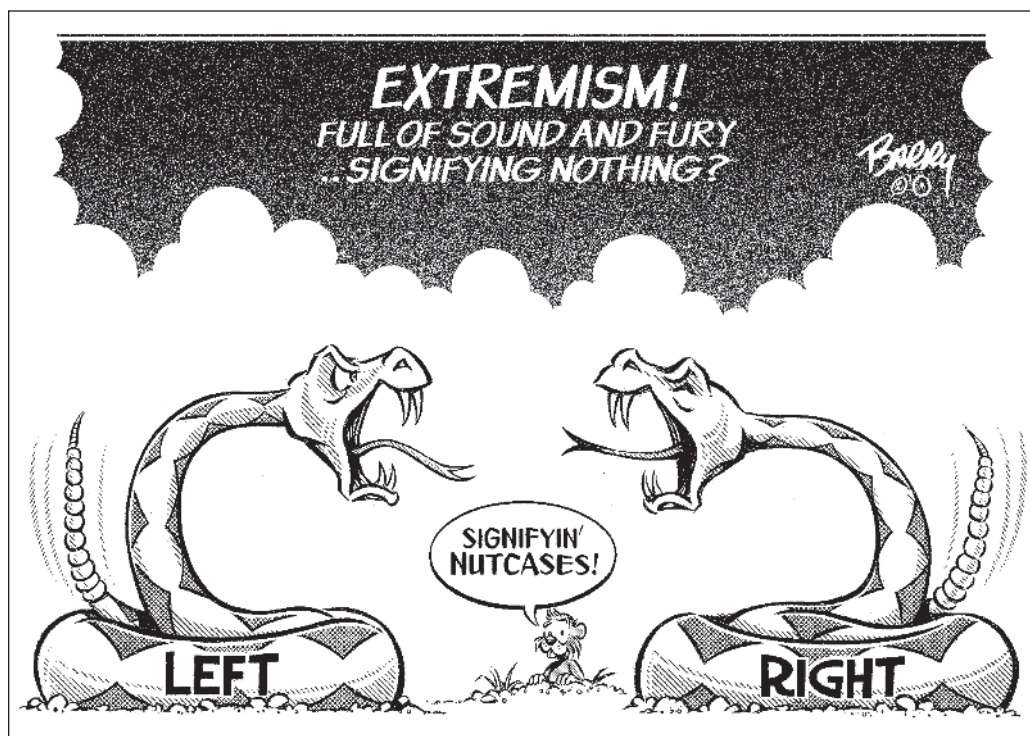
-- "The voters have chosen to elect [Trump]." Fact: Voters nationwide chose Hillary Clin-

Issaquah entrepreneur Jack Hughes-Hageman is vying for Washington's 8th Congressional District. At 26-years-old, he is the youngest candidate in the race. The Wenatchee Business Journal asked Hughes-Hageman a variety of questions and the following are the answers he gave:

WBJ: Why are you running for office?

Hughes-Hageman: As a fifth-generation resident of the state, I am a staunch supporter of Veteran's rights, Tourism, and Small Town America. Following in my grandfather's footsteps, I want to bring practical "No Nonsense" politics to a dysfunctional congress.

WBJ: Why is your youth an asset?

Hughes-Hageman: In today's technological and fast paced atmosphere politicians need to be aware of the unique and ever changing threats to American interests and democracy. My age gives me a unique perspective that is both malleable and well informed. I am focused on creating solutions not making problems, still young enough to remember that our government is of the people, by the people, and for the people of the United States of America.

I am an unabashed dreamer, and man is the American dream strong when I dream it. I was raised in a post 9/11 world dominated by internet commerce, the conflict in the Middle East, fast food, and social media.

WBJ: What do you tell people who say you don't

Theodore Roosevelt, William Howard Taft, and Dwight D. Eisenhower. These men reformed legislation, won wars, and changed the face of the globe. They did it with style, and a sincere love and respect for our great nation. These men are why I am a Republican, them and others like them gave me the audacity to dream of a better world.

WBJ: What are your opinions about abortion, gun rights, North Korea, Jerusalem as the place for the American Embassy, Steel/Aluminum tariffs?

Hughes-Hageman: My official opinion on abortion is that I have no opinion on abortion. As a man it is an issue that will never affect my body or my autonomy and thus I refrain from forming an opinion or passing judgement on others. My decisions as a law maker will be based on the decisions, input, and feedback of my female constituents. Those decisions should be made by the women of Washington's 8th district, and I will be relying on them for guidance in regards to women's health issues.

Today the rights to firearms versus their danger to the public is one of the number one issues in America. The problem has gotten severe enough that more children have died in schools this year than active military personnel in the battle field.

Is this a problem with regulation or mental illness? I think it is both. We need a complete overhaul to bring gun checks into the 21st century, eliminating backlogs

entirely and give the public real time accountability to gun regulation in the United States.

The old embassy in Tel Aviv was a building; the new one in Jerusalem is also just a building. Was the move advisable from a peace process point of view? Jack doesn't think so, but then again not many do.

In global economy unilateral moves tend to trend negative in the long run; people remember getting screwed out of the blue. In the short run you might get lucky and the tariffs increases American steel and aluminum production, but the long-term downturn in manufacturing from higher commodity prices means there will be no increase in demand at all for steel and aluminum. These tariffs will devastate American steel and aluminum in the long run and destroy short term manufacturing.

WBJ: What do you mean by calling yourself an "entrepreneur"?

Hughes-Hageman: Believe it or not I was a private business consultant for a number of years. I returned to Washington after college to advise new business in developing markets with the kind of cutting edge techniques they would need to be successful in a fast paced and competitive markets. Specializing in good old fashioned know-how and having a knack for success, I had several clients in the micro agriculture and retail sectors.

WBJ: Where do you stand on DACA?

Hughes-Hageman: DACA stands for Deferred Action against Childhood Arrivals, this policy was implemented in 2012 to acknowledge that many in our nation came here without documentation or legal status as children and grew up as an American and that they deserved legal recognition, the ability to work, and protection from deportation as long as they maintained their biannual paperwork. This program stopped short of giving these people a true path to citizenship, which is in my opinion a travesty.

WBJ: Are you in favor of building a wall?

Hughes-Hageman: I do not feel large scale walls and border fortifications have been effective for several hundred years. Even the best of the best giant walls in history have been spectacular failures; the Great Wall of China, the Trojan wall, the double Theosodian walls of Constantinople, Hadrian's wall, the walls of Jericho and even the fabled walls of Babylon are all famous for how they didn't work as intended.

WBJ: Are you able to represent rural Washingtonians as well as urban?

Hughes-Hageman: My ability to represent both urban and rural populations comes from hands on experience living in both.

WBJ: Should Trump be forgiven his corruption or impeached?

Hughes-Hageman: I think as American's we can all agree on the kind of severe punishment that high trea-

son comes with. Anyone, even the president or president elect, who commits treason against the government founded of the people, by the people, and for the people of the United States of America should be held accountable.

WBJ: Can you work well with others to pass bipartisan laws?

Hughes-Hageman: The real chances of passing a law without bipartisan support are virtually nil; anyone trying to pass legislation without bipartisan support has no real intentions of passing it into law. I pride myself on my ability to find compromise, and there is certainly no other candidate willing to cut a deal like I am. I am young, empathetic, and have a sincere love for America and all her people; this is why I am much more like to make friends across the aisle than any of my counterparts.

WBJ: Feel free to tell the readers about yourself:

Hughes-Hageman: I am an avid camper, hiker, gardener, and I really enjoy a nice bike ride. As for education I graduated from Sammamish Highschool and went to university at the University of Alaska Fairbanks. I am also a graduate of the Frank J. Ruck Leadership Institute in 2013 and received awards at the Carlson Leadership Academy in 2012.

Plain's Zach Miller wants to be Chelan County Commissioner

As part of our continuing interview series with candidates for county, state and federal office, NCW Media, parent company of the Leavenworth Echo, Cashmere Valley Record and Lake Chelan Mirror, sat down with Chelan County Commission candidate and Plain native Zach Miller and asked him a variety of questions. His answers are presented below:

NCW Media: Why do you want to run for Chelan County Commissioner?

Zach Miller: With gratitude for all that this community has given me, I want to give back through public service. When I look at my daughter and think about the kids in our community, I want to ensure that they are afforded the same opportunities for work and housing when they grow up. We live in a special place, and it will take a lot of hard work and dedication to maintain our way of life in an ever changing world.

NCW Media: Do you have any organizational, NGO or private sector experience?

Miller: Throughout my time at Hopesource (a Community Action Council), and now Tall Timber (as the Assistant Director), my two primary responsibilities have been people management and problem solving. When managing people, my focus is providing each employee with the training, resources and support they need to most effectively carry out their job. I also

strive to make every position sustainable, creating an environment where employees are retained and enjoy being part of a team. Both of these jobs also had constant moving targets, requiring that I am on-call all the time and respond quickly to the needs of clients or guests. The work of Chelan County is never finished. As a commissioner it would be my full time job, with that same 24 hour a day dedication, to solve problems alongside Commissioners England and Overbay, and the county staff.

NCW Media: What is Chelan County's most pressing issue?

Miller: Affordable housing is our number one problem. With so little private land, a growing number of second homes, and zoning that leaves little room for high density housing outside of the towns, we simply don't have enough homes for the families and workers in Chelan County. Property taxes are on the rise, and it is getting more expensive to live in the homes

we have. But there are real solutions, and I am hopeful that through a combination of rezoning for higher density housing, and more public and private partnerships, we can find collaborative ways to solve this issue with a regional focus instead of putting off as a problem for our cities and towns to solve. Every day I talk to people that have creative ideas, and I truly believe we can solve this problem together.

NCW Media: How will you help the two most vital cogs of the county 1) Tourism 2) Agriculture?

Miller: Tourism is thriving in our towns, but we still have so many untapped opportunities in ecotourism. For example, if you look at Plain, and how nordic skiing has drawn more tourists into a rural community, you realize that this land still has a lot of untapped potential. I will draw attention to these opportunities, while also focusing on improving the roads through strong maintenance programs, to help our citizens and visitors get to the tourist destinations. For Agriculture, first and foremost we have to call out what an important and unique industry this is. Water will be an ongoing issue, and we need to make sure that our orchardist get the resources they need to keep their crops healthy. I will also call on our young adults to realize the opportunities available, and consider joining these important industries.

NCW Media: How do you

feel about the cannabis industry being chased out of the county by the current commissioners and will you keep their policies?

Miller: While there are tensions between cannabis growers and the county, the simple truth is that growers haven't been chased out. If the commissioners didn't want any growing they would have placed a permanent moratorium on growing and shut it down. Commissioners have the constant challenge of balancing multiple sides of every issue, and I believe they are trying to honor the many voices they have heard. I will always be open to reviewing policies and trying to find common ground, because I don't want anyone to feel they are being chased out of a community.

NCW Media: As an ordained pastor, will you be able to keep your religious beliefs from crossing over into county business?

Miller: With any faith based organization, just as within politics, there are differing views on almost every topic. Conservative and liberal, traditional and progressive, left and right. I have done my best to stay neutral and honor all voices wherever I have worked, supporting people for who they are while looking for ways to help everyone work together in harmony. The most foundational part of my beliefs are that every person, regardless of any categorization is of equal value, dignity, and worth. I will always stand for

everyone, because a commissioner's job is to represent the people, not their own special interest. I want to serve, and I don't have any religious agenda going into local politics other than honoring the amazing people of Chelan County.

NCW Media: Do you feel city, county, state and federal government has too many regulations that inhibit growth?

Miller: The question of regulation is not about how many regulations, but having the right regulations. We need good codes and standards by which we can live together that don't infringe upon individual liberties and rights. Talking to business owners, you almost always hear about a frustrating regulation that doesn't make sense for a rural county. But there are also numerous good regulations that keep us safe and preserve our infrastructure. As a commissioner, I will fight for common sense, taking in all opinions and facts so that we can maximize our growth while adequately planning for our future with the right regulations.

NCW Media: How will you join Republicans and Democrats divergent points of view if elected, and why are you running as an independent?

Miller: The truth is that I'm for both parties. I want to see Republicans and Democrats operate as the best versions of themselves. Iron sharpens iron, and we need two parties with diverse opinions and ap-

proaches engaged in respectful dialogue. My working life has shown me the benefits of equally valuing everyone in the room, and I want to carry that into local politics. Within our county, I want to be a voice for diplomacy. We are all in this life together, and the divergent views we have can help us see more innovative solutions to the problems we face. I am running as an independent to stand for both parties equally. I care more about people than party lines, and will do everything I can to ensure that every voice is heard.

NCW Media: Tell the readers about yourself, family, hobbies, etc.

Miller: I grew up in Plain, and met my wife Cassie, as a freshman at Cascade High School. We have now been together for 18 years. Our daughter Melanie turned 4 this summer. The two most important things to Melanie in Chelan County are finding water to swim in and unrestricted public dancing. I love my family, and am so thankful for their support. My wife has spent more than half my life with me, and knows my heart is fully dedicated to the people around me, which is why she supports me running for office. I am thankful for the opportunity to show my daughter it is more rewarding to serve than receive. It is with deep gratitude and thankfulness that I am seeking public office, because the communities of Chelan County have given me and my family so much.

Duncan seeks to be Chelan County Commissioner

NCW Media's Managing Editor Gary Bégin sat down with businessman Lee Duncan recently at Tastebuds Coffee & Wine restaurant in Wenatchee to discuss his candidacy for a seat on the Chelan County Board of Commissioners. Here are his answers:

WBJ: Are you running as a Democrat, Republican or Independent?

Lee Duncan: Independent. I feel it is unnecessary to bring political partisanship into a position that needs experience and leadership. To try and use political ideology to elect local leaders is just further dividing our communities and leaves us with the wrong people in charge.

WBJ: What is your political philosophy as compared to the typical Republican commissioners Chelan County has had for many years?

Duncan: I feel there is a fundamental difference in philosophy between what we have seen for many years now and what I believe the County Commission should

be. I believe the duty of the Commission is to foster cooperation and compromise. For years the Chelan County Commission has unilaterally increased its authority to regulate and control its citizens rather than assisting them. They ignore the recommendations of their own Planning Commission, ignore the public comments of their citizens and simply pass whatever regulations they want. Their recent amendment to their Title 16 Enforcement and Violations code is a perfect example of this. The amendment allows the County to take legal action against anyone in violation of any county

code without having to go through the administrative process first. The code is set up to make sure everyone is in violation of something.

WBJ: Tourism and agriculture are the main economic driving force in the county. Do you have any projects or policies that will benefit that sector?

Duncan: It is important for us to preserve our agricultural roots and economy. Our agriculture is part of what drives our tourism. This area is a recreational destination for people from all over the globe. As Commissioner I would obviously stay engaged with both industries to ensure they have the support they need. I believe making the fundamental changes at the County will ensure both industries continue to thrive.

WBJ: Tell our readers how you will ensure that Chelan County government will become more transparent than it has been?

Duncan: Again, I go back to changing the mentality of the County. Transparency will be a natural part of that change. Once we have a fair

system of governance transparency will be inherent in that system. We must restore order to the internal structure, get the right people in the right positions. This will allow transparency back.

WBJ: Where did you get your inspiration to run for office in the first place?

Duncan: I worked for Chelan County Natural Resource Department for almost a decade. What inspired me in that job is the same thing that inspires me to run for office, bringing people together to improve our community. I facilitated and managed watershed management committees. I was able to bring together all the different stakeholders of an area from irrigation districts and individual farmers/property owners to environmental groups and various state and federal agencies. All with their own special interests and agendas.

WBJ: What do you feel is the most important issue facing Chelan County and what do you plan on doing to fix it?

Duncan: The most important issue right now for the

County is the lack of leadership. There does not seem to be any forethought in anything it does. Everything seems to be a knee jerk reaction. In today's world, not everything can be fixed through increased regulations and zoning. The first thing that needs to be done is getting the right people in certain positions. In the last dozen years there have been six or seven Community Development Directors and Interim Directors! This department is the heart of the County, but they don't seem to be able to find anyone to "lead" it for more than about 24 months. This is probably due to not wanting someone in that position who will question their decisions.

WBJ: What plans do you have to help all Chelan County businesses and residents?

Duncan: I would have a review of the current county code to determine what fees, permits and other red tape can be eliminated. The county code is set up to be used as a deterrent to local business rather than assisting them. A business or individual can spend thousands of dollars just to have a proposed project reviewed plus it takes weeks just to get a pre-application meeting! That is all before you even submit a

business application. There are multiple departments that must review business applications and they each have their own process and fees. This is the definition of wasteful government bureaucracy. Streamlining the County Code and process is a must.

I moved my family here over a dozen years ago to work for Chelan County. For almost a decade I worked in this community to help restore and manage the natural resources of the area which we all rely on in one way or another. I was successful in securing millions of dollars of grant funding for irrigation infrastructure improvements, water storage projects and water quality improvement projects. In an area with so many competing interests for water I was always able to find common ground and compromise among the many stakeholders. I understand the different opinions and interests of farmers, private landowners, special interest groups, businesses and industries when it comes to natural resource management. Everyone's interests must be taken into account.
