Lakeside Park Master Plan will be modified with \$1.1M

CHELAN - In two hours on June 21, Parks, Recreation and Community Services Director Karen Sargeant was able to present to the public and the Park Board members two different Master Plans for the Lakeside Park.

In order for the Lakeside Park project to be officially started, Sargeant has been working with a consulting group in order to find funding for the various park projects in mind.

The Lakeside Park project could potentially be funded by the Reservation Conservation Office Grant. Since February, Sargeant has been putting all the documents together and gathering the correct

information in order to file an application for the RCO Grant. The application was then filed on May 1, followed by a 12 minute presentation given to a Parks and Recreation committee from all over Washington State, in Olympia.

A technical review was given to the application by the committee and comments, along with suggestions were emailed to Sargeant after her presentation. On July 13, Sargeant will file a final application and will give one last presentation which will determine the acceptance of the grant.

The RCO grant will cover 60 percent of the project's cost, the other 40 percent will come from the Parks General Fund. Lakeside Park enhancements will cost \$1.1 million dollars

for Phase 1 only. If the RCO Grant is approved, it will cover \$660,000, leaving \$453,000 to be paid off by the Park's fund.

Some of the park's issues have to do with the restroom facility not being to capacity. It can't handle all the amount of people that go to the park. Last Sunday, June 17, on a regular day, 240 people used the bathroom at the park claimed Sargeant.

Pathways and walkways are not wide enough and they are beat up, the park needs to be more accessible for the public. Parking is also an issue that needs to be solved. Seventy five parking spots are available right now for the visitors to use. On a typical day the parking tends to quickly fill up, causing visitors to park in the different streets that sur-

round Lakeside Park.

The playground, picnic facilities, connectivity with the

city, the sports courts, lawn areas, irrigation system and trees also need some type of

maintenance or replacement.

Senior Living Initiative: Volunteers wanted

The Senior Living Initiative group met on June 20 at the Chelan PUD Conference room to discuss future summit plans and review reports from the Campus Task Force and the In Home Care Committee.

In 2015, the SLI group first got started in hopes of developing a way to help the senior population of Chelan and nearby cities.

This led to their first summit in 2016, in which they informed the community the needs of the senior population, their plans to helping out and different ways in which the community could get involved.

From this, two task force teams were created, they were the In Home Task Force and the Campus of Care Task

Force.

Looking at the feasibility to construct residency for seniors in the Chelan Valley is the primary goal of the Campus of Care Task Force. They look into possible residential options that are financially friendly to include a memory care facility and incorporate independent living for seniors.

Seeking for new ways to help out seniors living at home, helping them get their groceries done, transporting them to different places and in general building companionship with the senior residents, is the In Home Task Force priority. Right now two help services are in place. The Tender Loving Care ran by volunteers helps seniors get connected to other services they need. The Chelan Valley Community Nurse Program,

also in place, allows a nurse to visits local seniors when they need it. Both help services are free of charge to seniors.

Two years later, the SLI group is putting together their second summit which will be held on Wednesday, September 25 from 5 p.m. to 7 p.m. at the Chelan Senior Center. In this second summit, the SLI group wants to report back to the community where they are in the process of fulfilling those needs and where they are going next.

In the June 20 meeting, summit planning took place. Two important topics that will be talked about in the summit will be an opportunity to build a Memory Care Facility. As well as, more affordable housing opportunities for senior residents. These two topics are of huge concern to the Chelan seniors, who need

something to get done about such issues.

Affordable housing doesn't mean nursing homes anymore. "We are looking at the newest models ... we are looking at what seniors want," said SLI Facilitator Mary Murphy.

The Campus Task Force reported that they are working on testing out a business plan to develop a facility. However, they are looking into having enough funds for the construction and making sure the facility will be successful before getting started on the project.

A successful event was put together by the transportation service LinkPlus and the TLC volunteer program, reported the In Home Care committee. During this event, seniors were able to sign up for LinkPlus services without having to go down to their main of-

fice, instead they came to sign them up at the Senior Center. In hopes is another event in collaboration with LinkPlus to get more seniors signed up for the service. A partnership with the Food Bank was also implemented. The TLC volunteers go to the local food bank, pick up the groceries for the seniors and then deliver them to seniors' homes.

The Tender Loving Care program is looking for more volunteers who are willing to give senior residents a helping hand, so they can continue to live in their own home. If you are interested in volunteering please contact Kathy Miller at 509-687-3377.

On August 15 at 5 p.m. the Senior Living Initiative will meet again at the Chelan PUD Meeting Room located on 1034 E. Woodin Ave. Everyone is welcome to attend.

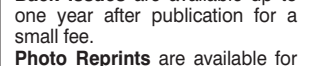

Public lands commissioner Hilary Franz to visit Chelan June 27 for Wildfire, Forest Health Town Hall meeting

CHELAN – Fire season has begun, and Public Lands Commissioner Hilary Franz is hosting Town Hall outreach events to make sure communities are prepared and engaged. The events are scheduled in Chelan (June 27 - 6-7:30 p.m.), and Spokane (June 28).

Commissioner Franz leads the Department of Natural Resources – the state's largest wildfire fighting force and the agency responsible for preventing and fighting wildfires on 13 million acres of

private, state and tribal-owned forestlands.

The public is invited to attend and speak with Commissioner Franz, be briefed on wildland fire preparations, learn how they can prepare for wildfire season, and learn about forest health issues and opportunities that will reduce wildfire risk in the future.

"Communities are essential to our success in fighting and reducing wildfires, and we want to engage them early and often in what we're doing," said Franz. "In the face of wildfire seasons that are getting more difficult, we need

to partner with each other and our neighbors if we are to overcome this great threat. I strongly urge the public to come out and learn about how we are preparing – and what they can do to help – as we go into another fire season together."

Attending with Franz will

be her new Wildfire Deputy and Washington State Forester George Geissler, who joined the Department of Natural Resources earlier this month. Geissler has day-to-day oversight of the agency's forest health and wildfire responsibilities, which includes the state's largest wildfire fighting force, with more than 800 permanent DNR employees available and another 550 seasonal firefighters hired for the summer season.

These events follow previous town halls held earlier in Cle Elum, Wenatchee and Winthrop.

the proposed Master Plan include: restroom building expansion, boat ramp improvement for non-motorized boat launching and swim area reconfiguration.

Landscape designer Jim Brennan came up with two alternatives for Lakeside Park based on the information Sargeant collected from the community. "We want to maintain the passive quality of the park ... we want to just enhance what is there already," explained Sargeant to that being the inspiration behind the two alternatives. Park safety needs to be taken care of and it's at the top of the list for Sargeant.

Plan alternative one addresses a few things. For one, it will have connecting pathways that take you to a central gathering area with benches, enlarged bathrooms, boat launch enhancement, the sports courts will also be connected

by a pathway and will allow bikers to connect directly to Hwy 97A. Small picnic shelters will also go into the park and the beach will be refurbished. The only major change then, will be the parking lot. Additional diagonal parking and an unloading/loading area will be added.

Once Phase 1 of Lakeside Park is completed the parking spaces will grow from 75 spots to around 100.

The bathrooms will go from three stalls to six in the women's side and the men's will grow to three stalls and two urinals instead of two stalls and one urinal, the sinks will go from one to two for each side. In addition, dressing rooms will be a part of this bathroom

enhancement.

The second alternative plan is not too different from the first one. The major difference between the two will be a larger central gathering area for the public to hang out and enjoy the view from the park. A large playground area will also be a major feature, down at the beach the seas wall will be removed and the sandy beach will be expanded. Everything will remain the same as the first plan, except for the walkways which will be smaller.

Sargeant told the audience that the only request from the City Council is to pick and chose a bathroom model that could be use through the different parks in Chelan, because they will soon be modified as well. Bathroom maintenance is also a major factor and Sargeant wants

to find the perfect model which won't be too hard to maintain throughout the years.

After presenting the two plans, the Parks Board had lots to say about the proposed plans.

Overall, majority of the Board were not content with parking lot only growing by 25 to 30 spots. Parks Board member Jane Lloyd stated "I am mainly concerned about parking ... and just to add 25 parking spots doesn't touch the parking problem."

However, "we have heard the public definitely say something [about parking] and this is our chance to upgrade ... we got what we got to work with" said Parks Board member Garth Donald.

Council member Servando Robledo was also present in the meeting. "I am just glad that something is being done ... I hear everybody's concerns and I agree to some degree that we are not really fixing the problems entirely,

but the goal is to enhance what we have. Otherwise we will have to start from the beginning and even then we will still not fix the problem," Robledo said.

The public also some opinions that could potentially help Sargeant with the final master plan. Once again, parking solutions were brought up, some of them included making a formal arrangement with the nearby school to use their parking lot during the summer.

Jani Palomino lives close to Lakeside Park and walks

her dog there every day. Palomino is able to see the summer, winter and all the crowds that come to the park, she wants to see some barbecue grills added to park for people to use. Adding a second paying kiosk is also something Palomino wants in the Lakeside Park because there is always one long line of people waiting to pay in the current kiosk.

The overall goal of the Lakeside Park project is to give people a better experience when they go and use the facilities. Sargeant made it

clear that "If [they] do not get the grant this project will continue, it will just take a lot longer to do. We will do one a year, a couple small ones here. That is the way it will work."

A second Public Meeting will be held Wednesday, June 27 from 6 p.m. to 8 p.m. at the City Hall, 135 E. Johnson Ave. Sargeant will go over the two Master Plans, people who missed out on the first meeting are encourage to go and learn more about the Lakeside Park project and share their thoughts and opinions about it.

Kirtman became a board member because his dad was diagnosed with Alzheimer's in 2017. Louis Kirtman, David's dad, became the second generation to be affected by the disease in the family. Ever since Kirtman found out his dad was being affected, he knew he wanted to get involved and find ways to impact the cause.

In particular Kirtman wanted to focus on the North Central Washington area because there are a lot of people living here who are retired and of older age. North Central Regional Library purchases two new mobile libraries

WENATCHEE - Two new library bookmobiles are now visiting communities throughout North Central Washington.

North Central Regional Library purchased the new mobile libraries this spring to replace the old one that broke down last year and was retired after many years of service.

The rural schools bookmobile is now stationed in Omak and is currently visiting schools in Republic, Nepelem, Orient, Keller, Incheilium, Wilson Creek, Beaver Valley, Orondo, Palisades and the Paschal-Sherman Indian School on the Colville Reservation.

The community bookmobile works out of Wenatchee and visits adult living facilities, community festivals and farmers markets, and will be expanding its route to include stops in rural communities.

The primary goal of having bookmobiles has always been to bring library services to people who cannot easily access them, said Luke Ellington, bookmobile manager for NCRL.

"But we also want to surprise residents and meet people in our communities who might not know what this library has to offer," he added.

With the exception of Republic, the school bookmobile visits locations that do not have a public library and, in some cases, don't have a school library. Classrooms are able to come into the bookmobile and check out

books. Teachers also get books to support their curriculum, and a selection of story books are delivered to Head Start programs and kindergarten classes.

During the summer, the bookmobile will continue to visit schools on its rotation that offer summer programs to students. It will also make regular stops at day camps, federal free lunch sites, community parks and recreation programs, farmers markets, and community events and parades.

The larger community bookmobile is now visiting retirement, assisted living and memory care facilities. It also participated in the Washington State Apple Blossom Festival youth and grand parade and the Classy Chassis Parade, and has set

up at the Wenatchee Valley Farmers Market.

It's route is still being developed, but it recently began stopping at the community of Plain near Lake Wenatchee. It will soon add a stop at the rural neighborhood of Ponderosa near Plain.

The bookmobile will also be a mainstay at community festival and events, such as the Cashmere Rhythm & Blues Festival and the NCW Fair in Waterville later this year.

"We hope to partner with other community organizations to add value and support to what other nonprofits are already doing in their communities," Ellington said.

Improving on the old design, the new bookmobiles are larger, more user friend-

ly, and feature colorful lights, sound and eye-catching exterior designs.

"We wanted to create a space that is more akin to a public library space," Ellington said. "These bookmobiles are more open and inviting, with windows and natural light. Families come in together and many sit right down on the floor and parents will read to their children — and there's space for others to move around them."

Many visitors to the new bookmobiles share stories of visiting bookmobiles in their youth, he said.

"These are good memories they have," he said. "They look back with nostalgia. We are creating those kinds of memories for our patrons now."

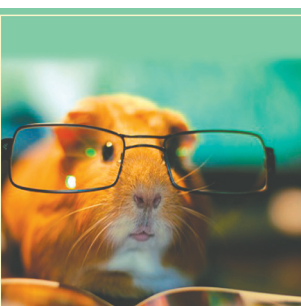
