# Supreme Court sides with Goodfellow Brothers



Part one of "School Safety" series

As parents, one of the most frightening days is the day your child leaves your side for the first time to brave a whole new world, a world filled with learning, sharing and trusting others. That same day, parents too learn to entrust another with the safety and well-being of the embodiment of their world, their child.

Schools across the nation take measures to ensure the safety of the student body from all forms of threats, whether it be a natural disaster or an out-of-place individual within the walls of a school. Drill after drill has been conducted to prepare the students for these scenarios. Manson and Chelan schools have been equipped with automatic or key fob door-locking systems, locked side entrances, video surveillance and more, in an effort to provide the utmost protection and safety for the students.

Safeguarding the student body

But, what do you do when the threat to a student body is a member of the student body? Manson School District Superintendent Matt Charlton and Chelan School District Superintendent Barry DePaoli explained what steps are being taken for prevention and preparedness of the students in an exclusive interview with Lake Chelan Mirror (LCM) staff. Manson School District

Manson Superintendent Charlton explained drills conducted in preparation for disasters or a crisis. Along with the monthly disaster drills, the district does a district-wide emergency drill at least once a year, he explained, "we coordinate that with our emergency

services partners, fire, EMS and the Sheriff's department, and we do a pretty extensive drill," he continued, "the staff doesn't know what's coming, they know something is happening, we do plan that, but they react to whatever the scenario is ... we try to test our system and see how would we react? We're not looking for 100

percent," he emphasized, "we're looking for where we can improve."

Last fall, the district conducted a weapon on campus scenario, Charlton stated, then explained the situation, "we fired some blanks in a classroom, and looked to see how people would respond to that and looked to see how kids would respond to that. Based on how we did with that, afterward, the staff started asking about how we can improve and what can we do better?" Details of the drills and preparedness methods are not all divulged, as the safety of the students remains the primary focus and details of the school's safety provisions are only effective when they can be used without expectation from the threat.

The school district also uses an incident command system, Charlton revealed,

# **Chelan Fire receives breakdown on protection rating** *Lack of staffing and apparatus age hit hard for the department*

CHELAN – In what was originally intended as a workshop for staff, Chelan Fire and Rescue (CFR) staff and commissioners received an explanatory presentation on the district's rating provided by Washington Surveying and Rating Bureau (WSRB), and any rippling effects the rating could create on insurance rates for our homeowners.

WSRB is a private, nonprofit insurance rating bureau, explained Vice President of Public Protection Robert Ferrell. "We get our license and regulation from the OIC," he continued, "that's the Office of the Insurance Commissioner, they regulate everything having to do with insurance in the state."

Effective April 1, the district's Protection Classification (PC) will be a class seven, which is an improvement from the previous class eight. The PC scale, which ranges from one (being the most protected/ prepared for fires) through 10 (being the least protected or prepared), is based on various factors inspected by WSRB and is calculated using a deficiency point system. The four categories evaluated in a district and city are fire safety control, water supply, fire department and emergency communications.

The over-all classification rating provided by WSRB will be utilized by insurance groups to determine appropriate rates, based on the risk-level of fire protection services within a district. The higher the fire-loss risk, the higher insurance premiums for homeowners.

Water supply, which is evaluate by the capacity, distribution and maintenance of water systems and fire hydrants, is 35 percent of the total points allowed. The district earned 804 of the 1,450 points possible in this area. The category focuses on "the water supplies in the community that provide fire hydrants," as explained in the PC Report provided. One of

# *Immediate moratorium in place*

CHELAN COUNTY –PUD Commissioners unanimously voted to cease all application acceptance and processing for electric service requests with the intent of mining cryptocurrency, Monday, March 19. "The moratorium is effective immediately to reduce operating and financial risks," explained Public Information Officer Kimberlee Craig in a press release.

Cryptocurrency, or Bitcoin, is a digital currency used in

web-based financial transactions. What's the big deal about that, right? Well, if you're a resident in Chelan County, the harvesting of the digital currency can have near-devastating consequences on your community, due to unauthorized and improperly

equipped harvesting operations, as well as pulling the utility district's attention away from planned work, explained General Manager Steve Wright. Chelan County offers one of the lowest en-

# Manson Fire emphasizes out-of-district protection services

Discusses possibility of acquiring pictometry services

MANSON – Ever wonder how residents out of district boundaries receive fire protection? That topic was one of several topics discussed during the scheduled monthly commissioner's meeting, Tuesday, March 13 at Station 51.

In the recent past, firefighters responded to a structure fire, out of district, that resulted in the dispatch of six apparatus and an ambulance, explained Fire Chief Arnold Baker. "We had less than \$2,000, at state chief's rate, for all the personnel and equipment that went up there," he clarified for the commissioners, "when you're inside the fire district, there are taxes, which means there is no bill," he continued explaining, "this was out of district." Chief Baker proceeded by explaining his intent for the topic, the request for a discussion amongst commissioners on what billing action should be taken in out-of-district response situations.

"You go to another fire district as mutual aide to that agency because they help you, so everything is kosher," Chief Baker stated, "this one was not (in any district). This one was no-mans-land ... so, we've got time up there, as well as personnel and I think we need to address it." The difference, if it were a wildland fire, is that a wildland fire could be a risk to the town, he emphasized to the commissioners, "a structure fire is a contain to itself point, not really a risk to you (the town)." In response to Baker's discussion proposal, Commissioner John Spencer stated, "you have tax payers and non-tax payers," he began, "there is an avenue for people out of the district to pay for coverage if they want it. It's their call,"

he emphasized on the coverage option, then continued explaining that, if desired, an out-of-district resident could pay a yearly fee for services and coverage. "A lot of people don't even know it exists," he expressed, "(but) we'd charge them a rate and they write a check every year, and are covered every year, if they want to do that."

"Here's the thing," stressed Baker, "state mobilization is exclusively only for fire districts, (so) those people out in no-mans-land are their own entity, they don't have state mobilization." The optional yearly protection and services fee ensures a response in an emergency situation, even though the residence may lie outside of the district.

Looking ahead into the spring of 2019, Chief Baker discussed the possibility of acquiring imaging services through Eagle View, who would composite a topical, five-angled photograph, referred to as pictometry. "Ev-

the biggest hits in this area was in the distribution of hydrants section, more specifically in regard to residential districts. "Residential structures in the community will be evaluated to determine if a fire hydrant is available within 600 feet," as explained in the report. However, due to the location of a majority of residences within the district, and the absence of fire hydrants, especially within 600 feet, is not uncommon. What the district was lacking in distribution, they more than made up for in inspections and

conditions, earning 97 percent of total points possible. This particular section commonly receives lower scores with other districts, with confusion as to responsibility, explained Ferrell.

Moving into scoring on the fire department, which evaluates the total service area for the fire department, both incorporated and unincorporated areas, and worth 40 percent of the over-all score. This section took into consideration 17 different areas, including pumpers, ladder trucks/ladder service, distribution of companies, pumper capacity, maintenance and condition of apparatus, number of officers, department staffing,

engine and ladder company unit staffing, stream devices, equipment for pumpers and ladder trucks, hose, condition of hose, training, response to alarms, fire operations, special protection and miscellaneous factors and conditions. With an abundance of categories, there are only with notable scoring, as the remaining scores were all above average. Scoring on the number of company officers indicated a shortage of on-duty officers. There must be one on duty at all times, stated the report, or two active volunteers which may be equivalent to one full on-duty officer, up to half the number of officers required. Department staffing, the next of

teer is pulling "defined shifts at fire stations". The third section, "Fire Operations" hit the department hard with only 18 percent of points earned. This section accumulates scoring from "Department Staffing," "Engine and Ladder Unit Staming" and "Training." With a majority of the point deficiencies coming from staffing issues. Next was review of the emergency communications segment, which evaluates the emergency communication system used to dispatch the fire department, and worth nine percent of the overall score. The department earned 68 percent of possible points in this category, with very average scoring across the board, and no notable surprises. Lastly, fire safety control was reviewed. This portion evaluates the fire code enforcement and fire safety education activities in the community and is worth 16 percent of the overall score. The department earned only 28 percent of the possible points

in this department, with low scoring in the public fire education subcategory.

What does all of this mean in a nutshell? Individual residence insurance premiums are calculated based on the district's rating, as well as the proximity of the property to the nearest station and distance from fire extinguisher to residence, and other factors. However, as the district's PC improves

or degrades, the community's premiums will be reflective of that change. The residences within city limits are currently at a class six, with the district and residences within five-miles of Station 71 at a class seven, and Stations 72 and 74 "are not adequately staffed with firefighters," as explained in the report cover, resulting in a PC 9. "Dwelling properties within five road miles on only Station 72 or 74 will have their rating changed to PC 9A," continued the explanation. While the fire district has improved its score from a class eight to a class seven, the elimination of six of the paid firefighters would drastically affect the scoring, explained Ferrell, which would in turn effect homeowner insurance rates as well. He could not give specifics on how much rates, premiums or scores would be affected, but with already low scoring in the staffing department, a hit like losing half of the paid staff present would be reflected.

ergy rates nationwide, which draws in consumers looking to expand on the Bitcoin harvesting.

# Volunteer staffing supersedes target

CHELAN - Fire and Rescue 7 chiefs and the two remaining commissioners convened for their regular monthly commissioner's meeting. Wednesday. March 21 at Station 71.

Public commentary at the district's monthly meeting of the commissioners is few and far between. On this night, however, Chelan resident Dr. Gordon Tagge took a moment to voice a concern that has been weighing heavily on his mind, he said. "I know that there's a plan in the hike of the levy," he began, "I'm not for it or against it. I just wanted to say that ... it doesn't seem like a lot, but then you add them all up and it's a lot of money. I'm not yet collecting Social Security," he continued into his intended message, "but I'm getting to the point where I'm thinking about what it's going to be." He proceeded by explaining that, after reviewing what he will be receiving in Social Security income, if that were his sole income after retirement nearly a quarter of that income would be going toward local and state taxes. "I just want to know what people who rely solely on their Social Security for income are supposed to do," he expressed, "before they pay their mortgage and before they buy food, 25 per-

ognition will take place June 22 in Bremerton.

Deputy Chief Mark Donnell began updating commissioners on operations, fire prevention and public education events. The tactical response plans are right on target, he explained, and the safety fair conducted through the school district was successful. Looking ahead, the department is preparing for their open house, which will take place April 21 in conjunction with Earth Day. The B-shift crew is responsible for the event, he explained, "but they've already got a really good start on it, and it sounds like it's going to be a much bigger program than last year." The next public event for the department, after the open house, will be the annual firefighter's pancake breakfast, scheduled for June 2.

Breaking into the volunteer and recruit aspect of the agen-

There are an additional eight volunteers currently that will need gear, he explained, but after talking with a representative on the SAFER grant, he was informed that the gear funding is a set amount and may be distributed however is needed throughout the four years, as long as it does not go over the allotted amount provided within the grant agreement. "It's a great first-recruit class," he expressed in conclusion, "and some really good people too. They're motivated and it's off to a really great start."

Following his recruitment and volunteer update, Commissioner Russ Jones asked Asher how many hours are required for a volunteer to become combat qualified. A qualification which is not only required for a volunteer to enter a burning building to "combat fire", but also for a firefighter to count as part of the two in two out rule. "It's close to 150 hours, just for the initial basic firefighter (training)," Donnell responded to Jones, "then there's Firefighter 1, which is the certification that we'd like them to get to, but there's a process ... if they want to continue to move forward ... so, for Firefighter 1. Firefighter 2 and hazmat, you need about 13 weeks (total), of 40-hour weeks." In response to Donnell's information, Jones supplied, "I can guarantee the general public isn't aware of the investment and commitment that it takes (to become combat

"where during a crisis or emergency, there's a clear chain of command, but there's also a clear way of dealing with things," he stated, adding, "we have staff that are already on teams

... there's a first aid team, there's a recovery team, there's a reunification with parent team, so depending on what the incident is, we'll activate those teams.'

"On the proactive side (of preparing for an active shooting scenario)," Charlton expressed, "we do put a lot of our energy and resources to that. One of the best ways to prevent a school shooting is to have really good relationships with your students," he voiced, emphasizing, "with all students ... making them feel supported, that they are connected and that they have people they can talk to if they need help, but also with other students who might report or might share 'I'm worried about my friend,' or 'my friend said this," he expressed.

The district is using an ACE system in the social/ emotional aspect of prevention. "We've done a lot of work, on trying to help children learn those skills that they need to deal with conflict and if I'm hurting how do I get help," Charlton stated, "and how to be advocate for themselves. So, trying to teach our staff how to teach students that, but also staff how to work with kids that have come from where they've had serious incidents in their life. We're doing a lot of work in that realm, and I think as a school, systems statewide, but also right here in Manson, I think we're doing a lot better there. It's never perfect," he conveyed, "every community has kids or people in their community that you could go 'gosh, those people need more help,' you know."

Looking at the possibility of such a tragedy happening here, in Chelan Valley, Charlton stated "we're proactive, we try to never let it happen. We prepare for if it does happen, what are we going to do in the moment. But, we also have to think about afterwards, recovery," he explained, then continued clarifying steps taken, such as the combat training received by many staff, allowing the on-site staff to handle a traumatic injury

until emergency services arrive, if needed.

"If you see something, say something," Charlton challenged the students. The district strives for each student having at least one adult at the school they feel comfortable talking to. "We really do encourage students to take care of one another and if you see something, share it with an adult you trust. We try to have every student in the school have at least one adult they trust in the school, it could be a cook, it could be a coach, it could be a teacher ... at least one adult that the student knows they really care about them and there's a relationship there. We really work to make that happen."

## Lake Chelan **School District**

Looking into the Lake Chelan School District (LCSD), Superintendent DePaoli began with a summary of the physical security measures being taken to ensure safety of the student body.

"The way I look at school safety is there's really two areas of safety," he began, "there's the building safety, then the second piece is the psychology safety, which is the social/emotional wellbeing, which is the prevention part for our students."

Starting with physical safety, in regard to the building, the LCSD board has been really proactive, expressed DePaoli. "We've upgraded our security (in recent years)," he explained, "all of our schools have automated door locking systems on all the exterior doors ... our entrances, at both the elementary and junior/senior high schools have the buzz-in system, which is the current state of the art standard." The system requires an office staff to buzz in any visitor, he explained, as the doors to access the students are locked. "We also have a school resource officer that is employed on campus, and he advises both students and staff regarding personal safety, drills, prevention, all that stuff. We have some really strong community partnerships, one with local law enforcements and one with our fire district, so that we're prepared for all emergency situations. And, like all schools, we have a crisis response plan, and that would address a full range

recently hired a district counselor, explained De-Paoli, "we're just training our district counselor in a course, so that she can train all of our front-line staff, bus drivers, secretaries and eventually teaching staff, on any signs of kind of a mental wellness piece where kids aren't feeling well, or may be feeling uneasy, so we're doing that training as part of a preventative process in the psychological area.'

After the most recent school shooting, the district had created a safety summit, DePaoli explained, "I got all our nurses, counselors, teachers, liasens, and some administrators on that group and we just took a look at what we need to look at going forward." The active shooter drill was the primary focus of the summit safety, and the group evaluated and discussed how well the district is prepared in the event of a school shooting ... "we'll reconvene in early April and really put together a strategic plan to really focus on this active shooter issue.' School shooters, DePaoli explained, "(are) not just the school's issue, it's about the community. How do we keep our community safe? So, everyone has a responsibility for keeping our kids safe at school," he emphasized, "the parents do, they have a responsibility to report anything they see as awkward or unfamiliar with their own students, or friends of their students, and our teachers have that responsibility. I really believe our students do as well, so we're going to educate our student on the idea of 'if you see something, you need to say something." Manson Council explains 'special meeting' agendas

MANSON - During the Manson's Community council meeting on Tuesday, March 6, a question was raised by council member Jorge Valencia as to why the special meetings were being scheduled between the regular council meetings. Council member Kathy Miller and Chairman Kim Unstanik explained the reasoning behind the special meeting and that they may not always occur.

The council has set the first Tuesday of each month for their special meeting times. Yet Miller said, "that it may not always be the first Tuesday, it just so happen to be today because of the bylaws that they had to go over in order to get a copy out."

Unstanik added another reason for special meeting was in case that something came into the council from Chelan County and needed discussion prior to their normal meeting then it could be discussed.

Voting could not take place, yet they could discuss the matter prior to their regular meetings held every third Tuesday of the month.

Prior to continuing work on the bylaws, Unstanik stated she wanted to go over a few items. The first, being a clarification of her conversation with Hank Luis concerning vacation rentals. A questionnaire concerning vacation rentals was sent out, yet their seemed to be some confusion. The confusion was on whether to answer the questionnaire or to grade how the questions were put together. The whole point on the questionnaire was to gain insight on how other communities handled vacation rentals prior to making rules and regulations for these rentals in the Manson area

Other items on the agenda were Shotlz dock/buoy, Bitcoin mining, Facebook and utilizing it as another form of getting information out to community. Email procedures and whether or not to assign individual position email addresses, fundraising and Manson Parks letter.

There was a small discussion on Bitcoin mining in the valley. It was stated by Ustanik that Jeremy Jaech, secretary-

Ustanik stated that in the original bylaws, that there were provisions to be able to do fundraising. The issue was that the council does not have a non-profit license. It was agreed to have Ustanik check into having Kathy Blum, vice-chair, apply for the license on behalf of the council.

The council moved into working on updating the remaining bylaws and adding in the additional items to gain clarity for those members that would be added to the council in the future.

# Many activists ready to surf the Big Blue Wave



# LCCHC board introduces interim CEO, discusses building project at board meeting

CHELAN - Lake Chelan Hospital Board Chair Mary Signorelli introduced interim CEO Steven Patonai at March's regular board meeting Tuesday, March 20. Patonai, who has more than 25 years of senior healthcare executive experience, will serve as CEO while the Board searches for a permanent replacement for CEO Kevin Abel, who leaves for a new CEO position in Montana April 1.

During March's meeting , board members heard presentations regarding bond rates, the USDA loan process and project draft budget. State representatives from the USDA visited last week, said Abel, and the application will soon move to the federal level. Bond rates continue to look encouraging, and the board voted to update dates in the bond resolution they voted on last year, as well as approve the current space program for the replacement hospital, which moves the business office and other administrative offices to the Johnson Avenue building to make room for clinic services within the new hospital building.

In response to a request by local physicians, represented by Chief Medical Officer Ty Witt, the hospital board also considered Initiative 1000, the "Washington State Death with Dignity Act."

"After careful, thoughtful conversations with our medical staff and the board of commissioners, we have decided that whether a physician will participate in the 'Washington State Death with Dignity Act' should be the provider's own choice. As hospital administrators,

we do not wish to interfere in the relationship between the provider and the patient," said Abel.

Lake Chelan Community Hospital & Clinics (LCCHC) will, however, ensure all the laws and safeguards of the "Washington State Death with Dignity Act" are followed if a provider and patient choose to participate.

Lake Chelan Community Hospital & Clinics does not mandate that any provider participate in the "Washington State Death with Dignity Act," nor encourage any provider to do so. Only those providers and patients who are willing and desire to participate should do so.

"All providers at LCCHC are expected to respond to any patient's query about life-ending medication with openness and compassion.

We believe our providers have an obligation to openly discuss the patient's concerns, unmet needs, feelings, and desires about the dying process. Providers should seek to learn the meaning behind the patient's questions and help the patient understand the range of available options, including but not limited to comfort care, hospice care, and pain control. Ultimately, LCCHC's goal is to help patients make informed decisions about end-of-life care," said Abel.


While LCCHC allows its providers to participate, it will prohibit patients from taking any life-ending medication at the hospital or clinic. It also will not stock the medication, and patients must fill their prescription elsewhere.



Forty champion spellers from Chelan, Manson, Tonasket, Mansfield, Ephrata, Omak, Wenatchee, East Wenatchee, Moses Lake, Royal City, Cashmere, and Leavenworth competed for the opportunity to represent our region at the national Scripps Spelling Bee in Washington, D.C., later this spring. Our local spellers included two sixthgrade spellers from the Chelan Middle School, Cray Silva and Charlie Morgan, and two sixthgrade spellers from Manson Middle School, Ella England and Ben Cullison.

Our local champions spoke with confidence and composure, despite the varied complexity of words in each round. The first two rounds were brutal. Among the 15 spellers eliminated in the first round, Cray misspelled hyphen by only one letter. Ben and Charlie were among the next 15 eliminated in the second round, with quesadilla being one of the multitude of misspelled food-related words that round. By the end of the third round, only the top three, including Ella England of Manson, remained. In round five, Kalea Macon (Foothills Middle School)

In the sixth round, Ella struggled with the silent H in apartheid, writing the word out on her arm as she had in each round. Ella asked for the definition and to have the word used in a sentence, applying all of her academic skill and etymological tools available, but to no avail. Ella earned second place as Kara Willson, of Tonasket Middle School, correctly spelled her round-six-word, peccadillo, and the championship word, recidivist, to earn first place. As an eighth-grade




student, this was Kara's fourth and final opportunity to compete in the NCW Regional Spelling Bee, and her victory and trip to the national competition were


