## Tender Loving Care Program reaches out for seniors in the valley

CHELAN VALLEY - The Tender Loving Care (TLC) program for Seniors is looking to expand their client and volunteer list. The friend-based volunteer system brings a wide of assortment of assistance to seniors in the valley, from companionships to assistance with household maintenance, shopping and transportation.

Currently, the program has twice the number of volunteers than clients, "focusing outward always helps the inner part of you," expressed TLC Coordinator Claudia Swenson, "if you give, you get so much back by nourishing yourself." Swenson has a Doctor Pharmacy Degree and has managed people for four years. She currently volunteers with Chelan Valley Hope and was hired on

## Manson Parks talks levy tax, policies

MANSON - Parks and Recreation staff and commissioners gathered, Thursday, Jan. 11 at the Parks and Recreation office for their regular monthly board meeting. With a full quorum and agenda, the board covered a multitude of topics in preparation for the 2018 season.

The Manson Bay Revitalization Project was briefly discussed, as one portion of the project's boundaries are uncertain at the moment. The dog park, also referred to as the 'old swimming hole', boundary lines are unclear as to where the property line ends, and the closest private property begins. This, said Parks Director Robin Pittman, is one of the few things that will need to be reviewed further prior to moving into the next stage of the Revitalization Project. The dog park was

also perceived to be owned by the Lake Chelan Reclamation District, however, after further research, the park is owned by Chelan County PUD and has been leased out to the Reclamation District with Manson Parks maintaining the property. Why worry about ownership specifics though? With the funding options available for the upcoming waterfront project, certain criteria need to be met for various funding sources. In a prior meeting with Pacific Engineering, who the Parks board have hired to aid in the development of the project, it was explained that one of the funding options for the project, Recreation and Conservation Office (RCO) grants, cannot be used on mitigated land, which the dog park is such a land.

A levy tax increase beginning in 2019 was another sub-

## Chelan City Council swears in new members, accepts resignation

Finance department helps right some wrongs

CHELAN - Oaths of office by incoming councilmembers Ty Witt and Tim Hollingsworth, as well as incumbents Erin McCardle and Servando Robledo initiated the regular City Council meeting, Tuesday, Jan. 9 in council chambers at City Hall. Each council representative stood, hand raised,

repeating oaths as instructed by City Clerk Peri Gallucci. After each receiving their certification solidifying their placement on the council, regular agenda items began.

Motion considerations consumed a bulk of the night's agenda. Considerations included the assignment/election of a Mayor Pro Tempore, which was designated to Councilwoman Wendy Isenhart by unanimous decision. Isenhart currently serves in this capacity, and will continue to for another two years.

Association – Servando Robledo with Kelly Allen as an alternate.

North Central Washington Economic Development District (NCWEDD) – Previously liaised by Wendy Isenhardt, will now be attended by Servando Robledo.

Planning Commission – Previously liaised by Kelly Allen, will now be attended by Tim Hollingsworth.

Concluding the night was reports from each department. Two of those reports, however, stood out amongst the rest. The Public Works Department added City Engineer Jake Youngren to the staff during the summer of 2017, with the intent of filling in the shoes of Public Works Director Dwayne Van Epps when he eventually retired. Van Epps' attempt to pass during the department reports was interrupted by Mayor Cooney, as said to Van Epps in fun, "well I'm going to read a letter then," he began. The letter, as Cooney began reading, was the official resignation from Van Epps. Within the letter, Van Epps stated, "I will take the occasion to express my gratitude to the City of Chelan for providing me the opportunity to work in a career that has proven to be

tremendously rewarding. I am humbled by the trust extended to me by Mayors, administrators, councils throughout the years, and to you (Mayor Cooney) in particular. I am at the same time proud to have been part of so many projects within Chelan, the hometown that I love." While his letter of resignation has already been submitted and accepted, Van Epps will be working until May 31, and will officially be off staff starting mid-July as he will be using up the remainder of his vacation, explained Cooney.

tor Cheryl Grant. Reading off an interoffice correspondence, she began explaining a mystery payment received through the city's online point and pay system. After contacting the source of the payment, finance department staff discovered that the payment was made by a local gentleman. "He stated that when he was younger, he threw a rock at one of the globes on the bridge and broke it," Grant explained, "this was 20 years ago. He was not caught, but felt compelled to make right on his wrong." The payment was for

## Manson Fire covers year-end reports

**EMS Director reports on past and future**

MANSON – Chelan County Fire District (CCFD) 5 commissioners and staff gathered for a regular commissioners meeting, Tuesday, Jan. 9 at the Manson Fire Station.

The night's agenda included some fairly basic items, however, others were more excit-

ing. In a move to increase training on Emergency Reporting, CCFD 5 Administrative Assistant Patty McClellan will be traveling to Phoenix, Arizona in February. The current program in place for all the department's incident reporting and training is only a small piece of what the program offers explained Fire Chief Arnold Baker, "there is a ton of more modules in there that I'm not even getting into," he added, "one of the things we're going to get into is oc-

cupancy and fire inspections. There's modules in there ... I know there's a ton more stuff that we need to do. It's all your queues of when your stuff is due, it's all your equipment checks, all that stuff in inside the system if you want to delve into it that deep." The three-day training seminar would allow McClellan to achieve the knowledge to build-up the system with the newer features, that will ultimately assist in the productivity of the department. "I think it's a good

investment," said Baker.

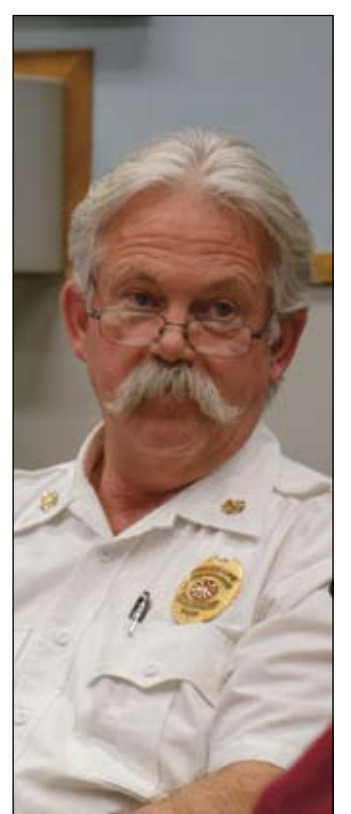
Moving into the Chief's report, Baker began explaining some information from year-end. Emergency Medical Services (EMS) calls, in particular, have been steadily increasing every year, he explained. "Almost 80 percent of what we do is medical," stated the Chief. Although the majority of calls responded to are medical, these calls do not affect the department's overall goals, "we're right on target" said Baker, "it's very on target with national data." Baker, who's serving as a Rivercom board member this year, moved into statistics on the dispatch center's efficiency. "They (dispatchers) need to dispatch a fire call in 64 seconds and they need to dispatch an EMS call in 90 seconds ... those are the standard," he explained to commissioners, "they're doing 54 percent on the fire side and 81 percent on EMS," he said, expressing that "they have improved by miles." While improvement on dispatch times has been noticeable, the times still need to see some improvement, he explained.

Continuing into the night's agenda, was a report given by Chelan EMS Director Ray

Eickmeyer.

"(We) saw more patients than we ever have before," he began, "1,407 total for the year." The total calls for 2017 has surpassed previous years, with 43 more

calls than in 2016 and around 100 more calls than in 2015. Moving through his report, Eickmeyer began to provide statistics for total transports in 2017. With a total of 221 transports "holding steady," he explained, "that means our hospital is taking care of the patients in the hospital than out, which is only about three percent than the total ER volume." Transitioning into staffing, he explained the likelihood of the addition of two new full-time paramedics to CEMS. "I had about 10 applications for one full-time position, I've never seen that before," joked Eickmeyer, "especially right now, where all EMS agencies are struggling and on the West Side there's a lot of retiring career medics." The 10 applicants went through multiple interviews, skills testing, and knowledge testing and ulti-

mately two positions were offered to highest placing candidates. The visioning for medical services is fo-

cused on the community explained Eickmeyer.

"We'll be starting our community paramedic work, we've already started our training," he began, "no one in the whole

four counties (Chelan, Douglas, Okanogan and Grant) is doing this." Medical services within the counties will be receiving a waiver from the state, somewhere around the tune of \$5, and "some of that money will be funneled to community paramedic work," he stated, "which will be a key piece to increase the wellness of our community. We want our patients to be less acute, we want them to be less sick, we want healthier communities. I want to work myself out of a job," he joked, adding, "I don't want to respond to anymore medical problems, so that is our goal."

Manson Fire Commissioners meet every second Tuesday of the month, beginning at 4:30 p.m. at the Fire Station. The next meeting will be held Tuesday, Feb. 13.

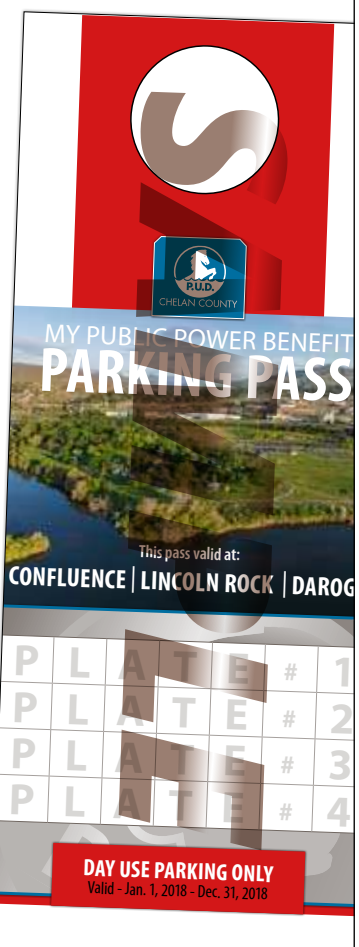

# Chelan Fire and Rescue Staff moves up

**Welcomes Assistant Chief of Volunteer Services

CHELAN – Fire and Rescue 7 staff and commissioners initiated the regular commissioner's meeting with an oath of office, and promotion and badge pinning ceremonies.

After being elected as commissioner number one to Chelan Fire and Rescue (CFR), Phil Moller swore his oath to office and sat amongst fellow commissioners, Russ Jones and Tom Peters, Wednesday, Jan. 10 at CFR Station 71. Following Moller's oath to office, was a promotional and pinning ceremony for Assistant Chief Mark Donnell, who will now be serving as Deputy Chief of Operations. Brandon Asher was then announced as the new assistant chief of volunteer services, and was pinned by his father, and Entiat Fire Chief Mike Asher. Concluding the pinning ceremony was Ed Blietz, who has been assigned as Chaplain.

As Fire Chief Tim Lemon began his monthly reporting, he briefly began describing his previous meeting with the City Administrator on the requested false alarm ordinance, but "he is not in favor of it," said Lemon, "as he put it to me, typically the false alarm ordinances are kind of a negative pressure issue that goes against businesses with protection systems that are required by the city to be put in, and now they're putting another layer of pressure on them to keep them maintained. So, you have that negative connotation of the whole deal, so then you have the different business owners out there putting pressure on the councilmembers and it becomes real uncomfortable scenario for them. What he

has told me is that it will go to council for a decision as to whether or not they will pursue it. I just told him we just need a yes or no as to whether we're going to pursue this or not." The station is still working with one of the local resorts that has been known to have frequent false alarms, however, and are working to get all smoke detectors up to code and working effectively.

The Chief continued into his report, talking to the commissioners about the firefighter's success with the three recent fires, Union Valley, GrandView on the Lake and the last at Lakeside. The response time and time it took for the crew to contain the fires were really impressive, said Lemon.

Moving into training, Deputy Chief Donnell began explaining the work the crew has put into the Tactical Response Plan, and how it has already benefited in a fire situation. The Tactical Response Plan has been assigned one per shift per member, and "we've actually been doing presentations on those," he explained, "we're actually pretty fortunate because one of the ones that we had already (completed) was GrandView," he continued, "if you talked to Lt. Woods, who happened to be on the shift at the GrandView, he'll tell you that the beauty of having the hazmat presentation in mind was that he knew that he had to go over the bridge off of Woodin and he knew exactly where the connection was to the GrandView and where the area (fire) was at there, and was able to direct everybody. It worked like clockwork." Moving forward, the crew will still be assigning one per shift, then beginning in March will begin doubling that, he said. The various buildings have different response plans, and buildings such as the GrandView and Campbell's Resort, explained Donnell, are considered to have

multiple occupancies (each building is an occupancy) and are also considered high-risk occupancies due to the amount of people in each area. The response plans allow the emergency crews to already be familiarized with a business'

layout and individualized or abnormal needs.

Chelan Fire and Rescue meets every second Wednesday at 4 p.m. at Station 71. The next commissioner's meeting will take place, Wednesday, Feb. 14.

impersonal care. Volunteers and clients are compatibly matched, and a care plan for the senior is created based on their individual needs, not taken from a predesigned list. "We're working with people on a long-term, friend-based volunteer system," Swenson explained on the program, "it's a long-term friendship." Every volunteer is training for approximately two hours by Swenson, one-on-one, "we have policies around everything from confidentiality, adult protection services, infection control ... so they're very well versed in setting boundaries and working with people." The current group of volunteers through TLC are abundantly diverse, enabling them to fit the many different needs of clients.

The program is for seniors who need that companionship that has been lost, or even just a friendly ear to listen or help with shopping. The program's benefits don't stop there though, it also offers volunteer help not solely for the benefit of the seniors, but for the caregivers, spouse or family members who are caring for their aging loved one as well. "That's where we're really shining is in respite," expressed



Swenson, "for that 24-seven caregiver, if we don't take care of them they're not going to be there to take care of that mom or dad or spouse." The volunteers can come in and care for the senior for two to four hours while the regular caregiver or family member takes a break. Swenson explained that nearly 75 percent of seniors wish to be able to stay in their own homes, but financially it is extremely difficult to be able to afford. The TLC program helps this group to be able to stay in the environments they are most comfortable in.

TLC has a list of resources "as broad as the needs of people," said Swenson. "We try to figure out what people need, and they really need to not be alone," she said, "we are not limited in the things we can do." Some of the resources available to clients include in-home hairstyling and cuts, in-home exercise visits and even dog visits. Who couldn't benefit from some time with man's best friend?

So, what's the process for including yourself or your loved one in the TLC program

for seniors? With permission from the senior, Coordinator Swenson can come and do an in-home assessment. It can't be a 'cold call', so it needs to be the senior themselves or if someone is calling on behalf of the senior, they have permission from the senior for the Coordinator to come in and talk with them about how the program may benefit them, "it's just a conversation," expressed Swenson. "I'll go into the home for about an hour and a half and basically assess everything about them, their personality, their needs, who their family or support system is, their healthcare provider," she explained, "what medications are they taking, what are their risk for falls? This is all taken upfront so we really have a good picture of who they are and what their needs are." Once the assessment is completed, the TLC crew can compile a care plan specialized for the needs of the individual and assign a matched volunteer. The visits of the volunteer can range from a couple days a week to once a month, it just really depends on the needs of that client, said Swenson.

ject during the commissioner's meeting that was discussed in depth. The previous levy tax increase took place in the year 2015, at a rate of 23 cents per \$1,000. The funds from the levy tax are used to help maintain the parks' functionality, maintenance and aesthetics, along with any other issues that may come up along the way. The last couple of years have remained at the same rate of 23 cents per \$1,000, explained Commissioner Rob Campbell. This rate will remain for the next levy election as well, for a three-year period, which should appear on the April ballots.

With spring time right around the corner, youth sports sponsorship policies

were discussed. With the valley's abundant winery supply, the commissioners and staff were faced with a decision as to how to allow local sponsorship without the promotion of alcohol. The policy discussed will ban sponsorship by illicit drugs, alcohol and firearms, and will be selective on the terminology, logos and pictures displayed on youth sport jerseys. Agricultural businesses that may transfer into an alcohol industry, such as vineyards into wineries, may opt to emphasize on the winery aspect of the business, promoting the agriculture versus the alcohol. In new business, policies were added and eliminated for

Wapato Lake Campground. A new policy for beginning the 2018 season will limit the number of people, tents and cars at each camp site. With the previously policy, it was found that the sites were becoming overly crowded with people and vehicles, and causing a disruption in what should be a peaceful camping experience. "Some of these changes will probably affect revenue," explained Campbell, "but will increase quality." A visitation policy was also removed from the policies. Previously, visitors were not allowed at the campground during Labor Day weekend, however, beginning this season, that policy will no longer be in place.

**Gun rights activists call for a halt to five firearm bills**

Olympia - About 100 gun rights supporters rallied on the steps of the Capitol building in Olympia on Friday, Jan. 12.

Most held signs and many carried pistols, rifles or knives.

"This is the safest day to be at the capitol," Senator Phil Fortunato, R-Enumclaw said.

A long list of speakers, mostly Republican, voiced opposition to legislation they say would limit or eliminate their rights to bear arms. They called on lawmakers from both sides of the aisle to halt gun regulation bills.

The Gun Rights Coalition national chair member Rick Halle opened the rally with the Pledge of Allegiance.

Robert Satiacum, member of the Puyallup tribe, then lead the group in prayer. He emphasized that the right to bear arms unites everyone regardless of party lines, race, or ethnicity.

The gun regulation bills being considered this session are numerous, but here's a rundown of the five most contested.

SB 5444 and companion bill in the House 1387 would require a state license to own, sell, buy or manufacture an assault weapon with a large capacity magazine.

SB 5463 and companion bill in the House 1122 would require a firearms seller to sell or give the buyer a locked storage box and mandates that a person who leaves a firearm unlocked or accessible to someone not intended to use the weapon is guilty of community endangerment.

SB 5992 would ban any trigger modification devices that increase a weapon's rate of fire like bump stocks.

SB 6049 and companion bill in the House 2422 would ban high capacity magazines of 10 rounds or more.

SB 6146 and companion bill in the House 2666 would allow local governments -- cities and counties -- to determine their own gun regulation laws.

Representative Morgan Irwin, R-Enumclaw, directly addressed the bill potentially banning high capacity magazines.

"Can anyone tell me what this is?" he said as he held up a magazine. "It's 40 rounds of freedom. Do you know why I need it? It

doesn't matter because it's mine. I can have it because this is America."

Groups like Giffords Law Center for Gun Violence support some of this legislation. Laura Cutilletta, legal director of the law center says that bump stocks were designed to skirt regulations on firearms. Banning them, she said, would only make current regulations more accurate, not infringe on second amendment rights.

Representative Matt Shea, R-Spokane said that these laws would restrict freedoms of law abiding gun owners and they won't reduce crime.

"A new law isn't going to stop bad people," he said. "A ban on a plastic accessory is not going to stop bad people. Registration is not going to stop bad people. Armed good people are going to stop bad people."

Democratic Representative Brian Blake, D-Raymond, said the bills are misleading. He said himself and other lawmakers are willing to work with gun right activist groups to achieve a compromise.

"We are willing to work with anyone to reduce suicide and violence of any type," he said. "But we are not going to do that on the backs of responsible gun owners."

The legislature is expected to hold hearings on all five bills on Monday Jan. 15 at 10 a.m. in the Senate Law and Justice committee.

## Beebe Springs closed until maintenance resumes in spring

CHELAN - The Washington Department of Fish and Wildlife (WDFW) will close the Beebe Springs Unit of the Chelan Wildlife Area on Jan. 11 until maintenance can resume this spring.

WDFW Lands Operation Manager Rich Finger said that a vault toilet on the property, just east of Chelan off Highway 97 on the Columbia River, is routinely locked during the winter months when conditions limit maintenance ability. However, while the gate to the area has remained open, some highway travelers have been using the grounds as a rest stop.

That has created issues with sanitation, trash, and general public health and safety issue, Finger said.

"Typically wildlife areas like this can remain open in the winter without maintenance and not cause problems," he said. "But because Highway 97 is a major travel corridor through Chelan County, this property is being abused. I'm sorry we have to make this closure, but we can't allow this situation to continue."

WDFW is looking for a long-term, fiscally-sustainable solution for Beebe Springs, but until then the department will implement a seasonal closure from Dec. 1 through March 15.

## Manson FFA Ag Mechanics team competes at Cashmere

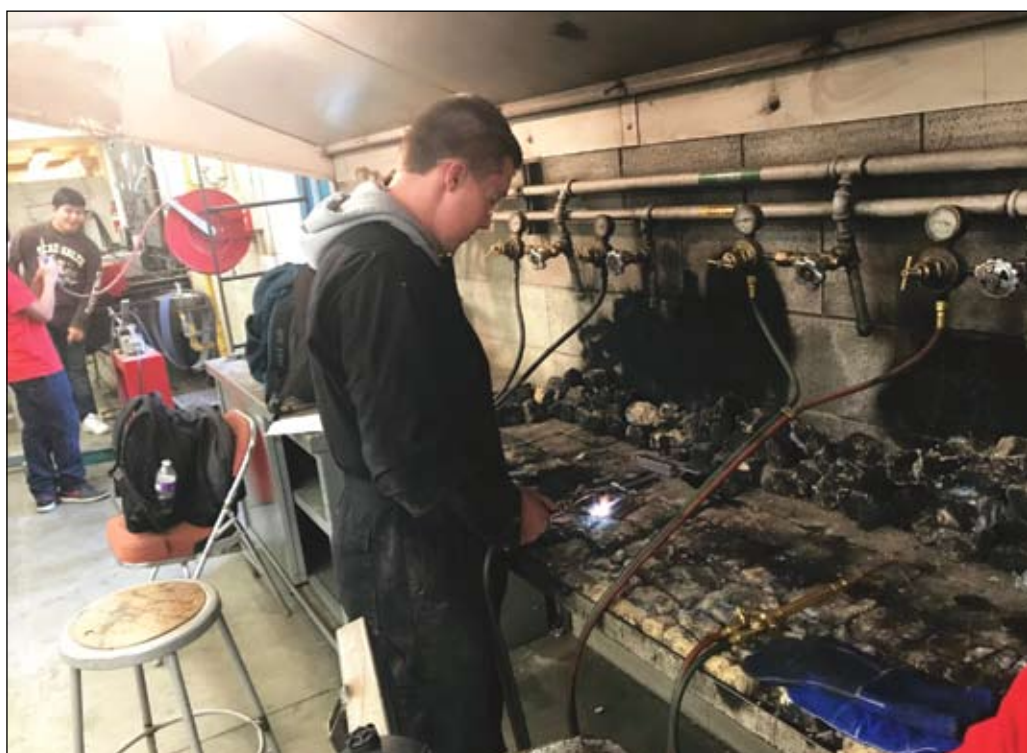
