

## Hospital Project Manager speaks at Rotary meeting

CHELAN - Lake Chelan Community Hospital (LCCH) Project Manager Barry Leahy was the guest speaker at the Lake Chelan Rotary Club's meeting Tuesday, Dec. 19, held at Tsillan Cellars in Chelan. Leahy boasts 36 years of experience overseeing major construction sites, including the Chelan Lake House. He has been involved in the vitality needs of LCCH for the past 13 years in one aspect or another.

Leahy stood in front of the Chelan Rotary member-filled dining area and began his introduction, stating a unique commonality shared with those in attendance. "I'm an old rotarian actually," he began, "Bellevue Breakfast Rotary Club, I was a member of that for almost 10 years," he went on to mention that along with his decade of rotary service, he's also acquired 12 years through the Seattle Downtown and Bellevue Kiwanis Clubs, "so, I am uniquely familiar with everything that rotary does."

Hired by Larry Peterson about 13 years ago, Leahy has been following the hospital's need for remodel and, now

rebuild, from the beginning. "If the first bond issue for the remodel was going to pass, I was going to construct it," he explained, then described his qualifications to the attendees, "for 36 years I have traveled everywhere overseeing construction projects. Some people hire me to buy the land, other people hire me to develop a property and they can construct it themselves, and other people hire me to do the whole thing," he stated. In the case of the hospital build, he will be overseeing the design and development of the care facility. "Starting a project of this size takes some time because there's a process," he explained in regard to the time-

## City Council's night filled with recognitions, presentations, anticipations

CHELAN - A night of presentations, acknowledgements and assignments was had at the city council meeting Tuesday night, Dec. 19 at City Hall. Prior to addressing the night's agenda, Mayor Mike Cooney and councilmembers took a moment, acknowledging current councilman Guy Harper for his long-standing service to the council.

Commencing the presentations for the night was Guy Evans, with a proposal for council on a potential development of 284 apartment units at Apple Blossom Center. "We have a signed purchase and sale agreement (PSA) and the time is ticking away," he began "my asking

of the council ... is that we come together and put a connection agreement together, if there was interest in that on behalf of the council, that would effectively be a mix of upfront fees and basically an analysis of this project to get a little more fine-tuned focus than the rate sheet currently offers. Right now, it's a ... one-size fits all." The proposed multi-family development through Weidner Apartments will boast over 200 units on a 10-acre parcel currently for sale at the Apple Blossom Center. Evans figured out current pay wages needed to be able to afford rentals in the Chelan area at this time, one example being an \$18 an hour job is needed to afford a one-bedroom in the area. "There is the four-two-five Chelan economy," explained

Evans, "and the five-oh-nine Chelan economy ... these are for the five-oh-nine Chelan economy." The rates, however, would be based on market-rate, not a fixed rental rent. Market rate essentially states that the rent amount would 'float' or fluctuate with the availability, as occupancy increases so would the rental amounts. "More than likely, this project's going to find itself in that same challenged \$1,200 zone," expressed Councilman Ray Dobbs as the discussion of the market-rate pricing continued, "I would say that affordability is driven by availability," responded Evans.

After the presentation provided by Evans, Cooney announced a first-ever town hall meeting to

### Entiat gathers public feedback on Waterfront Master Plan

ENTIAI - The Entiat City Council held an open house on Wednesday, Dec. 21 to gather public input on what they would like to see as part of their waterfront master plan. "The idea is to have this whole strip the new downtown area for the city of Entiat," civil engineer from Pacific Engineering Aaron Anderson said. "They have never had one here before since it got washed out when the dam was put in and the water level raised. So, the idea was to have mixed use, residential or businesses come in there to support the marina ... some of this is quite a ways out, because Pipkin Construction has the rights to mine all the material - gravel - out of there so that end could be 10-15 years out. This is going to be developed as the money comes in and as the need for the land arises. In my opinion once you get some hotels in there and the marina, businesses and people will want to invest in there and it'll take off."

### Chelan exemplifies generosity with Food Bank receiving piles of donations

CHELAN - People are often in a generous mood around the holidays because it's a time for giving back. This was made evident for the Lake Chelan Food Bank which has been the beneficiary of some sizeable donations over the past couple weeks. "It started with the Toshiba Group who initiated their own food drive in December and donated over 200 pounds of food," Lake Chelan Food Bank representative Kyle Sparks said. In addition, the Home Team Harvest, which is a statewide program where customers can purchase a \$10 'hunger bag' of food at their local Safeway that then gets donated to the local food bank, brought in over 600 bags of food. "There was a competition between the Lake Chelan Rotary and the Realtors Association (Coldwell Banker Lake Chelan Properties) on how much they could raise," Sparks stated. "81 total bags of food were sold at Safeway and 44 bags at the Red Apple Market. We were presented with \$2,305 from Skaar and then the rest will be used as store credit at each respective location."

He is a great connection and bridge to the Hispanic community, but that he represents all 4,000 citizens in Chelan regardless of race. I think the community gets a great new councilman in Servando," Cooney concluded.

## Manson Parks Department welcomes new commissioners, applauds outgoing

### Reviews fees, payroll and levy

MANSON - Oaths were sworn for the Parks and Recreation department during the special board meeting Tuesday, Dec. 19 at the Parks office. Taylor Quigley and Ross Young are the two newly elected Manson Park and Recreation's commissioners effectively the start of the new year.

The parks board also covered

the budget for 2018. Included in the budget was an increase in marina and camping site fee increases. Currently, the cost for a non-powered slip through the parks is \$13, which will slightly increase to \$15, and the powered slip cost will remain the same rate of \$20. Wapato Lake Campground camp site fees have increased as well, with the new rates of \$25 for a tent site, \$30 for a 30 AMP camper site and \$35 for a 50 AMP camper site, "there's some pretty big budget items in that place that need work and need paid for,"

explained Board Chairman Rob Campbell regarding the slight increases visitors will see in the upcoming months. Parks staff will also be seeing a bump in pay with the new budget. In an effort to keep ahead of the increasing minimum wage, employees' wages will increase a small percentage, with the exception of one staff member, who has been promoted to a foreman position which provides a pay increase from the promotion as well.



CHELAN COUNTY - Newly elected Chelan County Commissioner Kevin Overbay might have just retired after 25 years as a Washington State Patrolman, but he is refusing to ease into his new position. The 4th generation North Central Washington resident was elected to the District 1 post that was vacated by Ron Walter in November.

Overbay traveled up to Chelan from his hometown in Malaga to introduce himself and indulge the Lake Chelan Rotary Club on some of the issues he is working on at their lunch meeting on Tuesday, Jan. 21.

"I have been on the job for 28 days, (and) I will tell you that I have been drinking out of a fire hose for the last 28 days, it is self inflicted," Overbay said in his speech. "You can be as busy as you want to be in this position, but I made a promise that I would be a full-time commissioner. I don't have another job that I have to worry about. I have this job to serve you folks. As I have the opportunity to grow in this position I can see things where we might lack something. I believe in having the most efficient form of government possible. The economic development, the transportation needs, all of these things are interrelated. There is not just one thing that faces this community, it is multi-tudes of things that are interwoven."

### Land use gets addressed at comp plan workshop

CHELAN - The residents of the Lake Chelan Valley took another step in forming the Lake Chelan Comprehensive Plan at a land use workshop on Wednesday, Feb. 15. The finished comp plan is set to be completed by the end of June.

"We hired an engineering company to do preliminary engineering work on each site and give us the earthwork, substation, distribution and transmission costs for each location," Consultant Gary Rice said. "Each site is a one acre lot, which will allow us to put in another transformer on site in the future."

### City holds two meetings to get input on Woodin Ave one-way bridge

CHELAN - It took awhile for Mayor Mike Cooney to come around on the one-way idea for the Old Bridge on Woodin Ave.

"I was totally against it at first, and then I remember when Mayor Bob Goedde was there and we talked about either the one way, two way or adding another deck, and I just kept looking at the third option as a council member, but the light went on when I was standing with traffic consultants watching people struggle." Cooney opened with at the meeting with residents on Thursday, March 2.

Built in 1927, the old bridge was constructed to withstand the size of cars in that era i.e. the Model T. Now almost a century old the Woodin Avenue Bridge, although solid, needs repairs.

"Within the next couple years it has to be restored," Cooney admitted. "We know there is a fair amount of concrete swallowing underneath, one of the sections is leaning toward the river and the electrical system needs upgrading, so the restoration needs to be addressed whether we do one way, two way or whatever way."

### Vote-no committee needs to lay out problems with new hospital

CHELAN - Although the Lake Chelan Community Hospital and Clinic (LCHC) has garnered a considerable support in favor of a new hospital levy, there are some in the Chelan Valley that are not convinced a new hospital is the best option.

On Wednesday, March 8, a "Vote-No" committee met at Campbell's Resort to outline some of the reasons they are against the levy.

One being, the \$14 million estimate it would take to do maintenance on the hospital.

"We don't agree with the number of \$14 million for improvements in the hospital," Chelan PUD Commissioner Ann Congdon said. "There are a couple people a part of our group that are structural engineers and builders and have been their whole life, and they have really scrubbed the numbers. They feel it could be done for much less and they are putting the figures together as we speak."

### Chelan covers \$280,000 for No-See-Um

CHELAN - It's official.

As of March 17, construction on the No-See-Um Roundabout is a green-light.

"The Department of Transportation (DOT) accepted the bid today," Mayor Mike Cooney confirmed Friday afternoon. "We made up the shortfall, so the project should basically start (in) four to five weeks or sooner from now."

The \$9 million project has been on the drawing board for almost a decade now, and already has a little more than \$3 million in the ground, but after the discrepancy was announced in early February, there were questions as to which project the money would go. However, after Cooney met with the Chelan Douglas Transportation Council (CDTC) and announced the Chelan City Council had stepped forward - as a last result - to cover the difference, the decision was pretty much made.

### Bear Mountain Water District holds public hearing on potential ULID

CHELAN - Growth is as much a guarantee as the problems that come with it, and the Bear Mountain Water District is finding that out after proposing a Utility Local Improvement District (ULID) along the South Shore.

What is a ULID?  
"It only refers to an area that is being assessed," Bear Mountain Water District Attorney Mark Peterson explained. "That is part of it when a municipal corporation wants to do a project that is going to benefit certain parcels. The first part of the process is the formation, and then the second is the assessment role where you mail out a notice to property owners that will be in the ULID."

Some of the issues property owners had had though is with the notice. As some of said they got their notice late or had a return address that was nearly unreadable.

"We are aware that mailing has its shortcomings, but that is just the statute that we followed," Peterson said in defense of mailing out the notices. "People complain that they didn't get the notice, but it is not as easy to get ahold of people any more. You could get a reverse directory, but people don't have landlines, so mailing is the most efficient way to get ahold of folks."

### Vote Yes and Vote No layout both arguments for Chelan Valley residents at forum

CHELAN - After months of going tit-for-tat, the 'Citizens for a New Hospital' and the 'Vote No' Committee met last Thursday, March 30 to present their side of the argument of the proposed \$44.5 million hospital at Apple Blossom Center.

The forum came at an opportune time as the vote is set to take place on April 25. If approved, the public would facilitate \$20 million of the total bill through an increase in property taxes of residents in the hospital district. The Lake Chelan Community Hospital and Clinic (LCHC) is covering the remaining \$24.5 million.

Representing the New Hospital group were Ty Witt, MD, Megan Guffey, MD, Keri Bergeson, MD and Guy Evans. Mike Sherer was the lone spokesman for the 'vote no' side.

The event was run as a traditional debate, with both sides beginning with an opening, then transitioning into rebuttals before finishing with a question and answer - where each side could respond to the question - from the attendees.

Evans and Bergeson set the stage by giving a brief summary of the intent and reason for voting in favor of a new hospital.

"All of the signs point for the need for a new hospital," Evans began in his opening Thursday night. "To be clear, if you were to vote yes, you are voting to maintain current services. It is going to be about \$10 per month of increased support for a \$300,000 home and you would be adopting a vision that is pragmatically optimistic. This is the most wise option to take in light of the needs."

"All of that is important, we genuinely want you to vote yes with confidence," Bergeson said. "As a physician, I don't want us to lose the real heart of this, and this is about healthcare for families, neighbors and loved ones. I'm tired of having to make excuses and apologize to patients why they didn't have the experience they deserve, and

it is always related to the limitation of the facility."

### Frontage ULID dead after Bob Jankelson pulls support for project

CHELAN - Well, the people won this battle.

The Bear Mountain Frontage Utility Local Improvement District (ULID) was officially shut down last week after former Bear Mountain board member and Tsilan Cellars Owner Bob Jankelson withdrew his support for the ULID, effectively giving the lakefront property owners the 40 percent land area needed to reject the ULID.

Jankelson originally was in favor of the ULID but withdrew his support on Friday after sending an email to Bear Mountain homeowners.

"After protestations of potential stakeholders, it is obvious the political sentiments and climate are averse to undertaking such an ambitious project at this time," Jankelson wrote in the email.

The proposal would have stuck lakefront property owners with a \$16,500 bill to help finance the construction of a \$2.5 million project to extend the municipal waterline to homes in Hawks Meadow/Hawks Ridge and some parcels near the Bear Mountain Golf Course while installing fire flow for lakefront owners.

When the proposal was announced, lakefront property owners, who already have water, were furious and demanded the ULID to be voted down. However, the way the annexation was drawn, they wouldn't be able to stop the process without the help of Jankelson or other ag owners.

With Jankelson's change of heart, the frontage LID is effectively dead.

### Representatives from Okanogan, Douglas and Chelan County meet to discuss tourism partnership with TOTA

The group gathered at Rio Vista Winery along the Columbia River to discuss how they can cooperate and work together to promote tourism throughout the interior Cascades of British Columbia and Washington along Route 97.

Overall, TOTA has been successful in garnering tourists from all over the world and in 2010 alone they generated over \$1.7 billion to the regional economy. So they came to the meeting basically pitching cities along Route 97 to buy in to their website.

"We use Facebook the most, but also a Route 97 wire that serves as a newsletter," Industry and Community Development representative Simone Carlyse-Smith said. "So we have a database of people that we talk to ev-

### Lake Chelan community votes for new hospital

CHELAN - Patience and perseverance.

Those are the qualities the Lake Chelan Community Hospital and Clinics (LCHC) have held since their first bond failed in 2006. Over a decade and two previous bond failures later, the LCHC finally has a new hospital.

Although the announcement was made shortly after 8 p.m. on Tuesday, April 25 the official results were posted on Friday, April 28 at the Chelan County Election with the proposition receiving 64.87 percent of the total 4,239 votes cast. The measure needed a 60 percent supermajority to pass.

One building in particular that was full of ecstatic people after the news broke was the Lake Chelan Chamber of Commerce office, which was filled with the LCHC board members, administrators, staff and supporters from the community.

Do you see how many people are in this room," LCHC Board Chair Mary Signorelli said amongst the cheers in the building, "it took that plus all of the community to get on board and to make this a reality. It is great to see and as a group we have been working on this for 10 years. Finally, we have the super majority."

### PUD hesitant to underground all power lines

CHELAN - The Chelan County Public Utility District (PUD) might be listening to Chelan residents in their plea to underground power lines, but PUD Commissioner Ann Congdon wouldn't bet on all of the lines in Chelan going underground.

"The answer is no," Congdon responded after being asked if the PUD was under-grounding all lines in Chelan. "There have been several requests to underground distribution lines as part of the substation discussion. But there are significant costs to under-grounding power lines."

At the last PUD meeting on May 1, Congdon said staff presented numbers for underground and over ground lines, but that was just the start of the conversation of considering how, when and where to underground distribution lines and who is going to pay for the increased cost.

As far as the North Shore Substation, Congdon said specific sites have still not been identified.

"But two areas, very close to the 'blue line' or load center, have been highlighted," Congdon said. "Staff is in the process of talking to owners to see if they are willing to sell, so we should be able to identify two sites by the next meeting on May 15."

Although developments are being planned throughout the Chelan Valley and the current load is hovering around 80 percent capacity, Congdon said staff is confident they can adequately service all new and existing homes until the new substation is up and running.

# Senior Living Initiative committee meets

## Updates on Tender Loving Care program, site selections

CHELAN – Committee members for the Senior Living Initiative (SLI) and Tender Loving Care (TLC) programs gathered Wednesday, Dec. 20 in the Chelan PUD meeting room.

Mary Murphy commenced the meeting with an expression of gratitude for fellow board member, Kathy Miller, and the hard work she has put in on the history of the initiative. “Thank you for being here and making this work,” said Murphy, “it’s really making a difference in people’s lives, it’s just incredible.

Moving into a follow-up on the TLC volunteer and in-home care program, Miller began by explaining how much progress and success has been made in the program. She explained the recent activities of Coordinator Claudia Swenson, who had prepared and given a presentation for the Lake Chelan Health and Wellness Foundation, in request of \$1,400 for the program. The \$1,400 “would pay for two seniors,” Miller explained, “we estimated for us to see

a senior in-home would cost approximately \$700 for gas, interviewing and other initial stuff.” The TLC program has yet to hear back from the Health and Wellness Foundation on their grant request, but are hopeful to hear soon. As of currently, the program has “18 volunteers that have been orientated and 10 clients, that at least 10 of them (the volunteers) are seeing,” said Miller.

After the TLC program update was completed, Murphy began discussing what goals are for the clients and how they factor in with the United Health Care (UHC) grant, which was the program’s major funder for the first year. The program requires two goals for each client, however most of the clients have only identified one primary goal so far. Some goals may be transportation, household chores or medications, “the whole purpose of the TLC program is to empower seniors to be able to do these things, not to do it for them,” expressed Murphy, “right now, because the program is so new, companionship is the first obvious thing for both the client and volunteer. What we’re going to do if further training of the volunteers to help them identify ... the goals.” In the next year, the TLC program will be working on the strategic planning and

fundraising goals for the program. The funds have already been raised through August 1, 2018, so future fundraising is needed to maintain the program from that point forward. The total amount for a total year’s budget is \$20,000 to provide assistance to approximately 30 seniors.

Concluding the meeting was an update on campus site selections from Amanda Ballou. The selections are beginning to be boiled down even further, and there are now several very solid options that are capable of moving forward on, once a final decision has been made on the site. The boiled down sites offer may opposite features, some offer a better proximity to attractions and local features, while others offer more living, program and parking space, as well as a less busy outdoor surrounding. With the site selections decreasing, other aspects of the potential care campus sites will start to be considered, factoring in all possible benefits and downsides to each until only one solid selection remains.

The Senior Living Initiative meets every other month on the third Wednesday of the month. The next meeting will take place Wednesday, Feb. 21 at 5 p.m. in the Chelan PUD building’s meeting room.

frame of the build, “it has to be designed, and in this particular case, the Department of Health (DOH) has a lot of oversight, the USDA wants oversight, and our silent partner, which is the City of Chelan, which we’ve already met with and will permit this project for us to go forward.” Leahy addressed some talk of the build beginning before the winter of 2018, “frankly, I don’t believe in my heart of hearts that’s a prudent decision,” he expressed. The plan, as of now, is to break ground around March of 2019 he explained, bringing an anticipated completion sometime in September or October of 2020.

Hospital staff and board members traveled to Seattle, Wednesday, Nov. 15 to meet with Collins Woerman, architect on the build, and Bouten Construction, the general contractor on the build, in an introductory meeting. Bouten Construction is based out of Spokane, and was selected as the general contractor through interview selection process conducted by a consultant out of Bellevue. Washington State laws allow a selection process in lieu of bidding out the job, and Leahy preferred this option over the option to bid out. When bidding out jobs, he explained, any contractor in the United States could bid on the project, which is not always beneficial to the community he said, “because what does a contractor from Oklahoma know about the conditions of Lake Chelan when it comes to weather? Zero. That’s the answer, zero.” He emphasized

that during the process some “fairly sizeable people” had been interviewed, after all was said and done, the available scoring revealed Bouten Construction as the best fit, “they are going to do a wonderful job for the citizens of Chelan,” he added confidently. “Bouten is a small, family-run business ... but they work in and around eastern Washington, they’re very familiar with the weather conditions here, they’re very familiar with the subcontractor community here that’s going to supply manpower and materials for this site.” A member of the audience asked Leahy how many health care facilities Bouten Construction has completed, which in turn got a response in the ballpark of 10 or 12, “that’s (health care facilities) their primary focus,” explained Leahy, “They understand the environment of working in health care.”

The selected architect, Collins Woerman, is a firm that Leahy said he has worked with for the past 35 years, “I have done a tremendous amount of health care work with them,” he explained, “they’re very good, they’re very competent.” December 13 through 15, the entire development team, including architects, contractors, and management, collaborated in Chelan and met with the hospital staff, “and when I say staff,” Leahy joked, “I mean the entire staff at the hospital.” The goal for meeting with the staff was to get a realistic idea of the sizing needed to accommodate every aspect of the facility. “In the health care field, what drives the facility is technology,” he explained, “the doctors, the nurses and the staff need the

most up-to-date technology. Unfortunately, sometimes that technology needs space.”

“There’s no way you can predict where the health care business is going past five years, but we’re going to try to design it,” Leahy stated. The hope is that the fully-designed facility will appropriate square footage needs in the new hospital. Once this step is complete, the process will move forward into formal designing and permitting by the DOH, USDA, and City of Chelan.

In regard to design, an inquiry was made as to how the new hospital will keep up with the needs of the community, if expansion is needed, will it grow up or out? Leahy explained that both options are being explored at this time. There are cost concerns with “growing up” that need to be address at the time of build, such as the affordability of the cost of footings and columns now for an additional level, as well as factoring in elevators and many other factors that need to be considered. “One-story facilities work the best if you can do it,” he said, “here you have the land to do it. You’re talking about expansion, so we’re evaluating whether we can afford to do something that can support a larger level sometime, or, do we design a facility that we can add a wing on at a future time? I think the staff, not speaking for them, I think they would say they would rather have a wing.”

“So, basically 2018 is preparing our permit documents for those three entities ... and we’ll submit those to the city probably somewhere August or September of 2018,” he said, clarifying the timeframe.

discuss the housing needs in the community. The town hall meeting will take place Tuesday, Jan. 16 at 6 p.m., at the Chelan Senior Center. “I am going to hold a town hall meeting once a quarter,” explained Cooney, “I find things to be very restrictive as far as public comment, so we’re going to do it once a quarter ... we are looking for solutions, not necessarily more questions or more rabbit holes to find. That will be followed up by a more structured City Workshop on Tuesday, Feb. 6 that Craig (Gildroy) will have certain examples of things that can be done by way of code.” Cooney then took the last few minutes to provide a personal moment with community members in attendance, “people always wonder what goes through (our) minds, for me, and others that I serve with up here, we put the town first, our town comes first, our people our roads, our services, they come first. People question that all the time ... our town comes first. Also, I want to say that I want to make sure that we have housing for all, home ownership for those that are residents of Chelan, I would like it if everybody’s first home that wants it here, is before somebody else’s second home ... there’s too many people wanting their first home. I hope that everything I do makes the community a little bit better, and what more can we do together to make the community better?”

Following the Weidner Apartment presentation was a very special presentation for not just the council, but for community members as well. Chelan County Sheriff Brian Burnett stood in the front of the room as he expressed his best wishes

and gratitude for Councilman Harper, before moving into his introduction of Chelan’s newest sergeant, Chris Foreman. “We’ve wanted to recognize Sgt. 2019, Manson Parks is discussing the presentation of a levy on the April or November ballot. The placement of the levy will be discussed further in their January meeting agenda.

Manson Parks Director Robin Pittman concluded the night’s agenda with a report on recent activity within the office. One particularly noteworthy event was the placement of a fluidity unit placed by Lake Chelan Research Institute’s Phil Long. The Research Institute received two of the fluidity units, which

will effectively take samples for e-coli in the water via electronic prompting. “They can text the little robot and say, ‘take a sample’, it takes a sample, grows its little test tube full of water – it’s its own little lab.” The cost of each unit was stated around \$14,000, which was funded by the Washington State Parks, “there’s definitely some backing and support for it,” Pittman expressed, “I think they’re right in line with our efforts (too), it’s a good collaboration of the groups.

Other items mentioned at the special meeting included a survey to be distributed to Manson addresses, requesting opinion on the upcoming waterfront

project, and the permission for use of the day use dock for a local company offering jet boat rides to pick up and drop off passengers with the exception that no financial transactions or signage takes place on the park’s property.

Before adjourning the meeting, the parks commissioners and staff acknowledged the outgoing commissioner, Marylene Rios, for her time served and dedication to the board, “four years,” Campbell said, “thank you for doing it, we will miss you.”

The next Manson Parks and Recreation meeting will be held Thursday, Jan. 11 at 4:10 p.m. in the Parks Office.

## Jacob (Jack) Max Goehry


Chelan, Washington

On Sunday, December 17, 2017, Jack Goehry died peacefully at the age of 100. Born in Oak Harbor, Wash. January 14, 1917 to Max and Hazel (Neil) Goehry. Jack's mother passed away in March from the 1918 flu pandemic. At age three his father remarried Dee Holden and moved to Brewster, Wash. where they added three siblings: Bob, Stan, and Kay. One of Jack's first jobs as a teen was building wooden apple boxes. He built 500 boxes a day for a penny a box until he graduated from Brewster High School in 1935. He then attended the University of Washington where he drove a topless 1929 Model A Ford over Highway 2.

In November 1941, weeks before the attack on Pearl Harbor, Jack enlisted in the Army Air Corps. Jack was a B-24 Bomber Pilot during World War II with the 513th Squadron, 376th Bomb Group. Stationed in Benghazi, Libya, the 376th flew missions over the Mediterranean Sea to strategic targets in Southern Europe. His combat tour finished with 33 missions and 305 combat hours. Jack was awarded the Distinguished Flying Cross with Cluster, seven Air Medals, 2 Presidential Unit Citations and five Battle Stars. After returning from combat in 1943, Major Jack Goehry was assigned as a B-24 Flight Instructor where he met and married Betti Lou Schram. He returned to Brewster, Wash. where he worked as a car salesman for the family business.

During the floods of 1948, he flew a 2 seater Cessna into the Methow Valley landing wherever possible to deliver supplies and transport the injured. During the Korean War, Jack was called back into service and was stationed in Bermuda as a hurricane hunter for the U.S. Air Force. Jack married Elinor (Peg) Clinton, the love of his life, in 1957.

In 1965, Jack and Peg moved from Brewster into their newly built home on Lake Chelan where Jack enjoyed riding his snowmobiles on the beach,



spending time with family and friends on the porch and growing the best tomatoes known to mankind.

Employment history after military service included diverse job experiences in Brewster and Chelan as a Car Salesman for Goehry's Incorporated, Apple Buyer for North Country Fruit, Ground Crew for Cascade Helicopter, Co-owner Chelan Concrete, and owner of Rapid Rental Storage.

Jack married Rebecca Creighton in 1994. He enjoyed gardening, reading, skiing, swimming, flying, snowmobiling, and cocktails at five. Civic duties were a large part of his life, including 73 year American Legion member, over 45 year Lions Club member, and many years as the Lake Chelan Sewer Commissioner.

Jack is survived by his children: Max Goehry, Patty Hughes Schmauder, Kim (Steve) Olsen, Clint (Maria) Goehry, 6 grandchildren, 4 great-grandchildren and sister Kay Welborn.

Jack was preceded in death by his brothers Bob and Stan, wives Elinor (Peg) Clinton and Rebecca Creighton.



Obituaries and memorials need to be typed and emailed no later than Friday by 4:00 p.m. to be placed in the next available issue(s). Please call for cost of an obituary and which NCW paper(s) that it will be placed in to.

Cost of the obituary/ memorial is due at the time of placement. Funeral homes and chapels can submit obituaries by Noon on Monday, unless a holiday.

Obituaries are priced per word while Memorial ads are per column-inch.


They may blow their brains out or they may be firing with an empty chamber. That is the gist of the game - win or die.

It was estimated the substitution would take around two years to construct.

"The next step is to determine if we have willing sellers, getting options and then presenting these options to the customer focus group for recommendation to the commissioners."

### Still work to be done: Chelan residents voice concerns with comp plan at last public hearing

CHELAN - Over 70 Chelan Valley residents gathered in the city council chambers on Wednesday, May 17 for the final public hearing on the city's Comprehensive Plan. Their overall feel of the plan, which began last November and coming to a head with a possible motion for council approval at the end of July, is that it needs some tweaking.

Their list of grievances include:

- Population size and the zoning along Lakeside Bay

"The plan has seriously underestimated both the current population of 5,000 and the future growth," Friends of Lake Chelan representatives John Olson and Steve Kline read off a prepared statement. "According to the (Chelan County) PUD's meter administrator we have 4,224 residential meters in Chelan. With an average of just three people per meter, that's 12,672 that live here now... The planning department's fact sheet states that the summer peak population for just

Chelan is over 25,000. When you add similar summer numbers from both the north shore and south shore, it's conceivable that the summer population, that all use Chelan services in one way or another, is currently approaching 75,000. (So) something well over 5,000 must be used for planning purposes."

Olson and Kline - along with a few other residents who gave testimony later in the evening - also expressed their disdain for the zoning of "Commercial Waterfront/Water Transportation Hub along the Lakeside Bay portion of Zone 7.

"Such zoning would permit 40-foot condos and a large marina like Sunset Marina," Olson argued during his monologue. "This zoning will result in the following losses to the community: lake view, water quality, up lake view corridors, public access to the lake, the extreme need of a third waterfront park, - as identified in the city's Parks and Recreations and Open Space Plan (PROS) - recreational opportunities, quality of life and the character of the town. In short, this zoning would damage and degrade the general welfare as outlined in the plan's vision and intent statements."

### From Olympia to Chelan, Jennifer Keitzman joins HDCA

"I have vacationed in Chelan in the past with my family and found that I really enjoy the small town atmosphere, the climate and the lack of I-5 traffic," Keitzman said.

### Free-drop off recycling service in Manson set to close at the end of June

MANSON - The trash cans in Manson will likely be a little more full this summer now that the drop-off recycling site is set to be permanently closed beginning June 30.

The report came out after last Thursday, June 1 after Jill Fitzsimmons, spokeswoman for Chelan Public Works, made the announcement in a press release to media members.

After originally suspending free curbside recycling in February - once grant funding for the service ran out - Fitzsimmons said that Manson business could still use the free drop-off location at the Red Apple Market. As of July, they will no longer be able to enjoy that option.

The reason: "it is no longer financially sustainable," Fitzsimmons wrote in the release on Thursday. "The City of Chelan, which was servicing the bins under an agreement with Chelan County, unfortunately cannot continue the program because it is no longer sustainable."

According to Fitzsimmons, the collection bins located on Quetilquason Road have become a draw for illegal dumping. As a result, the program has incurred additional costs associated with sorting the bins because people were contaminating recyclables with garbage.

### Lopez-Maciell sentenced to 41 months for hit-and-run fatality

WENATCHEE - A young Bridgeport man charged with the hit-and-run death of Brewster resident, Gary Knowlton last July was handed a 41-month prison term at a sentencing hearing in Chelan County Superior Court last Thursday, June 1.

Jovany Lopez-Maciell, 22, received the maximum available term from Superior Court Judge Lesley Allan under the standard sentencing range. Maciell will receive credit for time served since his incarceration last September when he surrendered to authorities.

Sources at the Chelan County Prosecutor's Office said that Maciell has been remanded to a detention facility in Monroe for further processing and determination as to where he will serve out his sentence. Under current sentencing guidelines, Maciell may later be eligible for parole or a reduced sentence.

A restitution hearing for Maciell has also been scheduled for August 23.

Maciell pleaded guilty in the hit-and-run accident that took the life of Brewster teacher, Gary Knowlton. Knowlton, 50, was also a part-time life-guard for the Manson Parks and Recreation Department and was riding his

bicycle on Apple Acres Road north of the Lake Chelan Airport when the accident occurred on the evening of July 16, 2016.

### Wells Fargo to close Manson branch July 12

WENATCHEE -- Wells Fargo's District Manager for North Central Washington Agustin Reyes, said the Manson branch of the San Francisco-based bank is closing Wednesday, July 12.

"We notified the employees in late March and a letter was sent to customers in early April," he said.

Reyes, in an exclusive interview with NCW Media, said the closing was part of evaluating and consolidating the company's branch network. "The Manson branch customers can still look forward to banking at the Chelan Wells Fargo branch where they will recognize familiar faces" as three former Manson employees will be transferring to the Chelan office, according to Reyes.

A total of five staffers will be affected by the closure with the current branch manager, John Freeze, transferring to Seattle and another worker going to the Wenatchee branch, according to Reyes.

### Potential drowning, missing hiker cloud beautiful week in Chelan

CHELAN - The sun was shining, weather calm and business booming this week with tourists, but overall, it really wasn't the best week for Chelan.

First, the Chelan County Marine Patrol responded to a call early Tuesday afternoon about a potential drowning in the middle of the lake across from the Three Fingers.

The 23-year old identified as Donghoon Lee of South Korea was on summer break from the University of Washington and visiting Chelan with a friends. The group decided to rent a boat and were swimming off the back toward the middle of the lake in approximately 30-40 feet of water when Lee started to experience difficulties in the choppy water. One of Lee's friends attempted to throw him a personal flotation device, but were unsuccessful before Lee sank beneath the surface.

Rescue swimmers got in the water shortly after the call, but were unable to locate the 23-year old. Search and rescue efforts continued through Tuesday night before swimmers had to retire because of the cold water.

The next day, rescue efforts turned to recovery as equipment, including a helicopter, and personnel from Chelan County Sheriffs, Steven's County and the Douglas County Sheriffs Office worked in conjunction to help find the missing student. Unfortunately, weather conditions forced them to suspend their efforts.

As of Monday, the search continues as Chelan County Marine Patrol will continue to use under water camera equipment, divers, rescue swimmers and a helicopter in hopes of finding Lee, who is presumed to have drowned.

The Chelan County Sheriff's Office advises using this as a reminder to stay educated on water safety in order for everyone to have a safe and healthy summer while visiting Chelan County.

Missing hiker

On Thursday, June 22 at approximately 12:30 p.m., Rivercom dispatch received a report of an overdue person in the Chelan area. The caller advised that her son was camping somewhere in Chelan and they hadn't heard from him in two days. The caller also advised that the son's two dogs had been located by another hiker on the north side of the Chelan Butte, but her son was not with them.

The subject, was identified as 31-year old Johnathan M. Taylor of Mount Vernon, Wash.

A Chelan County deputy responded to Chelan Butte and located Taylor's vehicle abandoned at the top of the butte. Deputies searched the area but were unable to locate Taylor before a helicopter was called in to assist.

On Friday morning, search and rescue deputies and volunteers from Chelan County began an extensive ground search and located Taylor at approximately 2:30 p.m. deceased at the bottom of a steep embankment on the south side of Chelan Butte. As of Monday, no announcement has come from the Chelan County Sheriff's Office on what caused Taylor to fall. Taylor's next of kin have been notified.



Quick response by Chelan Fire and Rescue Firefighters stops fire at the GrandView

CHELAN - Chelan Fire and Rescue was dispatched to a report of smoke in a third floor room of the GrandView by the Lake at around 6:47 p.m. on Dec. 16.

The first units were on scene within five minutes of the 911 call and two and half minutes of being notified by the dispatch center. The engine connected into the Fire Department Connection (FDC) that supports the stand pipe and fire sprinkler system while other members of the crew accessed the third floor room which they found to be charged with smoke and heat.

The crew located a working fire in the void space around the bath tub and reported fire coming from the ceiling area in the unit below them. A second crew was sent in to the second floor unit and found fire in the ceiling area above the bathroom. Both crews were

able to knock the fire down and then check for extension.

No fire sprinklers were activated due to the fire being in the void spaces and not in the living space of the rooms. The fire was confined to the two units, but a fourth floor unit suffered smoke damage and the first floor unit had some water damage. Guests in Building C and D were displaced for about an hour during fire operations.

"The fire could have been much worse if we had not had a strong initial response from our on-duty crew followed by aggressive firefighting," said Fire Chief Lemon. "I credit them with keeping this fire from causing any further damage. During the initial fire operations we were using all available resources that were on the scene to include our EMS folks and the GrandView staff to help ensure the buildings were completely evacuated," said Fire Chief Lemon. The fire is under investigation.
