MANSON - Finances and recruits were among many topics discussed during the regular Chelan County Fire District (CCFD) 5 Commissioner's meeting, Tuesday, Dec. 12 in Manson. The meeting commenced with a financial report overview. The financial report showed approximately \$83,000 to be carried over into 2018's finances. resulting in a final budget for next year of \$723,746.

Moving into the recruitment and retention segment of the night's agenda, Chief Arnold Baker expressed satisfaction with the current volunteer and recruit applications received recently. One of the applicants already has his Firefighter One certification,

along with EMT certifications he explained, adding that there are also two other solid applicants from within the

community that he is hoping to bring in the Manson Fire family. Other changes to staffing will include an incentive compensation plan for firefighters who chose to advance to a fire officer or chief officer position. Assistant Fire Chief Kermit McClellan recently completed and passed the Fire Officer 1 certification, which in turn inspired at look at the district's current compensation plan for the courses. "As we looked at the plan," explained Baker, "we really didn't have that (compensation) in the plan." There was some compensation information available for Firefighter 1 and 2 certifications, but not much stating compensation for costs incurred in achieving the instructor's or inspector's certification required, in ad-

dition to hazmat certification, in order to test for any officer position. "Segments were tested out of all of those pieces," he stated, "when they test for Fire Officer they throw a smattering from all the previous tests at you to make it really hard - and it was." The plan is that every new candidate for officer classes will have to have the required instructor, inspector, and firefighter's certifications before they can even get into class. "Anybody that follows behind me," Baker explained, "I think they need the whole gamut to be an effective fire chief in the future," he continued, explaining that from this point forward certain certifications will be required for advance-

## Watershed Planning Unit hears presentations

CHELAN - The Lake Chelan Watershed Planning Unit met Wednesday, Dec. 13, at Chelan Fire Station 7 in Chelan. The meeting agenda included department updates as well as special presentations on water supply and quality, as well as a presentation on invasive and non-invasive mollusks and snails by the Washington Department of Fish and Wildlife.

Phil Long, of Lake Chelan Research Institute, provided an update on current activities and grant opportunities available to keep the Research Institute successful. In his update, he briefly mentioned new metering equipment that can go as deep as 25 meters in the lake. This equipment cost around \$12,000 which was paid for with

a 75/25 split, with Sunset Marina covering \$3,000 of the cost, and the remaining \$9,000 covered by Washington State Parks Departments. Long also discussed the 70-meter internal rocking in Lake Chelan, "In an extreme case of rocking you'd get displacement, where the warm water is on top the cold water," he explained to the attendees of the watershed meeting. He added that the rocking plays havoc on currents, as well as water temperature fluctuation. "The notion is that it's like a teeter-totter and it's rocking back and forth," he said, adding an interesting fact about the severity of the rocking, "the 70-meter swing (rocking back and forth) was biggest ever measured back in 1989, and as far as we know it still is." The rocking takes about two days

CHELAN - A formal introduction of Chelan Fire and Rescue (CFR) 7's newest firefighter, Austin Murdock, opened up the district's regular meeting Wednesday, Dec. 13 at Station 7. Murdock was hired on Nov. 20 and just recently went to shift after completing two weeks on days. Assistant Chief Mark Donnell provided

"Austin was actually working part-time with Marysville and Lake Stevens fire departments," said Donnell, "and came through the testing process number one, and we're very pleased to have him."

ment. "This is establishing that those people coming along are going to have to take the long route," he concluded, "and they're going to get compensated for each step on the long route because they have to do the pre-requisites." Compensation for certification costs were approved by commissioners at that time.

In regard to paid staff, employees will begin to accumulate paid sick leave which is mandated for any employee under L&I. State law currently states that sick pay must be provided at a minimum rate of one hour per 40 hours worked. After evaluation of work schedule and pay rates, commissioners agreed at this rate, which would provide around two and a half hours paid sick leave for 96 hours worked in a four-week period.

At the county's request, Manson Fire will be working to include the area fire plans

#### as a layer within the county. By making the fire plan accessible to other department or districts within the county, mutual aid engines will have access to the plan ahead of time in an emergency situation, allowing for quicker response times. While there are currently some connectivity issues with the programs, it is hoped that once they're resolved the plans will be available for viewing and distribution as needed.

Concluding the general agenda was the oath taken by Brian Harris, who ran unopposed for the seat in the latest round of elections.

Before closing the meeting, Assistant Chief McClellan announced that snowplow services will be available to the public again this winter, with a flat rate of \$55 per job.

happy to stay down there and we're just waiting to see if they are going to decide on that option or not," he explained to the commissioners, "the boys are checking in regularly, they held the line last night ... getting some front-line fire combat operations in ... I'm sure they're providing a very good service down there.'

The false alarm ordinance that Station 7 commissioners and staff had hoped to establish for 2017 is still at a standstill said Lemon, "we've had no movement from the county or the city on that." On the brighter side of things however, Lieutenant testing has been completed according to Assistant Fire Chief Mark Donnell. The top three finalists from the testing will be realigned next year on shifts and will be Steve Saugen on A-shift, Joe Cox on B-shift and Jake Hepper on C-shift. Donnell added that there will also be two new members joining the Station 71 family, returning fighter AJ Mendiville and local resident Doug Morgan. "We have, right now, seven people who are slated to go into our volunteer recruit academy next year," he said concluding

of the prevention plan includes AIS inspections, which are currently open seven months out of the year, and stationed at two locations, one on Interstate 90 from Idaho and the second on Interstate 395 from Oregon. "The only way the zebra mussels get here," he emphasized, "is that someone's got to physically bring them on their boat, by not emptying their water out of the live well or the bilge, or anything else that holds water." The adaptive mussels will live on the outside of the boat, out of water, for up to 30 days he said. The best prevention,

nation method. This method requires cleaning water apparel and watercrafts with clean soap water, draining water reservoirs, and rinsing everything thoroughly. Bleach water or a salt water solution are also good options. The most efficient way, though, is a level two decontamination, which requires thorough rinsing with hot water (at least 140 degrees), and repeat as needed.

# Entiat city council, staff provide project updates at meeting

ENTIAT – Councilmembers and city staff gathered to discuss and resolve agenda items including the City's 2018 budget and scheduling of city fees for services, licensing and permits during the regular council meeting, Thursday, Dec. 14 in Entiat. One mentionable service fee that came up during the meeting was an annual three percent water and sewer increase to Entiat residents. Until details can be further researched by councilmembers, the rates will remain the same as they are presently, however if any increase takes place, it will require a budget amendment.

Initiating the regular meeting was an update from City Planner RJ Lott, stating that he was in attendance at the last North Central Washington Economic Development District (NCWEDD), Wednesday, Dec. 13 in Chelan. Lott will be continuing to attend the meetings along with Councilman Bob Anderson. "It's something I think that will greatly help us in moving forward," explained Lott, "they're a pretty solid organization." He proceeded into his next update regarding the community center feasibility study, "I met with Pacific Engineering," he began explaining to Mayor Keith Vradenburg and councilmembers, "a quick summary of that is that we're still on track, the delays we had, so to speak, didn't derail us from the qualifications of the grant." After a few revisions, the final report should be available for review the end of December or beginning of January Lott concluded.

Next to report was City Engineer Larry Cordes with an update on the budget for the backup well project around Hedding Street in Entiat. Cordes began by explaining that, although receipting a little lower-cost well bid, the overall project "budget was skill kind of fuzzy." Afterward, he stated that he asked to reevaluate the project's budget, to get a better idea of the projected costs. "Essentially, we're just trying to drill a well," he began, "initially we were wanting to drill two wells in that area, a 12-inch and an eight inch, but now we've settled on just drilling one 12-inch well." According to Cordes' report, the total grant amount for the project is \$498,614, with a city contribution in the amount of \$16,071. "Of that (grant amount), \$321,410 is the construction costs," he explained, "I went back to the original construction costs estimate that we developed, which was in 2012, and I did quite a bit of research, pulled together some cost data from more recent projects from our Kirkland office and such, and I just took a real hard conservative reality check on all the project components." He continued by explaining that cost adjustments were needing to be made to catch up with current costs, "the test well originally had a number of \$49,700, bids came in at \$97,300, so there's a \$47,000 difference," he emphasized. "What we're heading at here ... is we need about \$190,000 more to get through this project as planned." Actual construction costs are looking to be nearly a 100 percent increase of what was initially anticipated, and if funding can be secured then drilling is projected to take place during the winter/spring and construction in the summer/fall.

Councilman John Alt took a moment to provide an update on a couple different housing projects in the works. "RJ and I attended the 'our valley' housing solutions meeting," Alt began, then explained the process of the group. "It's broken into subgroups, RJ is working on housing types and inventories. and I'm working on codes and solutions," he explained. "The board is moving along quickly and a lot of good people are showing up to the 7 a.m. meetings to try and make some progress on that.," Alt added, "I think RJ and I are feeling really excited about what's going on there." Moving on to his next update, Alt said he also attended the Wenatchee-Chelan Housing Authority board meeting and brought forward a discussion on a piece of property that they have a current intent to purchase agreement on. After asking the board to consider moving forward on that and actually purchasing the property, he said they felt confident enough in their funding to move ahead with the purchase. "The sense I got, without it being said, was that they thought they had pretty good funding string potentially, but I think they also realized that they are in a pretty good position to purchase property and may have concerns that that wouldn't be available if they tried to renew again."

Moving into the action items of the night, Lott proposed revised zoning along Highway Commercial zone in regard to mini-storages. "This is regarding mini-storage facilities, not to be confused with cargo containers, in the Highway Commercial Zone." He began

After Christmas Inventory Reduction Starts Dec. 27 through Dec. 31 Mosey the Moose says .... explaining, "as it sits now, commercial mini-storage facilities are available in the Highway Commercial Zone via the use of a Conditional Use Permit (CUP), Ordinance 774 which I believe we did in either August or September ... before you tonight is the decision to remove that use via the CUP and not allow mini-storage facilities at all in the Highway Commercial Zone." Along with the proposed rezoning, was the redefinition of storage units, separating the mini-storage from vehicle and watercraft storage. Councilmembers approved and passed the proposal, disallowing mini-storage units in the Highway Commercial Zone.

Due to the holiday, there will be no Dec. 28 Entiat Council meeting, so councilmembers will meet again for a regular meeting, Thursday, Jan. 11 in the council chambers.
