Council signs new sheriff agreement, hears update on parking kiosks

CHELAN - Good news. The Chelan City Council signed a new Sheriff Contract with the Chelan County Sheriff office at a special council meeting on Tuesday, Aug. 1.

Council signed a two year agreement that runs through 2018 but wanted to clarify a few things with the Sheriff

"What I've heard is that we don't have any shifts or changes, we're happy with enforcement we are receiving, but it's a chance to strengthen the contract and touch on some of the items we have talked about," Chelan City Administrator Mike Jackson

One was getting a roster of officers on duty in Chelan.

"That may be all we can get, but (at least we can) get an idea of who is assigned to the city," Jackson suggested. "I think a better understanding of a firm duty roster and times they go back and forth. Something that shows a breakdown of who are the regular people, so we have a good understanding of who is serving the city, not that we're challenging them."

Another thing Jackson brought up was the price of the contract. Since it was a 4 percent increase, council will look to escalate the lease on the Sheriff office on Johnson

"We have never changed the lease amount for the police department, maybe we could tie that to his escalator as

well," Councilman Ray Dobbs stated.

In case a new supervisor takes over for Sergeant Rob Huddleston, council would like to at least be in the conversation of potential candidates.

"If there is a change potentially the sheriff could propose a couple candidates and give the city an opportunity to discuss... I think it's nice to know who is coming on," Jackson

pressed to council. "They have always had a good supervisor, the first guy we got was great, and then we got Rob, and he is a great guy too," Chelan Councilman Guy Harper said. "All of his people that are at that level are top notch and if he said it was the

right guy, I trust him."

Chelan Councilman Servando Robledo agreed both sentiments but advised including some language to be in the discussion because although the relationship is great now, "maybe it's the best time to include language now as opposed to when something happens (down the road)."

After council signed the agreement, they moved onto a director report from Parks Director Karen Sargeant.

Sargeant outlined some of the projects that have been completed and gave an update on the parking kiosks, which

have been in use since April. "The table down below shows the amount of revenue

we have collected," Sargeant said, pointing to a handout that showed \$94,838 in four months. "The number of tickets sold, which are the receipts are 18,651."

Pretty good for a total cost of \$30,000 for all four kiosks.

"We still don't have August (either), Sargeant affirmed. "The monthly service fee is less than we were paying the other guy, and the parking enforcement are spending a lot of time giving courtesy notices. We're not out to get people, it's an educational moment... One thing I want council to think about is rolling some of the money back

Primary whittles down City Council, Hospital **Commissioners candidates**

Signorelli, Jaech, Gleasman, Isenhart, Morehouse and Hollingsworth advance to general election

CHELAN - The votes are counted. The Hollingsworth stage set. November will feature some hot races for Chelan City Council, and both the Lake Chelan Hospital Commissioner openings in the general election.

Chelan Council Races

Current Planning Commissioner Tim Hollingsworth secured the top spot in the primary for Chelan City Council Position 6, garnering 455 of a total 947 votes - not including write-ins - (48.05%). He will face incumbent Cameron 'Skip' Morehouse, who received 388 votes (40.97%) as of the Friday, Aug. 4 count.

"I am pleased with the support I received in the primary," Hollingsworth said last Thursday. "Councilman Morehouse and I are both well-known and respected around Chelan and the close results reflected that. I think it's great that (Andrew) Baker participated in the election and I expect he will make great contributions to our community Mary in the future."

With the race being tight, Hollingsworth knows he has to reach out to more voters to secure the council position over Skip.

"I understand that I need to earn people's vote by hearing their concerns and giving them the opportunity to understand my mind," Hollingsworth said. "The harvest season in our valley is a busy time, but I hope to reach out during the Fall months and meet as many groups and individuals as possible Jeremy to discuss concerns, ideas and things we love Jaech about living here.'

Morehouse responded to the following

What are your thoughts on the outcome?: "Never had a primary before and was very curious and happy with the outcome. Tim did advertise and Mayor Cooney is both supporting him and failing to pass on Council actions with any reference to me, on the KOZI radio following council meetings."

Was it closer than you anticipated?

Not really, I have only garnered 59 pe in any fall election."

What are your feelings heading into the general election in November?

"Very positive, Rotarian, John Anderson, who also led the charge for the Chelan Valley Hope organization, is backing me all the way. He knows both of us and spent a year under Tim's Presidential term in the Rotary. Jerry He thinks I should continue. He may be the Isenhart most community minded person I know and was a great asset to this City."

How are you going to try and secure more votes from Andrew Baker to put you past Tim?

"If you look at my record over the last 11 plus years, the most recent accomplishment, funding Lake Chelan Research Institute at a realistic level, it is unmatched by any council person for adding value to our valley. Experience, Knowledge, and Accomplishment. I plan on talking to more than six people about the fall election and will get my record out, which serves the community. If the Andrew Baker voters and the Tim voters compare our community work the last 12 years they would no doubt be Morehouse voters. And I will try to smile a little more ... Be sure to come look at the Planning Tim has in mind. He would like to convert single family zoning to multifamily and Tourist Accommodation, blocking your sunrise and sunset vistas."

Hospital Board Races

The Hospital Commissioner races drew, as of the Aug. 4 ballot count 4,561 voters, and will be hotly contested over the next few months, with incumbent Mary Signorelli getting 1,086 votes (47.24%) compared to challengers Jeremy Jaech, who accumulated 782 votes (34.01%) and Stan Morse receives

431 votes (18.75%) Mary Signorelli

"I have lots of duties and responsibilities to address between now and November," Signorelli said. "Having said that, as far as my campaign is concerned, I am delighted to have the opportunity to show the voters of our Hospital District 2 why they show re-elect me Commissioner. I am ready to put the time and energy it will take to accomplish this."

Jeremy Jaech "I'm pleased to make it to the general election. This is my first attempt to run for public office so I feel good about the primary results. I had no ideal how the voters would vote and am happy to have attracted about a third of the voters given that I have low name familiarity and am a relative new-comer to the valley, Jaech said. I'm hopeful that my message of bringing my expertise with building new facilities and understanding the future of health care will continue to resonate with the voters. I plan to continue to hold small group meetings with interested voters to explain why I can best represent them on the commission, and hope that this approach will not only attract voters who voted for Stan in the primary but also voters who voted for Mary. I believe that the more people get to know me and what I could bring to the commission, the better my chances are of gathering

The other Hospital Commissioner race was tighter with incumbent Phyllis Gleasman leading with 1,024 votes (45.27%), Jerry Isenhart, received 951 votes (42.04%) and Kathy Jo Porter received 287 votes (12.69%) Jerry Isenhart

"Now that I am a candidate in the General Election, I will begin to formulate more specific thoughts that i would like to see considered. One of those will be the expansion of the Hospital Commission from a five to seven member body," Isenhart said. "As our valley grows in all ways, it would be extremely beneficial if we could have a more diverse Commission.'

"I've spoken to Kathy Jo and learned that she and I share many of the same ideas," Isenhart said. "We both feel that new members to the Commissioner would serve to bring fresh perspectives, and that would be a good thing."

Phyllis Gleasman Gleasman did not respond with a comment.

For each race, whoever can secure the votes that went to the others candidates (Andrew Baker, Council, Stan Morse, Hospital Commissioner 1 and Kathy Jo Porter, Hospital Commissioner 5) will likely win the election in November.

It would be behoove to not point out the discrepancy in voter turnout since 4,273 residents voted for the Hospital Bond in April compared to a meager 1,851, and 1,821 in the two LCCH Commissioner races. The votes cast in the previous two Commissioner races in 2015 (Wall - Murphy) and (Warren-Farrell) drew 2,508 and 2,389 votes each.

Entiat City Council race In the Entiat City Council race, incumbent Robert Anderson secured a strong hold on his seat, tallying 156 votes (73.24%) compared to 40 (18.78%) for Norman Stenberg and 17 (7.98%) for Richard Crump.

Stenberg will look to rally more of the residents in Entiat to overcome Anderson.

Final ballot count and certification of the election will be on Tuesday, Aug. 15

Heart saver Ray Eickmeyer steps up as new EMS director at Lake Chelan hospital

CHELAN - Paramedic Ray Eickmeyer, who has 25 years of experience in emergency medicine, was recently honored for his heart-saving abilities, as well as hired as new Director of the Emergency Medical Services (EMS) department at Lake Chelan Community Hospital & Clinics (LCCHC).

"My passion is high quality emergency care that makes a difference to the community," said Ray. "I especially like that we can help people at their times of greatest need - one person at a time."

Replacing Karl Jonasson, who served in the director position for more than 25 years, Ray wants to continue the excellent service Jonasson built and provided to the valley, he said. He also looks forward to working on a new community paramedic program. This is an extension of patients' existing medical care and may at some time include home visits to check on individuals.

Ray earned his bachelors of science in Paramedicine in 1997 and has been the EMS Operations Manager at LCCH since 2010, as well as interim director. A governing board member of the North Central Washington Accountable Communities of Health and chairman of the Greater Wenatchee EMS and Trauma Care council, Ray is also a speaker and educator. He and his wife Christine have lived in the Chelan Valley since 1999 and have two children.

Last month Ray received the Perfect CPR Award from

Laerdal and Healthstream. He is one of only two people in the nation to make that achievement.

It's a fitting award for a man who led the charge to improve cardiac arrest survival in Chelan and Douglas counties. In 2010, Ray was the first in the region to attend a resuscitation academy in Seattle. He came home with a passion to improve our area's system and helped regional emergency medical professionals embark on a radical change for our community.

The team started by implementing High Performance CPR, with Ray instrumental in the training process. He also established rigorous training for Lake Chelan EMS to ensure the highest quality choreographed CPR and was very supportive in the establishment of a Quality Improvement Officer to allow review and feedback of actual cardiac arrest cases. The result was a number one rating in the state for two of the last four years for out-of-hospital cardiac arrest save rates.

"I am very grateful for the positive energy Ray injects into our system," said Dr. Lance Jobe, medical program director of Chelan and Douglas County EMS, "and for all the hard work he does to improve survival from cardiac arrest throughout Chelan and Douglas counties."

Ray has received multiple other awards, including, but not limited to, LCCH Employee of the Year, Outstanding Safety Leadership and Excellence in Safety awards (out of 33 Hospitals), Washington State Emergency Cardiac and Stroke TAC award for helping implement the state's first ECS system, Life Saving award from Chelan County Fire District #7, American Red Cross Hometown Hero award and Administrator of the Year award for Chelan/Douglas County - Greater Wenatchee EMS Council. Lake Chelan Community Hospital & Clinics commits to improving **Resuscitation outcomes**

CHELAN - The American Heart Association's (AHA) Resuscitation Quality Improvement (RQI) Program is a groundbreaking new approach to maintaining competence in CPR. It takes CPR training a step farther than traditional training programs, keeping CPR skills fresh through quarterly skills practice.

Performing CPR is not a part of many health care providers' regular practices. In fact, some rarely perform it other than during bi-annual training. As a result, CPR compression and ventilation skills degrade, and overall CPR effectiveness is reduced

To help Chelan caregivers stay confident in their CPR skills, LCCHC now uses AHA RQI. Its premise says that brief and regular skills practice — referred to as "low-dose/high-frequency" training — leads to higherquality CPR skills.

The RQI Program uses realistic eSimulation patient cases and a mobile RQI cart equipped with adult and infant manikins for regular psychomotor skills activities. The training provides audio feedback on hand positioning, compression rate and depth and ventilation rate that an alternative CPR manikin simply cannot provide. With focus shifted from course completion to ongoing competency in CPR skills, RQI allows caregivers at LCCHC to more effectively retain lifesaving CPR skills.

"The hospital's commitment to improving CPR effectiveness will improve patient care and save lives," said Ray Eickmeyer, LCCHC EMS Director.



Last week CNN reporter Jim Acosta attempted to criticize President Trump's new immigration proposal by bringing up Emma Lazarus's poem – "The New Colossus".

"Give me your tired, your

Your huddled masses yearning to breathe free,

The wretched refuse of your

teeming shore. Send these, the homeless,

tempest-tossed, to me: I lift my lamp beside the gold-

Acosta was roundly attacked by White House spokesman Steven Miller for having the audacity to ask such a loaded and prejudicial question.

The problem is Lazarus's poem is just a poem. It is not part of our founding documents nor has it ever been made part of our official political position through legislation or executive office decree.

Historically speaking the poem was not connected with the Statue of Liberty monument until 1903, well after the statue had been erected. In fact Lazarus had reluctantly agreed to donate her poem to the effort to raise funds for the pedestal for Lady Liberty.

The "Statue of Liberty En-

lightening the World" was a gift of friendship from the people of France to the United States. But it was understood at the time that Americans would be responsible for building a platform for the statue.

The monument was the brainchild of Edouard de Laboulaye an abolitionist who saw the monument as a tribute to the end of slavery in America and a way to inspire the French people to call for reform of their own repressive monarchy.

It was not intended as a monument to inspire immigration to America. And while Lazarus's sonnet calls for us to accept the poor and the homeless, it is highly doubtful those were the immigrants that found their way to America. Even in late nineteenth century passage to America was a costly endeavor.

Yes, it is true that many of our early immigrants sold everything they owned and made their way to the New World with

only what they could carry with them. That does not mean they were without skills or talent they could rely on to enrich our developing nation. Early immigrants also could not expect to receive free government services when they arrived.

It is also true that many could not speak English or read or write. But the world has changed and we cannot take on all of the "huddled masses" of the world. Immigration policy, like any other government policy needs to be reviewed and changed to fit the needs of our country.

The truth is we can do a lot more for the poor and downtrodden by confronting evil dictators who are abusing their citizens. Unfortunately, most "progressives" support these dictators because they claim to be out to help the working class. They rarely do. And when their countries fail we cannot become the safety net for their suffering

An honest review of these regimes will reveal that they nearly all end up lining the pockets of the powerful leaders while the general population struggles. The solution is not to make our country a haven for all of the downtrodden in the world. That simply burdens our citizens to make up for failed leadership around the world.

The solution is to challenge the dictators of the world to live up to their promise to improve the lives of all of their citizens, and to actively oppose their abuse of those citizens.

That is not to say we don't have problems with immigration. First, allowing illegals to overwhelm our system is not acceptable. Second, we need a guest worker system. Third we need a way to enforce our temporary visa system. Our current system is broken. It is time for Congress to fix it and to enforce the laws they have passed.

Congress has demonstrated a total inability to address the problems facing our country.



In my simple mind, simple answers represent more of a general philosophy than an actual game plan with step-by-step actions taken to achieve a specific goal.

I believe in God, but so do billions of other humans. The way we all behave proves there are millions of different ways to express this belief and just as many justifications for bad behavior or seeming beneficence.




