



Chelan Council weighs potential ice rink

CHELAN - Winter is coming for Chelan.

Instead of the non-fictional white-walkers, giants and dragons in the Westeros kingdom (Game of Thrones) however, winter is coming to Chelan in the form of an ice skating rink.

At least that's what Chelan councilwoman Erin McCardle is hoping for within the next couple of years.

"Let's say two to three years," McCardle suggested at the Chelan City Council meeting on Tuesday, July 25, "in terms of coming back with set funding, a business plan, an idea of management and structure and the ability to move forward."

"You know, set expectations low and deliver high," McCardle articulated after council was given a presentation from Hunden Strategic Partners; a consultant group from Chicago brought on to analyze the potential of constructing an ice rink in Chelan.

For the past four months Ice Rink and Town Toyota Owner/ CEO Rob Hunden and Project Manager Michael Montgomery have interviewed various residents and hockey groups in the area to gauge their overall interest. They also reached out to several ice complexes including both the Winthrop

Ice Rink and Town Toyota Center.

Their report concluded that not only would a rink be viable, but also serve as an asset to Lake Chelan that can attract people during the lull winter months.

"As you know, you are a unique community that has

a population that expands quite a bit in the summer but is relatively small in the winter," Hunden began in his opening comment. "This is an opportunity to have an asset that enhances your year round livability, tourism, and

Hospital set, now waiting approval from USDA

CHELAN - Everything for the new hospital is going swimmingly. The vote passed, financial information in order, and the facility was just approved by the State Project Review Committee on Thursday, July 27. (see story page 2)

All that's left is to send in the application to the USDA, which according to Wipfli Director of Strategic and Capital Planning Kelly Arduino, should be a piece of cake.

"The program has about \$7 billion in loans they have made to healthcare organizations, and 75 percent of that to critical access hospitals," Arduino began at the Lake Chelan Community Hospital Board meeting on Tuesday, July 25. "The program has been essential for rural hos-

pitals in need of large renovation projects or replacements, and its rates and terms are very advantageous and could not be attained elsewhere."

Hence the decision to apply for the loan program.

Arduino explained the interest rate is fixed at 3.275 percent with no ongoing or application fees attached.

"The documentation is very standard and keeps legal fees down so you don't have to worry about ongoing covenant," Arduino said.

According to Arduino, the only hinge left is an examined financial forecast from a CPA firm and an environmental assessment, which Wipfli already submitted to the state. After the state is done reviewing the application, Arduino said they will likely "come-

WSP clarifies some issues on new E-DUI law

WASHINGTON - Not even two weeks into the new E-DUI law and residents are already petitioning for some changes regarding some of the secondary offenses.

Some 8,000 commercial drivers and workers alike have banded together in hopes of continuing to drink their coffee or eat a quick bite on their daily commute. The only problem; it's still legal to do so. You only get pulled over if that distraction causes a driver to commit a traffic violation, like crossing the center line or following too closely.

"It is pretty common to sip a coffee or nibble on some fries. Most of us can sip our coffee and stay between the lines," Washington State Patrol Communications Director Kyle Moore said in a Q & A with media members Friday, July 28. "The law does not prohibit any such activity. It just requires that activity does not interfere with the safe operation of the vehicle. If the driver

does commit a traffic offense because the driver is distracted, then they are subject to an additional \$99 fine."

Just because you have a drink or food in your car though, an officer would need to see bad driving and determine that was caused by a distraction to administer the additional fine.

However, should you be pulled over for driving while using an electronic device, a standard \$136 traffic fine will be issued for a first offense with the fine increasing to \$234 for any subsequent offense within the next five years. Any violation will be reported to insurance companies.

According to Federal Motor Carrier Regulations, a Commercial Driving License (CDL) will be disqualified after two or more convictions of any state law on handheld mobile use while operating a Commercial Motor Vehicle (CMV).

Despite initial reports that officers in King and Snohomish county are issu-

State Project Review Committee approves Chelan hospital proposal for GC/CM building method, ensuring cost and scheduling predictability

CHELAN - The State Project Review Committee unanimously approved the proposal by Lake Chelan Community Hospital & Clinics (LCCHC) to use the Construction Manager / General Contractor (GC/CM) building method for the new hospital facility last Thursday, July 27 after they heard an hour-long presentation by the LCCHC team.

With overlapping design and construction phases, the GC/CM collaborative method incorporates the contractor's point of view into the project much sooner than design-bid-build. The contractor is hired early enough to contribute expertise to guide the design process and control the budget. This helps the design phase transition seamlessly into the construction phase and includes better budget control and time savings.

"The review committee members were very supportive that we were pursuing this method," said Barry Leahy, project manager of the new hospital building. This option is an excellent fit for us, because the Chelan valley is small and somewhat isolated from materials and

construction staff. The project will also stretch over two winters, he said, which needs additional consideration.

Using the GC/CM method is for the community's benefit, he continued, because it allows predictability of cost and schedules. "The general contractor will work with all parties from the beginning to give the community comfort in knowing this is going to work."

With Thursday's state committee approval, LCCHC will now work with Dick Bratton, an experienced GC/CM consultant, who will guide the organization through the final selection of the general contractor. Bratton will next submit requests for general contractor proposals. Applicants will be reviewed and finalists interviewed. The plan is to have the contractor on board by Oct. 1, said Leahy.

"We have a great building project team," said Mary Signorelli, LCCHC Board of Commissioners Chair. "And now that we have approval from the State Project Review Committee, we can begin the process of hiring a general contractor. Once this key player is in place, the many facets of putting a final plan together will proceed. We look forward to a smooth and well-crafted process to accomplish this project."

back with some questions and clarifications" before the application goes to Washington D.C for final approval from the national office.

The goal is to have approval by September and lock in the lowest possible interest rate (since it went down from last quarter).

"So we are just waiting for the wheels of USDA machine to move forward and be given the thumbs up," Arduino said. "I don't see any problems with approval, but I don't know what day that will happen either. I have worked on over 50 financing projects and never had one disapproved."

Construction is set to begin early next year.

into spring 2018.

"At this point though, I anticipate we'll be wrapped up with the majority of the work around the first of November," Waligorski stated.

Once the round-a-bout is complete, Waligorski said the shoe-fly detour will be "removed and regraded."

"On the East side we will construct a storm-water detention pond to hand storm-water run off," Waligorski stated. "The West side will be filled in

and a slope reconstructed and seeded."

"The contractor is finishing up underground utility work with water and sewer upgrades. They are also installing electrical wiring for the illumination system and constructing retaining walls along the lake side of the road," Waligorski concluded. "Once this work wraps up they will bring in crushed rock and start pouring concrete curbs and the roundabout will start to take shape."

ing tickets, "the Washington State Patrol (WSP) is enacting a 6-month grace period to give people time to learn about the new law," Moore said. "The WSP wants people to drive safely and comply with the law though and will be issuing warnings which will include printed rack cards that detail the law. Troopers will begin citing motorists if stopped more than once for the same infraction because they have already been educated about the issue."

Officers are not exempt from

the law either and can face stiff punishment should they cause an accident as a result of distracted driving.

WSP is hoping that all the outcry will spark a growing consensus on the issue and curtail most drivers using their cell phone. The state has had some success in keeping drivers to a 95 percent compliance with seat belt usage and has limited the amount of drunk drivers over the past decade.

Woodstock 2017 anniversary concert coming soon to Watson's Aplenhorn Cafe

Event raises funds for Chelan Valley Hope

CHELAN - It's been 48 years since 400,000 people migrated to up-state New York for "three days of peace and music" to attend Woodstock, but every August, the festival seems to live on with several tribute concerts around the country.

Chelan being one of those towns, will carry on the tradition with their own Woodstock festival at Watson's Aplenhorn Cafe on Aug. 26, from 5 to 9:30 p.m.

The event is also a fund-raiser for Chelan Valley Hope (CVH) with all money generated going toward operating funds for CVH.

The concert will feature performances of Woodstock-era

rock from local musicians including Waterdog, Brittany Jean and the Old Friends.

There will also be a costume contest for the most authentic 1969 outfit, most flamboyant and the most creative dressed

patrons.

Food and beverage will be available at the event with festival style seating (bring your own folding chairs or blankets). No coolers or outside food and beverages allowed. There will

also be a raffles and silent auction items at the concert.

is a facility that can be multi-purposed."

In Hunden's vision, the domed ice rink would be used while in the cold winter months. During May through October, the multi-purpose flooring could be utilized to host any number of events from concerts, farmer's markets, dances and other social events to basketball, volleyball and pickle-ball games. Hunden also mentioned the possibility of baseball teams using the area during wet or snowy days in the spring.

In terms of cost, "it is a relatively inexpensive facility at just under \$3 million," Hunden casually insisted, "but it has to have absolute quality ice sheets and has to be well taken care of and groomed."

The reason for this is because hockey teams, the main bread and butter of any ice complex, will only play on a rink that is maintained, NHL regulation size and of top quality."

Luckily for Chelan, being located in the middle of the state carries a beneficial factor as well. "There was a great desire because of the central location," Hunden said. "People like Chelan, and it is east to get to. Wenatchee also said they were interested in events up here and the central location was key. Because you are a destination market, people don't need an excuse to come here."

"As Rob mentioned, we tried to get feedback from complexes, local sports, and regional hockey groups to get their thoughts and they were very consistent (in saying) Chelan is a destination for a future tournament," Montgomery interjected. "You can have teams meet from the east and west side of the state and have a unique covered complex that is on the water. Outdoor hockey is still unique to these teams, and having eight to twelve team tournaments with youth, adult or club hockey are real possibilities."

Out of potential sites, Don Morse Park was recommended because of its close proximity to other commerce and tourism spots in downtown.

According to Hunden, the building would also be seen through, to preserve views because "the lake is for the people."

Although there is a lack of ice in the area, Hunden and Montgomery believe that a new facility will generate interest among local residents and draw people from around the area. However, fostering that hockey interest could take awhile with kids already dedicating their time to other sports.

"You have to start young with leagues and develop the kids at the mite level," Montgomery said, "It builds upon it self because if you start young, you'll develop more of a community. Plus, the Wenatchee Wild mentioned that they want to come here and have training's and clinics to make sure there is an excitement about the sport."

Conservative estimates from Hunden show the complex could host 310 hours of rentals and 81 events a year, generating an estimated 4,673 additional room nights per year and \$24,000 in fiscal impact solely through the lodging tax.

"There are facilities that lose money and ones that make money, we show this as a bit of a loss, but it is minima," Hunden said, pointing at a projected \$135 net operating loss in year one. "But that could be plus or minus \$50,000. The key is not to overstaff it and put people in charge that are committed to maximizing potential and minimizing expense."

Another foreseeable problem is what to do with the current vendors (go-carts, bumper boats and paddle boards) that already occupy the space where a new rink would go.

Council woman McCardle suggested those decisions would come farther down the line. The next step is "building a business plan for the facility and getting local folks involved in the project," McCardle concluded. "I am a realist, we're not saying that we are moving ahead right now, but I would say two to three years."

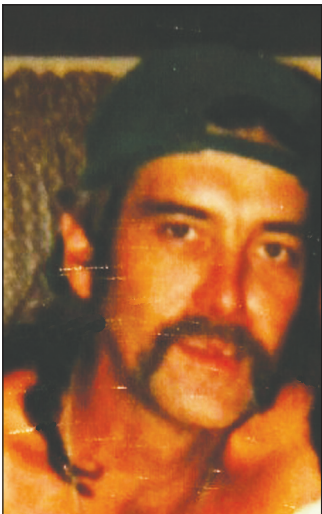

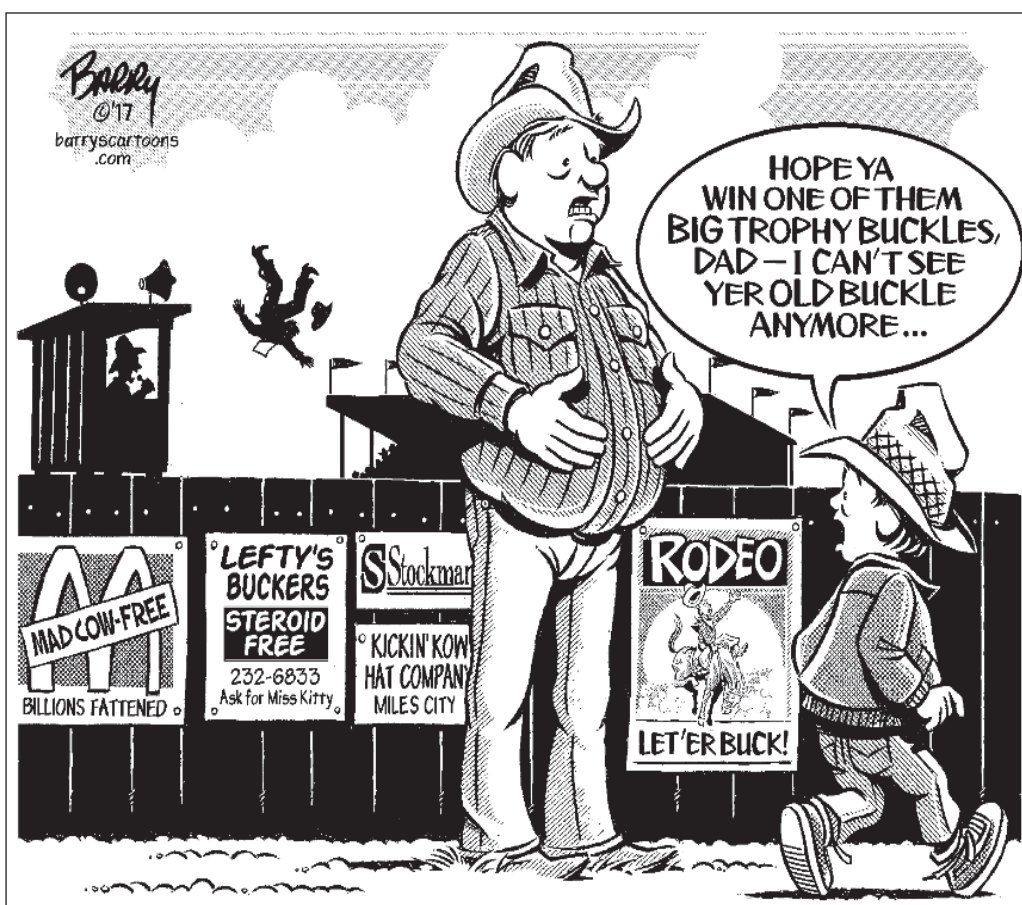

Climate change and science

No matter how much proof is offered that mankind has had minimal or no impact on global temperature, there are those who would still rather believe gross distortions and lies based on science fraud than the truth, wrote environmental scientist Dr. Michael S. Coffman in the Fall edition of Range magazine.

"Today's problem with the man-caused warming hypothesis was that it was never tested to determine if it was true," he explained. "The purpose of the United Nations Intergovernmental Panel on Climate Change (IPCC) was to 'provide the world with a clear scientific view on the current state of knowledge on climate change and its potential environmental and socio-economic impacts.'"

It was a given that CO2 was driving climate change. Any scientist who challenged the "fact" was immediately attacked and isolated by the press. No matter how many experiments showed that solar changes were a far better predictor of global climate change than CO2, the IPCC, Environmental Protection Agency and opposing scientists did all they could to trash and bury contrary theories.

Over time the "proofs" that man was causing global warming have been systematically disproved. One of the worst was the "hockey stick" graph of Dr. Michael E. Mann of Pennsylvania State Univer-

sity. Mann's graph showed a relatively flat temperature for over the past 1,900 years, when it suddenly shot up in the 20th Century. Dr. Coffman contends that Mann used the wrong statistics, which always gave a hockey stick appearance no matter how random the data was. Mann's calculations also ignored the well-established historical event, the Little Ice Age during 1650 to 1710, Coffman wrote.

Mann was recently involved in a Canadian trial, which could have far reaching impact, and has been referred to as the "climate science trial of the century."

Why Scientists Disagree

Dr. Coffman spelled out why scientists disagree on climate change:

- Climate is an interdisciplinary subject requiring insights from many fields of study. Very few scholars have mastery of more than one or two of these disciplines.

- Fundamental uncertainties arise from insufficient observational evidence, disagreements over how to interpret data, and how to set the parameters of models.

- IPCC, created to find and disseminate research finding a human impact on global climate, is not a credible source. It is agenda-driven, a political rather than scientific body, and some allege it is corrupt.

- Climate scientists, like all humans, can be biased. Origins of bias include careerism, grant-seeking, political views,



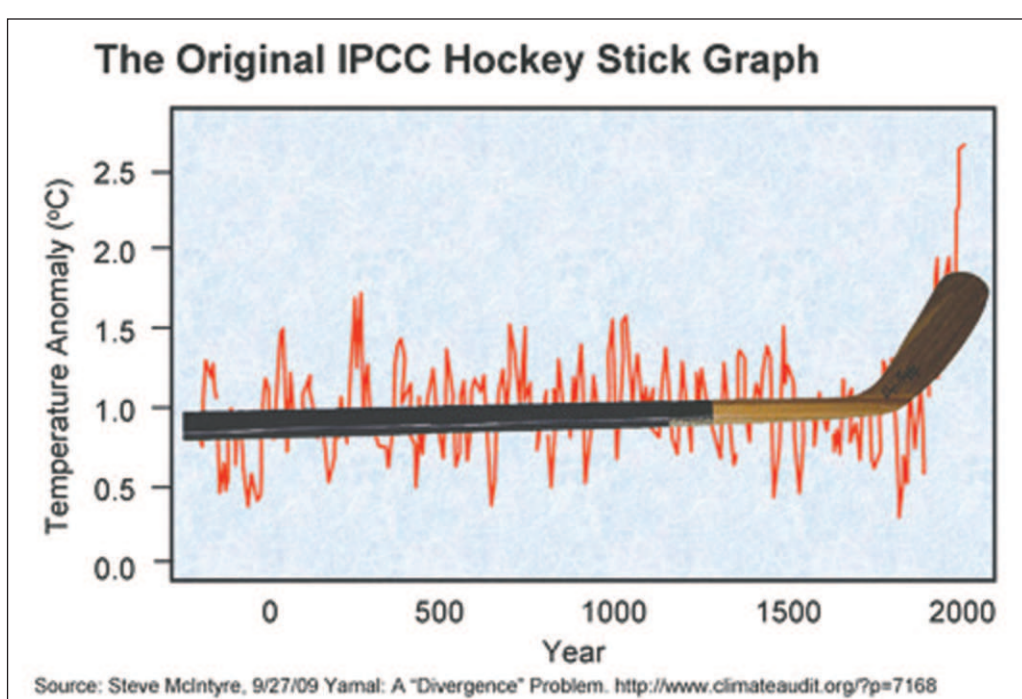

and confirmation bias.

"No consensus exists when it comes to climate science," Dr. Coffman wrote. "The only scientists the world hears from are the ones who toe the party line that mankind is destroying the planet with industrial progress."

Despite the verifiable evidence that warming is not happening, and even when it is, it is primarily caused by solar events, the agenda marches ever forward, Dr. Coffman said. The United States is branded at the international level as the cause of all the trouble and intention-

ally vilified. The truth is that the U.S. is the leader in reducing carbon emissions, which, in fact have plummeted since about 2007 and are now at 1994 levels. As important, as a percentage of total global CO2 emissions, the U.S. will make up a small amount, contrary to prevailing media accounts.

The original IPCC "hockey stick" graph was the centerpiece of Michael Mann's "proof" that mankind was responsible for global warming—research that was discredited because it relied on incorrect statistics. Before then, Mann's information was used many times and by many scientists in other research. When correct data was applied, the hockey stick disappears.

It's All About the Money
The entire man-caused climate change push is nothing more than a tool in the hands of the global elite to redistribute international wealth

that the poor countries want the handouts to be retroactive. Brazil even put forth a proposal for just how the U.S. and other first world nationals could hand over the dough.

Meanwhile, China, which has six of the top 23 most polluted cities on the planet, won't have to reduce carbon emissions until 2030.
