## Chelan City Council approves funding for water quality monitoring on Lake Chelan

**CHELAN** - The Chelan City Council is beginning to take more action toward monitoring the quality of the Lake Chelan after approving a request for \$10,000 from Chelan County for Keep It Blue.

The \$10,000 will add to the \$45,000 that is already funded from multiple agencies including Chelan County, Cascadia Conservation, the Reclamation District and the State Department of Ecology (DOE).

While the council members were all in agreement for funding the program a discussion about how much funding to award would be appropriate.

"Just to sample one component is an annual cost of \$59,000," councilman Skip Morehouse said. "If you follow the study, over the years going back to 2004, they have had very spotty data because they have not had a consistent plan. So Lake Chelan, unlike a lot of other lakes, has no consistent data."

Morehouse has been attending the Lake Chelan Water Quality meetings for the past five years and meeting with various agencies and community members about how to promote water quality in Lake Chelan.

"I think they asked for less because they want a long term plan and are the most active group I've seen. So I am going to suggest we double the amount to \$20,000 for a five year period," Morehouse stated. "Chelan has not taken the lead role in this and we should. People come up here for the lake, and it is our biggest and best resource,

we need to keep it pristine, and the only way to do that is to monitor."

Morehouse said the additional funding would allow Keep it Blue to start building on their program and make it easier to find other partners, knowing the city stepped up.

However, not every council member was in consensus with the proposal.

"I would feel more comfortable if that request came from Mike (Kaputa) and the group that is driving this," councilwoman Erin McCardle responded. "I agree with you, but I would rather see the request come from them so we see what the money is being committed to."

Morehouse reminded council again that testing only one component costs \$59,000 a year.

"For biological testing or if you want to monitor dissolved oxygen, nitrogen or any other, it will cost an additional amount for that probe," Morehouses insisted. "We just have a total lack of scientific information and at some point we have to start doing something. We shouldn't be afraid to do the right thing."

Councilman Ray Dobbs, although supporting Morehouse's

proposal, sided with McCardle, saying he would prefer to approve the original motion and encourage the county to come back with a five year proposal.

"I wouldn't have any trouble with the \$20,000 at that point. I would really like to see them come to us before we do our budget for next year so we can put it in the budget," Dobbs said. "I think everyone here has nothing but support for this."

Morehouse then withdrew his previous motion before making a similar one, that would award the \$20,000 for a five year period, contingent on a five year proposal that would describe where the money would go.

Council voted down the motion on the floor before requesting a third from Morehouse that would tie in an inter-local agreement with the county with a proposal for a five year plan at \$20,000 per year.

Council passed the motion unanimously.

The next Chelan City Council meeting is scheduled for Tuesday, June 13 at 6 p.m.

Johnson - got a hands-on science lesson as they navigated around the islands while collecting data samples to help better understand the Sound and its larger marine environment.

Manson was awarded the trip after receiving funding through a \$1,100 grant from the Community Foundation of NCW.

"Our program makes it easier for students to imagine what it would be like to be a research scientist or work in the maritime sector," Salish Education Director Dan Hannafious said. "Kids have the chance to get excited about science and math

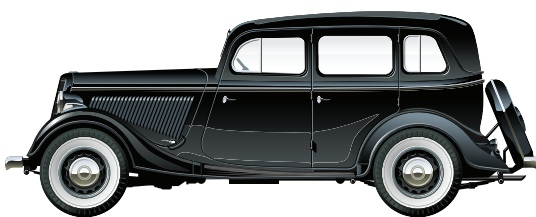
when it's taught in an environment where those skills are put to everyday use."

## Pre-tagging, weighing for market livestock begins June 3

CHELAN - CASHMERE - It is time once again for the Chelan County Fair Pre-tagging and weighing for all market livestock that is to be entered in the Chelan County Fair. There are two options for exhibitors.

The first option is to bring fair animals is Saturday, June 3 at the Chelan Rustler's Rodeo Arena in Chelan on Union Valley Road. Steers will be weighed and tagged 9-10 a.m.; and, lambs and meat goats will be weighed and tagged between 10 a.m. and 1 p.m.

The second option is to bring fair animals on Saturday June 10 to the Chelan County Fairgrounds and Expo Center in Cashmere. Steers will be weighed and tagged 9-10 a.m.; and, lambs and meat goats will be weighed and tagged between 10 a.m. and 1 p.m..

Due to the persistence of PED (Porcine Epidemic Diarrhea) throughout the swine industry outside the state of Washington and that some pigs shown at the Chelan County Fair may come from out of state, pigs will not be weighed and tagged in June. Instead 4-H Club leaders and FFA Advisor will need to provide the Livestock Committee at list of exhibitors and the point of origin on the pre-weigh and tagging date. All animals coming from out of state will need to provide

a health certificate per the Washington State Veterinarian at the weigh-in at the fair. Numbers will be assigned to exhibitors and specific pigs at that time. It will be the responsibility of the leaders/advisors to tag the pigs in their club/chapter. All pigs are susceptible to the PED virus, however it has only proved fatal to suckling pigs under two weeks of age. All exhibitors are advised to practice sound biosecurity measures in their production operations. Once again, please do not bring your weaner pigs to be weighed in in June.

At the Fairgrounds, all exhibitors will enter through the Rodeo Gate on Kimber Road and exit onto Wescott Drive through the livestock gate.

At the Chelan Weigh-in, exhibitors are asked to enter the North entrance and exit through the South Entrance off of Union Valley Road

Exhibitors must have market animals pre-tagged and weighed to participate in the market animal classes and livestock sale at the fair. Exhibitors may choose to not pre-weigh their animals but this will exclude them from the Rate of Gain and Supreme Showman Classes. Exhibitors may pre-tag and weigh in up to two market steers, three market hogs, three meat goats and three market lambs. For the 2017 Chelan County Fair, exhibitors may sell one market animal. At fair they may only weigh in and enter

three market animals. This is from any combination of beef, sheep, meat goats or swine.

All animals that are pre-weighed will be entered into the Rate of Gain Class. This class is designed to encourage exhibitors to monitor and manage their market animal's gain throughout the production period.

Animals that don't make market weight will not qualify for this class or premium points. Criteria will be established for each species to determine the rate of gain for blue, red, and white ribbon and premiums.

All exhibitors who participate in market animal classes, fitting and showing classes, and rate of gain classes are entered into the supreme showman class. The supreme showman will be determined by an aggregate score from all three classes. Premium points, ribbons, rosettes, and trophies will be awarded. The overall 4-H and FFA Supreme Showman will receive trophy buckles.

The Supreme Showman will be determined by how the individual exhibitor scores on rate of gain, market, fitting and showing classes. Exhibitors will be ranked from top to bottom in each area.

## Chelan couple to 'Charge Across Washington' via U.S. 2 EV Station Network

Showcasing the electric vehicle charging station network developed by Plug-In North Central Washington, Randy and Anne Brooks will embark on a "Charge Across Washington" June 7 and 8.

The historic US Route 2 connects Everett in the west and Spokane in the east with 326 miles of highway - and it is now fully electrified. By joining the Cascade Scenic Loop and the Stevens Pass Greenway, electric vehicles can now drive from one end of Washington to the other. But as most EV owners will tell you, it's more about the journey than the destination.

Starting in Everett on June 7, Randy and Anne Brooks of Chelan will spend two days driving a Nissan Leaf - nicknamed "Bean" - to Spokane via

US 2. Charging stops along the way include Sultan, Skykomish, Coles Corner, Leavenworth, Wenatchee, Waterville, Coulee City and Davenport, using some of the charging stations Plug-In NCW developed and installed.

Each charging stop will include educational opportunities for locals to see, ride in and talk to owners of EVs, from Volts, to Leafs, to Teslas. Charge Across Washington is designed to validate that small-battery EVs can in fact drive across Washington. And bring a lot of fun along the way.

"While this drive will demonstrate that an 80 mile-per-charge EV can now drive across Washington, it will also be the catalyst for mini-EV car shows called "Plug In" events at each charging stop," said Jack Anderson, committee chair for Plug-In NCW. "We want to invite local residents

to come see EVs and talk with drivers. They may even get a ride."

Anne Brooks serves as secretary on the Plug-In NCW committee. Plug-In NCW is operated by the NCW Economic Development District with the intention of advocating electrification of surface transportation and other processes that currently depend on fossil fuels, and installing charging stations at host sites throughout North Central Washington. All to encourage EV tourism to the area.

"The 2016 Nissan Leaf has the larger 30kw Lithium battery with about 100 miles in a full charge," Brooks said. "After three electric cars, we've learned some things that may be helpful to prospective buyers when they get behind their first EV steering wheel."

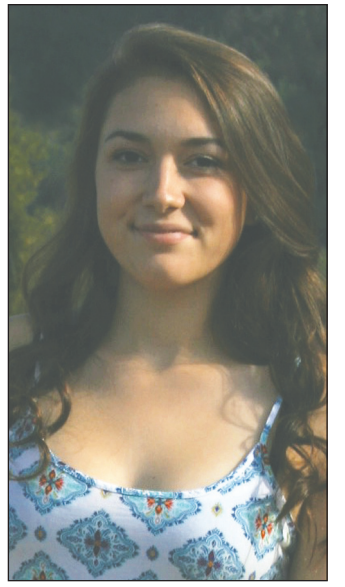

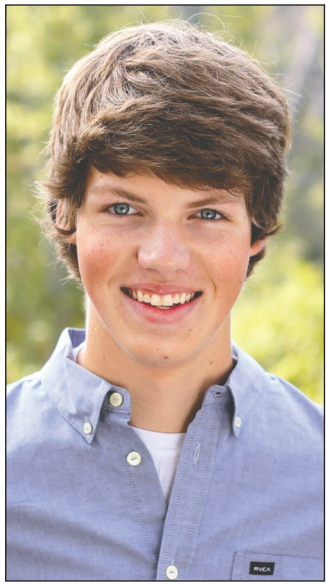

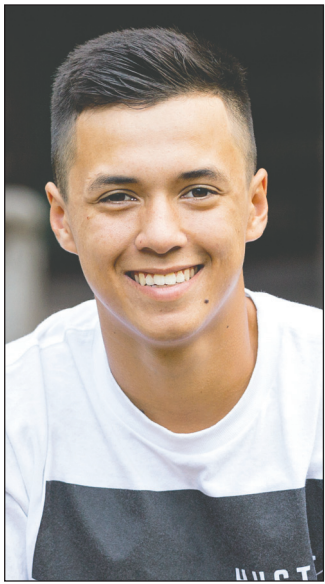

# Chelan, Manson Entiat athletes compete at State in Cheney

CHENEY - For any athlete, getting the opportunity to compete in front of thousands of screaming fans is a shared goal. It means that you have risen to the top of your athletic field.

Although a large crowd is not synonymous typically with track during the regular season, it surely is once you get to State.

This past memorial weekend Entiat, Manson and Chelan sent several of their best to compete against the top track stars in the state at the 1A, 1B and 2B State Track Meet in Cheney.

It was a blistering couple of days, but all three teams competed admirably in each of their respective events.

## Chelan

The Goats had five kids place in their respective events including:

Allie Barnes - 8th place in

800m (2:26.32)

Sterling Gordon-Fournier - 3rd place in Javelin (178 feet)

Dillon Dawson - 7th place in the 800m (2:00.11) and 15th in the 1600m (4:42.74)

Ava Dickes - 4th place in the 400m (59.05) New Chelan High School Record

Merek Palazzo - 2nd place in 3200m (9:29.08) New Chelan High School Record and 3rd in the 1600m (4:22.75)

After not making it to state a year prior, Gordon-Fournier was ecstatic with his third place finish in the javelin with a throw of 178 feet, 8 shy of his personal best he set earlier this year.

"I'm feeling very happy," Gordon-Fournier said after receiving his third place medal on Saturday, May 27. "I didn't make it last year to state and that was not good, so I worked my butt off over the past year and placing at state today is a big accomplishment."

Gordon-Fournier said he made the quick transition

after working out his legs everyday, training his upper body and a lot of yoga.

Chelan also had two boy's relay teams that qualified for state and past the pre-lims on Saturday, but both fell short in their performance on the second day and didn't place.

"It was great being able to watch a ton of great athletes from our great state," head coach Erik Romero said after the meet. "I am proud of how our athletes performed, especially the ones that had to run in the preliminary qualifying heats to make it to the second day. Our distance runners did a very good job at state this year and will be missed. I am proud to say that this year was a great year for all our kids. We had so many District Champions and our boys team was CTL District Champs again."

Although the Goats are losing a bevy of their top seniors, coach Romero is confident in the young bunch he will have for next year.

"I hope that we, as a coach-

ing staff, can continue to work with our young athletes and bring some hardware back in the coming years," coach Romero concluded in his post meet report. "I look forward to a great year next year and the opportunity to watch five seniors next year at the collegiate level competing for their respective college programs."

## Manson

The Trojans were not to be undone either with their production either as several athletes placed or achieved personal bests.

Spencer Ward led the Trojans in medals after earning a medal as apart of the 4x100m relay along with Joe Strecker, Eduardo Escalera and Mason Walters, the 4x400m relay along with Cody McClanahan, Escalera and Walters and as sixth place finish in the boys 400m. Ward was barely edged out in his 100m heat with a time of 11.51. He just missed qualifying for the finals by .03

seconds.

Mason Cameron finished 13th in the shot put, although he did so with a personal best throw, and 13th in the discus.

"It wasn't the finish he was probably hoping for, but he won multiple league and district championships in the past couple of years," head coach Kurt Toolson wrote in his post match report.

Freshman Connor Torgesen placed 8th in his heat for the 800m and did not make it out of qualifying.

"Still it was a remarkable season for Connor, who has had one of the most successful seasons as a freshman that I have seen," coach Toolson stated.

Mason Walters finished in 12th after topping out at 5'10" in a stacked field for high jump, as nine boys jumped six feet or higher.

"We say goodbye to an outstanding class of seniors. If you look at the Manson school record books you will find their names popping all over

the charts," coach Toolson concluded. "Congragulations on leaving behind a distinguished legacy, you will all be missed, but not forgotten."

## Entiat

The big event for the Tigers was hurdles as Blake Duncan got sixth place in the 110m hurdles with a time of (17.27) and Natalya Paz took third in the 100m hurdles with a time of (17.15) and third in the 300m hurdles with a time of (48.68).

Ronnie Parks had a nice showing as well as he placed 8th in the 100m with a time of (12.33). Parks also finished first in his heat in the triple jump with a distance of 40 feet 4.5 inches, but never improved his distance and finished 8th in the finals. Parks will now look to improve over the next year before getting a shot at redemption next season.

CHELAN - The Goats had a historic weekend at the 1A State Tennis Tournament in Yakima, with ever Chelan entry (3) medaling and the team finishing second overall.

- Bryce Robison finished in 7th place in singles.

- Henry Elsner/Rylan Anderson finished 6th in doubles.

- Collin Hendricks/Micah Larson finished 5th place in doubles.

Chelan was among three other schools (University Prep and Charles Wright

Academy) who had five athletes in the tournament, and all three finished in the top-three schools.

Robison opened against Malachi Gumpston from Granger and didn't break a sweat as he sailed to a 6-0, 6-0 win. Although Robison lost his next match to an exchange student from Riverside, he won a third match on Friday, May 26 to advance to the medal round.

It is not the responsibility of the media to make or break a President or a particular political party. It is their job to accurately report on the issues of the day.

Accurate means complete. The problem often isn't that the stories are factually inaccurate. The problem is that they are often incomplete or ripe with personal opinion and as a result convey a message that is inaccurate or leaves the listener or reader with a false impression.

For example, this last week the President was on a tour around the world to convey his message that things have changed in Washington D.C.

The President was often direct in his remarks to allies

and foreign leaders but the majority of the media found it important to describe his remarks as rude or out of place. But the most ridiculous reporting came when they couldn't resist the opportunity to suggest there was growing discord between the President and First Lady because it appeared she "slapped his hand away" as they approached the plane.

Are you kidding me? Really? There were important foreign relations issues being confronted by the President and yet the media found a possible marital spat more important than reporting on the President's message to foreign leaders.

NPR lead off their report this way, "President Trump has had, according to the White House, a successful maiden trip outside the U.S. But the bad news is he has to come home. 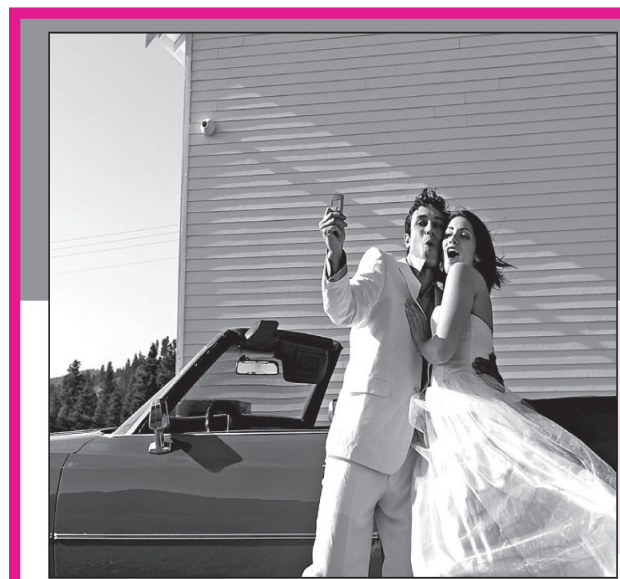
