CHELAN - It's April, which means - other than the start of baseball season - that it is Earth month and a time to show a commitment to a healthy and sustainable world.

The first Earth Day was in the Spring of 1970 after U.S. Senator Gaylord Nelson envisioned the idea in 1969. Nelson was inspired by recent teach-ins being held in protest of the Vietnam war and decided to do the same for the environment.

"It suddenly occurred to me," Nelson said in a speech years later, "Why not have a nationwide teach-in on the environment? In a speech at Seattle in September, I formally announced that there would be a national environmental teach-in sometime in the spring of 1970."

The first Earth Day was a momentous event, with over 20 million people taking part on April 22, 1970. It led to the eventual passage of the Clean Water Act, the Clean Air Act and the Endangered Species Act.

To commemorate Earth Day Chelan is hosting the 28th annual Lake Chelan Earth Day Fair at Riverwalk Park from 9 a.m. to 4 p.m., on Saturday, April 15.

Over the years the fair has gone through quite a change. "It used to be more flea market booths, first come-first served," Earth Day Fair Committee Co-chair Anne Brooks said.

Chelan City Council gets ready for summer, might punt decision on water line

CHELAN - The Chelan City Council addressed a few house-keeping issues in order to get ready for the Summer season in their regular meeting on Tuesday, March 28.

- Pickleball / tennis courts

One of the approved 2017 Capital Projects was to resurface the tennis / pickleball courts at Don Morse Park.

"There's huge cracks in it, so we temporarily patched them to make things playable," Chelan Parks Director Karen Sargeant said. "They were a big hit though, so we would like to get them resurfaced. The materials cost has increased since the budget was approved, so I am requesting an increase of \$600 to cover the cost."

Sergeant stated though that the pickleball group, who have continued to meet regularly throughout the winter, offered to reimburse the city for the cost of the resurfacing. The motion was approved unanimously.

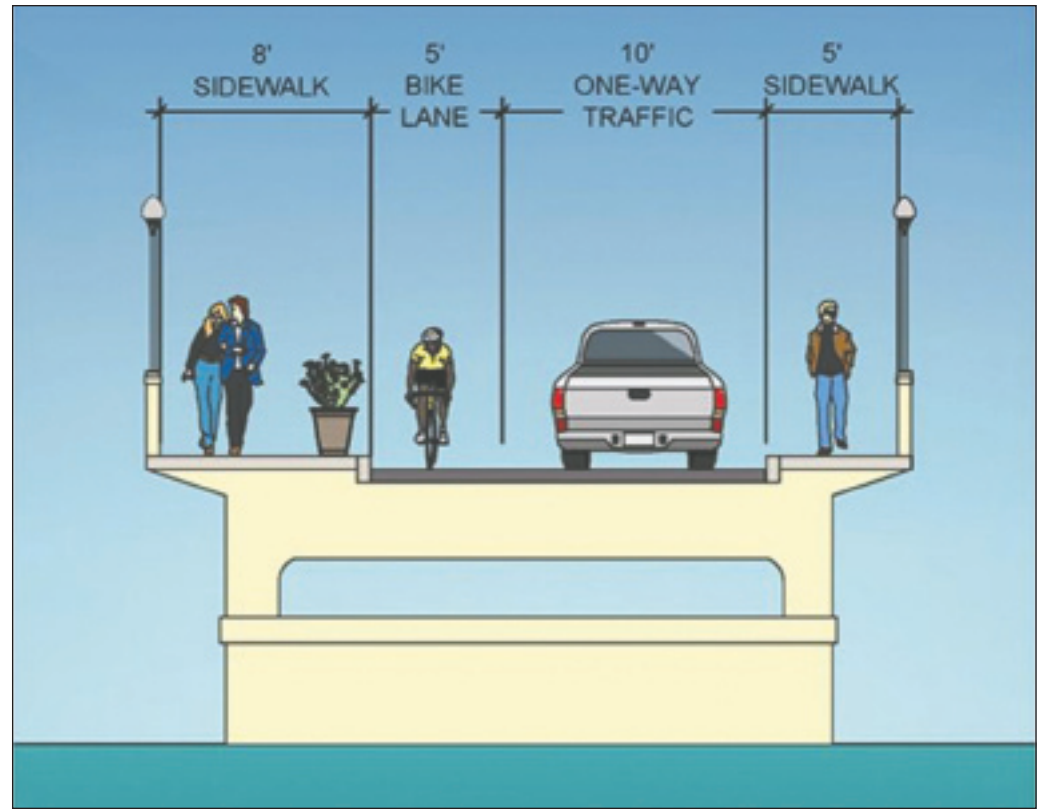
- Facilities Maintenance Worker

The Parks Department received approval from the Council for a new seasonal Facilities Maintenance Worker position. In order to make the evening shift more appealing, Sargeant proposed increasing the wage by \$.25 to make it \$13.50 per hour. The increase will make the wage equal with the day shift.

"I don't know why there was a difference between the two, but this will equal them out and hopefully draw some candidates for the evening shift," Sargeant explained.

The motion was approved unanimously.

- Woodin Avenue Bridge

Chelan Public Works Director Dwayne Van Epps gave an administrative update on the Woodin Avenue Bridge project. Preliminary renovation work will begin in April.

"What I would like to do is develop a strategy of working in three enhancements. Widening the bridge and pedestrian area and traffic enhancements adjacent to the bridge," Van Epps said. "I want to have the design compartmentalized in units so that it could be executed based on the funds we are able to acquire for the project on the whole."

"I strongly recommend that we commit to that style of design and strategy," Van Epps insisted.

- Airport waterline extension

In the search for funding, the City applied for a loan with loan forgiveness through the Drinking Water State Revolving Loan Fund (DWSRL) and the Washington Department of Health (DOH). The application was for \$6 million with a request for \$3 million in loan forgiveness, but in January, the City was notified that \$3 million was the total award with zero loan forgiveness. Since the return came out, the City has been weighing its options on whether to accept or deny the loan.

Chelan City Administrator Mike Jackson indicated that if the city rejected the loan, they could re-apply for the entire

\$6 million in a future funding cycle, however, their chances of improving their score are slim. Chelan ranked 14th out of 29 projects submitted.

Either way, the city would have to approve a new water plan, since the current one expired this past December before re-applying. If the city refuses the current loan, they won't be able to reapply likely until 2018 for 2019 funding.

Since there isn't a rush on accepting the loan, the City decided to wait to make a decision until a later meeting.

The next City Council meeting is April 25 at 6 p.m.

MANSON - On Saturday, March 18, Manson's Knowledge Bowl team battled against

a very tough pool of 2B competition (18 2B teams qualified from around the State) at the Washington State Knowledge Bowl Tournament at Arlington High School. The pool of com-

petition was split into two divisions (nine teams in each division). The preliminary rounds began with a rigorous written test and then proceeded with four intense oral rounds. At the end of the preliminary rounds, the top nine teams from both divisions moved onto the semi-finals. Manson pushed through and made it to the semi-finals.

The semi-final and champion round were fast-paced and electric. In the semi-finals, Manson battled against Tonasket, a juggernaut in NCW region, and Harrison Prep. Tonasket won the round with Manson taking second and Harrison Prep taking third. In the championship round, Manson moved into the 4th-6th place bracket with Ocasta and Soap Lake. It was a close round between the three teams with Ocasta taking 4th, Soap Lake (5th) and Manson pulling off 6th place.

Overall the NCW 4A, 1A, and 2B teams dominated the other State teams. 4A: Moses Lake (1st place), Wenatchee (3rd); 1A: Cashmere (1st place), Okanogan (2nd place), and Cascade (3rd place); 2B: Liberty Bell (1st place), Tonasket (3rd), Soap Lake (5th place), and Manson (6th place)

"We now have about 100 booths with reservations required and bringing in more educational exhibitors involving local businesses, agencies and organizations and exhibitors with over 1500 attendees. We also have over 20 local folks on our team/committee who coordinate areas of the fair."

Overall, Brooks believed their teams efforts have helped the citizens in the valley become more conscious of their environmental impact.

Their website, chelanearthdayfair.org has information about the Fair and also features tips and on how you can save the planet, 50 ways to reuse your garbage and a video about the global plastic epidemic.

When asked about which tips the committee practices, Brooks said "most of them". She said the committee does everything from recycling and composting to buying local, walking and owning electric and hybrid vehicles.

According to Brooks, the easiest thing someone can do to help out is "reduce, reuse, recycle and buy local."

To help fight the plastic crisis, which is slowly consuming our Oceans as individual plastic pieces now outnumber sea life 6-to-1, Brooks said there will be signs around the Fair this year suggesting ways that we can individually reduce our plastic use.

In addition to the fair, on Earth Day, Chelan Earth Day Fair organizers and local orchardist Scott Beaton will hold his 23rd annual Chelan Litter Cleanup from 8:30 a.m. to 11:30 a.m., with local sixth graders

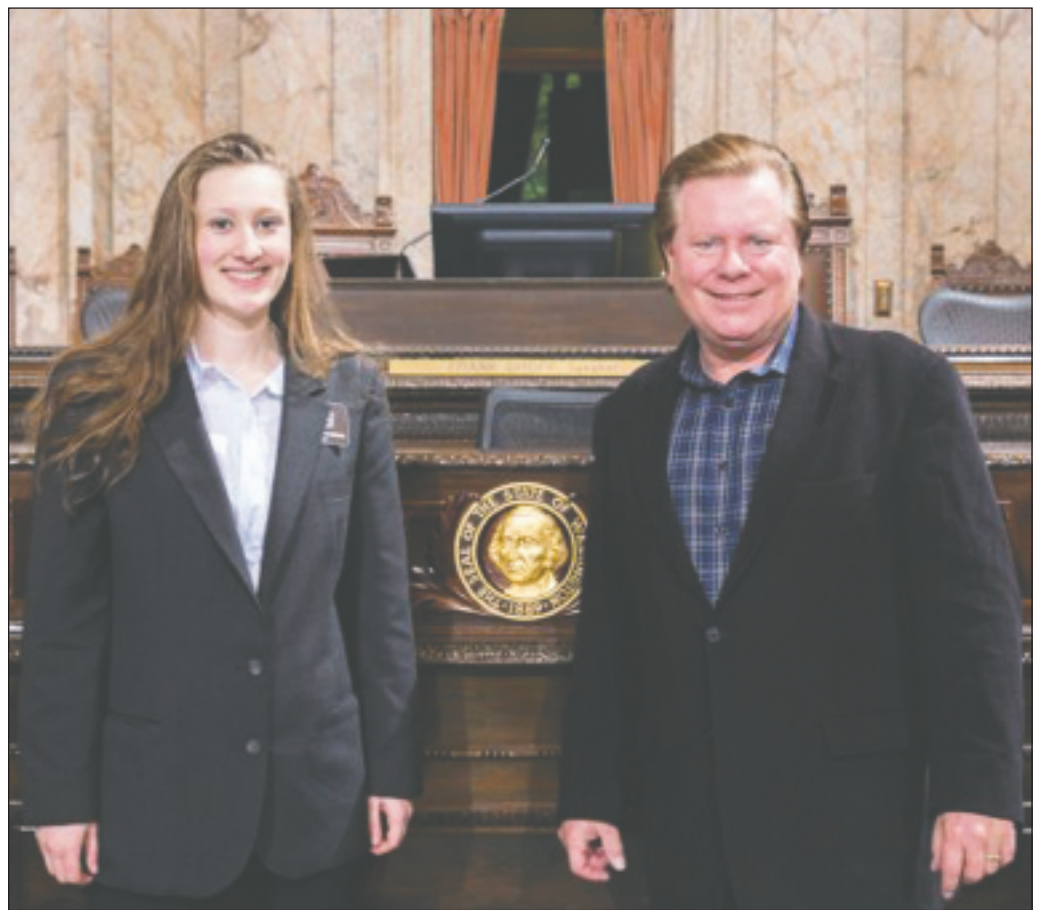

It was a good decision. This past winter my husband died and I was able to sleep 11 adult relatives who

needed privacy of their own rooms. The modern kitchen provided conveniences for preparing food for 18 people. Our decision 12 years earlier to build new allowed for the changes that had taken place in our family needs.

This scenario parallels the decision that Chelan citizens must make on the New Chelan

Hospital Bond Issue. Forty-five years ago Chelan residents bonded themselves with taxes to build a hospital that would provide for future needs of the community. That hospital has been upgraded and used quite well, but it's old and in need of more than a remodel. We should remember that a remodeled hospital will still be

an old hospital with more aging problems in the future. It's our turn to "pay it forward" and build a modern hospital that will provide the space needed for growth and future medical needs. Vote YES for a new hospital.

Save our family farms

Dear Editor,

I am a lifelong resident of Chelan County. I am an owner of one of the nearly 40 cannabis farms Chelan County officials seek to shut down by regulating us out of business. Our farm employs eight to ten of the over 600 people county officials are forcing out of a job. Our farm is two generations of family owned and operated. We have lived in the area of our farm for 27 years. We have great relationships with our neighbors. We have used all our resources, including two full years of our lives without a salary, to build our farm

with the American Dream of the opportunity for success. A shutdown of our farm, which the proposed regulations shuts every farm down, would force three members of my family to file for bankruptcy, including myself. We would lose just about everything. It would ruin our credibility and it would turn our world upside down. There are about 40 other farms with similar stories. A shutdown could force 50-100 people into bankruptcy. Chelan County officials approved, permitted and allowed us to build and operate our farms at our locations. Now they are trying to take that away. What

does that say of them? Should Chelan County commissioners let a few select people convince them to bankrupt that many honest, hardworking Chelan County residents? Do not forget about the 600 people forced out of a job in the midst of 600 jobs already lost at Alcoa, and more jobs lost at Hastings, Staples and many other local businesses shutting down. Grandfathering existing farms forces no one into bankruptcy. Chelan County is an agricultural community. Along with agriculture comes offsetting smells. We live with it because it is our culture. Everyone understands the

gripe, but it is not the only gripe involving agriculture in Chelan County. Chelan County's Code of the West Pg. 8 Sec. 5.6 states: Agriculture is an important business in Chelan County. If you choose to live among the orchards, farms and ranches of our rural countryside, do not expect county government to intervene in the normal day-to-day operations of your agribusiness neighbors. In fact, Washington has "Right to Farm" legislation that protects farmers and ranchers from nuisance and liability lawsuits. It enables them to continue producing food and fiber. Well, county

government is intervening in the normal day-to-day operations of agribusiness neighbors. It is complete hypocrisy.

National Committee to Abuse while profit off Athletes

What the acronym really stands for

Slavery might have been abolished a long time ago, but it seems that college athletics was one caveat to law.

This is illustrated by the continuous exploitation of our college athletes in order to make exorbitant amounts of money off of them with little to no compensation. After all, that is what capitalism is all about right? Obtain a profit at all costs.

Don't let the amateur non-profit designation fool you, the NCAA is big league money. In fact, just the television ad revenue from the 2014 NCAA Tournament totaled \$1.13 billion. That isn't enough though. No, the NCAA in

2009 decided they needed to increase their revenues in the Final Four by switching from regular basketball stadiums to NFL stadiums. The attendance in the 2008 National Championship was 43,256. Last year's attendance was listed at 75,505. Why sell 43,000 tickets when you can sell nearly double?

So don't be mistaken, the NCAA is a billion dollar corporation and involved in the money-grab business.

As a gesture of gratitude, but more-so a result of a February 2017 lawsuit, the NCAA will pay 40,000 athletes from 11 conferences between \$5,000

and \$7,000 each for food and the cost of living. Keep in mind this was fought tooth-and-nail from the NCAA side to not give the athletes anything.

This comes just two years after the NCAA conducted a study and found that 80 percent of college basketball players in the top conferences, live below the poverty line despite full ride scholarships. Many of these athletes reported not being able to afford transportation at home and had trouble paying for food and books. In the same study, Duke basketball players - one of the premier basketball programs - were valued at \$1,025,656 each for what they bring in for the University. The average team member lived \$732 above the poverty line. This all while their coach is among the top paid employee at the University.

If you are asking yourself, why don't these athletes get

a side job?

First, a lot do because they need at least some extra money. But really how many hours do you think they are able to work? On average, college athletes practice around 30 hours per week. Keep in mind that is just practice, it doesn't take into account all the time they spend doing extra work either on the field or in the weight-room, time spent doing homework or with a tutor - which are more and more becoming mandatory for college athletes - or in class. Still think they can balance all of that with a little side job and still afford to pay for their own food, books, clothes or cost of living?

And you wonder why there are so many scandals with players receiving money/benefits from coaches and boosters? That actually happens a lot more than what is known or reported. Of course broke, over-worked teenagers

are going to accept money, food or clothes if offered from a booster.

But these guys are going to go pro right? They'll make enough money to cover what they lost in college, I mean the average NBA salary this year was \$6.2 million. Unfortunately that theory doesn't match up with the numbers. On average only a little more than one percent of college players make it to the pro's in their respective sport.

The NCAA runs quite a brilliant scheme. Did you know they even invented the term 'student-athlete' so they could fight insurance claims for injured football players. Pretty slick, huh?

But that seems quite obvious to me. The issue that needs to be investigated deeper is the discrepancy between black men that are full-time degree-seeking undergraduate students and black men that are on the

athletic teams. For example, a 2010 study from the Penn Graduate School of Education found that in the big six NCAA conferences (ACC, Big East, Big Ten, Big 12, Pac 12 and SEC) between 2007 and 2010, Black men were 2.8 percent of full-time degree seeking students but on 57 percent of the football teams and 64.3 percent of basketball teams.

To me that says that these top and prestigious Universities, which already charge an arm and a leg for tuition, won't admit black students unless they can exploit them.

That is a serious problem.

"If you watch us take batting or infield, we think we can go out and beat the Yankees," coach Papasadero unwaveringly stated, "then when the game comes around, I don't know if it is nerves or inexperience, but we seem to have difficulty with that. Our kids are working hard though so I think the light switch will go on soon."

Now the Goats just need to find some consistency and they will be alright.

"Offensive, defensive and on the mound, we have have

good games and bad games in all three," coach Papasadero said. "We need to take what we learn on the practice field to the game. It is a celebration when you get to show off what you do in practice, and there is just a disconnect right now, but it is going to happen. I don't have the secret potion, but we are sure trying."

Another positive takeaway is that the kids seem to be all in for the season, evident by an optional practice over spring break in which everyone showed up to get some work in.

"I wasn't surprised, but

that really shows me how much they care and how much they are all in this together," coach Papasadero stated enthusiastically.

The Goats will look to capitalize on their momentum in their next game on Friday, April 14 against Okanogan, before returning for a double header at home against Nooksack Valley on Saturday, April 15. First pitch for the game on Friday is 3 p.m. and 11 a.m. on Saturday.

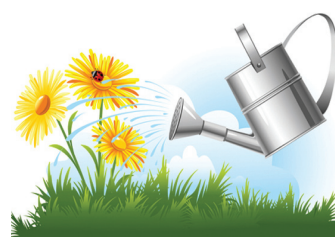

Good fire planned on over 9,000 acres across forest

CHELAN - ENTIAT - Beginning in April, firefighters on the Okanogan-Wenatchee National Forest will once again bring good fire back to the dry, fire-adapted Cascade landscape. Excluded from the ecosystem for nearly 100 years, frequent, low-intensity fire is essential for healthy forests and better protected communities. "It's time to put fire to work for us" said Deputy Forest Supervisor, Jason Kuiken. "In an era of destructive megafires, increasing prescribed fire is a cost-effective, proactive part of the restoration solution."

While more than 9,000 acres are planned this spring, fewer acres may be completed if conditions are not favorable. Conditions include correct tempera-

ture, wind, fuel moisture and ventilation for smoke. When these criteria are met, firefighters implement, monitor, and patrol each burn to ensure it meets forest health and public safety goals including air quality.

"Air quality and healthy forests matter to all of us" added Kuiken. "Before each and every burn, we work closely with air quality officials to balance smoke impacts near communities with the good fire this landscape desperately needs."

State senate would fund \$80 million in balanced investments for outdoor recreation and conservation

OLYMPIA - The Senate capital construction budget released recently includes \$80 million in funding for the Washington Wildlife and Recreation Program (WWRP). While falling short of the \$100 million included in Governor Insee's budget, the Senate's proposed healthy program level builds on the legislature's recent bi-

partisan efforts to update this nationally recognized program to meet current needs.

At this funding level, the legislature would fund 102 of the 220 projects proposed for this biennium.

"The Washington Wildlife and Recreation Coalition is pleased the Senate honored the program's balanced approach to funding the highest competitively ranked habitat conservation and outdoor recreation projects," said Coalition Board Chair Deborah Jensen. "These

investments are vital for securing recreational access for hikers, hunters, anglers and others, and ensuring Washington remains such a special place where people choose to live, work, and recreate in our great outdoors."

The WWRP is the state's premier grant program for outdoor recreation and the preservation of public lands. Since the program was founded in 1989, the WWRP has successfully leveraged over \$1.3 billion in public and private investments

for more than 1,200 projects, including iconic landscapes, state and local parks, farms, trails, and habitat that Washingtonians treasure and depend on.

In 2015, the Recreation and Conservation Office (RCO) performed a detailed review of the WWRP to update the program. As a result, in 2016, the Governor signed into law SB 6227, a bipartisan bill that shifted program funding toward recreation and renovation, development, and restoration

of state-owned conservation lands. Further updates made the WWRP more transparent, accountable, and accessible to underserved communities. The Senate proposed bipartisan capital budget shows renewed commitment to the WWRP as defined in statute.

With Washington's ongoing population surge, protecting and creating public spaces has never been more important. Along with generating \$22.5 billion for the state's economy and supporting over 227,000

jobs, outdoor recreation offers myriad health and wellness benefits.

The Coalition recently collected signatures from thousands statewide in support of \$120 million for WWRP in the next biennium. More than 140 organizations and opinion leaders and over 1,100 individuals signed the letter of support, demonstrating how important this program is to Washingtonians across our beautiful state.

Forest road conditions postpone firewood cutting permit sales

WENATCHEE - National Forests provide so much—clean air, water, jobs, food, wood, and more. Each year, thousands of people heat their homes with firewood gathered from the Okanogan-Wenatchee National Forest. As snow melts from valley bottoms many people are antsy to go into the woods to resupply their firewood piles.

Due to the record snow-pack, state-wide it's 120 percent of normal according to Department of Ecology's website, most national forest roads remain snow covered and not accessible via wheeled vehicles.

"Permits for gathering firewood from the Tonasket Ranger District are usually available for purchase beginning April 1," said Tonasket District Ranger Matt Reidy. "This year, though, there is still a lot of snow on forest roads and they are impass-

able for wheeled vehicles." Currently, that is the situation across most of the Okanogan-Wenatchee National Forest.

"As soon as the roads can be opened to wheeled vehicles without damage to the roadbed, we will begin selling woodcutting permits," Reidy said.

Ranger district personnel across the forest will assess road conditions as snow melts off. Although the first day of spring has past, winter-like conditions

still exist in the forest so it may take a while for roads to melt out and become firm enough to support motor vehicle use.

"Our normal woodcutting season is May 1 through Dec 31," said Methow Valley District Ranger Mike Liu. "We may open certain areas a little early this year because winter logging operations plowed out certain roads and they are melting and drying out faster as a result, but all other areas are still snow covered."

In past years, depending

upon road and weather conditions, woodcutting permits became available for sale starting as early as April 1 on some ranger districts, but generally May 1 is the date they are sold at most forest offices.

Depending upon road and weather conditions, woodcutting permits will be sold starting mid to late April on the Tonasket and Cle Elum Ranger Districts. Woodcutting permits will be sold starting May 1 at all other Okanogan-Wenatchee National Forest ranger sta-

tions, headquarters office and Forest Service office at the Omak Visitor Center.

Forest users are encouraged to contact local ranger district offices for information on current road conditions and the woodcutting permit program. Information is also available on the forest's website at www.fs.usda.gov/okawen.
