## Frontage ULID dead after Bob Jankelson pulls support for project

CHELAN - Well, the people won this battle.

The Bear Mountain Frontage Utility Local Improvement District (ULID) was officially shut down last week after former Bear Mountain board member and Tsilian Cellars Owner Bob Jankelson withdrew his support for the ULID, effectively giving the lakefront property owners the 40 percent land area needed to reject the ULID.

Jankelson originally was in favor of the ULID but with-

drew his support on Friday after sending an email to Bear Mountain homeowners.

"After protestations of potential stakeholders, it is obvious the political sentiments and climate are averse to undertaking such an ambitious project at this time," Jankelson wrote in the email.

The proposal would have stuck lakefront property owners with a \$16,500 bill to help finance the construction of a \$2.5 million project to extend the municipal waterline to homes in Hawks Meadow/Hawks Ridge and some parcels near the Bear Mountain Golf

Course while installing fire flow for lakefront owners.

When the proposal was announced, lakefront property owners, who already have water, were furious and demanded the ULID to be voted down. However, the way the annexation was drawn, they wouldn't be able to stop the process without the help of Jankelson or other ag owners.

With Jankelson's change of heart, the frontage LID is effectively dead.

According to Bear Mountain Attorney, Mark Peterson, the other two LID's at Hawks Ridge and along the golf course par-

rels are in question, but as of now still in place.

"We have a meeting on April 19, but much won't happen. I think we have to wait and see what Hawks Meadow wants to do. We have some fairly strong groups that want to do those projects, but they are still trying to find out how to make that happen, so I guess we're just kind of waiting," Peterson commented.

The meeting on the 19th will be at the Chelan Public Works Office at 1 p.m.

## Chelan Council hears Earth Day presentations

CHELAN - Maintaining a healthy Earth was certainly a topic of discussion at the Chelan Council meeting on Tuesday, April 11.

Before the council moved into their regular business, they listened to two special presentations on Arbor Day, Earth Day and gave a proclamation for a bike, walk or run to work day on Friday, April 21.

Although Arbor Day typically takes place on the last Friday in April, Chelan Parks Director Karen Sargeant issued a proclamation to declare April 13, as Arbor Day in Chelan. This year's event took place at Don Morse Park and included a free hot dog and the planting of a new Red Oak tree near the picnic shelter that is closest to the skatepark.

"We are hoping to have over 100 fifth graders," Sargeant said. "Part of the Arbor Day celebration is related to Tree City USA, which we are celebrating our 10th year of being a Tree City USA."

To be apart of Tree City USA, a city has to have a Tree Board or Department to care for the trees, a tree care ordinance, a community forestry

program with an annual budget of at least \$2 per capita and an Arbor Day observance and proclamation.

Chelan Mayor Mike Cooney then proclaimed Friday, April 21 to be Bike, Walk or Run to Work Day in Chelan and asks residents to observe the day by getting to work without motorized transportation.

Local Orchardist and former Chelan Recycle Center employee Scott Beaton gave his annual Earth Day presentation to the council members and also explained that his annual Litter Clean-Up Day in Chelan will be on April 28 from 8:30 a.m. to 11:30 a.m. This year will mark the 23rd that Beaton has gone out with a group of sixth graders to pick up some of the trash lying around Chelan.

Beaton also stated that he currently has five volunteers - six after councilmember Servando Robledo volunteered during the meeting - and looking for more to help out with the kids.

After the presentations were finished, Cooney gave the floor to Public Works Director Dwayne Van Epps for an update on General Facility Charges (GFC's).

"I want to touch on two things that have changed

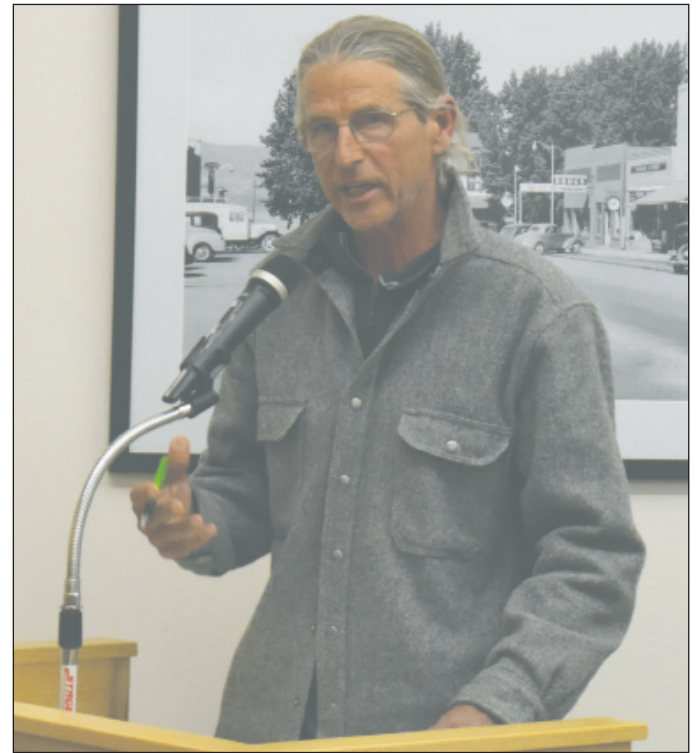

## Fishing derbies coming this weekend

CHELAN / MANSON - The water in Lake Chelan might still be too cold to swim in, but with the weather getting progressively warmer, it is perfect for fishing, and this weekend, residents in Chelan and Manson will have the opportunity to participate in one or two fishing derbies.

The first one is put on by the Washington Department of Fish and Wildlife (WDFW) and is free for anyone with a valid fishing license.

The 2017 Trout Fishing Derby runs from Saturday, April 22 through Halloween and will hand out over \$25,000 in prizes. There are over 900

tagged fish, stocked in over 100 lakes with Wapato Lake and Beehive Reservoir (near Wenatchee) being the only two participating lakes in Chelan County.

Each tagged fish has a corresponding dealer and prize, and in order to claim a prize, the angler must contact WDFW by phone at (360) 902-2464 and provide the tag information. WDFW will then provide specific donor prize information corresponding to the tag and the angler will have to present the tag at the donor's place of business to claim the prize. After Halloween, remaining tags have to be phoned in for redemption by Friday, Nov. 3.

For a more competitive fishing derby, the fourth annual Something Catchy Kokanee Derby will run this Saturday and Sunday, April 22 and 23.

The prizes will go to the biggest kokanee, the most boat weight - top 10 fish - a smallest kokanee, biggest lake trout, biggest cutthroat and biggest rainbow trout.

Something Catchy Founder Jason Williams said rods and reels from Velocity and a whole bunch of gear and manufacturers will be at the event as well.

Williams said the event has been growing steadily since the first event four years ago

"The first year we had 56 boats, then the second year we were flirting with 100, but last

year was the biggest and we had 120 tickets sold and gave away 20 other tickets," Williams said. "As of now, we have 102 tickets sold with another 20-30 kids."

Ultimately, Williams is trying to promote fishing to kids and get them outdoors instead of sitting on the couch stuck in technology.

Anglers will have until 5 p.m. Saturday to make it back down to Chelan to weigh their fish and then the final weigh in is at noon on Sunday.

ing citizens are bearing costs equal to amount relieved to developers. We ought to consider what monthly charges are, modifying monthly rates keep it to our current 5 year incremental structure. Whatever you decide it will be based on sound engineering and financial principles that are more easily defended."

Mayor Cooney stated that the resolution does not effectively raise GFC's, but it does help with commercial projects coming into the city.

All of the council members referenced that urgency was important, but that it should be done fairly and have a balance between monthly users and GFC's.

"That will be the art of the deal," Van Epps said.

"Development pays their way," councilmember Guy Harper commented, "if that is 100 percent than that is what it should be. Everyone bought into it, so it is pretty black and

white to me."

Sargeant then requested council to approve the hiring of a contractor to complete the pickleball and tennis court resurfacing project and have the mayor sign the motion once all of the needed documentation was in hand. The motion was approved unanimously.

Sargeant also asked council to approve the hiring of a contractor to do a roof and deck replacement at the Lake Chelan Municipal Golf Course.

"I'm just trying to get these projects going before we get into summer and it becomes a burden, but we have to get rid of the shake roof because it is a fire hazard," Sargeant commented.

The motion was approved unanimously.

The Chelan City Council will meet again on Tuesday, April 25 at 6 p.m.

## Rep. Mike Steele secures funds for Woodin Avenue bridge improvements

**\$280,000 allocated in the 2017-19 House transportation budget**

OLYMPIA - Last night (April 12), Rep. Mike Steele, R-Chelan, successfully secured \$280,000 for improvements to the Woodin Avenue Bridge in Chelan. The funding allocation was adopted by the House during negotiations of the 2017-19 House transportation budget.

"This is big victory for all of us," said Steele. "Improvements on the bridge are long overdue and these funds will

help increase its structural integrity and improve pedestrian safety."

While dozens of requests are submitted to the House transportation budget each biennium asking for fund-

ing of local projects, few are adopted.

In addition to funding for the Woodin Avenue Bridge, the House transportation budget will send approximately \$15.6 million to the 12th Legislative District for numerous ongoing projects.

Statewide, the \$8.56 billion budget will fund recruitment and retention of highly qualified state troopers; maintenance and repair to roads; removal of some fish passage barriers; and continued implementation of Connecting Washington projects.

The House transportation budget will now head to the Senate to await a vote of concurrence.

The regular session is scheduled to end Sunday, April 23.

Participants will challenge themselves to try new, environmentally-friendly behaviors for two weeks: bicycling to work, changing to LED bulbs, riding the bus, recycling, and eating local foods -- to name just a few. They choose the behaviors they want to change from dozens of options on the EcoChallenge website, then report their actions daily online.

Climate Conversation NCW, a grassroots group devoted to climate change solutions, is the primary sponsor of the EcoChallenge. Carolyn Griffin-Bugert, spokesperson for the group, said the idea originated with a Portland contest held last fall. Several local residents participated to test it, then customized the contest for Chelan and Douglas counties.

"Local businesses have been really generous about donating prizes, which makes the contest that much more interesting and fun," Griffin-Bugert said. The grand prize is an iPad.

A bigger prize, though, may be the good feeling you get from knowing you're doing something good for the environment—and your community. "Sometimes global problems seem too overwhelming," Griffin-Bugert said. "The EcoChallenge gives us ideas for simple and easy actions anyone can take right now that will benefit our community and the planet. It's a fun way to learn about climate change and how to reduce your carbon footprint."

Other EcoChallenge sponsors are the Community Foundation of NCW, Chelan County PUD, Link Transit, Waste Management and Columbia Valley Community Health.

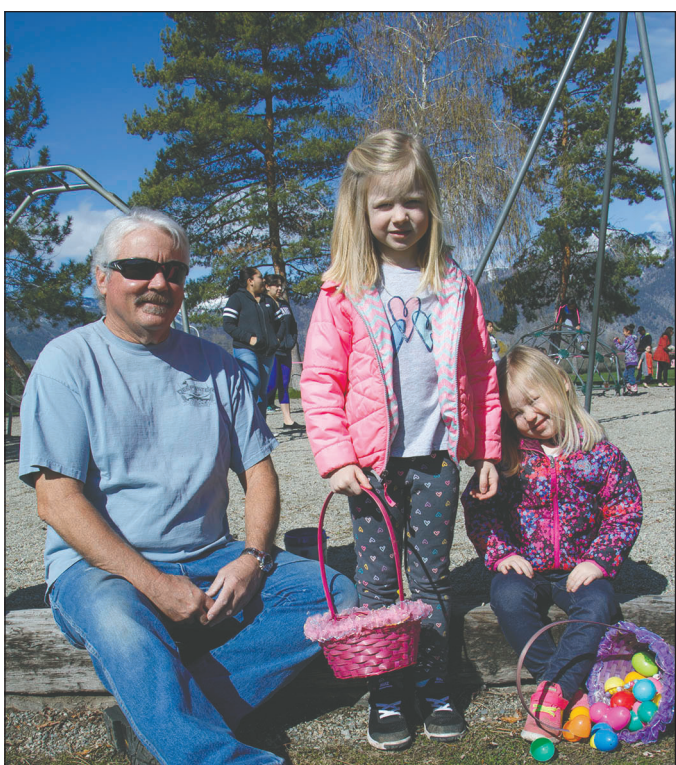

## Harv Holling

The Life and Times of Harv Holling



was a rock for the family. He had a variety of jobs and can learn anything with simple observation and could memorize numbers like no one else.

Harv Holling was born on January 17, 1940 to Harry and Clara Holling. During his time in Manson, he was into fast cars, he worked as a baker at the Judy Jane Bakery, excelled at sports, and the list can go on and on.

Manson Trojans were state football champions in '58 and '59. Also, he held the state record for the mile for 8 years. In addition, he was a natural bowler. His first game he ever bowled was a 203 and he rolled a 300 a perfect game. Another sport that came easy to him was the game of golf. He used to play with professionals and U.S. Senator's at the Chelan course. After high school he attended Wenatchee Valley College for one year studying Business.

Then he was drafted into the Army and went to Korea. The war was over but the tensions were still high. Bob Hope came to visit with his USO tour and dad was back stage standing watch and got to meet a lot of big name stars. He thought that was the highlight of his time in Korea until he met his forever wife Min Sun. They got married in South Korea in 1966 and she came to America to start their lives together.

Lastly, just remember you can talk to me anytime. I promise I will listen intently and hope the way I lived will aid you in finding your answers.

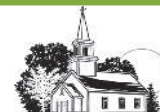

**Four reasons to vote yes**

Dear Editor,  
I am voting yes for the Lake Chelan Community Hospital Levy because I want to maintain quality health care here in the Lake Chelan valley. Here's four specific reasons why:

First, to continue to meet the needs of our growing valley, our hospital needs more space. A quick tour of the current facility confirms this reality. Bathrooms are used for storage rooms. Storage rooms are used for offices.

Offices have been torn out to make room for patient care. The place is stuffed.

Opponents argue we don't need more space. They argue we shouldn't grow but instead reduce our services. "Stabilize and Ship", they call it. This would mean the end of delivering babies in the Lake Chelan valley. And it would leave the community with a significant tax burden. Visit Leavenworth to see this model in action. It doesn't make sense here. We are Lake Chelan. Second, building a new facility is the most economical route. The new hospital will cost \$44 million. That's on par with

other new hospitals of similar caliber around the state. What will it cost you and me? An extra \$10 per month if our homes are valued at \$300,000. And that rate will go down over time as more homes are built in the valley.

Opponents argue that \$44 million is too much for our community to pay. But staying put has its price as well. The "Stabilize and Ship" model would run well in excess of \$14 million. So staying put still costs big bucks, reduces our services, and requires significant taxes. This may make sense elsewhere, but it doesn't add up here. We are

Lake Chelan.

Third, a stable and sound plan exists to pay for the hospital over time. Increased reimbursements combined with taxpayer support will pay for over 90% of the yearly debt payment. The balance, less than 1% of total hospital revenues, will be less than current debt service payments.

Even in the face of this sound plan, opponents are worried. They fear the money won't be there. They compare us to other places where hospitals are struggling: Grand Coulee, Quincy, Kennewick. But these communities don't

have what we have.

We have a stable hospital with sound finances. We have a low percentage of uninsured. We have stable reimbursements. And we are a growing community with a swelling retiree population. We are Lake Chelan.

Finally, the time has arrived to build a new hospital. We built our first hospital in 1948, and the second in 1972. It's our turn now to reinvest in our future.

Is there uncertainty and risk? Yes, without a doubt. Life is uncertain. The opposition casts dire predictions of our health care future. But

our risk actually goes up if we stay put. We would still be required to invest in our current hospital, we still would pay significant taxes, and we get fewer services. That just doesn't make sense.

I'm voting yes because we are a growing community. I'm voting yes because we have a stable and sound hospital that needs a new facility to continue to grow. I'm voting yes because we are Lake Chelan. Please join me in casting your Yes vote on April 25.

**If the hospital bond doesn't pass, we will lose health care workers**

Dear Editor,  
I completed residency and an additional year of fellowship a little over two years ago. My husband and I had one child at the time. He is from New York. I am from Edmonds. We felt like we could go almost anywhere-it was actually fairly overwhelming to decide where to "settle down". The nationwide shortage of family physicians results in a lot of great opportunities. I trained to practice full scope family medicine-which means that we take care of elderly patients, children, obstetric patients, newborns and everything in between and...we learn who and when to refer to specialists.

While I was in fellowship training, I received an email

that CVCH was looking for someone to practice full scope family medicine-including c-sections in Chelan. Like many of you who have chosen to relocate here-I had vacationed here growing up, at Campbell's actually. On a trip from Edmonds to Spokane, I drove my husband through Chelan to see if he could live somewhere, "like here". Having roots on Long Island, I really didn't know how he would feel about a small town. Compared to my training institutions, the hospital was much different, but my experience was similar to most of yours, in that, the staff was friendly and eager to help-looking forward at that time to building an up to date facility.

We considered a few different clinics (including my hometown of Edmonds) which actually boasted a "shiny new clinic". Stevens hospital had been bought out by Swedish and was growing and improving. We chose Chelan.

We chose Chelan because it boasts a tight-knit, yet growing community. It boasts the lake and sunshine with modern influence from the West side of the state as well as an up and coming wine and tourism industry.

When we joked about Costco being only an hour away, Manuel Navarro told us that we would change our minds, that we would get to know the Kellys and want to spend a few more dollars to shop at Kelly's Ace Hardware rather than travel to Home Depot. We would realize that the Red Apple Market has an amazing variety of produce and groceries and that we didn't need to travel outside of Chelan.

Over the past two years, we have grown to love and feel connected to this community. I think that all of the physicians and hospital staff share a similar sentiment. We are not supposed to wave and acknowledge our relationship with you when we see you on Woodin Avenue in

an effort to respect your privacy and legally due to HIPPA but we want to wave and ask, "How are you? How is your mom doing?" When you come to Lake Chelan Community Hospital, you are not a 96 year old with a hip fracture-you are so and so's great-grandpa. Your baby is not a newborn with a cold-she is my son's best friend's little sister.

Chelan has the charm of family medicine 50-100 years ago with real medical needs and a growing economy. Our specialists at Confluence are fabulous-but Chelan has a need for local health care. I want to believe that those voting no for the new hospital are misinformed, misunderstand the facts, don't have all of the right information. As health care professionals we are concerned for the future of your healthcare in Chelan if the hospital bond doesn't pass. We will lose health care workers. We will be very unlikely to meet the standards and requirements necessary to start a residency program to train

more rural physicians.

Whereas, a new facility will attract high quality nurses and staff and allow us to meet standards to train rural physicians-improving the quality of rural healthcare. This is simply impossible in a stabilize and ship model.

There has been a decent amount of distortion and misinformation about cost of a new hospital. The cost to local businesses and commerce if we don't build will be higher. A no vote is not a vote for a remodel. A no vote is a vote for an exodus of the quality healthcare we take for granted in this rural community. A ship and stabilize vote is a vote for you to travel to Wenatchee-if not Seattle or Spokane to grieve the death of your loved one far from home.

A good portion of our patients' don't appreciate an unnecessary helicopter ride when they are already feeling sick-not to mention a bumpy ambulance ride. I delivered my son at Lake Chelan Hospital after training

at larger institutions because I trust the physicians and nurses working there. I appreciate that they know and care deeply about my family and I.

As a physician, a mom, a wife, a daughter, a friend, and a concerned community member, I urge you to consider the ramifications of a no vote for yourself, your family, your neighbor, your coworker and your community. I implore you to ignore rhetoric and hear the stories and know the facts. I agree with contacting Lake Chelan Hospital or watching the video recording of the debate if you are undecided.

The newhospitalnow website is full of legitimate information. You trust us in the office, please trust us now. We need your help to continue to serve you the best that we can. Please trust us and vote yes.

But this overbooking fiasco isn't relegated to just United, every major airliner does the same thing. They do this in order to quench their thirst for greed by squeezing every last penny they can get off an individual flight while minimizing the chance they have a flight that is half-full.

Would it be such a huge deal if a few flights a day weren't

as jam packed? I doubt it. I'm sure their margins aren't that slim. Plus, more people are flying today than have ever before, so the likelihood of having one or more flights half full is minute.

The fact that a multi-billion dollar corporation can bring in airport law enforcement to forcibly remove a paying passenger, whose only crime was refusing to get off because he had to get to work and see patients the next day, should be a blunt reminder of who is in charge. Let us not forget though, this could have been any airline, United isn't alone in the overbooking practice. Basically this is just a byproduct of the America that we live in, where exploitation is just the name of the game.

Let me explain:  
• Social safety nets like welfare, unemployment benefits and homeless shelters have dwindled through our

austerity measures over the past three decades, leading to greater income inequality.

• Labor unions have been gutted through the years, leaving workers with little protection against exploitation from their employer.

• A universal healthcare system - while gaining popularity and used in all major western countries - is vehemently opposed from a majority of both sides because of the pharmaceutical and insurance industry that spends hundreds of millions in lobbying and campaign contributions.

• Citizens United (2010) essentially gave corporations the power to buy elections and politicians through unrestricted - and sometimes undisclosed - campaign contributions, thus ensuring the needs and wants of the corporation are kept first and foremost.

• NAFTA and other trade agreements have consistently

been pursued without an inkling given to the possible externalities; loss of jobs, slave wages or environmental degradation.

• The agency in charge of protecting the environment is now run by climate deniers and people who have spent their life fighting against the very agency they work for. Because somehow that makes sense.

• Our education department, now under Betsy DeVos, is now pursuing more 'for-profit' charter schools, despite evidence that they have proven to be highly detrimental to the public school system. DeVos also led the charge in rolling back various protections intended to protect student loan borrowers, effectively putting the welfare of the loan contractors above those of students.

• The United States has less than 5 percent of the world's population yet we have almost

25 percent of the world's total prison population despite the fact that crime has been at a historically low level compared to 30 or 40 years ago. This all while our Attorney General, Jeff Sessions wants to bring back mandatory minimum sentencing, the immensely failed war on drugs and increase private "for-profit" prisons.

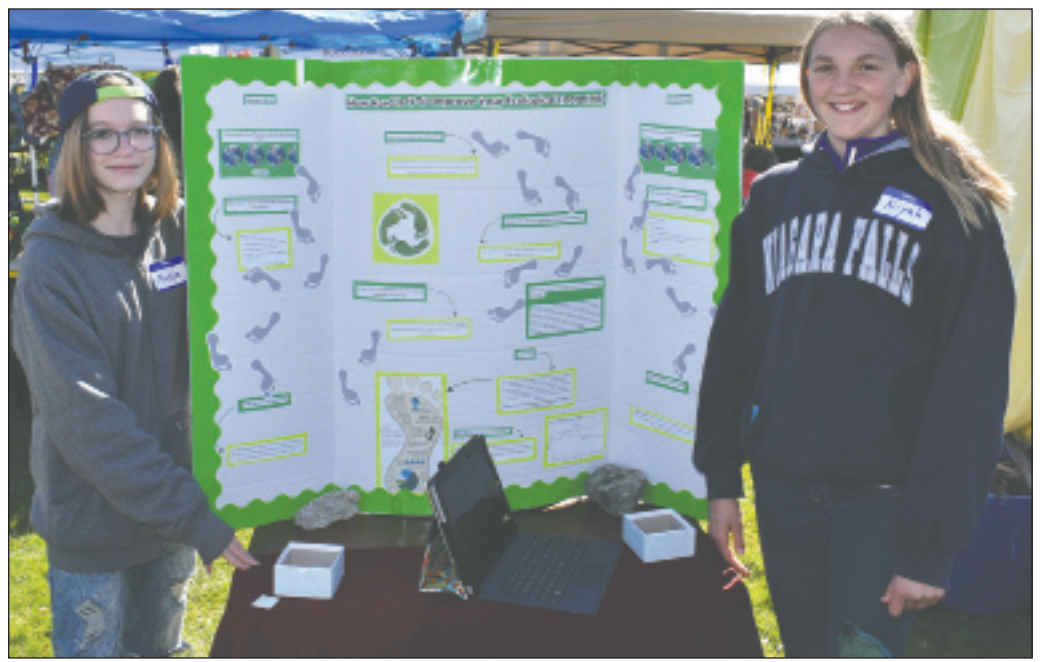

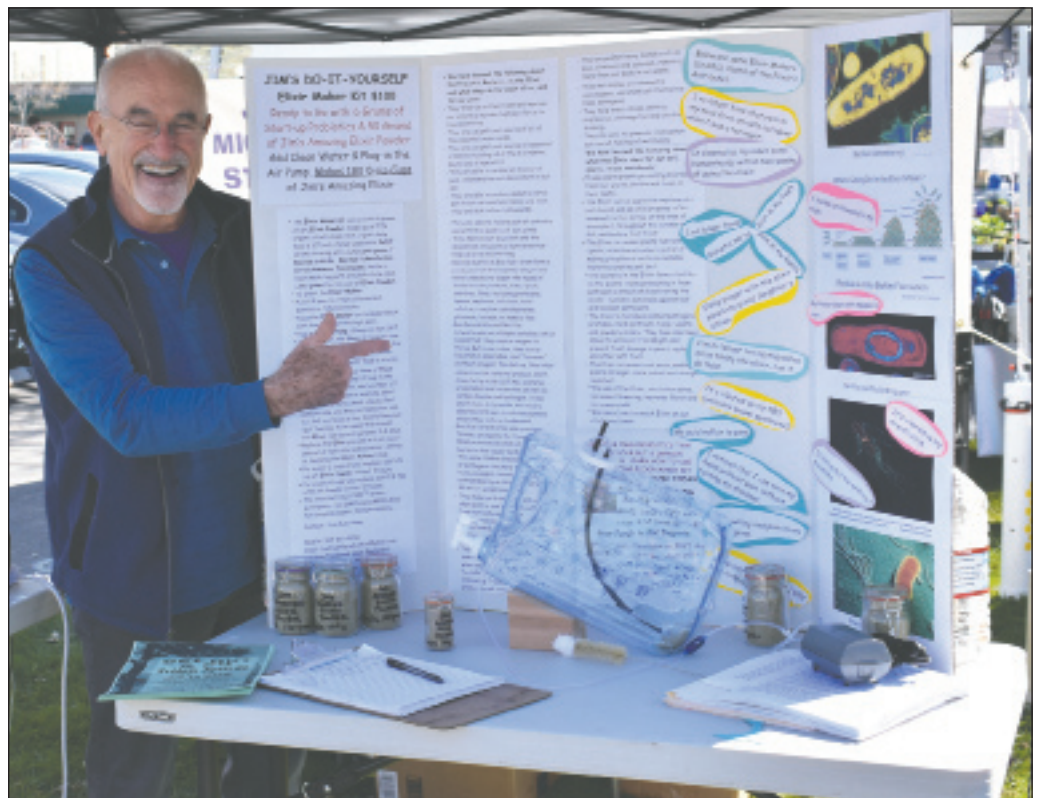

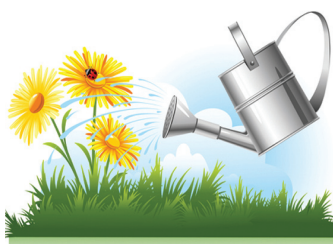
