10th annual scarecrow walking tour takes over town

CASHMERE - Scarecrows are taking over the streets of Cashmere again this month for the 10th annual Scarecrow Walking Tour, known as Scare-Crazy.

Visitors are encouraged to stroll downtown Cashmere to see all the creative scarecrows created by business owners and residents.

Each year, scarecrows are displayed, enlivening the downtown area and drawing visitors from around the region to stroll through town, capture photos, discover the Cashmere community, and enjoy the scenery while the creations are on display.

Many businesses participate, including the Cashmere Library.

"We try to support the scare crazy community activities," Cashmere branch librarian Lisa Lawless said. "A lot of the businesses like to do it, and anybody can participate. It's just a lot of fun, and it makes Cashmere look so festive. Everyone is so creative, and I love to see what businesses and residents and different individuals come up with."

"It makes it really fun to walk around Cashmere," she said. "Cashmere is a good town to walk around."

Lawless said walking around town is especially pretty and festive when the leaves change to their fall colors and the scarecrows are decorating the sidewalks.

The Cashmere Library's scarecrow theme this year is Gnome Your Way to Reading.

Lawless and Friends of the Library board members JoAnne Prusa and Nancy Fike had a lot of fun coming up with their theme and decorating their scarecrow.

The scarecrow's beard is made from an animal pelt, and the boots are made from big gnarly pumpkins, Lawless said.

During October, self-guided scarecrow maps will be available outside the Chamber office at 103 Cottage Avenue and participating businesses.

Enter the Grand Prize Giveaway by completing the map tour. Select scarecrows will be assigned a scarecrow badge, which you can locate and record on your map. Turn in completed maps by October 31 to be entered for a chance to win the Grand Prize Giveaway.

City Council declares state of emergency and addresses critical fire hydrant issue

CASHMERE - During the Cashmere City Council meeting held on Sept. 25, several significant developments took place, including the announcement of three upcoming public hearings and a unanimous decision regarding the city's fire hydrants.

The most pressing matter discussed was the Council's unanimous passing of a Resolution declaring a State of Emergency. This declaration authorized the mayor and city staff to take immediate action by purchasing and replacing nine or more fire hydrants within the city. Director of Operations Steve Croci, revealed that Woodard and Curran, the city's water system contractor, had identified multiple non-operational hydrants. These hydrants had not undergone maintenance for 5 to 10 years. Council members raised questions about the lack of a Standard Operating Procedure for hydrant maintenance. Mayor Jim Fletcher responded that they should have been flushed every two years, but deferred maintenance had prevented this. Croci further noted that many of the hydrants are approximately 40 years old and are plagued with issues, such as being unable to turn on or off. Council member Chris Carlson underscored the gravity of this situation, emphasizing its implications for public health.

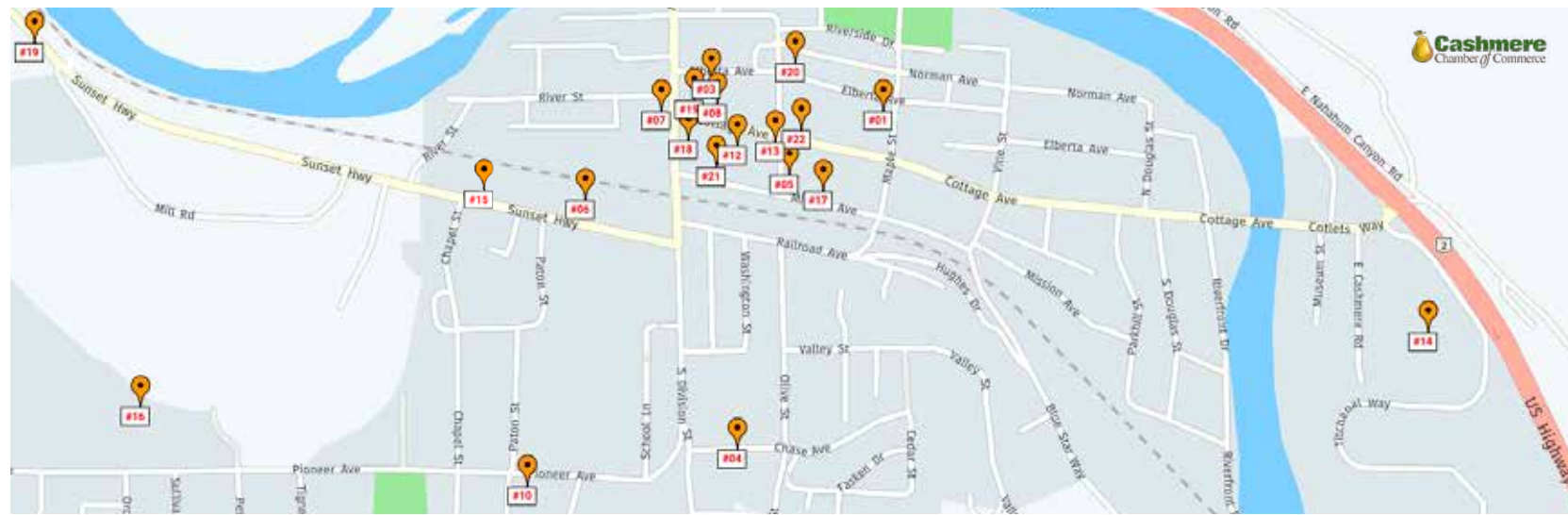
In another development, the Council unanimously approved a proposed 2024 budget presented by Woodard and Curran (W&C) for water and wastewater utility operations. Chris McMahon, the Area Manager for W&C, explained the rationale behind the 13% budget increase compared to 2023. He cited substantial increases in chemical costs, with chlorine costs for drinking water treatment surging by a staggering 347% over the past year. Polymer chemicals used for solid waste treatment also saw a significant 25% cost increase. In response to Council member Derrick Pratt's query about in-house testing, McMahon acknowledged potential long-term savings but highlighted the substantial start-up costs.

The Council renewed its annual contract with the Emergency Management Division of the Chelan County Sheriff's Office, ensuring continued emergency management planning and services for Cashmere.

During the public comment period, a concerned Cashmere resident implored the Council to prioritize pedestrian safety in light of increased housing and traffic. The resident specifically raised concerns about the safety of children walking to and from school on streets lacking sidewalks.

In other business, Manuel Navarro, CEO of Columbia Valley Community Health (CVCH), delivered a comprehensive overview of the organization and its services. Founded in 1971 to provide medical care access for migrant workers, CVCH now serves Chelan and Douglas Counties, both designated as medically underserved areas. Navarro emphasized CVCH's commitment to age workers, featuring a sliding fee scale based on income. Notably, approximately 1,500 CVCH patients hail from the Cashmere/mid-valley area.

Three public hearings were announced. The first hearing will be held on Oct. 23 to receive public input regarding a possible increase in property taxes. On Nov. 13, a hearing will be held to hear public comments regarding the preliminary 2024 budget. A hearing will be held on Nov. 27 to obtain public comments on the final 2024 budget. All of the hearings will be held at 6:00 p.m. at the Cashmere City Hall. Written comments can be sent to Kay Jones, City Clerk-Treasurer at kay@cityofcashmere.org

Washington Outdoors Report

BIRD HUNTING PROSPECTS

The Washington Department of Fish and Wildlife has published its hunting forecast for this fall. Here are the highlights when it comes to bird hunting where our readers live:

DISTRICT 1

(Stevens, Ferry, and Pend Oreille Counties):

Grouse numbers have declined in the last 14 years, but hunters should see success similar to recent years, averaging about a bird every other outing. Look for grouse on little-used Forest Service roads, especially ones gated off to vehicular traffic.

Pheasant hunting is pretty much limited to released birds at the Sherman Creek Wildlife Area in Ferry County. Wild turkeys, on the other hand, are prolific in this part of the state, and the Fall harvest of these birds has increased in recent years. Forest edges, as well as grass pastures and agricultural fields, are all good places to look for turkey.

Waterfowl hunting should be good, especially along the Pend Oreille River from Newport to Usk, for dabbling and diving ducks, as well as Canada geese. Early-season hunters also have the chance to harvest wood ducks in the Colville, Kettle Falls, and Pend Oreille River valleys.

DISTRICT 6

(Okanogan County):

Waterfowl hunting doesn't get much press in a county known primarily for big game. Still, there are a few public places worth hunting near the mouth of the Okanogan River as well as the mainstem Okanogan and Upper Similkameen Rivers. Public hunting access can be found at the Washburn Island Unit of the Wells Wildlife Area, the Driscoll-Eyhott Island Unit of the Sinlahekin Wildlife Area, and the Similkameen-Chopaka Unit of the Scotch Creek Wildlife Area.

Okanogan County has "robust populations" of grouse, and although the number of adults in breeding areas this spring declined due to last year's extended winter, brood survival was good for the

young birds. Quail populations are also solid in this region, and the spring breeding season for quail was similar to what was seen for grouse here. Hunters should find quail in lower elevation, tree-lined areas, or shrub steppe in state wildlife areas throughout the county. Pheasant populations, on the other hand, are fairly minimal. There will be releases throughout this season at the Bureau of Reclamation's Hegdal and Kline sites and at the Chiliwist Unit of the Sinlahekin Wildlife Area.

The fall turkey season opened up on Sept. 1, and you'll find good numbers of these birds in flocks throughout the district, especially on private land near agricultural lands. The best places to hunt are in Game Management Units (GMUs) 204, 215, and 239

DISTRICT 7

(Chelan and Douglas Counties):

According to WDFW, Chelan and Douglas Counties offer some of the best quail

hunting in the state. In the early season, the birds can be found in good numbers in state wildlife areas. Still, better hunting can be found on private lands, especially around orchards, if you can secure permission from landowners to hunt on their property.

Hungarian (or gray) partridge can be found in shrub-steppe habitats in Douglas County, and in 2021, nearly half of the Huns harvested in the state came out of Douglas County. Nearly 1200 of these birds were harvested statewide that year, about 500 more than average.

Chukar have typically thrived in this part of North Central Washington; on average, 4400 chukar a year are harvested. However, in 2021, there was a dramatic decline in the chukar harvest here, with only 2345 birds taken by hunters. It's thought a heatwave that year stunted chukar numbers, but with relatively mild weather this spring and summer, we will hopefully see an increase in

the population of these hardy game birds.

Grouse numbers and the hunters that go after them have both declined in recent years. However, there are still plenty of grouse to be found in GMUs 245, 246, and 251 within Chelan County, as well as GMUs 248 and 266 in Douglas County. Look for Grouse in forested areas, especially around stands of aspen for ruffed grouse and above where ponderosa pine grows for spruce grouse.

Pheasant hunting has become difficult in the region, and there are only three releases per season at the Swakane and Chelan Butte Wildlife Areas. The Columbia River provides good late-season duck hunting for dabbling and diving ducks. However, remember you are not allowed to hunt on the river between the George Sellar and Odabashian Bridges.

Breast Cancer Survivor's Struggle with Long-Term Medication

"I don't think I can take this medicine for the next five months, let alone five years," insisted Robbie, a 61-year-old breast cancer survivor.

After completing chemotherapy and surgery six months ago, Robbie's doctor prescribed an anti-estrogen medicine called Arimidex® (anastrozole) to help prevent it from coming back. He wants her to take it for five years. But two weeks after starting it, she was ready to quit.

Anti-estrogen medicines are widely used to treat and prevent breast cancer. There are two types of anti-estrogen medications: those that reduce estrogen production and those that block its action on the body.

In women who have gone through menopause, an enzyme called aromatase is needed to create estrogen. Medications interfering with estrogen production by aromatase are

called aromatase inhibitors. Anastrozole (Arimidex®) and letrozole (Femara®) are aromatase inhibitors often prescribed for five years after initial breast cancer treatment to decrease the risk of recurrence.

Estrogen-blocking medicines prevent estrogen from binding to breast tissue. The estrogen blocker tamoxifen (Nolvadex®) is used alone or with other drugs to treat breast cancer and avoid recurrence in high-risk women.

Anti-estrogen medicines' most common side effects are aching muscles or joints, hot flashes or night sweats, weight gain, dry skin and hair, and vaginal dryness and discomfort.

One way to combat dry skin and hair is to eat a "good fat" diet with olive oil like in the Mediterranean diet, or coconut oil instead of vegetable oil or butter. I'm not a fan of the taste

of olive oil. I prefer avocado oil, which has a buttery flavor.

Hot flashes and night sweats are common side effects of tamoxifen or aromatase inhibitors. Unfortunately, hot flashes from these medicines don't seem to respond to eating soy or taking black cohosh (Remifemin®) or red clover supplements.

Unfortunately, Remifemin® and other herbal products sold for menopausal symptoms like hot flashes CAN act like estrogen in breast tissue. This is precisely what you DON'T need if you are trying to decrease your risk of breast cancer.

Fortunately, some prescription medicines can help relieve menopausal symptoms without estrogen. Antidepressants like venlafaxine, citalopram and nerve medications like gabapentin can ease hot flush and night sweats.

Like Robbie, nearly half of women taking aromatase inhibitors experience aching muscles or painful joints. Although non-prescription medicines may offer relief, no option is better than any other.

One place to start is with either Tylenol 8-Hour® or Tylenol Arthritis® Extended Relief, which lasts twice as long as Tylenol® Extra Strength. Sarah could try one or two of the 650mg tablets twice daily every day.

Anti-inflammatory medications may also help muscle aches and joint pain, like Ibuprofen (Motrin-IB), naproxen (Aleve®), fish oil capsules, and cannabidiol (CBD).

Glucosamine may offer relief and has minimal side effects; it can also be added to other medicines without causing problems. I recommend glucosamine

powder twice daily because it is less expensive and better absorbed than taking the pill form. Allow 4-6 weeks of taking glucosamine to see the full effect before deciding if it's helping you.

If these don't help, please talk to your doctor. People differ widely in how drugs affect them. Switching to a similar medicine can make a huge difference.

Here are 5 Tips for Living With Anti-Estrogen Medicines:

1. Try a "good fat" diet.
To help relieve dry skin and hair, switch from a "low-fat" to a "good-fat" diet like the Mediterranean diet. "Good fats" include coconut, avocado, and olive oil. Taking a fish oil supplement may also help.

2. Avoid soy and menopause relief supplements.

Don't take concentrated soy products and herbal



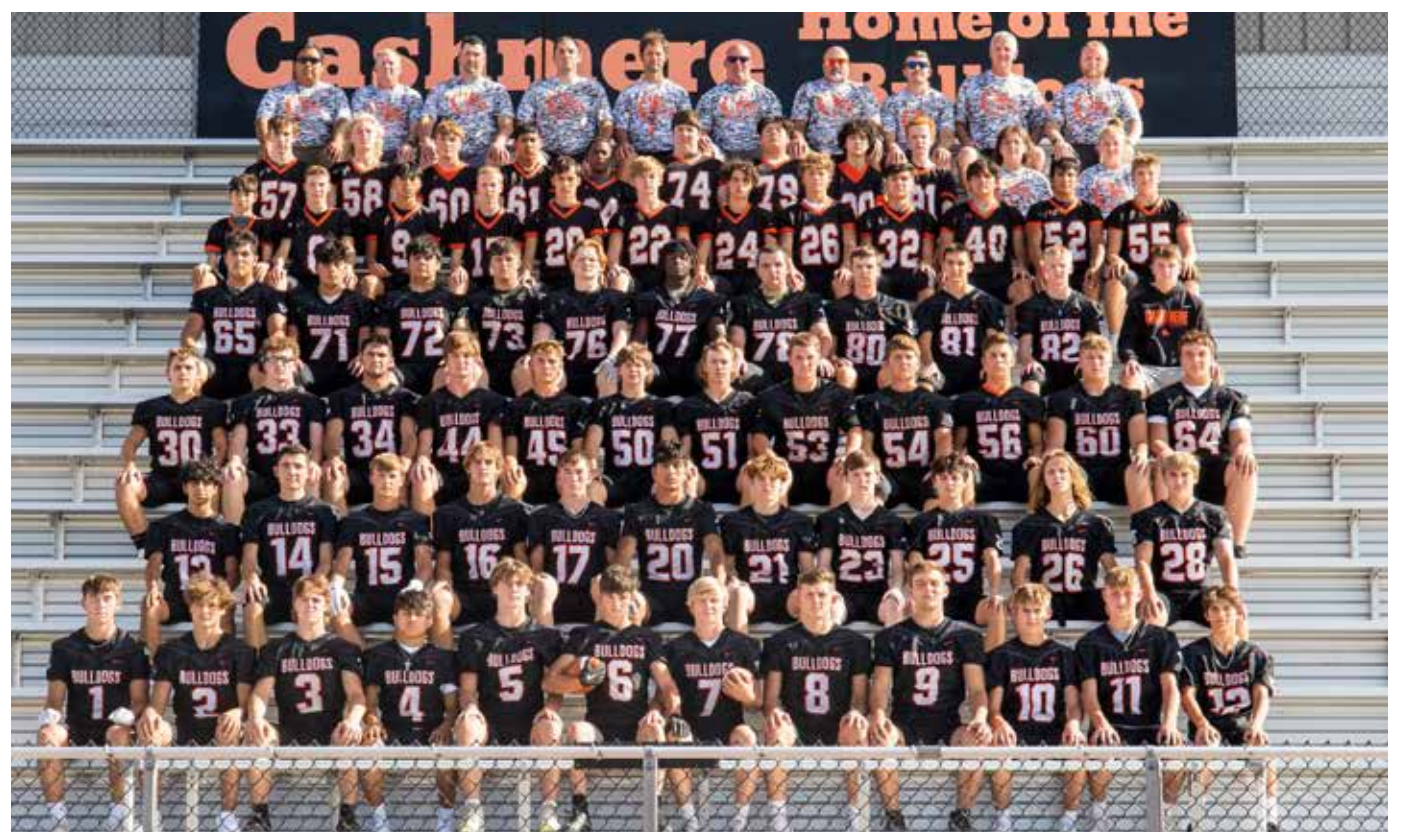
supplements marketed for hot flush symptoms. Although weaker than prescription-strength estrogen, these alternatives can have similar effects on breast tissue and should be avoided by women at risk for breast cancer.

3. Keep moving.

Physical activity discourages weight gain, boosts mood, and may reduce the muscle aches and joint pain experienced by nearly half of women who take an aromatase inhibitor, like Robbie. If your muscles or joints ache, don't blame old age; it may instead be due to your medicine.

tablets), Aleve® (naproxen), Motrin-IB (ibuprofen), fish oil capsules, and even CBD elixirs can help you stay more active.

4. Talk to your doctor.

For hot flashes and night sweats, prescription medicines like the antidepressants

venlafaxine and citalopram or anti-seizure gabapentin may help.

5. Don't suffer, speak up!

Talk to your doctor if your muscles or joints hurt. Switching to another medicine may improve Robbie's symptoms, making the five years of taking anti-estrogen pills more bearable.

Crepe Stack Cake

Grandma Gay sent me home with a whole lot of apples from her back yard trees. It being the season for apples, I was trying to find a good recipe for them when I came across my stack cake recipe.

A few years back I found a recipe for old fashioned stack cakes. Folklore has it when there was a pioneer wedding each family coming to the wedding brought a layer for the cake; when all the families showed up for the wedding the cake was assembled by stacking the layers with apple sauce in between each layer.

Despite what my kids may think, I wasn't around then so I'm not 100% sure that's the case. However, it makes sense to me that stack cakes would have been used at gatherings because food was often scarce.

For a wedding I doubt one family would have been able to gather all the ingredients to make the kind of wedding cake we use today, then be able to spend the time to make it when they had gardens to tend, chickens to feed, cows to milk, hay to cut not to mention the day to day 'doings' that keep body and soul together like cooking, laundry, home maintenance and sleep.

When I found that old recipe for stack cakes it called for six to eight round cake pans only partially filled then baked for 15 to 20 minutes. I don't have six to eight round cake pans; I don't have an oven that fits six to eight round cake pans and I certainly don't have half a day for making a cake. So instead, I make a double batch of crepes for breakfast and hold back half the crepes to be made into an applesauce stack cake dessert for dinner. Works for me.

Crepe Stack Cake

Cooked Apple Sauce

- 4-8 apples peeled, cored and diced • ¼ to 1 cup brown sugar (optional)
 - Water as needed
- Ground spices (optional)
Put peeled, cored and diced apples in a small crock pot or a sauce pan. Simmer until the apples fall apart adding water as needed. Mix in sugar and spices to taste. Set aside to use as filling between the layers of crepes for the stack cake.

Crepes

- 3 eggs • ½ cup milk • ½ cup water • 3 Tablespoons melted butter or oil • ¾ cup flour • ½ tsp salt
- Mix eggs, milk and oil. Add flour and salt and beat until well blended. If the batter is left to set for a few hours or overnight it will be less lumpy;

more uniform; easier to swirl in the skillet, and errant egg shells will settle on the bottom and don't have to become part of the crepe.
Heat a small skillet brushed with oil until a drop of water splashed in it sizzles and skittles across the bottom of the pan. (It's important that the skillet be hot or the crepes will stick to the pan.) Then pour in just enough batter to cover the bottom of the pan (about 3 Tablespoons for a six-inch skillet) Tip the pan with the handle, swirling until the batter is distributed all across the bottom of the skillet. This has to be done quickly in order to spread out the batter before it stiffens up in the heat. Cook until the top is just becoming dry, then flip the crepe and brown the other side. Oil the pan as needed so the crepes don't stick.

To Assemble

On a plate large enough to hold the crepes start making layers. First a crepe then a thin layer of apple sauce, repeat, repeat until the cake is as tall as you'd like, or you run out of crepes or apple sauce. Frost the top with a layer of apple sauce and cut into wedges to serve as dessert. If whipped cream, vanilla yogurt or ice cream are available they make good toppings too.

Choices

Any fruit puree, jam, pudding or frosting will work as filling between the layers of crepes. Leftover flattened toast or pancakes can be substituted for the crepes. It's all good.

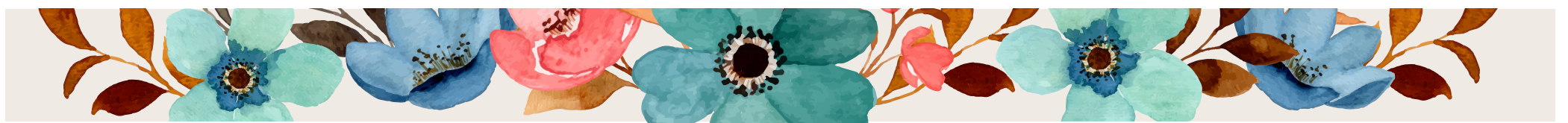
