Tumwater Dam maintenance work

The viewing area is closed; intermittent traffic impact is expected in October

WENATCHEE - Chelan County PUD is preparing for a maintenance project at Tumwater Dam. September 5 through mid-December. The work involves repairing and reinforcing the dam's apron, a section of concrete that sits just downstream of the dam, with new concrete to prevent undercutting of the structure.

The viewing area at Tumwater Dam closed on September 5. Construction crews will allow portage around the job site for whitewater rafters as needed.

Starting mid-October, drivers on Highway 2 through Tumwater Canyon can expect intermittent, short delays with flagger-directed traffic on weekdays. In September, an unrelated guardrail replacement project led by the Washington State Department of Transportation will also impact traffic through Tumwater Canyon.

This is the second part of a multiyear maintenance plan for Tumwater Dam. In 2020, the PUD reinforced the entrance of the fishway with concrete. The work is required to continue to meet dam safety standards regulated

Cashmere Planning Commission Reviews Parking Codes for Economic Growth

CASHMERE — In the recent Cashmere Planning Commission meeting on September 5, the Director of Operations, Steve Croci, made announcements regarding upcoming changes to the commission's membership and crucial developments within the city.

During the meeting, Croci announced that several positions within the Commission would soon become vacant, which could shift the city's leadership landscape. He invited anyone interested in joining the Commission to contact the Mayor's office.

Croci also reported essential infrastructure improvements underway at Riverside Park. The park's trail is undergoing extensive repair and repaving efforts. Furthermore, significant upgrades to the pump track are underway as a memorial to Brent Holladay.

The Commission's unanimous motion approval directs the City to delve into a comprehensive evaluation of the existing parking code with a view to fostering economic development. A spirited discussion among the Commissioners preceded the vote, centered on the merits and implications of potential changes to the city's parking regulations.

Croci explained how the existing parking codes could encumber new businesses, necessitating an undue space allocation for parking facilities. He maintained that the status quo hampers new developments by obligating them to prioritize parking space over building infrastructure.

Mayor Jim Fletcher, addressing the Commissioners, underscored the city's quest to determine an equitable and pragmatic approach to assessing parking needs for new businesses. Fletcher revealed that the city had embarked on a review of off-street parking codes, some of which have remained essentially unchanged since the 1960s. This move highlights the city's commitment to modernizing its regulations in response to evolving business models, such as the rise of online banking.

Croci emphasized the potential consequences of the existing code, which could lead to a proliferation of oversized parking lots at the expense of more functional building spaces. Commissioner John Torrence brought a national perspective into the discourse, pointing out a broader trend across the United States to reevaluate parking requirements. He posed the question: Does Cashmere aspire to facilitate economic development? If the answer is affirmative, Torrence argued, the city must adapt its codes accordingly.

Commissioners found common ground in their collective commitment to preserving the downtown area's unique character while actively supporting economic growth. Commissioner Kirk Esmond urged a careful examination of the type of growth Cashmere and its City Council wish to foster, recommending a comprehensive analysis of strategies employed by other cities.

Zak Steigmeyer echoed the sentiment, emphasizing importance of clearly defining the city's goals and objectives in revising its parking codes for new development. Steigmeyer asserted that the existing requirements were

at odds with the character and vibrancy of downtown Cashmere.

Paul Kinser made his stance clear, expressing strong support for relaxing the city's parking codes as part of a broader vision

for the city's future. Christina Wollman, a consultant for Perteet, Inc., suggested additional options that could provide flexibility to the parking code. One option would be to have a business owner prove to the city how many parking spaces the business would actually need. A second option would be to allow businesses to share parking spaces; for example, a business could share parking spaces with a church. A third option is to get rid of the parking requirements.

As Cashmere grapples with the tension between preserving

its distinctive downtown charm and encouraging economic development, the Commission's deliberations mark a crucial juncture in shaping the city. The coming months will undoubtedly witness further discussions, evaluations, and potential transformations as Cashmere navigates its path toward a vibrant and prosperous future.
