Bridgeport council dives in for pool renovation contractor



The Bridgeport city pool has not seen a major facelift in the last 15 years.

BRIDGEPORT – Council members discussed renovations to the city's public pool at Berryman Park during the regular monthly meeting last Wednesday, March 15.

Public Works Superintendent Stuart Dezellem reported that invitations for bids (IFB) for specific pool repairs were sent to three contractors and one responded.

'We received one bid from Jh Construction & Sons out of Wenatchee," said Dezellem. "We budgeted \$75,000 for this project and the bid came in a little higher than that.'

Dezellem said the quote to paint, sandblast, and regrout the concrete section is \$84,000 and to retile the

water line at the level of the pool water skimmers is an additional \$8,000 bring the total to \$92,000. The pool is missing some tiles and the city has used up the extras it purchased so that leaves two options: either remove all the waterline tiles and repaint that area or retile it.

The extra funds needed to come up with the difference of \$16,000 from other city sources has been found.

Dezellem said the pool has not seen a major facelift in the 15 years he has served at public works.

"Public works painted it twice," said Dezellem.

He noted that the tile mastic fails over time because the pool is considered a caustic environment owing to the level of the high chlorination.

Pool manager/council member Jackie Hentges inquired about the difference in difficulty between cleaning tiled surfaces versus painted ones. Council members also discussed using larger six-inchby-six-inch tiles to replace the current four-inch ones.

The council voted to approve the \$92,000 contract bid plus tax to cover any additional charges that might come up. Venting the air

The Bridgeport Library has received funds from NCW Libraries as part of a systemwide renovation of its network of branches. Mayor Janet Conklin said the local branch approached the city last summer to request that the city agree to make a portion of specific upgrades.

The library submitted a

contract to the mayor asking the city to install a ventilation system to bring fresh outside air into the building. Dezellem estimated the city's cost at \$12,500 just for the unit alone, not including installation. He said the city would need to cut the access in the roof and hire a contractor to seal the access after the unit is installed.

This type of system has been growing in popularity possibly due to the Covid pandemic, said Dezellem, and more buildings and high-scale home projects are incorporating ventilation design that brings in outside air.

Mayor Conklin said she has scheduled another meeting with the library to discuss the project and possible options and will bring the results to a future meeting.







Mildred Ruth Carr Powell. age 90, was taken home to Heaven on February 10, 2023.

She was an active member of Calvary Baptist Church in Brewster for over 60 years, where she played the piano and organ and taught Sunday School for many of those years.

Born in Lubbock, Texas on September 6, 1932 to Ora and Galen (Pappy) Carr, she was raised with her siblings, Galen and Margaret, eight miles from Abernathy, Texas, on the family's dairy and cotton farm.

At age 16, she was Salutatorian of Abernathy High School's class of 1949. That fall, she attended Texas Tech. Besides her classes, she worked as Assistant to the Dean of Students and did runway modeling for Hemphill-Wells Department Store.

On August 31, 1951, Millie married her high school sweetheart, Travis (Mike) Powell, who started his apprenticeship in the I.B.E.W. From 1952 to 1959, they were blessed with four children: Michael, Marilyn, Dawn and Kenneth.

In 1961, the family moved to Soap Lake, Washington, following Travis' work as a journeyman electrician. They moved to Brewster in 1964, and two years later bought a 40-acre farm where they could enjoy their ever-evolving menagerie: horses, cattle, chickens, pigs, ducks, dogs, cats, coyote, rabbits, quail, mudhens, weasels and any other creatures the kids or husband would bring home. They developed what had been Freeman's Berry Farm into alfalfa and pasture. Eventually, an apple orchard replaced the alfalfa.

Besides her busy farming life, Millie packed apples for many years; then ran the rural mail route for 18 years. In retirement, she taught first grade at the Calvary Baptist Christian School, volunteered as a mentor in the HOSTS reading program, was secretary for the TV District and was president of Christian Women's Club. In 1977, at age 45, Millie returned to college to finish her degree. She earned a BA in English and Education from Fort Wright College. Also at this time, she took up skiing, 20 years of Bloomsday Runs and story-writing. She developed in her family a firm grasp of the English language and a powerful appreciation of literature. She was an amazing cook, seamstress, and quilter hosting many sessions around a quilting frame. She instilled a firm faith in God and family. Gardening was a passion and necessity - continually canning, freezing and drying the farm's bounty. Spare time was filled as a Den mother, Camp-Fire leader, and helping with countless 4-H projects. Travis and Millie's love of the outdoors led to family hunting, camping and fishing trips throughout the decades.



They enjoyed many road trips and visiting relatives across the country. When Travis was working on the Trans-Alaska pipeline in the early 1980's, Millie was able to join him for a week at his work camp in Prudhoe Bay.

When cancer took Travis away in 2003, they had been married almost 52 years.

A few years later, Millie found friendship and shared the love of the outdoors with family friend, Larry Boyd, who became her close companion for many years before his death in 2020.



Q: After my knee replacement surgery, my surgeon recommended I take a stool softener for a couple of weeks to prevent constipation from my pain medicine. How does that work?

Many surgeons advise their patients to take a stool softener while taking pain medication during the first couple of weeks after surgery. They hope taking a stool softener will help you avoid the discomfort of constipation. This practice has been called into question because very little evidence proves it works.

The word laxative means "to loosen," similar to the word "relax" and "lax," which means to act loose or relaxed. A laxative works to "loosen" vour bowels, relieving constipation. By encouraging the movement of stool through your intestines, a laxative can prevent or reduce the pain and pressure of constipation.

Stool softeners make your stool softer or "slippery," which makes defecation more comfortable but doesn't prevent or relieve constipation.

After you swallow it, food moves through your digestive tract, a series of tubes. In your stomach, gastric juices mix into your chewed food, which starts the process of digestion. From there, it moves as a liquid mass into your small intestine, where the absorption of vital nutri-

Muscles running the length of your intestines start squeezing in a rhythm, which keeps the mass of food moving from one end to the other. To assist digestion and absorption, your intestines

are lined with special cells designed to carry nutrients, medicines, and water out of your intestines into your bloodstream. What's left behind eventually becomes feces.

The longer food stays in your intestine, the more water can be pulled out of your stool. With less water, your feces becomes smaller, harder, and more painful to eliminate.

A stool softener can draw moisture back into or lubricate the food mass to ease the discomfort of constipation. Two common stool softeners are docusate and mineral oil.

Docusate is a surfactant, much like detergent or soap. It encourages water to move into your stool. Docusate can replace some of the water your body absorbs as the stool moves through your intestine. It may occasionally cause diarrhea or stomach cramps. Unlike mineral oil, docusate doesn't interfere with the absorption of nutrients or vitamins.

Mineral oil is a liquid refined from crude oil. Unlike docusate, it lubricates the stool instead of increasing its water content. Mineral oil is colorless and odorless. The product "baby oil" is a scented version of mineral oil.

Used over a long period, mineral oil can interfere with your body's absorption of fat-soluble vitamins like vitamins A, D, E, and K. This can eventually cause a type of vitamin deficiency. Mineral oil can also cause leakage of stool from the rectum.



Accidentally inhaling mineral oil when swallowing can cause life-threatening lung irritation. Mineral oil usually stays in your intestine. However, if you take docusate and mineral oil together, mineral oil can move into your body, away from where

you need it to work. Docusate and mineral oil are called emollients. They turn stool "mushy" but don't directly stimulate the muscles lining your intestine. ("Mush instead of Push"). Most people notice results within 2 days, but the full effect can take up to five days.

Here are 6 Tips on Using a Stool Softener Effectively:

1. Stay hydrated.

Drinking enough fluids will help docusate do its job of moving water into your stool.

2. Avoid docusate sodium if you are on a sodiumrestricted diet.

Docusate has two forms, docusate sodium, and docusate calcium. If you restrict your sodium intake, choose docusate calcium instead of docusate sodium. Docusate calcium can be hard to find, so ask a pharmacist for assistance if you don't see it on the shelf.

3. If you have trouble swallowing pills, avoid 250mg docusate capsules.

The 250g and 100mg capsules are the same prices. I recommend buying the smaller 100mg capsules because the 250mg docusate capsules are HUGE and should never be cut.


4. Never cut or bite docusate capsules.

Docusate tastes HORRI-BLE because it is a soap! Avoid biting or cutting docusate capsules unless you prefer a nasty, soapy flavor that lingers for hours. Docusate liquid and syrup taste nearly as bad. At liquid taste tests I've hosted, they rank consistently at the very bottom.

5. Choose a laxative for constipation prevention or symptoms.

There is little evidence that docusate can prevent constipation. Using a nonprescription laxative like Senakot® and Dulcolax® is much more effective. Docusate is also available in combination with a laxative like senna or bisacodyl. Look for Senakot-S® and Peri-Colace®.
