## Poppy Days is Honoring all Veterans

Cashmere American Legion Auxiliary volunteers were distributing the familiar red handcrafted poppies honoring America's veterans in Cashmere on Saturday, May 22, outside of Doanes and at Martins Market Place.

Planned to coincide with Memorial Day, the annual event pays tribute to those veterans who have willingly served their country for decades. Memorial Day, originally called Decoration Day, is a day on which Americans remember and pay tribute to their ancestral family members. It is sometimes easy to forget the true significance of this solemn day.

Where did the poppy tradition originate? The poppy comes from the poem in Flanders Fields, written by Lt. Col. John McCrae. The poem refers to the poppies that grew out of newly dug soldiers' graves during World War I in Europe.

The American Legion Auxiliary adopted the poppy as its memorial flower in 1921 and started the Poppy Program in

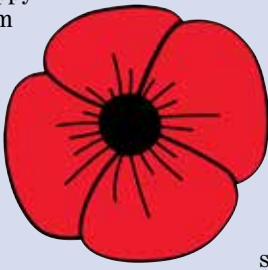

## Trailhead for Cashmere Canyons Preserve Officially Open

Public now has access to over 11 miles of trails on private land

**WENATCHEE** — The Chelan-Douglas Land Trust (CDLT) and Hay Canyon Ranch LLC opened the Cashmere Canyons Preserve to the public on Saturday, May 15. Although the preserve has been quietly open for the past month, it was officially opened with a small ceremony at the trailhead attended by Chelan County Commissioner Bob Bugert, Cashmere Mayor Jim Fletcher, Christine Mahler of the Washington State Wildlife & Recreation Program and representatives from the Washington Fish & Wildlife Department, as well as landowners, Jabe Blumenthal, Julie Edsforth and Don Poirier, CDLT Executive Director Curt Soper, key

Land Trust staff and supporters.

Cashmere Canyons Preserve is a 2100-acre preserve, privately-owned and protected for critical wildlife habitat. The preserve is permanently protected by a conservation easement held by CDLT who will also manage the trail system. The CDLT and the landowners have worked for the past two years on the development of a suitable trailhead to allow for public access to the preserve's over 11 miles of hiking trails. The preserve is open daily from dawn until dusk for foot



traffic only. Dogs and bikes are not permitted on the property.

The preserve has incredible wildflower displays and expansive views to the Enchantments, the Entiat Mountains and the Wenatchee Valley down to the Columbia River. The property's varying elevation, habitats and connectivity to other public lands make it valuable wildlife habitat and particularly resilient to the effects of a changing climate.

## McManus sets new Bulldog Record in 1600 meter race

Rob McManus, senior distance runner at Cashmere High School, set a new school record finishing in third place at the Tacoma High Performance track meet held at the Bellarmine Track and Field Bowl on Saturday May 15th. Rob's time of 4:10.90 betters the existing school record set by Shawn Anderson in 1987. The previous school record time was 4:15.6. McManus is the defending state champion in the 1600 run, winning the race as a sophomore in 2019. That was the last time the state meet was held due to the COVID outbreak. He was undefeated this year in the COVID shortened cross country season winning the North Central Region championship on April 1st by over 32 seconds. McManus was undefeated in all of his individual track races this spring running 800 meters in a personal best time of 1:56.31 (second best on the CHS All-Time Records list) and racing 9:45.16 in the 3200 run (third best in CHS history) to go along with his new school record in the 1600 run. He will be attending Montana State University on a scholarship next fall.

# ICE Unable to Track Most Illegal Immigrants Released Into Country

As thousands of illegal immigrants are released into the United States every week, the agency responsible for enforcement is unable to keep tabs on most of them.

Immigration and Customs Enforcement (ICE) Acting Director Tae Johnson admitted to Congress that “there’s certainly some gaps in our ability to track” illegal immigrants being released.

After being apprehended at the border, illegal immigrants are processed by Customs and Border Protection (CBP) to determine who they are and whether they’re subject to being immediately turned back under the current Title 42 public health provision.

Single adults from Spanish-speaking nations are almost all subject to immediate expulsion under Title 42, according to Acting CBP Commissioner Troy Miller. But Border Patrol is also encountering more illegal aliens from non-Spanish speaking nations, in particular Brazil and Haiti.

Of the 178,000 illegal border crossers encountered

in April, around 62 percent were expelled quickly under Title 42, according to CBP data.

The remaining 38 percent (or 68,000 individuals) were released into the interior (family units), into Health and Human Services custody (unaccompanied minors), or ICE custody (single

adults from non-Spanish-speaking nations).

In some border sectors, particularly the Rio Grande Valley in south Texas, the Border Patrol facilities have been so overwhelmed that many individuals weren’t released with the common Notice to Appear document that states a date and time to

appear in court. Rather, they received a Notice to Report, which is an honor system that requires the person to check in at their closest ICE facility within 60 days.

“For individuals that are just released with a notification to report to ICE or to show up in court, then our ability to track those folks

quite closely is much more limited,” Johnson said during a congressional hearing on May 13.

About 20,400 individuals have been released with a Notice to Report, and Johnson said ICE has no way to track those people or where they plan to reside, as the agency’s system doesn’t link to the information Border Patrol collects at the initial intake facility.

“Once they report to an ICE office, they’re put into our system of record, and at that point we can track those folks,” Johnson said. “But otherwise, we would just have to get a list from Border Patrol of the 20,000 cases and check them pretty regularly.”

Johnson said ICE has more success tracking individuals that are released under the alternatives to detention program, including those wearing an ankle monitor.

However, illegal immigrants regularly cut off their ankle bracelets or fail to honor their obligation to check in with ICE or turn up in court.

“Based on the number of individuals that we enrolled in alternatives to detention in FY20, we had about 11,000 individuals abscond from the program,” Johnson said. So far, in fiscal 2021 through March, Johnson said about 2,700 have absconded.

Under the agency’s narrowed criteria for priority removal, most of those who abscond won’t be a priority

for ICE to track down unless they commit an aggravated felony. Nationwide, the agency arrested 645 illegal aliens for removal in March and 1,152 in April, Johnson said.

## The Fall of Title 42

Johnson’s biggest concern is the impending removal of Title 42.

President Donald Trump implemented Title 42 in March 2020, which effectively closed the border to nonessential travel in attempts to mitigate the spread of COVID-19.

It allowed for Border Patrol to turn back illegal border crossers almost immediately, rather than be placed in ICE custody for a more protracted process through deportation proceedings under Title 8.

Once Title 42 is revoked, the 3,000 to 3,500 single adults that Border Patrol is currently arresting on a daily basis will have to be accommodated by ICE.

At the same time, ICE has less capacity than it did during the previous border surge in 2019. ICE had around 55,000 detention beds in 2019; however the capacity was reduced to 30,000 beds in the fiscal 2021 appropriations package.

“Title 42 is absolutely critical,” Johnson said. “I don’t think it’s a situation where it’s going to just be lifted electively—we will be mandated, through some sort of court order, to lift it.”

## Lawmakers Demand Reinstatement of Space Force Officer Who Was Removed for Denouncing Critical Race Theory

A group of Republican lawmakers sent a letter to the acting secretary of the U.S. Space Force on May 19, urging him to immediately reinstate a lieutenant colonel who was relieved of his command after publishing a book that warned of the spread of Marxism and critical race theory (CRT) in the military.

Lt. Col. Matthew Lohmeier, a former instructor and fighter pilot, was relieved as commander of the 11th Space Warning Squadron “due to loss of trust and confidence in his ability to lead,” a Defense Department official told CNN on May 14.

The decision came after Lohmeier took part in podcasts to discuss his self-published book, titled “Irresistible Revolution: Marxism’s Goal of Conquest & the Unmaking of the American Military,” which warns against the spread of Marxism and CRT in the military.

During an appearance on the podcast “Information Operation,” Lohmeier criticized Defense Secretary Lloyd Austin’s agenda. The department deemed his comments to be “partisan political activity.”

In their letter, the two dozen Republicans expressed their alarm over the decision to relieve Lohmeier. They said it appeared to

reflect the development of an “increasingly politicized environment” in the Department of Defense, which has now manifested in the Space Force.

The lawmakers criticized the use of euphemisms such as “diversity training” in describing CRT. Such terms, they said, are “grotesque distortions of reality.”

CRT has gradually proliferated in recent decades through academia, government structures, school systems, and the corporate world. It redefines human history as a struggle between the “oppressors”—white people—and the “oppressed”—everybody else—similar to Marxism’s reduction of history to a struggle between the “bourgeois” and the “proletariat.” It labels institutions that emerged in majority-white societies as racist and “white supremacist.”

Like Marxism, CRT advocates for the destruction of institutions, such as the Western justice system, free-market economy, and orthodox religions, while demanding that they be replaced with institutions compliant with the theory’s ideology.

Proponents of CRT have

argued that the theory is merely “demonstrating how pervasive systemic racism truly is.”

“Those leaders who are complicit with this poisonous philosophy which promotes racial essentialism and collective guilt in our beloved military will be judged by history accordingly,” the lawmakers wrote. “Promoting critical race theory will disrupt the good order and discipline in the Space Force and eviscerate our nation’s ability to attract patriotic talent to serve in uniform and fight our wars.”

Signatory Rep. Doug Lamborn (R-Colo.) said in a statement that the military should focus on threats to U.S. national security and “not pandering to one political ideology.”

“I can’t imagine a better way to weaken ourselves in the midst of a great-power competition with China and Russia,” he said. “Lt. Col. Lohmeier listened to the Secretary of Defense and stood up against extremism on the left. He should be praised for his courage.”

Space Force officials didn’t respond to a request for comment by press time.

## House Passes Bill Approving \$1.9 Billion More for US Capitol Security

The House of Representatives voted on May 20 to approve \$1.9 billion to increase U.S. Capitol security in response to the Jan. 6 breach, with several left-wing “Squad” members voting either no or present.

The House voted 213–212 to approve the measure, which faces an uncertain future in the Senate, where 60 votes are needed to advance legislation.

Reps. Cori Bush (D-Mo.), Ilhan Omar (D-Minn.), and Ayanna Pressley (D-Mass.) voted no. Meanwhile, Reps. Jamaal Bowman (D-N.Y.), Alexandria Ocasio-Cortez (D-N.Y.), and Rashida Tlaib (D-Mich.) voted present. All other Democrats voted in favor and all Republicans voted against.

“This bill is not about politics. It’s not about settling scores,” Appropriations Committee Chairman Rosa DeLauro (D-Conn.) said on the floor of the chamber. “It’s about ensuring that every person who comes onto the Capitol grounds is safe and is protected. The funding is not optional.”

Republicans have said that while the GOP supports the U.S. Capitol Police and National Guard members who were deployed after the Jan. 6 breach, they view the bill as partisan and drafted without consideration for how the funds would be spent.

The bill would reimburse the National Guard for costs incurred when troops were deployed to the Capitol earlier this year, provide Capitol Police with overtime pay, and other resources. The bill would also create a response force that would aid Capitol Police during a crisis, as well as fortify doors and win-

dows at the building.

“House Dems just passed a Capitol security bill that costs \$3.5 million per member of Congress. Defund the Police for thee but not for me,” wrote Rep. Jim Banks (R-Ind.).

to establish a force within the D.C. National Guard to respond to incidents at the Capitol, raising serious concerns about the role of our military on American soil.” Rep. Kay Granger (R-Texas) added.

Senate Minority Leader Mitch McConnell (R-Ky.) indicated that the proposal needs another review when it heads to the Senate.

“We’re not sure what to spend the money on yet. So I think we are pushing the pause button here,” he said.

The three Democrats who voted against the measure said they don’t want to provide more funding for what they called police surveillance.

“This bill prioritizes more money for a broken system that has long upheld and protected the white supremacist violence we saw on display that day,” Bush, Omar, and Pressley said in a statement. Bowman, who voted present, told news outlets that he doesn’t want to provide “more funding to police budgets.”

The bill’s passage comes as the Pentagon confirmed at a news conference that the National Guard will be leaving the Capitol on May 23.

“We have received no request to extend it,” Department of Defense spokesman John Kirby said, referring to the National Guard deployment around the Capitol building.

# 20 Attorneys General Petition Biden Admin to Backtrack on CRT and '1619 Project'-Based Education Proposals

A joint letter by 20 state attorneys general directed to Education Secretary Miguel Cardona is asking the Biden administration to retract its education plans that would promote Critical Race Theory (CRT) and the New York Times' "1619 Project" in schools.

The group's criticism centers on recent proposals from the Department of Education that detail plans in April to provide grants under American History and Civics Education programs for a curriculum teaching diversity and the effects of "systemic marginalization."

The letter, led by Indiana Attorney General Todd Rokita, claims that the proposed priorities issued by the Education Department are a "thinly veiled" effort to insert CRT and the 1619 Project into American classrooms.

"As the chief legal officers of our respective states, we write to express our deep concerns with the proposed priorities recently issued by the United States Department of Education. The proposed priorities are a thinly veiled attempt at bringing into our states' classrooms the deeply flawed and controversial teachings of Critical Race Theory and the 1619 Project," reads the letter in part.

It further argues that the new education proposals would "distort" the accuracy of history, rendering it at odds with state and federal law.

"CRT is an ideological construct that analyzes and interprets American history and government primarily through the narrow prism of race. Similarly, the 1619 Project seeks to 'reframe the country's history.'

As such, it distorts, rather than illuminates, a proper and accurate understanding of our nation's history and governmental institutions and, therefore, is fundamentally at odds with federal and state law," state the attorneys general.

The ideas being put forward by the 1619 Project suggest that

the United States was founded on white supremacy and oppression and that these are still fundamental aspects of society.

The letter was signed by attorneys general from Alabama, Alaska, Arizona, Arkansas, Georgia, Idaho, Indiana, Kansas, Kentucky, Louisiana, Mississippi, Missouri, Montana, Nebraska, Ohio, Oklahoma, South Carolina, Texas, Utah, and West Virginia.

"The Department should not adopt the proposed rule or, at a minimum, should make clear that grants may not fund projects that are based on CRT, including any projects that characterize the United States as irredeemably racist or founded on principles of racism," they state.

Ibram X. Kendi's works are

specifically cited in the new priorities that progressive politicians want to implement, with the claim that they would reduce discrimination and racism.

They assert that the biggest issue is the impact of the theories being promoted on students, and urge the department not to embrace the proposed measures.

In criticism of the potential

adverse effect on students, the AGs refer to educator and political scientist Frederick Hess:

"Upon closer scrutiny, it quickly becomes apparent just how wholly Kendi's doctrine is at odds with American traditions of equality, free inquiry, and ordered liberty. Kendi holds that every single thing in the world—every action, idea, thought, and policy—is either 'racist' or 'anti-racist.'"

To illustrate their point, they give an example that demonstrates the unfairness of "equity"—a term that stems from the Marxist idea of absolute egalitarianism.

"Kendi helped lead the opposition against the selection process for the elite Boston Latin School, the Boston Latin Academy, and the John D. O'Bryant School of Math & Science," the letter reads.

"Relying heavily on a merit-based testing regime, Asian applicants received a disproportionately high number of the scarce 205 available seats. 'With COVID as a pretext, equity advocates set up a new system to fill the spots based on zip codes and grades, a plan that will result in a 24 percent reduction in Asians, an 18 percent reduction in whites, a 50 percent increase in blacks, and a 14 percent increase in Hispanics.'"

Another notable criticism is aimed at the proposal's alleged discrimination of students based on "privilege" or "oppressor" status based only on racial identity.

"Teaching this in a classroom clearly runs afoul of broad non-discrimination provisions adopted by many states to prevent the same sort of separatist teaching that the guidance attempts to integrate into schools through teachers and students," the letter maintains.

After attending the programs being put forward, the teachers would be violating Indiana law if they "indoctrinate students" discriminatorily, the coalition of attorneys general added.

The Department of Education told The Epoch Times: "We look forward to receiving the letter and responding directly to the signees."

## Rubio Unveils Bills Targeting China's Collection of Americans' DNA

Sen. Marco Rubio (R-Fla.) has introduced two bills to counter the Chinese regime's efforts to collect the genomic data of Americans through both legal and illegal means.

The Republican senator, who has been a leading voice in addressing the issue, introduced the Genomics Expenditures and National Security Enhancement (GENE) Act and The Genomics Data Security Act on May 20.

Beijing has for years been collecting large amounts of American health care data, using illegal methods such as cyber hacking, investments in American biotech companies, and partnerships with hospitals and universities to gain access to the sensitive information.

The National Counterintelligence and Security Center (NCSC) said in a fact sheet released on Feb. 1 that it poses serious privacy and national security risks.

"There is no reason for American taxpayers to be funding Beijing's research or for our policies to enable access to American's genomic data," Rubio said in a statement, announcing the legislation. "It's imperative that

Congress take steps to confront this growing national security and privacy threat."

Rubio's office said that the GENE Act, which is co-sponsored by Sen. John Cornyn (R-Texas), would increase congressional oversight by requiring the Committee on Foreign Investment in the United States (CFIUS) to include the Senate Select Committee on Intelligence and Senate Committee on Foreign Relations in its briefings.

It would also increase cross-agency awareness of "transactions of concern" by requiring that the Department of Health and Human Services (HHS) be consulted on any deal that involves a genetic data transaction.

Lastly, it would direct CFIUS to rewrite its regulations to require mandatory filing for any deal that involves a company working with genetic information, Rubio's office said.

Meanwhile, the senator's second bill seeks to prohibit any National Institutes of Health (NIH) funding from going to support entities with direct ties to the Chinese regime.

It would also require that every Clinical Laboratory Improvement Amendments Act

certificate specify if a company with access to Americans' health data is directly tied to Beijing.

Vast amounts of genomic information (a person's entire genetic sequence) can fuel developments in the cutting-edge field of precision medicine (or personalized medicine), allowing China to overtake the United States to become a global leader in biotech, according to the NCSC. Such data can also be weaponized to target individuals in the country for intelligence and military operations.

A 2019 report found that at least 15 Chinese firms were licensed to perform genetic testing or sequencing on U.S. patients, giving them access to genetic data.

Americans' genomic information is particularly valuable to China due to the ethnic diversity of the U.S. population, the paper noted. This is because varied data sets are more useful in research to identify genetic diseases. The Chinese regime last year passed laws to severely limit the ability of foreign firms to access Chinese people's biological data.

## Ohio Vaccination Rate Surges After \$5 Million Lottery Announcement

New York, Maryland rolling out similar programs

The COVID-19 vaccination rate in the state of Ohio has surged after Gov. Mike DeWine announced that five residents will win \$1 million each as a monetary incentive for getting inoculated, health officials said this week.

Ohio's Department of Health said on May 20 that from May 14 to 17, vaccination rates for people 16 and older jumped 28 percent. The Republican governor announced the state's incentive program, named "Ohio Vax-a-Million," on May 12.

Under the "Ohio Vax-a-Million," which will be funded by existing federal pandemic relief funds, Ohio residents who are at least 18 years old and have received "at least" one dose of the COVID-19 vaccine are eligible to win the sum in once-a-week lottery drawings, the governor announced last week.

The first drawing will occur on May 26, DeWine said at the time, noting that the Ohio Department of Health will be the sponsoring agency for the drawings and the state Lottery will conduct them.

"This dramatic increase in vaccinations indicates that

the Vax-a-Million drawing has been impactful in creating momentum for vaccinations throughout Ohio," Stephanie McCloud, director of the state's health department. "We are grateful that the drawings are helping spur Ohioans to take this important measure to protect their health, their loved ones, and their community."

A separate incentive for younger Ohio residents will see five vaccinated 12- to 17-year-old students receive full four-year scholarships to attend Ohio public universities, including tuition, room, board, and books.

New York and Maryland on May 20 also announced that they will be rolling out similar vaccine incentive programs.

New York Gov. Andrew Cuomo told reporters that New Yorkers who get vaccinated from Monday to Friday next week will be given a lottery ticket with a cash prize of as much as \$5 million.

Meanwhile, a vaccinated Marylander will be chosen at random daily for a \$40,000 prize, starting July 3 and ending July 4, Gov. Larry Hogan. He said that one person will receive a grand prize of \$400,000.

Companies have also started offering incentives as part of an effort to encourage Americans to get vaccinated. For example, Krispy Kreme stores are offering one free glazed doughnut for people who show that they have had one or two shots of any COVID-19 vaccine.

## Q My doctor says I need to take a calcium supplement. Which one is the best and how much of it do I need to take?

Your muscles, nerves and blood vessels depend on calcium to work properly. If there is not enough calcium in your blood for your muscles and nerves, your body will grab calcium right out of your bones to make it up. Over time, you lose more and more bone until something gives: your hip breaks or your backbone collapses.

How do you know if you are getting enough calcium to prevent this from happening to you? The Institute of Medicine recommends 1000mg daily of calcium for men and women up to age 50, and 1200mg for adults older than 50 years of age. The National Institutes of Health recommends more calcium for postmenopausal women:

1500mg daily for women who are postmenopausal but not taking an estrogen supplement, and 1500mg for all women age 65 and older. These recommended amounts of calcium refer to the actual amount of calcium mineral in each pill, also called elemental calcium. For example, each Citracal® tablet contains only 21% of elemental calcium, and Caltrate® has 40% elemental calcium in each tablet.

If you are taking a medicine to prevent or treat bone loss (such as Fosamax® or alendronate, Actonel® or risendronate, Boniva® or calcitonin nose spray) it's extra important to get plenty of calcium every day because these medicines work by putting calcium back into bones. It's important to have

enough calcium in your body so these medicines can do their job.

You'll get about 300mg of calcium daily from your diet, including beans, nuts, and green vegetables, with an additional 300mg of calcium for every 8 ounce glass of milk, fortified orange juice, yogurt, or 1.5 ounces of cheese you consume. Most men need 600mg and most women will need 600mg to 1200mg daily of a calcium supplement.

Most calcium supplements have either calcium carbonate or calcium citrate, with brand names and generics to choose from. Calcium carbonate is nearly twice as concentrated in elemental calcium as calcium citrate. The most concentrated are TUMS® antacid tablets,

available as 500mg, 750mg and 1000mg each. Caltrate®, OsCal®, and Viactiv® each contain either 500mg or 600mg of calcium carbonate. Citracal® has calcium citrate in a variety of strengths, from 200mg to a slow-release form containing 600mg. Citracal® Gummies use tricalcium phosphate.

It's best to pick a calcium supplement that you are willing and able to take regularly. A bottle of calcium pills sitting on the shelf because they're too big to swallow won't help your bones! Here are some tips to help you out:

### 6 Tips For Selecting A Calcium Supplement:

**1. Most women need 1000-1200mg of elemental calcium as a daily supplement.** That's two each of calcium carbonate or about four each of calcium citrate for women, and half of that dose for men over 60 years of age. Most calcium supplements show calcium content on the label by a serving size of 2 each.

### 2. Take supplemental

### Vitamin D to help your body absorb calcium.

Vitamin D is now recommended as 600 IU daily for folks up to 70 years of age and 800 IU daily for those over 70. You can also get Vitamin D from salmon (800 IU per 3 ounces), canned tuna (150 IU per 3 ounces), fortified milk (about 120 IU per 4 ounces), and fortified orange juice (80 IU per 4 ounces). Most calcium supplements contain Vitamin D but you can also take it separately.

### 3. Maintain an adequate water or fluid intake to avoid kidney stones.

Calcium is not very soluble in water, and can form painful crystals or stones inside your kidney. Calcium citrate is less likely to do this than calcium carbonate supplements; talk to your doctor first before taking calcium if you have had kidney stones in the past.

### 4. Choose calcium citrate if you take any medicines for stomach acidity, stomach ulcer, or hiatal hernia.

Prilosec® or omeprazole, Prevacid® or lansoprazole, Zantac® or ranitidine, and other medicines like these reduce the acid in your stomach. Calcium



carbonate needs an acidic stomach to be completely absorbed; calcium citrate is well absorbed regardless.

### 5. If you have trouble with constipation, avoid calcium carbonate.

### 6. Take advantage of chewable calcium if you can't swallow large pills.

If you hate to take big pills like me (I tend to gag on them or get them stuck partway down), try smaller tablets (Citracal® Petites), caramel-like chews (Viactiv®), or new gumdrop-like "gummies" (Caltrate®, Citracal®).

"Our hope is that 100 years from now, when the population of the valley has doubled or tripled, there will still be places where one can see deer and bear, cougars and coyotes, rattlesnakes and raptors, and on lucky days walk in total solitude surrounded by a sea of wildflowers; where people can be neither above nor separate from nature, but in its midst. If that's still possible, it won't be by accident nor the

result of 'business as usual.' It will happen, or not, because of the conscious choices and investments made by the people and institutions of the Wenatchee Valley today," Said landowner Jabe Blumenthal.

# The Washington Outdoors Report

## Outdoors Roundup

There's a lot of news to cover this week when it comes to the outdoors in our region so let's get to it:

**Fishers Breeding In Chelan County** – The Washington Department of Fish and Wildlife reports the birth of first wild fishers in the North Cascades in a half century. Fishers are a house-cat sized member of the weasel family and were eliminated in Washington by the mid-1900s. They are listed as an endangered species.

Between 2018 and 2020, WDFW, the National Park Service, Conservation Northwest and the Calgary Zoo released 89 of these animals into North Cascades National Park and the Mount Baker-Snoqualmie National Forest. Four young kits from one of these fishers was seen on a trail camera set up near its den in Western Chelan County.

**Icele River Opens To Salmon Fishing** – Despite very low returns of Spring Chinook up the Columbia and Snake Rivers this year, state fisheries biologists believe they will have enough of these hatchery-raised chinook salmon return to the Leavenworth hatchery to provide a fishery. Salmon fishing opened on May 22 and is scheduled to go until June 30 though it may close sooner than that if the number of

returning fish is lower than expected. Traditionally, the end of May and early June provide the best fishing on this small stream. The limit is two hatchery chinook salmon a day with a minimum size of 12-inches.

**Trout Stocked In Lake Roosevelt** – Speaking of hatchery fish, WDFW along with the Spokane and Colville Tribes are teaming up to plant some 485,000 fish this month in 151-mile-long Lake Roosevelt. The fish are all triploid rainbow trout and they contain an extra set of chromosomes that renders them sterile but turns them into eating machines. Many of the fish are only 8 to 12-inches long right now but within a few months they'll grow to 18-inches. Others being released in the lower third of the lake already weigh around one pound.

**Potholes Bass Fishing Hot** – Bass fishing is very good in the sand dunes of Potholes Reservoir right now. Largemouth bass are in shallow water on spawning beds and walleye are also in this area of the lake as well. For the bass fish less than six feet deep with weedless jigs and craw trailers, plastic worms and shallow running or lipless crankbaits. My long-time fishing partner Rusty Johnston and I fished this part of the lake last week and hooked some 20 bass, the vast

majority of them between 2 and 3 pounds, along with a bonus 3-pound walleye.

If you prefer trout, Pete Fisher at MarDon Resort suggests trolling for them near Perch Point or in front of the state park. If you don't have a boat Medicare Beach on the east side of the lake is the place to go or you can explore some of the seep lakes below Potholes Reservoir which have also been producing good numbers of rainbows.

**Catfish Are Biting In The Gorge** – According to staff at Gorge Outfitters Supply, Catfish catches out of the mouth of the John Day and ponds adjoining the Columbia River near Rufus have been great and there have been lots of big cats caught too. This should make for an interesting annual Gorge Outfitters Supply Catfish Derby on May 29th and 30th. Entrants will be fishing the lower John Day River arm for this contest hoping for a big fish prize. In addition to prizes for big catfish there will also be raffles, and included in your entry fee is dinner and country music after the contest ends. You can register at the store in Rufus for \$55 and get details at the Gorge Outfitters Supply Facebook page.
