### Company, Makers of Aplets & Cotlets Candies, To Close

Cashmere - After more than 100 years of business, Liberty Orchards Company, the Washington State family-owned makers of Aplets & Cotlets candies, will close operations by June 2021. The Company will continue to seek a buyer for the assets, including the brands, the production equipment, and the factory and warehouse buildings.

The company's Board of Directors and Shareholders wish to thank its many employees, its long-time suppliers, the people of Cashmere, where the factory and retail store are located, and its customers from around the globe for their loyalty over the last century.

The company was founded in 1920 by two Armenian immigrants, Mark Balaban and Armen Tertsagian, who bought a small apple orchard and were inspired to use their surplus fruit to create Aplets, an apple and walnut confection based on Locoum, the famous Near East candy popularly known as Turkish Delight. A few years later, a second product, Cotlets, made with apricots and walnuts, was introduced. Three generations of family members have managed the business since 1920. The founders' legacy was carried into the second generation by John Chakirian and Richard Odabashian, who ran the business from 1956 into the 1980s. Since then, Greg Taylor, the grandson of Armen Tertsagian, has served as the company's President. Besides Aplets & Cotlets, the company produces Fruit Delights, Dessert Delights, and Fruitlets, to name just a few of its products. More recently, the company created Orchard Bars, a nutritious fruitnut-seed bar, to meet the growing demand for gluten-free, non-GMO snacks. The company was founded by immigrants who came to this country as refugees, filled with gratitude, an entrepreneurial spirit. and a willingness to work hard. The family is immensely proud to have carried forward the founders' legacy in providing more than 100 years of the highest quality products and employment to generations of families in its community.

Cashmere Food Bank, Executive Director, Pam Leighton said that she and the committee have signed a 5year lease agreement with City of Cashmere. The new facility will be located at 316 River Drive and will be used for the food bank storage, and distribution center.

'We will clean and fix the flooring to accommodate the freezers and refrigerators, shelves," said Leighton who also stated that they will be applying for a Cares Act Grant to purchase a walk-in cooler to replace some of the freezers as they take up a lot of floor space. ## **Chelan County Sheriff Burnett: Short Term Rental rules** will only be enforced during normal work hours ... for now

He said most if not all county listeners understood that there was a huge difference between a criminal act and a code violation. The latter may be subjected to a fine, like a barking dog complaint, if the issue isn't corrected. After the initial response by the officer, a \$75 fine on second infraction or \$150 on third violation may result in an issuing of an order to appear in court. Details not vet set.

**MANSON** – At a recent Zoom meeting of the Manson Community Council (March 16), Chelan County Sheriff Brian Burnett explained that when the time comes to start enforcing Short Term Rental (STR) rules, it will be handled by a force of "code enforcement" sheriff's office officers who will be on duty Monday through Friday, during normal working hours.

Burnett went on to say that these officers must undergo similar police academy training on certain subjects like use-of-force, firearms and driving before they will be allowed on the streets to enforce STR issues. This learning curve is expected to last four weeks, but some applicants may take less time if they are already previously experienced law enforcement officers.

Once these criteria are met, candidates for the three positions would also be required to learn code enforcement. Burnett expects the county offices responsible for STR rules will be teaching staff the new rules. That would mean Chelan County Community Development staff.

Burnett said there would be one position (new hire) for Leavenworth, one for Chelan and one supernumerary as in an "at need" or "on call" basis.

Normal working hours in this case would mirror any other government agency's 8-5 or thereabouts office might even be subject to evening and weekend shifts within the code enforcement department.

As of right now, Burnett is asking for some "slack" as the entire concept is a fairly new one in the realm of county law enforcement and he sounded sure that minor tweaks will be an ongoing chore before the kinks are ironed out, hopefully by the fall season.

As far as the expected deployment of these officers, Burnett stated it would be around mid-May to early June.

He said he still needs to work with his staff to formulate a job description, policies and procedures as well as deal with sworn and administrative personnel and their respective unions.

The codes are due to be officially on the books around April 5, in time for tourist season. Burnett said there was a distinct difference between the expected Memorial Day crowd and the July Fourth tourists.

He noted the 4th tourists were perhaps a bit more rambunctious, but the code enforcers would already have boots on the ground, and with a little mud on them, by that time.

Burnett said the Leavenworth/Plain and Chelan/Manson areas are the two parts of the county expected to receive the most attention when STR rules start to apply.

Bob Bugert's (Leavenworth) district or, in the case of Lake Chelan, in Commissioner Tiffany Gering's district.

Perhaps the biggest surprise, as gauged by the reaction of MCC members, was the fact that these code enforcers will not be available 24/7 like the normal sheriff's office patrol deputies.

Burnett told them that in the meantime, complaints should be called-in to a non-emergency administrative phone voice mail for action beginning the following workday morning.

So, if you are complaining about loud noise or parking on a Saturday night, it isn't going to be handled by the Chelan County Sheriff Office (CCSO) department of code enforcement until Monday, depending on where your complaint might fall in the order of complaints received.

However, if you hear gunshots or see acts of violence or public safety concerns, then call the regular Rivercom emergency dispatch center and a deputy will be sent to that location asap.

Burnett said his office is experienced in serving warrants and legal notices and the like, but not in the area of STR's.

He clearly made sure the MCC members and a couple dozen citizen

Burnett said the regular CCSO patrol cars would be painted in silver and have lettering on the car stating: "Code Enforcement."

The enforcement officers would be armed and in uniform and that is why they must undergo police academy training, he said.

About 33 people, including MCC, staff and invited guests, attended the meeting.

They were also witness to Burnett's description of taking on this code enforcement challenge when he said he didn't really jump at the chance to take on this responsibility, but realized it was the best thing to do for the citizens of Chelan County.

"I try to be a team player" with the close cooperation of the Commissioners and the Community Development Department," he said.

He then asked the MCC and the entire STR-affected area to give him "a little bit of grace and patience" as he was hoping to iron out the kinks by a year from now, once tactics and policies are worked out.

# Taking Your Thyroid Medicine Successfully

**Q:** On my thyroid medicine bottle, there's an additional label that says to take it in the morning on an empty stomach. Sometimes I forget to take it before breakfast. Is it okay to take it later?

You're not alone in asking about this. The synthetic thyroid hormone levothyroxine the most prescribed is medication in the United States. My mother was always worried about what might happen if she didn't take her thyroid medicine "correctly." Taking her first bite of breakfast, if she saw her yellow levothyroxine tablet still waiting on the counter, she'd skip her dose that day.

"Louise, what if it can't be safely mixed with food? Could it start a chain reaction in my stomach?'

"Mom, if you do forget to take your thyroid medicine before you eat breakfast, the worst that could happen is your body won't get the full dose. That's because food can change how much of the levothyroxine your body can take in.

Taking it with breakfast gives you a lower dose, but skipping it guarantees you get none of your dose. Taking no thyroid medicine at all affects you more than accidentally taking it with food."

My mother wasn't the only one.

85-year old Ellen would set her alarm for 5 am every day to take her levothyroxine in the morning an hour before having breakfast. That's because otherwise, she'd forget about it altogether.

Ellen took medicines four times daily. She'd start with levothyroxine at 5 am, take her morning pills with her breakfast, a blood thinner medicine at 5 pm, and her cholesterol medicine at bedtime. She was taking her medication 4 times a day, which felt overwhelming.

"I want to take my medicines correctly, but it's so hard to remember to take all of them the way I'm supposed to."

I suggested she take her usual morning medicines at breakfast, then take her thyroid medicine, the blood thinner, and cholesterol medicine together at bedtime. That way, she only had to remember to take pills twice a day.

Within 2 weeks of taking her thyroid medicine at night, her improved consistency was paying off. Ellen told me she felt less overwhelmed and more energetic. Just as importantly, she no longer worries about taking her medicine correctly.

"It's such a relief to have less to remember and wonderful to have more energy!"

Your body processes and metabolism are controlled by the level of active thyroid hormone in your body. Your thyroid gland secretes a form of thyroid hormone called T3 or liothyronine into your bloodstream. Most of your T3 needs to

be converted to active thyroid hormone, called T4, in your tissues by specialized proteins called enzymes. Levothyroxine is a synthetic version of T4 that

> can be taken once daily. Your doctor monitors your thyroid hormone level by checking the amount of TSH in your blood. If TSH is too high, your body needs more thyroid hormone, and if TSH is too low, you need less. This may seem backward, but TSH is just a messenger, not thyroid hormone itself. Your doctor may also check your T4 level.

> If your TSH blood level is elevated or your T4 level is low, you need more levothyroxine (synthetic T4). Checking TSH 4-6 weeks later will confirm whether your thyroid hormones are back to normal.

Ways To Getting 5 the Most Out of Taking Levothyroxine: 1. Be consistent.

Levothyroxine is absorbed better if you take it on an empty stomach (30 minutes to an hour before a meal or 4 hours afterward). If you take it the same way every time, however, you'll get a consistent dose, and your thyroid level will be more stable.

2. Avoid taking levothyroxine with coffee or tea. Coffee and tea can decrease how much levothyroxine you absorb by nearly 30%. If possible, wait an hour after taking your thyroid supplement for your first cup of joe.



#### 3. Don't skip your dose.

Even if you forget to take it at your usual time, absorbing some of your thyroid supplement every day is far better than getting none.

any 4. Space out mineral supplements.

Some minerals interfere with levothyroxine absorption, including calcium, iron, aluminum, and multivitamin supplements containing those minerals. One solution is taking any multivitamin and mineral supplements later in the day, at least 4 hours before and after your levothyroxine. You can safely take multivitamins without any minerals with levothyroxine.

5. Try taking levothyroxine at bedtime.

If you avoid eating for 4 hours after your evening meal,

bedtime can be an ideal time to take levothyroxine. Dr. Louise Achey, Doctor of

are accustomed to constant rejection from others. Yet, we must remember that the Son of God, Christ Jesus, stepped into the depravity

of this world through his incarnation, and lived among wretches. Christ draws near to the sinner, inviting them to dine with him at his table so, in that closeness, they would be made whole.

Jesus is looking for sinners, that is why he came. In Mark 2:13-17, as Jesus was eating with tax collectors (the absolute dregs of Jewish society) and others, he was challenged by the religious leaders who were appalled that a Jewish Rabbi would ever dare to set foot in a sinner's home, let alone share a meal. Jesus replies in Mark 2:17, "Those who are well have no need of a physician, but those who are sick. I came not to call the righteous, but sinners.'

People error when they think that they must clean themselves up before ever coming fully to Christ. But it is Jesus who cleanses because he is the only one that has the power to do it effectually. We can try to change our behavior and have some marginal success or, attempt to "turn over a new leaf" but to deal with the radicalness of our sin and bring about true change, that can only come from Christ. Think of us as lepers, our bodies diseased and decaying. Yes, we can put on ointment and bandage our open wounds but due to the

spread of the disease and the pervasiveness of the decay, our

> efforts have very little effect. Yet, here walks Christ who is the Great Physician, and we turn to him and say, "Will you make me clean?' Moved with compassion and without one shred of disgust toward us, Christ replies "I will; be clean" (Mk. 2:41). That simple act of turning from the corruption and decay of our sin to Jesus in repentance and faith is all one has to do to

experience the mercy of Jesus and the salvation he brings.

What about those who have received salvation by faith and feel as if Christ is against them because they have sinned? Indeed, believers who are still plagued with the fallenness of this world will sin. The idea of "Sinless Perfectionism" is not only unbiblical but frankly untenable. None of us can love God or our neighbor perfectly as the Law demands and therefore as long as we are in this world, we will fall short. When a Christian sins, their conscience is pricked and due to the softness of their heart by the work of the Holy Spirit, they mourn over it. However, in that grief over our sin, we can easily fall into despair and believe the lie of the Devil that we have been cut off from God. forever condemned.

Believers who struggle with assurance have, on one hand, an appropriate view of sin. Sin is deadly, ruinous for the soul, and corrupts everything it touches. Yet, on the other hand, they fail to fully see Christ, in all his redemptive work.

To those struggling with sin, the worst thing you can do is run from Jesus. Instead, turn to him all the more and draw near because he will draw near to you (Jas. 4:8).

Your sin is great, make no doubt about that, but Christ's mercy is more.




