## Transmission line between Okanogan and Ophir substations energized



Substation

OKANOGAN - The transmission line between Okanogan and Ophir substations has been energized, 19 months after it was destroyed in the Cold Springs Wildfire.

The board of Okanogan County PUD commissioners heard the announcement at their April 11 meeting.

About 40 percent of the line was destroyed when the wildfire came through in September 2020, but the PUD decided to proactively upgrade the entire transmission line. The wooden poles have been replaced with steel structures and equipment has been upgraded as needed to allow for greater capacity.

The Okanogan to Ophir line has been energized

Crews will continue working on the Ophir-Brewster portion of the line, expecting completion early this summer. The total cost of the project has been estimated at \$13 million. The PUD expects about \$4.6 million in repayments from FEMA, but only about \$200,000 of that has been paid so far.

In other business April 11,

the board heard a financial report for 2021, showing a total of \$62.5 million in revenue over the year, \$45.1 million in expenses, \$4.3 million in debt service, and \$17.2 million in capital expenditures. The PUD ended the year within key performance indicators and anticipates official audited financial results by the end of May.

BREWSTER - For the first time in its history the Brewster Boys and Girls Club of Snohomish County (BGSC) has seen one of its members win Youth of the Year honors and the opportunity to compete for the state title.

Jennifer Valdovinos Aparicio, a Brewster High School senior, was one among nine finalists from across the state that won Youth of the Year for their regions and advanced to the state round of competition last March 24. There she competed against winners from clubs representing Skagit, King, Benton/Franklin, and Thurston counties, Southwest Washington, Olympic Peninsula, South Puget Sound, and Joint Base Lewis McChord for the Youth of the Year state title and the chance to compete at the regional and national level. The state winner was Johanna Gamboa from Skagit County.

Aparicio, a four-year club member, is active in several high school groups including Junior Staff of Power, World Language Club, Primero y Primeras, and FFA. She plans to attend college at Washing-

ton State University and major in surveying and mapping/civil engineering with the goal to one day be a surveyor.

Brewster Boys and Girls Club Executive Director Jamie Sluys said Aparicio received an \$8,000 scholarship for her YOY selection.

The Youth of the Year competition was established by the Boys and Girls Clubs of America (BGCA) as its premier recognition program for its members.

The rigorous competition includes essay writing, panel interview, and three-minute speech. Judges look for examples of community service, academic success, strong moral character, life goals, poise, and public speaking ability.

# AmeriCorps volunteers tackle Pateros Treehouse makeover

PATEROS - A new team of nine AmeriCorps NCCC (National Civilian Community Corps) volunteers arrived in Pateros earlier this month and one of the places they can be found is painting and prepping the inside of the Treehouse at 128 Independence Street for its upcoming reopening.

The Treehouse building that was once the Pateros Church of Christ was acquired by the non-profit Pateros Treehouse Early Education Organization (PTEEO) early last year with the help of a generous \$110,000 donation from Gebbers Farms, Chelan Fresh, and Apple House Warehouse & Storage, Inc. The donation met the matching funds requirement that allowed PTEEO to receive a \$540,000 Early Learning Facilities (ELF) grant from the Washington State Department of Commerce in May 2021.

District 15 and firefighters from several area stations were invited to use a double-wide manufactured home located just north of the church building as a controlled training burn as a useful way to remove the unsalvageable structure. avoid an overabundance of different plants.

# Bears record back-to-back sixth inning wins

**BREWSTER** – The Brewster Bears High School varsity baseball team continued their winning streak with back-to-back sixth inning wins over Meridian, 10-0, on April 7, and Lake Roosevelt, 11-1, on April 12.

The game against Meridian was much closer game than the score lets on, head coach Todd Phillips said.

“We were being no-hit through the fifth before we busted it open in the sixth,” said Phillips. “(We) had some early scoring opportunities, but we either failed to capitalize or they made a great defensive play.”

Reese Vassar’s 17 game hit streak came to an end when Meridian’s centerfielder made a phenomenal catch and play on the ball.

Pitcher AJ Woodward surrendered a leadoff single, then retired the next 17 batters before allowing his only walk of the game.

“Sixty pitches through six innings only allowing one guy on their team to reach base and striking out nine,” said Phillips. “AJ is doing a phenomenal job of keeping people off bases.”

Phillips said this Bears team has the potential to have the best fielding percentage of any team during his tenure at Brewster.

While the coach noted there was not much to talk about offensively for either team until the sixth inning, he summed up that inning this way:

Nico Maldonado broke up the no-no to lead off the sixth, Eric Ramirez walked, and Clayton Isensee bunted for a base hit to load the bases. Grant Baker singled to plate the first run of the game. Eric Ramirez scored on a wild pitch. Blake Burgett drew a walk and Brady Wulf was hit by a pitch to bring in another run. AJ then put the game out of reach by crushing a triple to clear the bases and scored on Vassar’s sacrifice fly. Maldonado was hit by a pitch, stole second and scored on Ramirez’s base hit. Isensee reached on an error and would score the tenth run of the inning when Grant Baker singled for the second time of the inning after a 12-pitch at bat.

Phillips described the action against a much-improved Raiders team from their first meeting two weeks ago:

First inning: We scored two in the first when Tyson Schertenleib walked, advanced on a balk and stolen base and scored on the Vassar single. Vassar advanced on a balk and stolen base and scored on a Maldonado sac fly.

Third inning: Burgett led off with a hit-by-pitch, stole second and scored on Vassar’s triple.

Fifth inning: Kash Vandelaç walked to start things off, stole second and advanced on an error and scored on Burgett’s single. Lake Roosevelt scored their lone run when Tyson Nicholson singled with one out and moved all around the bases on three passed balls.

Sixth inning: Pushed it to the ten-run rule when Maldonado and Woodward doubled back-to-back. Woodward then stole third and home. Isensee walked and stole second, advanced to third on an error and scored on a wild pitch. Vandelaç reached on an error and scored on a passed ball, error, then second passed ball. Burgett walked and scored on three wild pitches. Wulf walked, stole second, went to third on a fly ball out. Vassar walked, stole second and both scored on Maldonado’s second hit of the inning.

### Raiders routed in six

The Bears waited until the sixth inning to break the game open again.

“We were just trying to do too much at the plate,” Phillips said.

The coach said Wulf did a great job for his first start on the pitcher’s mound giving up zero hits in five innings.

How to get rid of annoying dandruff

Q: What is the best way to get rid of my annoying dandruff?

One of the most common skin conditions globally, nearly one-half of adults will experience the frustration and embarrassment of dandruff.

Dandruff happens when the skin cells on the skin of your scalp build up into thickened layers, then peel off as grayish-white flakes on your shoulders and upper back. Changes in your skin's oil production, physical or emotional stress, cold weather, and hormone changes can each trigger dandruff.

How Malassezia. If the top layer of your skin becomes damaged, that balance can get disrupted. If Malassezia is allowed to multiply beyond a healthy level, those additional organisms create byproducts that are irritating to your skin. This damages it further, triggering skin cells to multiply and stick together in thickened clumps, called scales. These scales eventually peel off as grayish-white flakes that show up in your hair and on your shoulders.

What is the best way to fight dandruff?

There are several products available. Antifungal shampoos are your best choice. They suppress the growth of Malassezia fungus. Shampoos containing a keratolytic loosen the skin cells clumped together, called scales, and work more slowly. Coal tar shampoos interfere with the growth of excess skin cells, reducing scale formation, and are the least effective.

Three antifungal shampoos are available without a prescription. The oldest product is pyrithione zinc, the active ingredient in Head and Shoulders® shampoo. Selenium sulfide is considered more effective than pyrithione zinc, and is available as 2.5% shampoo which is prescription only (Selsun®), and as 1% non-prescription shampoo, Selsun Blue®.

Other medicated shampoos marketed for dandruff work

When using a medicated shampoo, start by shampooing every day for the first week, then 2-3 times weekly for the next 2-3 weeks. Once your dandruff is under control, you can alternate with non-medicated shampoos. Dandruff can be persistent; you may need a medicated shampoo once weekly to maintain control.

Medicated shampoos can dry out your hair and scalp. Applying a hair conditioner after rinsing out a medicated shampoo won't interfere with its effectiveness, but may help reduce minor scalp irritation and ease itching.

Here 5 Ways to Help Defeat Dandruff:

1. Be gentle. To minimize scalp irritation that can encourage dandruff, try shampooing with non-medicated shampoo. To help loosen scales, soften them with mineral oil, coconut, or olive oil for at least 30

minutes before shampooing. If you have long hair, wetting it before applying the oil keeps it from soaking into your hair instead of your scalp. You can also use oil at night, gently scrub it into your skin with a toothbrush, and follow with shampoo in the morning.

2. Don't rush. Keep medicated shampoo on your hair for at least 5 minutes. When you start your shower, lather up with your medicated shampoo, then complete your shower before rinsing thoroughly.

3. Beware of staining. Coal tar can stain light hair, skin, and clothing. Selenium sulfide can stain your scalp, light-colored hair, and clothing yellowish brown.

4. Chill out. Physical or emotional stress can aggravate dandruff. Try getting more rest, or add a calming practice to your day, like meditation or yoga.

5. Consult your doctor. Dandruff is a mild form of a more severe skin condition called seborrheic dermatitis. Consult your doctor if you notice yellow, oily, scaly patches on your face, ears, or armpits, develop red, inflamed areas on your scalp or skin, or if you don't see any improvement in 4 weeks.
