# **Governor says cancel Thanksgiving and Christmas**

This week Governor Inslee called for everyone to cancel family gatherings for Thanksgiving and Christmas. He claims it is just too dangerous. He justifies this on the basis of an increasing number of cases.

He also called for a ban on out of state travel. Here is the press release from Governor Inslee's office on Friday:

Inslee issues travel advisory for Washington

Gov. Jay Inslee issued a travel advisorv for Washington, recommending a 14-day quarantine for interstate and international travel and asks residents to stay close to home. Inslee joined California Gov. Gavin Newsom and Oregon Gov. Kate Brown in urging visitors entering their states or returning home from travel outside these states to selfquarantine to slow the spread of the virus.

"COVID-19 cases have doubled in Washington over the past two weeks.

This puts our state in as dangerous a position today as we were in March," Inslee said. "Limiting and reducing travel is one way to reduce further spread of the disease. I am happy to partner with California and Oregon in this effort to help protect lives up and down the West Coast."

"California just surpassed a sobering threshold - one million COVID-19 cases – with no signs of the virus slowing down," said Newsom. "Increased cases are adding pressure on our hospital systems and threatening the lives of seniors, essential workers and vulnerable Californians. Travel increases the risk of spreading COVID-19 and we must all collectively increase our efforts at this time to keep the virus at bay and save lives."

"COVID-19 does not stop at state lines. As hospitals across the West are stretched to capacity, we must take steps to ensure travelers are not bringing this disease home with them," said Brown. "If you do not need to travel, you shouldn't.

This will be hard, especially with Thanksgiving around the corner. But the best way to keep your family safe is to stay close to home.'

In addition to urging individuals arriving from other states or countries to self-quarantine for 14 days after arrival, the states' travel advisories recommend individuals limit their interactions to their immediate household. The advisories define essential travel as travel for work and study, critical infrastructure support, economic services and supply chains, health, immediate medical care, and safety and security.

It is difficult to cover the issues of the COVID "Pandemic" without being accused of pushing fake news or expressing an opinion not based on scientific facts. It is not unlike trying to have a conversation about race.

The problem is that the issues have become so politically and socially sensitive that any disagreement about the policies immediately gets you tagged as insensitive.

That being said, it is time we started having a serious discussion about the issue of COVID-19 policy. This is a serious disease. It can have deadly consequences. The problem is the policies do not appear to be justified in the face of real impact of the disease or our experience to date. I wrote about this several months back and am not going to repeat it here. I am, however posting a couple articles this week that take issue with current policy.

It was not unreasonable that early in the year when little was known about this disease or how to treat it that restrictions were put in place to limit exposure. We now know a lot more. We can and have measured the risks. The danger is not as significant as once thought, and there is apparent hope that a vaccine may soon be available.

It is time to ask ourselves if the damage being done to our economy and the socialization and education of our children is worth it.

# **Rock Island** Mayor blasts fake pandemic An IQ Test

Shortly after the Covid lockdowns began this year, someone asked me what I thought was going on. I responded with; "It's an I.Q. test". Besides being humorous, I thought it might also be the latest Democrat attack on President Trump. To be honest, at the time I thought there might be a real possibility that some secret laboratory had created a truly deadly virus like Bubonic Plague, also known as the Black Death, and it had somehow gotten out. But over the months since then I believe my original suspicion has been confirmed. The amount of misinformation, disinformation and just plain fear mongering that we have witnessed since the beginning of this so called "pandemic" has been overwhelming. Original projections of the total possible deaths in the U.S. from Covid were up to two million. While that is a large number, as a percentage of the total population of the U.S. it's less than one percent (1%). For comparison, the European Bubonic Plague (the Black Death) of the 1300s killed almost one third (33%) of the entire continent's population. That's a real pandemic.

The official CDC numbers used in this article are as of October 16, 2020, which was the most current information available at the time. Also note that the "official" CDC Covid death count you constantly hear quoted is actually all Covid related deaths. According to the CDC that means all deaths where Covid was noted on the death certificate. What it does not mean is that Covid was the cause of death. While the CDC lists the official current number of Covid related deaths as 220,000, it apparently takes some time for the CDC to break them down into the categorized reports I used for this article. Finally, since we're talking about deaths, it should be noted that the last I was aware 100% of people die of something sooner or later.

So, with those things noted, according to the CDC the official number of Covid related deaths as of October 16, 2020 was 204,613. Ignoring the question of how accurate that number is for the moment, that would equal a death rate of six one hundredths of one percent (.06%) of the U.S. population (the U.S. population at the beginning of 2020 was 331 million). Not 30%, not 10%, not 1%, not one half of 1%, not even 1/10 of 1%, but slightly more than one half of one tenth of 1%! And this is what is being called a "pandemic", a "crisis" and a "national emergency"? The "reason" to lockdown America, destroy our economy, destroy small businesses, and give state governors the power of little banana republic dictators? Think about it, does that really make sense? According to the CDC, death certificates where Covid was the only listed cause of death is about 6% of the total Covid deaths. That would equal 12,277 of the 204,613 total Covid deaths. Unlike some people, I'm not trying to claim that there have only been 12,277 Covid deaths. On the other hand, to any honest person it should also be quite clear that we can't actually blame 100% of the official Covid deaths on Covid itself. Covid could have been anything from the final straw or simply a side note that had nothing at all to do with the death.

#### **Fake pandemic**

For example, 38,079 deaths were due to heart attack or heart failure. Did Covid cause the heart attack? Or did the person just happen to have Covid when they died of a heart attack. 6,871 deaths were due to accidents and suicide. Did Covid cause the motorcycle to have a head on with the semi truck, or did the rider just happen to have Covid when they hit the truck? 56% of the Covid deaths were associated with; respiratory issues (flu, pneumonia, etc.), circulatory issues (like heart attacks), sepsis, cancer (does Covid cause cancer?), comparison, according to the CDC, the deaths for the 2017-2018 flu season was around 61,000. Again, can we really consider Covid an end-of-theworld-as-we-know-it crisis? While the media and many in government would like you to believe that, it isn't.

I certainly don't want to belittle the pain and grief of those that have lost a loved one due to Covid but at the same time, as a society, we have to keep it in perspective. Especially in light of everything that has happened in America and around the world, supposedly because of Covid.

According to the CDC's 2018 Deaths and Mortality from accidents every year? Are heart attack and cancer victims any less important than Covid victims? There's certainly a lot more of them ... every single year.

Let's look at the death rate by age group. Please note that I had to use the Age Group Population numbers from July 2019 as those were the most recent ones available. Since the population in 2019 was less than it is for 2020, that actually makes the "odds of dying" numbers listed below a little higher than they really are. Below the age of 18 the odds of dying from Covid are almost nonexistent. There have been a total of 97 deaths in this age group. For the age group 18

diabetes, obesity, renal failure, Alzheimer, dementia and accidents. The point is, the real number of deaths actually caused by Covid is far less than the "official" total of 204,613.

The official combined Covid death rate for Chelan and Douglas counties is two one hundredths of one percent (.02%), which is one third of the official rate for the U.S. Just for fun, if we used our local rate as a more realistic percentage of the death rate, then the total U.S. deaths actually caused by Covid would be 67,522. For

report (the most recent year available), the total number of deaths in the U.S. was 2,813,503. Or put another way, on average 7,708 people die every single day in America. Heart disease was the leading cause with 647,457 (.20% of the total population). Cancer was next with 599,108 (.18% of the total population). Third was accidents with 169,936 (.05% of the total population). Do we shut down our economy, lockdown our citizens, spread hyperbole and fear because .05% of the population dies

to 39 the odds of dying from Covid are still miniscule. As a percentage of the total people in this age group there is a .003% chance of dying of Covid. Or in other words, a 99.997% chance of survival. The odds of being murdered are 60% higher than that. Have we closed all schools in America over fears of kids or the teachers being murdered? Why aren't we making students and teachers wear bullet proof vests and helmets? Doesn't anybody care about the children?

has a 99.6% chance of not dying from Covid! Looking at those facts, can you see any reason why our kids aren't in school? Why many of the college classes are online only? Why small businesses are shut down? Why there was any lockdown at all? Why Democrats want everyone to wear masks?

After spending billions of dollars for tests, the government is spending billions more to go out and randomly test people. We've seen a fair amount of this around the Valley lately. When they were testing Rock Island I asked the person in charge if the test would indicate how many people had already had the virus. I was told, no. 
The mandates, shut downs and other regulations made by our little dictator (Gov. Jay) Inslee are not just annoying but are totally lacking in any rationality. While I know some of these have been lifted, let's go over them. Government projects building are "essential" but private building projects aren't. Really? If I'm not sick, shouldn't I have the right to determine the amount of risk I'm willing to take? If no one else was wearing a mask, wouldn't I have the choice to stay home or wear a hazmat suit to protect

If I'm willing to take the risk of catching Covid in a restaurant, bar, hair salon, or any other sort of establishment where people gather, what right does the government have to tell me I can't? 

#### Veterans Hall for Wenatchee Valley opens in former Eagles banquet hall

**WENATCHEE** -- Wenatchee Mayor Frank Kuntz has designated a venue for a new Wenatchee Valley Veterans Hall, the former banquet room in the Fraternal Order of Eagles Aerie 204 on North Wenatchee Avenue.

Former Army vet George Turner, Marine vet Bob Ashford and Marine and Army vet Ron Bruno are the three local veterans responsible for organizing and creating this "safe space" for all vets, no matter what unit or branch they were in, or if they served in peace or war.

"We plan on hiring someone local to paint some murals to give the hall a lighter look. Right now, without windows, it is kind of claustrophobic and many veterans do not respond well to these type of rooms," said Ron Bruno, spokesman for the founding trio.

"We'd like to have a peaceful scene, maybe a beach, painted on the wall," he said.

Ashford said there will be colors (flags) representing every branch of service including the Merchant Marine and Coast Guard.

"The colors will be placed on the stage and lit. The colors will never be taken down for any reason, even if the Hall is rented by other groups," Ashford said.

The three men were adamant that no military criteria or membership will be required to visit the Hall, where Ashford

plans on serving coffee and donuts on the first Tuesday of every month from 8 a.m. to noon.

Plans for the room include kitchen facilities, an office and maintenance closet. It already has ADA approved restrooms. The room already has a large dance floor and small stage.

Army veteran Dan Beattiger will be the Secretary of the Hall organization. Douglas County Veterans Service Officer and Air Force veteran Sarah Simonson will also be involved.

The 3,000 square foot hall can accommodate about 250 people. No smoking or alcohol will be allowed in the Hall, but the Eagles club has a full bar and also serves food if anyone wants to step next door to buy those amenities

and consume them there, but Eagles membership would be required to be served.

That membership is \$42 annually, but a sponsor is required to apply for membership. Visit the Eagles for more information.

The Veterans Hall will have a private entrance apart from the Eagles and will not have any doors leading into the Eagles club.

The city of Wenatchee is leasing the Hall for the benefits of the veterans in the area. The old Veterans Hall at a former Catholic Church, was not considered a "dedicated" veterans' facility since it was often used by other citizens and groups of the Wenatchee community and was not always available to veterans.

Bruno states that any

veterans' organization will be able to use the Hall at no cost for whatever event they wish. The Hall will also be available for rent by individual veterans at no fee if the event is veteran related.

Other members of the community and organizations can also rent the Hall, but that fee hasn't been set yet.

For more information, email ron.bruno@frontier.com or call him, 509-679-2359. The Hall is in need of donations, both physical and financial, to get started, according to Bruno, but once the basic structural needs are met, it will be able to operate on a frugal budget.

want to work for your dinner the Washington Department of Fish and Wildlife reports, "Grant County is the state's top pheasant producer, averaging 12.000 birds harvested annually. Whitman County hunters harvested about 9,700 ring-necks a year over the past five years, followed by Walla Walla (7,100), Yakima (6,600) and Franklin (4,600) counties."

Another option for pheasant hunters? Pen-raised birds that are released on to several of our State Wildlife Areas. This pheasant stocking program is not as robust as it used to be and in Eastern Washington, bird plants often only occur two or three times a season. Traditionally, these plants occur before the youth hunt, before the general season opener in October and either

a few days or up to a week prior to Thanksgiving. You can download a document from WDFW with details about where these releases take place in Washington through this web link - https://wdfw. wa.gov/publications/02166

Turning from getting your holiday bird to cooking it I reached out to Ryan Neeley, the Marketing Manager for Camp Chef, who had some great advice about cooking turkey which applies to both the store bought and wild varieties:

1. Don't overcook that bird! The standard turkey with a pop-out red meat thermometer shows that it's done in your oven after the internal temperature reaches 190 degrees. Neeley says that temperature should be 165 degrees and that's why so many people suffer through a dry turkey meat holiday meal. 2. Instead of putting that turkey in the oven, consider cooking it in a pellet grill. Smoke flavored wood pellets can infuse the meat with flavoring. One popular option for holiday turkeys? Applewood pellets. As for cooking the bird, Camp Chef (and other companies) have internal thermometers in the grill you can insert into the breast of the bird. Neely suggests seasoning the bird over and under the skin. After that, just set the pellet grill to 300 degrees and cook the bird until the temperature reaches 165 degrees for a fantastic meal.

3. Want to put more flavoring into the bird and get moist meat out of it too? Consider using a Turkey Cannon, a large tube sold by Camp Chef. Fill the tube with water, herbs and spices, beer or wine. This puts the moisture in the middle of the bird and helps cook it from the inside out. If you are cooking a pheasant you can use

the 'beer can chicken" method of cooking it for similar results.

4. There's spatchcocking Neeley says too. this technique takes away from the presentation of the bird but since you are cutting it up anyway the flavor you get out of this cooking method makes it worthwhile. To spatchcock a bird you remove the spine from it, open up the bird, break the breastbone, and lay the bird flat on the grill. This helps the bird cook more evenly and also retains moisture in the meat.


information related to COVID-19.





#### History of the Pratt Building – Past to Present

Earlier known as: The Ellis Forde Building – 1907-1924

The Ludington Building – 1924-1974

One of the most interesting business lots in Cashmere is the present day Pratt Building, located on the southeast corner of Cottage Avenue and Aplets Way. More than eighty businesses have resided at this site. It is unknown if any building existed at this location before 1907 when the Ellis Forde Department Store was built, it was one of several chain stores in north central Washington owned by George T. Ellis and James E. Forde. The original building occupied 127 feet on Division Street (Aplets Way), and 88 feet on Cottage Avenue. It opened for business in Aug. 1908.

The Ellis Forde Company ceased operations in Cashmere in 1911, and the building was leased to the Mills Brothers Department Store (A. J. and W. H. Mills). The company later reorganized under W. H. Mills as Cashmere Mercantile. In 1914, the business was sold and the building leased to P. E. Hallum and William Birmingham. The name was changed to the Hallum and Birmingham Department Store.

A fire in Jan. 1915 destroyed much of the Cottage Avenue side of the building. The northwest corner where the Ardeta Park is located today was never rebuilt. This corner lot was occupied by a succession of gas stations from 1925 until 1963. The eastern part of the Cottage Avenue side of the building was repaired and leased to several businesses until 1924. After the 1915 fire, a blacksmith shop, several auto dealerships, a restaurant,

dealerships, a restaurant, a machine shop, two farm equipment businesses, and much later, the Cashmere Valley Record newspaper, occupied the Division Street side of the building.

In 1920, George Sussex Jr. bought the Ellis Forde

and Overland Auto Agency sold to James and William Terry and Frank Wardwell. Name changed to Service building, and in 1924, sold the property to B. W. Ludington who demolished the Cottage Avenue side of the building and built the new 60 x 45 foot Ludington Building and leased it to Tom Pinkerton for Pinkerton's Cafe. The back half of the original building remained intact and still exists today.

exists today. In 1946, Tom Pinkerton bought the property from Ludington and leased the cafe to Lilly Vickery. In 1948, Vickery bought the property from Pinkerton.

Musson of Wenatchee bought the property and leased parts of the building to different business for several years.


Bill Pratt arrived in Cashmere in 1971 and leased the NW corner of the building for his Chiropractic business. In 1974, Pratt bought the property from Musson. Pratt moved his business to the east side of the building in 1977. The Division Street side of the building was converted to a restaurant in 1981. A second story was added to the building in 1984. Bill Pratt still owns the building today.

# As COVID anxiety grows, tips to avoid crisis and conflict

STATEPOINT - Among mask mandates, social distancing, outspoken political views and personal challenges from the COVID-19 pandemic, there is a heightened risk for public spaces turning into places of conflict. According to experts at the Crisis Prevention Institute (CPI), the global leader in de-escalation training for over 40 years, mentally preparing and practicing responses can best ensure non-confrontational experiences. Potential challenging situations could include disagreements over mask requirements or social distancing, family gatherings, shopping lines, acclimating to more densely populated work environments or navigating political discussions.

"Having trained teachers, nurses and others who interact with the public, and being a social worker myself, I know the immense need for de-escalation training in the workplace and in everyday life," says Amber Belle, a global CPI trainer. "Learning conflict-prevention techniques can help ensure you have positive experiences in your community." CPI has identified probable areas of conflict and how to best mitigate tension. They recommend embracing four simple techniques to prevent and reduce conflict:

1. Avoid judgment. Understand that everyone has different life experiences and may be overwhelmed with struggles and anxiety from things

you know nothing about. Listen and focus on the feelings behind the message.

2. Don't take it personally. Another person's behavior is not about you. You are likely not the true target of someone's behavior. Tell vourself. "This may not be about the two of us; it may be about other issues in their life." Or repeat to yourself, "I'm going to be respectful. I'm going to be respectful."

3. Control your reactions. You can't control another person's behavior, but you can control how you react. Avoid

using facial expressions, gestures and language that could make another person feel anxious or defensive.

4. Be prepared if you have to engage. Have a plan to acknowledge and redirect. Here are some things you could potentially say:

• "Yeah. This year has been difficult on everyone."

• "I can understand where you're coming from."

• "We'll all be glad to have this pandemic behind us."

Over four decades, CPI has trained more than 15 million individuals in its techniques,

spanning many industries and professions, especially health care and education. CPI tracks violent incidents in the industries it trains, and data shows that de-escalation skills, when used correctly, can quickly decrease violence regardless of the industry. 

Chelan PUD will temporarily divert the river to allow crews to reinforce and stabilize the entrance of the fishway with concrete. Fish passage will be maintained during most of the \$370,000 project. The viewing platform will be closed to the public.

The work is expected to continue through January 2021. If weather or river flows delay the project this fall, the work may last into February or March 2021.


