# Gov. Inslee cuts ribbon to future in Cashiner

**CASHMERE** - Governor Jay Inslee cut the ceremonial grand opening ribbon at the old Cashmere Mill District site, Monday, Sept. 16, for the newest tenants of the Port of Chelan just constructed, multimillion dollar business park.

Both state representatives Mike Steele and Keith Goehner were in attendance as well as State Senator Brad Hawkins and Chelan County Commissioner Kevin Overbay.

The focus of the event was to show community support for Blue Spirits Distilling, LLC and Hurst International, LLC and it seemed to work quite well as the seating was full with another group of folks standing in various places.

The event was catered by

Cashmere's own Taqueria el Chavo and also featured a guided tour of the Hurst printing facility.

Governor Inslee said he was excited that this particular facility could produce 15 million fruit labels per day. He was personally guided on a tour by Hurst CEO Ari Lichtenberg.

Blue Spirits Managing Member Jeffrey Soehren announced he had already employed 20 workers averaging \$30 per hour.

Cashmere Mayor Jim Fletcher said that it was not too long ago that he worked with Jeff as an small business economic advisor. "He was working out of his garage in Chelan," Fletcher said.

Lichtenberg took the podium and promised the community that his company was "here to stay and working with agriculture companies PHOTO BY GARY BÉGIN/NCW MEDIA

is our future."

Soehren spoke to the audience and told them his company will become the "largest distiller in the state" once the Cashmere plant gets going at full capacity. Inslee told the crowd, "It isn't

often that the Department of Ecology is credited with job creation."

He was referring to the state department helping the Port of Chelan clean the former toxic waste site and making it suitable for new businesses.

The Port of Chelan's Commission President JC Baldwin was the emcee for the event and several other port commissioners from Chelan and Douglas county were also in attendance.

# Cashmere City Council

The Cashmere City Council met on Monday, September 9, for the first time since August 12, due to the cancellation of the meeting on August 26. There were five items on the business agenda. All council members were present with the exception of councilor Derick Pratt. The agenda was amended to approve streetlights.

The first scheduled business item was the agreement for legal services effective as of January 1, 2020, with the legal team of Ogden, Murphy, Wallace.

The second item was the contract for janitorial services for city hall and the city library. It was proposed to change janitorial services due to the receipt of a few complaints about the current service. It was proposed that the company that cleans the windows perform all janitorial services for both buildings at a slightly higher cost. The motion was accepted by all.

The third item on the business agenda was a professional service agreement with birdzeyephoto.com. Championed by Mayor Fletcher as his "pet project", he believes that it will be a great way to show the town from a "birds eye" view for possible developers.

The fourth item on the business agenda was the water resources drought agreement between the

Department of Ecology and the city for grant funds for well #10 improvements. A request for a \$50,000 grant was submitted by the city and was approved. Well #10 is not operational at the present time because the ground water level is too low. A grant request was submitted to put in a variable speed drive which would allow the speed on the well to be adjusted so it pumps at a rate where at least some water can be pumped when the water gets low. It was discussed that the well needs to be rehabilitated, with new pumps, cleanup and possible new construction. Steve Croci suggested that they take the grant money to rehabilitate the well so that it is operational and the city can get some water out of it. It was mentioned that during an intense storm this summer the surface water supply was shut down because the water was too turbid and the city was relying on one well which would not have been sufficient long term, so if well #10 was operational the city would be in a more comfortable position. The council agreed to accept the grant well #10 improvements unanimously.

Item five on the business agenda was the decision on an increase in water rates. Mayor Fletcher discussed how the city wants minimum balances in the operating fund each year and he would prefer if there was at least 90 days cash for working capital. He says that they are taking money out of the reserves right now and even if the water rates are raised by 4% as suggested, they are still reducing some of the reserves, but staying above the minimum for operating expenses.


The issue of raising the water rates has been a hot button issue during council meetings for some time now. Mayor Fletcher gave a presentation on what the balances in city funds would be every year until 2027 if the rates were increased by 0%, 3% and 5% and gave his opinion that a 4% increase is the best option. Mayor Fletcher justified his position by saying "we all want the lowest possible rates, but it's about longterm sustainability of our water system." Mayor Fletcher said that they could technically have no rate increase next year, but that would not be sustainable and the rates would eventually need to be raised anyway to make up for the revenue lost.

Councilor Kameon Smith said that she wished more members of the community were present at the meetings so the council could get their opinions on the rate increase, she also said that she would prefer the 4% increase because she would know what to expect each year. It was agreed upon that most of the public would rather have a level consistent increase rather than encountering larger, unexpected increases and that consistency is important.

Consider the "Green New Deal" a proposal that would ban airplanes, cows and require all buildings in the country to be rebuilt to new energy efficient standards.


If you think I am overstating

# Sleep Aids

Several years ago, Seattle Seahawks quarterback Russell Wilson shared his relentless work ethic in 2 phrases: The Separation is in the Preparation, and No Time 2 Sleep.

Sorry, Russ. You may be the highest paid football player in the National Football League right now, and a hardworking, compassionate and generous young man, but when it comes to sleep, you've got it wrong. You Need 2 sleep!

Arianna Huffington, founder of the successful news website the Huffington Post and author of the books Thrive and The Sleep Revolution: Transforming Your Life, One Night at a Time has credited getting adequate sleep as the key to her success: "When I get enough sleep, I am better at everything."

According to Ms. Huffington, Russell Wilson isn't the only one who devalues the need for sleep. Many Americans consider time spent sleeping as time NOT well spent. However, Amy Myers, M.D., physician and author of the book The Autoimmune Solution insists, "Sleep is medicine."

How much sleep should you get? According to the Sleep Foundation (www. sleepfoundation.org), most adults should get between 7 and 9 hours of sleep every night.

Ten years ago, my dad, an 82-year-old widower, faced surgery to replace his left knee. Rather than force him to stay at nursing home to recuperate from his surgery, I took some unused vacation time and took turns with my sisters to stay with him. We did the cooking, made sure he took his medicines and did his daily physical therapy exercises, and drove him to his doctor and physical therapy appointments until he was again able to do it himself.

"Dad, you need more sleep. Are you uncomfortable?"

"The pain pills work fine, Lulu. I've had trouble sleeping for years.'

"If you don't get more than 3 hours of sleep at night, you won't recover very fast from your surgery.'

At 6 foot one and 270 pounds, my father has never been sensitive to medicine, so I thought a non-prescription sleep aid could work for him.

Most over-the-counter (OTC) sleep-aid products contain a sedating antihistamine, either diphenhydramine or its close cousin, doxylamine. Instead of treating allergy symptoms like runny nose, itchy eyes and sneezing, these antihistamines are chosen because of their most noticeable side effect: drowsiness.

hydramine that night didn't help, so the next night we tried two tablets. Dad was smiling as I poured him coffee the

following morning. "I slept for five hours straight before waking up. It's been years since I've slept that well. That stuff really makes a difference."

According to a recent Pharmacy Times survey, the non-prescription sleep aids recommended most by pharmacists all contain diphenhydramine. The most recommended product was Unisom<sup>®</sup> with 35% of the votes and Tylenol PM took second place with 25%. Sominex® and zzQuil<sup>®</sup> tied for third place with 9% each of the votes.

#### Here are 5 Tips on **Using Non-Prescription Sleep Aids:**

1.Diphenhydramine is the most common and recommended ingredient.

Benadryl® is the most common form of diphenhydramine, available as a 25mg tablet or capsule sold in the allergy section and 50mg as the sleep aid Maximum Strength Unisom®.

#### 2. There are several formulas to choose from.

Unisom® is available both as diphenhydramine and doxylamine. zzQuil® contains the exact same medicine as Benadryl®. Tylenol PM® and Advil PM® each have a painkiller as well: there's an extra-strength 500mg tablet of Tylenol® in each Tylenol PM®, and Advil PM® contains one 200mg Advil® in each one.

#### Beware 3. of а "hangover" effect in the AM.

The sleepiness from doxylamine may last up to 10 hours compared to 6 hours for diphenhydramine. A longeracting sleep aid is not always an advantage because you may







feel "hung over" if the effects of your sleeping pill haven't worn off by the time you need to wake up.

#### 4.They're not for everyone.

If you get up in the night to use the bathroom, watch out; either diphenhydramine or doxylamine can cause dizziness and lightheadedness as well as blurred vision, urinary retention, dry mouth, constipation, and confusion. If you have constipation, prostate problems, urinary retention or take prescription sleep medicine, you should be very cautious or avoid them entirely.

#### 5. Take the lowest dose that works for you.


I suggest starting with just half a dose of any new sleeping pill, just in case it affects you more powerfully than you expect it to. If you're not sleepy within 30 minutes, go ahead and take the other half.

We all need 2 sleep. Sweet dreams!



Every September a diverse group of outdoors media professionals, tournament anglers and fishing guides as well as representatives from companies that make fishing gear and other outdoors products all head to the Columbia River Gorge. Their specific destination? The Peach Beach RV Park, located a stone's throw away from US 97 and the bridge that crosses into Oregon and into Biggs Junction.

The reason they come to the tidy, well-kept RV Park is to go to Fish Camp. For five days this group camps in the park, eats meals, socializes, networks and most of all, goes fishing. The annual event is the brainchild of Ed Iman, a promotor and well-known guide from The Dalles who pioneered walleye fishing on the Columbia River. The first gathering occurred in 2003. Originally called the Northwest Outdoor Writers Rendezvous, Ed says "Most of the writers couldn't spell rendezvous and decided to change the name of the event to Fish Camp. The new name stuck and the event became an annual, can't miss experience.

What you fish for depends on your fancy. There are lots of options to choose from. Most attendees head out in boats with guides for salmon, since the Fall Chinook tend to run hot and heavy off the mouth of the Deschutes and Klickitat Rivers at this time of year. Trolling or hover fishing are both good techniques to use that will draw strikes from salmon that often weigh over 20 pounds. If you prefer to fish opportunities to hook into a salmon or summer steelhead for anglers fishing bait, tossing spinners, or casting flies.

There's more than cold water species too. There is very good catch and release sturgeon fishing below the John Day Dam on the Columbia and sturgeon up to 11 ½ feet have been caught by attendees, most of whom report having very sore arms after the experience. This same stretch of the river, and for that matter, the Columbia from the Tri-Cities downstream to the Dalles, is also a good place to catch a walleye. However, September fishing can be challenging since the walleye tend to be gorged from all of the juvenile shad swimming in the river this time of year. Easier to catch, and plentiful to boot, are smallmouth bass. They can reach up to five pounds in size though the average fish runs between a half a pound to two pounds.

Another place for great smallmouth bass fishing is the John Day River. You can fish the mouth where it flows into the Columbia or fish further upstream, hiking along miles of trails that follow this scenic waterway through Cottonwood Canyon State Park. Try casting spinners or grubs for small, feisty bass more than happy to hit what you send their way. Pay attention though, because even though most of the bass are small in Cottonwood Canyon there are

a few lunkers.

Returning to camp there are fish stories to swap, salmon to fillet, salmon eggs to cure for bait and for a fortunate few, a nap before dinner. After a filling meal prepared by Ed's camp crew over camp stoves and Dutch ovens there are presentations given by the companies attending the event where new products are rolled out and the media members are given a chance to ask questions or try out samples.


Fellowship and networking follow as the day ends and a propane firepit tends to be a popular place to chat over drinks before everyone heads to bed and gets up to do it all again. It is certainly no chore to do so, it's a pleasure that brings many of the attendees back, myself included, for many years.

Ed Iman's Fish Camp is an invitation only event but the Peach Beach RV Park and MaryHill State Park next door are excellent places to camp and enjoy a September or October fishing vacation. 2. Put a firebreak around your fire.


3. Never leave fire unattended.




