PATEROS – Shortly before graduation day, June 4, more than a score of Pateros seniors officially committed to college and career choices on Gear Up College Signing Day, an

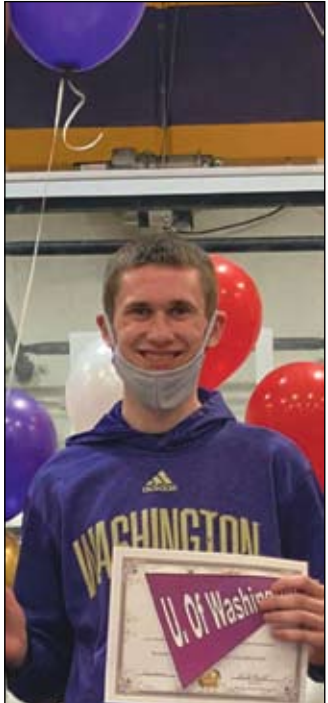
event that celebrates student achievement and for students to announce where they are going to college.

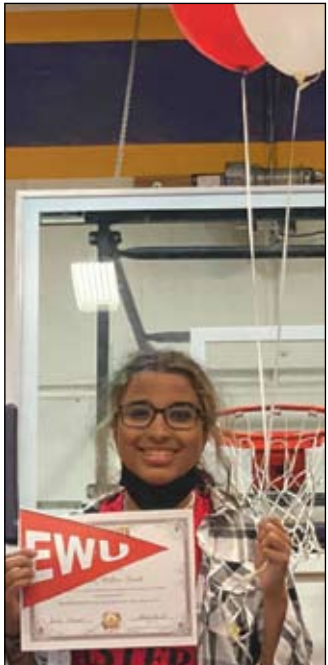

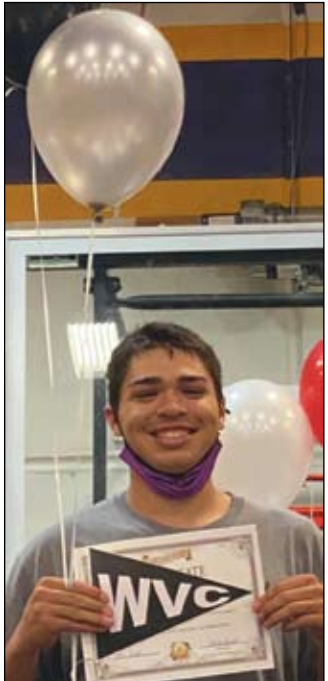

BRIDGEPORT – A stiff west wind blowing across the campus could not dilute the air of celebration surrounding commencement exercises of the Class of 2021 at Bridgeport High School last Friday afternoon, June 4.

## Legion Honor Guard turns out for Memorial Day services

BREWSTER – Memorial Day begins early for the dedicated citizens who are members of, or volunteer with, Columbia Post 97 of the Brewster American Legion. At the crack of dawn on Monday, May 31, nearly a dozen of them showed up at Locust Grove Cemetery to set out scores of large American flags that line the drive winding through the gravestones. Later in the morning six, who comprised this year's Honor Guard would return for the official proclamation, laying of the wreath, firing squad, and taps in the presence of citizens assembled to observe the ceremonies.

The Honor Guard services began at 9 a.m. at Pateros Memorial Cemetery where

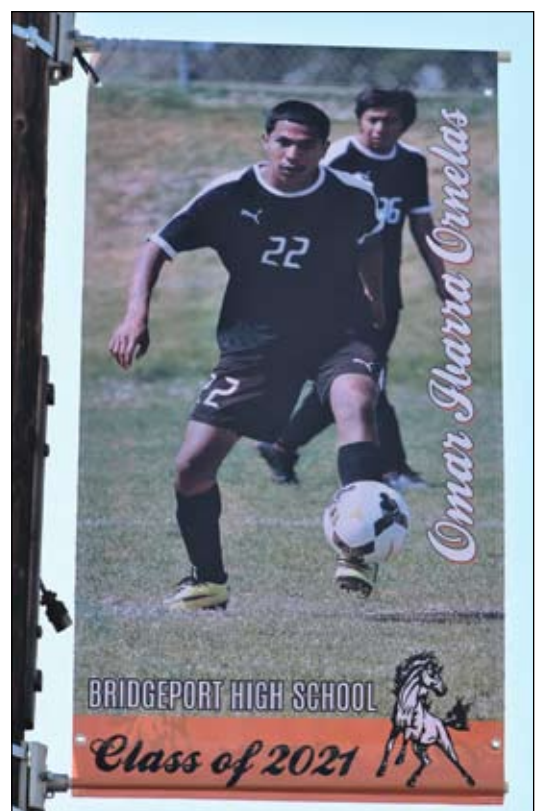

earlier the previous week volunteers with the Pateros Fire Department placed the large American flags that line Cemetery Road at the crest of the overlook. Among veterans buried there are Roy D. Baker who served with the U.S. Army in Korea, and George 'Roy' Gebbers who was an Army POW in the Philippines during WWII.

At 9:30 a.m. the Honor Guard paused on the middle of the Bridge Street bridge to dedicate a wreath in memory of those veterans lost at sea.

The Honor Guard's third of six stops was at Packwood Memorial Cemetery on Dyer Hill for a service among the pines and native plants at the rustic resting place. Among veterans interred there is WWII Navy veteran Raymond Spence, and WWII Army vet Eugene Housden.

An intimate gathering greeted the Legionnaires at Fort Okanogan Cemetery along State Route 97 north of Monse and the final resting

place of Korean War veterans Donald Woodward and John Cook, among others.

The largest crowd of the day welcomed the Honor Guard at Locust Grove where veterans buried there include Jake Holloway (WWII) and Navy veteran Claude Gillespie, whose father, David, founded

the Brewster Herald - later to become the Quad City Herald - in 1901.

The Honor Guard returned to its Brewster headquarters for the concluding service at the Legon Park memorial at noon where the day's temperature on the hot, sunny holiday would push 90 degrees.

# Pompeo Confirms Intense Opposition to Wuhan Lab Probe From State Department, Intelligence Bureaucracies

Former Secretary of State Mike Pompeo confirmed to The Epoch Times on June 3 that his efforts to get to the bottom of how the CCP virus—also known as the novel coronavirus—spread from China to the United States met with sustained opposition within the U.S. government.

[Officials] were explicitly told by colleagues not to explore the Wuhan Institute of Virology’s gain-of-function research.

Asked about revelations in a June 3 Vanity Fair report that key officials deep within the State Department sought to keep the public from knowing that U.S. funds had supported gain-of-function research at China’s Wuhan Institute of Virology (WIV), Pompeo described a “contentious battle.” That research, which focused on techniques for reconfiguring naturally occurring viruses to make them more virulent and transmissible to humans, was partially funded as far back as 2012 with U.S. tax dollars through the National Institutes

of Health and a nonprofit foundation known as the EcoHealth Alliance.

The Vanity Fair analysis “found that conflicts of interest, stemming in part from large government grants supporting controversial virology research, hampered the U.S. investigation into COVID-19’s origin at every step.”

“In one State Department meeting, officials seeking to demand transparency from the Chinese government say they were explicitly told by colleagues not to explore the Wuhan Institute of Virology’s gain-of-function research, because it would bring unwelcome attention to U.S. government funding of it,” the article reads.

China has insisted since the virus first appeared in late 2019 that it had spread from bats to humans via an open-air meat market in Wuhan. Some government and public health officials, private sector scientists, and investigative journalists, however, have said since early in 2020 that there’s substantial evidence that the virus spread somehow from the WIV.

Then-President Donald Trump and Pompeo, as well as Sen. Tom Cotton (R-Ark.), publicly noted the existence of such evidence in April 2020 and called on Chinese officials to allow independent investigators to access the WIV and its records. China refused to do so.

After the November 2020 election, Pompeo pushed

within the State Department and the Trump administration for public release of as much evidence as possible.

He issued a Jan. 15 statement that includes a significant disclosure, that WIV researchers appeared to have suffered virus symptoms months before the disease spread throughout China and to other countries, including the United States.

The statement also notes the gain-of-function research taking place at WIV and asks whether U.S. funding may have been diverted to secret Chinese military projects at the WIV.

But even getting that statement out was a struggle, Pompeo told The Epoch Times on June 3.

“I became aware at the end of 2020 that we now had an increased level of confidence in the datapoints that supported what we put out in the middle of January. The clock was clearly running, and I was fighting very hard inside the State Department and even more broadly,” he said.

A major roadblock was the fact that significant portions of the evidence were held by intelligence agencies that opposed their public release.

“There were places outside of the State Department that owned the dataset inside the intelligence community, so we were banging away to get them to give us as much space to write as much as we possi-

bly could,” Pompeo said. “We were drafting language that protected classified things that needed to be protected but we wanted to make sure that we got this information out in the public space.”

The former secretary of state said he viewed it as important at the time, and continues today to say that the American people should know all the facts, and the Chinese government should be held accountable if the virus did escape from the WIV.

“There were two reasons for that. One, it was a matter of transparency and, two, we

wanted the Chinese Communist Party to have to explain what we knew as well, so we had a very high degree of certainty around what we did,” Pompeo said. “The statement was very carefully crafted, but it is unambiguous about what it said.”

A former senior State Department official with direct knowledge of these matters, who spoke on background, told The Epoch Times that Pompeo made clear to everybody involved in the State Department’s investigation of the source of the virus that they were to pursue facts wherever they led.

When told of internal opposition to the effort, the former senior official said that Pompeo responded with a salty aphorism reflective of his Army career.

“He said, ‘Screw them and tell them the secretary of state said do it.’ And he also said something that’s very, very important. He said: ‘I don’t care what conclusion you guys dig out. It may be something we like to hear, politically, or something we don’t like to hear, but I want the truth.’ That was exactly the attitude throughout the whole investigation this group was doing.”

## Biden Orders Ban on 59 Chinese Defense and Tech Firms

WASHINGTON—President Joe Biden signed an executive order on June 3, amending a Trump-era ban that prohibits U.S. investors from investing in Chinese military companies. The new order expands the previous prohibition list by adding more Chinese defense and surveillance technology firms.

The order also moves the authority of selecting targeted companies to the Treasury Department from the Defense Department.

Biden’s order expands the scope of the national emergency declared by then-President Donald Trump last year and bans more companies involved in “the development or use of Chinese surveillance technology to facilitate repression or serious human rights abuse.”

The order “prohibits United States persons from engaging in the purchase or sale of any publicly traded securities” of 59 entities listed in the annex of the executive order.

Blacklisted companies include telecoms equipment maker Huawei, video surveillance manufacturer Hikvision, aerospace firm Aviation Industry Corp. of China, and state-run mobile operators China Mobile and China Telecom.

The Treasury Department will continue to update the list

of these Chinese entities. The selection will be determined by the Treasury secretary in consultation with the secretary of state and, if deemed appropriate, the Defense secretary, according to a White House factsheet.

The ban list doesn’t mention subsidiaries of these companies as the list is “intentionally targeted and scoped,” according to the factsheet.

The Trump administration targeted 44 Chinese military companies and intended to include publicly traded subsidiaries that were “50 percent or more owned” or “determined to be controlled” by those companies.

The new order, however, shrinks the scope of the ban by excluding subsidiaries.

The investment prohibitions will take effect on Aug. 2, but investors are permitted to make trades to divest their holding until June 3, 2022.

Sen. Marco Rubio (R-Fla.) raised concerns about Biden’s move to shift the authority to the Treasury Department.

“We know for a fact that Wall Street is helping to finance the Chinese Communist Party’s effort to weaken and ultimately replace American leadership,” Rubio said in a statement.

“While the administration updated the Trump-era policy in important ways, I am very concerned that President Biden’s Treasury Department is too closely aligned with Wall

Street to take the actions necessary to prevent American savings from being used to fund the Chinese Communist Party.”

In his final weeks in office, Trump took swift action to ban investments in Chinese military companies, in an effort to curb Beijing’s access to lucrative U.S. capital markets.

Trump’s order aimed to curb U.S. pension and retirement fund investments in companies that support the Chinese Communist Party (CCP). Many of these companies are publicly traded on stock exchanges around the world and are tracked by major indexes such as MSCI and FTSE.

The American Securities Association (ASA), which represents regional Main Street financial services companies, welcomed the new executive order.

“ASA strongly supports today’s action by the Biden Administration to prioritize America’s economic and national security interests by continuing the previous Administration’s crackdown on Communist China’s infiltration of the U.S. capital markets,” ASA CEO Chris Iacovella said in a statement.

“For far too long, the CCP has taken advantage of regulatory loopholes to fund its military rise, a cyber army that attacks us, ‘re-education camps’ used to perpetrate crimes against humanity on its own citizens, the use of slave labor in violation of international law, and its new position as the world’s leading polluter.”

## Google Reassigns Diversity Staffer Who Said Jews Have ‘Insatiable Appetite for War and Killing’

Google has reassigned a top diversity officer after critics noted he wrote years ago that Jews have an “insatiable appetite for war and killing,” the company said on June 2.

Kamau Bobb has been removed from Google’s diversity team, a spokesperson told The Epoch Times in an email.

Bobb was the company’s global lead for diversity strategy and research.

Roughly a decade before joining Google in 2018, Bobb wrote on his blog about how he would feel if he were Jewish.

“If I were a Jew I would be concerned about my insatiable appetite for war and killing in defense of myself,” he wrote. “Self-defense is undoubtedly an instinct, but I would be afraid of my increasing insensitivity to the suffering [of] others.”

Bobb reportedly sent an apology letter to colleagues at Google, writing in part: “What was intended as a critique of particular military action fed into anti-Semitic tropes and prejudice. I think we can all agree, there is no easy solution to this situation. But that’s beside the point. The way I expressed my views on that conflict [was] hurtful.”

Jewish groups had called for

Bobb’s firing. “Google must fire this anti-Semite,” the Simon Wiesenthal Center, a Jewish human rights group, said in a tweet.

The Coalition of Jewish Values wrote to Google CEO Sundar Pichai to urge him to immediately replace Bobb, indicating an apology was not sufficient.

Yaakov Menken, managing director of the coalition, told The Epoch Times that people can change their views, and perhaps the uproar over the old remarks could lead to a change in Bobb.

“We definitely believe people can change their views, and maybe this is waking him up to the fact that he imbibed anti-Semitic poison and that can be cured. But having him in a research position places him where he can do very little harm; being diversity lead was in a position where he could do tremendous damage to the very fabric, the very ideal of diversity,” he said.

Google’s spokesperson told The Epoch Times that company officials “unequivocally condemn the past writings by a member of our diversity team that are causing deep offense and pain to members of our Jewish community.”

“These writings are unquestionably hurtful. The author acknowledges this and has apologized. He will no longer be part of our diversity team going forward and will focus on his STEM work,” the spokesperson said.

“This has come at a time where we’ve seen an alarming increase in anti-Semitic attacks. Anti-Semitism is a vile prejudice that has given rise to unfathomable acts. It has no place in society and we stand with our Jewish community in condemning it.”

# Human Smuggling Leading to Pursuits, Bailouts, Crashes, School Lockdowns

UVALDE, Texas—A smuggler traveling at 140 mph races through town and crashes through a building in Uvalde, Texas. Another one drives onto a softball field in Crystal City, with children playing nearby.

In Del Rio, eight illegal aliens die after crashing head-on into another vehicle during a pursuit. Further east, in Lavaca County, a pickup truck carrying 18 to 20 illegal aliens crashes into a tree and bursts into flames.

In Kinney County, a smuggler fires an AK-47 out the vehicle window while fleeing from law enforcement, then passes the weapon to an illegal alien in the backseat to reload.

Many of the vehicles that smugglers are using to transport illegal aliens are stolen, and the unsuspecting owners won't get them back—they've been used in the commission of a crime.

If illegal aliens make it past Border Patrol at the U.S.-Mexico border, their goal is to get north to a large city as quickly as possible.

The average number of illegal aliens that Border Patrol detects evading capture along the southern border is about 1,000 per day. The number of those who go undetected is impossible to estimate.

While Uvalde sits about 65 miles north of the border, many roads converge in the town and high-speed chases with vehicles loaded with illegal immigrants have become a daily occurrence. And lured by the promise of quick cash, many U.S. citizens are providing transportation.

"Chases—that's something that we've never seen," Uvalde County Sheriff Ruben Nolasco told *The Epoch Times*.

"It's nonstop. Day after day, from sunup to sundown. Our deputies, our state troopers, our police officers, they're just frustrated, they're tired."

Today's illegal aliens are more violent than in previous years and will fight with law enforcement, Nolasco said. His deputies are also finding weapons in most of the smuggling vehicles they stop.

"And some of these traffickers have been found with 100-round drums [of ammunition] on their weapons," he said.

"There's always been a problem with [illegal] immigration, but nothing like this. We're like a welcome mat.

They're going to come in here and scrape the mud off on us and then they start going up to the bigger cities. And then, they can blend in and you won't have access to them."

Texas Gov. Greg Abbott deployed more state troopers to the border region in March, and Nolasco said it has helped, although it also has created a bottleneck in his jail.

"It's getting to the point that it's filling up my jail, so that's becoming a problem," Nolasco said on May 26.

Abbott issued a state of disaster declaration on June 1, which includes a directive to the Texas Department of Public Safety to ramp up its efforts in enforcing federal and state laws regarding offenses such as criminal trespassing, smuggling, and human trafficking. He also asked the state's Commission on Jail Standards to revise its standards to provide for more capacity in jails that have been operating under strict COVID-19 protocols.

Counties have been declaring local disasters since April 21.

## 48 School Lockdowns

Uvalde Mayor Don McLaughlin said local schools have been forced into frequent lockdowns in the past several months due to "bailouts" of illegal immigrants.

"We had a minimum of 48 different campus closures in Uvalde and five in Batesville during the spring semester. We had to hire off-duty officers for security at Anthon," McLaughlin said the school superintendent told him.

"They drive in and they bail out right by the schools." A bailout—now a common term in counties near the border—usually occurs when law enforcement is attempting to pull over a suspected smuggler with a load of illegal aliens. At some point, the smuggler slows or stops the vehicle and all the passengers scatter in different directions to avoid being caught.

"It's sad that all those small communities, and our law enforcement, are having to deal with this because it's eating up our budgets and we're neglecting our regular work for our citizens," McLaughlin told *The Epoch Times*.

"My other question is, while we're all over here chasing this car doing this, what's coming through that we're not catching?"

The small town of Cotulla, 70 miles north of Laredo on I-35 toward San Antonio, is being affected so much by illegal alien smuggling that the local school district sent a warning letter to parents and guardians.

"Please be watchful of your children as they are playing outside, walking home from school, or generally out of the house," the April 1 letter states. It's signed by Cotulla Independent School District Superintendent Jack Seals and La Salle County Sheriff Anthony Zertuche.

"Both our communities and the rural areas of the county have experienced a great increase in law enforcement chases and 'bailouts,'" the letter reads.

In Uvalde, Nolasco said children are scared.

"We have children that ride the school bus that live out in the country that are scared—they're scared to go home. If mom's working and dad's working and there's nobody there for them, they're going to open the door to their residence and find an illegal immigrant," he said.

"And mind you, you also have a lot of sex offenders that are coming into the United States—that's not good."

Border Patrol in the Del Rio Sector has apprehended 95 sex offenders so far this fiscal year, compared to six during the same period in fiscal 2020. Apprehension of criminals has topped 813, compared to 161 in the same period in fiscal 2020.

Nolasco said his deputies have been involved in catching the same smuggler three times in a six-week period. The smuggler, an illegal alien, was caught after a high-speed chase that carried on for more than 50 miles, he said.

"He bails out and the passengers bail out. We finally catch up to him and check with Border Patrol, and Border Patrol runs his name and says, 'Oh, yeah, he was just dealt with last week and he was released,'" he said.

"And here he is a week later. And that same thing happened about a month after that incident."

Nolasco, who has 14 deputies to cover 1,600 square miles, said 95 percent of his deputies' time is currently being spent on assisting Border Patrol with smugglers.

"It's valuable time and resources that are being spent on a federal issue. These monies and time should be invested in our local citizens here in this town," he said.

After being on the job for five months, the sheriff said he's not expecting federal help.

"All I hear is that we don't have a problem here at the border. No, I'm not going to get any help from the feds."

The White House has said it's focusing on the "root causes" of illegal immigration, particularly in the Central American countries of Honduras, Guatemala, and El Salvador.

4. Start low and go slow.  
When starting a new medicine, ask your doctor if you can start at the lowest dose possible. This usually means cutting a tablet in half and taking it like that for the first week or so. Then, if you are not having any problems, you can increase your dose up to taking the whole pill.

5. Speak up! Be a "Squeaky Wheel."

If you've noticed any changes in your thinking or balance since either starting one of your medicines or having its dose increased, don't suffer in silence. Instead, contact your doctor and inform them about it.

6. Don't stop your medicines on your own.

Don't stop any medicine you are already taking just because it's on a list! Check with your doctor first. Many medications should be tapered, not stopped cold turkey.

**Q: Are there medicines that I shouldn't take? How can I avoid taking them?**

You should definitely stay away from any medicines you're allergic to or that have caused you problems in the past. For example, if you are allergic to penicillin, taking amoxicillin (a type of penicillin) would be a very BAD IDEA.

Some medicines don't mix well with others. This can cause problems if one of the medicines is a common one that is available without a prescription, like taking ibuprofen for a headache when you take a prescription blood thinner. Your doctor or pharmacist can advise you if any over-the-counter (OTC) medicines shouldn't be taken with your current prescription medications.

As we age, our bodies change in ways that affect how we react to prescription and non-prescription medicines. The older we get, the less medication it takes to affect us. As a result, we become more likely to experience the "dark side" of taking drugs: annoying or dangerous side effects.

Getting older makes us more sensitive to the side effects of medication. Medications given to us to help us avoid health-related issues in the future can begin to cause us confusion, dizziness, and problems with our balance.

Side effects from medications can seriously threaten your ability to live independently, especially those affecting your thinking, memory, or balance. 13% of all hospitalizations are related to prescription medicines and happen most often to people over 65 years of age.

One way to minimize potential problems with medicine is to start with a lower dose, often one-half of the usual starting dose. This is particularly helpful for people who are very elderly or "sensitive" to medicines.

Using less medicine in an older person is not always enough to avoid problems. For example, some medications can cause confusion, memory problems, lightheadedness, and falls, even at low doses. In addition, these medicines are dangerous because by increasing the risk of falls, they can impact a senior's ability to live independently.

Problems with medications in older people were a particular concern of Dr. Mark H. Beers. With his patients who lived in nursing homes, he noticed that some commonly prescribed medicines caused them to become confused and fall down. As Dr. Beers kept track of which medications were associated with those problems, he built up a list of medicines that he felt caused more harm than good when given to older people.

First published in 2009, Dr. Beers' list of problem medicines became known as the Beers List, or Beers' Criteria. It included medications causing sedation, such as sleeping pills, antidepressants, antipsychotics, and muscle relaxants. After his death, the American Geriatrics
