
Healing of H(e)arts Celebration of Life remembers Nathan Hart



CDBG grant approved

Pateros council hears report on city retail growth potential

PATEROS – The city council approved two resolutions, held a public hearing, and was given an overview of city retail business growth potential in the form of a 60-page Retail Academy report completed by City Administrator Jord Wilson.

Wilson told the council that he is in receipt of an agreement with the state Department of Ecology for a combination 50-50 grant and loan to update the city's sewer plan which has last updated

more than 20 years ago in 1999. The work will include cleaning all sewer lines and use of a camera to inventory conditions and efficiencies of the lines.

A second resolution concerned application for a \$30,000 Planning Only Grant through the Community Development Block Grant (CDBG) program next month. According to Wilson the application will request funds for the city to conduct a review of its Zoning (Title 17), Subdivision (Title 16), and Environment Codes (Title 14) to assess how the codes affect the availability of affordable housing and low and/or moderate-income

housing. Once issues are identified recommended adjustments to the codes can be developed. The project also includes preparation of Public Works Design Standards that provide clear requirements for the design and construction of public and private infrastructure in

the community.

The public hearing was held to gauge citizen input regarding the CDBG as it applies to construction development guidelines and affordable housing in the city.

Masks remain required at **NCW Library branches**

BREWSTER - Visitors to North Central Washington library branches, including Brewster and Pateros, must still wear masks even if they are fully vaccinated. That is the latest advisory from NCW Libraries Public Relations Specialist Michelle Mc-Niel who sent the following media advisory on May 18.

The latest from the CDC has loosened mask recommendations for fully vaccinated individuals, and the library district is encouraged by climbing vaccination rates and declining infection rates. Here is why masks are still required when visiting libraries and bookmobile locations:

- Fully Vaccinated rates throughout our service area average 32 percent. In some counties the rate of fully vaccinated individuals is in the low 20 percent.
- · The guidance from the governor and the CDC does not apply to health care settings, homeless shelters, or schools, and the federal order requiring masks on public transportation remains in place. The service population of libraries is more akin to hospitals, schools, homeless shelters, and public transportation than it is to retail shops and

restaurants.

 We want our libraries to be free, open, and accessible to everyone and to do that all patrons can protect our most vulnerable populations by continuing to wear masks and limit their time inside our library buildings.

- · L&I guidance has not been updated by the state yet. In the absence of clear guidelines regarding our requirements as an employer, lifting the mask requirement for patrons would be premature.
- WA DOH has not provided updated industry guidance specific to libraries. We have used this guidance throughout the pandemic to inform our decisions and policies.

"Our libraries serve a lot of families with young children and other vulnerable folks who can't yet be vaccinated," said Deputy Director Kim Neher. "Continuing to mask up ensures that libraries can be a safe, welcoming, and accessible place for every community member.'

NCW Libraries has responded creatively throughout the pandemic to meet community needs, expanding access to free public Wi-Fi around all buildings, expanding digital services, providing mail order books and DVDs and offering curbside pickup.

State enters Phase 3

COVID-19 cases decline as state moves toward reopening

OLYMPIA - Gov. Jay Inslee announced that the state is moving toward a June 30 reopening date. Inslee said all counties were upgraded to Phase 3 of the Roadmap to Recovery plan last Wednesday, May18, until June 30. Inslee paused phase movement while he reviewed an emerging CO-VID-19 flattening trend and subsequent decline in cases.

The full reopening could happen earlier than June 30 if 70 percent or more of state residents over the age of 16are vaccinated. At this writing 56 percent of residents have initiated vaccination.

The Washington State Department of

Health (DOH) reported a total of 392,754 confirmed cases as of 11:59 p.m. on May 19. There have been 5,690 COVID-19 deaths in Washington. DOH said COVID-19 trends are moving

in the right direction with the help of vaccination. The latest DOH situation report shows disease activity is declining across the state. Immunity from vaccination is helping slow the spread of the virus

and reduce its impact on the health care system. Vaccination efforts and other preventive measures (like wearing masks and maintaining distance if you are unvaccinated) need to continue to keep trends from reversing.

The state's vaccine outreach has shifted from mass vaccination sites to mobile vaccination clinics. Following a successful four-month run, DOH is transitioning the state-led mass vaccination effort from stationary sites to mobile vaccination clinics. This new phase of vaccine outreach will help the state reach people who have experienced barriers in vaccine access and help distribute life-saving shots more equitably and conveniently across the state of Washington.

The school testing program will now include funding for screening tests. DOH, in conjunction with Health Commons Project, is making it easier for schools across the state to do both diagnostic testing and screening testing for CO-VID-19. New funding will allow districts and schools the option to add screening tests to their COVID-19 testing strategy if they choose.

Meanwhile, DOH continues to make

progress with COVID-19 vaccine distribution and administration efforts. As of May 17, more than 6,424,110 doses of vaccine have been given across the state, which is nearly 84 percent of the 7,664,240 doses delivered to our providers and federal partnership programs. More than 47 percent of people in Washington 16 years and older are fully vaccinated against COVID-19 and more than 59 percent of people 16 and older have received at least one dose.

If it has been less than two weeks since your final dose, or if you still need to get your second dose, you are NOT fully protected. Keep taking all preventive measures until you are fully vaccinated. Per CDC recommendations, fully vacci-

nated people no longer need to wear face coverings or physically distance outdoors or indoors, except in these settings:

- Health care settings like hospitals, long-term care, or doctor's offices
- · Correctional facilities
- Homeless shelters
- Schools

The federal order requiring masks on public transportation still applies.

On the topic of economic development in the city, plans for a Pop-Up Market include a Facilities Use Agreement that Wilson has submitted to the city for two market weekends in each of the months of June through September. An informal committee including Mayor Carlene Anders is still meeting to discuss other market issues.

Wilson said he recently the Department of Commerce (DOC) funded Retail Academy Project and suggested that its 60-page Retail Recruitment Plan (RRP) warranted serious council consideration. The RRP includes a comprehensive analysis of the potential consumer base in a three-mile, five-mile, and 10-mile radius of downtown Pateros. Wilson directed council focus on the Market Guide portion of the plan which estimates that nearly \$40 million (\$39,499,413) some of which could be spent is Pateros is currently leaving the area for other shopping destinations.

"There is definitely room for growth especially in restaurants and drinking establishments, grocery and general merchandise like Dollar General; gyms, health boutiques, and even building, hardware, and garden stores," Wilson said.

The report indicates that a population of 5,949 resides within reasonable access to downtown Pateros. This group includes 2,467 households with a median income of \$49,897 and average housing value of \$382,637.

The Retail Academy Project was funded by a \$12,500 grant from the DOC.

"I went into this process pretty bleak about Pateros but came out very excited about the Pateros Potential." Wilson said.

The city also voted to approve three upcoming events, the Pop-Up Market, Apple Pie Jamboree, and Hydro Races, "contingent upon events meeting the requirements issued by the state Department of Health."

Four hat tricks in last five games

Bridgeport's Yair Diaz named WIAA Athlete of Week

BRIDGEPORT - Yair Diaz. junior forward for the Mustangs varsity boys' soccer team is making headlines for his skill on the competitive

Diaz helped lead his team to a winning season this year with some high-octane standout play during the last half of the season. Diaz scored a total of 17 goals in the last five games that include hat tricks (three or more goals) if four of those. Bridgeport Athletic Director Scott Darwood said Diaz scored hat tricks in three consecutive games, had a goal plus assist in another end ended the season with a hat trick at home against Wahluke.

Thanks to a nomination by Darwood, Diaz was recognized as one of the Washington Interscholastic Activities Association's (WIAA) top 12 Athletes of the Week earlier this month for his outstanding performance on the soccer pitch. The WIAA description

BREWSTER - Bears varsity baseball senior catcher Logan McGuire played his final high school games in a doubleheader against Eastmont on Senior Day May 15. Head coach Todd Phillips had effusive praise for McGuire who was a varsity member as an eighth grader and was the anchor for his team this year.

"It is the end of an era of Brewster baseball," said Phillips about McGuire. "Not often do you get a guy to be a mainstay at a single position for a five-year period. That just does not happen.'

McGuire's baseball stats are hard to match, Phillips said.

"He took part in 70 Brewster wins, won a league title every year there was one, a district title, and two state trophy teams. I wish I knew how many innings and pitches he has caught for us," said Phillips. "Nearly every single game since he was in eighth grade."

Phillips said he is super proud of the leadership Mc-Guire displayed this year dealing with one of the most difficult situations a person could

ever imagine. The coach said Senior Day is always a bittersweet moment but especially so in this pandemic year with the loss of the team's star catcher and the passing of teammate Cade Gebbers.

"Every player wore No. 10for these two games as it would have been Cade's Senior Day," Phillips said.

Phillips said he regrets that there is not any sort of playoff in this short and unusual season.

'We would have made a deep run into the playoffs," said Phillips, "and probably brought home some hardware.

Both games against Eastmont were close with the Wildcats pulling out one-run wins in both.

"We should have come away with at least a split but just could not make a clutch play offensively or defensively," said Phillips. "Had the tying run 9-0 feet away and once with less than two outs."

Wildcats win 8-7

In the first game Eastmont got on top quick with a home run off Reese Vassar's first pitch. Vassar tied the game up with his first career homer in the bottom of the second inning. Eastmont dug a hole for the Bears with six runs in the third inning. The Bears chipped away at the lead with two runs in the third inning, three in the fourth, and one in the sixth to tie the score.

THE WASHINGTON OUTDOOR REPORT

There's a lot of news to cover this week when it comes to the outdoors in our region so let's get to it:

Fishers Breeding In Chelan County - The Washington Department of Fish and Wildlife reports the birth of first wild fishers in the North Cascades in a half century. Fishers are a house-cat sized member of the weasel family and were eliminated in Washington by the mid-1900s. They are listed as an endangered species.

Between 2018 and 2020, WDFW, the National Park Service, Conservation Northwest and the Calgary Zoo released 89 of these animals into North Cascades National Park and the Mount Baker-Snoqualmie National Forest. Four young kits from one of these fishers was seen on a trail camera set up near its den in Western Chelan County.

Icicle River Opens To Salmon Fishing - Despite very low returns of Spring Chinook up the Columbia and Snake Rivers this year, state fisheries biologists believe they will have enough of these hatchery-raised chinook salmon return to the Leavenworth hatchery to provide a fishery. Salmon fishing opened on May 22 and is scheduled to go until June 30 though it may close sooner than that if the number of returning fish is lower than expected. Traditionally, the end of May and early June provide the best fishing on this small stream. The limit is two hatchery chinook salmon a day with a minimum size of 12-inches.

Trout Stocked In Lake Roosevelt - Speaking of hatchery fish, WDFW along with the Spokane and Colville Tribes are teaming up to plant some 485,000 fish this month in 151-mile-long Lake Roosevelt. The fish are all triploid rainbow trout and they contain an extra set of chromosomes that renders them sterile but turns them into eating machines. Many of the fish are only 8 to 12-inches long right now but within a few months they'll grow to 18-inches. Others being released in the lower third of the lake already weigh around one pound.

Potholes Bass Fishing Hot – Bass fishing is very good in the sand dunes of Potholes Reservoir right now. Largemouth bass are in shallow water on spawning beds and walleye are also in this area of the lake as well. For the bass fish less than six feet deep with weedless jigs and craw trailers, plastic worms and shallow running or lipless crankbaits. My long-time fishing partner Rusty Johnston and I fished this part of the lake last week and hooked some 20 bass, the vast majority of them between 2 and 3 pounds, along with a bonus 3-pound walleye.

ICE Unable to Track Most Illegal Immigrants Released Into Country

CHARLOTTE CUTHBERTSON

As thousands of illegal immigrants are released into the United States every week, the agency responsible for enforcement is unable to keep tabs on most of them.

Immigration and Customs Enforcement (ICE) Acting Director Tae Johnson admitted to Congress that "there's certainly some gaps in our ability to track" illegal immigrants being released.

After being apprehended at the border, illegal immigrants are processed by Customs and Border Protection (CBP) to determine who they are and whether they're subject to being immediately turned back under the current Title 42 public health provision.

Single adults from Spanish-speaking nations are almost all subject to immediate expulsion under Title 42, according to Acting CBP Commissioner Troy Miller. But Border Patrol is also encountering more illegal aliens from non-Spanish speaking nations, in particular Brazil and Haiti.

Of the 178,000 illegal border crossers encountered

in April, around 62 percent were expelled quickly under Title 42, according to CBP

The remaining 38 percent (or 68,000 individuals) were released into the interior (family units), into Health and Human Services custody (unaccompanied minors), or ICE custody (single adults from non-Spanishspeaking nations).

In some border sectors, particularly the Rio Grande Valley in south Texas, the Border Patrol facilities have been so overwhelmed that many individuals weren't released with the common Notice to Appear document that states a date and time to

appear in court. Rather, they received a Notice to Report, which is an honor system that requires the person to check in at their closest ICE facility within 60 days.

"For individuals that are just released with a notification to report to ICE or to show up in court, then our ability to track those folks

quite closely is much more limited," Johnson said during a congressional hearing on May 13.

About 20,400 individuals have been released with a Notice to Report, and Johnson said ICE has no way to track those people or where they plan to reside, as the agency's system doesn't link to the information Border Patrol collects at the initial intake facility.

"Once they report to an ICE office, they're put into our system of record, and at that point we can track those folks," Johnson said. "But otherwise, we would just have to get a list from Border Patrol of the 20,000 cases and check them pretty regularly."

Johnson said ICE has more success tracking individuals that are released under the alternatives to detention program, including those wearing an ankle monitor.

However, illegal immigrants regularly cut off their ankle bracelets or fail to honor their obligation to check in with ICE or turn up in court.

"Based on the number of individuals that we enrolled in alternatives to detention in FY20, we had about 11,000 individuals abscond from the program," Johnson said. So far, in fiscal 2021 through March, Johnson said about 2,700 have ab-

Under the agency's narrowed criteria for priority removal, most of those who abscond won't be a priority for ICE to track down unless they commit an aggravated felony. Nationwide, the agency arrested 645 illegal aliens for removal in March and 1,152 in April, Johnson

The Fall of Title 42

Johnson's biggest concern is the impending removal of Title 42.

President Donald Trump implemented Title 42 in March 2020, which effectively closed the border to nonessential travel in attempts to mitigate the spread of COVID-19.

It allowed for Border Patrol to turn back illegal border crossers almost immediately, rather than be placed in ICE custody for a more protracted process through deportation proceedings under Title 8.

Once Title 42 is revoked, the 3,000 to 3,500 single adults that Border Patrol is currently arresting on a daily basis will have to be accommodated by ICE.

At the same time, ICE has less capacity than it did during the previous border surge in 2019. ICE had around 55,000 detention beds in 2019; however the capacity was reduced to 30,000 beds in the fiscal 2021 appropriations pack-

"Title 42 is absolutely critical," Johnson said. "I don't think it's a situation where it's going to just be lifted electively—we will be mandated, through some sort of court order, to lift it."

Lawmakers Demand Reinstatement of Space Force Officer Who Was Removed for **Denouncing Critical Race Theory**

A group of Republican lawmakers sent a letter to the acting secretary of the U.S. Space Force on May 19, urging him to immediately reinstate a lieutenant colonel who was relieved of his command after publishing a book that warned of the spread of Marxism and critical race theory (CRT) in the military.

Lt. Col. Matthew Lohmeier, a former instructor and fighter pilot, was relieved as commander of the 11th Space Warning Squadron "due to loss of trust and confidence in his ability to lead," a Defense Department official told CNN on May 14.

The decision came after Lohmeier took part in podcasts to discuss his self-published book, titled "Irresistible Revolution: Marxism's Goal of Conquest & the Unmaking of the American Military," which warns against the spread of Marxism and CRT in the military.

During an appearance on the podcast "Information Operation," Lohmeier criticized Defense Secretary Lloyd Austin's agenda. The department deemed his comments to be "partisan political activity."

In their letter, the two dozen Republicans expressed their alarm over the decision to relieve Lohmeier. They said it appeared to

reflect the development of argued that the theory is an "increasingly politicized environment" in the Department of Defense, which has now manifested in the Space

The lawmakers criticized the use of euphemisms such as "diversity training" in describing CRT. Such terms, they said, are "grotesque distortions of reality."

CRT has gradually proliferated in recent decades through academia, government structures, school systems, and the corporate world. It redefines human history as a struggle between the "oppressors" white people—and the "oppressed" everybody else-

similar to Marxism's reduction of history to a struggle between the "bourgeois" and the "proletariat." It labels institutions that emerged in majority-white societies as racist and "white suprema-

Like Marxism, CRT advocates for the destruction of institutions, such as the Western justice system, freemarket economy, and orthodox religions, while demanding that they be replaced with institutions compliant with the theory's ideology.

Proponents of CRT have

merely "demonstrating how pervasive systemic racism trulv is."

"Those leaders who are complicit with this poisonous philosophy which promotes racial essentialism and collective guilt in our beloved military will be judged by history accordingly," the

lawmakers wrote. "Promoting critical race theory will disrupt the good order and discipline in the

Space Force and eviscerate our nation's ability to attract patriotic talent to serve in uniform and fight our wars."

Signatory Rep. Doug Lamborn (R-Colo.) said in a statement that the military

should focus on threats to U.S. national security and "not pandering to one political ideology.' "I can't imagine a better

way to weaken ourselves in the midst of a great-power competition with China and Russia," he said. "Lt. Col. Lohmeier listened to the Secretary of Defense and stood up against extremism on the left. He should be praised for his courage."

Space Force officials didn't respond to a request for comment by press time.

House Passes Bill Approving \$1.9 Billion More for US Capitol Security

The House of Representatives voted on May 20 to approve \$1.9 billion to increase U.S. Capitol security in response to the Jan. 6 breach, with several left-wing "Squad" members voting either no or present.

The House voted 213-212 to approve the measure, which faces an uncertain future in the Senate, where 60 votes are needed to advance legislation.

Reps. Cori Bush (D-Mo.), Ilhan Omar (D-Minn.), and Ayanna Pressley (D-Mass.) voted no. Meanwhile, Reps. Jamaal Bowman (D-N.Y.), Alexandria Ocasio-Cortez (D-N.Y.), and Rashida Tlaib (D-Mich.) voted present. All other Democrats voted in favor and all Republicans voted against.

"This bill is not about politics. It's not about settling scores," Appropriations Committee Chairman Rosa DeLauro (D-Conn.) said on the floor of the chamber. "It's about ensuring that every person who comes onto the Capitol grounds is safe and is protected. The funding is not optional."

Republicans have said that while the GOP supports the U.S. Capitol Police and National Guard members who were deployed after the Jan. 6 breach, they view the bill as partisan and drafted without consideration for how the funds would

The bill would reimburse the National Guard for costs incurred when troops were deployed to the Capitol earlier this year, provide Capitol Police with overtime pay, and other resources. The bill would also create a response force that would aid Capitol Police during a crisis, as well as fortify doors and win-

dows at the building.

"House Dems just passed a Capitol security bill that costs \$3.5 million per member of Congress. Defund the Police for thee but not for me," wrote Rep. Jim Banks (R-Ind.).

to establish a force within the D.C. National Guard to respond to incidents at the Capitol, raising serious concerns about the role of our military on American soil." Rep. Kay Granger (R-Texas) added.

Senate Minority Leader Mitch McConnell (R-Ky.) indicated that the proposal needs another review when it heads to the Senate.

"We're not sure what to spend the money on yet. So I think we are pushing the pause button here," he said.

The three Democrats who voted against the measure said they don't want to provide more funding for what they called police surveillance.

"This bill prioritizes more money for a broken system that has long upheld and protected the white supremacist violence we saw on display that day," Bush, Omar, and Pressley said in a statement. Bowman, who voted present, told news outlets that he doesn't want to provide "more funding to police budgets."

The bill's passage comes as the Pentagon confirmed at a news conference that the National Guard will be leaving the Capitol on May 23.

"We have received no request to extend it," Department of Defense spokesman John Kirby said, referring to the National Guard deployment around the Capitol building.

20 Attorneys General Petition Biden Admin to Backtrack on CRT and '1619 Project'-Based Education Proposals

A joint letter by 20 state attorneys general directed to Education Secretary Miguel Cardona is asking the Biden administration to retract its education plans that would promote Critical Race Theory (CRT) and the New York Times' "1619 Project" in schools.

The group's criticism centers on recent proposals from the Department of Education that detail plans in April to provide grants under American History and Civics Education programs for a curriculum teaching diversity and the effects of "systemic marginalization."

The letter, led by Indiana Attorney General Todd Rokita, claims that the proposed priorities issued by the Education Department are a "thinly veiled" effort to insert CRT and the 1619 Project into American classrooms.

"As the chief legal officers of our respective states, we write to express our deep concerns with the proposed priorities recently issued by the United States Department of Education. The proposed priorities are a thinly veiled attempt at bringing into our states' classrooms the deeply flawed and controversial teachings of Critical Race Theory and the 1619 Project," reads the letter in part.

It further argues that the new education proposals would "distort" the accuracy of history, rendering it at odds with state and federal law.

"CRT is an ideological construct that analyzes and interprets American history and government primarily through the narrow prism of race. Similarly, the 1619 Project seeks to 'reframe the country's history.'

Letter by 20 state attorneys general

As such, it distorts, rather than illuminates, a proper and accurate understanding of our nation's history and governmental institutions and, therefore, is fundamentally at odds with federal and state law," state the attorneys general.

The ideas being put forward by the 1619 Project suggest that

the United States was founded on white supremacy and oppression and that these are still fundamental aspects of society.

The letter was signed by attorneys general from Alabama, Alaska, Arizona, Arkansas, Georgia, Idaho, Indiana, Kansas, Kentucky, Louisiana, Mississippi, Missouri, Montana, Nebraska, Ohio, Oklahoma, South Carolina, Texas, Utah, and West Virginia.

"The Department should not adopt the proposed rule or, at a minimum, should make clear that grants may not fund projects that are based on CRT, including any projects that characterize the United States as irredeemably racist or founded on principles of racism," they state.

Ibram X. Kendi's works are

They assert that the biggest issue is the impact of the theories being promoted on students, and urge the department not to embrace the proposed measures.

"Relying heavily on a meritbased testing regime, Asian applicants received a disproportionately high number of the scarce 205 available seats. 'With COVID as a pretext, equity advocates set up a new system to fill the spots based on zip codes and grades, a plan that will result in a 24 percent reduction in Asians, an 18 percent reduction in whites, a 50 percent increase in blacks, and a 14 percent increase in Hispanics."

Another notable criticism is aimed at the proposal's alleged discrimination of students based on "privilege" or "oppressor" status based only on racial identity.

"Teaching this in a classroom clearly runs afoul of broad non-discrimination provisions adopted by many states to prevent the same sort of separatist teaching that the guidance attempts to integrate into schools through teachers and students," the letter maintains.

After attending the programs being put forward, the teachers would be violating Indiana law if they "indoctrinate students" discriminatorily, the coalition of attorneys general added.

The Department of Education told The Epoch Times: "We look forward to receiving the letter and responding directly to the signees."

Rubio Unveils Bills Targeting China's Collection of Americans' DNA

Sen. Marco Rubio (R-Fla.) has introduced two bills to counter the Chinese regime's efforts to collect the genomic data of Americans through both legal and illegal means.

The Republican senator, who has been a leading voice in addressing the issue, introduced the Genomics Expenditures and National Security Enhancement (GENE) Act and The Genomics Data Security Act on May 20.

Beijing has for years been collecting large amounts of American health care data, using illegal methods such as cyber hacking, investments in American biotech companies, and partnerships with hospitals and universities to gain access to the sensitive information.

The National Counterintelligence and Security Center (NCSC) said in a fact sheet released on Feb. 1 that it poses serious privacy and national security risks.

"There is no reason for American taxpayers to be funding Beijing's research or for our policies to enable access to American's genomic data," Rubio said in a statement, announcing the legislation. "It's imperative that Congress take steps to confront this growing national security and privacy threat."

Rubio's office said that the GENE Act, which is co-sponsored by Sen. John Cornyn (R-Texas), would increase congressional oversight by requiring the Committee on Foreign Investment in the United States (CFIUS) to include the Senate Select Committee on Intelligence and Senate Committee on Foreign Relations in its briefings.

It would also increase crossagency awareness of "transactions of concern" by requiring that the Department of Health and Human Services (HHS) be consulted on any deal that involves a genetic data transaction.

Lastly, it would direct CFI-US to rewrite its regulations to require mandatory filing for any deal that involves a company working with genetic information, Rubio's office said.

Meanwhile, the senator's second bill seeks to prohibit any National Institutes of Health (NIH) funding from going to support entities with direct ties to the Chinese regime

It would also require that every Clinical Laboratory Improvement Amendments Act certificate specify if a company with access to Americans' health data is directly tied to Beijing.

Vast amounts of genomic information (a person's entire genetic sequence) can fuel developments in the cutting-edge field of precision medicine (or personalized medicine), allowing China to overtake the United States to become a global leader in biotech, according to the NCSC. Such data can also be weaponized to target individuals in the country for intelligence and military operations.

A 2019 report found that at least 15 Chinese firms were licensed to perform genetic testing or sequencing on U.S. patients, giving them access to genetic data.

Americans' genomic information is particularly valuable to China due to the ethnic diversity of the U.S. population, the paper noted. This is because varied data sets are more useful in research to identify genetic diseases. The Chinese regime last year passed laws to severely limit the ability of foreign firms to access Chinese people's biological data.

Ohio Vaccination Rate Surges After \$5 Million Lottery Announcement

New York, Maryland rolling out similar programs

The COVID-19 vaccination rate in the state of Ohio has surged after Gov. Mike DeWine announced that five residents will win \$1 million each as a monetary incentive for getting inoculated, health officials said this week.

Ohio's Department of Health said on May 20 that from May 14 to 17, vaccination rates for people 16 and older jumped 28 percent. The Republican governor announced the state's incentive program, named "Ohio Vax-a-Million," on May 12.

Under the "Ohio Vax-a-Million," which will be funded by existing federal pandemic relief funds, Ohio residents who are at least 18 years old and have received "at least" one dose of the COVID-19 vaccine are eligible to win the sum in once-a-week lottery drawings, the governor announced last week.

The first drawing will occur on May 26, DeWine said at the time, noting that the Ohio Department of Health will be the sponsoring agency for the drawings and the state Lottery will conduct them.

"This dramatic increase in vaccinations indicates that

the Vax-a-Million drawing has been impactful in creating momentum for vaccinations throughout Ohio," Stephanie McCloud, director of the state's health department. "We are grateful that the drawings are helping spur Ohioans to take this important measure to protect their health, their loved ones, and their community."

A separate incentive for younger Ohio residents will see five vaccinated 12- to 17-year-old students receive full four-year scholarships to attend Ohio public universities, including tuition, room, board, and books.

New York and Maryland on May 20 also announced that they will be rolling out similar vaccine incentive programs. New York Gov. Andrew Cuomo told reporters that New Yorkers who get vaccinated from Monday to Friday next week will be given a lottery ticket with a cash prize of as much as \$5 million.

Meanwhile, a vaccinated Marylander will be chosen at random daily for a \$40,000 prize, starting July 3 and ending July 4, Gov. Larry Hogan. He said that one person will receive a grand prize of \$400,000.

Companies have also started offering incentives as part of an effort to encourage Americans to get vaccinated. For example, Krispy Kreme stores are offering one free glazed doughnut for people who show that they have had one or two shots of any COVID-19 vaccine.




