## Medieval Faire offers an opportunity to head back to Middle Ages

Adults \$15, kids and seniors \$10.50 and family of four is \$45.

Valley residents have the chance to travel back in time to the Middle Ages at the Two Rivers Medieval Faire at the Chelan County Expo Center in Cashmere. The ambiance, jousting and a dragon master roaming around will displace those attending the celebration back to Ireland in the midst of the Middle Ages.

Those interested in wandering into an era very distant from social media and the Kardashians, have the chance from 10 a.m. to 6 p.m. on April 27 and 10 a.m. to 4 p.m. on April 28.

"We have a lot of free entertainment once you get into the fair," said Debra Johanson, Two Rivers Medieval Faire director.

For a single day, the adult rate (13 and older) is \$10 and children and seniors (65+) is \$7. For families consisting of two adults and two kids, the rate for a single day of fun is a \$30 package. Those who want to stay immersed in the Middle Ages for both days can purchase a weekend pass:

Children are invited to join in for the fair with an enticing offer to participate in a dragon egg hunt and partake in goblet decorating. Johanson said this year there will be a pirate cove for children to migrate to.

"It's a family affair," said Johanson. "We have some reasonable rates, especially for the children. It's a lot of bang for your buck."

With the promise of two stages to rotate between and a variety of performers to entertain, there is a packed schedule. Musicians, a belly dance troupe, a blind juggler are just a few of the talents that will be at the event.

"We have several local entertainers this year. We have Kurio, a local duo that does Celtic and folk music. We have Alicia Dart who is amazing with hoops, she's a roaming entertainer," said Johanson, among some other local acts.

Some of the highlights from previous years are returning for an

## CHS FFA hosts plant sale to fuel their State Convention fun

April showers bring May flowers - and a trip to FFA State Convention.

A herd of Cashmere High School students will be Pullman bound for the State FFA Convention from May 8 to May 12 - they will compete against schools scattered across the state. Roughly 40 students are bringing their talents and skills to compete and represent Cashmere. The Cashmere FFA crew is hosting a plant sale to help raise funds to go.

"What I love about it is that they get to apply what they've learned in the classroom in a competition setting,"

said Rusty Finch, FFA advisor. "What I like about these competitions is they are very real world, applicable and there's a lot of problem solving and higher level thinking."

With 40 students and the cost of \$250 each to go, that's a lot of money being shelled out of pockets. In order to finance the price of making it to compete, the club is hosting the plant sale on May 4 from 9 a.m. until 5 p.m. in their greenhouse. This is their second year in the greenhouse, according to Finch.

"That's a big way we pay for these things, with that big of a group it's hard to pay for everything, we'd break the bank," said Finch. "Every

kid going is competing in something."

At state, students will demonstrate their skills in a variety of categories, beyond stereotypical agricultural elements that people often align with the club. From public speaking to agriculture sales to food science, those are just some of the different forms the Cashmere FFA students will compete.

"Don't be arrogant, but be confident. We're not going there to play, we're going there to compete," said Finch. "We hope to place in every event we go there in."

Cashmere FFA isn't a stranger to

Seventy Pacific Lamprey released into Wenatchee River as part of species restoration effort

The Yakama Nation Fisheries and United States Fish and Wildlife Service (USFWS) held a release event for Pacific Lamprey on April 17 at Jolanda, Lake near the Alps Candy Store. During the event, officials from both organizations, along with students from Beaver Valley Elementary School, released 70 adult Pacific Lamprey into the lake where they would swim up or down the Wenatchee River.

The release event is a part of an effort of Yakama Nation Fisheries to restore and bolster the number of Pacific Lamprey in the area.

The USFWS lists Pacific Lamprey, an eel-like animal, as a "species of concern." Tyler Beals, Fish Biologist I with the Yakama Nation Fisheries explained that Pacific lamprey had been absent upstream of Tumwater Dam in recent years. Through the translocation of adult Pacific Lamprey to the

river upstream of the dam, larval lamprey can be found in the upper Wenatchee River and some of the tributaries.

Reasons for the decline in the species' numbers include poor water quality, lack of passage caused by dams and other manmade structures, and reduced flows.

Before they released the Lamprey, students learned numerous facts about the species.

While holding a live Lamprey in front of a group of curious children, Dave'y Lumley, Lamprey Technician III, explained that Pacific Lamprey are more than 400 million years old.

After 6-7 years, Lamprey will grow to its full size and develop a suction disc for a mouth. The species will migrate to the ocean for 2-3 years before returning to freshwater in order to breed. Fish biologist Barb Kelly-Ringel explained Lamprey will swim to areas with fast flows and many rocks. The species

will move rocks and make a nest to lay their eggs. She added that female lamprey can lay up to 150,000 eggs during a spawning cycle.

When asked if the creature is parasitic, Lumley confirmed Lamprey use their suction disc to feed off blood and bodily fluids from salmon, whales and other species. She added that Lamprey do not hurt the species it feeds from and the cut from suction disc will heal.

While Lamprey feed on species, it provides a pivotal role to the eco system. In its larval stage, Lamprey inhabit the bottom of rivers and feeds on organic debris, cleaning the water in the process. They also act as a shield for salmon against predators in and out of the water.

Children learned the culture significance of the species. Sean Goudy, Fish Tech III, explained the lamprey was a significant food source for native culture and traditions. Tribal fishermen would spend most of their day catching

Lamprey using nets and their bare hands.

Goudy said tribal members considered the species a "super food" because it was rich in nutrients.

"Lamprey is a dense, nutritious snack, you could get full really fast on them," Goudy added.

Goudy said fishing camps would catch an abundance of Lamprey during the day. However, the construction of dams inundated the fishing camps. The decline in Lamprey and the disappearance of these camps has resulted in younger generations losing out on the opportunity to learn their cultural ties to the species and fishing traditions.

After learning facts of the Lamprey, students were divided into two groups and released the fish. Each of the Lamprey released in the river was tagged and embedded with sensors in order to track their future movement.

Lumley explained the organization also holds

outreach events to educate students and people about lamprey and how they affect the environment.

"We want to get to the point where we can release them with a high survival rate," Lumley said.

The publisher's April 10 commentary, "Who is going to save the Democrat (sic) party?," has little to do with the Democratic Party, other than trashing Democrats and Democratic candidates as "just plain insane," or stating as fact that "[my greenie friends] have already concluded that life on earth will end in 12 years."

At issue here is overwhelming evidence that we humans are altering the climate of our Earth by building up an excess of "greenhouse gasses," primarily carbon dioxide (CO2) in the atmosphere, trapping heat and changing weather patterns. Fossil fuels emissions are the main source of the increase in greenhouse gasses. Climate change is a health issue, an economic issue, an equality issue since its effects hit economically vulnerable people the hardest. We here in the Northwest see the consequences of our

changing climate: increasing wildfire and accompanying smoke, ocean acidification, receding glaciers, threats to crops, megadroughts. Globally, we see extreme weather events: floods, tornadoes, storms in increasing severity.

There is growing recognition of the gravity of climate change. An overwhelming majority of climate scientists — up to 97% — agree that climate change is happening, with dire consequences if it is not addressed by reducing greenhouse gas emissions. Recent polls show that around 70% of Americans now believe that climate change is real — a 10-point surge from previous polls. "We've not seen anything like that in the 10 years we've been conducting the study," said Anthony Leiserowitz, a researcher at Yale.

I applaud Governor Jay Inslee for making climate change the centerpiece of his Presidential bid. In

working to transition from fossil fuels to renewable energy, Washington has set goals to reduce carbon emissions, established a Clean Energy Fund, and promotes electric vehicles and renewable energy, among other initiatives. And the state legislature recently passed a bill requiring 100% of Washington's electricity generation to be free of carbon emissions by 2045. As Governor Inslee points out, "Climate change is not more important than the economy; it is the economy."

The worst thing we can do is to ignore, or dispute, the fact of climate change. Climate change denial, led by right-wing propagandists and big oil magnates, is rapidly losing credibility. This is despite

efforts of Donald Trump, who label climate change a hoax, withdrew from the Paris Climate Accord, rolled back fuel economy standards, and deregulated the fossil fuel industry. Perhaps in fear of losing a big part of his base, Trump has appointed a panel to "assess whether climate change poses a national security threat." Leading this panel is William Happer, a physicist with no training in climate science, and a former director of the Heartland Institute, the leading climate denier think tank. Happer, a founder and former president of the far-right funded CO2 Coalition, has stated that "the demonization of carbon dioxide is just like the demonization of the poor Jews under Hitler."

The fact of climate change

and where it leads must be recognized, and we must continue to move to solutions. In the words of Collin O'Mara, President of the National Wildlife Federation: "It's an absolute disgrace to bury the truth about climate impacts in a year that saw hundreds of Americans die during devastating climate-fueled megafires, hurricanes, floods." Climate change denial needs to be put to rest and go the way of such notions as a flat earth. Oh wait — there really is a Flat Earth Society, whose members really believe the idea of a spherical earth to be a hoax. Now this is something the publisher might want to investigate for more of his "facts."

making it to state - they have consecutively been over the years. However, despite being regulars at the statewide competition, the students are still hungry for the chance to show off their hard work. The students emphasized what it means to them to continue the successful legacy of Cashmere's constant presence at the competition.

"Personally, I just think it's awesome to go there and show everybody else all the

hard work and time and effort that you put into it," said Aranza Arroyo, president of Cashmere FFA. Arroyo herself has a loaded schedule and is competing in three events.

Finch stressed the importance of going to state as more than a chance to rack up awards. The FFA competition is a way to provide an avenue to compete and to display talent that can't be recognized on a court or on a field. He noted that he particularly likes the portion of competitions that are based on objectivity rather than subjective.

"Everybody loves to compete

inherently, at some level. Now this gives everybody a little something they can be good at," said Finch.

FFA is an important component to the kids education besides the school work and competitions. Vice president, Elizabeth Worley credits FFA for not only teaching them the logistics of agriculture, but the importance that she says is often overlooked.

"It teaches you where your food comes from and where really everything comes from. It shows you the importance of agriculture in our community,

because it kind of gets overlooked in the bigger scale of things. So it teaches you the importance of why we need to continue doing this," said Worley.

Beyond competing and earning recognition for their hard work, the students will get an opportunity to explore Washington State University's agricultural facilities during the state competition. While many of them have checked off the state competition box in the past, the students are eyeing the next step - nationals in Indianapolis, Indiana that would roll over from the school year into the upcoming fall.

**Flax is an oily grain grown for its fiber, seeds**

**Q:** My sister takes flaxseed oil because she can't stand getting "fishy burps" from the fish oil, and insists that flaxseed is just as good for you as fish oil. Is this true?

Flax is an oily grain grown for its fiber and seeds. While the fiber is used for clothing, the seeds are sold as whole seeds, partially defatted seeds, ground seeds, flaxseed meal and flaxseed oil. Flaxseed is used as a natural way to decrease your total cholesterol and "bad" LDL cholesterol levels and can relieve menopausal symptoms like night sweats and hot flashes.

Both flaxseed and fish oil have high concentrations of a type of fatty acid called Omega-3. Eating foods rich in Omega-3 fatty acids helps counteract the effect of "bad" fatty acids called Omega-6, which create inflammation in your body.

Omega-6 fatty acids contribute to arthritis and heart disease, and there are lots of them in a typical American diet. Omega-6 fatty acids are found in popular foods like popcorn, pasta, potato chips, corn chips, bread, French fries and hot dogs as well as many salad dressings, canola oil and soybean oil.

The "good" Omega-3 fatty acids EPA and DHA help counteract the inflammatory effects of a diet high in Omega-6 fatty acids. Flaxseed also contains large amount of an Omega-3 fatty acid called ALA, but ALA is inactive until it is changed into EPA or DHA, and most people can't convert it into an active form.

Although flaxseed oil CAN decrease menopausal symptoms in SOME women, this supports the fact that most people can't convert enough of the inactive Omega-3 fatty acid ALA in flaxseed into biologically active EPA or DHA to get much benefit.

Flaxseed is a very good source of fiber, especially soluble



fiber. Adding fiber to your diet with flaxseed has been shown to decrease LDL and total cholesterol. Flaxseed's fiber helps you stay regular because it works as a bulk laxative, similar to psyllium or Metamucil®. In fact, most of the documented benefits of eating flaxseed can be explained by the effect of more fiber in your diet. Flaxseed oil has not been shown to lower either LDL or total cholesterol.

The outer coating of flaxseed is a gummy layer that's very high in fiber, especially soluble fiber. Getting adequate fiber in your diet helps decrease your "bad" cholesterol (LDL) level and your total cholesterol level.

The beneficial effects of flaxseed over flaxseed oil or lignin extract on your LDL and total cholesterol can be explained by the increased fiber from its seed coat, whether from eating the whole seeds or grinding them up like flaxseed meal.

You can add whole flaxseed to your diet by adding it to cereal, granola, or smoothies. Ground flaxseed or flaxseed meal is less gritty and can be blended into smoothies or baked into breads, muffins or cookies. Whole and ground flaxseed each contain lots of fiber and act as a bulk laxative very similar to psyllium or Metamucil®. When starting them, add flaxseed to your slowly to avoid suffering intestinal distress such as gas, bloating, cramps or diarrhea and get plenty of fluids to avoid intestinal blockage.

Most sources suggest up to 40 grams flaxseed daily (4 tablespoons of whole flaxseed or 7 tablespoons of flaxseed meal) to lower LDL and total cholesterol.

Avoid taking more than 45 grams per day (4.5mg tablespoons of whole flaxseed or 8 tablespoons of flaxseed meal) to decrease your risk of intestinal problems.

Here are 5 Key Facts About Flaxseed and Omega-3 Fatty Acids:

**1. The Omega-3 fatty acid ALA found in flaxseed is not active in your body.**

ALA from flaxseed needs to be converted into active Omega-3 fatty acids like EPA and DHA by your body before it can benefit you. Some people can make this happen, but most cannot.

**2. Fatty fish, fish oil and krill oil have high concentrations of the active Omega-3 fatty acids EPA and DHA.**

The foods containing the most Omega-3 fatty acids EPA and DHA are fatty fish like salmon, herring, mackerel and sardines.

**3. The soluble fiber in flaxseed lowers total cholesterol and LDL (bad) cholesterol.**

Flaxseed's soluble fiber is concentrated in its seed coat. Flaxseed oil and lignin extracts do not significantly affect cholesterol levels.

**4. Start slowly and limit whole or ground flaxseed to 45gm daily to avoid intestinal distress.**

Add fiber to your diet gradually to minimize painful gas, bloating or cramps.

**5. Avoid flaxseed while pregnant or breastfeeding.**

Flaxseed contains phytoestrogens and should be avoided if possible during pregnancy and while breastfeeding.
