The latest city council meeting on Monday, May 8 discussed new changes going on in Cashmere, including changes to the public pool and cemetery along with a new playground dome that is being put together for the public.

The public pool rates have been on

the rise since the minimum wage for life guards has also increased.

In regards to new additions to the Cashmere Cemetery, Treasurer Kay Jones revealed that niche walls have been put in.

Niche walls are walls that have spaces available for people to put urns containing loved ones' ashes.

"We didn't have anything in the regulations about that so we wanted to add that," Jones said. The city council members went on

to stress the fact that it is not the responsibility of the city to maintain the cemetery's headstones.

According to Jones, some members in the community have requested that the city officials be the one to mow the grass in the cemetery when the grass grows too tall.

Because the wheel of a lawnmower could potentially damage the headstones, Jones stated that mowing the grass allows for only

### Drill Team places 2nd in parade

Jones said. "By having FCS Group do that financial analysis, it's going to save us money because of the rate study that we're doing at the same time.'

The latest hot topic brought up at the city council meeting was a new local playground dome that is soon going to be established.

There will be more information on the playground dome provided shortly.

"There's a big dome and then netting so kids are going to climb all over it," Jones said.

### Honor all veterans, wear a poppy on Memorial Day

Cashmere American Legion Auxiliary volunteers will be distributing the familiar red poppies honoring handcrafted American's veterans in Cashmere on Friday May 19. This day is designated as Poppy Days. Please look for them at the Post Office, Martins Market Place, Cashmere Valley Bank and outside of Doanes Valley Pharmacy.

Planned to coincide with Memorial Day, the annual event pays tribute to those veterans who have willingly served their country for decades. Memorial Day, originally called Decoration Day, is a day on which Americans remember and also pay tribute to their ancestral family members. It is sometimes easy to forget the true significance of this solemn day. This year will be the 69th "Cavalcade of Flags" ceremony at the Cashmere Cemetery on Memorial Day Monday May 29 at 11 a.m. put on by the Cashmere American Legion Post #64. The ceremony started in 1976 with just 22 flags under the supervision of Commander Art Cote. This year around 430 American flags

donated by veteran's families will be put up at the cemetery. Also over 900 small flags will be put on all veterans and auxiliary graves on Sat. May 27. If anyone would like to help with this monumental task, please come to the cemetery on that Sat. at 9 a.m. The big flags will be put out, weather permitting, early on the morning of Memorial Day, May 29 and taken down in the afternoon and put away for another year. None of this would be possible if it weren't for volunteers.

Where did the poppy tradition originate? The poppy, which

symbolizes freedom and the blood sacrificed by our troops during war, comes from the poem In Flanders Fields, written by Lt. Col. John McCrae. The poem refers to the poppies that grew out of newly dug soldiers' graves during World War I in Europe. Moina Michael, a teacher from Georgia, read the poem while attending a YMCA Overseas Conference. She wrote her response to the poem and vowed to keep the promise by always wearing a red poppy to honor those who died. The American Legion Auxiliary

adopted the poppy as its memorial flower in 1921 and started the Poppy Program in 1924. Today Auxiliary members distribute millions of poppies in exchange for contributions to assist active-duty military, veterans and their families. You should look at the poppy and

see what it represents. It's not just a flower with a label on it. Try to remember what the poppy stands for and also what the meaning of Memorial Day is. Please take the time to set aside this one day of the year to remember, reflect and honor those who have given their all in service to our country.

Veterans sacrifice a huge part of their lives to pay for the freedoms we enjoy today in the USA. Everyone should be able to say "I know why I am free". Proudly wear a poppy for Memorial Day.



Suicide is never the easy way out, nor is it the best alternative to living. It births tragedy, pain, and the shockwave of suicide lasts in friends and family for a lifetime. Regardless of the Shakespearian ideal or the veneer of slickly produced 52 minute episodes, suicide is never glamourous.

The Netflix show "13 Reason's Why," which graphically depicts

events and the psychology of a teenage girl who chooses to end her life, has once again put teenage suicide back into the realm of public discussion. Its unflinching portrayal of suicide is difficult to watch, to say the least, yet that is its intention. Suicide should disturb us to the very core, and for that I appreciate what the show is trying to communicate.

episodic ventures, but rather it is the existence of a deep feeling of being ostracized, and depressed, all of which are not so easily defined and categorized. We never really know the reason why someone chooses to end their life, we can make strong guesses or speculations given their circumstances, but the question of "why?" will always remain unanswered.

One of the most challenging things that a minister can face, is counseling a family in the wake of suicide. As pastors we are looked at as men who are supposed to know the answers, yet when it comes to something so shattering, we are left with shaking our head and saying "I don't know why." Again, the reality of being there in that moment with a family, and walking with them as they try to piece together the reasons why, is hardly fodder for a television program.

Nonetheless, suicide can

be prevented. It is not an inevitable end to some one's life or some random act of violence that suddenly snuffs out an innocent victim. Suicide prevention begins with hope.

The Scriptures are clear that "hope deferred makes the heart sick..." (Prov. 13:12). Where there is an absence of hope and all seems at a loss, it deeply affects the soul. Think about the teenager who is contemplating ending his life, where is his hope? All he sees is rejection from friends and family maybe, that his circumstances are never going to change, and that the only alternative is to end his life. That teenager needs hope - a beacon that is to pierce the darkness of what they are feeling and going through. The word "hope" is not some political buzzword, hope is everything and hope begins with God.

"Hope in God" (Psalm 42:5) the Psalmist says as he was in the middle of the darkest seasons of life. Why hope in God? Because he is love, he is there, and he is mighty to save.

God is always near to the brokenhearted and to the one, who is deeply hurting he brings in close, binds up the wounds, that we and others inflict on us and gives grace to endure. The God of the Bible is the God of life, and that is why he beckons all of us to choose it every moment of every day (Deut. 30:19). Death is never the solution. Death by its very design is meant to be tragic,

even going against our natural instincts to live; death is at odds with our own nature.

I don't know what this article is going to do, or even it is going to make an impact. It is hard to condense what needs to be said, because there is much that we can say regarding suicide. But I want to appeal to you the reader, if



you are contemplating suicide, please choose life. In the name of Christ, I promise you there is a better way. You are not alone, and you are not unloved. There are people that love you, more importantly there is a God in heaven who is there, to give hope, and what he gives, never disappoints. He is faithful and him who is calling you, will remain faithful forever (1 Thess. 5:24). Reach out for help, please.

Suicide is preventable and it is incumbent upon us to prevent it. Give hope and believe in hope, for the sake of yourself and for others around

Peter D. Devries passed away on April 30, 2017 in Wenatchee following





#### SPRING IN THE ORCHARDS

By Teri Miller

Last week my daughter Rachel was out hiking and came upon a patch of morel mushrooms. Being of a certain age and excited for what she found, she photograhed them and posted them on social media. Before she could get to many questions as to where they were, I suggested she remove the posts. Morel mushrooms are highly coveted and the location of where to find them is usually a well keep secret. This time of year lots of folks are out looking for this fantastic fungi. Some of them she picked were "false morels" which can be toxic if eaten. Since I can not disclose the location of our morels I can give you some tips to help you find yout own. Our local bookstore has books about mushrooms and other edibles that you can forage for. I suggest you get one or look online to know what a morel mushroom looks like. Morels usually proliferate in fire burn areas so that is a good place to start. Certain trees such as oak, sycamore, elm and ash are popular hosts for morels. Fruit trees are also a good place to look. Morels usually appear when the soil temperature is about 50 degrees and the soil is moist. South facing slopes are also good spots to hunt morels. When preparing for your mushroom hunt, pack a lunch, grab a netted bag, it works best and a knife. Morels can be pinched or cut at the base. Also while you are out looking you may find some wild asparagus which pairs great with morels.

I was at the Pike Place Market last week and asparagus was \$5.00 per pound and morels were \$50.00 per pound. So save money have fun and forage for food. Enjoy!

#### **Morel Mushrooms and Asparagus Saute**

3 quarts water

1-1/2 pounds asparagus

1 tablespoon butter

1 shallot, thinly sliced

3-4 cups fresh morels, halved lengthwise 1/2 teaspoon salt, divided

1 tablespoon olive oil

1/4 teaspoon freshly ground black pepper







