## Bridgeport Chamber hosts Hooked on Kids Fishing Derby

BRIDGEPORT – The annual Hooked on Kids Fishing Derby hosted by the Bridgeport Chamber of Commerce for youngsters aged 4-14 will be held at Marina Park Lagoon on Saturday, June 8.

Participants can pre-register at city hall until Thursday, June 7, or just sign-up at 8 a.m. on the morning of the derby. There is a \$3 entry fee per child and a 10-fish catch limit with no catch-and-release requirements. Anglers must provide their own fishing gear and children under 10 years of age must be accompanied by a parent or guardian.

The Washington Department of Fish and Wildlife will once again provide 400 trout with 25 of those tagged as special prize fish. North 40 Outfitters is chipping in with some store merchandise and volunteers to help the young anglers with tackle and other

chores, Bridgeport mayor Janet Conklin said. Prizes for tagged trout caught will be awarded at 3 p.m. Saturday afternoon and winners must be present.

The narrow entrance of Marina Park Lagoon at the east end of the RV park is temporarily blocked to keep the planted trout from escaping.

Hooked on Kids coincides with WDFW's Free Fishing Weekend so any anglers inclined to take advantage of that opportunity can wet their lines for leftover trout after the derby concludes.

Hooked on Kids was originally the inspiration of former Bridgeport resident and council member, Neil Jacobson. Jacobson even held a competition for Bridgeport school students to come up with a design for the derby logo.

The winning design, showing a large trout holding a bent fishing rod that is hooked onto the collar of a dangling youngster, remains the official logo.

## CAMP project engages Pateros, Bridgeport school students about parks

PATEROS/BRIDGEPORT – Representatives of the Washington State Parks & Recreation Commission (WSPRC) spoke with students at both the Pateros and Bridgeport school districts last week as part of their efforts to gather input and ideas from local users of Alta Lake State Park near Pateros and Bridgeport State Park along Rufus Woods Lake near Bridgeport.

The project called Classification and Management Planning (CAMP) is "a multi-staged, public participation-based planning process for individual parks that culminates with adoption of park land classifications, a long-term park boundary, and park management plan," according to a WSPRC information release.

Parks Planner Melinda Posner from Olympia, together with Central Lakes Area Manager Sharon Soelter and assistant Amy Brotherton, both based at Alta Lake State Park, met with Pateros students from grades 8-11 on May 28, and with grades 6-8 at Bridgeport the following day.

Posner said the group met with about 90 students at Pateros and, following a brief presentation, broke into small groups to address specific questions about the future of their local park.

"The kids identified swimming, hiking, camping, BBQ, hunting and fishing as the recreation activities they like to do at the park now," said Posner. "As far as the future, their ideas were all over the place and included more food – including ice cream, more

trails, more fishing, bigger beach, bike paths with nice views, electric car chargers and more."

For several years now the Pateros sixth grade class spends an April week at Alta Lake State Park camping at an Outdoor Classroom.

Posner and crew met with about 200 middle schoolers at Bridgeport where she reported that they enjoy many of the same activities as the Pateros students along with seeing animals, taking pictures and exploring.

"A skate park was a repeated theme in the 'what do you want to see in the future' category," said Posner, "as well as places for dog walking."

The WSPRC staff manned a booth in Fireman Park during Bridgeport Daze on Saturday, June 1. With the help of bilingual speakers at the booth the crew collected comments from respondents and wrote their comments on large easel pads.

Two more public meetings are just ahead. The first is from 5:30-7:30 p.m. Wednesday, June 12, at the Bridgeport Elementary School cafeteria at 1400 Tacoma Avenue in Bridgeport. The second, also from 5:30-7:30 p.m., Thursday, June 13 is at the Pateros Fire Station meeting hall at 191 Industrial Way in Pateros.

## Brewster Council approves emergency water resolution

BREWSTER – In a special meeting last Friday, May 31, city council members recognized that the city is facing an emergency regarding its ability to provide an adequate volume of high-quality water to its ratepayers and approved a resolution to accelerate the identification and construction of a new supply well.

Citing a May 30 memorandum from city engineers J-U-B Engineers, Inc. of Coeur d'Alene, Idaho, city Public Works Director Lee Webster explained that the manganese levels in the city's two river wells represent both risks to public health and significant maintenance issues.

The smaller of the two river wells with a 30 horsepower (hp) pump produces 300 gallons of water per minute (gpm) with manganese levels some 13 times greater than the maximum contaminant level (MCL). The larger

river well (75 hp) pumps 750 gpm and its manganese level is around five times above MCL.

This leaves the city's third water source, the Canyon Well (75 hp) that pumps 500 gpm with low manganese content. However, the city requires approximately 1,050 gpm to reliably cover daily peak demands.

"The city cannot meet this demand without the use of the 30 hp River Well," the J-U-M memo said.

The manganese level in the smaller of the two river wells is so high that the city does not use except in the event of an emergency.

"Reliability rules require capacity to be determined with the largest source" (the 75 hp River Well) "out of operation," the J-U-B memo said.

With the contaminated 30 hp River Well water unusable at its current MCL, the remaining Canyon Well cannot meet city water requirements.

The city is currently under contract with O'Connell Drilling & Supply, LLC, to drill up to six test wells to identify future water supplies.

"Two of the sites have identified productive zones of high-quality water and should be considered for city well sites," the J-U-B memo recommended.

To accelerate the process to convert both test wells to

production wells, a quorum of council members voted to waive the usual competitive bidding requirements and allow Mayor Art Smyth to negotiate a change order agreement with O'Connell to allow construction of production level wells. The contract modification will allow the wells to be online by peak demands in June 2020, an estimated two months before the same project could be completed using the more involved conventional bid process, according to J-U-B estimates.

O'Connell has already been paid for equipment mobilization and is familiar with the test sites that would be converted to production wells.

In addition to the faster turnaround time, "significant economic savings should be incurred by the City bypassing the public bidding process in light of the existing health risks associated with the now present emergency water quality issues facing the City," a portion of the emergency resolution said.

## Sheriff's office investigates whereabouts of missing boater

BRIDGEPORT – The Douglas County Sheriff's Office (DCSO) is seeking information on the whereabouts of a boater whose unoccupied watercraft was found drifting on the Columbia River five miles above Chief Joseph Dam.

Charles Baker, 81, was last seen on Monday, May 27, and the DCSO is requesting information from anyone who saw

Baker launching or operating his boat on the river that day. Baker's boat is a 14-foot green Alumacraft, registration number WN4147SJ with a Honda outboard motor. His 1990 blue Dodge pickup and boat trailer was found at the Army Corps of Engineers boat launch above the dam.


The DCSO, Okanogan County Sheriff Search and Rescue, Colville Tribal Police and Corps of Engineers searched the river for the

missing man.

"No foul play is suspected in his disappearance," a DCSO media release said.

As of press time Tuesday, June 4, no new developments have been released by the DCSO in the continuing search for Mr. Baker.



## Meeting date changed to June 13 for Advisory Committee to discuss Title II project proposal

WENATCHEE -The Resource Advisory Committee for the Okanogan-Wenatchee National Forest will meet on June 13 to discuss potential funding for projects that benefit watersheds and forest-related resources on national forest lands in Okanogan and Chelan counties. Twenty-three projects will be reviewed by the committee.

"We had planned to meet on May 30 but found out we will not have a required quorum of committee members avail-

able to meet on that date--a minimum of nine advisory committee members must be in attendance for a meeting to occur. Instead, the meeting set for May 30 has been cancelled and rescheduled to occur on June 13," said Deputy Forest Supervisor Erick Walker.

The rescheduled meeting will start at 9 a.m. and end around 3:30 p.m. and will be held at the Okanogan-Wenatchee National Forest headquarters office downstairs meeting room at 215 Melody Lane in Wenatchee.

"Nine projects have been submitted for consideration for Secure Rural Schools and Com-

munity Self-Determination Act Title II funding in Chelan County and 14 projects for Okanogan County," Walker said. "Just over \$223,000 in funding is available for Chelan County and \$371,000 for Okanogan County."

Advisory committee members represent a wide variety of citizen interests and are residents of each of the four counties within the two national forests. The committee's funding recommendations will be forwarded to the Okanogan-Wenatchee National Forest Supervisor for final approval.

All committee meetings are open to the public.

Along with Aguilar, eight Mustangs made First, Second or Honorable Mention team status. Four Brewster players were also nominated.



grateful for his team's nominations he added that seven Bears merited First Team status.




