# **New Director** for Cashmere Museum and **Pioneer Village**

The Board of Directors of the Cashmere Museum and Pioneer Village is pleased to welcome Alexandra "Lexie" Palmer as the new Director of the Museum, as of February 2017.

previously Lexie was the Provenance Researcher at the Herbert F. Johnson Museum of Art, Cornell University in Ithaca, NY, where she traced the ownership histories of objects in the collection. Prior to joining the staff at the Johnson Museum, she worked in Collections and Documentation at the Whitney Museum of American Art, and the Prints Department at Sotheby's, both in New York.

She holds a BA in Art History from Wellesley College, an MA in Early Modern Dutch Art from the Courtauld Institute in London, and an MLitt in Modern and Contemporary Art from Christie's Education, also in London. She is currently on the Board of Directors of the Robert Graves Gallery, on the campus of Wenatchee Valley College.

Lexie succeeds Jim Wonn, who stepped down from his position as both the Museum Director and as President of the Board of Directors in November 2016.

Jim provided critical guidance and direction for the Museum, and leaves it a stronger and more robust institution. # Murder of Cashmere's Stephen Smith may be solved Leavenworth woman and Sultan man charged with 1982 murder

The Chelan County Sheriff's Office shocked residents of the upper valley early this month when it was announced there had been arrests made in the 1982 murder of Stephen E. Smith of Cashmere. Two people were arrested, 60-year old Bernard Swaim of Sultan, Washington and 57-year old Dawn M. Soles of Leavenworth. Both have been charged with first degree murder.

According to a Chelan County Sheriff's Office news release, on July 18, 1982, 30-year old Stephen Smith of Cashmere was reported missing by family members. He was last seen at his home on or about July 12, 1982.

Smith's car, a 1966 Pontiac Tempest, was found abandoned on Dead Man's Hill Road hear Drvden, several days after his reported disappearance. The initial investigation stalled in 1982 with no sign of Smith.

Late in 2016, this case was assigned to detectives for further investigation. After interviewing numerous people, including Smith's family members and witnesses, detectives identified Bernard Swaim as a person of interest in Smith's disappearance.

Prior to his July, 1982 disappearance, Smith and Soles were married. During their marriage, they had a child. They two divorced, and as part of the divorce, Smith was granted full custody of the child, with Soles getting only supervised visits.

Later, Soles married Swaim and moved to western Washington. According to the news release, on or before July 1982, Soles and Swaim traveled to Cashmere with a plan to murder Smith. The investigation concluded Swaim and Soles planned to get Smith drunk to the point of passing out. Then, they would murder him.

Using old investigative interviews and new interviews, detectives

were able to create additional leads, piecing together critical evidence to establish probable cause to arrest Swaim and Soles for the murder of Smith.

Detectives are still conducting follow-up interviews, trying to gather more information related to the disappearance of Smith and locating his remains.

I have written much about health care over the years. The problem is that unless we begin to address the underlying structural problems of health care nothing is going to change. All of the efforts that have been submitted so far suffer from the same basic problem. That is we continue to insist on modifying an outdated insurance model that was developed during WWII.

with large groups were able to negotiate lower costs small employers and individuals had to make up for the discounts insurance companies provided to the large employers. To make matters worse, when employees retired thev discovered they could no longer afford the plans that had been provided by their employer. The government stepped in with Medicare to help individuals get health insurance they could not afford on their social security income.

Medicare actually made the problem worse since the government doesn't pay the providers for the full cost of services. The result was providers increased their fees to cover the discounted payments from the government. The result was medical costs spiraled out of control and once again individuals and small businesses were left to pick

up the tab. caused employers to

If President Trump wants to fix health care he has to engage his deal making tactics and end the current system employer/government of provided health care. It will undoubtedly take a plan that phases in over time so individuals can adjust but it is far past time to look at new models that don't carry the same built in problems of the old WWII system.

I have said before that insurance companies need to sell the policies directly to individuals and premiums must be the same for all policyholders. They can sell different types of plans for different prices, but the premiums for the plans must be the same regardless of age, sex or health.

The price of coverage can only vary based on the level of coverage. In other words, a plan that provides full coverage will cost the same for all who select that type of coverage, and a catastrophic coverage plan would be priced the same to all buyers as well.

Under the current system of health insurance networks. buying across state lines will not do much to reduce the cost of insurance and will most likely result in less coverage than the buyer expects.



Health savings accounts make great sense in helping individuals manage their health care costs but to be truly effective they need to be part of a massive overhaul of our tax system. Taking a deduction on your tax return for a contribution to a health savings account will not work when half of the population is not paying taxes. Especially when it is that half that needs the most help.

Obamacare is not the only alligator in the swamp. Eight years of failed foreign policy has left us a world where America is no longer respected or feared by third world dictators who could not stand up to American military power but who could do serious damage trying.

Government regulations on banking and the environment are killing small business - the engine that drives economic growth. Misguided energy policies are wasting enormous sums of money on failed green energy and killing good paying American jobs. And our tax policies are driving private sector employers to move their operations to more favorable tax havens.

Trump promised to drain the swamp. He will need to kill a few alligators if he expects to have any lasting impact on the swamp in DC.

# Honoring our Native Americans

As I get older I appreciate more and more the contributions of our Native Americans. I grew up with the Baker boys of Cashmere and the Cheer family, later of Leavenworth. As **HOMETOWN** our flag is threatened always amongst the first to stand are our

Native Americans. A good example is IRA HAYES. A Pima Tribe member from New Mexico, he and the other male members of his High School class left together for the Marine Corps right after the Japanese bombed PEARL HARBOR. The girl's of their class didn't even have a graduation because of that. The next time you view the flag raising on IWO JIMA he is the back one.

The Baker Brothers, John, Frank and Bert all served. John did a tour with the ARMY. Frankie joined the MARINE CORPS after High School and served with the First MARINE DIVISION in Korea. He later told me that when they made it out of the Chosin Reservoir

his Company had lost half killed in action and half of the rest casualties of wounds and frostbite. Bert joined the Army and proudly served with the First Air Cavalry in Vietnam. He was a door gunner on a Huey gun ship as I understand. Ernest Cheer joined the Marine Corps and served in Vietnam. I have not been in contact with Ernest

since then but wish him the best and SEMPER FI.

As the two older Baker boys passed it was my pleasure to help with the services. Because of that I was able to meet the extended family. I think all most all the older guys served. Serving as a Monitor Community Council member from 1991 to 1998 we had occasion to meet with the Colville Tribal Council. Again I noticed that most of the guys were veterans. Some of the extended family were there. It was a pleasure to meet them again.

The Navajo Nation and neighboring tribes contributed greatly to the winning of the war in the Pacific. The Native Americans that joined the Marine Corps were sent to a top secret school set up by the

Corps. They were schooled in blending the different dialects of the native languages as to avoid mistakes. They were trained in the operation of the radio systems. As they were assigned to the different units a corporal or sergeant was assigned to stay glued to these Code Talker's. These non commissioned officers carried side arm's and were sworn to not let the Code Talker's fall into Japanese hand's even if it meant killing them. I personally don't think these guvs would have allowed themselves to be taken prisoner or let the Japanese break them. They were just too tough!

I have recently studied the history of the Columbia band's that include the Wenatchee's, Entiat's, Chelan's, Methow's and as I understand the Okanogans. I intend to follow with more information on that history later. Meantime I think the contributions of our Native Americans can not be over stated. They have given so much and been given little in return. I believe that these AMERICANS will always support America and stand for the flag. The next time you see a Veteran or a person in uniform take time to thank them. Later the Wenatchee's host a Pow Wow in 1933 at the mouth of Mission Creek.

Frazier Strutzel was born in Leavenworth in 1942 and graduated Cashmere High School in 1960/61. **WENATCHEE** -- A railroad bridge in Cashmere is the main competition for immediate funding instead of a previously priority-ranked interchange project at Hwy 150 and No See Um Road in Chelan. Olympia legislators will make the decision on which city gets what, if anything, later this week

State Senator Brad Hawkins is intimately involved with the final outcome and has asked the CDTC for guidance.

That guidance came in the form of a letter from the Chelan County Commissioner's office to him urging him to consider the importance of the bridge and that it may be closed without the monies needed. Hawkins also received a letter from city of Chelan Mayor Mike Cooney pleading for about a quarter of a million dollars to finish the roundabout that has been on the drawing board for more than a decade. Cooney appeared at the board meeting March 9 and said the project was "weeks from turning dirt,"

money is allocated elsewhere by legislators, the Chelan City Council has "stepped forward" and guaranteed the funding out of city coffers, he said.

The county commissioners' letter asked for funding for the West Cashmere Bridge Replacement Project due to its potential for facilitating "new industrial growth to the west side of Cashmere." Safety is also mentioned in the letter. The 85-year-old Goodwin Bridge is called "functionally obsolete and structurally deficient" in the letter signed

# What is your life?

SMITH

In the Scriptures there is one poignant question that has been jumping out at me lately and it is found in James 4:14 where it says "What is your life?" It seems rather a difficult question to answer due to its scope. Added to the complexity, is this question is deeply personal and the answer would vary from person to person depending on their background, present situation and circumstance. But really, have you considered lately what is your life?

I suppose the reason why this question, raised by the text in James, has been rattling in my head recently, is due to the fact that a very dear family friend



many of us do not have such clarity. We either A WALK define our lives by temporal terms, such PASTOR as what our occupation is or our role in the family. People define

themselves by their past or by some hurt or emotional injury that occurred in a moment in their life. Others define their life by their successes or accolades. Whatever it is, is the definition you believe really who you are, and is it eternal?

The Bible, particularly the New Testament, identifies people in two categories: sheep or goats, dead or alive, in the Spirit or in the flesh. However there is one identifying phrase that stands out above all others and it is used primarily by the Apostle Paul; it is the expression "In Christ". People are either in Christ or they stand outside of Christ, and before someone will balk at the exclusivity of such a statement. I again ask, is the definition of your life truly the totality of your person and is it an everlasting definition?

For the Christian, it is Christ that defines their life. When someone enters into a relationship with Christ by faith, they are no longer defined by this world, their successes or even their past. When the world would try to inject racism into the dialogue between African Americans and Caucasians, in Christ there is no such thing as black or white. I have many African American brothers in the Lord and when we are together we don't see the color of our skin, we see Christ in us. The same can be said of anyone, divorcee. recovering addict, successful entrepreneur, if they are in Christ, it is Jesus that provides the definition to their life. Why is this important? It is important because we do not define ourselves accurately. Our perception of ourselves is either overtly prideful or hopelessly jaded.

Part of my responsibility as pastor is to remind people of who they are. More specifically to show (as best as I can) the glory therein of having Christ define your life. "Christ in you, the hope of glory" (Col. 1:27),

the Apostle Paul says is the great mystery and the primary definition of a Christian. Yet what does this mean? Truthfully, it is such a weighty reality that to try to sum it up in such a short column wouldn't nearly give the attention it deserves. However, it means that an individual who is in Christ is different, changed, possesses a value not in and of themselves but of Christ who is invaluable. It is a hopeful existence and in addition a liberating one, because of the power of that union with Christ frees you from the baggage of the past.

So we go back to the question, "What is your life?" To our family friend who passed on, the answer was clear: His life was Christ. For some reading this, it is true that you perhaps have more yesterdays than

tomorrows, so what is your life? Is it identified by some temporary definitions that are here today and gone within the next, or is it distinctly marked with eternity's values in view? As C.T. Studd once said "we only have one life, 'twill soon be past, only what's done for Christ will last." Our lives are but a vapor, a "mist that appears for a little time and then vanishes" (James 4:14), so while you are here and when the curtain closes on your life, what is going to be that distinguishing quality? If it not be something eternal, more specifically Christ, then it is not worth living for.

"It's our gift to the community, and it's a lot of work," Vecchio said.

Vecchio also expressed her gratitude and thanks for Teri Weedman, the manager of the Cashmere Riverside Center, where the Community Concerts organization is located.

"We're lucky to have her," Vecchio said.

# **Rx bottles**

When my husband, Charlie's colonoscopy was scheduled for noon this past Friday, he was instructed to drink an entire gallon of prep solution, starting at 3 pm the day before. As I warmed up some soup for my dinner that night, I asked him with a smirk, "Well, how's it "going", dear?"

"I'm not sure I'm going to finish drinking that stuff.""Oh, sorry, I guess I shouldn't be eating in front of you."

"It's not that, it's my hands. With my carpal tunnel, my hands hurt so bad getting it open I might just leave the top off the rest of the way."You're having trouble with the cap?"

When he nodded, my jaw hit the floor. "Why don't you just pop the top off the cap? It's really easy to do."

"You mean you can DO THAT?" "Sure!" Leaving my soup, I walked over to the junk drawer in the kitchen, dug around for the small screwdriver we keep there and expertly flipped off the white child resistant cover, leaving just a simple twist cap in place. "There. An easy open top, just for you."

"Thanks, hon. But, isn't that against the law or something?" "Heavens, no." Eyes narrowing, I added, "Do you have any trouble opening your other prescription bottles?"

"Uh, yes. But only the new ones." "Oh? So, what do you do with them?"

"I put the new pills into my old bottle, so it's easier to open. Why?" "You don't have to put up with those child-resistant tops. You can opt out."

"Really? I thought it was federal law that you have to have them." "That's true, but you can request easy open lids from the pharmacy on your medicine bottles. You just have to ask for easy-open tops and sign a form."

"Really? That's all? I had no clue you could do that." Shaking my head, I thought about how my spouse is not alone in his struggle with child-resistant caps. And they're not only on prescription medicines but lots of other common household products like vinegar, vitamins and liquid non-prescription medicines like cough syrup.

Just last month, 82-yearold Eva brought her medicine bottles in from home for me to review. As I lifted each brown vial out of the shoe box she brought them in, I noticed how the green lettering on each of the white plastic child-resistant lids was almost completely worn off. Some of the lids were sitting crooked, barely fastened, and one vial's label was 4 years old despite having newly refilled pills inside.

Setting the box to the side. I accidently bumped one of the bottles with my elbow, knocking the lid off and spilling pills across the countertop. Picking up the yellow capsules, I asked. "Do vou ever have any trouble with the lids on these bottles?"

"Not if I'm careful to not twist them on all the way. I also keep some older bottles just in case I have any trouble with the new lids." Why do older adults end up struggling with these hardto-open lids? It all started as a well-meaning response to a serious problem.

Back in the 1960s, the most common documented cause of injury in children under 5 years old was accidently swallowing medicines or household cleaners. The **Poison Prevention Packaging** Act (PPPA) was passed in 1970, requiring all prescription and non-prescription medicines you swallow to have childresistant (C-R) packaging. In the decades since, C-R

packaging has saved many young lives but caused significant inconvenience for many adults, especially those with below average strength and dexterity, and, ironically, the ones who take the most medicines.

How do they design those frustrating child-resistant lids? According to the PPPA, packaging is considered child-resistant if a child under 5 years old cannot open it within a reasonable amount of time but a normal adult can use it.

There's a specific way they test to determine if a particular cap or package is legal to use as a child-resistant closure. First, children between 3.5 and 4.5 years old are given five minutes to open the product, then are shown a visual demonstration of opening it once (similar to seeing a parent open it), after which the children are given another 5 minutes to open it. If 20% or fewer children can get it open at that point, it moves on to be tested on adults. If 90% of adults are able to open and close it within 5 minutes. it passes as child-resistant packaging.

The age of the adults used in these tests was originally 18-45 years old, but was then changed to 50-70 years old. I get frustrated when I struggle with a bottle that doesn't want to open the first time I try it, let alone fighting with it for 5 minutes. No wonder Eva didn't want close her pill bottle lids all the way!

Since PPPA went into effect in 1974, we pharmacists have been required to dispense all medication refills in brand new vials and lids, because as the lids get used, they get easier to open and eventually won't be able to meet the C-R standard. Pharmacists must dispense ALL medicines (except under-the-tongue tablets of nitroglycerin) with C-R lids unless the patient requests otherwise in writing

and signs it.

Some years ago, while chopping wood at 15 degrees below zero I tore a ligament in my right wrist, forcing me to wear a cast for 6 weeks and a rigid brace for an additional 6 weeks. For a right-handed pharmacist, this was a major handicap because I couldn't use my wrist to open child resistant lids with that cast on, and I needed to open a LOT of child-resistant lids every day at work.

I finally figured out a way to PUSH and TURN those tricky caps that didn't require using my wrist at all, and I still use that technique because it helps me open any child-resistant top quickly and easily without straining my hands or wrists.

Here's how I open childresistant pill bottles with a PUSH and a TURN:

1. I pick up the bottle in my right hand and place the palm of my left hand FLAT against the top so that my hands form a sideways "T". My left hand is turned with my thumb pointing up as if I was going to shake hands with you, and my right hand is perpendicular to it like my left hand was a door and I am reaching for the doorknob.

2. Next, I PUSH my hands together with my arms, keeping my wrist straight. The pill bottle in my right hand is pushing up against my left palm (the top of the T) while I TURN my right forearm just a bit until the brown vial moves up into the white cap and is free to move. You may have to turn your right arm just a tiny bit to get the cap into position for the outer edge of it to disengage, so that pushing the vial unlocks the white cap part.

3. While holding that position, I TURN my entire right arm slowly clockwise just a bit WITHOUT moving my wrist. It's like turning a doorknob with your whole forearm instead of using your wrist. As I'm turning my right arm with the pill bottle clockwise the pressure of my hands pushing toward each other keeps the outer cap free as my right arm turns. You don't have to turn your arm verv far for the outer cap to

completely disengage. 4. When I feel the cap come free, I tip the vial so that it faces up, grasp the outer cap with my left hand and separate my hands, one holding the cap and one holding the vial. Opened!

with my thumb pointing up as if I was going to shake hands with you, and my right hand is perpendicular to it like my left hand was a door and I am reaching for the doorknob.

2. PUSHING my hands together with my arms, the pill bottle in my right hand pushes up against my left palm (the top of the T) and I TURN my right ARM just a bit until the brown vial moves up into the white cap and is free to move. You may have to turn your right arm just a bit to get the cap into position for the outer edge of it to disengage, pushing in the vial and unlocking the outer white cap.

3. While holding that position, I TURN my entire right arm slowly COUNTERCLOCKWISE just a bit without moving my wrist, like turning a doorknob with your whole forearm instead



of using your wrist. As I'm turning my right arm that's holding the pill bottle counterclockwise, the pressure of my hands pushing toward each other keeps the outer cap free as my right arm turns. You don't have to turn your arm very far for the outer cap to engage.

4. When I let up on the pressure the cap should stay on by itself. Done!

1- (8oz) package cream cheese, softened 2-1/2 cups shredded chessar cheese 1 teaspoon Dijon Mustard 2 tablespoons half and half or milk Kosher salt 1/4 cup Guinness beer 2 scallions, finely chopped 2 tablespoons finely chopped parsley

Combine all ingredients in a bowl and stir to combine. Mix well, refrigerate at least one hour before serving. Garnish with more chopped parsley or green onion.

Note: for a more smoother dip run everthing through a food processor. Serve with kettle cook or ruffled potato chips or pretzels. Drink the remaining Guinness.
