The Arbor Day Historical Panel comprised of longtime Pateros residents Jerry Bryant, Phil Brownlee, Bill Meadows and Mike Hull, who discussed Pateros history with visitors to the April 27 Arbor Day observance, will be in attendance.

Pateros Council passes temporary housing ordinance for fire survivors

PATEROS – One ordinance and four resolutions won unanimous approval at the regular monthly meeting of the Pateros City Council at its regular meeting last Monday, May 21.

An ordinance discussed at last month’s meeting to allow wildfire victims to live in temporary housing while rebuilding their homes was submitted for approval last Monday. The new measure as drafted amends the Pateros Municipal Code to allow residents who are rebuilding to live in an RV or trailer for a period of one year provided they have secured a building permit and are connected to the city’s water, sewer and trash services.

Council members also approved a resolution to renew an Interlocal Agreement with Okanogan County for solid waste services. In 2003 the city became part of the county’s Comprehensive Solid Waste Management Plan that is renewed as needed to allow the county to provide solid waste recycling and disposal facilities, establish a schedule of fees to be collected from all users and related services.

A resolution to approve an

Cooper nominated (again) for unwanted office

Race is on as candidates file for elective office

OKANOGAN – Candidate filing week opened across the state on May 14, and prospective office seekers had through Friday, May 18, to get on the ballot. Online filing was open through 4 p.m., May 18, and that allowed plenty of time to nominate even an unwitting citizen to a vacant seat.

In Douglas and Okanogan counties some notable names

will not be on the ballot this year. Another has once again been nominated for an office he neither wants nor filed for, similar to an ordeal he experienced last year.

Okanogan County Sheriff Frank Rogers will not seek

Lack of support cited

Word pulls the plug on Brewster outdoor volleyball court

BREWSTER – Plans to construct an outdoor volleyball court near Brewster High School have been cancelled after community support for the project failed to materialize.

Karl Word, a Brewster alum and Bears sports booster said he pulled the plug on the project when solicitations to prospective donors to cover the estimated \$14,000 cost to build the facility were unsuccessful.

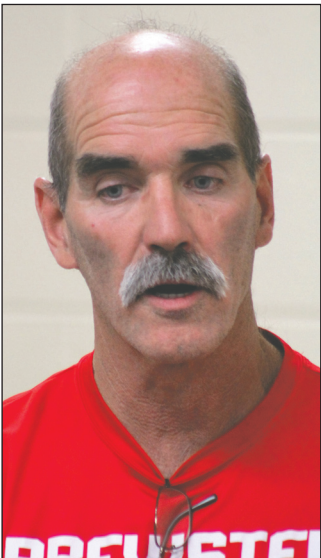
Word said he assembled packets including details, plans, and cost estimates for the court and sent them out to prospective donors.

“I got prices on everything from Volleyball USA,” said Word,” right down to the type of sand to use.”

Word said he would have volunteered to do much of

the work and calculated the project would have required a couple of weeks to complete.

Word first introduced the outdoor court at a meeting of the Brewster City Council in June 2017. His proposal was modeled after the dual outdoor court complex in Chelan’s Don Morse Park. The Brewster model originally proposed for location near the Karl Goehry Memorial Basketball Court included a fenced enclosure for

security and to prevent possible contamination from roving cats or other animals.

Word was also the prime mover behind creation of the Karl Goehry court in 2013.

“That cost about \$30,000 and had wide community support,” said Word. “Building the volleyball court for \$14,000 is a real bargain

annual fee paid to R2 Solutions of Banks, Oregon, for use of a patented plug popper to clean service lines from meter to main passed the council unanimously. City Administrator Jord Wilson said the device saves the city time and money that otherwise would be required to dig up streets to service line blockages.

The council also passed a resolution to reduce the cost of a professional service agreement with city engineer Varela & Associates of Spokane. The original agreement calling for a payment of \$26,000 to Varela for engineering assistance was not in line with the city's sewer capital budget. The new proposal allows Wilson to assist Varela and reduce the cost to \$9,640.00.

The final resolution involved a \$54,000 change order for Tapani, Inc. of Battle-ground, the city's reservoir contractor, to allow the installation of approximately 100 feet of PVC pipe from the city's new well site No. 4 to

the existing water main. In other business, city fire chief Keith Zweigle previewed new Scott high-pressure oxygen tank and mask units acquired for members of the all-volunteer department through a \$75,000 grant from the Federal Emergency Management Agency (FEMA). Zweigle said he was advised by a fire equipment supplier that Pateros "is the first volunteer department in the State of Washington to have these brand-new Scott units."

Zweigle said the department acquired 20 of the new high-pressure tanks that were divided 10 for the fireman packs and the remaining 10 for the trucks. Each truck is required to have four packs so Zweigle said the department will need to acquire five more tanks to meet the required number.

The council will host a special meeting at 7 a.m., Monday, May 29, to discuss the city franchise agreement and other issues. The regular monthly council meeting is at 6 p.m. on the third Monday of every month.

Omak, Jeff Koplin (R) Tonasket, Anthony (Tony) Hawley (R) Okanogan, and Court Creighton (R) Winthrop. Douglas County Sheriff Harvey Gjesdal has also declined to run for another term. Candidates who have filed for Gjesdal's seat include Kevin Morris (R) of Bridgeport, and Leon Leyde (R) of Wenatchee.

Steve Jenkins will not seek another term as Douglas County Commissioner for District 3. Those filing to fill that position include Mark Straub (R) of Orondo, and Norman (Buck) Tupling (R) of Mansfield.

Arian Noma (R) with the firm of Thomason Law & Justice in Pateros is challenging Brandon E. Platter (D) Omak for the Okanogan County Prosecuting Attorney's office.

Christine Brown (D) Ken-

newick will try to unseat Republican incumbent Dan Newhouse for the office of U.S. Representative District 4 that covers Adams, Benton, Douglas, Franklin, Grant, Okanogan, Walla Walla and Yakima counties.

Brown visited 13 cities and towns across the District from Oroville to Moses Lake, May 7-11, on her Big Table Tour that brought her to the Bridgeport Public Library on May 9. In an intimate discussion with Bridgeport residents, Brown discussed her platform and the issues like health care, immigration and climate change that she believes are high on voters' lists this year.

Clark Cooper of Brewster was not running for any office, but on Tuesday, May 22, the

Okanogan County Auditor's Office notified him by mail that he had been nominated to fill the office of Republican Precinct Committee Officer.

"I called the auditor's office and spoke with deputy auditor Jessica Maher as soon as I received the notice," said Cooper. "The deadline to withdraw had already passed but she said

she would take care of it." This isn't Cooper's first brush with elective office. Last year an anonymous prankster nominated Cooper online for a position as Brewster School District Director opposing Maria Maldonado. Despite his efforts to discourage voters, Cooper won by a small margin but declined to fill the seat.

good place for the varsity volleyball players to practice in

the summer."

Support for Brewster community projects remains viable as evidenced by a new playground complex, paid for largely by donor funds, that just broke ground on the old playground site near the basketball court.

Word had the backing of Brewster varsity volleyball coach Marcy Boesel, assistant coach Alisia Foyle, and the varsity players, several of whom appeared with Word's before the city council.

Word said the Chelan court, the only one in the area, enjoys wide use. One person who can

verify that is Pateros varsity volleyball coach Gene Dowers, who also coaches summer club volleyball.

"We have used the Chelan court in the past," said Dowers. "And we would use a Brewster outdoor court whenever it was available."

Dowers added that collegiate-level sand volleyball is rapidly increasing in popularity as more and more colleges add sand teams to their athletic and scholarship programs. "It's just skyrocketing at the college level," Dowers said.

In contrast to indoor volleyball, Dowers said outdoor teams are smaller, consisting of two players.

Both Word and Dowers acknowledged that playing

volleyball on sand requires different strategies and movements.

"It takes players a couple of weeks before they can work effectively on sand," Dowers said. "and they interact with the environment too, the wind and the sun."

The volleyball court was to be named the Gary Knowlton Memorial Volleyball Court in honor of Brewster native, elementary teacher and Manson Pool lifeguard, Gary Knowlton, who was killed in a hit-and-run accident near Chelan in June 2016.

"I think it would have been a great way to honor Gary and the Knowlton family," Word said.



Donald ‘Ducky’ Reese

Donald "Ducky" Reese died peacefully at home on May 18, 2018 in Brewster, Washington at the age of 85.

Don was born on June 6, 1932 in Coeur d'Alene, Idaho to Mary and Gilbert Reese. He was one of three children. In 1947 Don enlisted into the Army, serving four years in the Air Force, including a tour to Guam during World War II. Don was no stranger to hard work. For 50 years Don was a member of the United Brotherhood of Carpenters and Joiners of America, local number 96. He mostly worked in the hydro-electric field, he held many jobs as a Millwright Foreman over the years including working for Morrison-Knudsen of Douglas County, Allis Chalmers, Kaiser Aluminum Plant in Spokane, Fruin Coleman in Walla Walla, J.A. Jones Outage in Hanford, Quincy Chutes, Commercial Construction Corporation, Lundeen's Inc. and Harder Mechanical, to name a few. As a Millwright, he worked on nearly every Dam in Washington State. He was most proud of his stator replacement at Grand Coulee Dam in 1997 with Siemens Corporation. He retired at age 72.

He then married Jean Carden in 1966, settled and made their home in Brewster, Washington. Together they joined their families to include a daughter Tina along with Mary and Pat. Don and Jean fulfilled their dream and built a successful Charolais cattle operation. Side by side Don and Jean worked the alfalfa fields, bringing hay in for the cows, worked long nights during calving season and putting them out to pasture. This is where they built their legacy, to be passed down to their family. Together they enjoyed hunting, fishing, taking trips to the casino's and being members of the local American Legion Post 97.

BRIDGEPORT – The Bridgeport Mustangs and Brewster Bears varsity boys’ soccer teams were bumped from state competition after both schools lost in the first round of 16 games on Tuesday, May 15. The Mustangs hosted Wahluke in their 2-0 loser-out game and the Bears traveled to Royal and fell to the Knights, 1-0.

The Mustangs, who finished second behind Brewster

in the Central Washington B-2B league with an 8-2 regular season record, came on strong at season’s end with a one-point win over the previously undefeated Bears. That momentum carried Bridgeport through post-season victories over 1A Caribou Trail League rivals Cashmere, 3-1, and Chelan, 2-1, and into the District 5/6 title game against the Bears. In that pitched battle at the Wenatchee Apple Bowl, May 10, the Mustangs won their first-ever District champion-

ship, 3-1.

The Wahluke Warriors finished their regular league season with a 7-3 record and second-place in the South Central Athletic Conference-East behind Royal.

“Wahluke is a team with experience in State playoffs and it took us longer to figure out how to play against them,” Mustangs head coach Gabe Gonzalez said.

While putting up a strong defense in front of their goal, the Warriors managed to score in both the first and



second halves of the first-round, loser-out battle and leave their host scoreless.

“We had a great season and are proud of how we have played and everything we have accomplished this year,” said Gonzalez. “We would like to thank all of the staff and students at Bridgeport, and the community for their support this season.”

The Mustangs finished the most successful season in their program’s history with the District 5/6 trophy, Bridgeport Athletic Director Scott Darwood said.

The 9-1 Royal Knights led the 1A SCAC-East into post-season play against the CWB-2B league champion 9-1

Bears and a battle between two evenly matched teams. In a tight defensive struggle Royal pulled out a single goal to end Brewster’s state run.

Both Wahluke and Royal defeated their Elite Eight opponents and will face each other in the state semifinals at Sunset Chev Stadium in Sumner on May 25.

I saw that over 600,000 sandbags had been filled as of last Tuesday with many schoolchildren in Okanogan and Tonasket helping fill bags – including Oroville School District students who canceled sports practices to fill sandbags.

The Farm Service Agency is also working to gather information on agriculture

losses as far as production, livestock and infrastructure so that the agency can be ready to work towards recovery based on accurate damage assessments.

Last Friday, May 18, marked 38 years since the eruption of Mount Saint Helens, which was one of the greatest natural catastrophes to strike the Pacific Northwest. Then, as now, Washingtonians joined together to clean up Mother Nature’s devastation and offer a hand of help to those in

need of assistance.

I am pleased that locals are coming together to help one another in Okanogan, and I stand ready to help in any way I can. You can get more information and sign up for alerts about meetings at the Okanogan County Emergency Management website at <http://okanogandem.org>.

Lady Bears capture Regional crown, earn No. 1 state seed

MOSES LAKE – The Brewster High School girls' varsity softball team battled through a field of three District 5/6 rivals in a day-long trio of playoff games Saturday, May 19, to claim the District 5/6 Regional title and earn the No. 1 seed to the state playoffs in Yakima next Saturday, May 25.

Following their 12-2 victory over Liberty Bell in the Central Washington B-2B league championship game the previous week, the Lady Bears boarded an early bus for Moses Lake last Saturday morning for their 10 a.m. opening game against Tri-Cities Prep at Paul Lauzier Athletic Complex.

Brewster shut out the Lady Jaguars, 11-0. Tri-Cities Prep came to the regional playoffs with a 7-7 league record and fourth place in the Eastern Washington Athletic Conference.

The win advanced Brewster into the 2 p.m. seminal round against Liberty Christian, ranked second in the EWAC with an 11-3 regular season record. The Patriots defeated Lake Roosevelt by a run, 6-5, in their opening game to move into semifinal competition against the Lady Bears. Brewster ended Liberty Christian's state title hopes with a 9-5 loser-out defeat.

The regional final came down to EWAC No. 1 Kittitas/Thorp, undefeated 14-0 in league play, and the CWB-2B league champion Lady Bears. The Coyotes beat Tonasket, 13-2, in first-round play and Dayton-Waitsburg, 14-4, in the semifinals to reach the title game.

The Lady Bears handed Kittitas/Thorp an 11-3 loss to take the regional crown and earn No. 1 seeding in the state playoffs. Brewster will travel to the Gateway Sports Complex in Yakima for their first game against Onalaska at 11 a.m., Saturday, May 26. The Onalaska Loggers finished fifth in the 2B Central League with an 11-5 record.

Bears slay Dragons, pen Panthers to advance to state baseball Final Four

YAKIMA – The Brewster boys' varsity baseball team took two steps closer to a shot at the state title with wins over St. Georges and Asotin in the first two rounds of elimination play on Pete Orgill Field in Yakima last Saturday, May 19. The Bears slayed the St. Georges Dragons, 5-3, in the opening round of 16, and penned the Asotin Panthers, 4-0, in the quarterfinals to advance to the final four semis in Centralia next weekend.

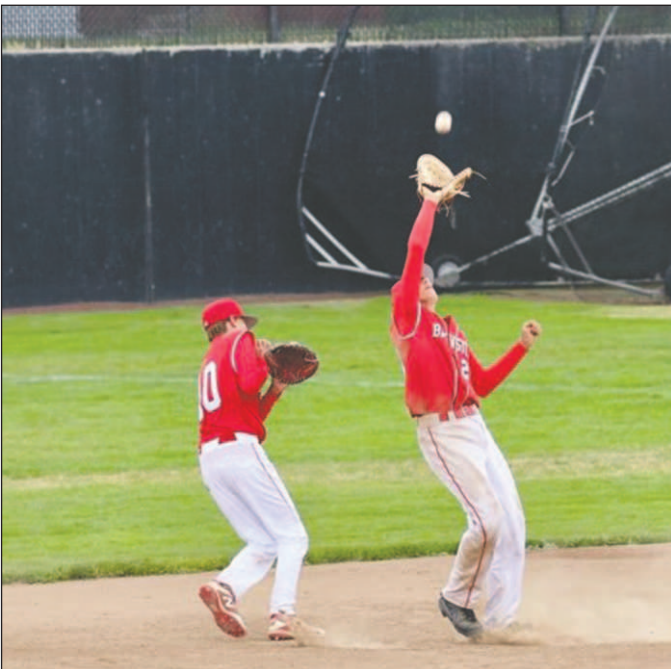
“Any other field we've played on this year, that is a bomb,” Phillips said of Taylor's wan-

it was Jarrell's turn to walk, reach third base on a Baker fly ball, and score Sonneman's sacrifice fly.

In the fourth inning Ramirez reached base on an error and scored on Baker's single. Cade Gebbers scored Brewster's final run in the sixth inning when he singled, reached second on a Ramirez bunt, and scored on Jarrell's two-out double.

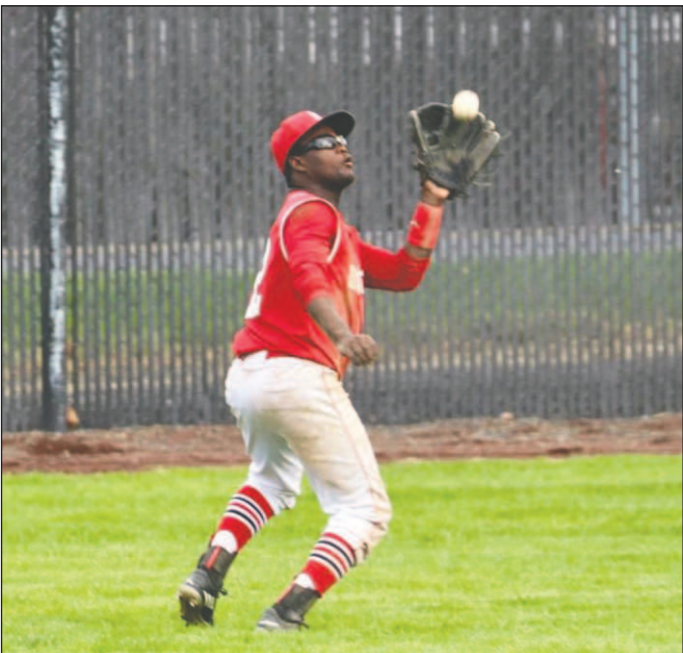
Phillips said he was particularly pleased with the way his batters approached the plate.

Middle School – Bus Lane; current bus loading for the Middle School occurs on Douglas Avenue. To improve student safety and reduce traffic congestion, a 2-bus loading lane is being proposed in front of the school. The entry will have generous walks with room enough for students to assemble for bus loading. Angled street parking will remain with 2 new ADA parking stalls. Parking Lot / Parent Drop-off; a parent drop-off lane and improved parking will be provided on the west side of the middle school. This lane will include an ADA loading stall and room for 4 vehicles dropping of students. The layout allows for 12 cars to "Queue-up" for drop-off onsite. This parking lot will accommodate 19 staff vehicles. Fire / Service Lane; the fire / Service lane on the south side of the building will be improved to be 20' wide. The trash bin will be move back near the kitchen and out of public view.

High School - North Parking Lot. The existing parking lot / service access and fire lane will be improved to accommodate approximately 40 cars. Two ADA stalls will be added near the northwest Gym entrance. The parking lot is designed to accommodate trash collection vehicles and delivery trucks for the kitchen. Pedestrian Connection; a new ADA compliant sidewalk will be added from the Middle School to the High School. This will allow all Middle School students to walk up to the new Music Room in the new wing of the High School.

Elementary School - Parking Lot / Parent Drop-off; this existing parking lot will have minor modifications. The main access will be moved from 14th Street to 15th Street. This will reduce congestion at the High School parking lot access. Vehicle traffic will be routed in a one-way direction for parent drop-off. The reorganized parking lot will accommodate 56 parking stalls, which includes 3 ADA stalls. A low fence directing pedestrians to the front entrance will be provided. This is to help mitigate pedestrians from crossing at un-identified crosswalks. Fire Lane; a fire lane is being proposed west of the Elementary School between the softball field and the existing buildings. WENATCHEE—The Grade Creek Road No. 8200 will be closed Mondays through Thursdays for approximately six weeks. The closure is for public safety while gravel is hauled on the road and repairs are made to fire suppression related damage to the road during the Uno Peak Fire in 2017.

The closure started May 16 and is estimated to end by June 30. The road will be open Thursdays starting at 6 p.m. and remain open all day long on Fridays, Saturdays and Sundays.

"Large dump trucks will be traveling on the road hauling gravel to the sites where the road was damaged during the fire," said Project Engineer Lori McAlister. "Gravel will be applied to segments of the 40-mile stretch of road from just past Antilon Lake to the junction of the Gold Creek Road No. 4330-600."

Over a dozen loads of gravel will be applied to the road daily, work on drainage dip improvements will also occur.

"The road maintenance activities being conducted are part of fire suppression rehabilitation efforts that began after the Uno Peak Fire was contained in September 2017.
