

### Schools will observe Veterans Day on Nov. 9

BRIDGEPORT – Schools in Mansfield, Brewster, Pateros and Bridgeport will all observe Veterans Day at different times on Thursday, Nov. 9.

Veterans Day officially falls on Saturday, Nov. 11, this year but the schools will hold early observances to allow students to participate.

Representatives of the American Legion posts in Bridgeport and Brewster will visit Bridgeport High School at 9 a.m., travel to Pateros for a 10:30 a.m. ceremony, and conclude at 1 p.m. at Brewster.

There will be no American Legion contingent at Mansfield High School for its 1:30 p.m. observance.

BREWSTER – Water users in this city owe a collective debt of thanks to a handful of dedicated administrators who have really earned their pay while performing near-wonders on the funding front for water storage and system upgrades.

Those who still need convincing, need look no further than the Infrastructure Assistance Coordination Council (IACC) that held its ninth annual conference in Wenatchee on Oct. 24-26.

Brewster received the IACC's annual Drinking Water Award for the just-completed renovation of one of the city's

## Brewster begins RV park electrical and water service upgrades

BREWSTER – The city's public works department recently began a project to improve the utility services for users of the Columbia Cove RV Park adjacent to the community pool.

"We are putting in all new electrical services and installing new water services," said Public Works Director Lee Webster.

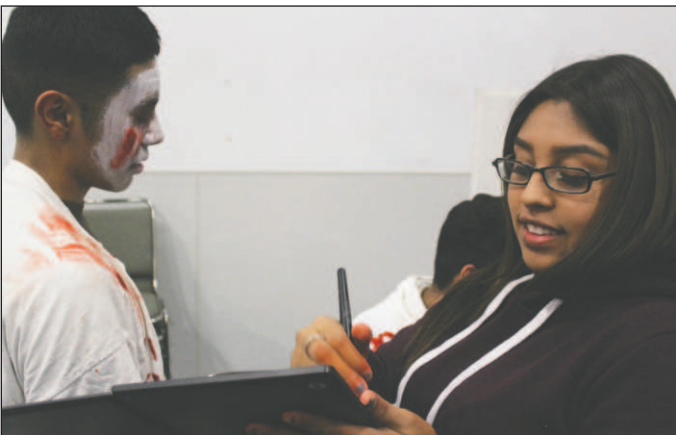

"There wasn't enough pow-

er coming in from the PUD," said Webster, "so we had to have a new larger transformer and breaker panels installed before we could begin."

Webster said the completed project will include all new services, wires, breakers and panels.

"We have six excavated and installed now, but not hooked up yet," said Webster. "The other 17 will have to wait until

500,000-gallon reservoirs.

"We had no idea," said city clerk Misty Ruiz. "We didn't think this project was eligible. It was supposed to be completed on August 10."

During a preliminary analysis, a crack was discovered in the reservoir and the repair process was delayed as options were weighed about going forward. The unexpected obstacle pushed the project beyond its August completion date and the final ribbon cutting dedication took place on Oct. 27.

Nonetheless the renovation impressed IACC enough to bestow the award "and this is just the first part of our project," Ruiz said.

During the IACC's morning session, Ruiz was asked to address the conference on Brewster's water upgrade program including the seven-year struggle to win approval of the U.S.D.A. Rural Development funding to help finance the ambitious project.

Ruiz explained how Brewster's dedication and persistence enabled the city to compress a projected 20-year water upgrade into less than half that time and corral some \$6.3 million in funding, over 70 percent of which qualifies for loan forgiveness.

The conference chair cautioned the audience that in today's public infrastructure financing climate, funding on that scale is all but nonexistent and forgiveness rates are more typically in the 30 percent range

"Receiving the award was wonderful," said Public Works Director Lee Webster.

It was also a complete surprise to the Brewster attendees since the city's engineering consultants, J-U-B Engineers of Spokane quietly nominated them for the award.

"The reservoir project was a great project from start to finish," said Webster, "made possible with help from State Legislators Cary Condotta, Mike Steele, Jim Honeyford, Brad Hawkins and many others."

Last year, the City of Pateros was recognized by the IACC for the decorative tiles that were added to the exteriors of its two prominently visible reservoirs.

Commissioner Franz unveils Forest Health Plan

OLYMPIA – Public Lands Commissioner Hilary S. Franz stood where plumes of Jolly Mountain Fire smoke reared overhead just months ago to announce a new plan to treat Washington’s ailing forests and reduce the risk of catastrophic wildfires. The Commissioner made her announcement in Cle Elum flanked by legislative, industry, environmental and community leaders. The audience included many of the 56 participants from the more than 33 agencies and

organizations that collaborated on the plan’s creation. Commissioner Franz stressed that implementing the plan will take time – it spans 20 years – and the vision is expansive. The plan involves a combination of scientific restorative work and prescribed burn treatments (using controlled fire to heal forests in a natural way) across 1.25 million acres of eastern Washington forestland. That’s the land-based equivalent of combining Seattle, Spokane, Yakama, Ellensburg and Wenatchee. The Commissioner credited bipartisan work last legislative session by Washington senators

Brad Hawkins (R) and John McCoy (D), and representatives Joel Kretz (R) and Larry Springer (D), with partnering with her to make forest health a top priority so early in her tenure. Commissioner Franz also announced the state’s first Forest Health advisory committee, a group that will be critical to implementing the recent bipartisan legislation. The committee represents diverse interests spanning industry to conservation groups, forest collaborative land managers to affected communities, and those who protect wildlife habitat to

those who respond to wildfire emergencies. It is her hope that this committee will form a strong foundation for the statewide partnerships “We now have the plan and the partners necessary to treat our high risk forests with scientifically sound, landscape-scale, cross-boundary projects. With long term partnerships and commitment we can begin to stem the severe damage from overgrowth, mismanagement, disease and intense wildfire that so many of our forests are experiencing,” said Franz. The plan includes strategies

to develop marketable forest treatment byproducts from the waste made by thinning sick and overgrown forests. By following responsible, scientific methods for improving forest health, Franz added, Washington can both improve forest resiliency and add new natural resource streams to local economies. The plan also lays out protocols to work with landowners, collect and share better science, and prepare communities for coping with threats created by unwell forests. “If we fail to do this work, we face formidable wildfire

Taxing the rich and other sacred cows

The Republicans revealed the details of their tax plan last week. President Trump called it a Christmas present to the American people. Democrats and most journalists called it a gift to the rich.

I am disappointed to say that in my 30 plus years in the news business I have found it extremely difficult to find a reporter who understands economics or math. In fact, in my early years working

for large daily newspapers I regularly lobbied that all newsrooms should have a financial person on their staff. It didn’t happen. So reporters fall back on the same old tired rhetoric that sees

tax cuts as a way for rich and powerful republicans to reward their rich friends. The problem of course is that we keep going down the road of trying to put lipstick on a pig. Our tax system is broken. It is counterproductive and divisive. It pits the poor against the rich and small business against big business. Having said that, I am dubious about the ability of Congress to remodel the tax code into a system that will work for all Americans. But I know one thing for sure. We cannot continue to expect the richest and most successful members of our society to subsidize the rest of us. We must all share in the cost to some extent. Personally, I have lobbied for abolishing the income tax in favor of a national sales tax. In Europe they call this a VAT tax for Value Added Tax. Let’s be clear, the government adds no value to any product or service. So a VAT tax is just another one of those politically sensitive names designed to make taxpayers feel better about paying it. Whenever, Republicans begin to talk about a tax cut Democrats start screaming how it will explode the deficit. Like somehow the Democrats are suddenly concerned about deficits. Ideally, they would agree to cut spending along with cutting taxes but don’t expect that to happen. So let’s look at the numbers and try to make some sense of what is being proposed.

First the 2018 budget calls for spending of \$4.09 trillion with revenue of \$3.65 trillion. So in other words the government is planning on adding another \$44 trillion to the deficit next year. That is actually down from last year’s deficit of \$58 trillion. That is a 24% savings! Try not to let your eyes glaze over here. I’ll try to make this as simple as I possibly can. Personal income tax accounts for one half of the tax collections. Payroll taxes add another one third. So 83 percent of the Federal governments revenue comes from individuals. Ten percent comes from corporate taxes and 1 percent comes from the death tax. The remaining 6 percent comes from excise taxes, tariffs and interest. The corporate tax rates are scheduled to drop from 35 percent to 20 percent. That is a reduction of 42 percent in the tax rate. Critics of the plan love to point out that few corporations pay the 35 percent rate because of deductions and exemptions. None of that is relevant without knowing what the exemptions and deductions were. The reality is that at 35 percent many American companies have found moving their headquar-

ters overseas has dramatically reduced their U.S. tax bill. As a result, revenue that might have gone to the U.S. government went into foreign governments and foreign banks. If nothing changed except the tax rate the net impact to government revenue would be a reduction of 4 percent of the federal revenue or \$.15 billion. The other major criticism is the plan eliminates the inheritance tax or “death tax.” This is an especially unfair tax because individuals who have paid their taxes all of their lives are taxed once again because they died so they can’t complain. It accounts for something less than 1 percent of the total federal revenue but Democrats want you to believe the government just can’t function without it. The truth is that much will change about this plan as it winds its way through the Congressional washing machine. So it is much too early to speculate about what the final bill will include. What is absolutely true is that our current tax system is far too complex. It discourages individual initiative and the creation of wealth. We all need to contribute something to the operation of our government. There is no free lunch. We have tried the liberal way of increasing government programs and making the rich pay for all of it. The result is our economy is stagnating and the middle class has had to pick up the bill. It is time to take a different road.

On November 1, 2017, Shell Energy North America (US), L.P. (Shell Energy) filed a final license application with the Federal Energy Regulatory Commission (FERC) for the 5-megawatt (MW) pumped storage hydro project. The Pearl Hill Battery Storage Project (Project) is a proposed pumped storage hydroelectric project located on the south bank of the Columbia River, about 7.5 miles upstream of Chief Joseph Dam along Rufus Woods Lake. The Project would consist of a power generation platform (77 by 77 feet) mounted to the shoreline with a partially buried penstock (36-inch diamated and 5,800 foot in length) water line extending up the hill to a water storage tank (approximately 20 feet tall and 300-foot-diameter). A buried transmission line would extend along the penstock route to an existing Douglas County PUD power line along Road L in unincorporated Douglas County. The project will cycle water from the Columbia River on a daily basis to provide grid availability-services as needed. The Project is being developed to help maximize the potential of renewable energy resources in the region.
