PATEROS – The temperature may have been rising but nobody seemed to notice during a weekend of cool events in Memorial Park and city-wide that had something for just about everyone from Friday, through Sunday, June 23-25.

If the near three-dozen garage sales scattered from Pryor Drive to Alta Lake wasn't enough to keep a body busy, a string of attractions from a beer garden to bike rally, live music to a long boat and antiques to archeology were available to fill the schedule.

Aaron Naumann and Randy Lewis used the newly installed barbecue in the Memorial to the Methow Park to prepare filets of Copper River salmon fresh from Alaska's Copper River.

Native flautist and guitar player/singer, Arnold Cleveland entertain the early afternoon crowd before live music by Brian DiJulio and the Love-Jacks took over at 3 p.m.

Methow native Mark Miller and a crew of paddlers brought a traditional long boat from

the Methow River safely into the Pateros dock.

Stan Gough, Director of Archeological Services at Eastern Washington University manned a display explaining some of the Eastern Washington's early history unearthed from excavation sites.

The Sinkietqu Okanogan Basketweavers Association brought a display of baskets made from the roots of Western Red Cedar trees and imbricated with corn husk wild cherry bark and beargrass.

Beadwork artist, Linda Saint of Okanogan demonstrated her craft and displayed several of the elaborate baby boards and other articles she has created over the years.

The Okanogan Samaritan Rivers participated with other cyclists in the fifth annual Pateros River Run.

The Junk Stops Here Vintage Market attracted about a half a dozen vendors to this year's event. It will hold a similar event at Riverwalk Park in Chelan on July 22.

A spectacular fireworks show over Lake Pateros brought the curtain down at 10:30 p.m.

Chihuahuas are most prolific

Stray, unlicensed dogs plague Bridgeport streets, neighborhoods

BRIDGEPORT – At-large and unlicensed dogs are becoming a problem within the city limits. At its regular monthly meeting on Wednesday, June 21, the city council pursued possible remedies with animal control contractor, Bill Zweigle, who also handles Mansfield dog issues.

Zweigle said that some 75 percent of the stray dogs he captures are Chihuahuas, and those he fails to catch escape into the area's trailer courts.

Zweigle said he picked up

his 21st dog on June 20, and averages 60 to 65 impounds in a year, so is a little behind the average

"Regardless of the count, that's just too many for the population of our little community, to have that much recycling of dogs," said Zweigle.

Council member Jackie Hentges said one of the main problems is establishing ownership and responsibility of unlicensed dogs.

Public works director, Stuart Dezellem said a dog license does not keep a dog from running at large.

"I think we need to writ-

ing more citations," said Dezellem "People do not change habits until you financially pain them."

Dezellem used the service call charge for utility customers as an example.

"We had 30 to 40 monthly service calls that only charged five dollars, but as soon as we went to \$25 that dropped to a handful," Dezellem said.


Zweigle said he has been advised by the sheriff's department that he cannot pick up a dog based solely on a citizen complaint unless he has personally witnessed the infraction.

"If that's a law, it's a horrible law," said Zweigle "because the police are not believing our citizens that a dog was there at such and such a time."

Zweigle advises citizens to record the dog incident with a photo to verify that an infraction took place.

Dezellem said that with the abundance of cell phone cameras owned today "it's pretty easy to get a photo of a dog running at large."

As the law now reads, Zweigle said he does not have the authority to write a citation.

Pateros mayor promoting installation of two roundabouts

PATEROS – Resident Gary Ogden appeared before the city council at its regular monthly meeting Monday, June 19, to lobby for a reduction of the speed limit on U.S. Highway 97 passing through the Pateros city limits from 45 miles per hour to 40 mph.

Ogden argued that reducing the speed by five mph would reduce crosswalk hazards and promote pedestrian safety.


Mayor Carlene Anders said she is promoting the installation of two roundabouts on U.S. 97 at four-way cross streets on both ends of town, but does not yet know "what kind of time frame that is going to take."

Anders said a proposal to

lower the speed limit from 50 to 40 mph eight years ago

resulted in the current 45 mph limit.

"I would recommend community-wide that if people

see this as a need to go ahead and write some letters that express their safety concerns," said Anders, "If we could start

collecting some of those pieces then that is what I could move forward with."

Swimming pool, sidewalk improvement discussed

Bridgeport Council moves Capital Facilities, Comp plans forward

BRIDGEPORT – The city council held a public hearing and first reading for Bridgeport's Capital Facilities Plan (CFP) at its regular monthly meeting last Wednesday, June 21, and voted to move the plan forward.

Members discussed and approved amendments to the city's Comprehensive Plan (CP) and council also set a hearing date for the city's six-year Transportation Improvement Plan (TIP) for July 19.

City Planner, Kurt Danison

of Highlands Associates in Okanogan explained the remaining elements of the CP adopted by council last year still to be approved.

Those elements include:

- Amend the comp plan capital facilities element, primarily goals and policies to streamline it and make comp plan and CFP are consistent;

- Amend the environment and critical areas conservation element to meet 2017 mandated update to CP

- Update the critical areas map that identifies where critical areas exist within the city

Following Danison's review of the CP revisions, council voted to approve the second reading of CP amendments.

Council also adopted amendments to the Bridgeport Municipal Code (BMC) pertaining to regulations for the protection of critical areas to align with changes on the CP.

Danison also explained Project Relight, a program through the Transportation Improvement Board (TIB) that replaces the city's sodium vapor and mercury vapor lights with light-emitting diode (LED) lights.

"Douglas County PUD must be involved and it is 100 percent grant funding," Danison said.

Danison explained that in Okanogan County, its PUD created a lower LED rate. When the rate for non-LED lights went up three or four dollars a month last April, conversion from the 200-watt lights to the 40-watt LED, the cost will drop to five dollars less than what is being paid now. Danison said he did not know if the Douglas County PUD was interested in pursuing a similar program but added that for the TIB to be interested there must be a cost savings benefit.

Mayor Conklin noted that Douglas County electrical rates are currently the cheapest for power "but they're starting to creep up."

Engineer, Mike Meskimen and Julio Renteria of Gray and Osborne Consulting Engineers in Yakima updated

council on the sidewalk improvement project on Foster Creek Avenue from 26th Street to State Route 17. Since construction costs are running 25-30 percent higher this year than is typical, it was recommended that the city bid the work this year but begin construction in 2018 when rates might be

cheaper.

In other business, Public Works Director, Stuart Dezellem, advised that the pool is open but that multiple leaks continue to be an increasing problem.

Council member Matthew Schuh recommended that the city address repairs soon to avoid increasing costs and

the leaks become more pronounced.

Dezellem said he will contact the limited number of pool contractors who specialize in that type of work and expressed hope that the use of dyes in the water after the pool is closed for the summer will help narrow down the source of the leaks.

Mayor Janet Conklin said she would check with the city attorney about allowing the animal control to issue

citations.

Council members discussed procedures used in other jurisdictions to address dogs at large.

"I took a stroll Saturday (June 17) from 12th and Douglas to the 1000 block on Columbia and was attacked by dogs going down and attacked by

dogs coming back," Dezellem said.

A citizen in the audience added the telling observation that "you can't walk your dog in this town on a leash."

One idea is to have Zweigle use some of his time to do more foot patrols and make door-to-door calls on residents to inquire about ownership and legality of dogs they own. Conklin said she will also discuss Zweigle's animal control hours with Mansfield's mayor before council revisits dog control measures at its next regular meeting on Wednesday, July 19.

In his report to the council, city administrator, Jord Wilson, who participated by cell phone, recommended that the mayor and council send a formal letter to the Washington State Department of Transportation (WSDOT) requesting beacons at the Lakeshore crossing on U.S. 97.

Wilson also wrote in his report that the city should soon be in receipt of Re-Light Washington contract from the Transportation Improvement Board (TIB). The project will reduce the cost of street lighting by replacing existing 200-watt bulbs with less expensive and longer-lasting 70-watt light-emitting electrodes (LED) in the downtown area and 40-watt LEDs in residential areas.

Under water system improvements, Wilson wrote that both the reservoir and wells projects are out for bid. DJB Construction, LLC, of Wenatchee is progressing with the Ives Landing expansion, Wilson wrote. The lab building has been removed and crews are finalizing clean-up of the site.

Anders said the Long Term Recovery Group is moving into Phase Three of residential rebuilds.

"We have three homes left in Phase Two and anticipate that work will go on to next year," Anders said.

The group has already raised about \$400,000 for Phase Three work.

"All the rebuilds from here on out are north," Anders said.

Center member, Sue Burgess has been very proactive in contacting businesses this year.

“Thanks also to Barbara Fenton, another member, for her help with the wall ads,” Lowry said.

The Center will accept a donation of whatever a business wishes to offer and will advertise the business for one year.

“It’s a win-win situation for all because we seniors have a direct place to look if in need

baskets building up and any basket will have a 25-cent tag on it.”

Paula Peckham, Rummage Room manager, and Patsy Whitley, the assistant manager, will be on hand to help fill bags.

The Center will man a booth at Columbia Cove Park from noon to about 5 p.m. on July 4.

“We will have slices of watermelon available for a \$1 donation per slice,” Lowry said. If anyone would like to donate a watermelon or bag of ice to keep them cool, please stop by the booth.”

Brochures and membership applications for prospective new members will also be part of the Center’s effort to recruit new faces.

The Center can accommodate up to 150 occupants and is available to rent for birthdays, anniversaries, memorials, showers and other events. For more information, call 689-2815 and ask for Kathy Lowry or Paula Peckham.

Lisa Bees Bistro burglarized

DOUGLAS COUNTY -- In an exclusive interview with NCW Media, Lisa Bee's Bistro, Bakery and Produce Market owner Lisa Stanton said her social media accounts have been overwhelmed with an outpouring of community support after her namesake establishment was burglarized June 14.

"We are 99 percent sure it was three young males, probably high school age or around 19 or 20," Stanton said.

The surveillance cameras at the popular Columbia Riverside eatery captured photos of masked men and even showed their footwear, which is one reason Stanton thinks the criminals can be pegged as young men.

Stanton, family and friends only had to close shop briefly thanks to a great team effort to get things in order, cleaned-up and back in business.

She especially wanted to thank Sheriff Harvey Gjesdal and his deputies for spending

"five hours" on site after the incident doing investigative work. Stanton also wants to give a big shout out of thanks to LocalTel Communications and the Douglas County PUD who made sure the shutdown was brief.

"The PUD came out within an hour and LocalTel was there within two," she said. "New equipment was overnighted."

Word of the break-in spread like wildfire throughout the close-knit Douglas-Chelan counties communities via Facebook where Stanton reports "more than 160,000 people reached" as the story spread from one group and was picked-up by another and another and so forth. She has more than 5,000 followers on her own site.

Stanton originally offered a \$500 reward leading to the arrest of the men, but others have upped that amount to more than \$1,200 as of this interview. She has also installed incredibly loud security alarms on every building "that can be heard a quarter of a mile away"

as well as motion detectors, dead bolts and "beefed-up security" measures designed to thwart any future efforts at ruining her livelihood.

Stanton said more than 20 customers have already expressed concern to her personally and one little boy even gave her \$1 in a card that said, "I'm sorry your money was stolen."

She has also received more than a dozen bouquets of flowers and plants. "People get really upset. You work so hard ...this is a great community."

Stanton is positive this crime was not aimed at her personally, "They could have done much more harm than they did," Stanton, "It was nobody that knew us." According to a news release from Douglas County Sheriff Harvey Gjesdal, four residential burglaries took place in early June and "a fifth

burglary occurred on June 14 at Lisa Bee's fruit stand at the 13000 Block of Hwy. 2. Three cash registers, \$1,250 in cash, a Mac laptop computer, and an i-phone 6S were stolen. There was substantial vandalism inside the business."

Gjesdal reports that "A neighbor who lived west of the business said he had seen a suspicious vehicle in the area. It was a dark or flat black wagon with a very loud exhaust."

Gjesdal said, "This spike in burglaries is not usual in Douglas County. I encourage everyone to be security conscious."

Report any suspicious activity to law enforcement immediately. Try to provide detailed descriptions of suspicious persons or vehicle's.
