Chelan and Manson entities among recipients of County Lodging Tax Grants

WENATCHEE – Chelan County Commissioners greenlit the allocation of nearly \$320,000 in lodging tax dollars toward various tourism-related entities, benefitting a gamut of local organizations.

These funds, generated by local lodging establishments, are distributed with precision. Half of the yearly revenue is designated for six local chambers, Ohme Gardens, the Cascade Loop, and TREAD. Additionally, a part is reserved for the county's Visit Chelan County initiative.

The balance is annually earmarked for grants aiding tourism-related bodies, like festivals and museums. The Lodging Tax Advisory Committee (LTAC) thoroughly reviews applications, recommending disbursement to the Board of County Commissioners.

"LTAC budgeted \$280,000 for this round of 2024 grant applications," said Commissioner Tiffany Gering, who chairs the nine-member advisory committee.

"The committee recommended allocating nearly \$40,000 more because of the quality of applications that came in. These dollars are an investment in our communities and the organizations that play a vital role in our tourism-dependent economy."

In 2024, a total of 23 local groups and nonprofits will

benefit from the \$319,681 granted. This financial boost will support diverse endeavors, from marketing and outreach efforts to enhancing new and established festivals, museum exhibits, and event arrangements.

The awarded entities intend to utilize these funds to further their initiatives, solidifying their roles in fostering community engagement and bolstering tourism prospects.

The LTAC has a biannual call for grant applications, opening annually on Sept. 1 (for events and marketing grants) and Feb. 1 (for capital grants), with respective deadlines on Oct. 15 and March 15.

Chelan PUD considers 5,000-acre Ravenwing acquisition

WENATCHEE – A block of nearly 5,000 acres of undeveloped land south of the city may be the latest acquisition to Chelan PUD's property holdings as disclosed at the regular meeting of the board of commissioners on Monday, Dec. 18.

PUD real estate manager Vicki Griffin confirmed that at the direction of the senior management team and as part of the utility's 50-year vision process a purchase and sale agreement has been negotiated for 4,910 acres of property known as Ravenwing Ranch.

The purchase price of the undeveloped land located along Colockum Road in the Malaga foothills is \$5,325,000 or \$1,085 per acre.

Staff attorney Daniel Appel explained that the proposed purchase and sale agreement signed on Dec. 14, and contingent on approval by the board includes:

• A recoverable \$5,000 earnest money payment.

• A 90-day period to perform a due diligence investigation.

• An additional 90-day optional extension period, if needed.

The Ravenwing acquisition is part of the utility's planning vision for the next half century of growth in the industry.

"I view it as a strategic purchase," said PUD general manager Kirk Hudson. "It provides options down the road, whatever that 50-year vision might look like."

Commissioner Garry Arseneault said he is familiar with the land and topography

CHELAN - The Chelan Valley Housing Trust recently received much needed donations from local government, businesses and private donors to bolster their efforts in building attainable homes for local wage earners, families and seniors in the Chelan Valley.

Both Chelan County and the City of Chelan donated \$20,000 each, while the Lake Chelan Chamber of Commerce donated \$10,000.

"We are proud to have pledged support for this tremendous and very important work" says Mike Steele, Chamber of Commerce Executive Director.

"Without the support of our local government agencies, we would have a much harder time providing opportunities to keep our local workforce intact. I believe the ongoing support also shows how important solving this problem is to those elected officials" says Scott Meyers, Executive Director of the Chelan Valley Housing Trust.

This season of giving was kicked off by Larc Hill Vine-

yard Ranch whose first-timeever "Boots Up for Charity Gala" raised over \$200,000 in gross revenue for CVHT and Lake Chelan Rotary.

Fielding Hills once again sponsored the housing trust in a Give Back Saturday fundraising event in December with proceeds to benefit attainable housing. ington State Department of Health (DOH) unveiled an innovative online tool, the WIC Clinic Locator, designed to bridge connections between individuals and the Women, Infants, and Children (WIC) Nutrition Program.

This initiative aims to enhance accessibility to the underutilized program across the state.

The WIC Clinic Locator map, a key feature of this online platform, showcases over 200 WIC clinics statewide. It offers comprehensive information, including clinic addresses, contact numbers, and operating hours, empowering users to locate and access WIC services easily. Additionally, a newly introduced WIC Interest Form enables individuals to submit applications directly to their chosen clinic online. Healthcare providers and com-

munity-based organizations can also utilize this form to facilitate referrals to the WIC program.

Michele Roberts, the Assistant Secretary for Prevention and Community Health at DOH highlighted the significance of this digital advancement, stating, "The WIC Clinic Locator tool is another important step the state of Washington is taking to modernize the WIC Program and improve equitable access. We know that in our state, as well as nationally, about 50% of people on Medicaid who are also eligible for WIC benefits are not currently enrolled in the program. Our goal with this tool is to spread awareness of WIC and remove as many barriers as possible."

The WIC Nutrition Program extends monthly food benefits, emphasizing nutritious items such as milk, fruits, and vegetables. Additionally, it offers health screenings, nutritional education, and invaluable support for breast/chest-feeding. Eligibility for WIC encompasses pregnant individuals, new mothers, those engaged in breast/chest-feeding, and children under the age of 5.

Moreover, fathers, grandparents, foster parents, and guardians are encouraged to apply for WIC benefits on behalf of eligible children. In 2022, Washington's WIC program provided services to 195,655 individuals statewide.

The launch of the WIC Clinic Locator marks a pivotal step forward in the state's efforts to expand the reach and impact of the WIC Nutrition Program, striving to empower more individuals with access to essential health and nutrition services.





CASHMERE - It has been more than 10 years in coming but the Chelan varsity girls' basketball team emerged victorious, 42-37 over host Cashmere in a nail-biting contest on Tuesday, Dec. 19, on the Bulldogs' home court.

The first quarter set the tone for the game as Cashmere took an early lead and finished the quarter with a narrow 14-12 advantage. Chelan turned the tide in the second quarter and outscored Cashmere to tie the game, 22-all, going into halftime.

The third quarter found the teams neck-and-neck as each side scored 14 points.

In a dramatic fourth quarter, Chelan intensified its defense and held Cashmere to a single point. The Goats connected for some crucial baskets, inching closer to victory. With a final push, Chelan sealed the game with a five-point victory.

Brynn Hughbanks led Chelan with 11 points, Lydia Petersen and Arabelle Finch contributed nine points each, and Jailyn Reinhart added seven.

"Tonight, we didn't play our best basketball, but we played consistently throughout the whole game. It was enough for us to get a historic win against Cashmere," said head coach Nick Longmire. "It has been over a decade since the Chelan girls have been able to secure a win against the Bulldogs. They have a great program and are coached well.'

The Chelan girls take possession of first place in the Caribou Trail League (4-0) and improve their regular season record to 5-3.

Goats by five

The Goats varsity basketball team picked up a 53-48 overtime win in their CTL squeaker against the Bulldogs.

Defense made the difference as Chelan managed to build an eight-point lead during the first quarter that dwindled to just one, 25-24, at halftime.

The Goats made another run at the start of the third quarter and momentarily held a10-point lead before back-to-back three pointers by Cashmere's Landon Baker and Riley Hatmaker. Isaac Wilson paced the Goats

in the third quarter with nine of his game high 18 points during that quarter.

The teams were knotted at 40 going into the fourth quarter with Chelan starters Luca Faletto and Ryan Rainville on the bench with four fouls each.

With the game tied at 46 and just seconds remaining, Cashmere's leading scorer, Rylan Nelson, drove to the basket under the tight defense of Chelan's Zack Noyd.

Nelson, who finished with 14 points, was unable to get his driving bank shot to fall and Chelan's Kellen Reinhart secured the rebound as time expired, sending the game into overtime.

Overtime began with a driving reverse lay-in from Noyd. After forcing a pair of turnovers, Chelan's Dom Solarza and Isaac Wilson each got to the free throw line and made one of two shots.

Chelan forced a ten-second violation with a full court press and less than a minute to go on the clock. On the ensuing play Kellen Reinhart was fouled and put the Goats up five by hitting one of two free throws.

Landon Baker answered quickly for Cashmere with a bucket and brought Cashmere to within three points with 10 seconds remaining. The Goats showed poise against Cashmere's full court pressure defense. Cashmere was forced to foul Jacob Allen who hit both shots to seal the victory.

"It was great to see the guys force so many turnovers near the end of the game," said Chelan head coach Tony Callero.

The Goats forced 23 turnovers and had just 11 themselves.

"Anytime you can hold a team to just eight points over the final 12 minutes of the game, your chances of getting a win are pretty good," Callero said.

Chelan got 18 points from Wilson, 12 from Rainville and eight points from Reinhart. Cashmere's leading scorers were Nelson with 14 and Baker with 13. The win improves Chelan's record to 7-1 overall and 3-1 in the CTL.

Cashmere drops to 2-4 overall and 0-3 in the CTL.


